(57) **CLAIM**

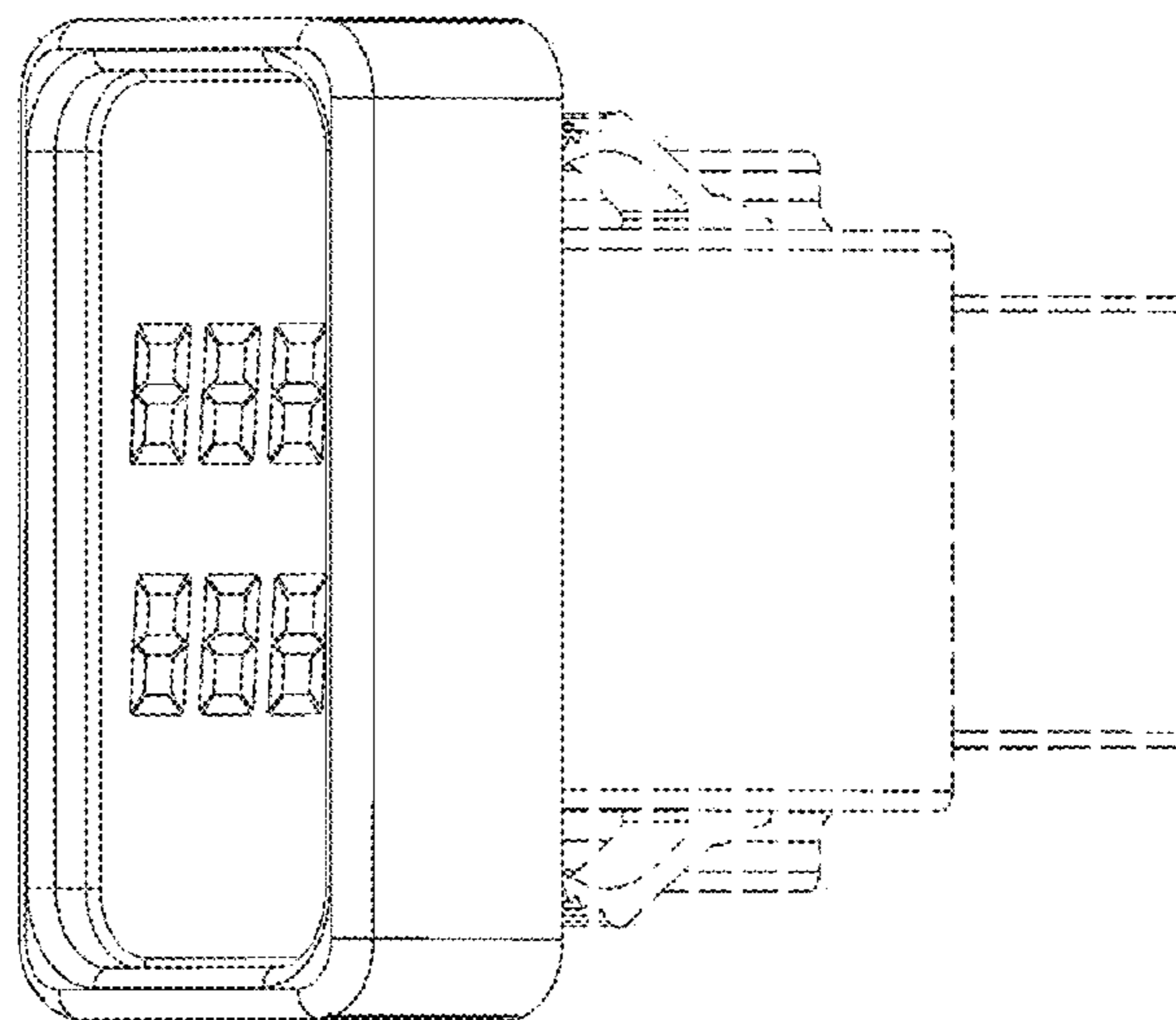
The ornamental design for a portable digital display unit, as shown and described.

DESCRIPTION

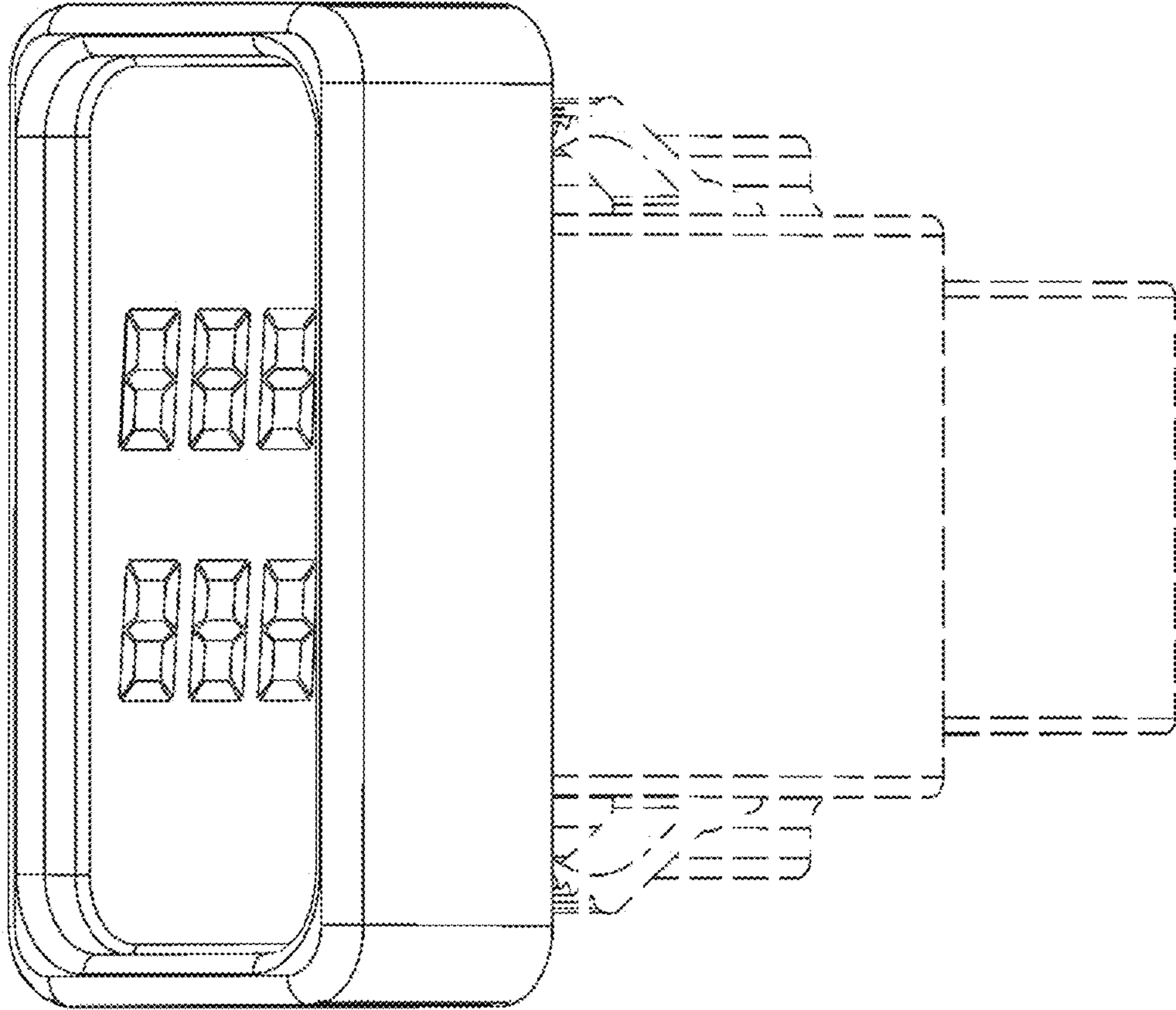

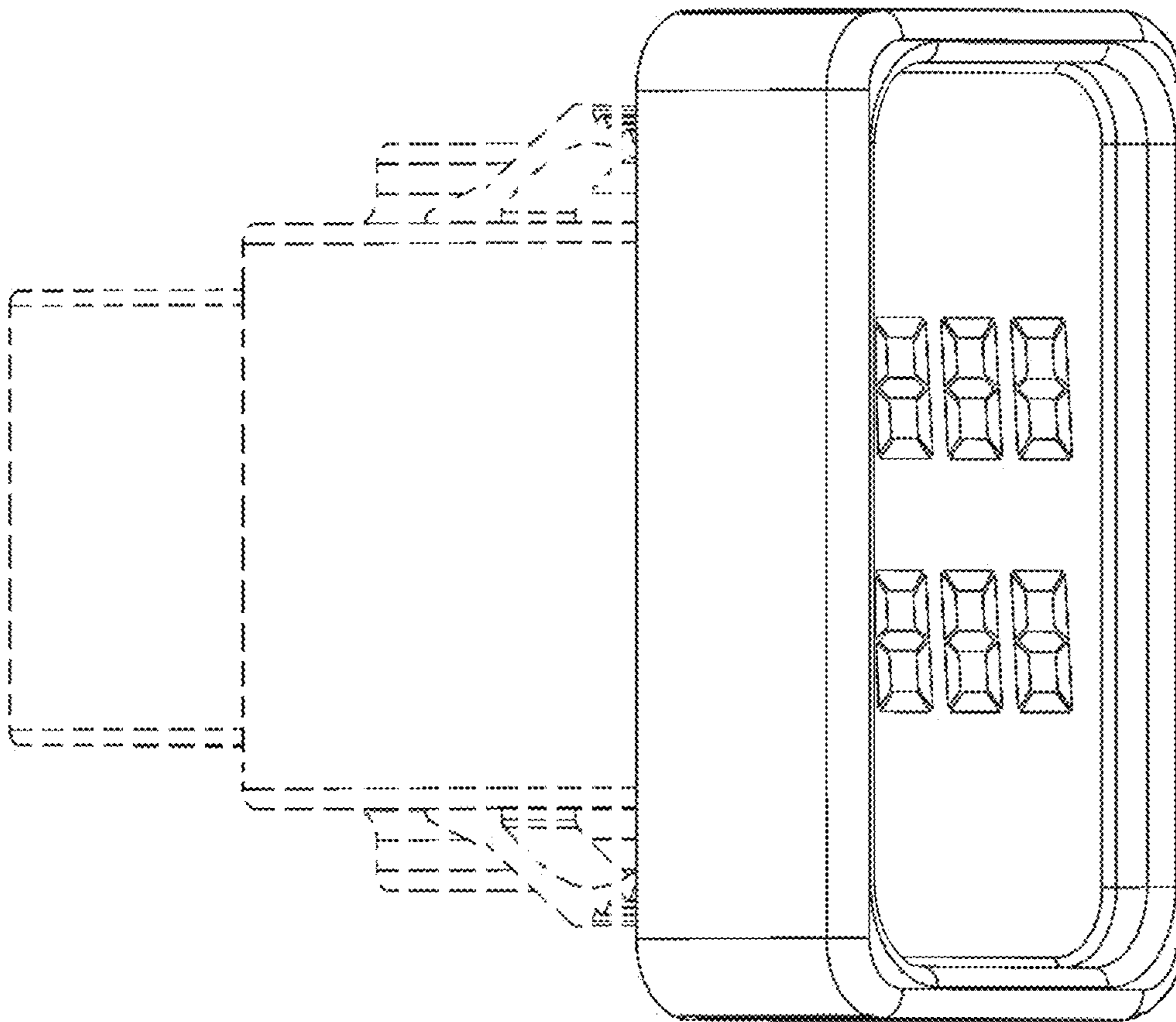

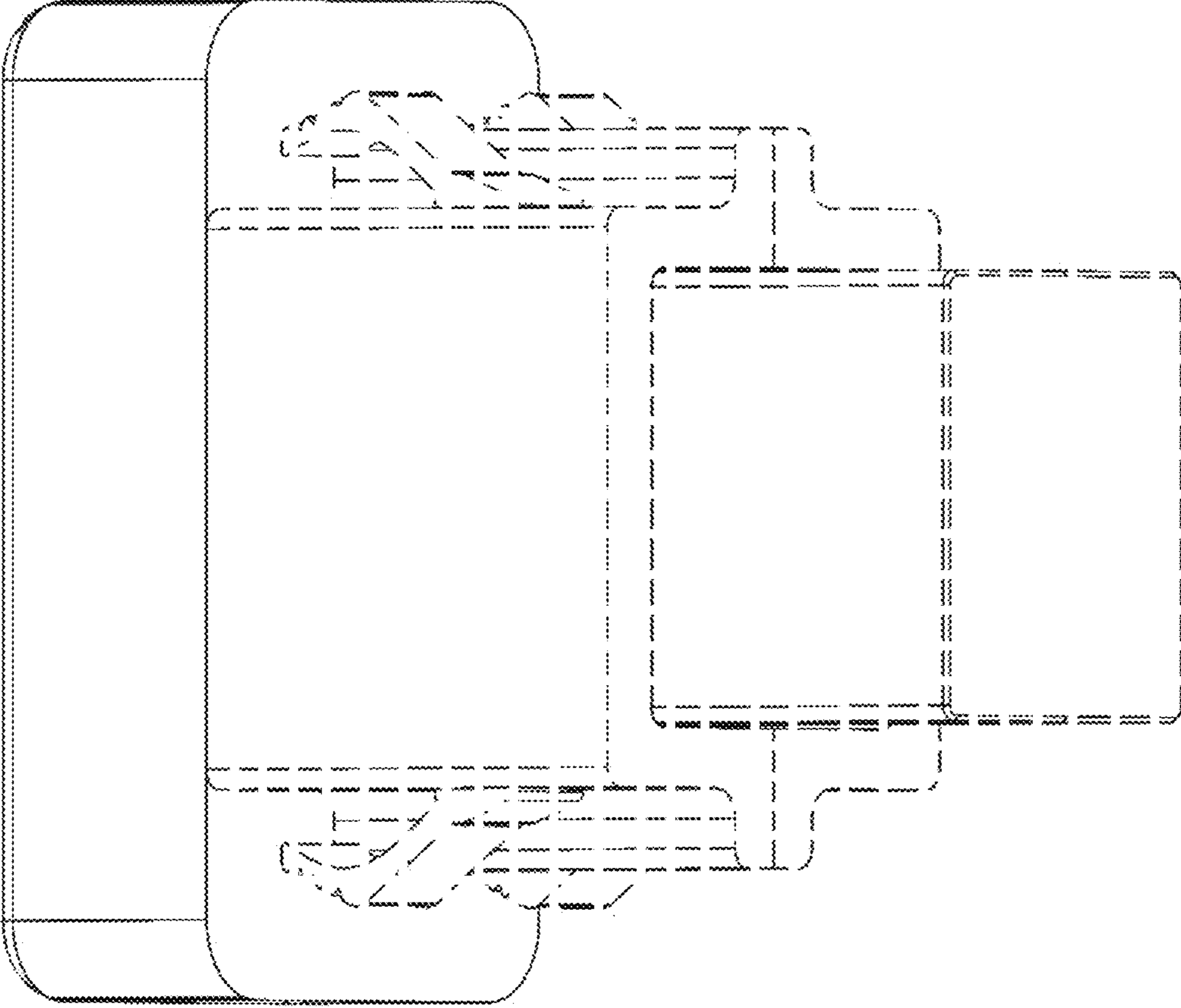

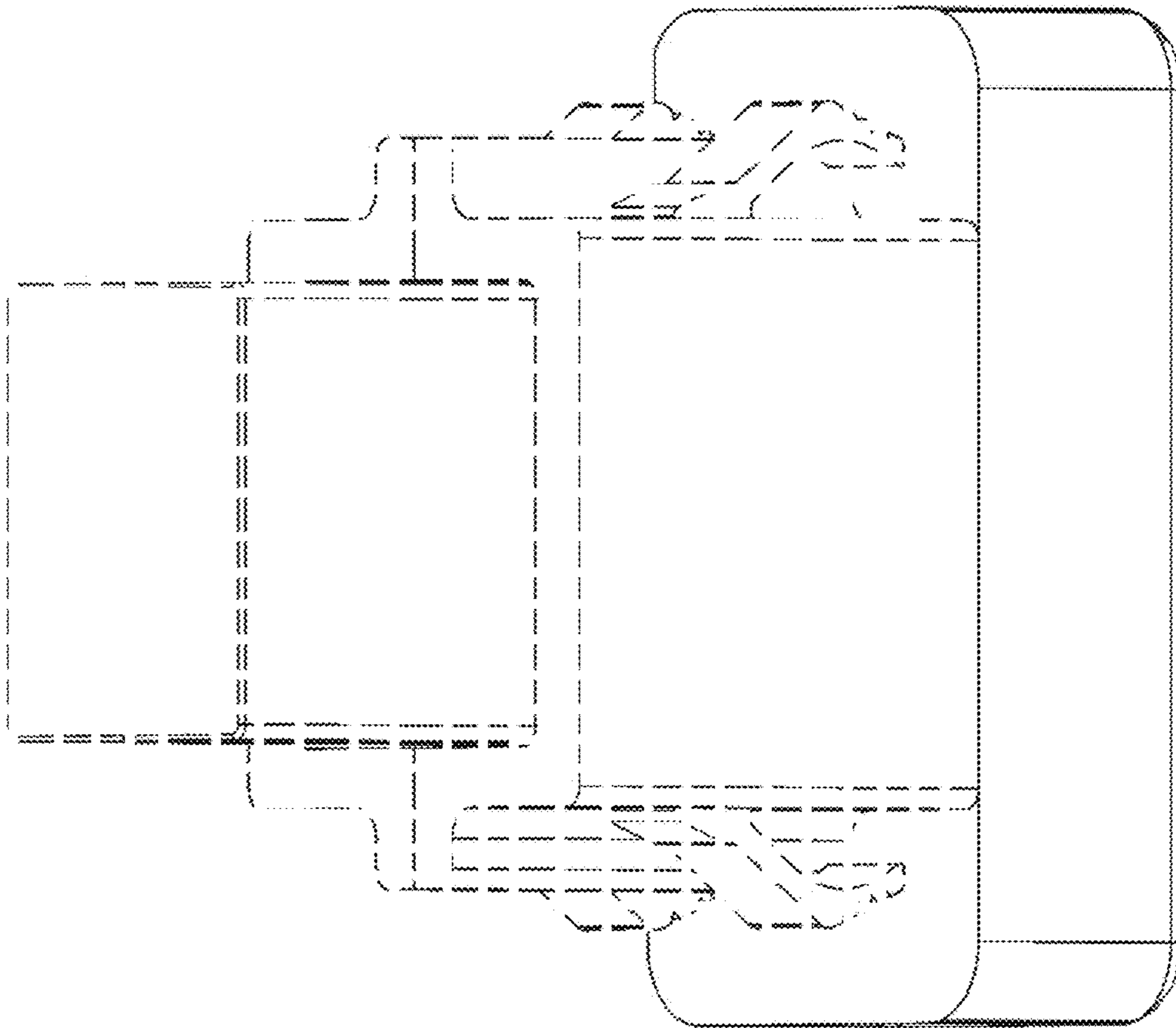

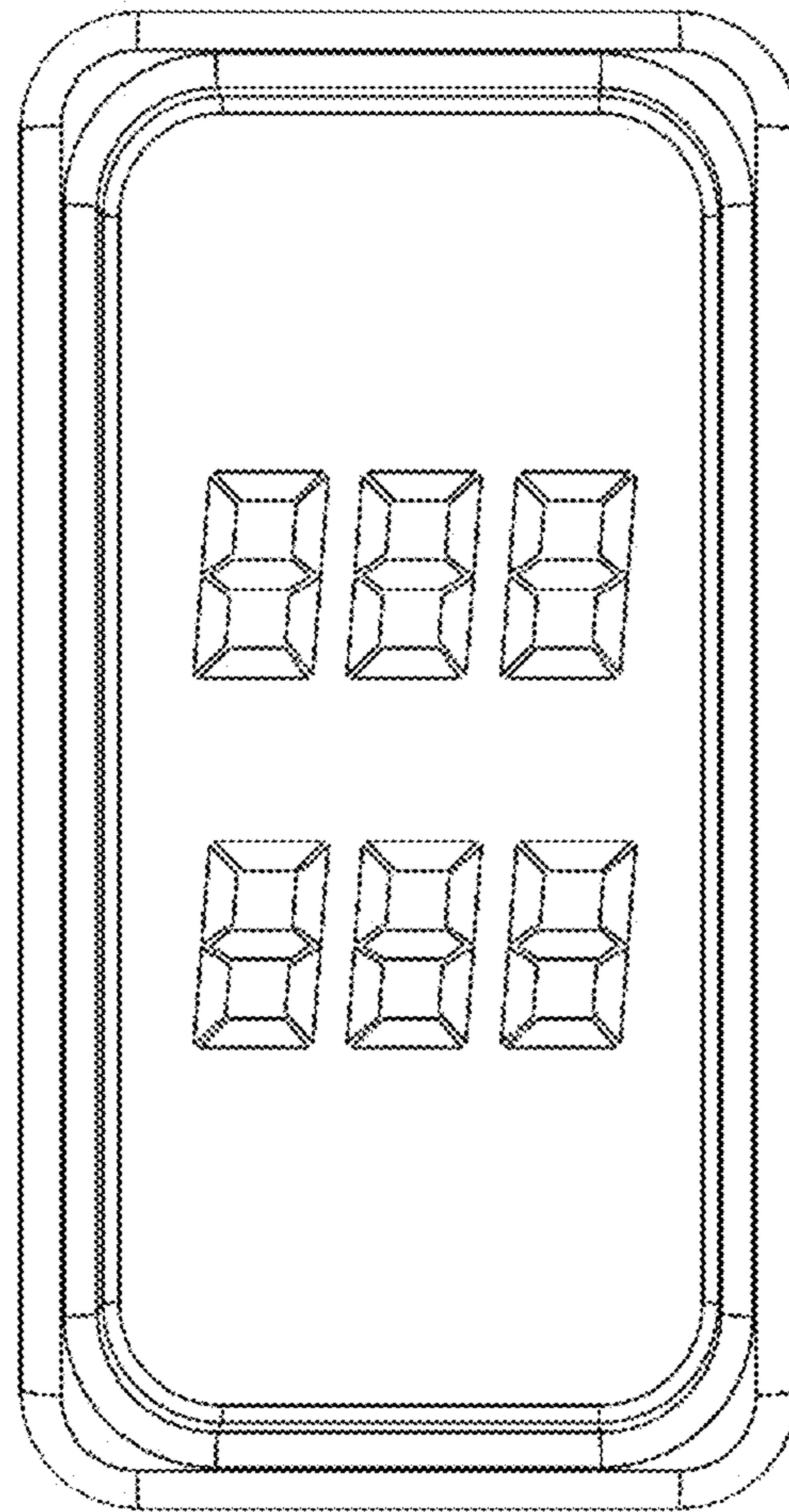

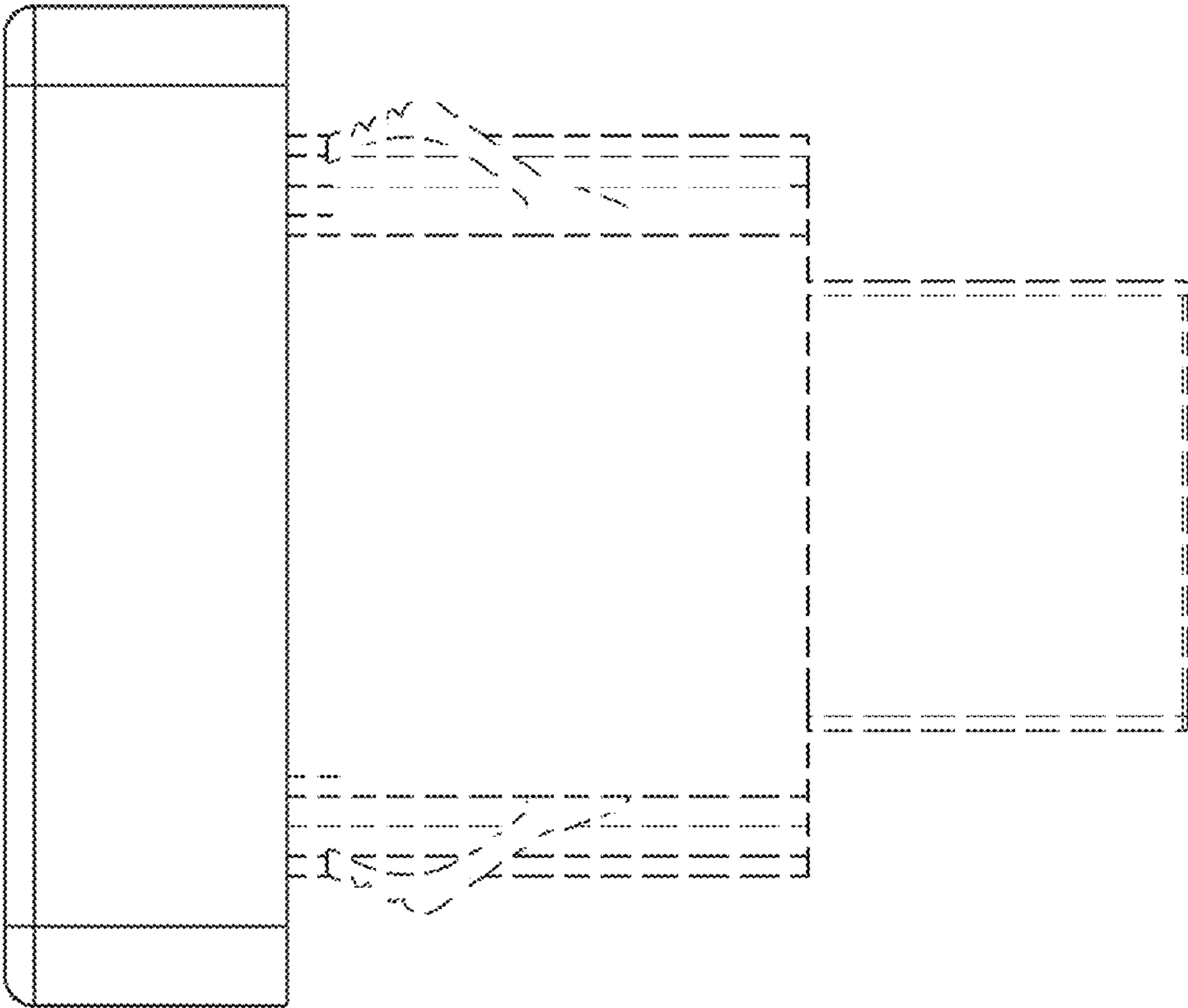

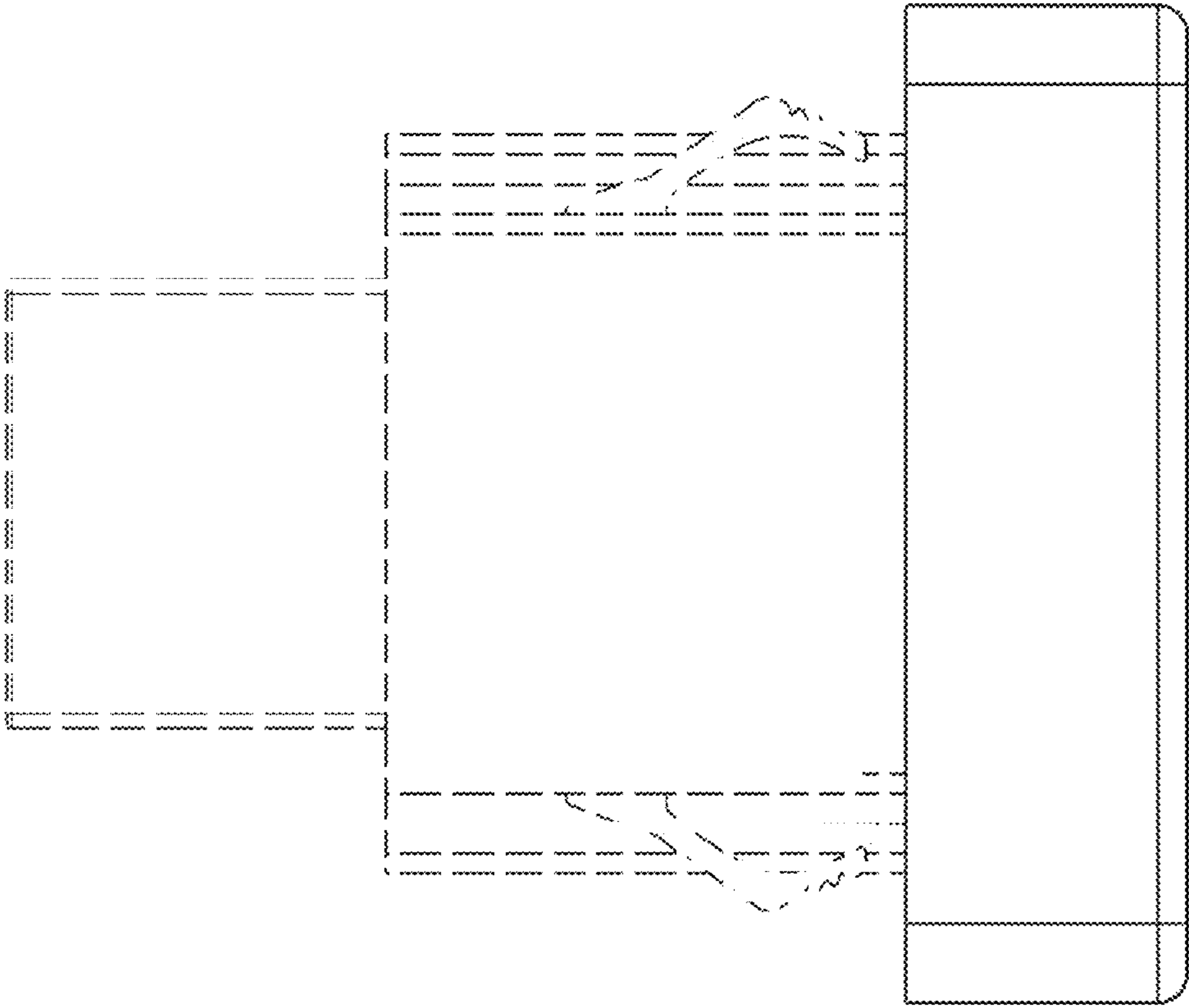

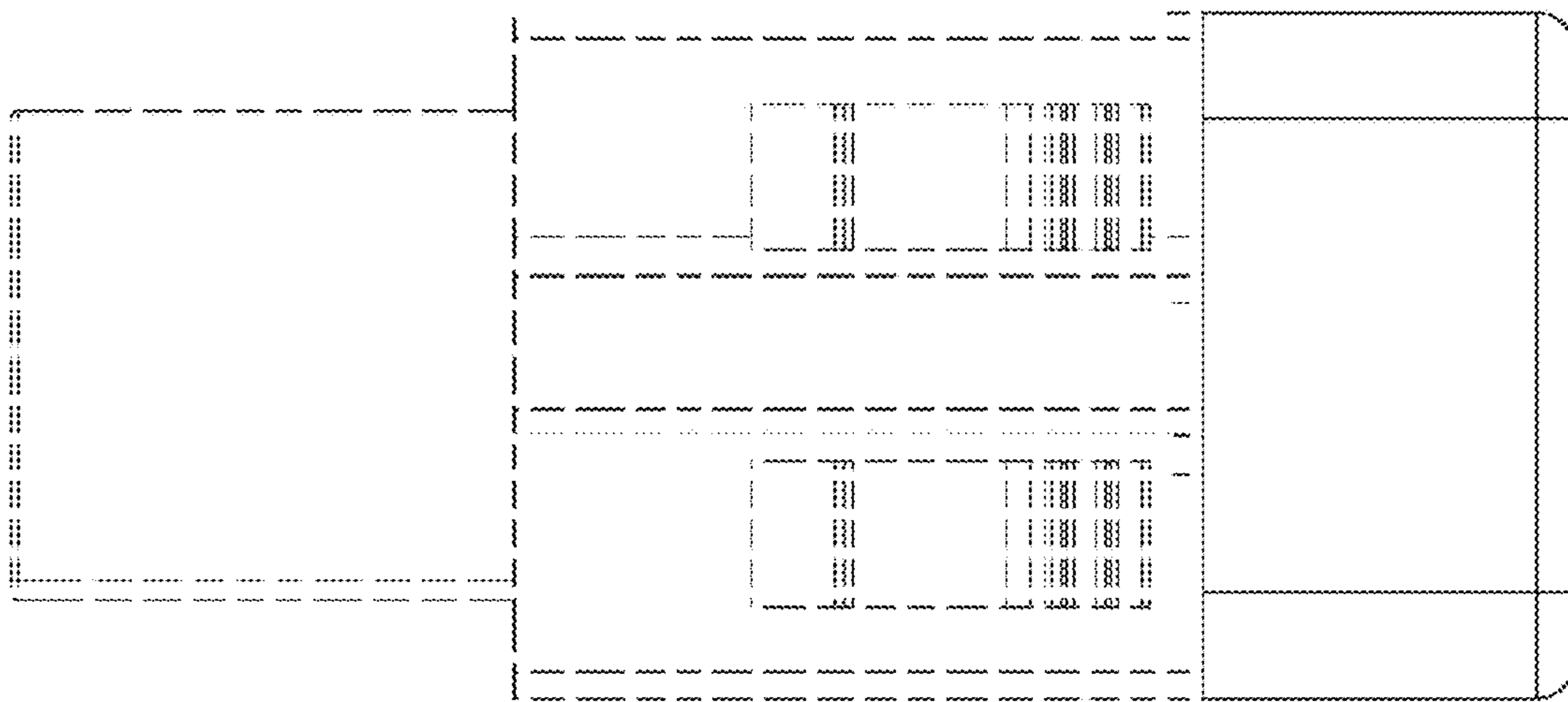

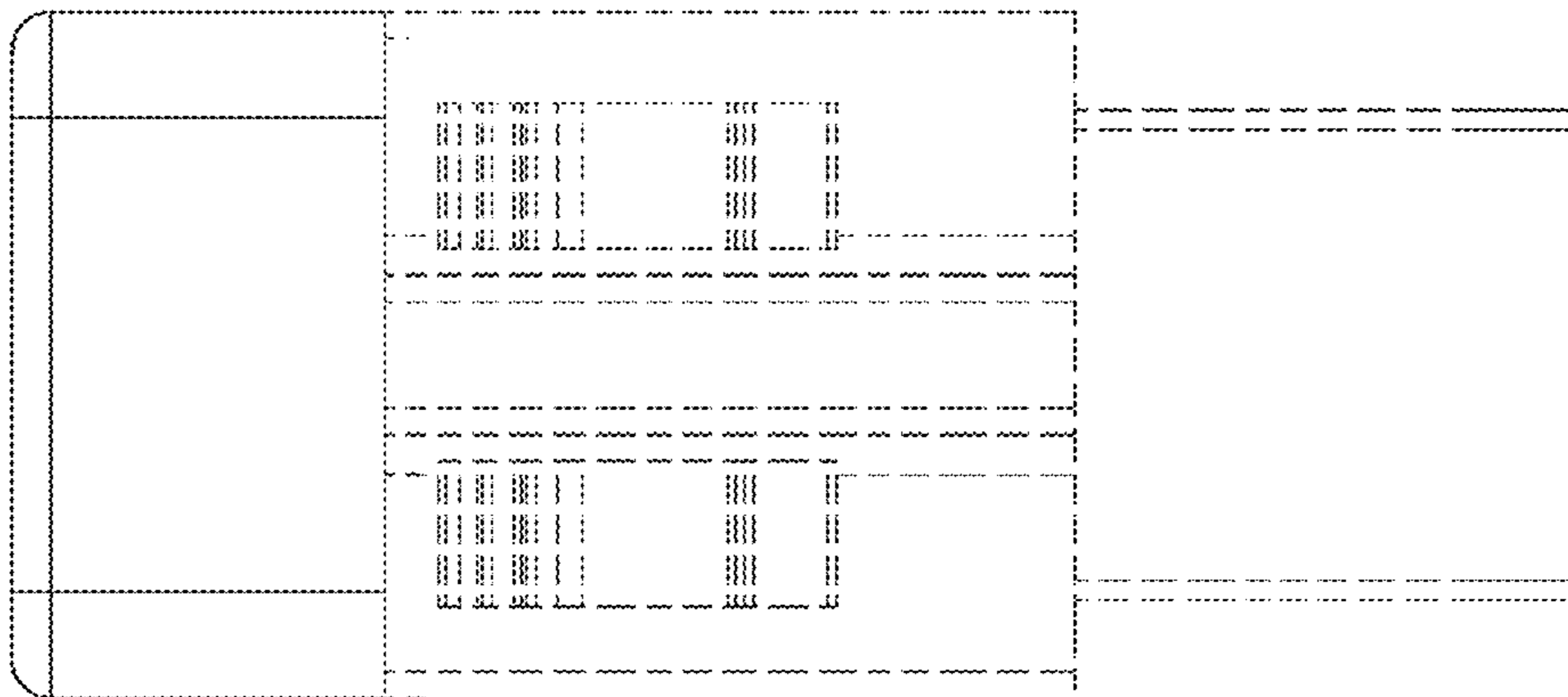
