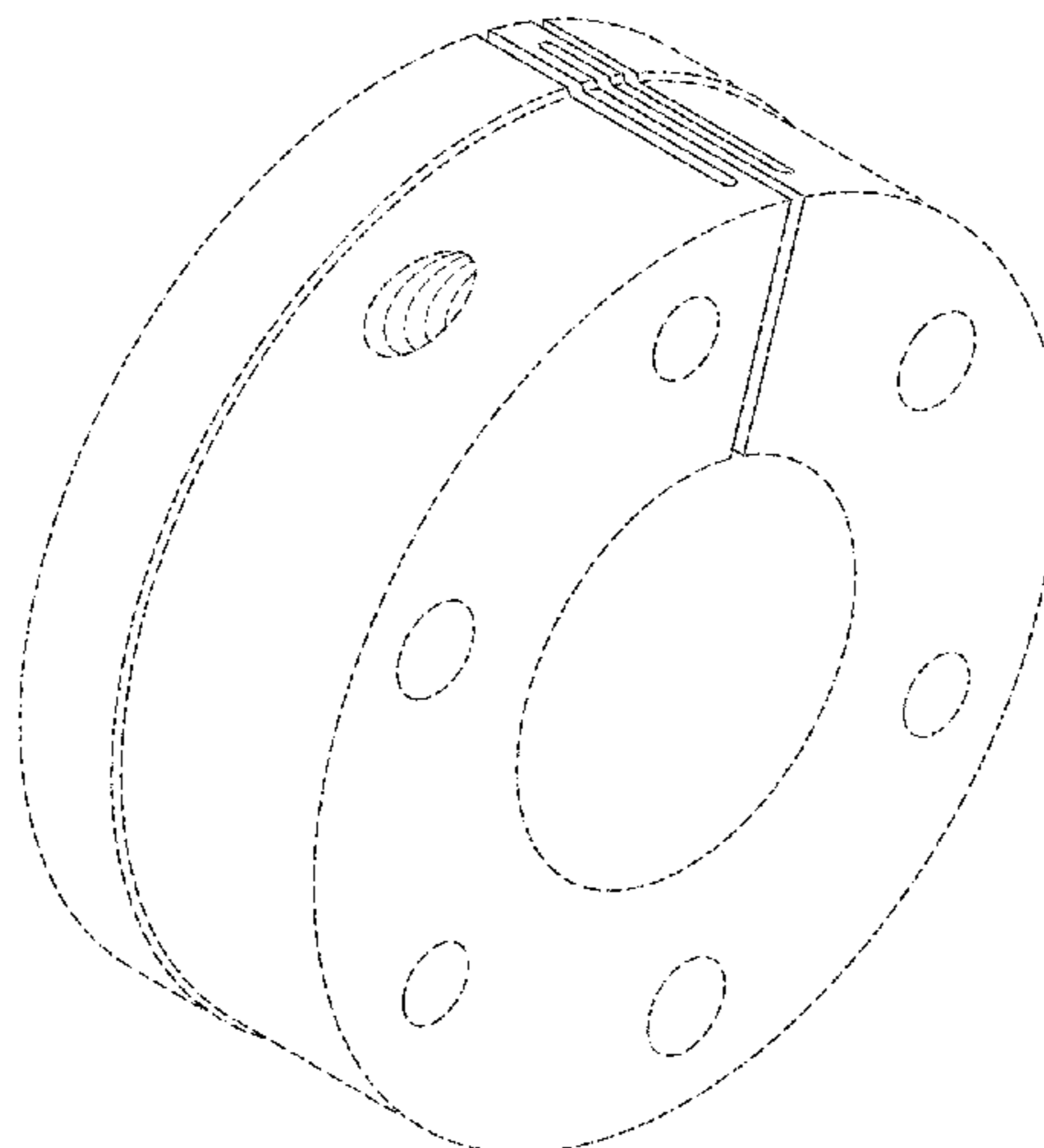
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left front perspective view of a shaft coupling hub;

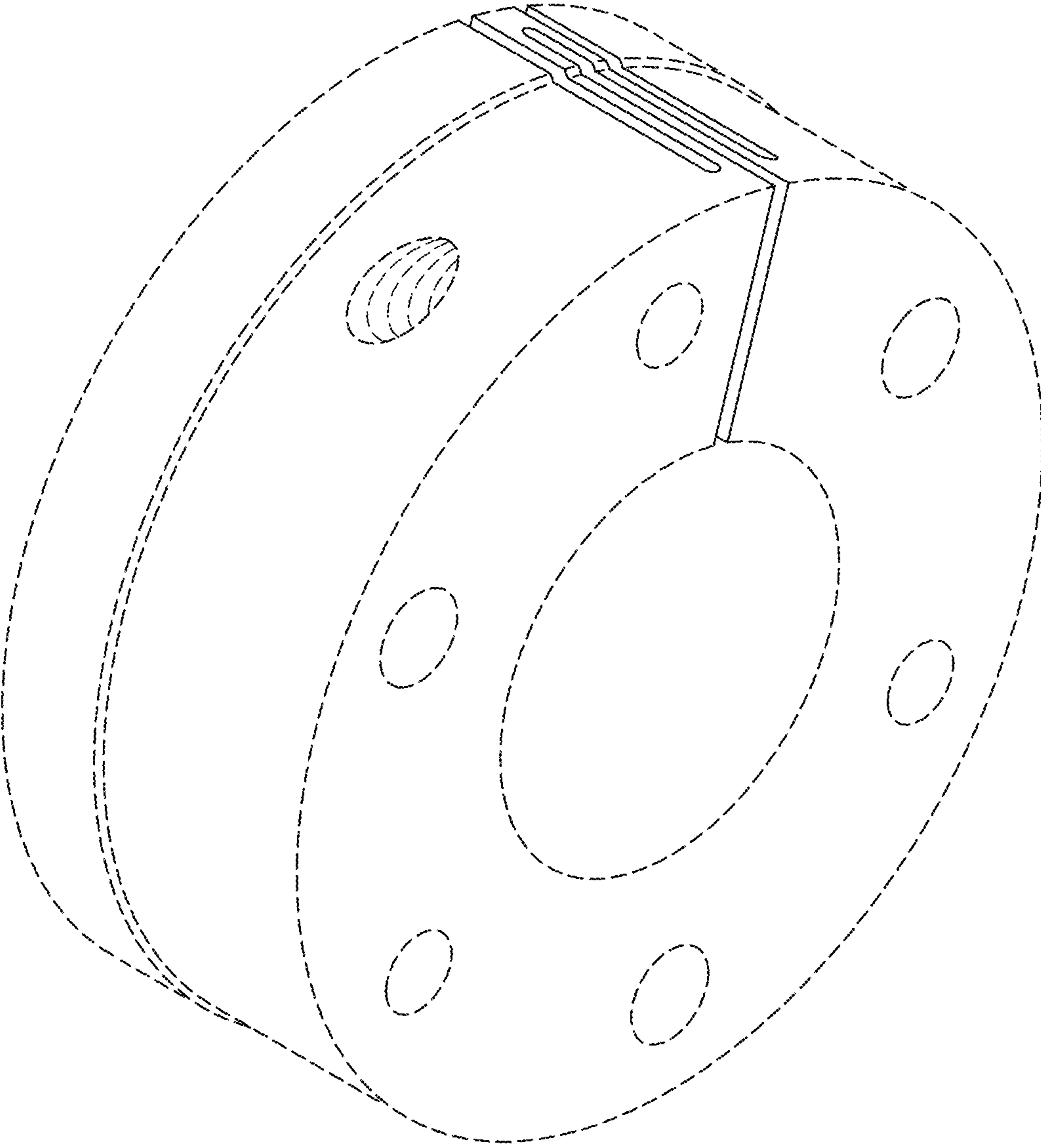

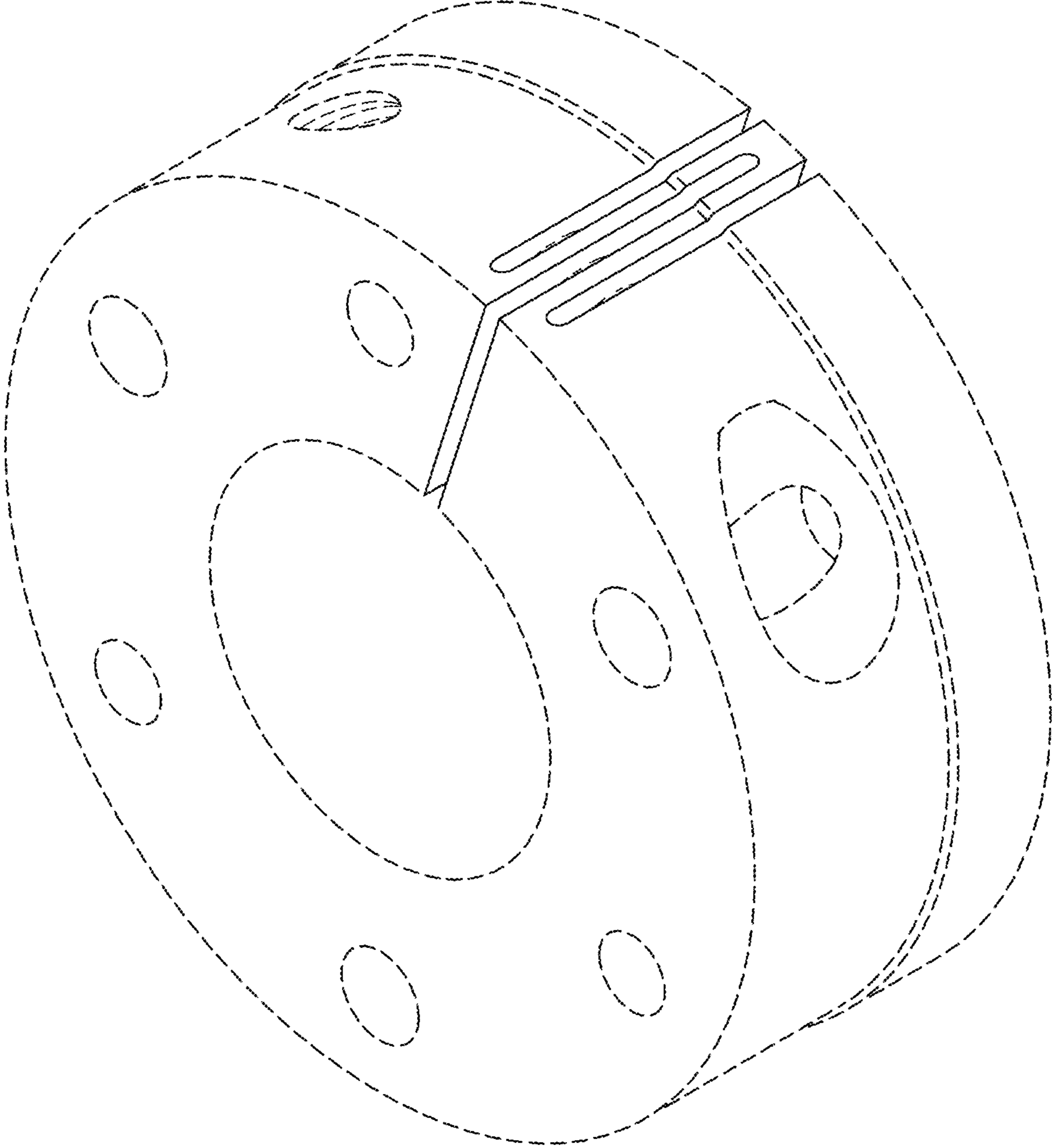

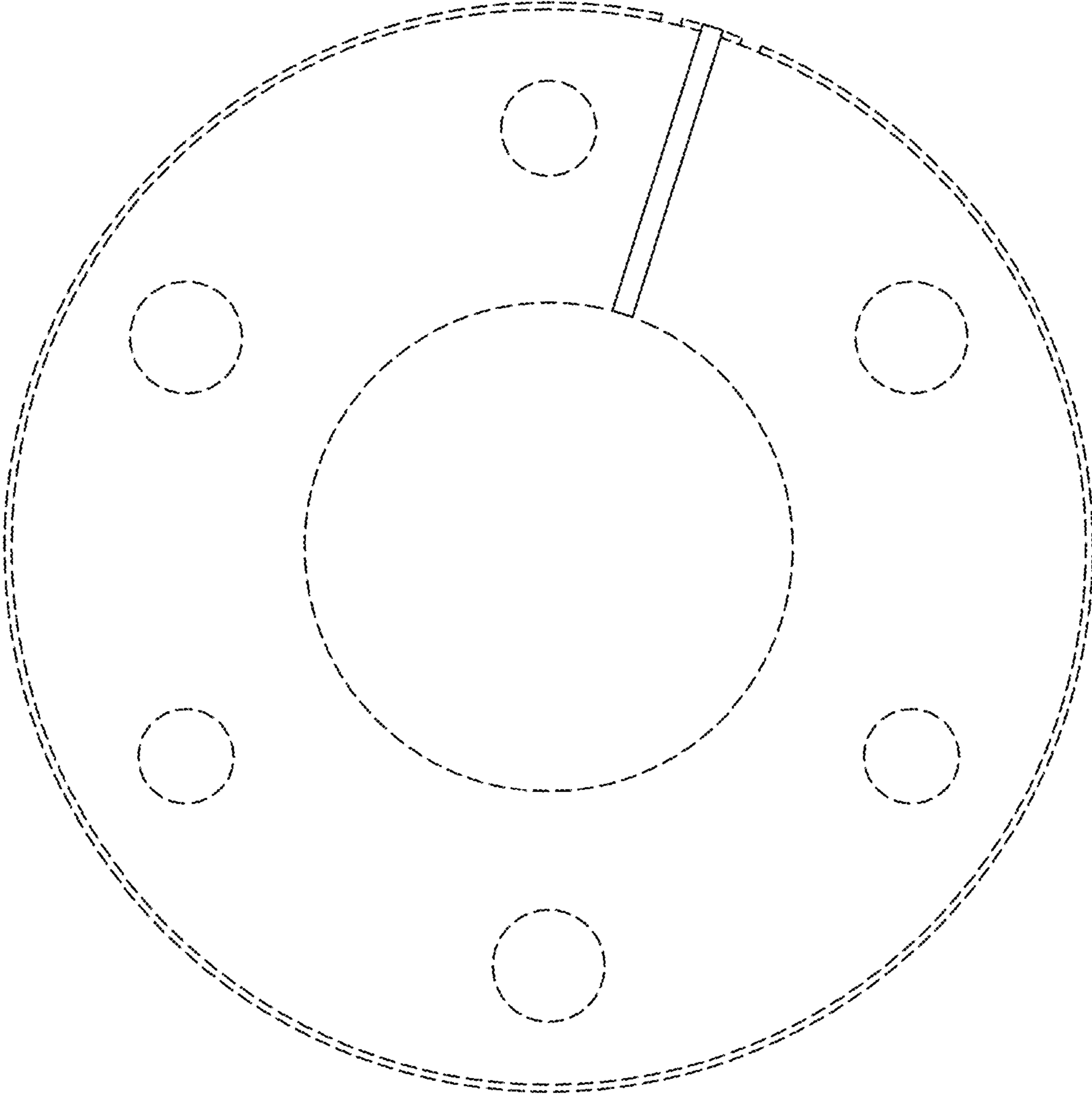

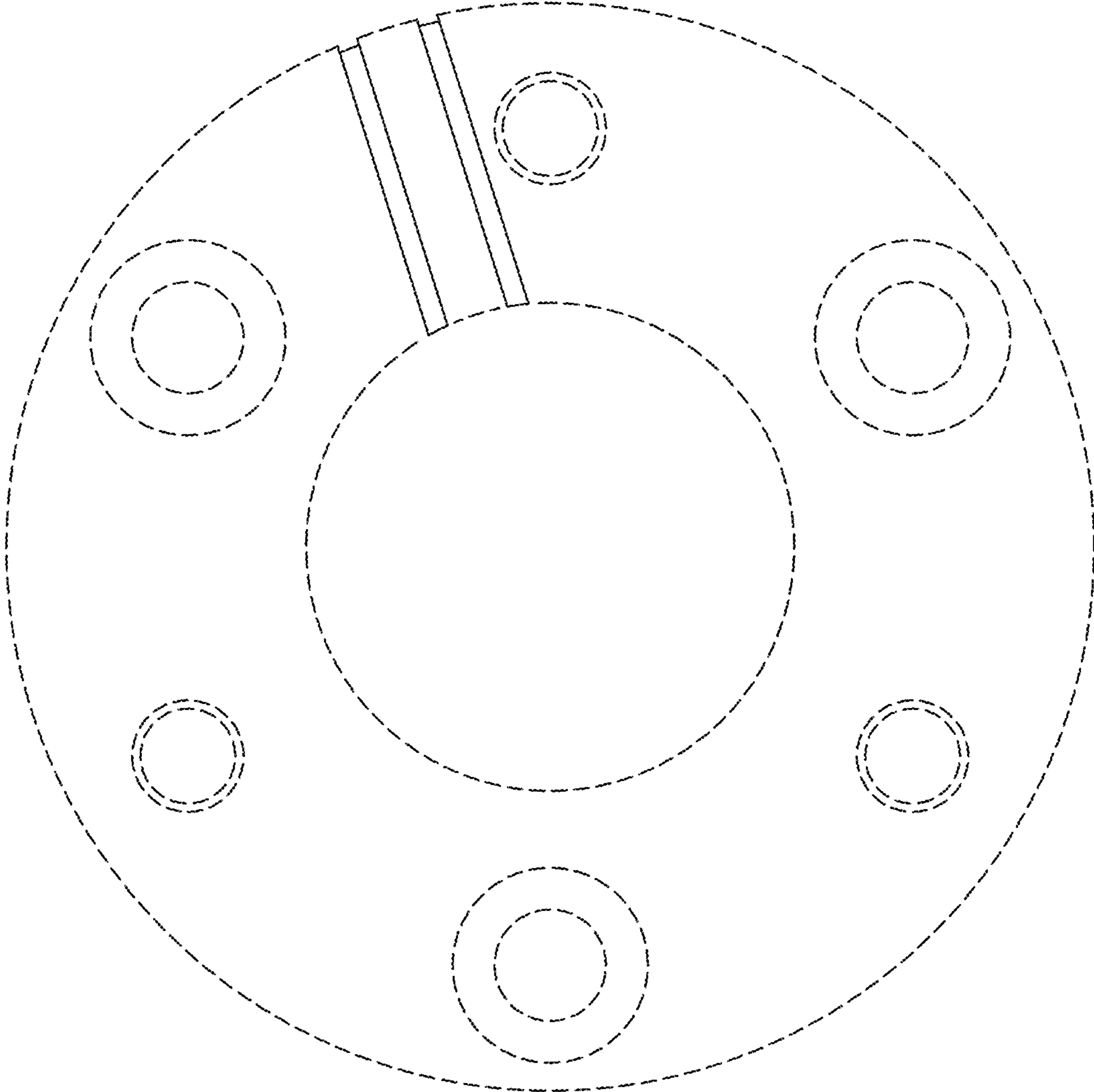

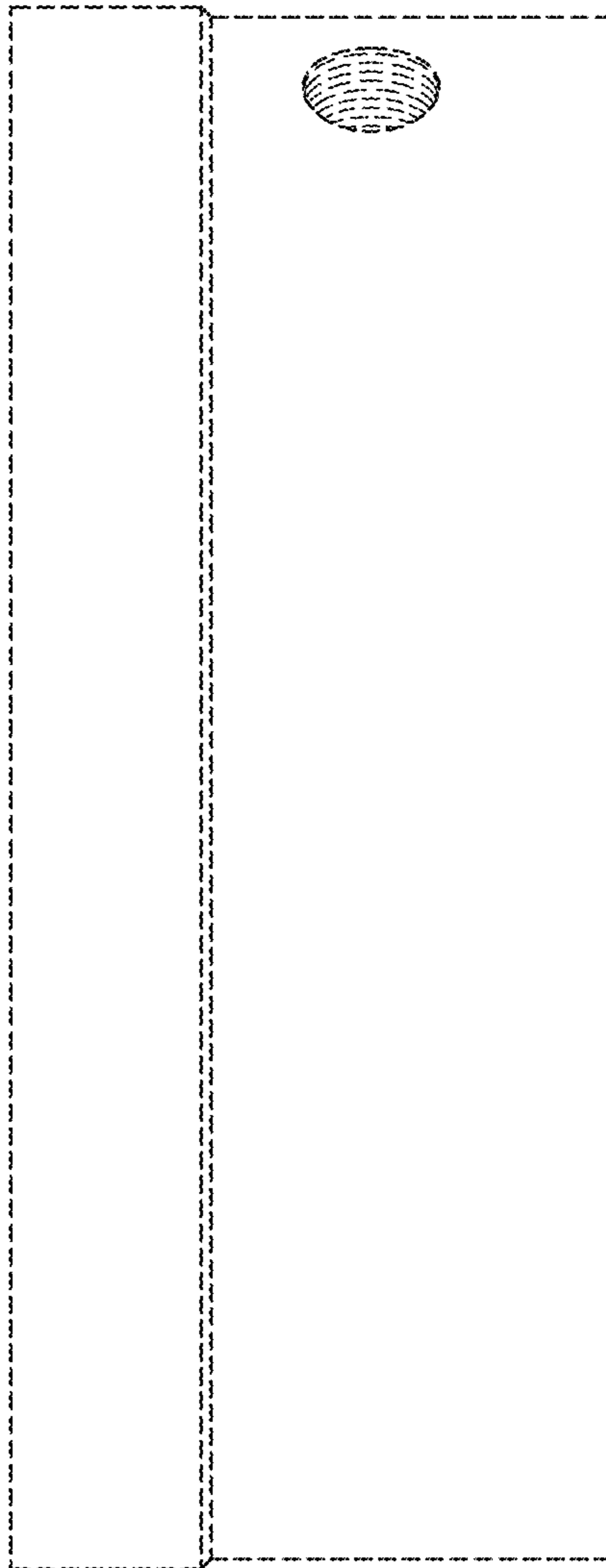

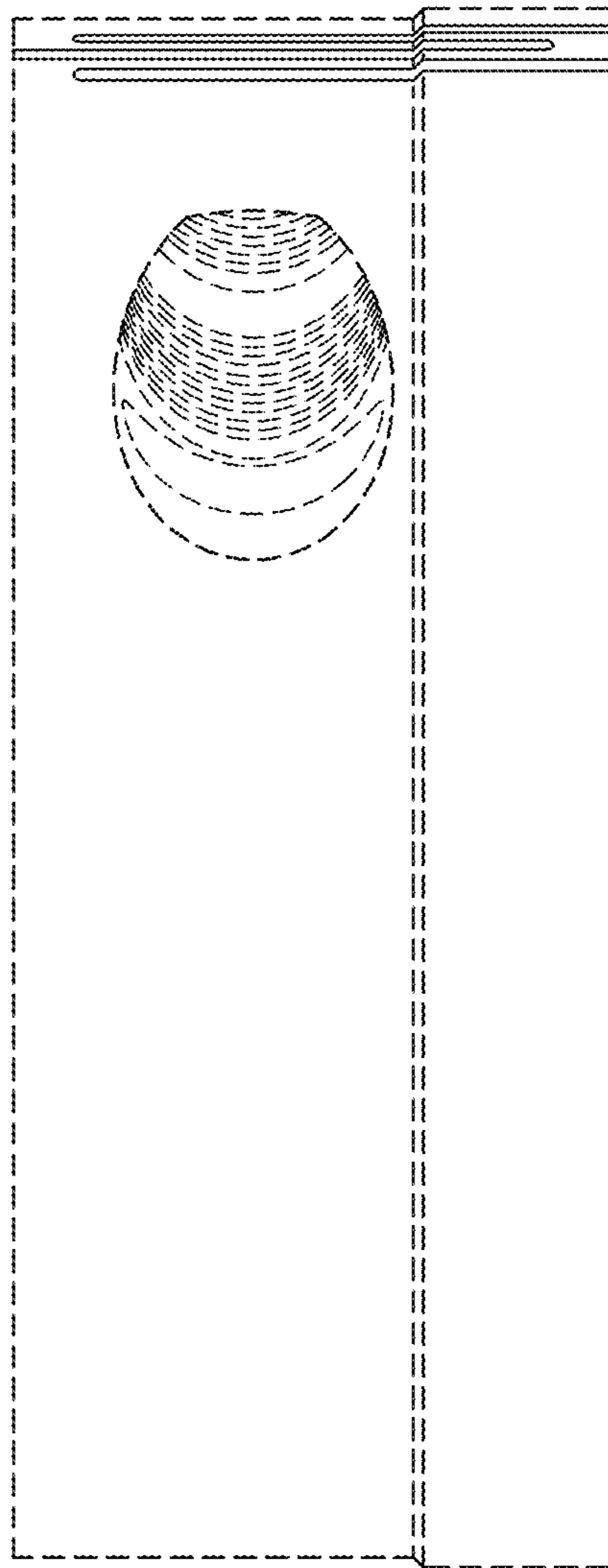

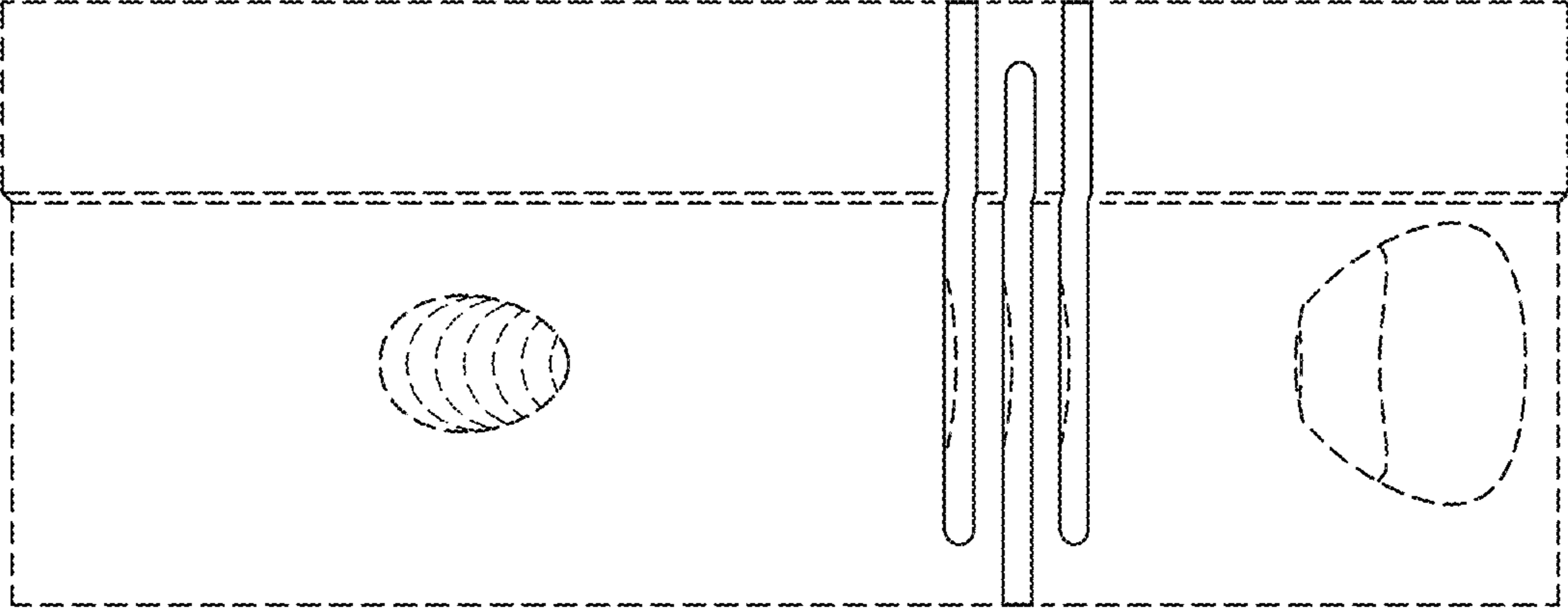

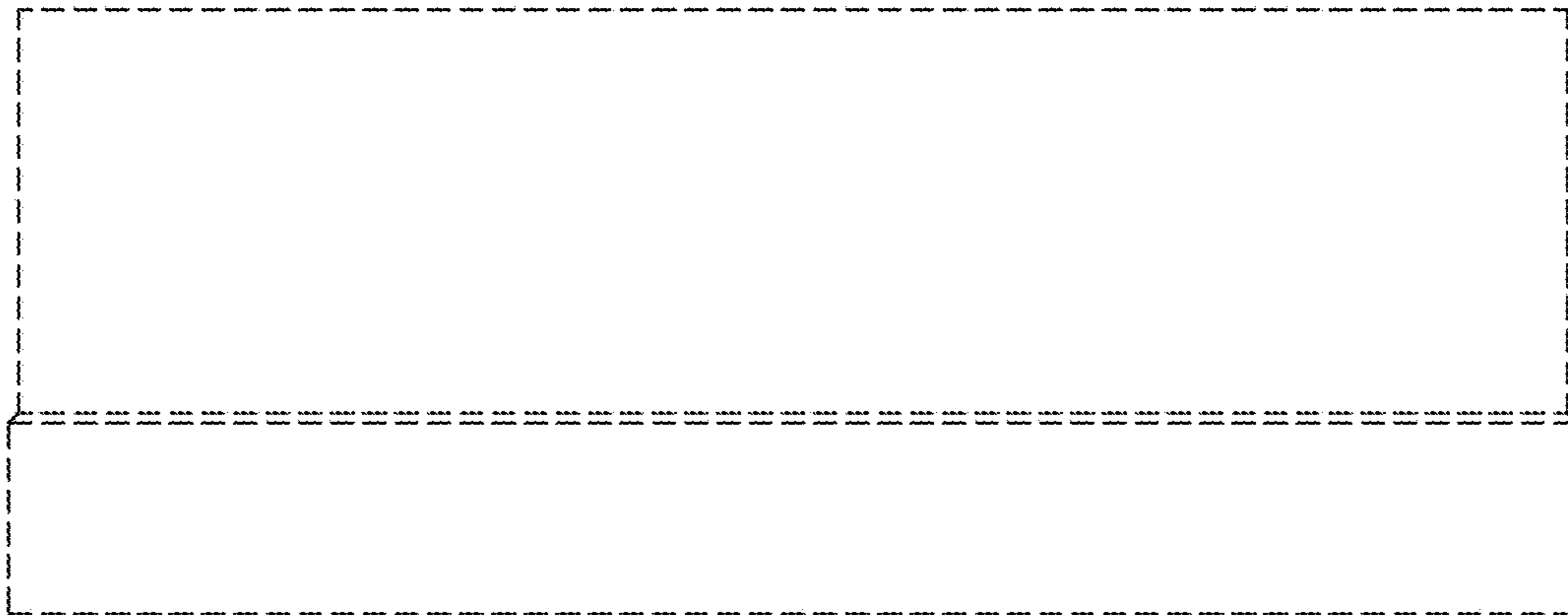
