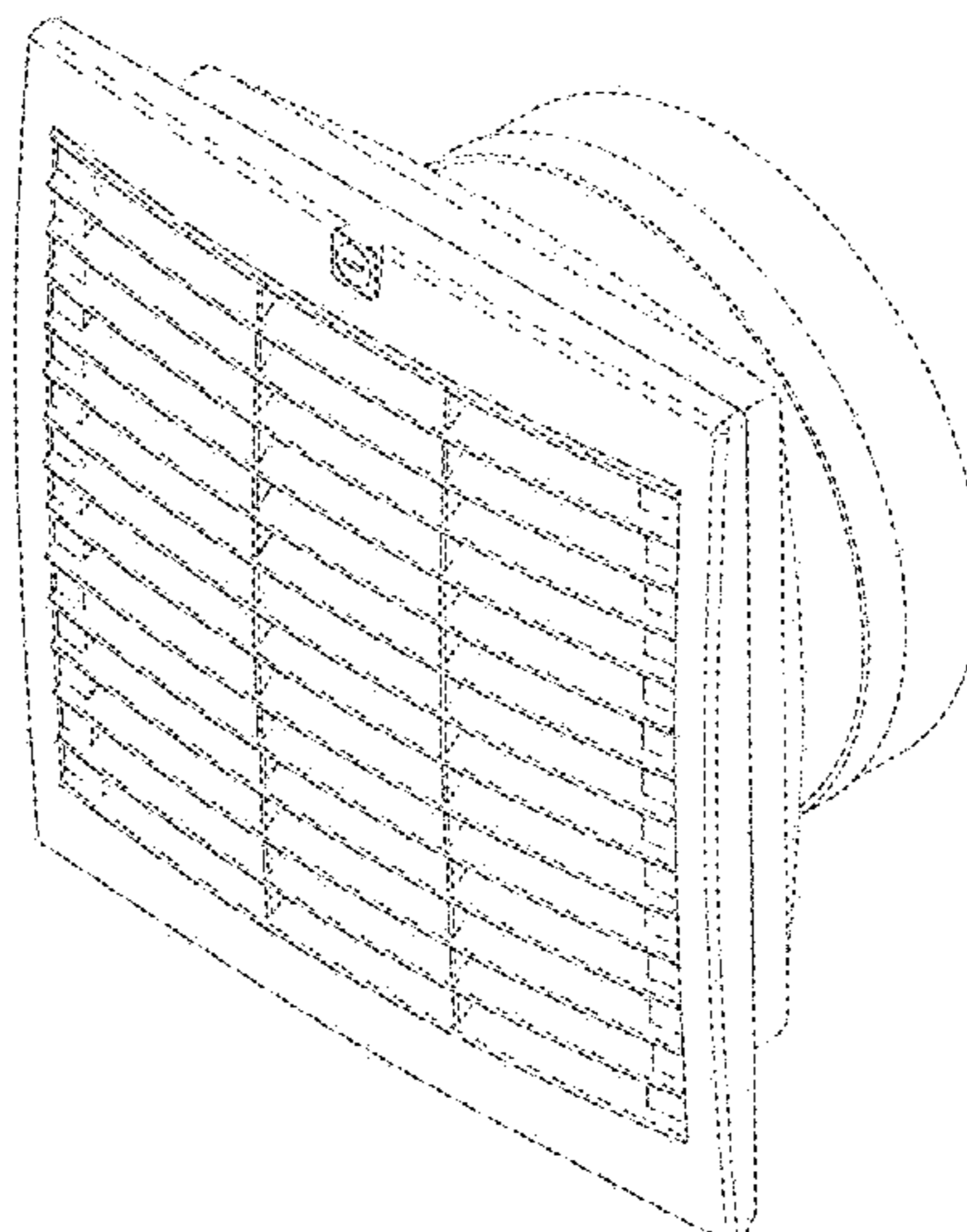
(57) **CLAIM**

The ornamental design for a fan, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a fan in accordance with the present invention;  
FIG. 2 is a front elevational view of the fan of FIG. 1;  
FIG. 3 is a rear elevational view of the fan of FIG. 1;  
FIG. 4 is a side elevational view of a first side of the fan of FIG. 1;  
FIG. 5 is a side elevational view of a second side of the fan of FIG. 1;  
FIG. 6 is a top plan view of the fan of FIG. 1; and  
FIG. 7 is a bottom plan view of the fan of FIG. 1.  
The claim is directed to the design shown in solid lines; all surfaces shown between the broken and solid lines form no part of the claimed design.

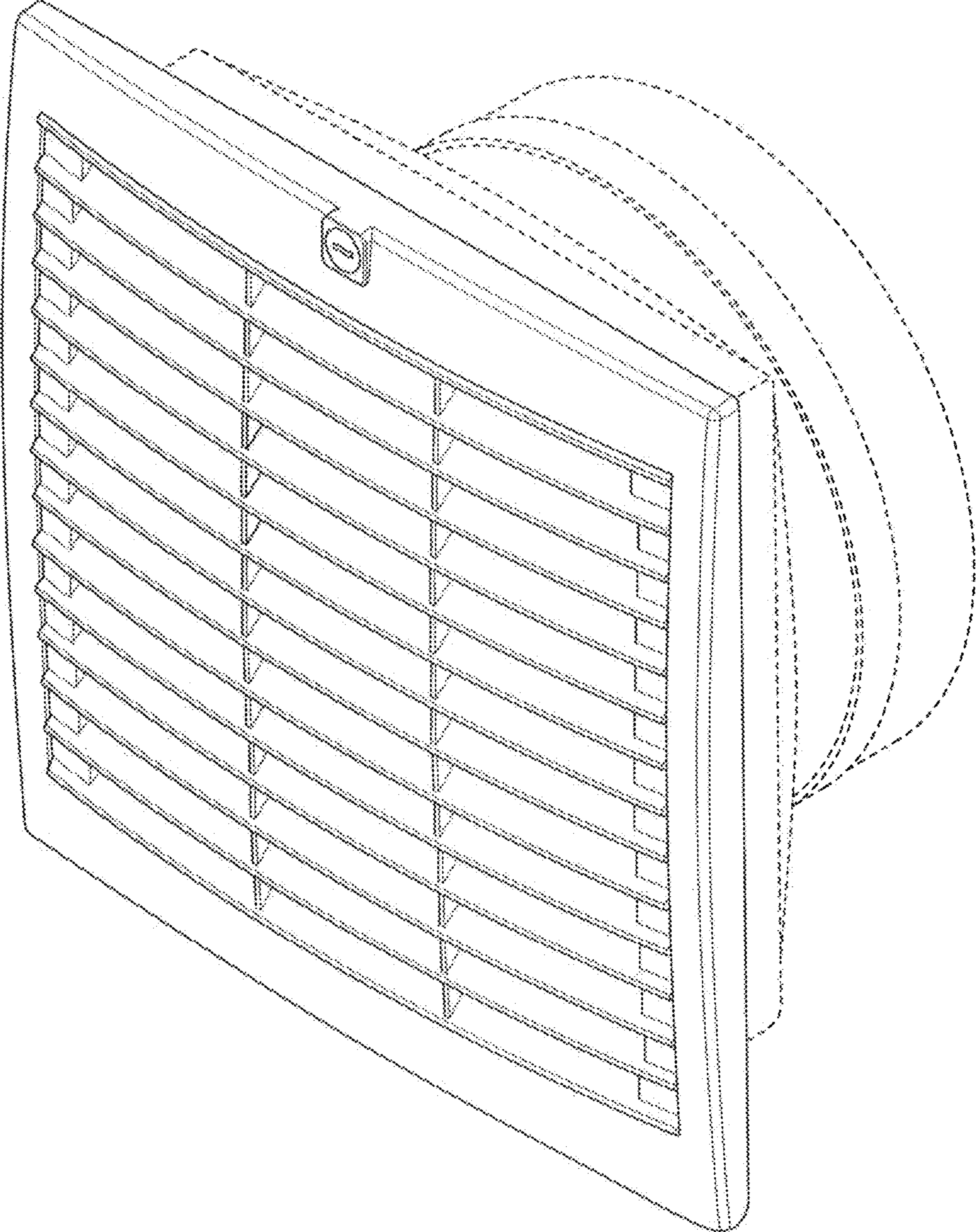

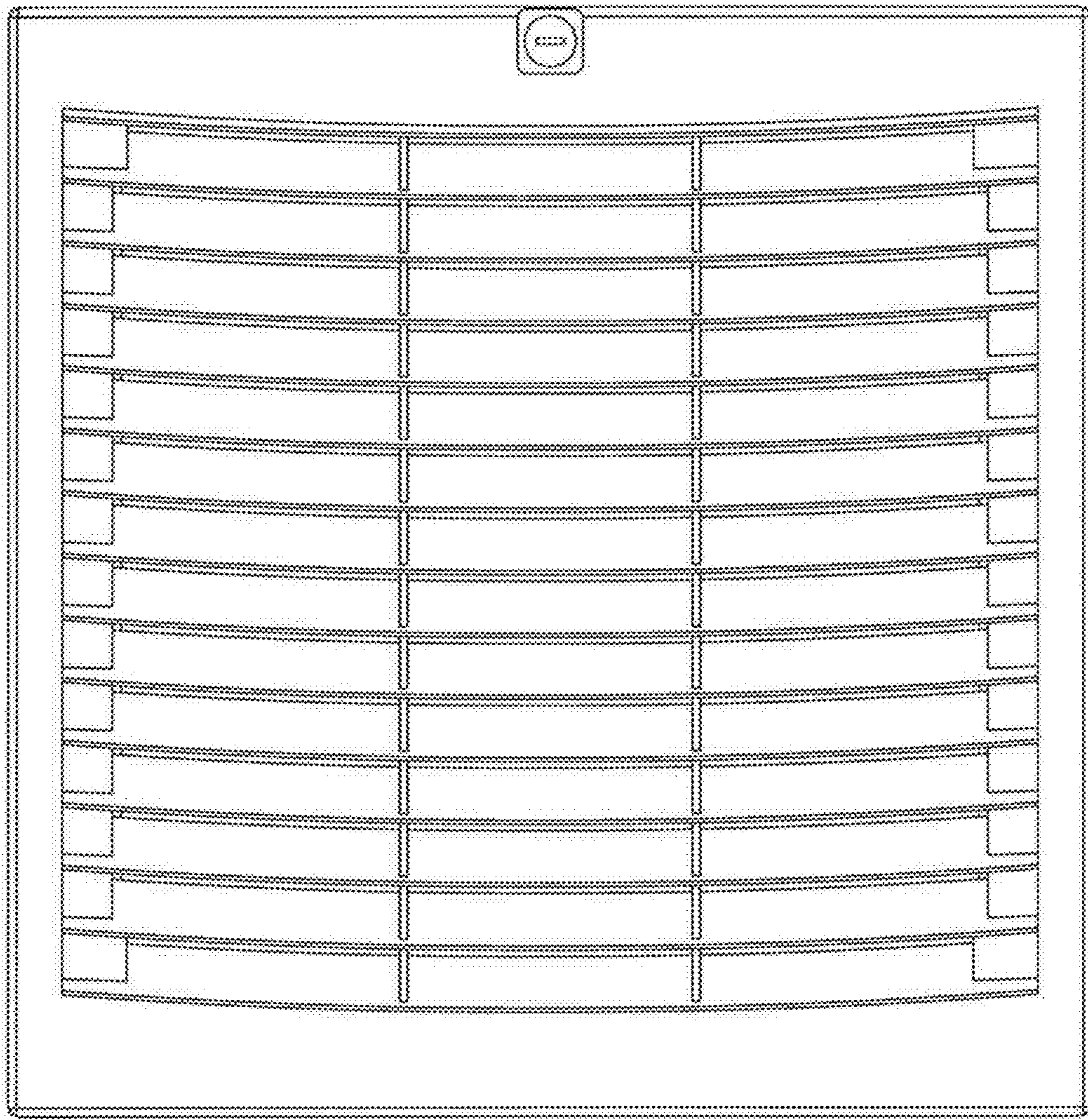

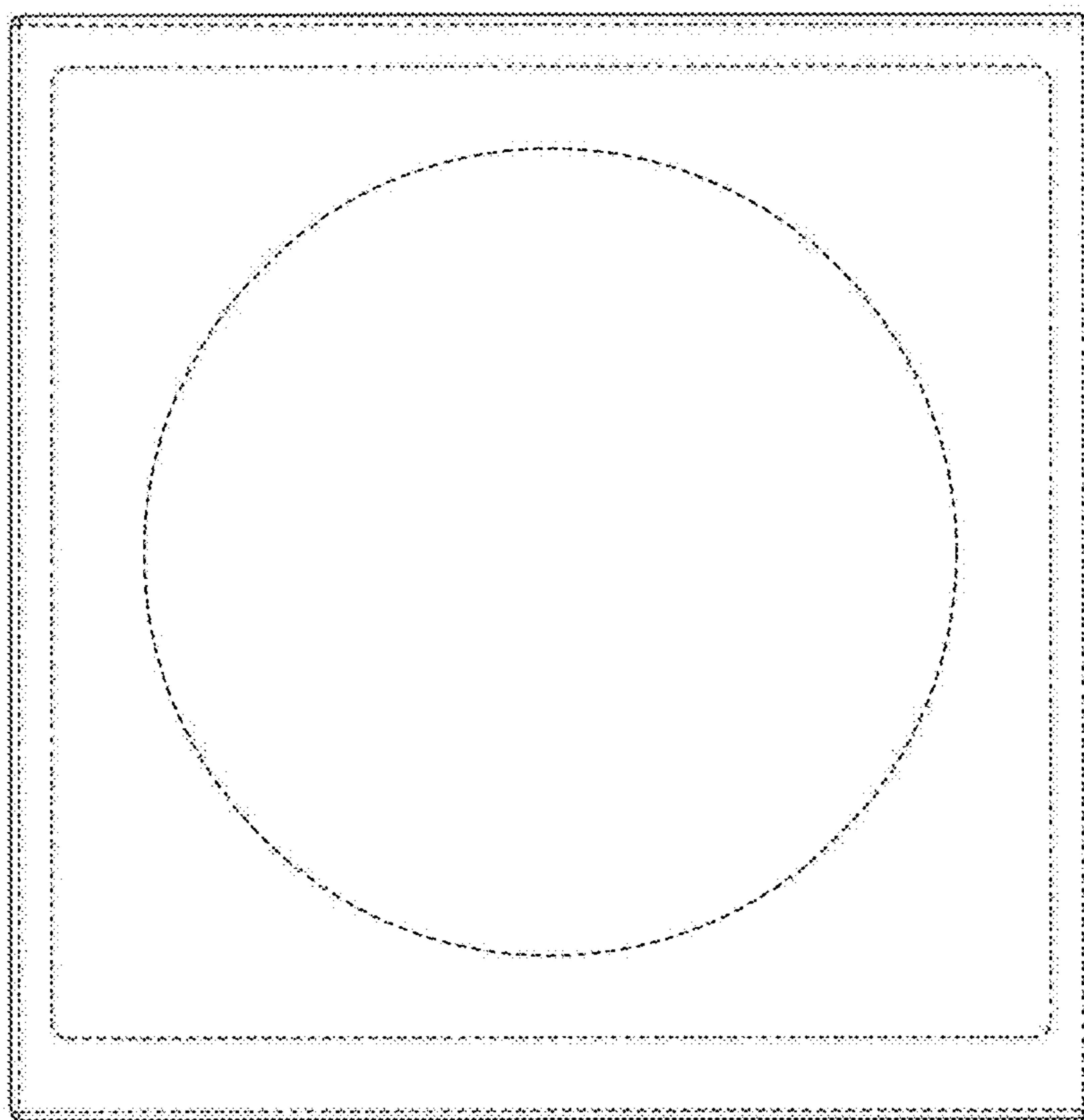

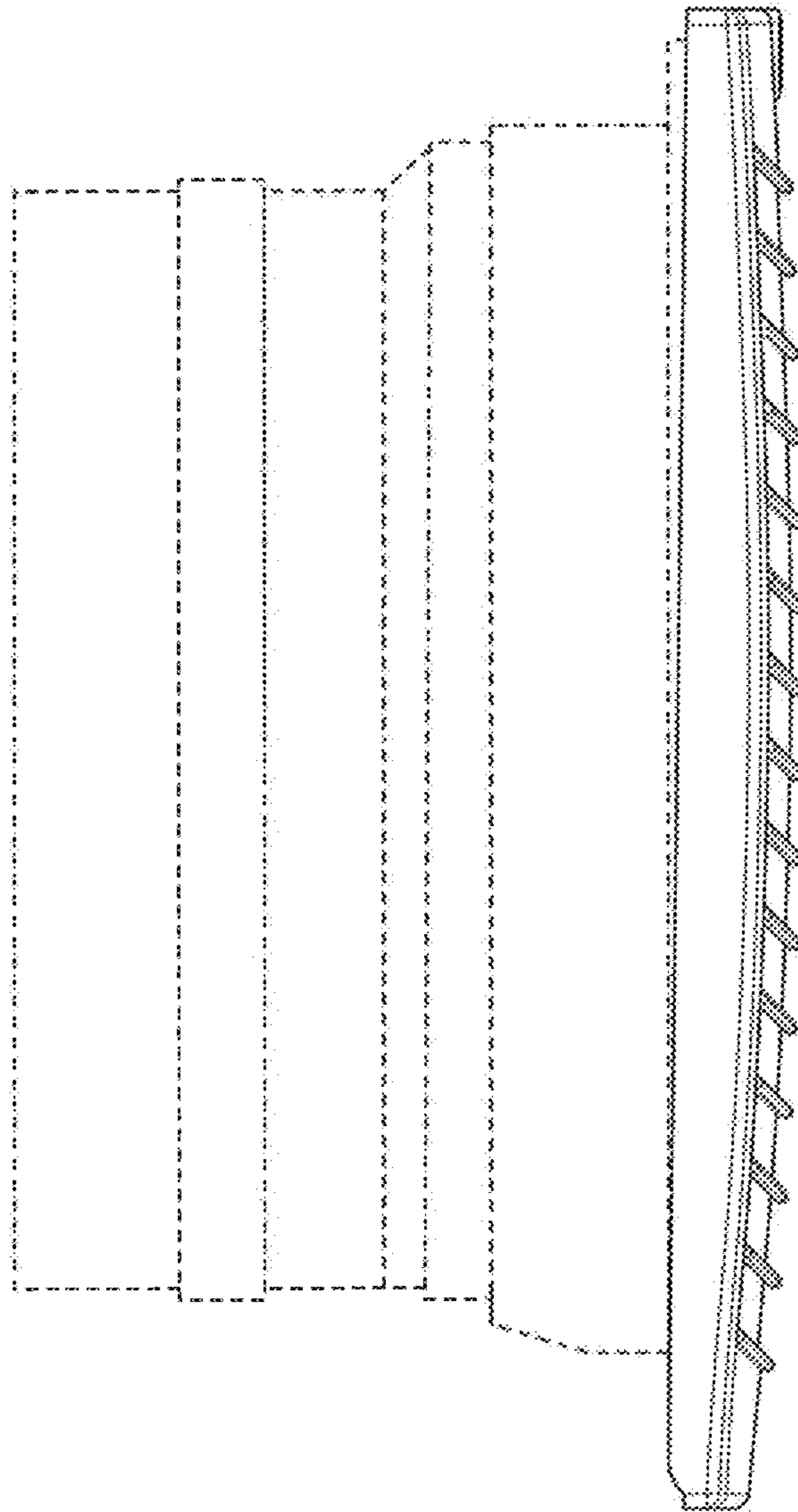

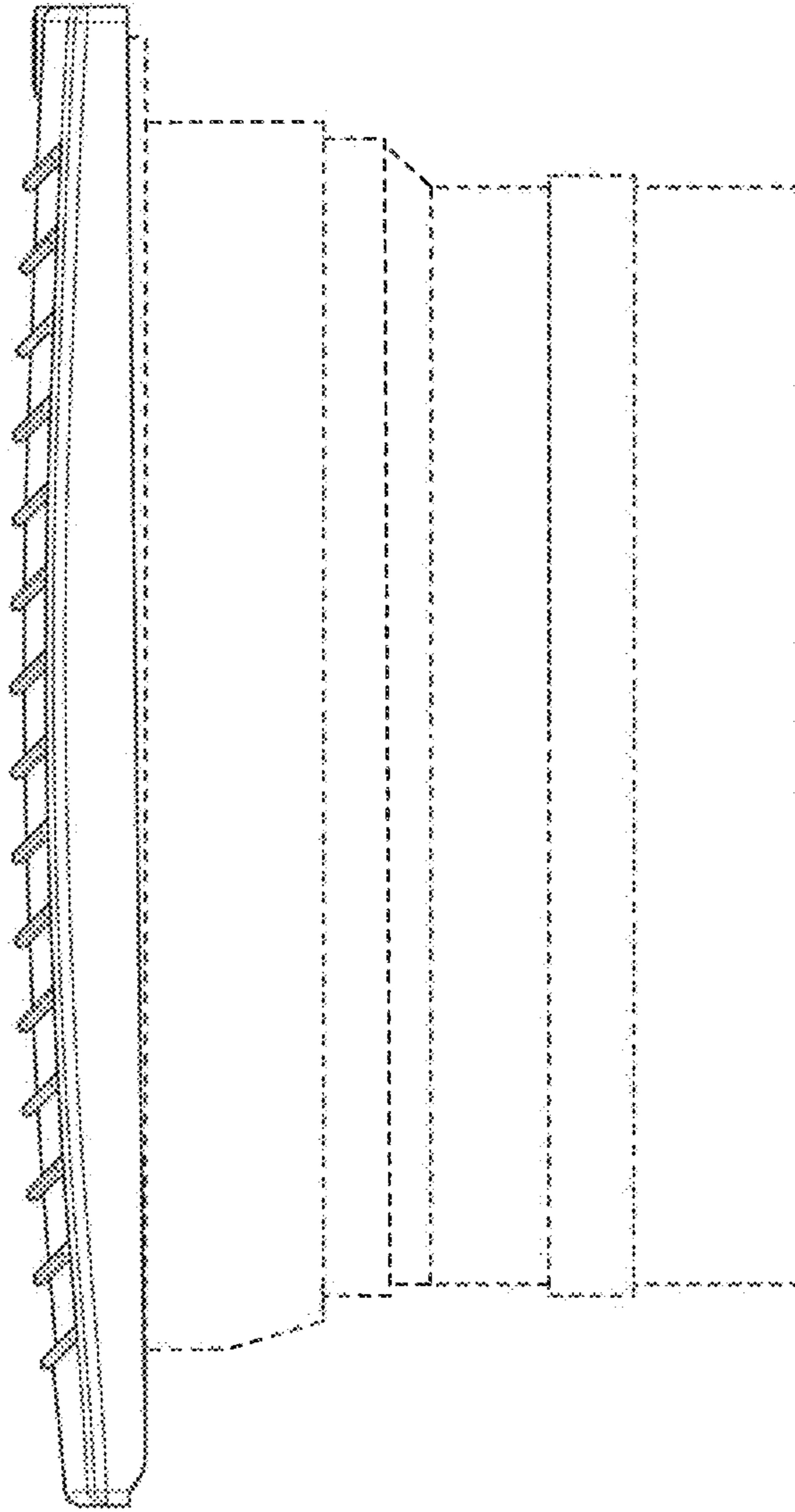

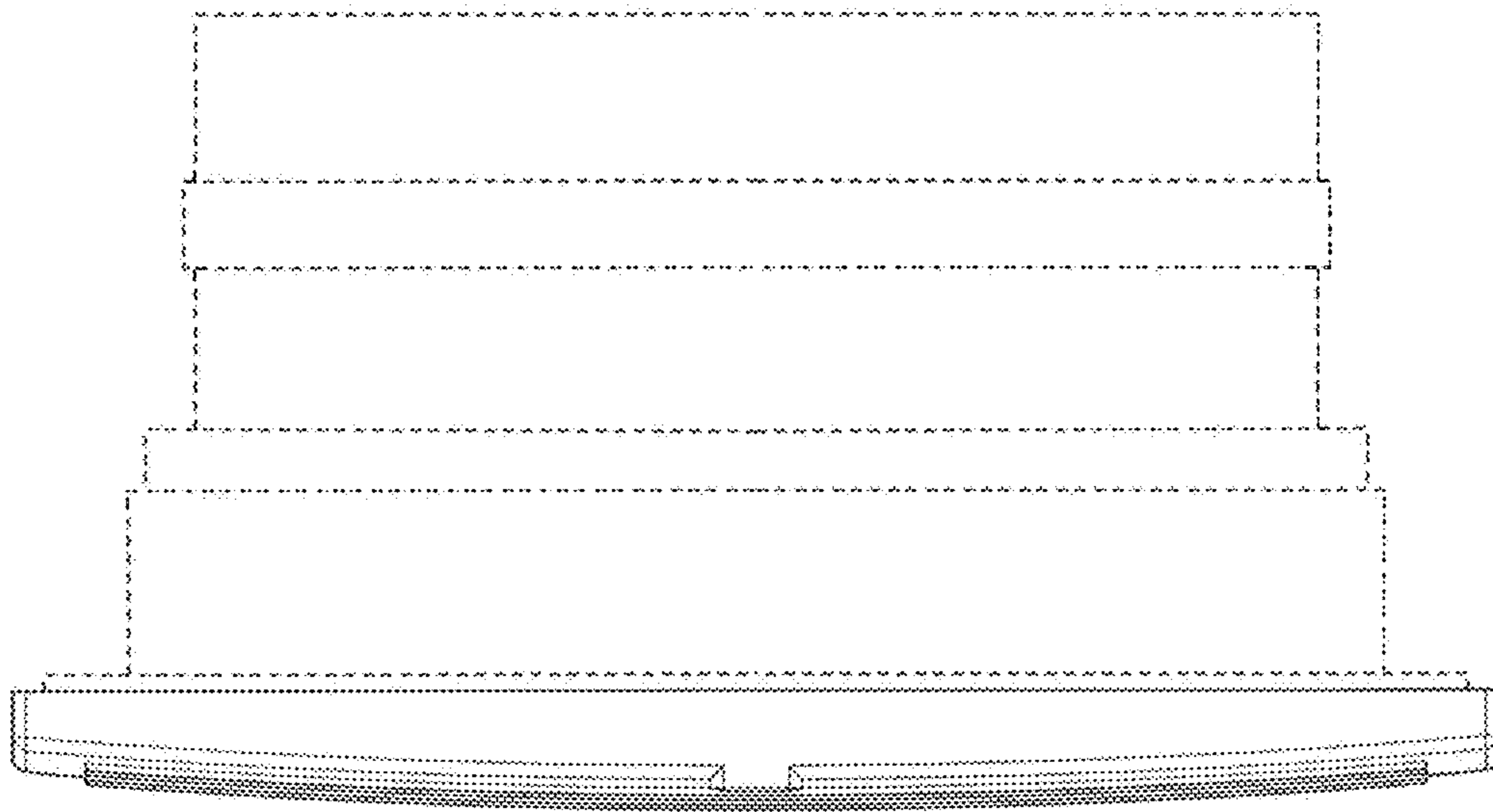

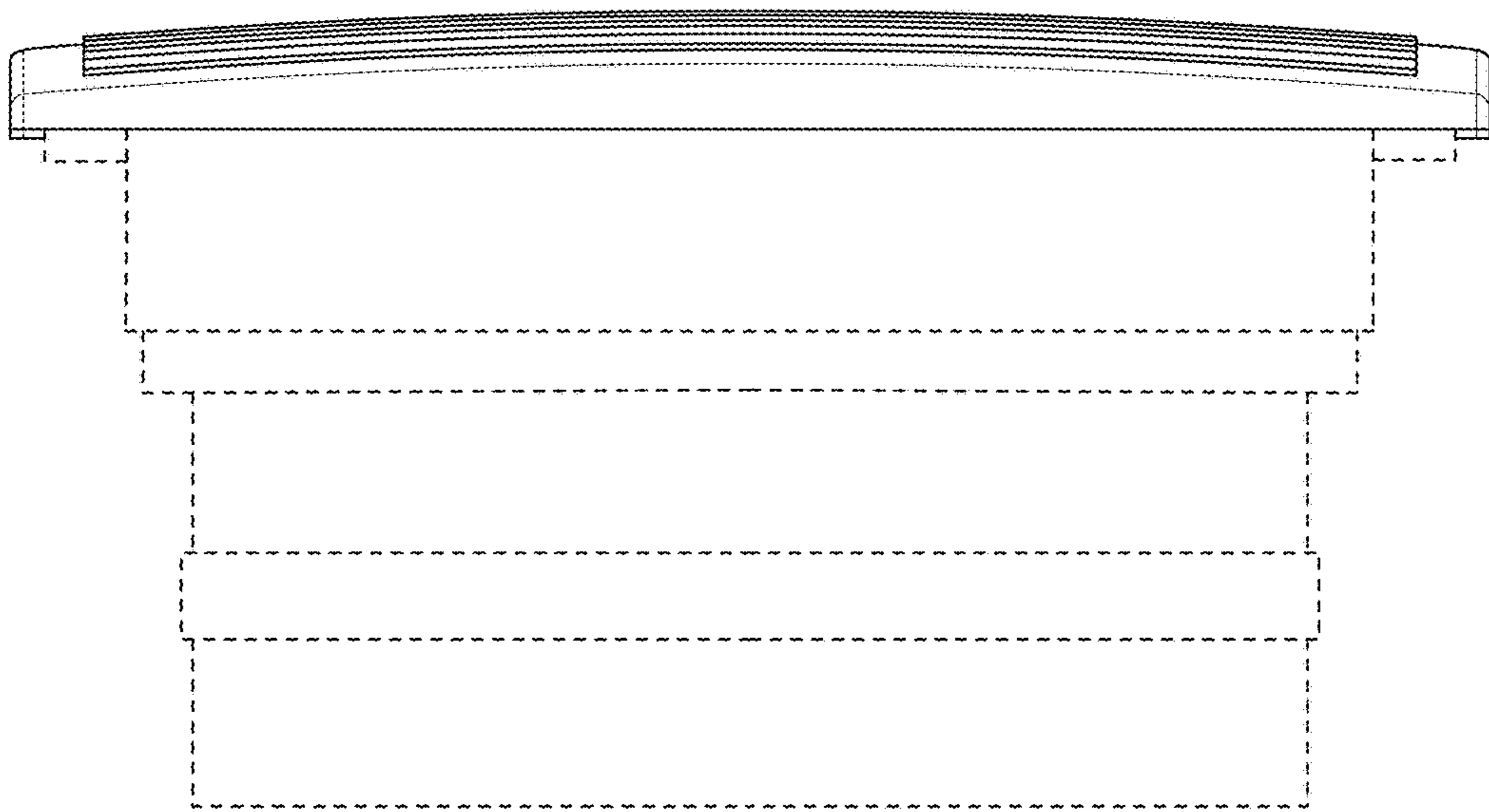
