DESCRIPTION

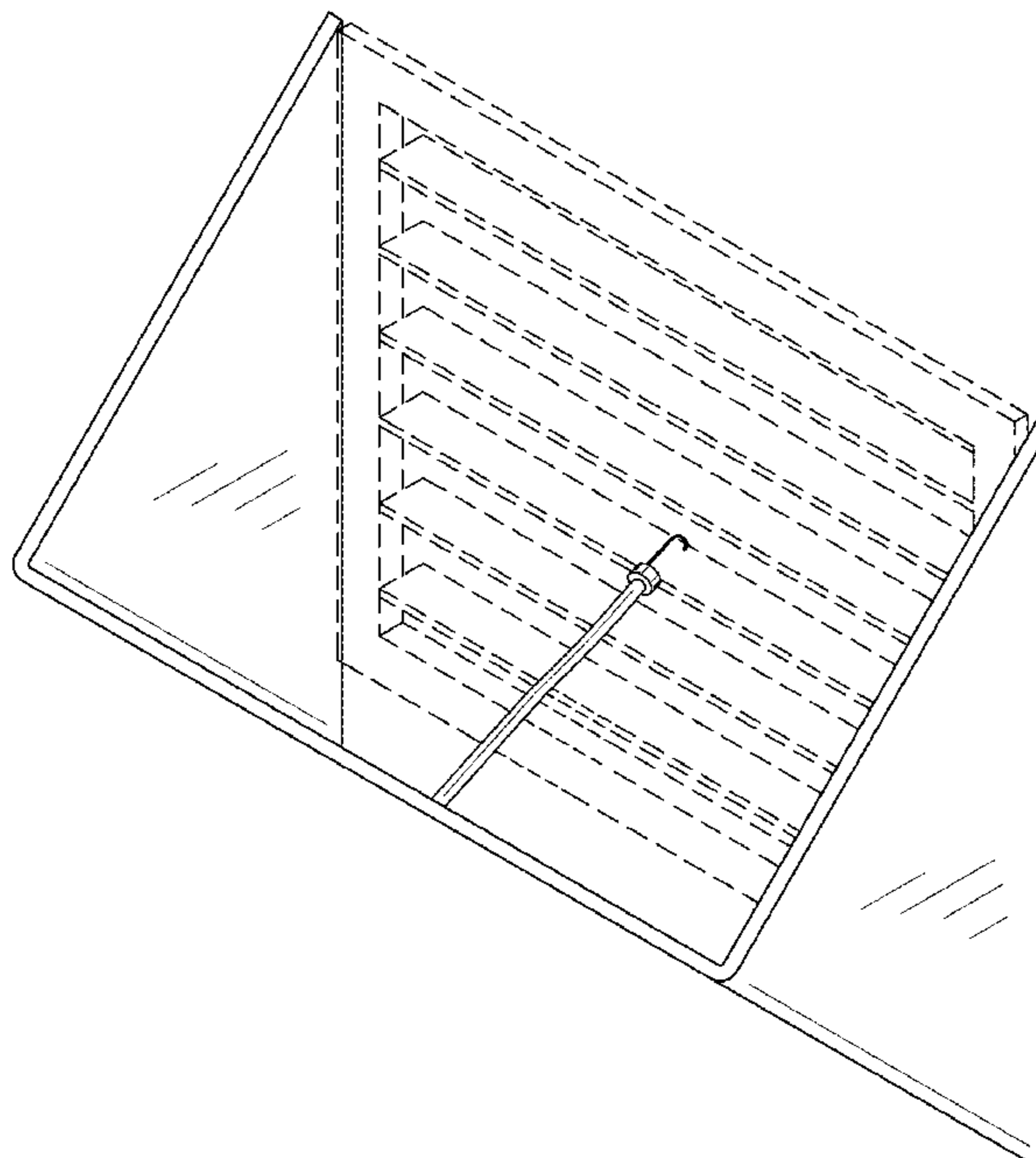
FIG. 1 is a front view of an air flow director showing my new design;

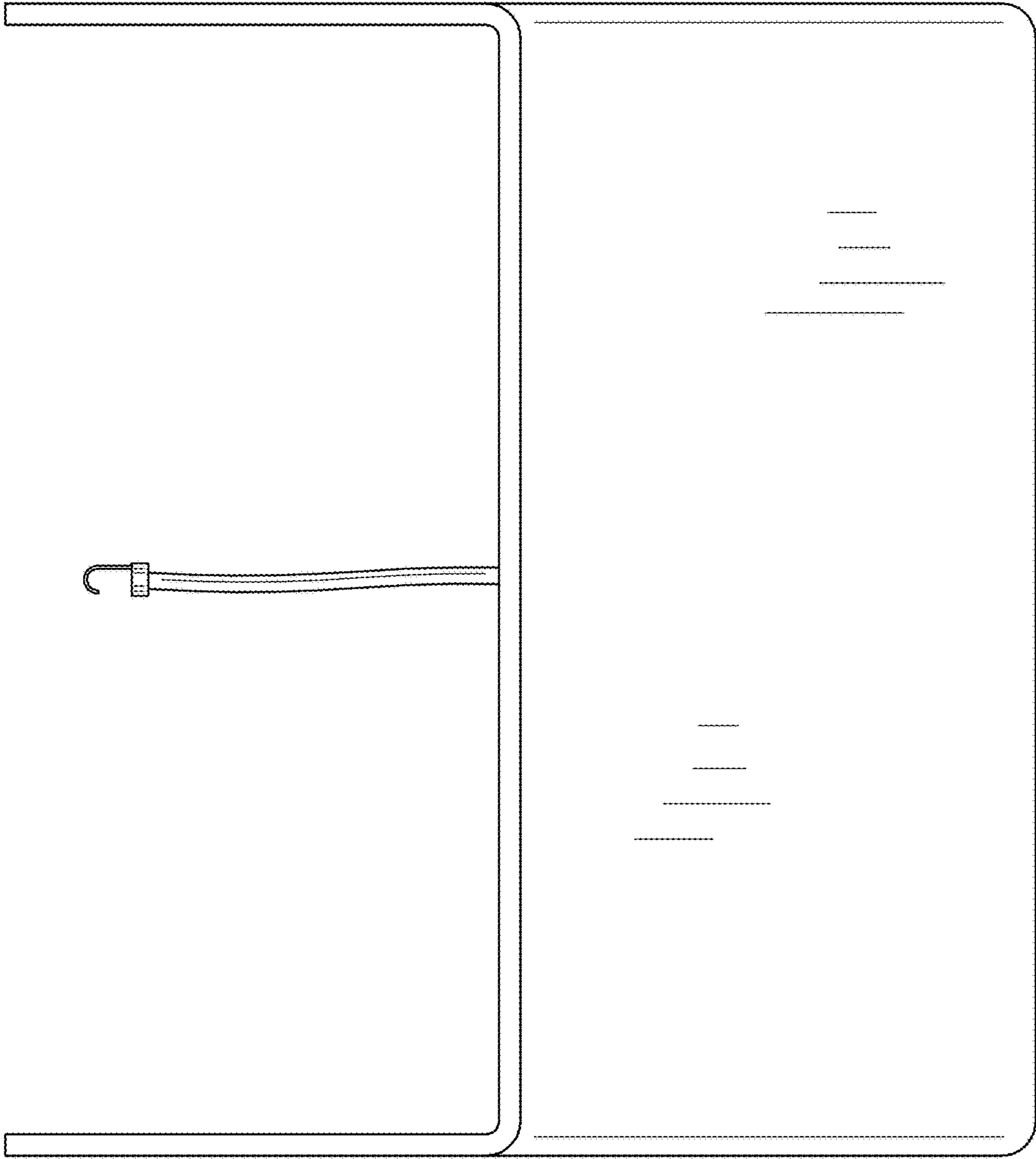

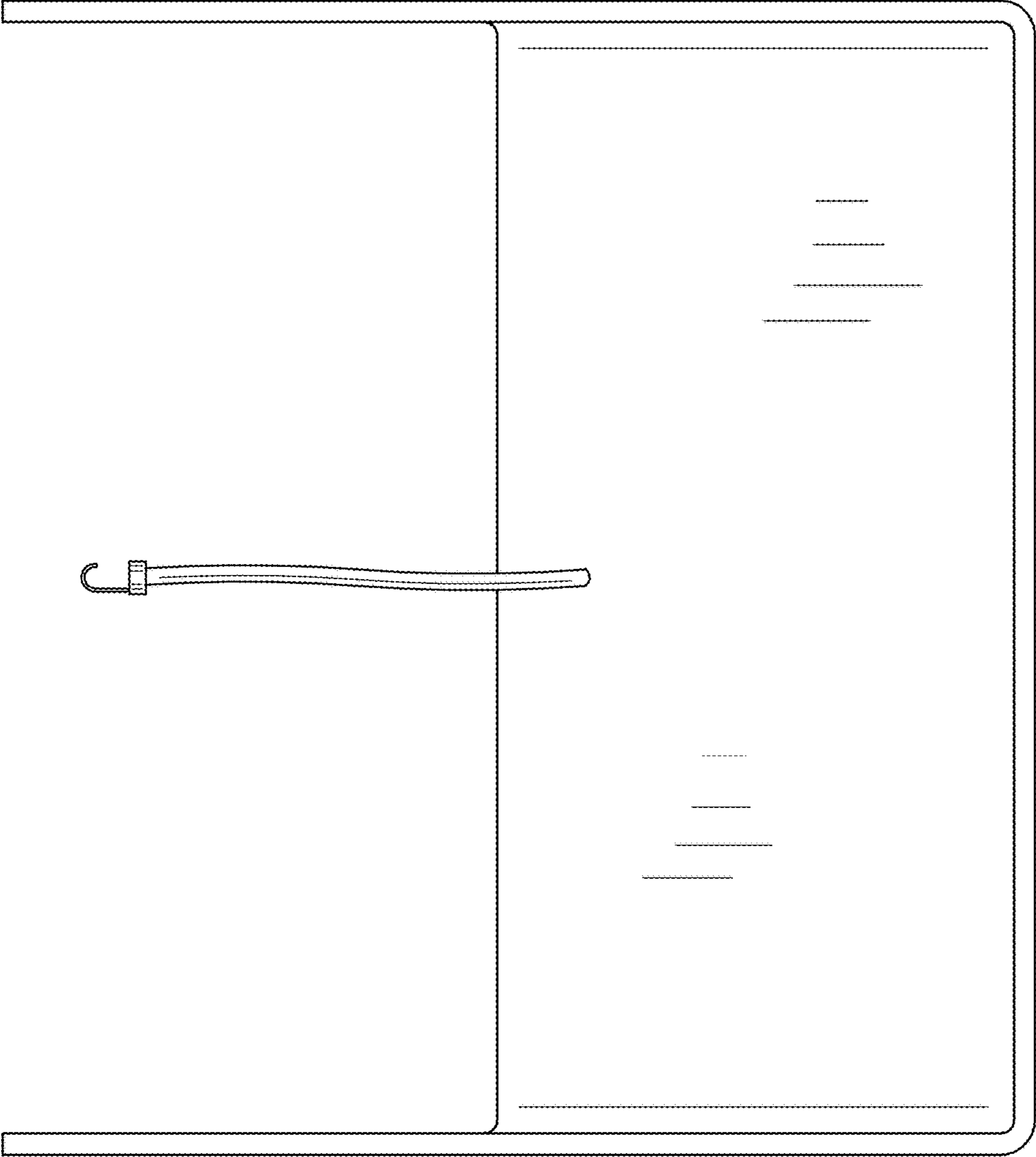

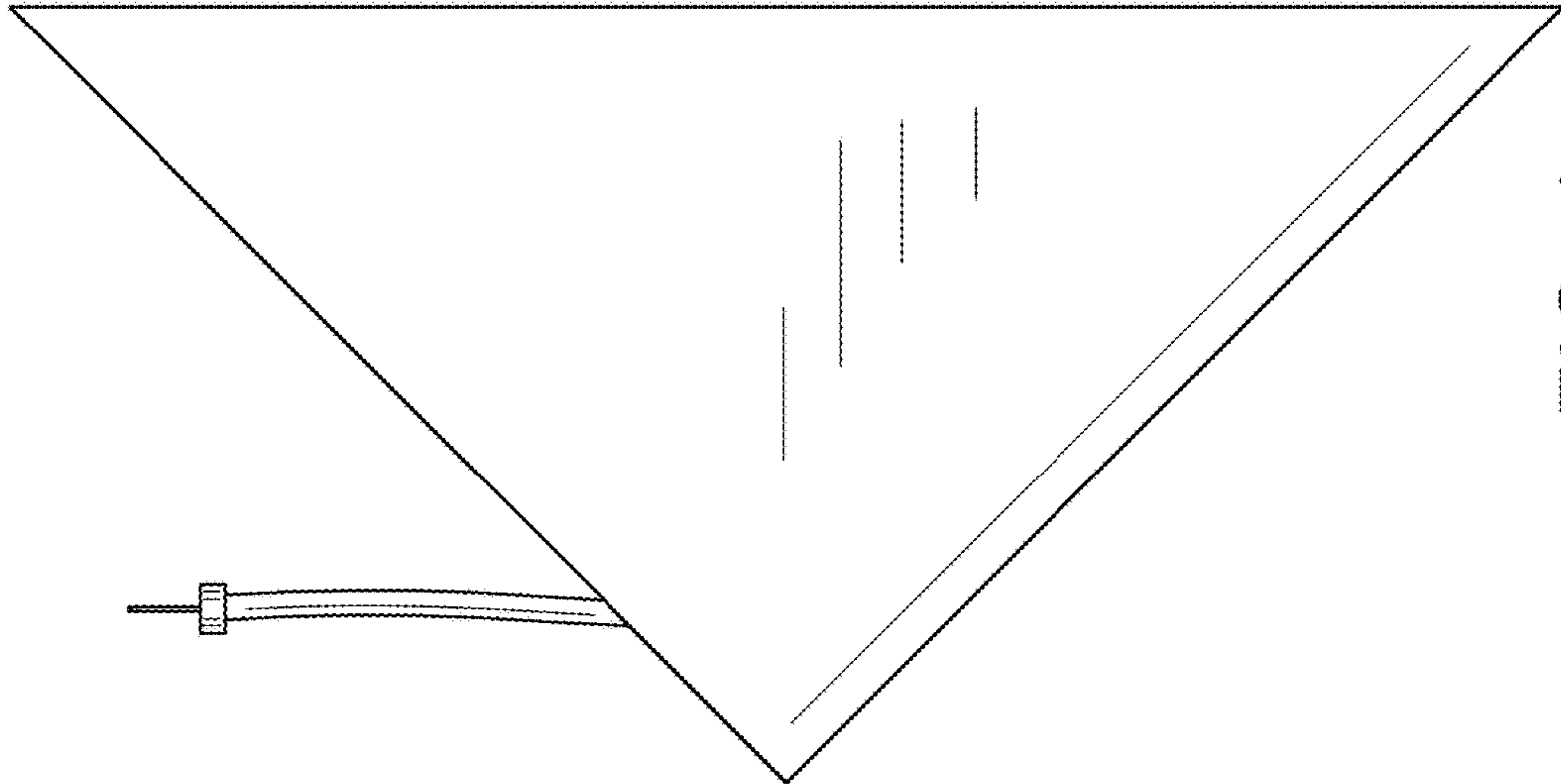

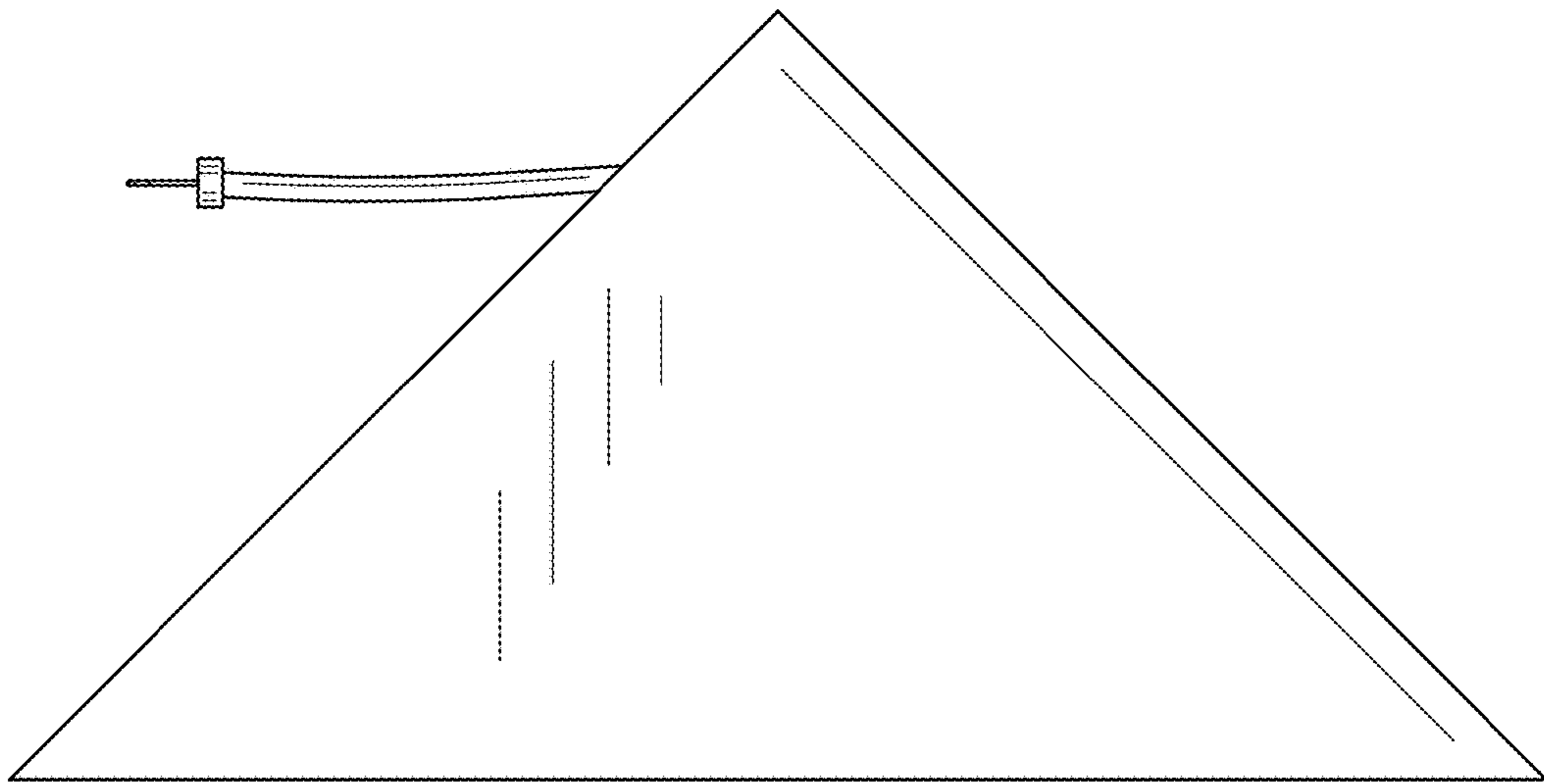

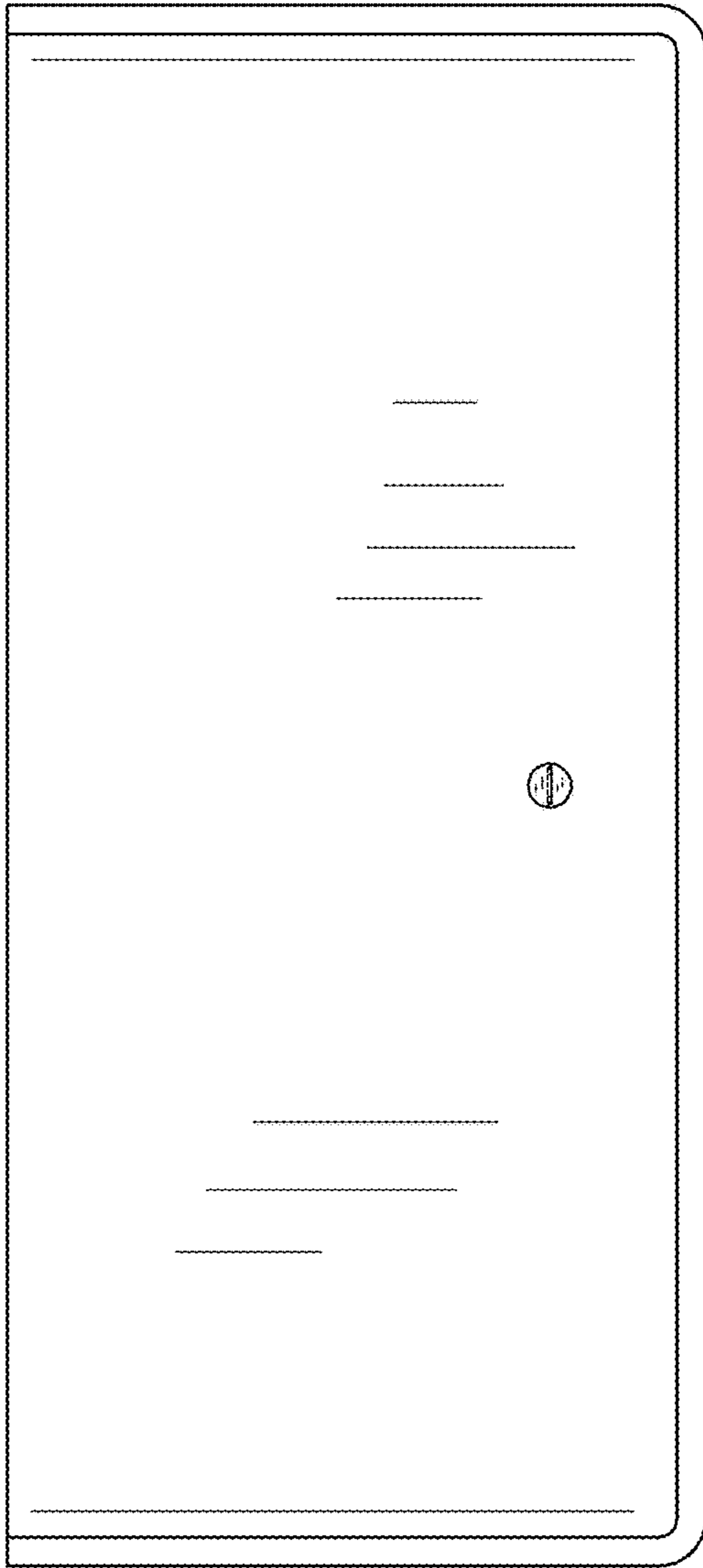

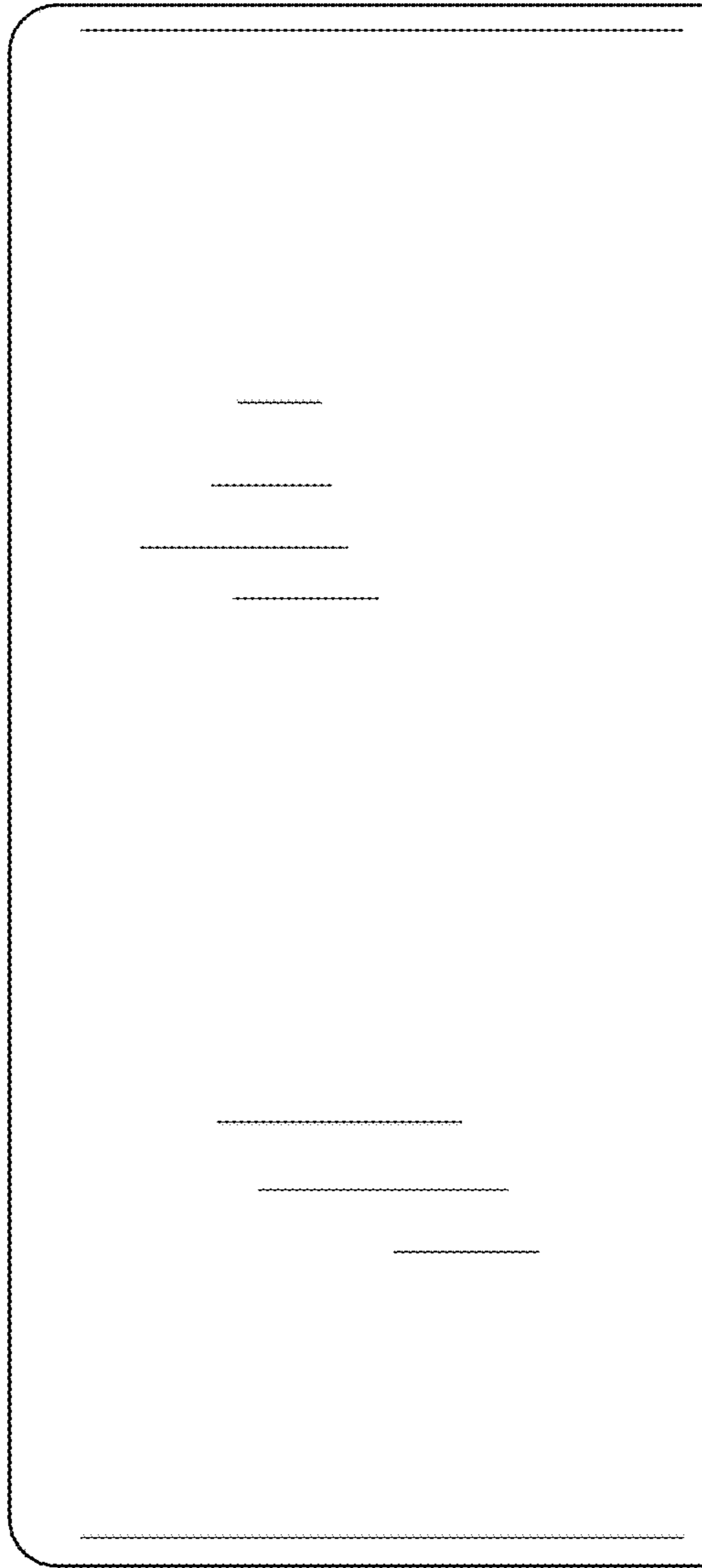

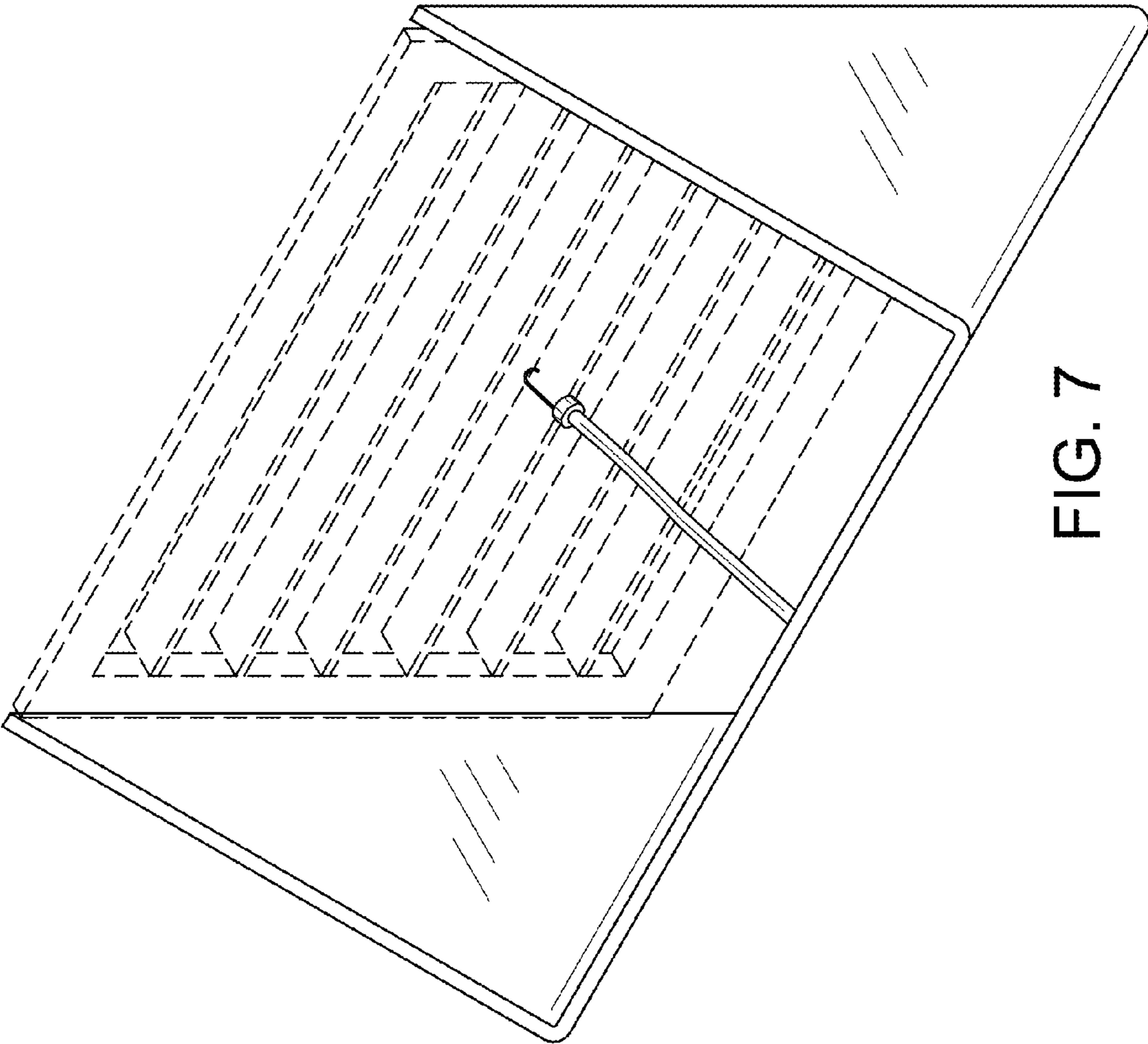
