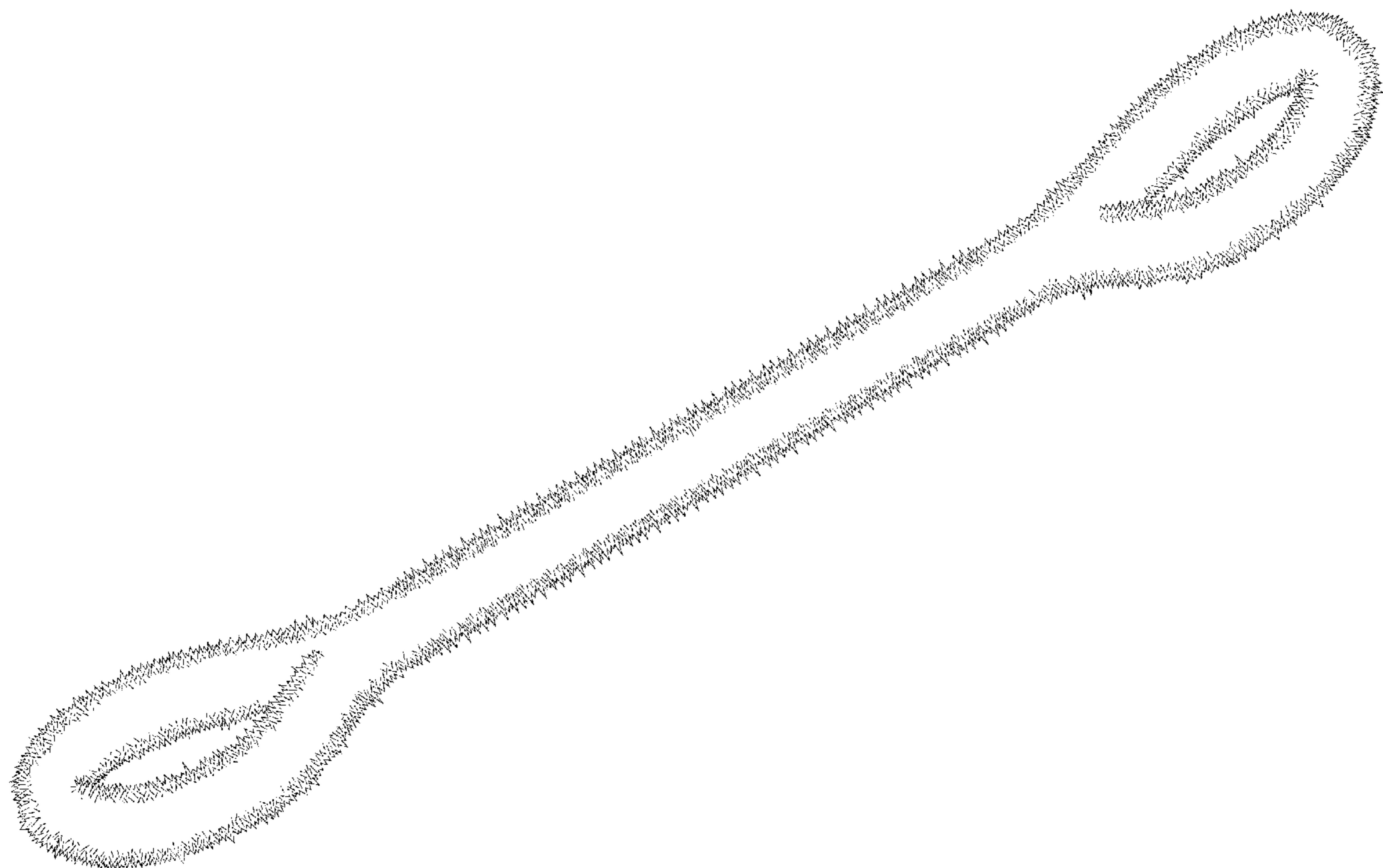
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a side perspective view of the sexual aid showing the new design in an unflexed state;

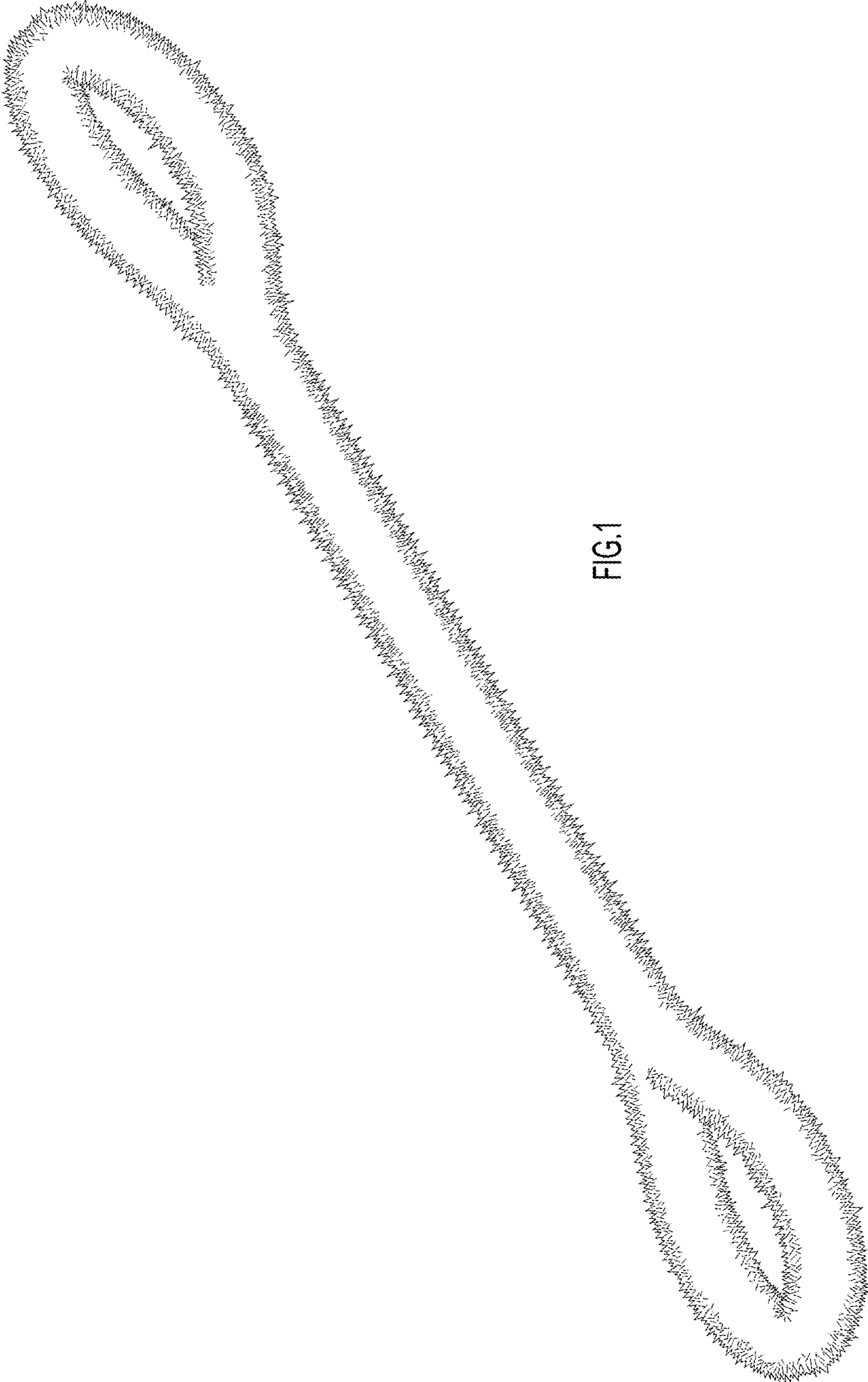

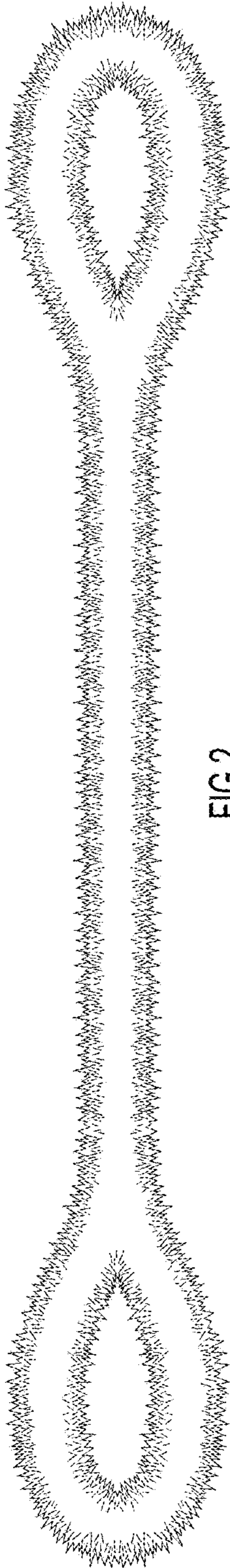

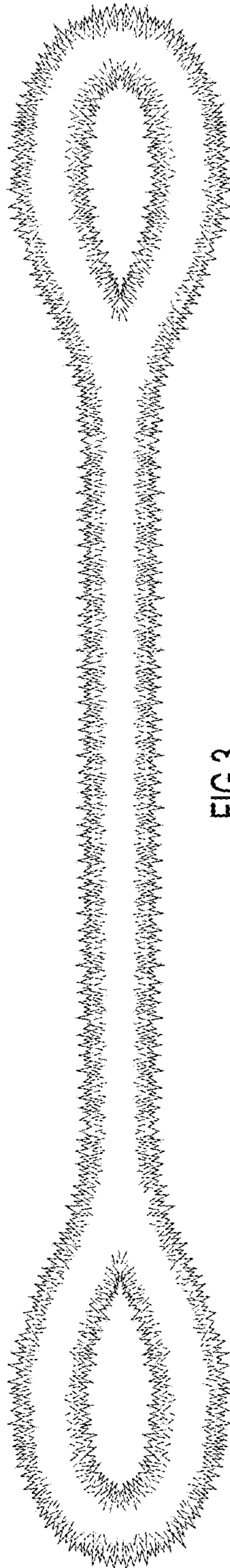

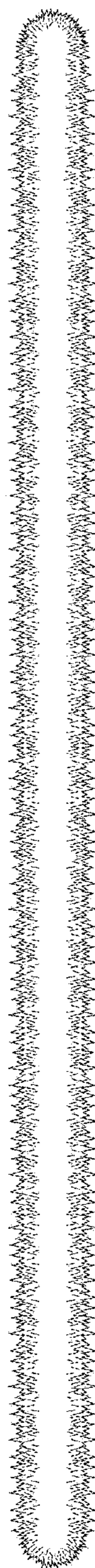

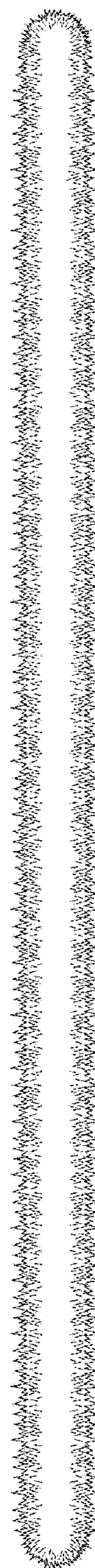

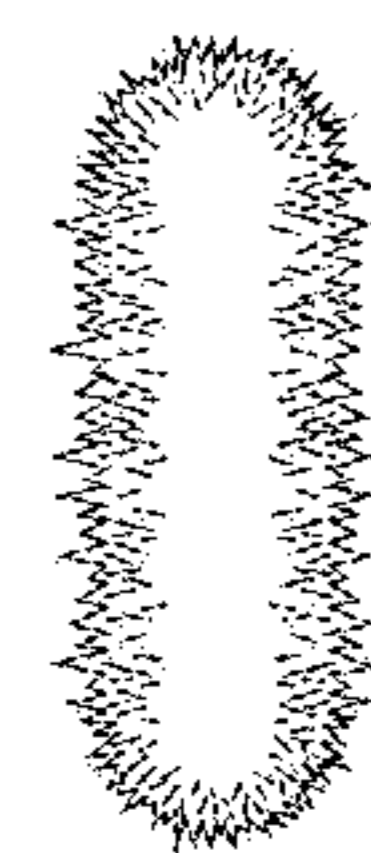

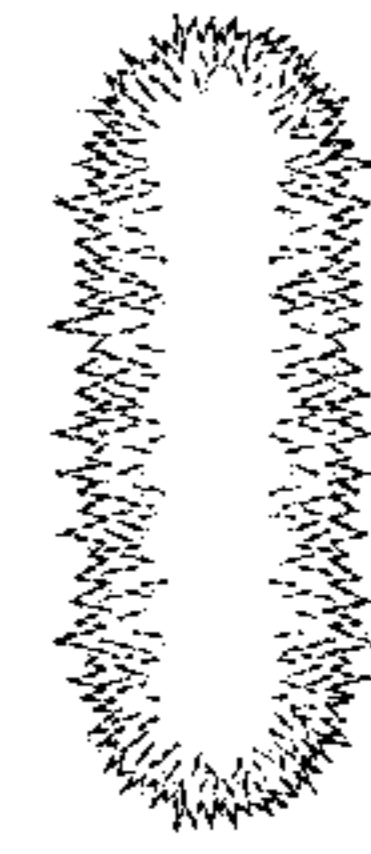

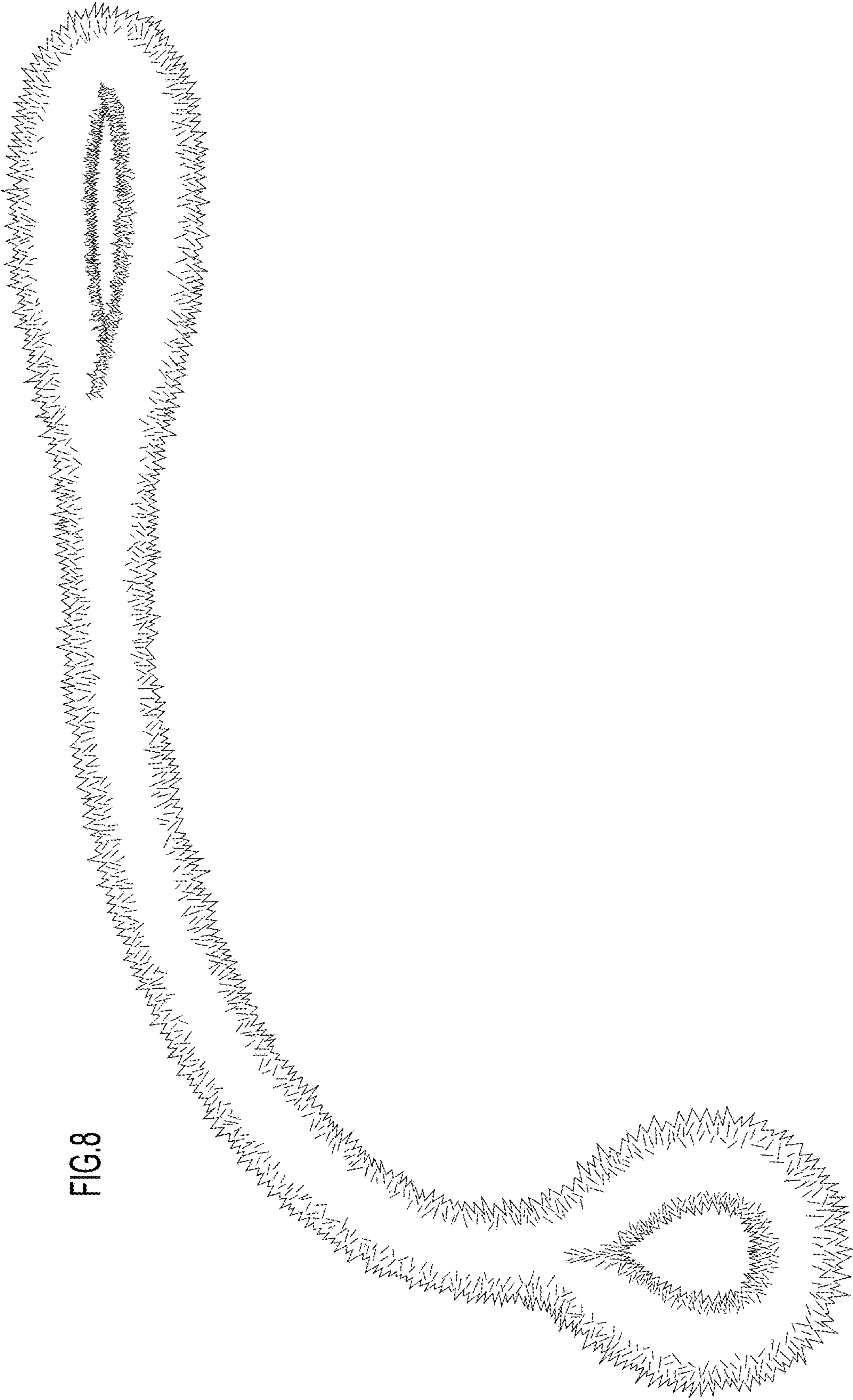
