DESCRIPTION

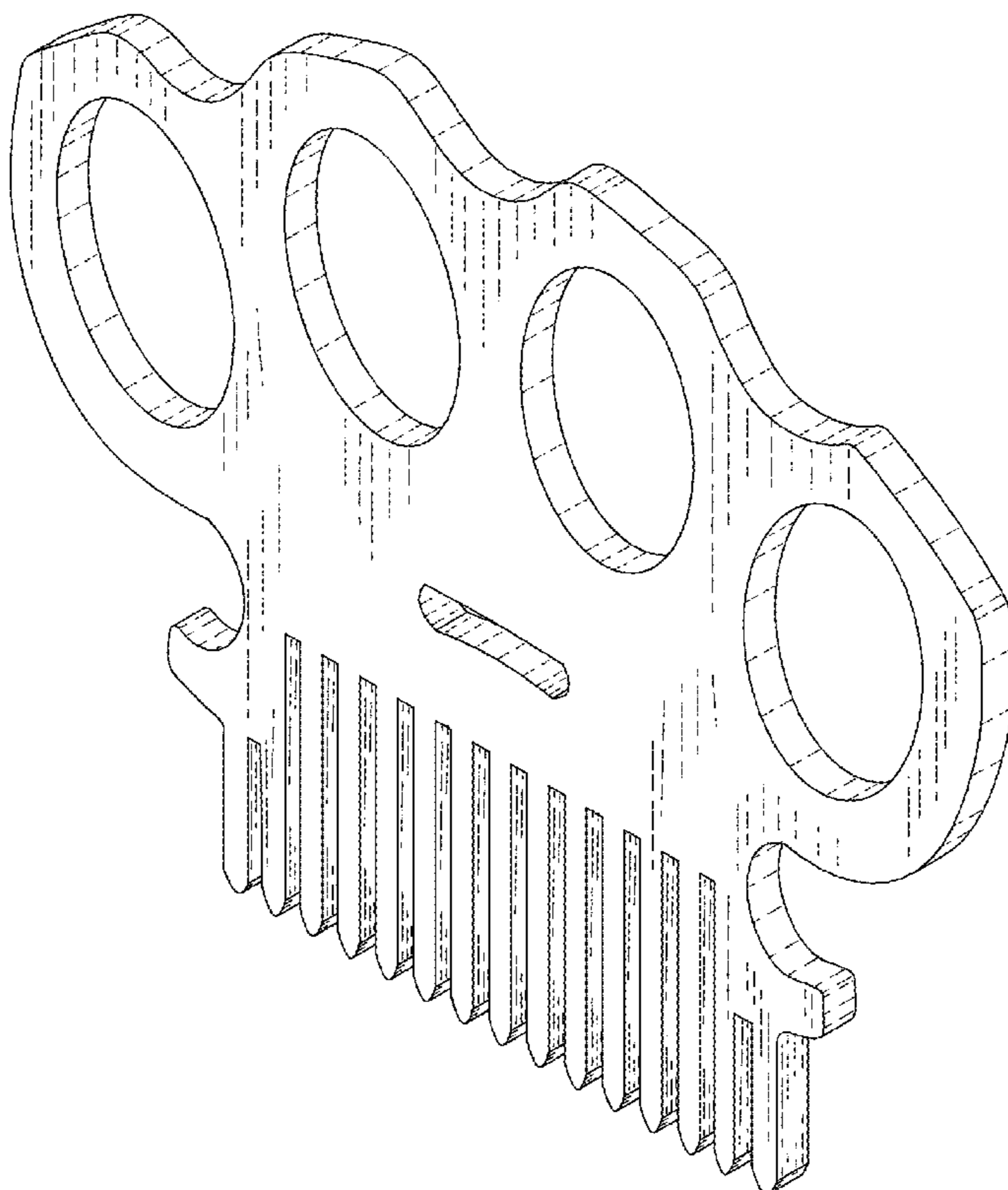
FIG. 1 is a top perspective view of a brass knuckles comb showing my new design;

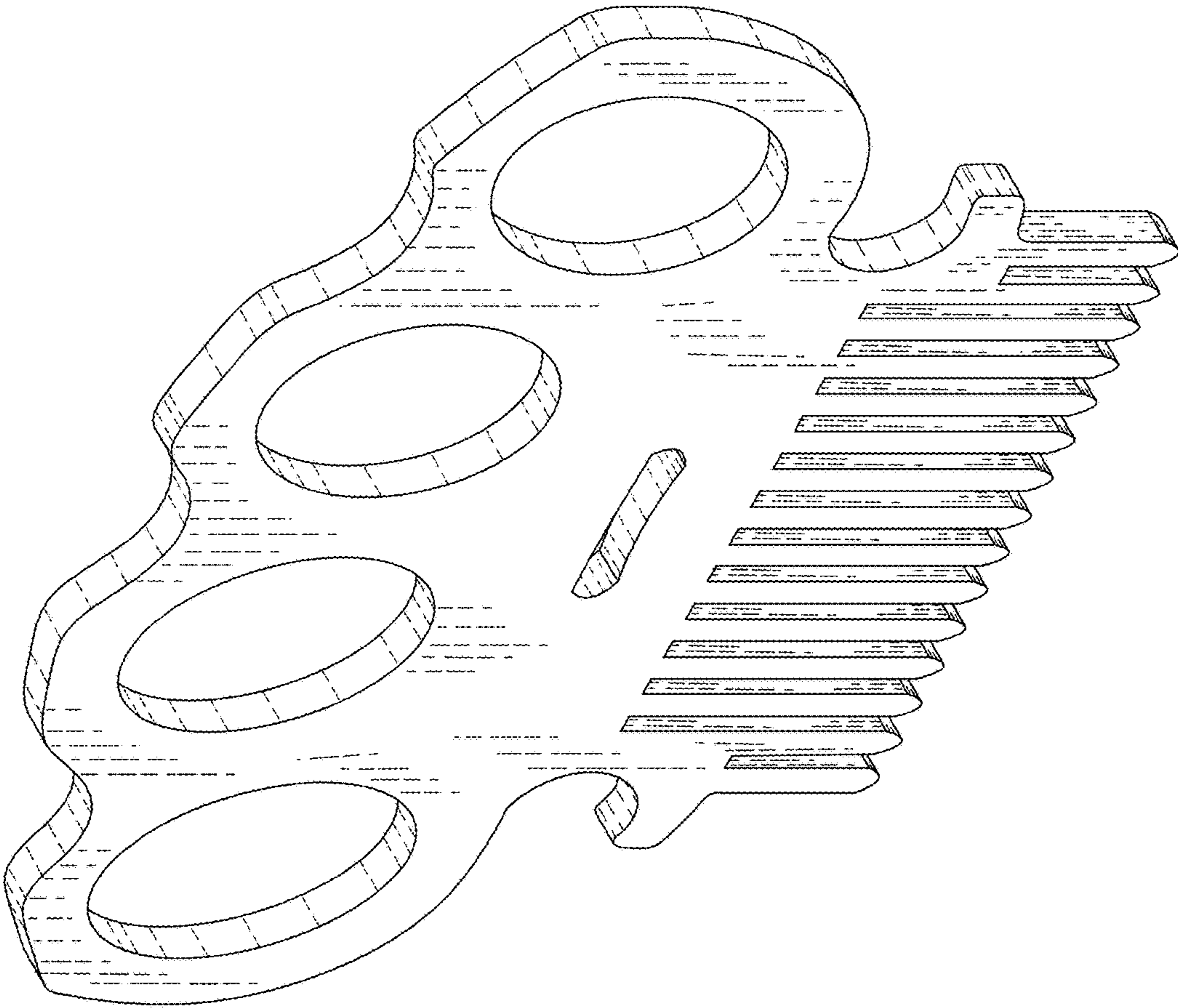

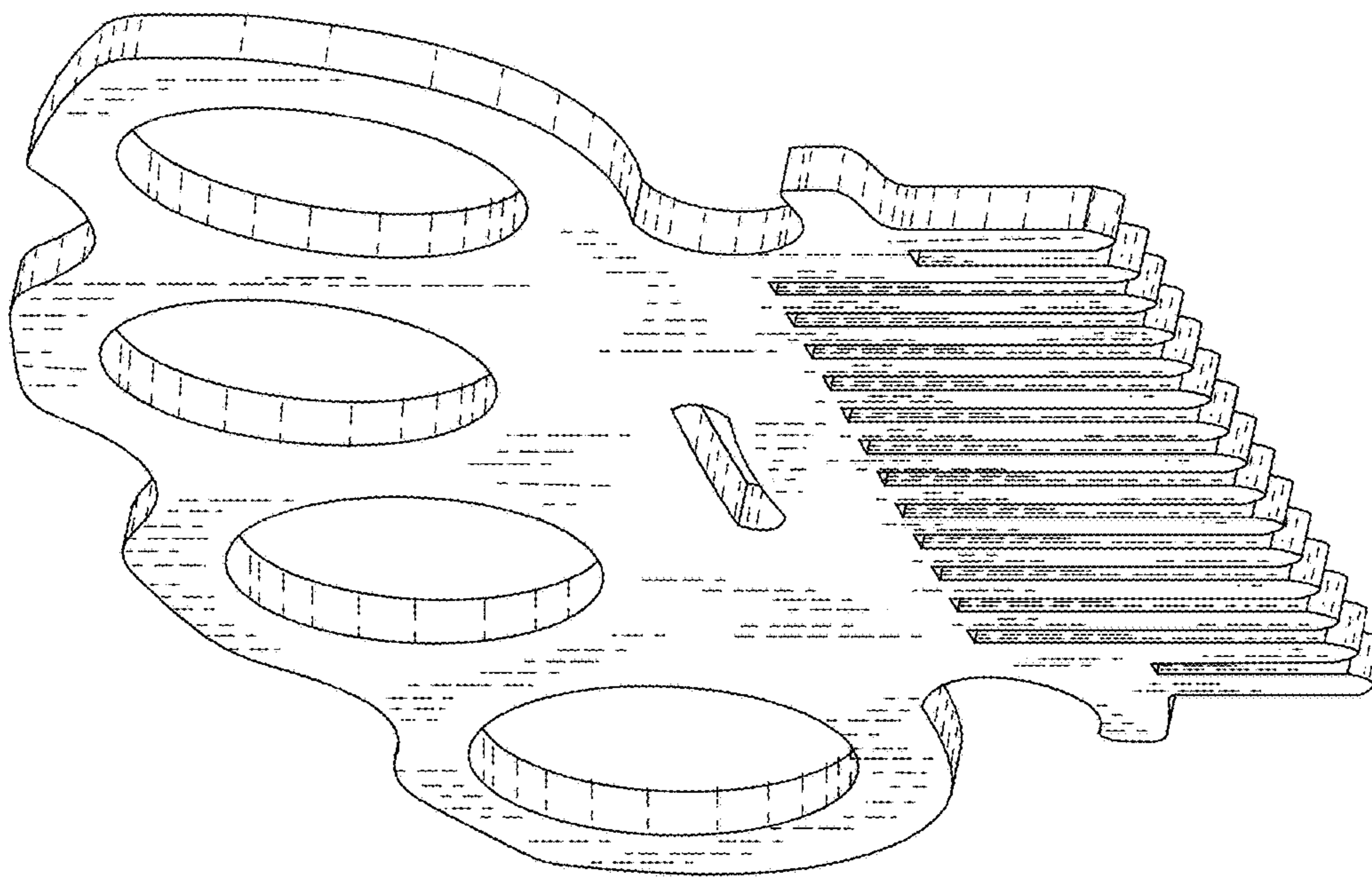

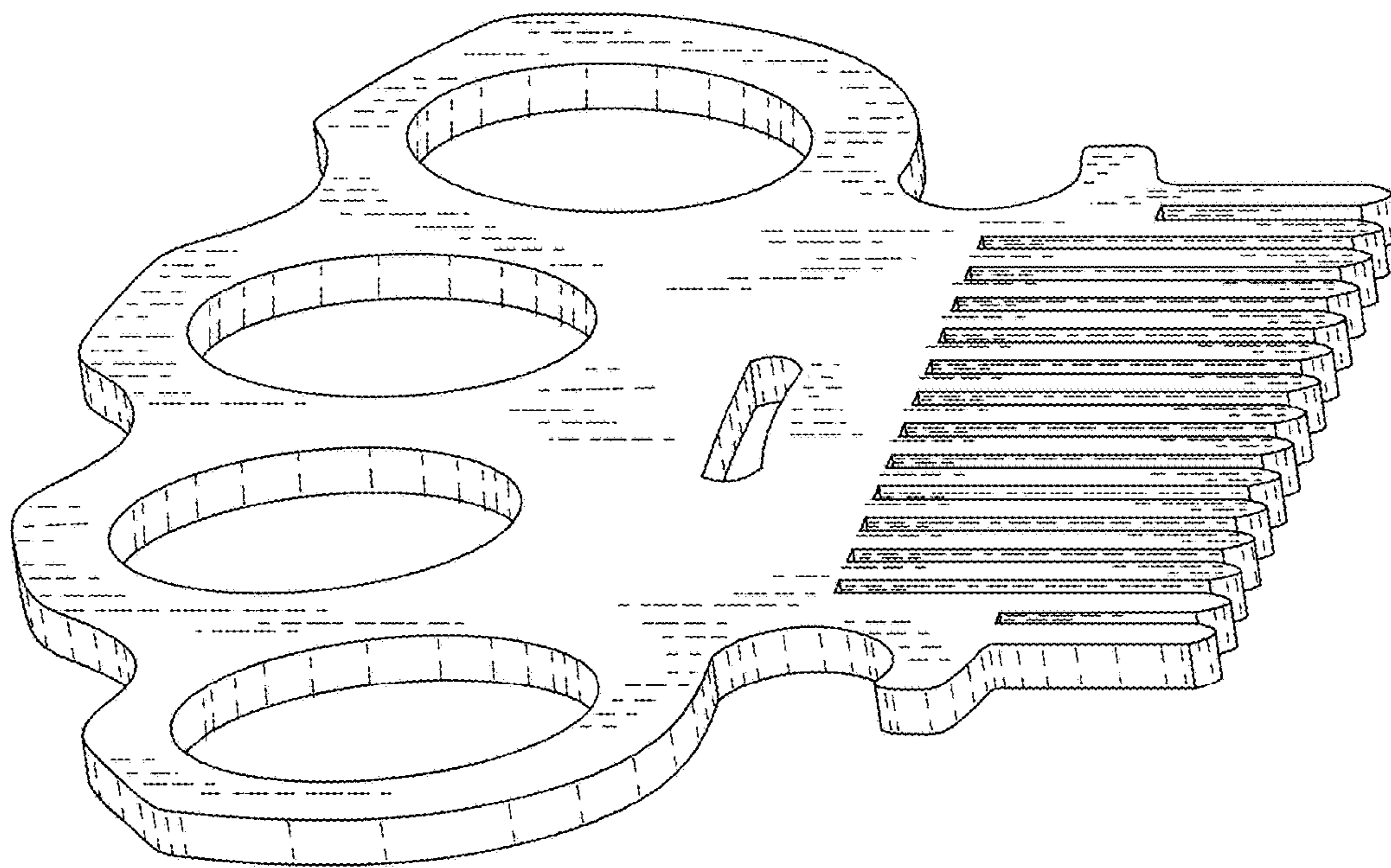

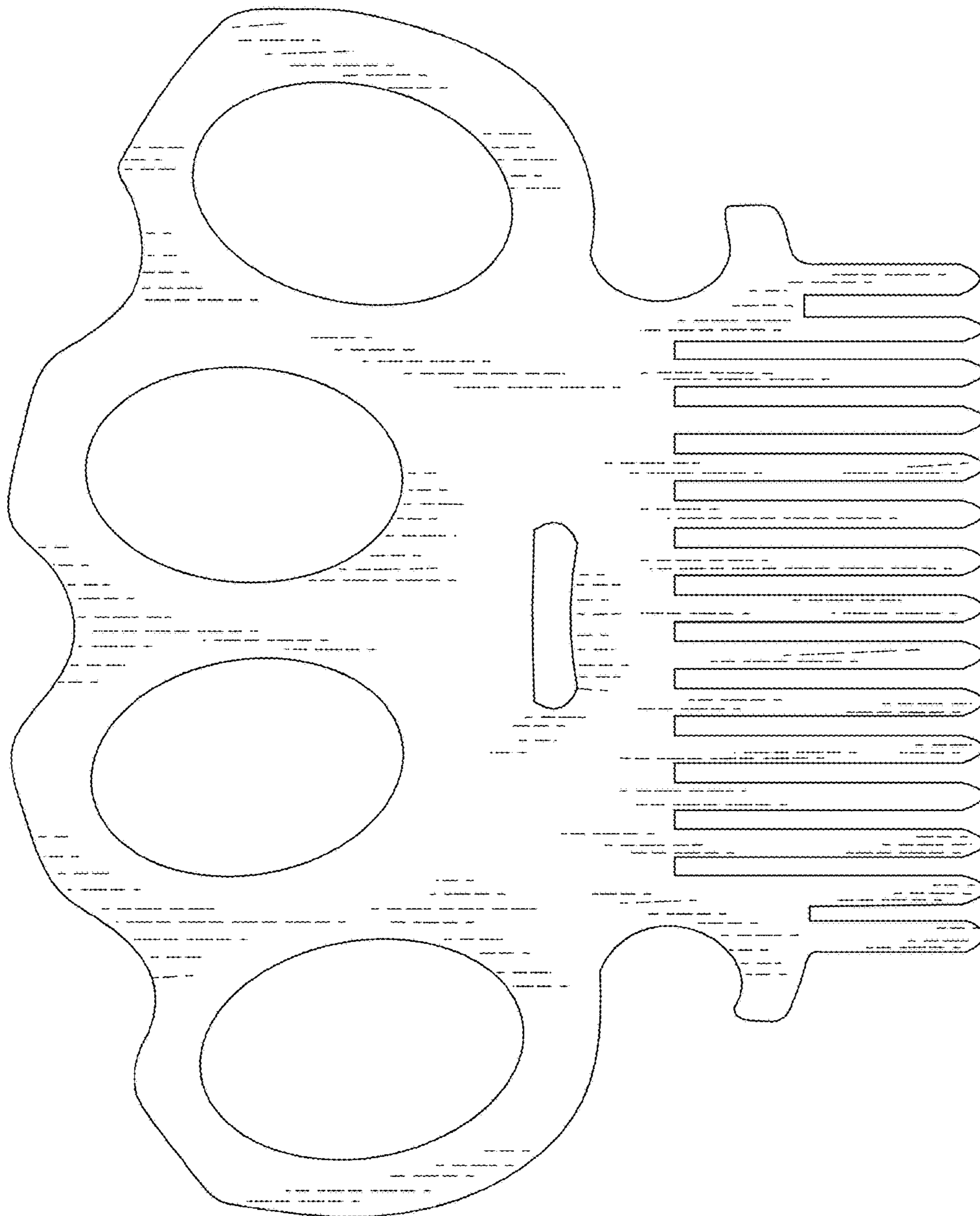

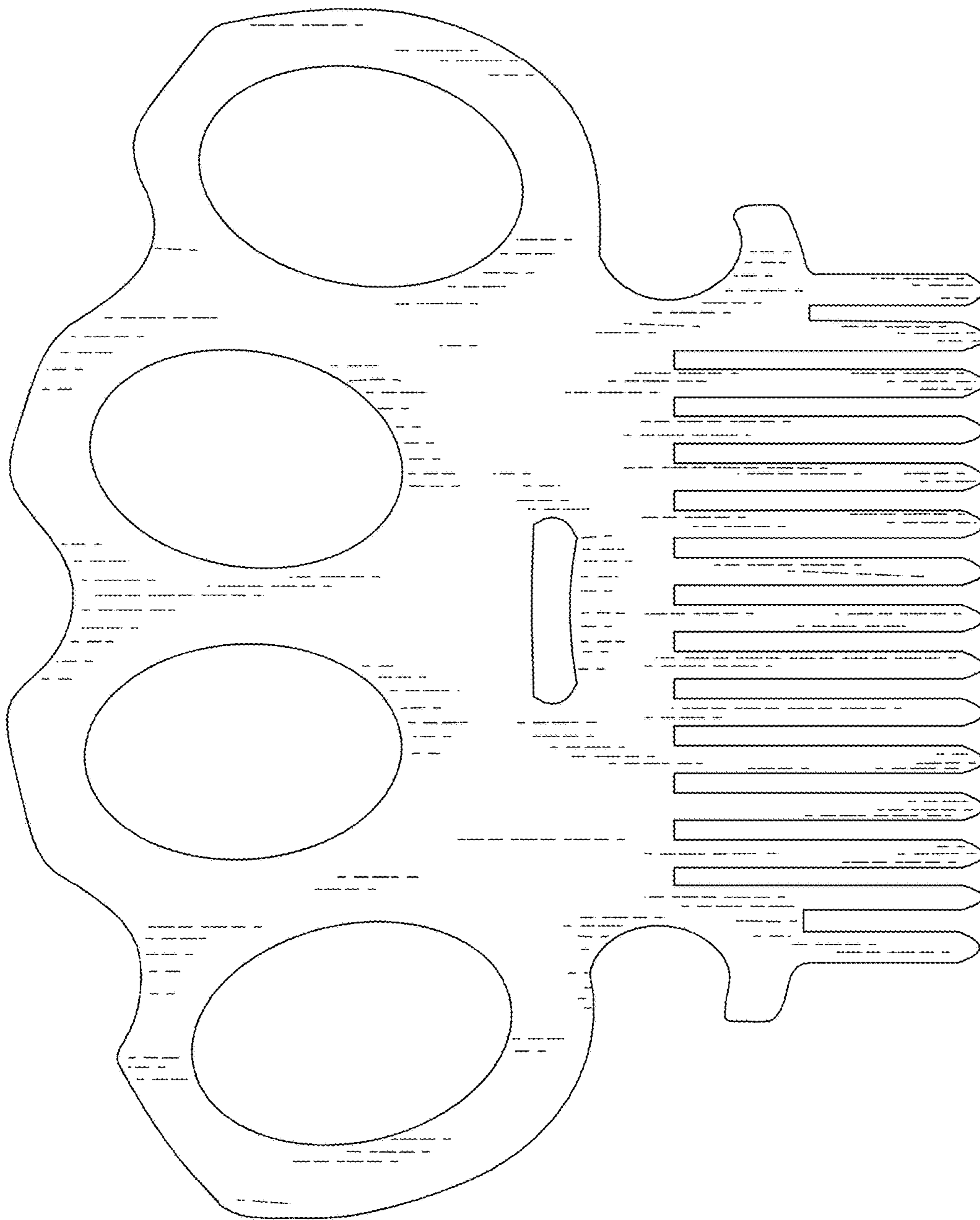

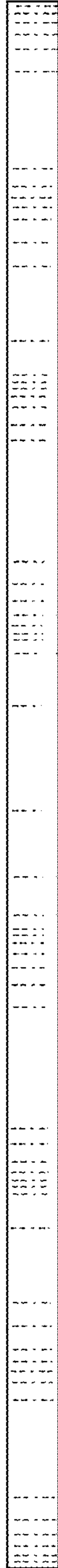

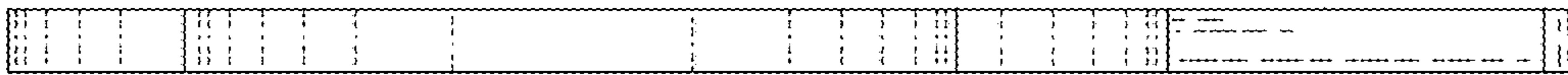

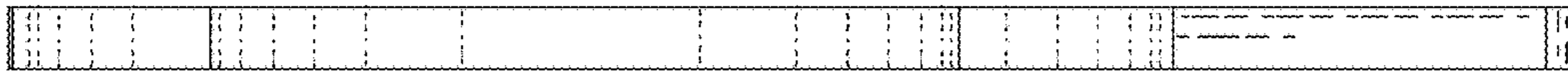
