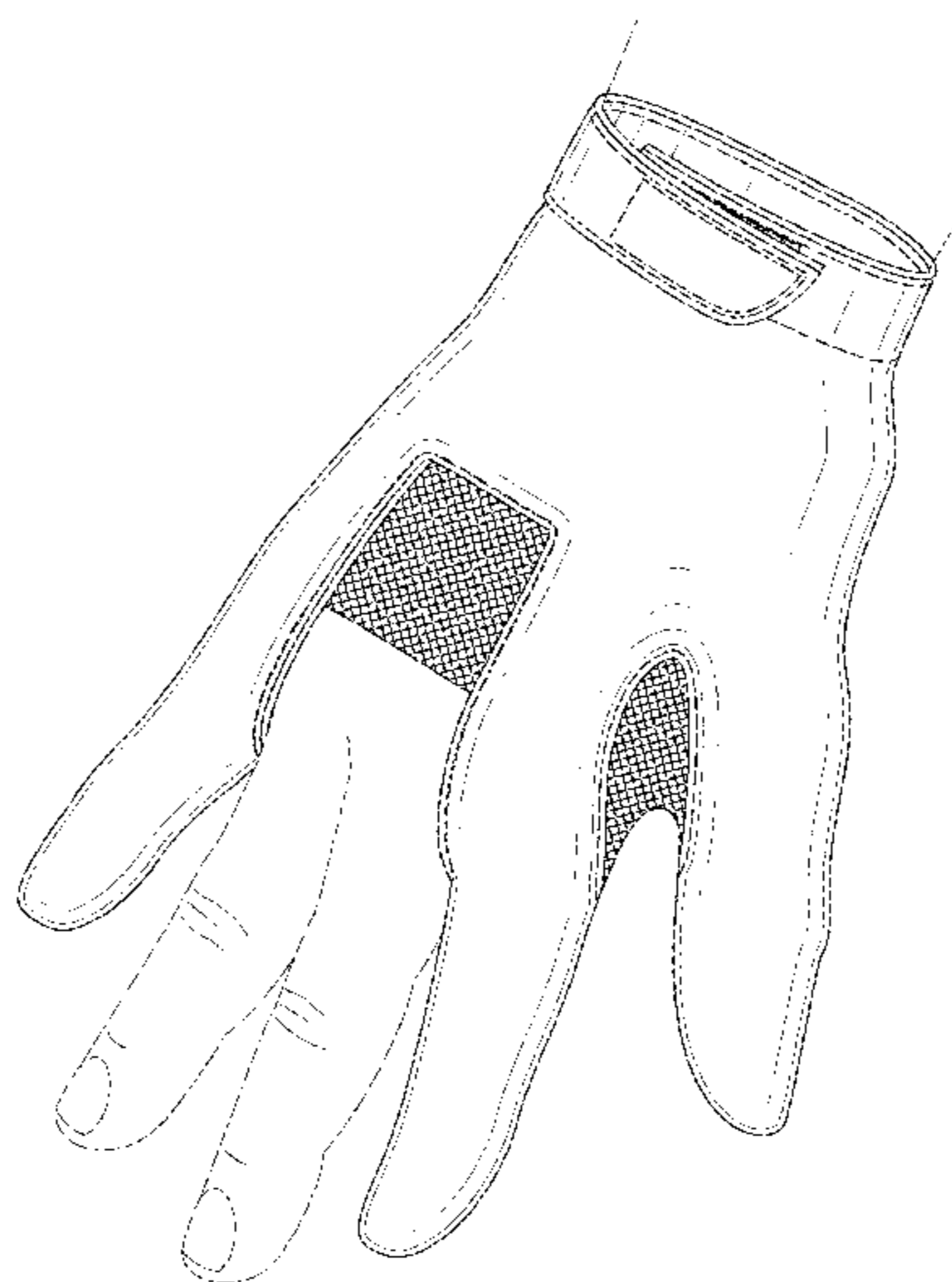
(57) **CLAIM**

The ornamental design for a glove for video game play, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view for a glove for video game play showing my new design;  
FIG. 2 is a rear side view thereof;  
FIG. 3 is a front side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top side view; and,  
FIG. 7 is a bottom side view.  
The long dash broken lines in FIGS. 1-6 depict environmental subject matter of a hand and form no part of the claimed design. The short dash broken lines in FIGS. 1-6 on the surface of the glove illustrate stitching on the glove and form no part of the claimed design. The broken lines in FIG. 7 represent the boundary of the claim and form no part of the claimed design.

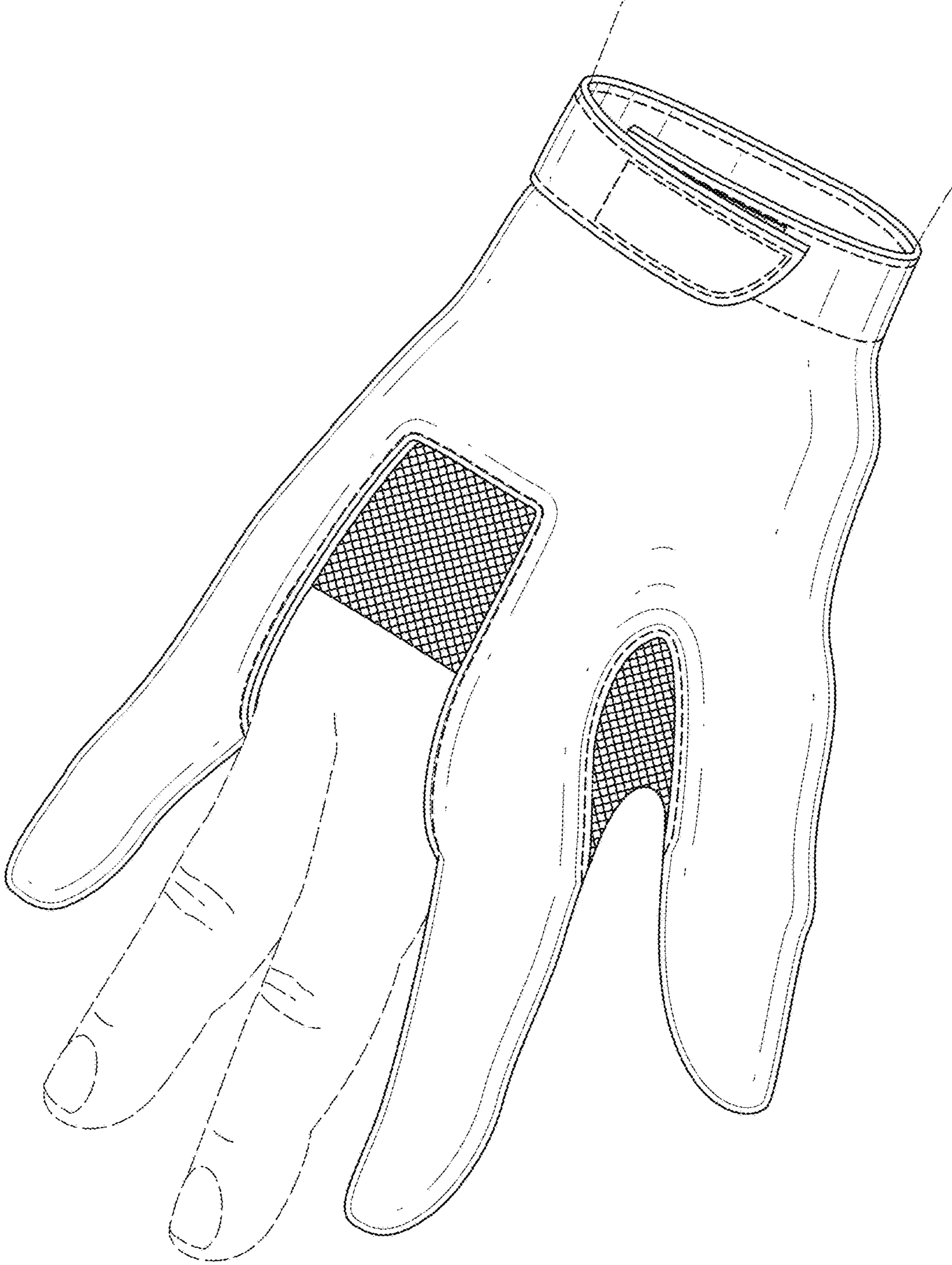

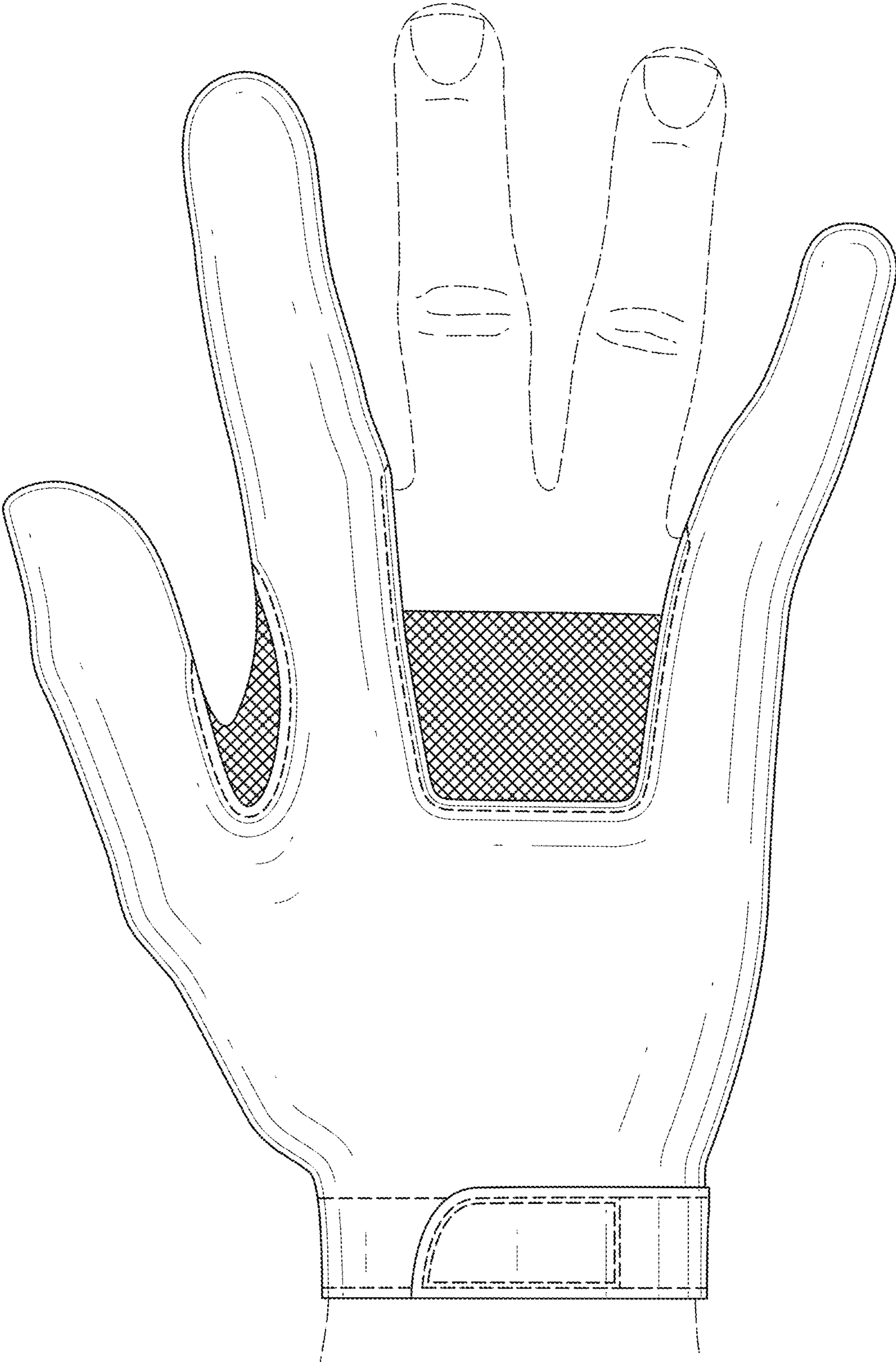

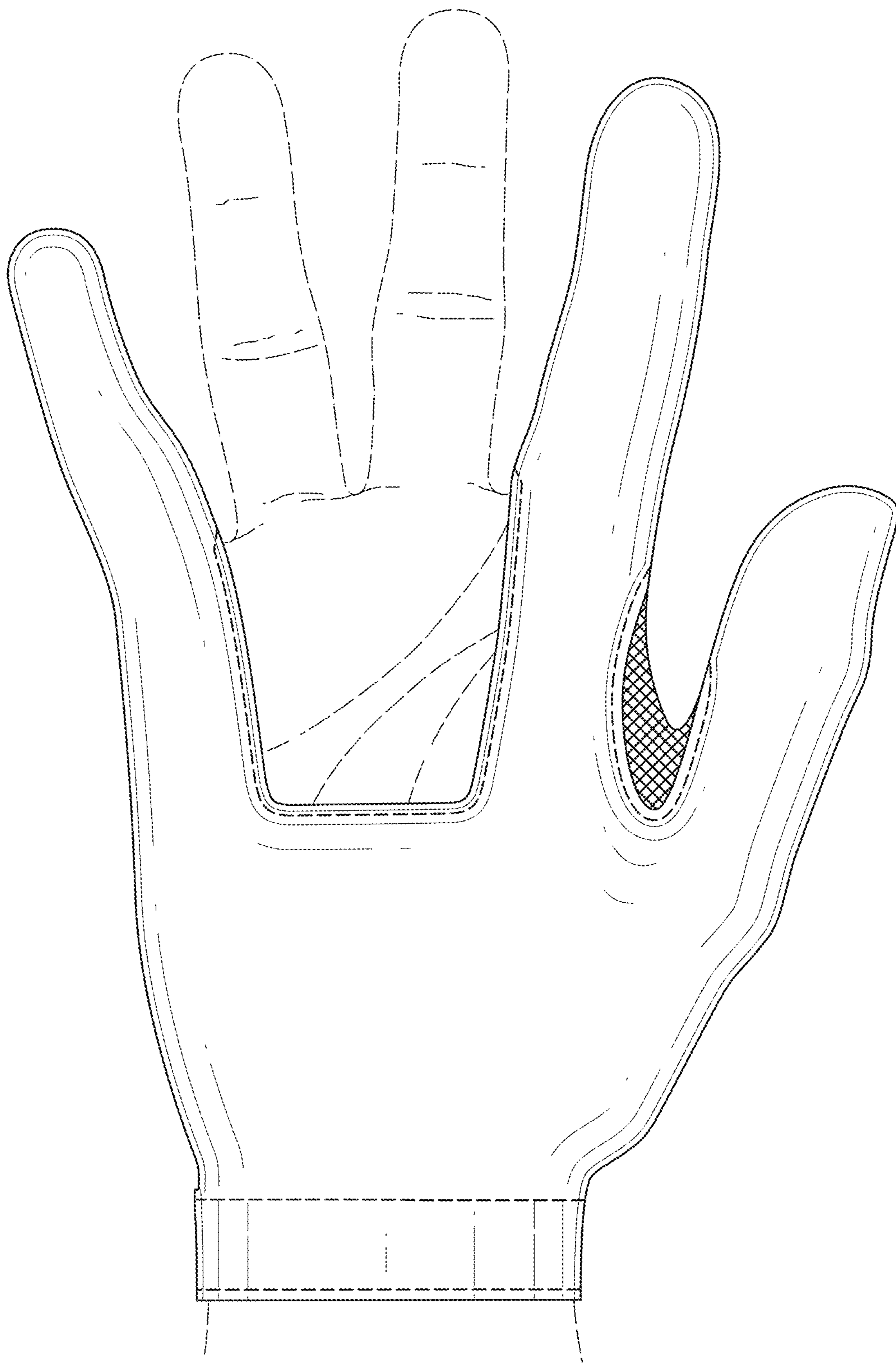

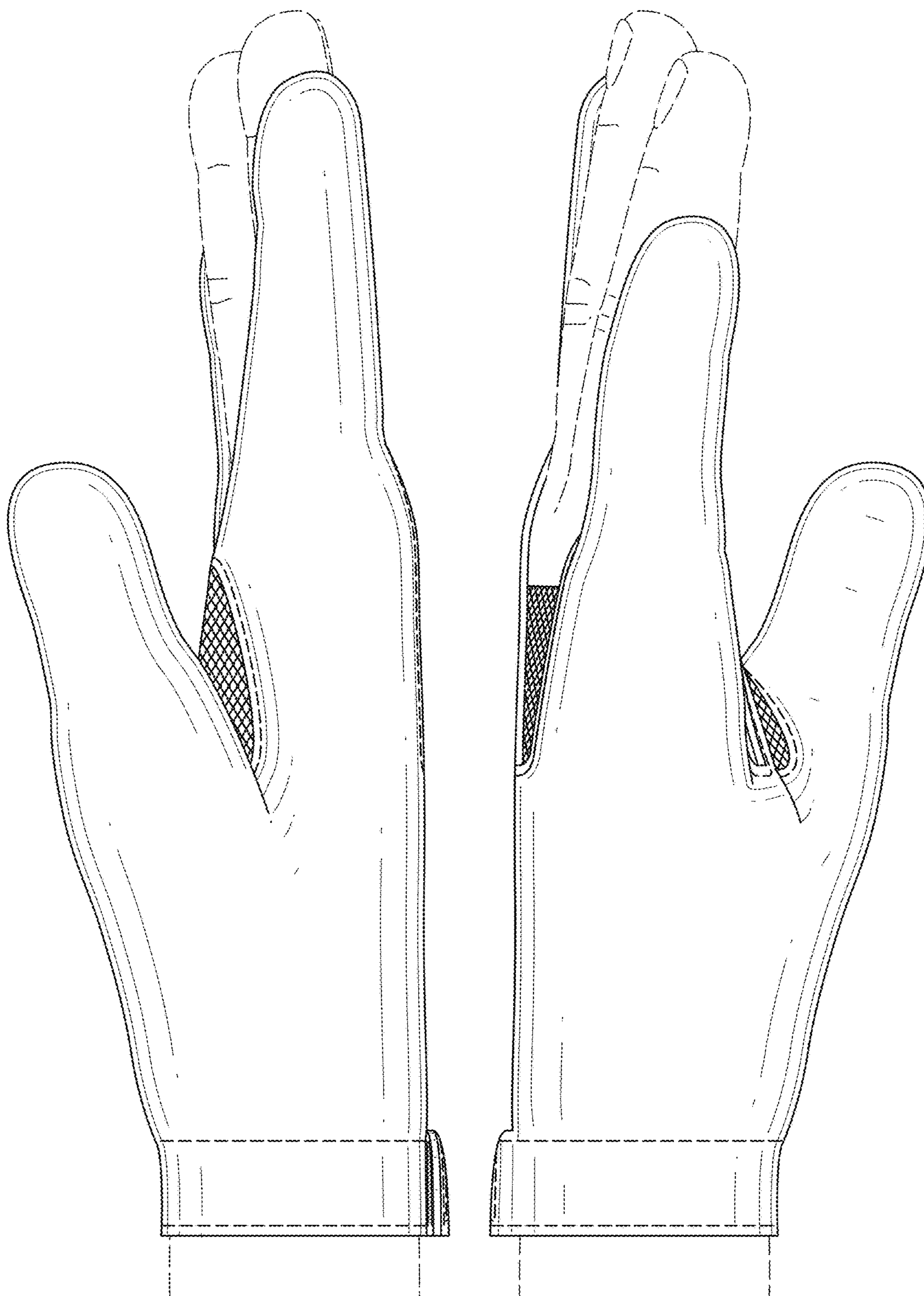

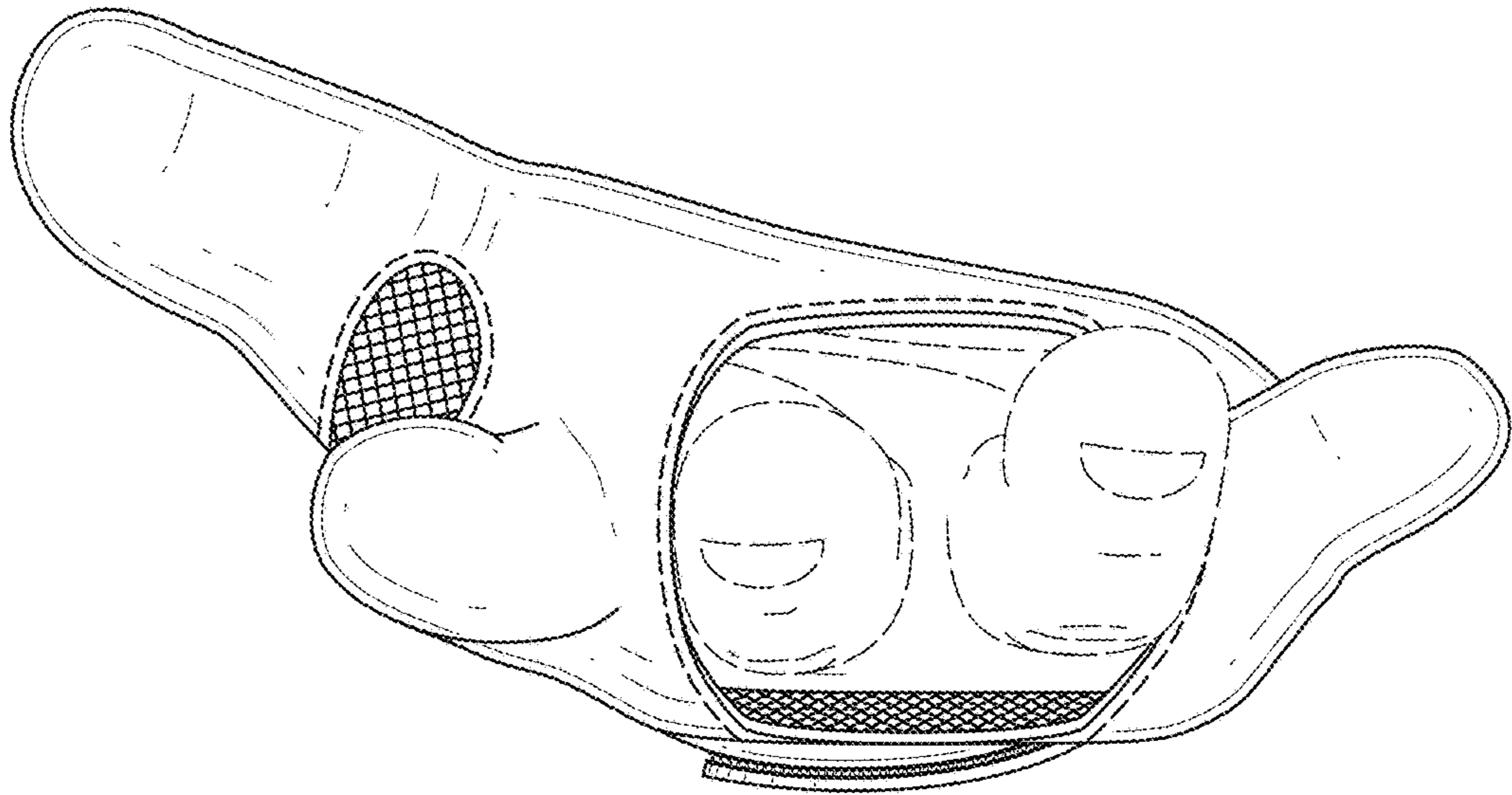

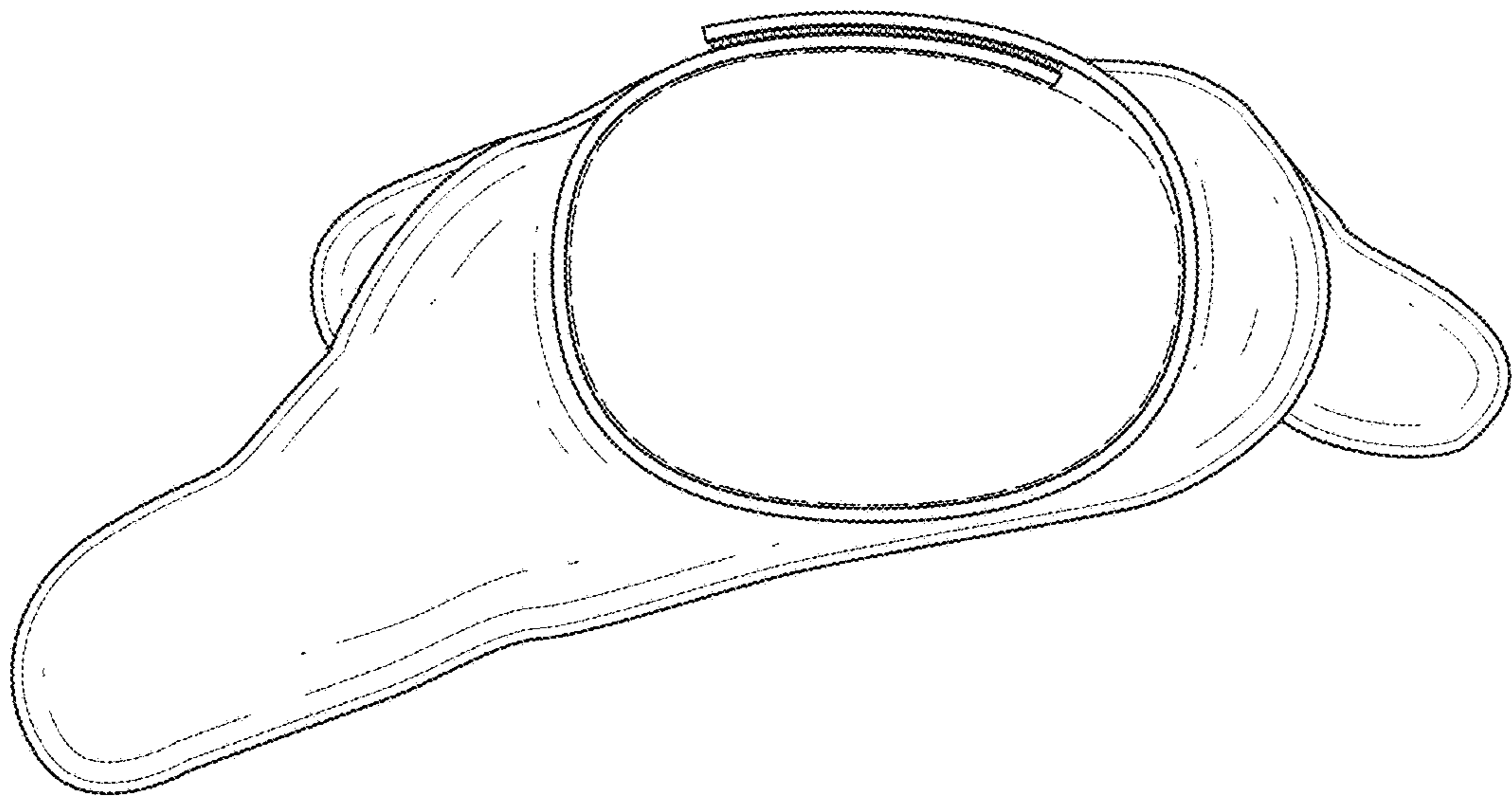
