FIG. 6 is an enlarged view of the claimed region in FIG. 1, shown in isolation.

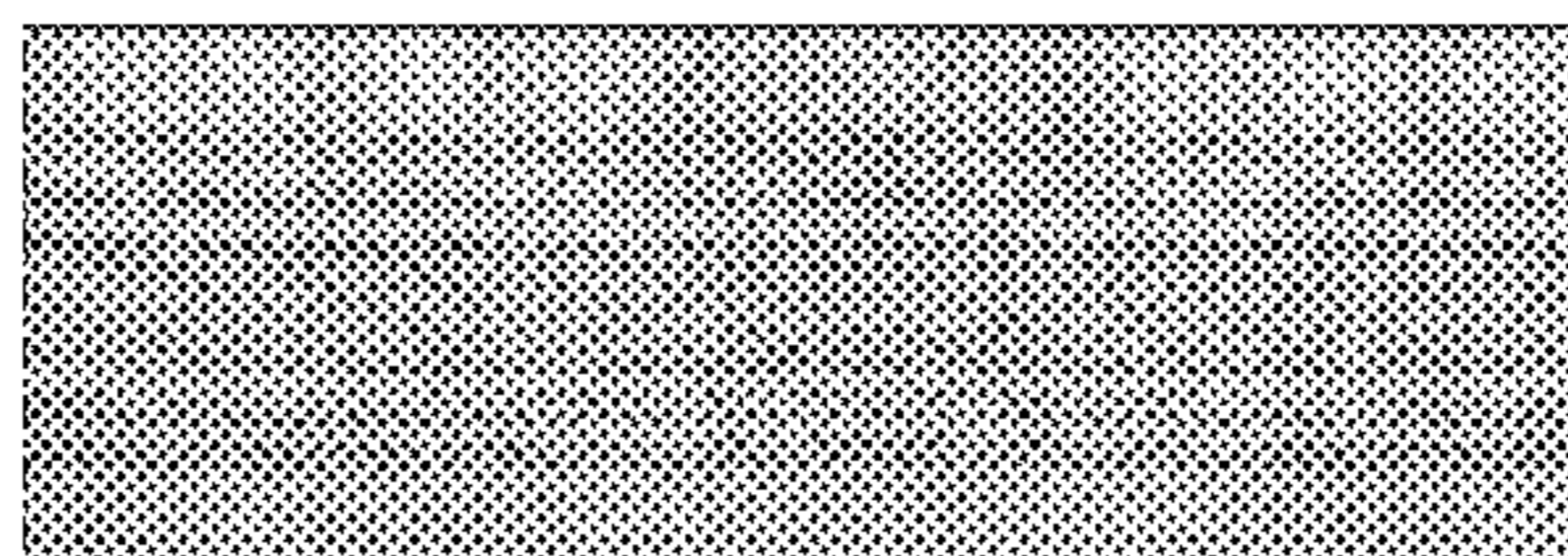
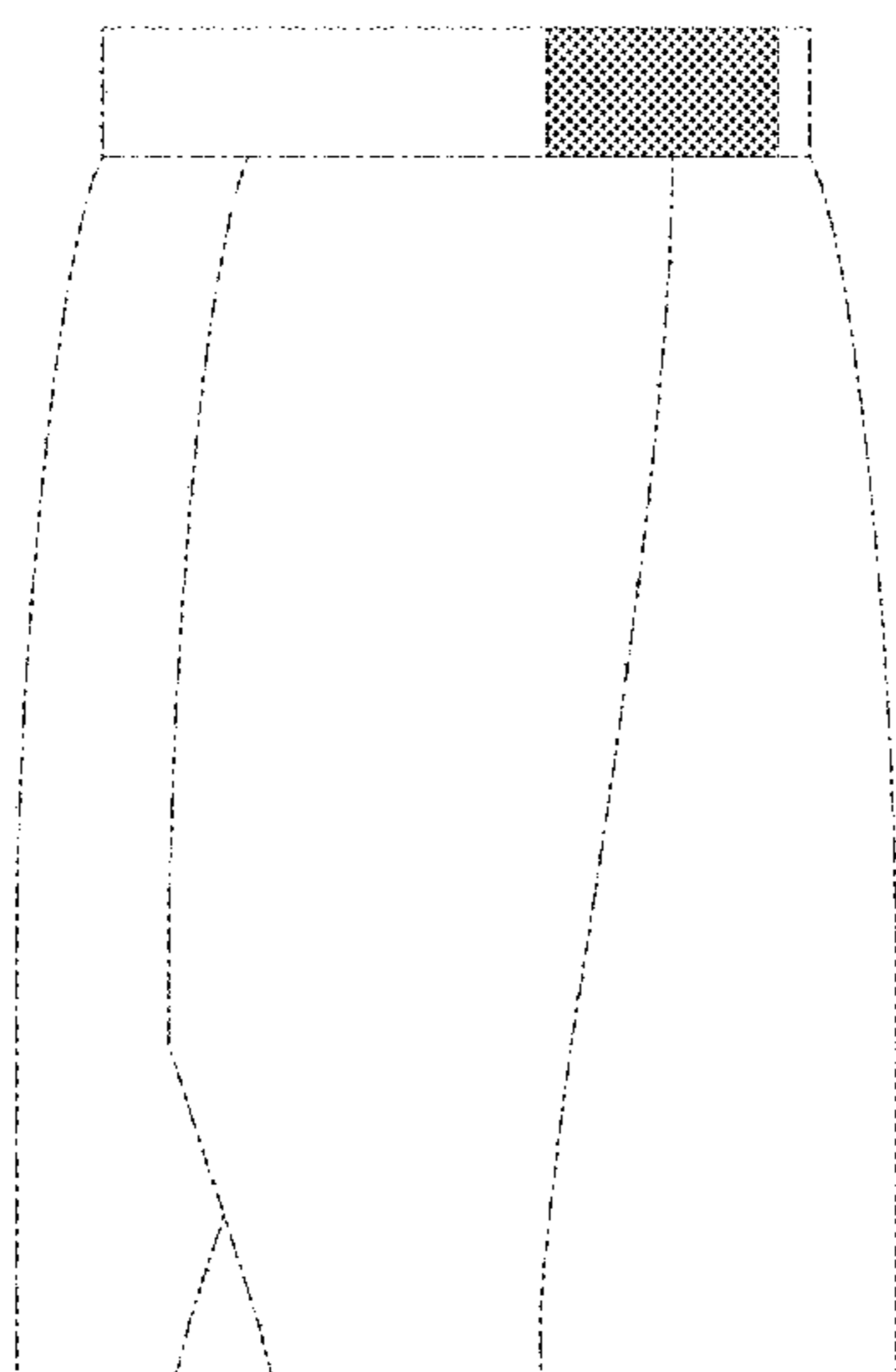

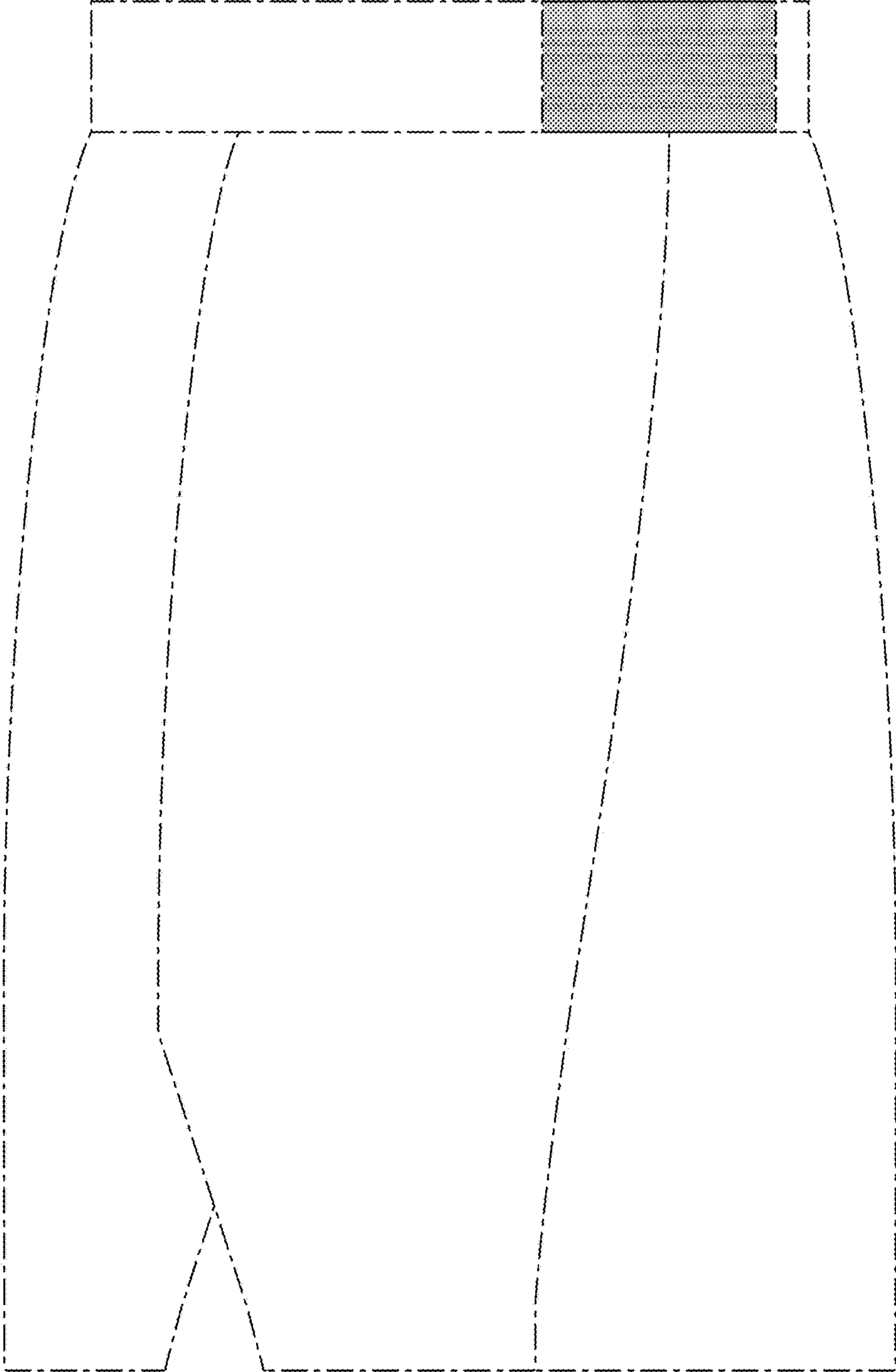

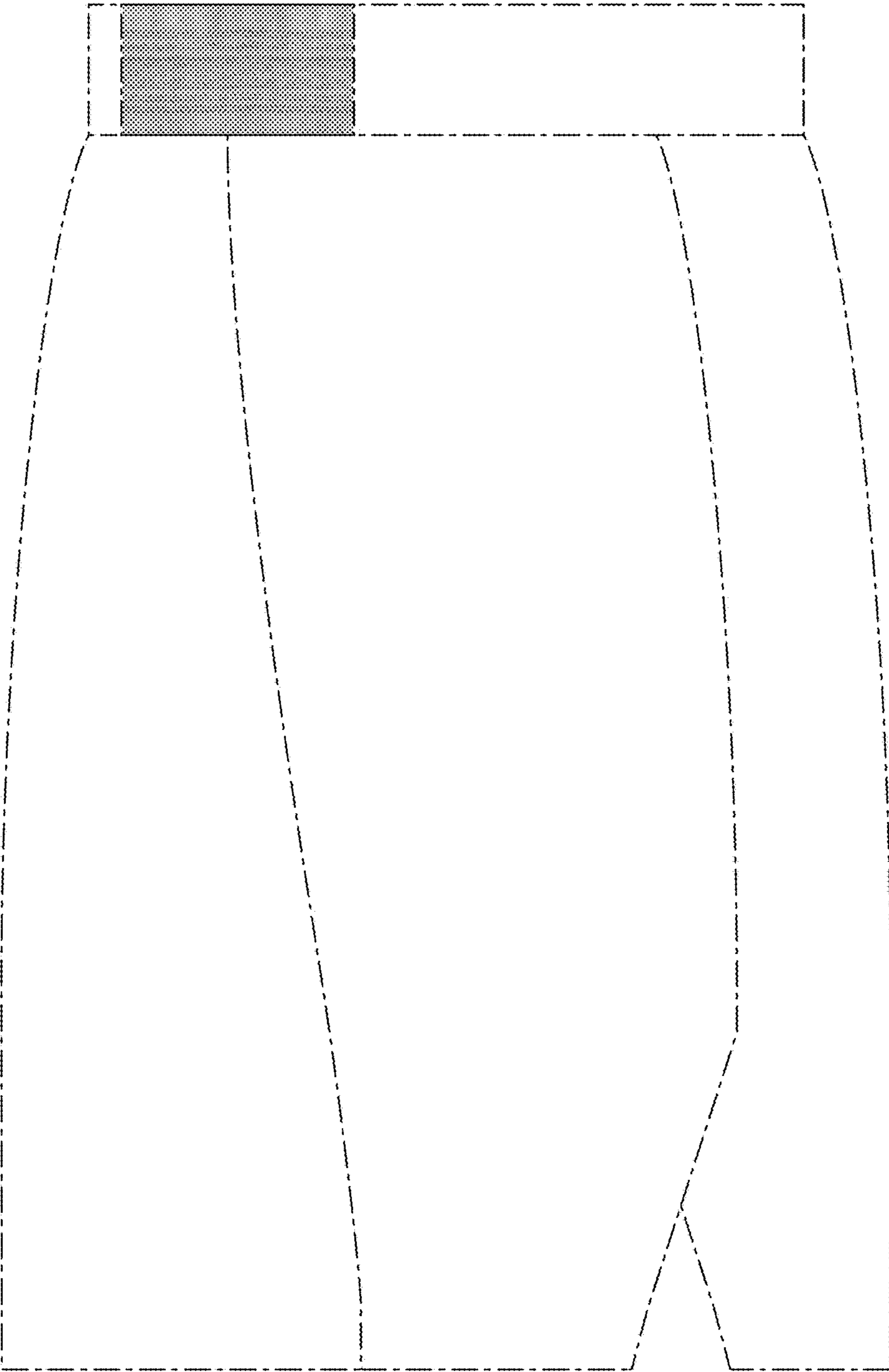

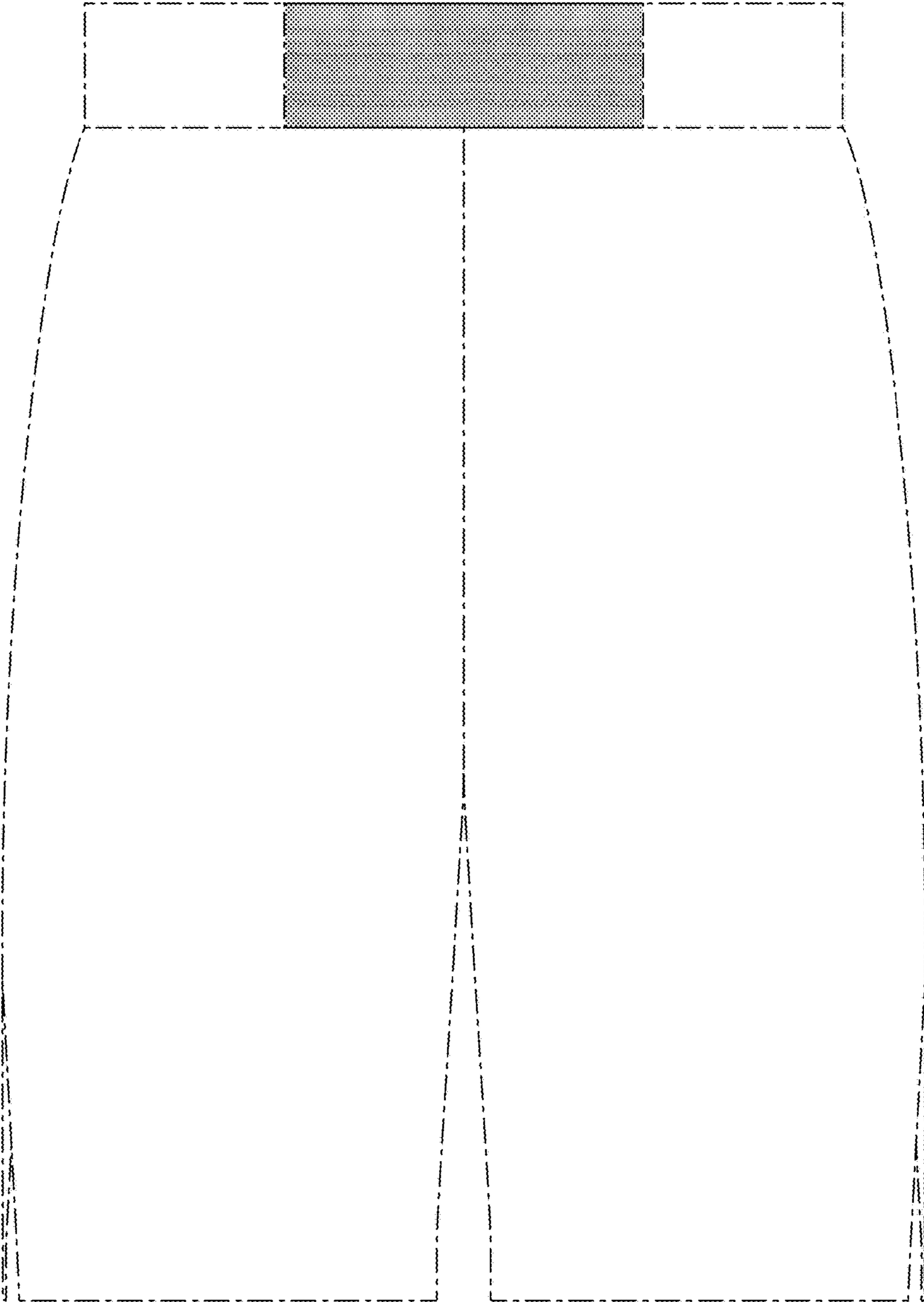

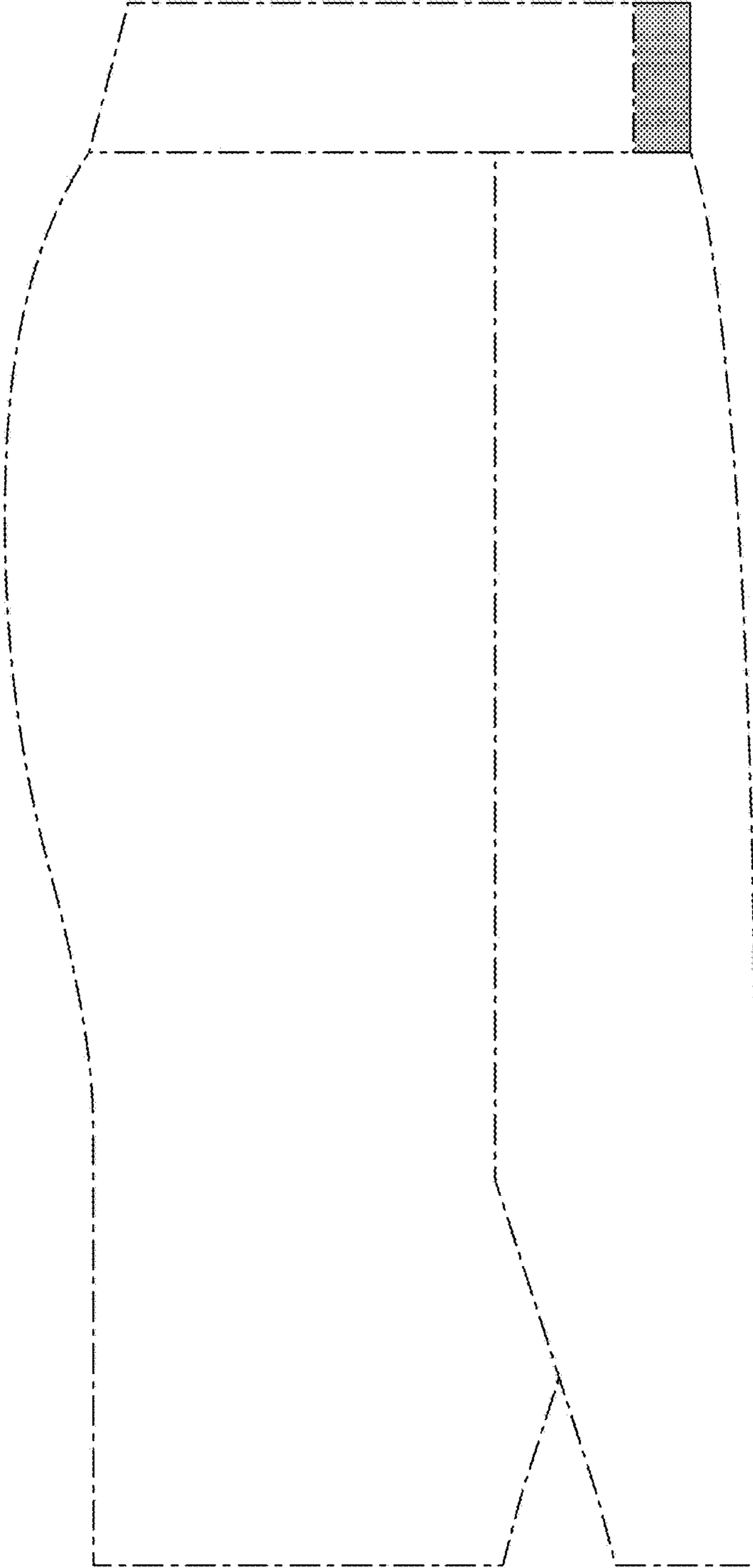

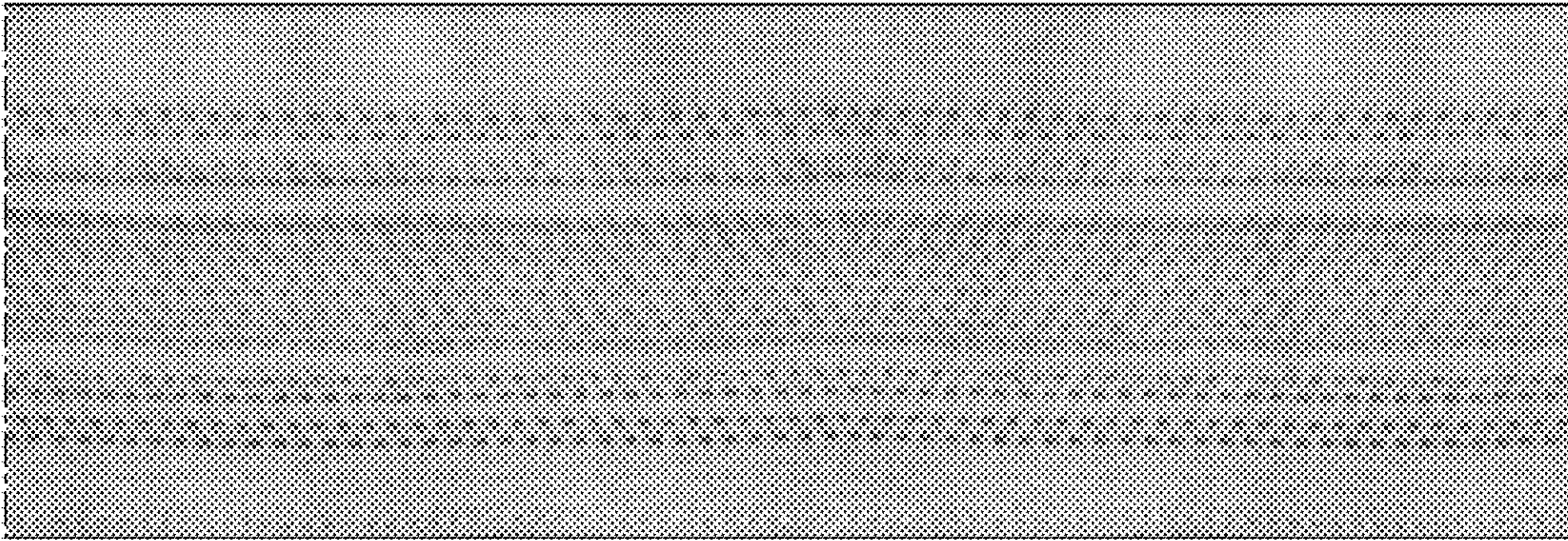
