The ornamental design for a headwear support form, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a headwear support form in accordance with an embodiment of the present design; FIG. 2 is a front elevational view of the headwear support form of FIG. 1; FIG. 3 is a rear elevational view of the headwear support form of FIG. 1; FIG. 4 is a right side elevational view of the headwear support form of FIG. 1; FIG. 5 is a left side elevational view of the headwear support form of FIG. 1; FIG. 6 is a top plan view of the headwear support form of FIG. 1; and, FIG. 7 is a bottom plan view of the headwear support form of FIG. 1. In FIGS. 1-7, the features of the headwear support form shown in phantom lines illustrate environmental structure that forms no part of the claimed design.

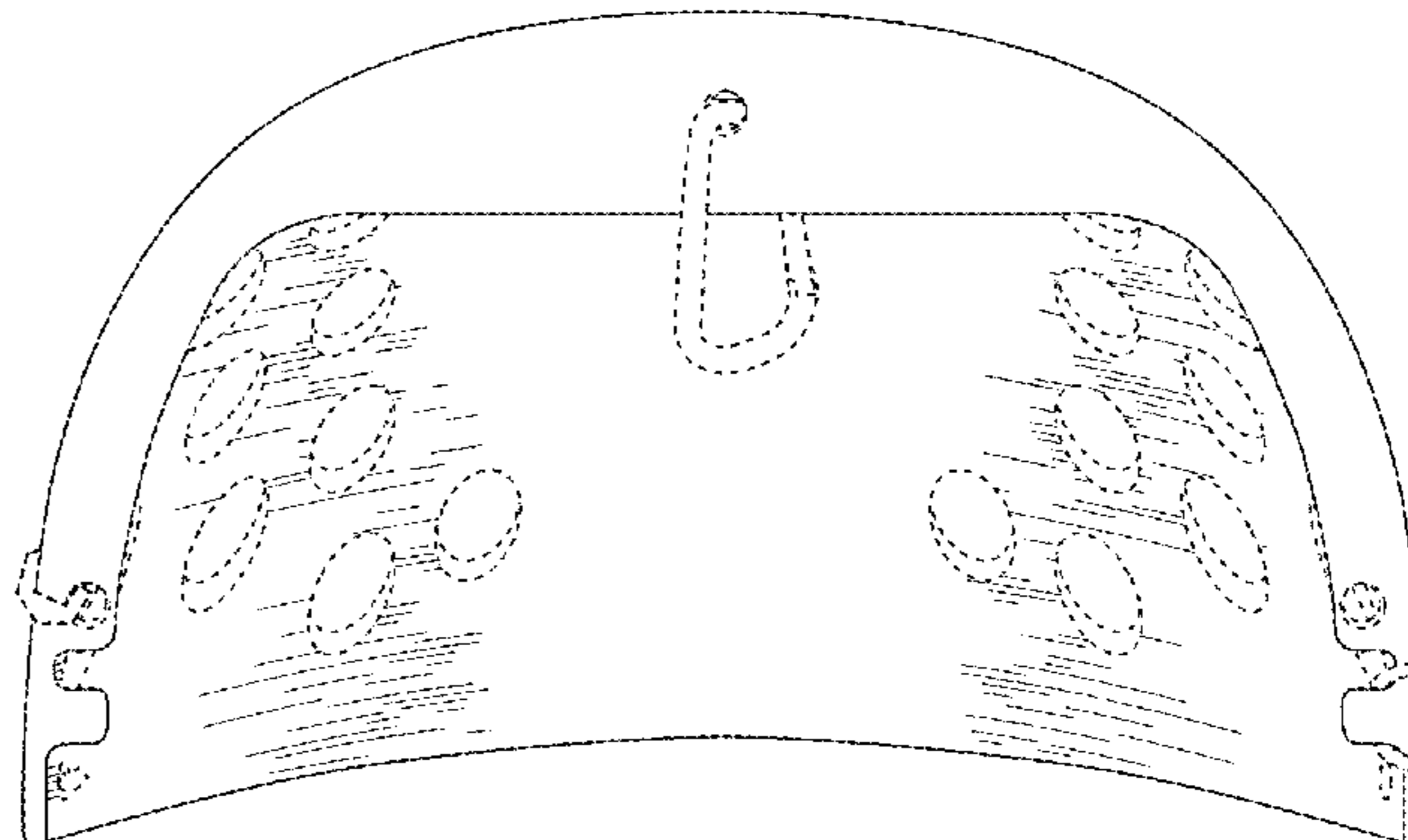
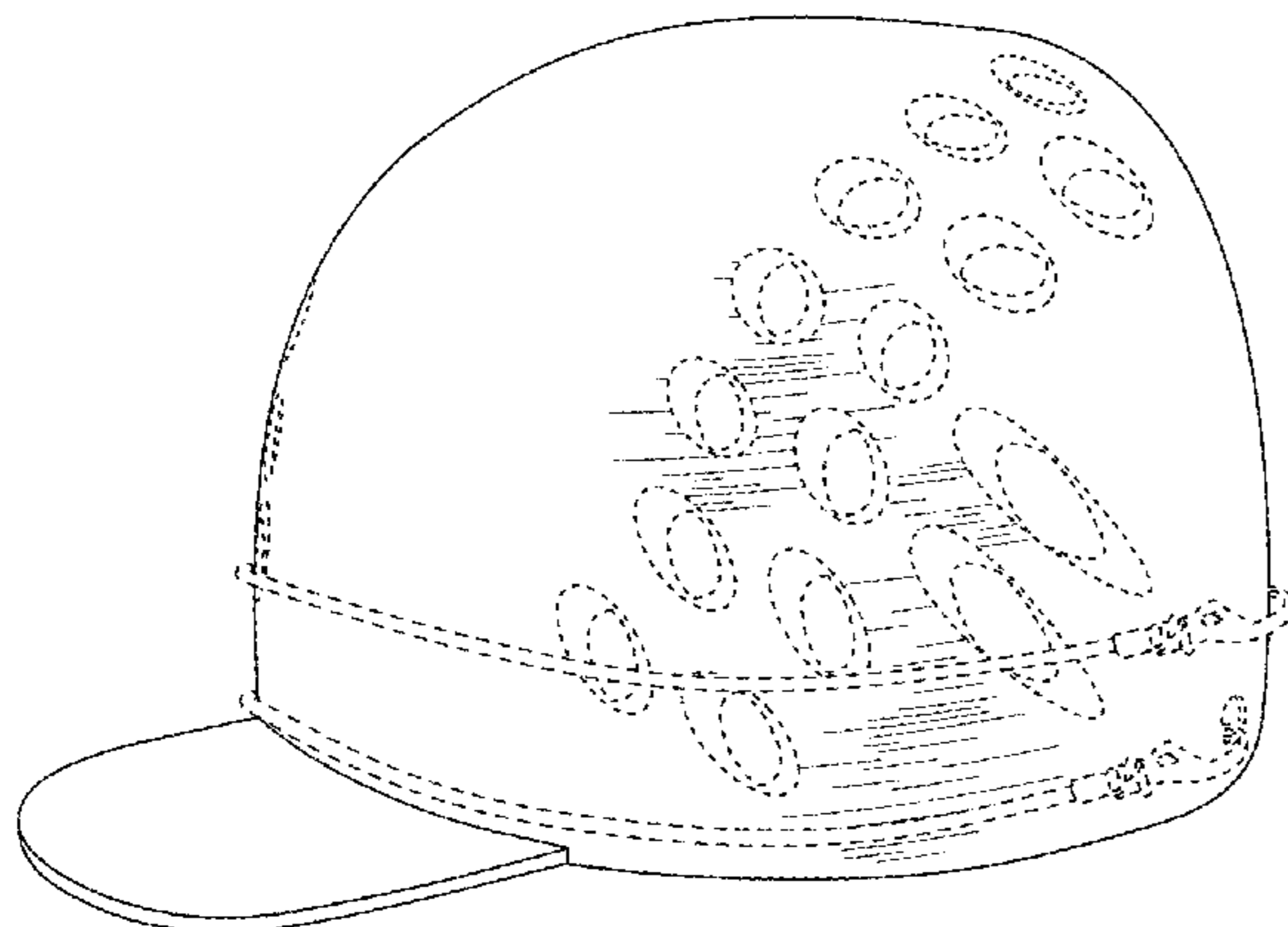

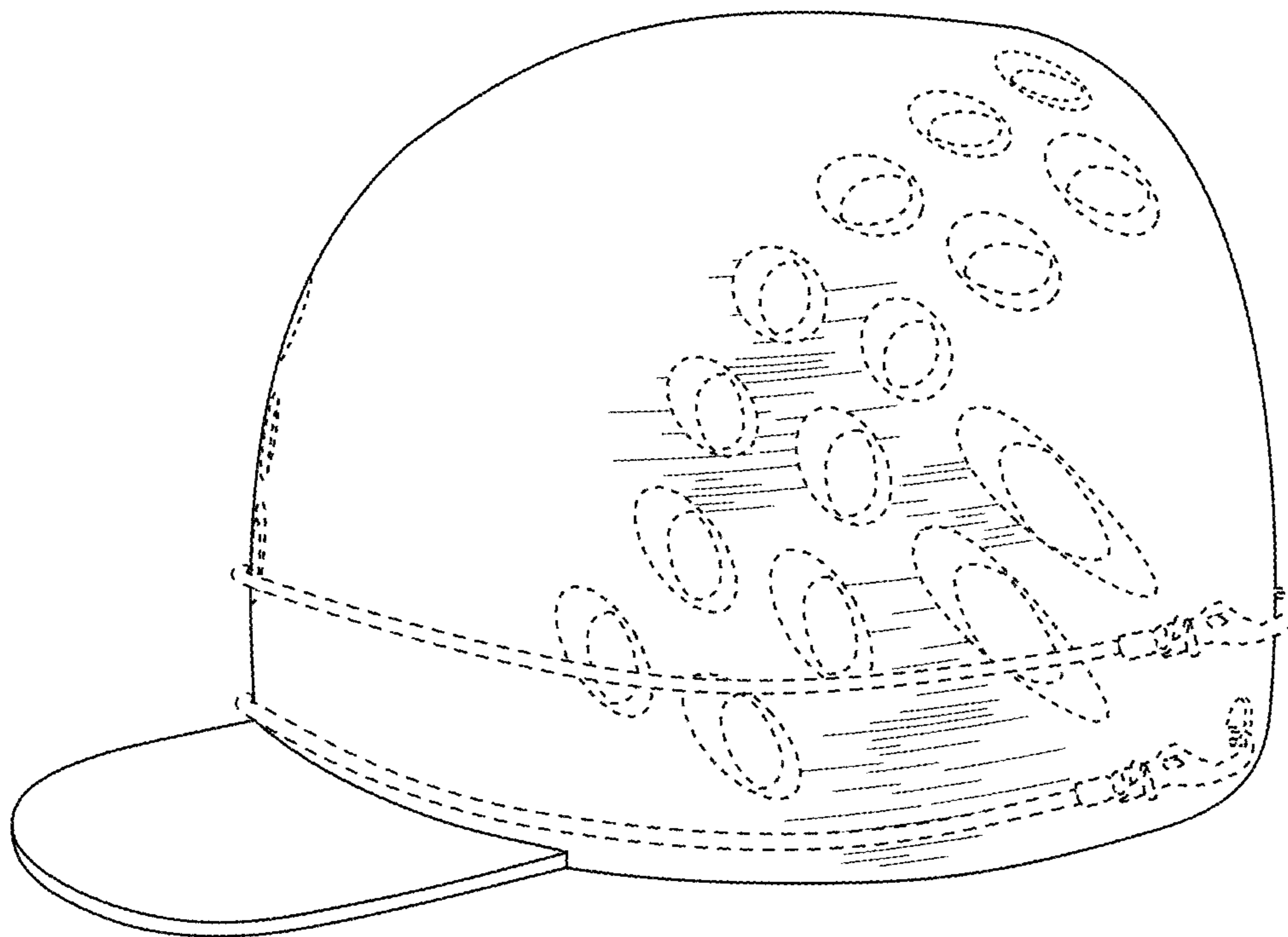

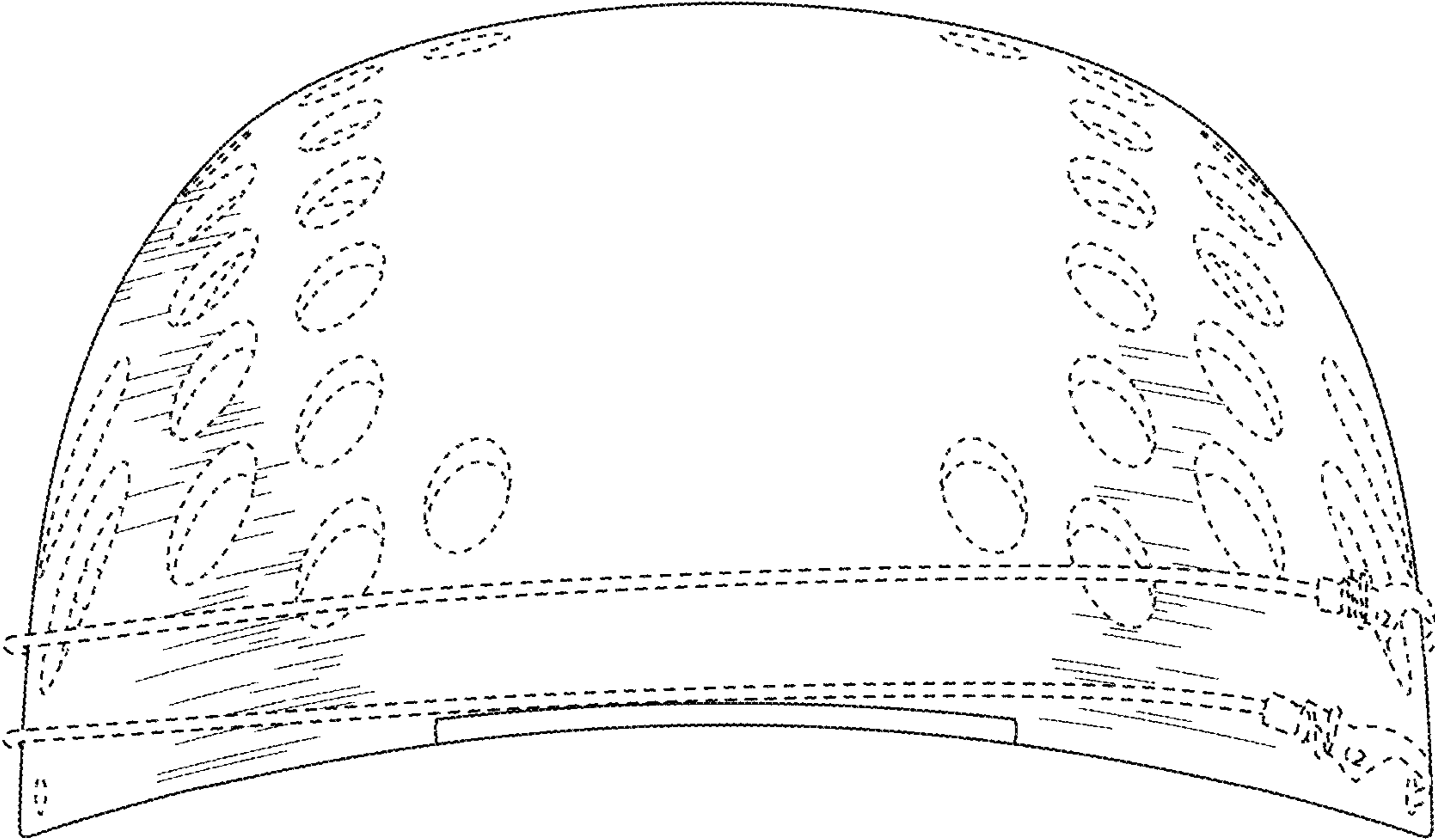

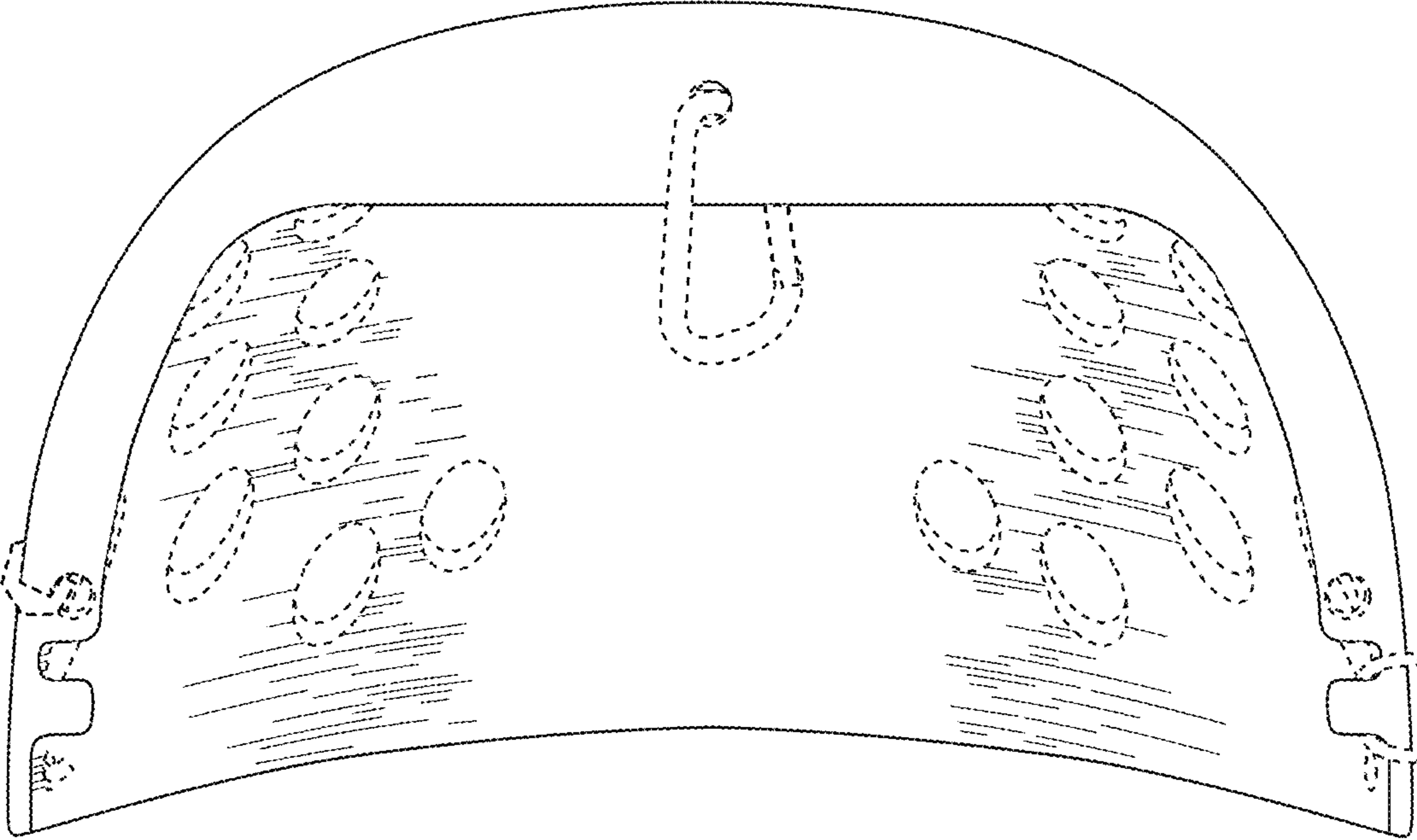

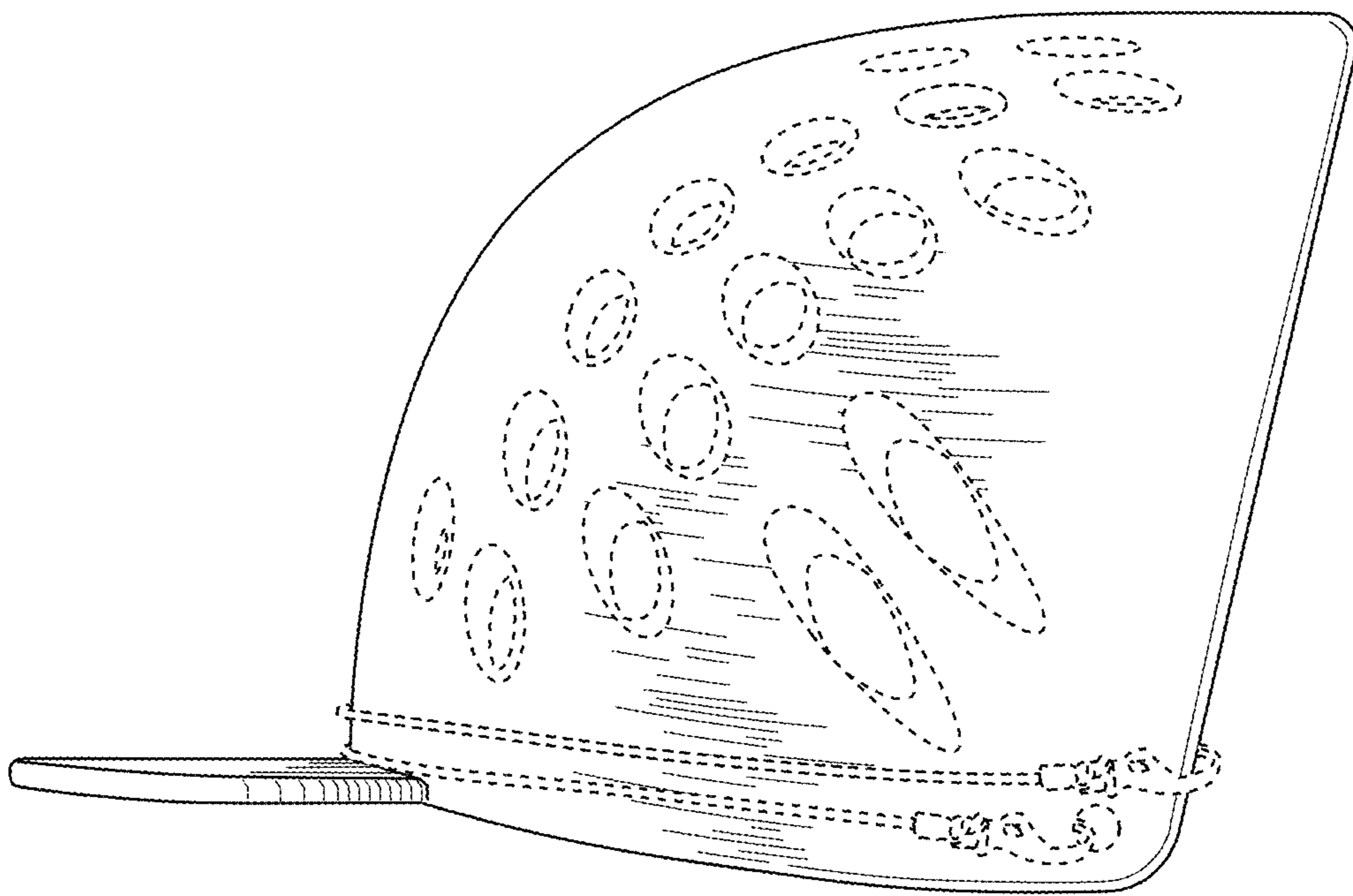

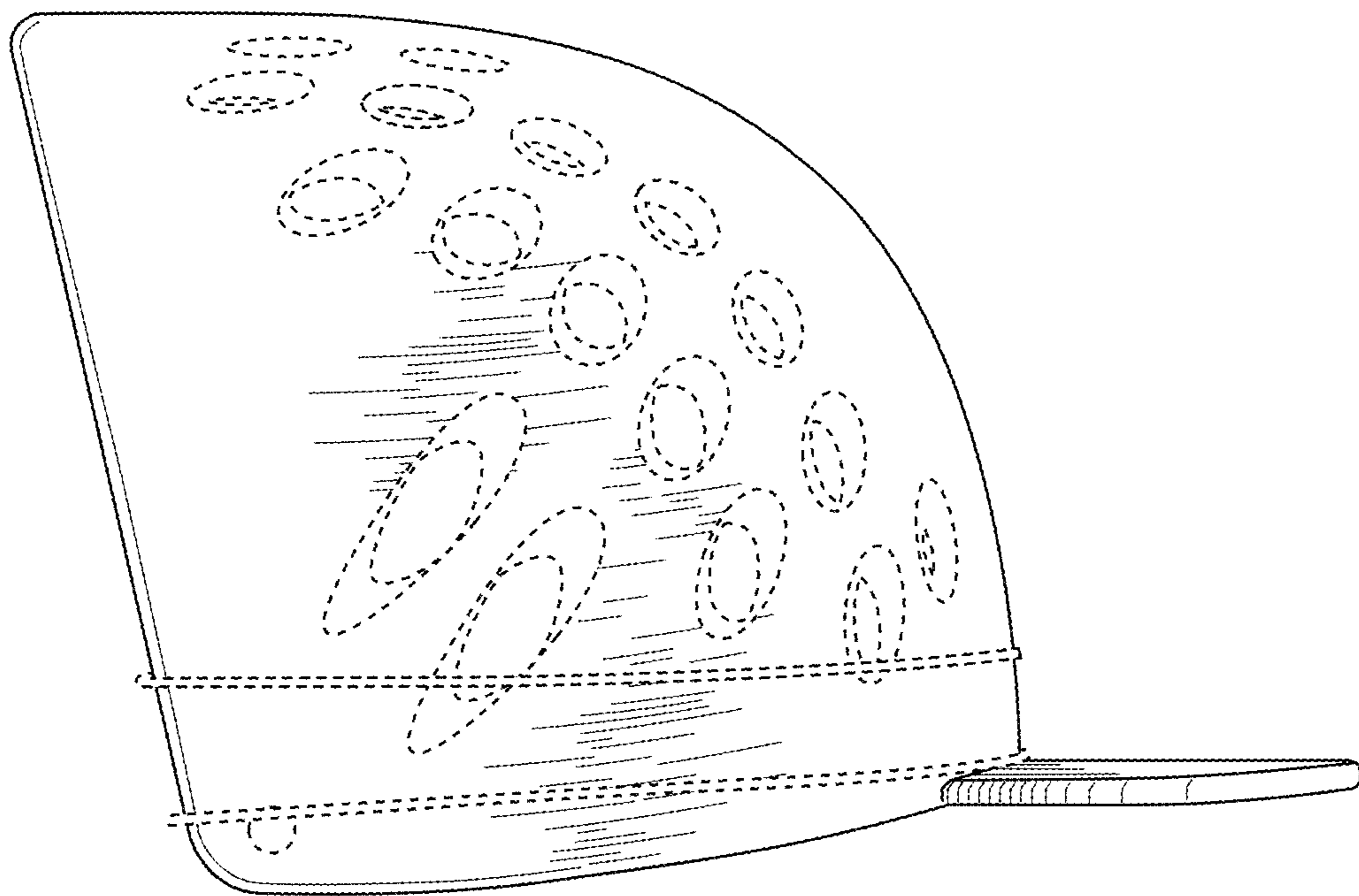

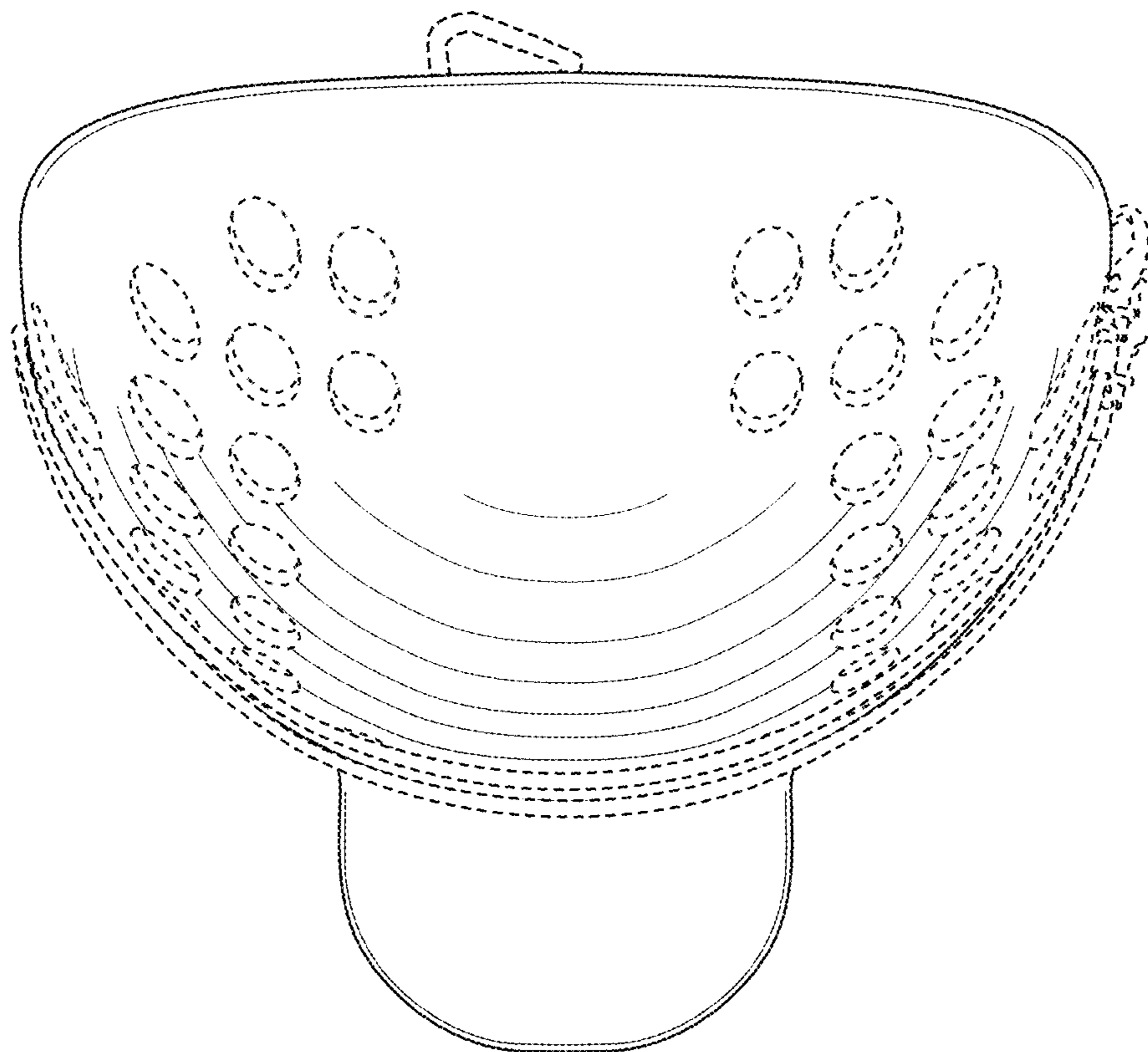

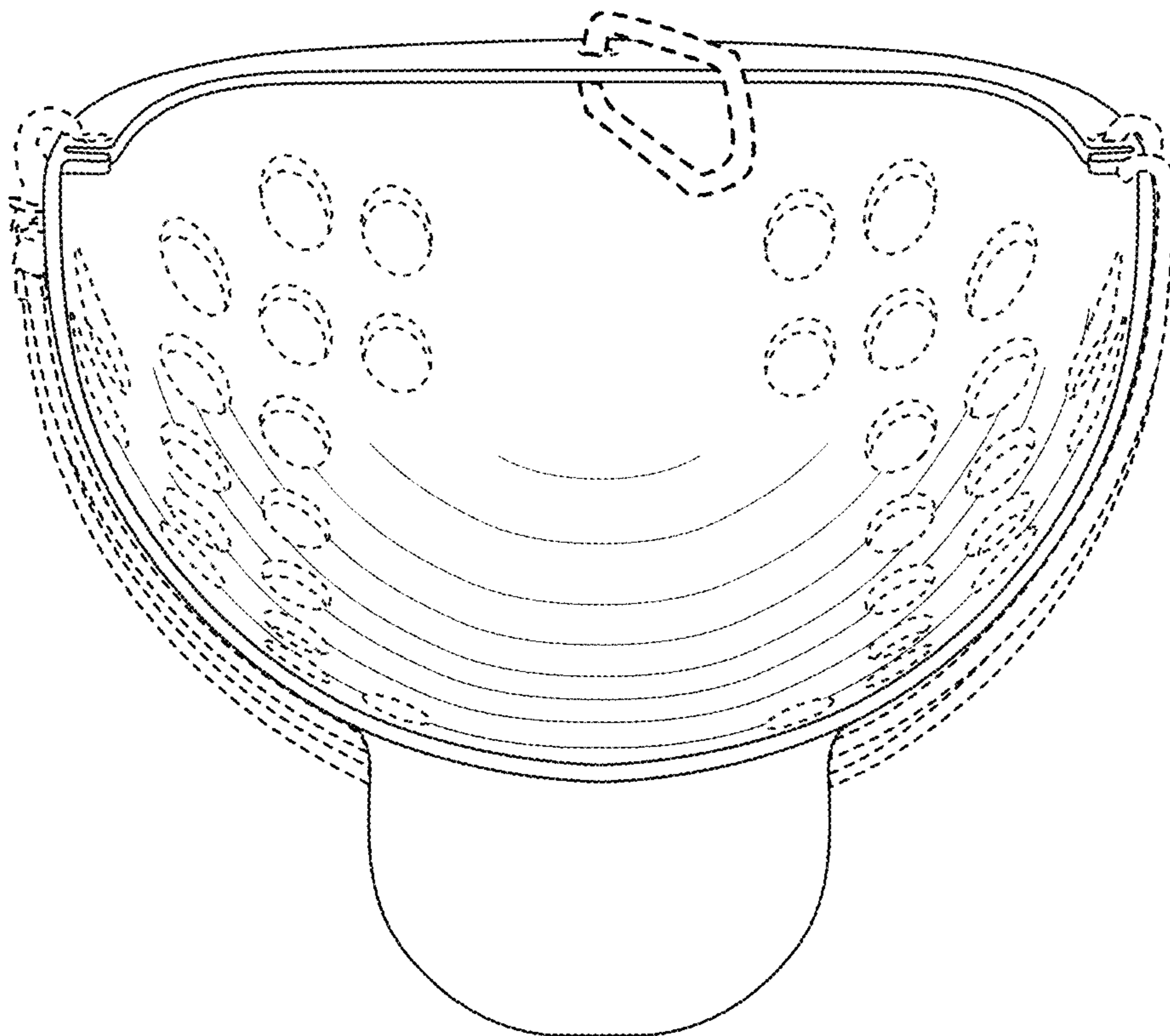
