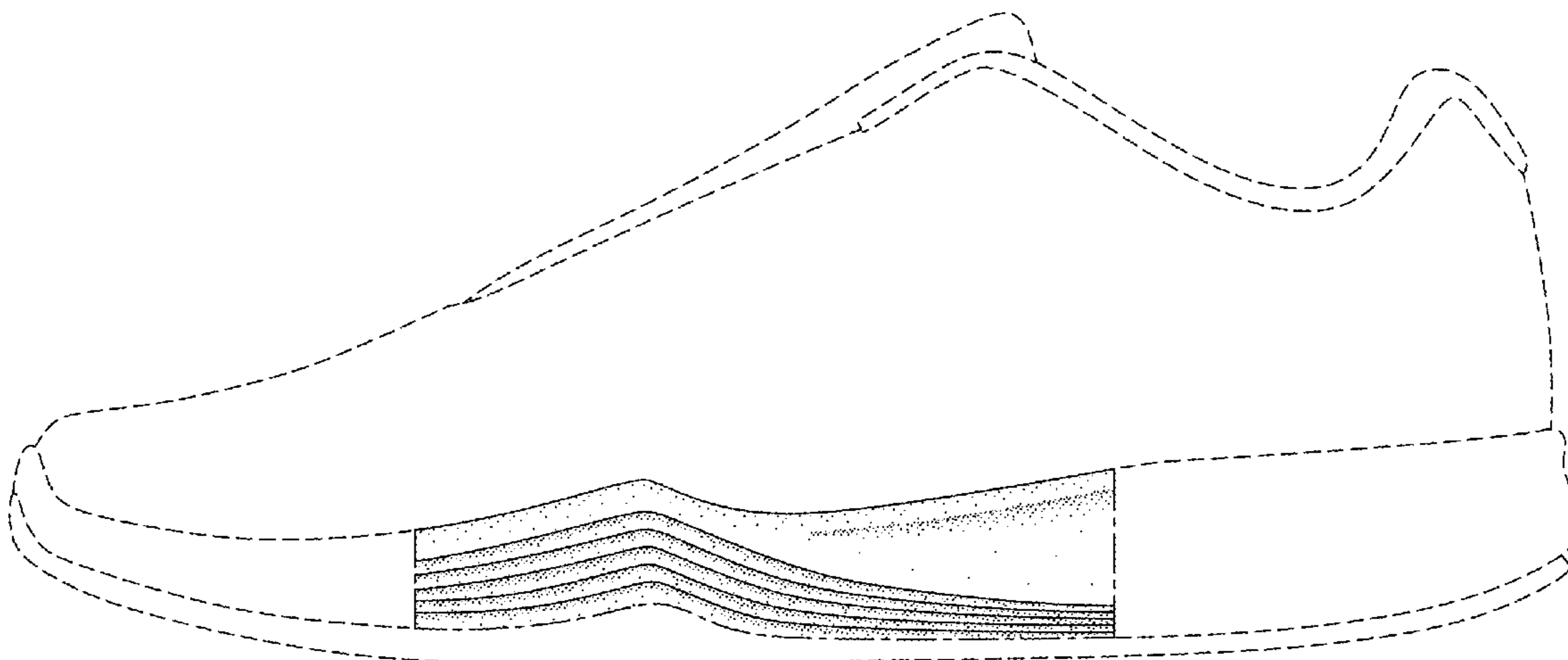
(57) **CLAIM**

The ornamental design for a shoe midsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front lateral side perspective view of a shoe midsole showing my new design; FIG. 2 is a lateral side view thereof; and, FIG. 3 is a rear lateral side perspective view thereof. The long and short broken lines are boundary lines, which define the bounds of the claimed design. These boundaries do not exist in reality in the article embodying the design. 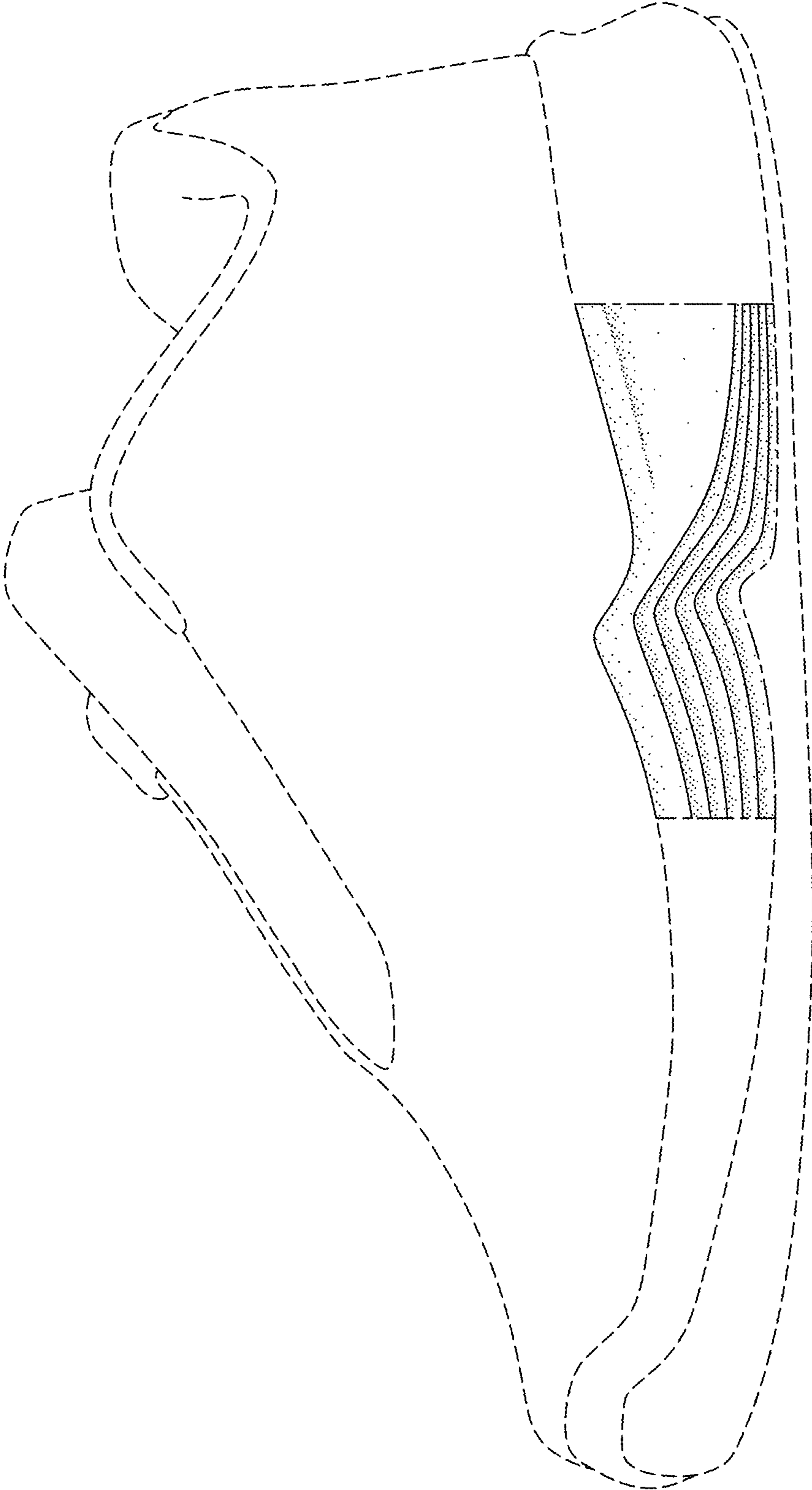

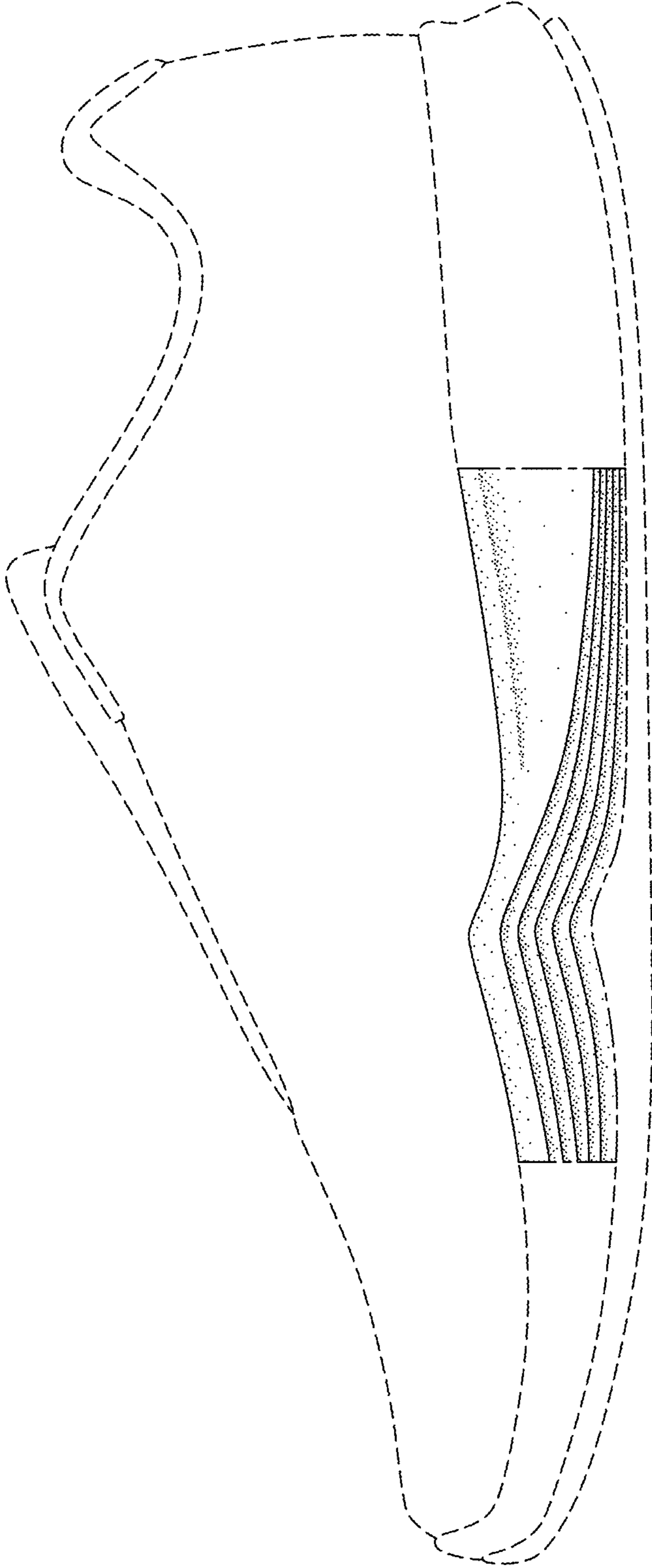

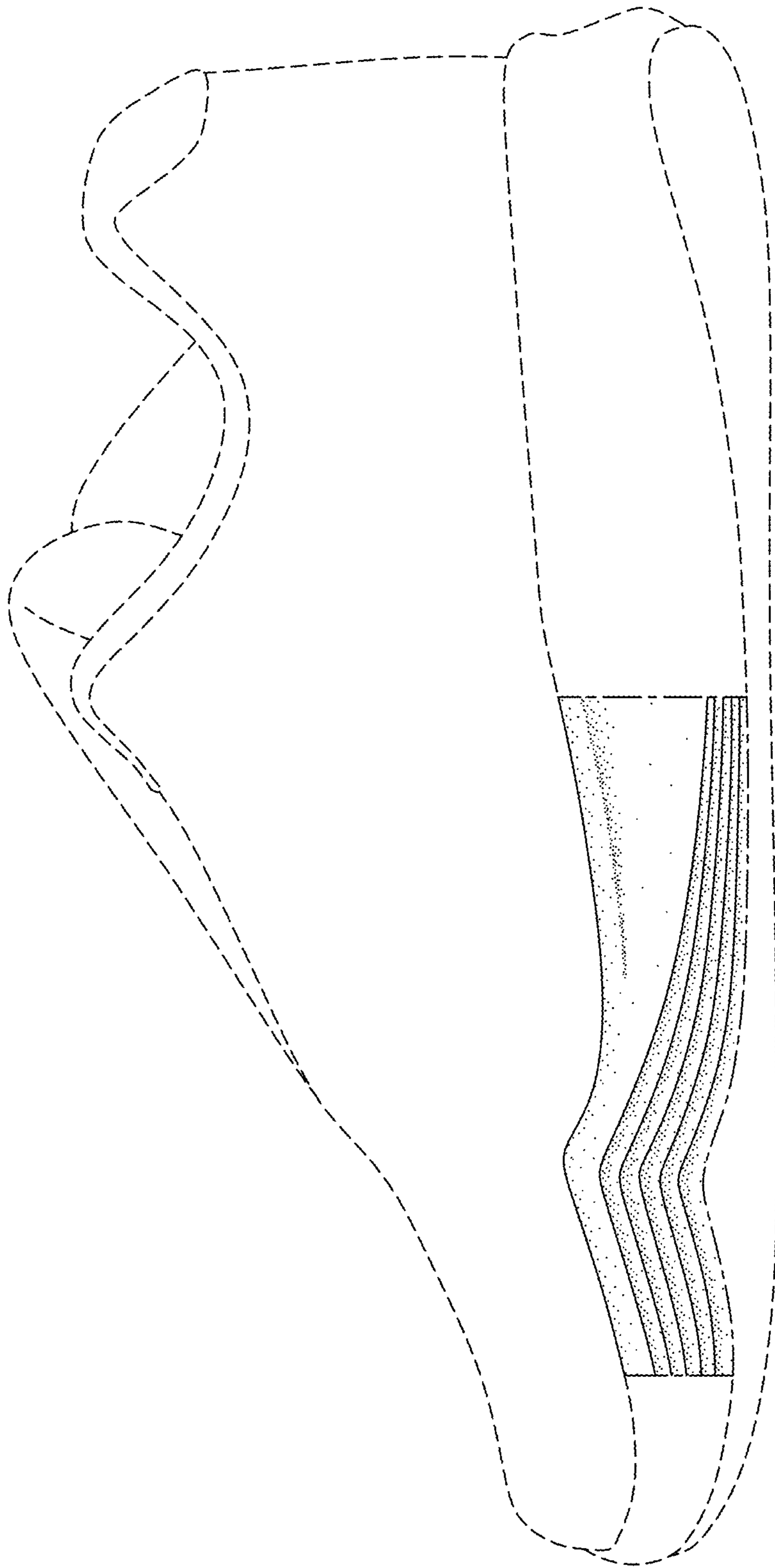
