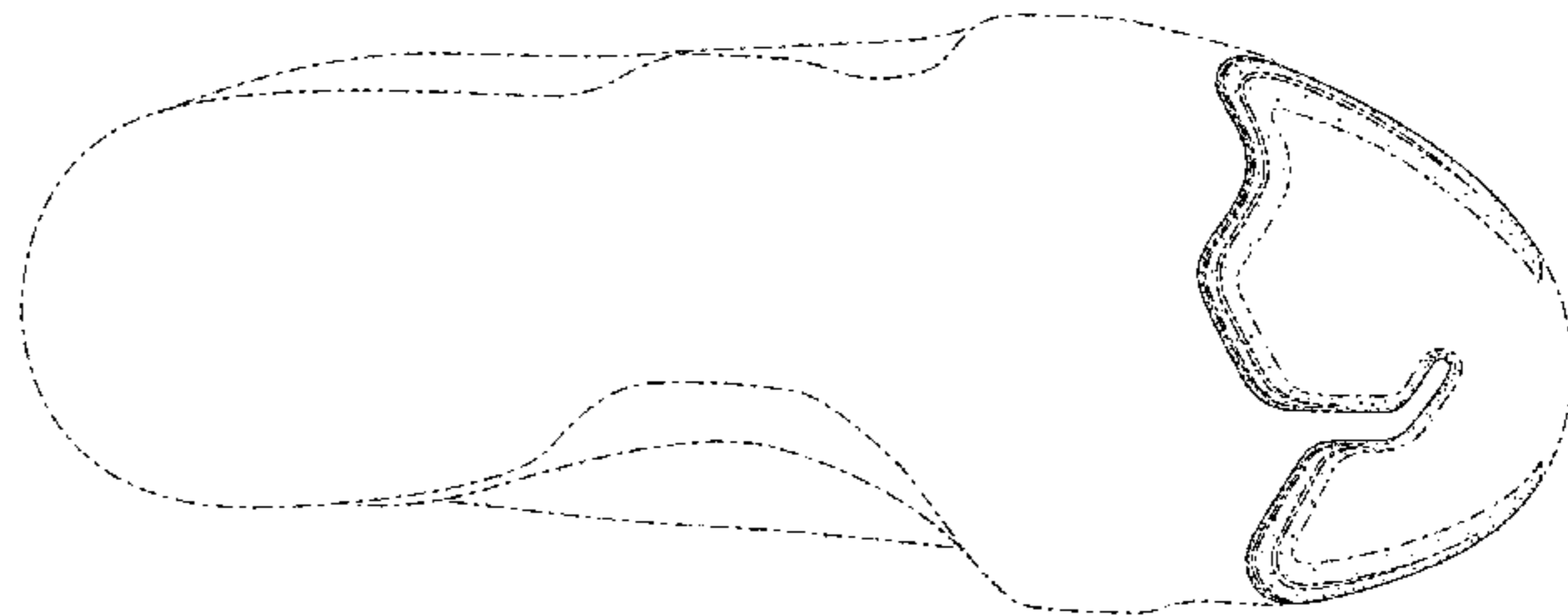
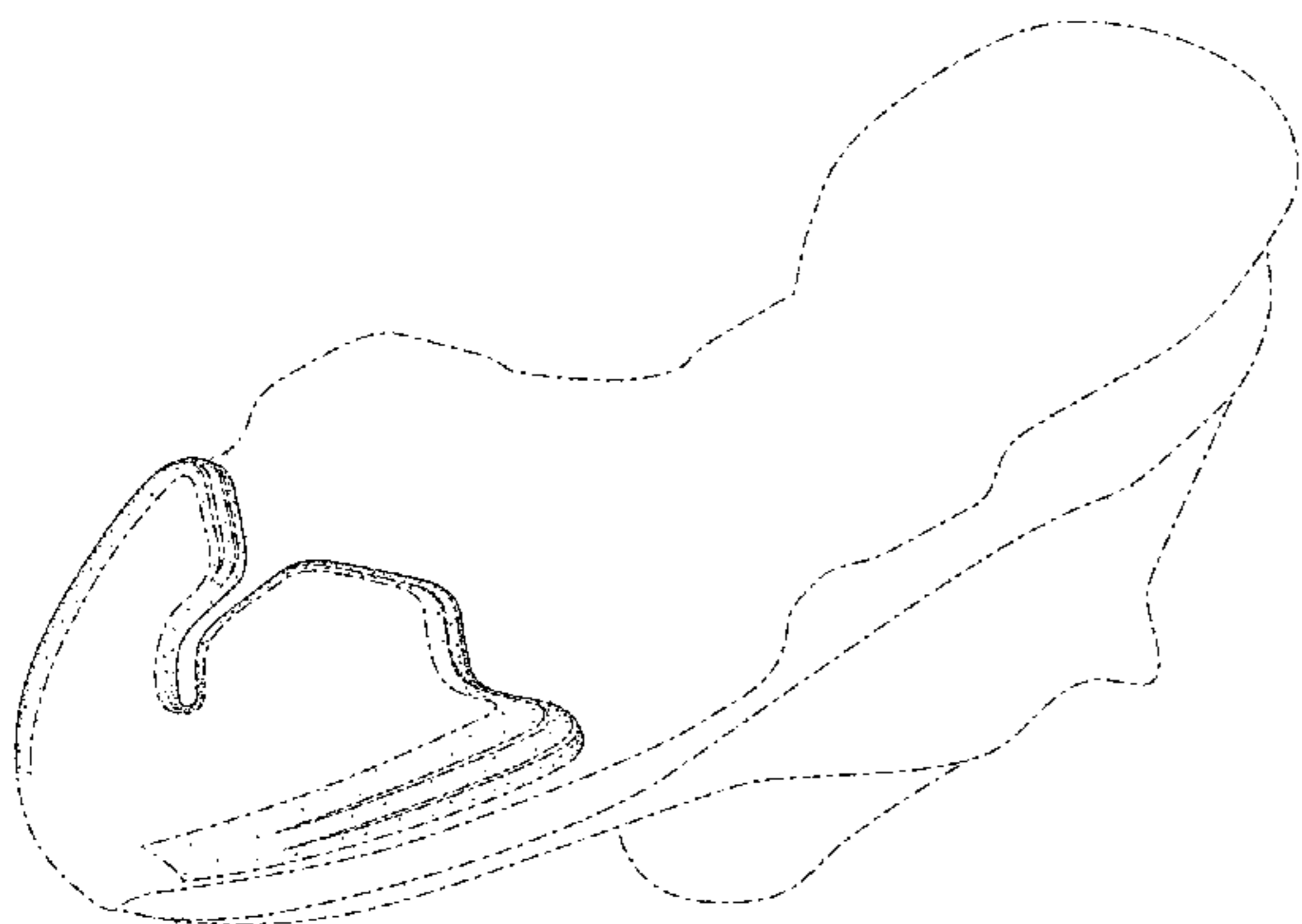
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;  
FIG. 2 is a bottom view thereof; and,  
FIG. 3 is a rear perspective view thereof.  
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the elongated generally horizontal grooves and remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

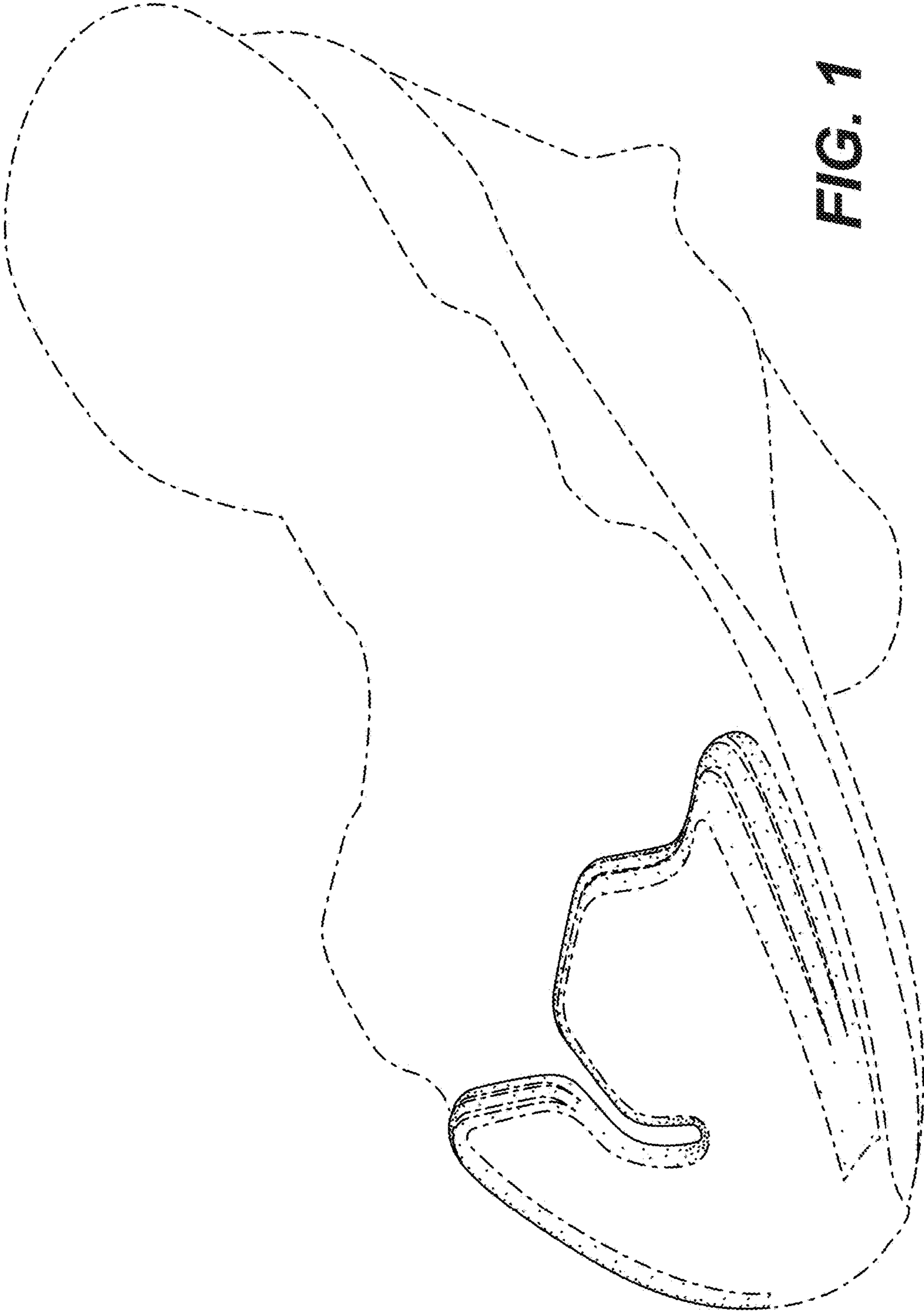
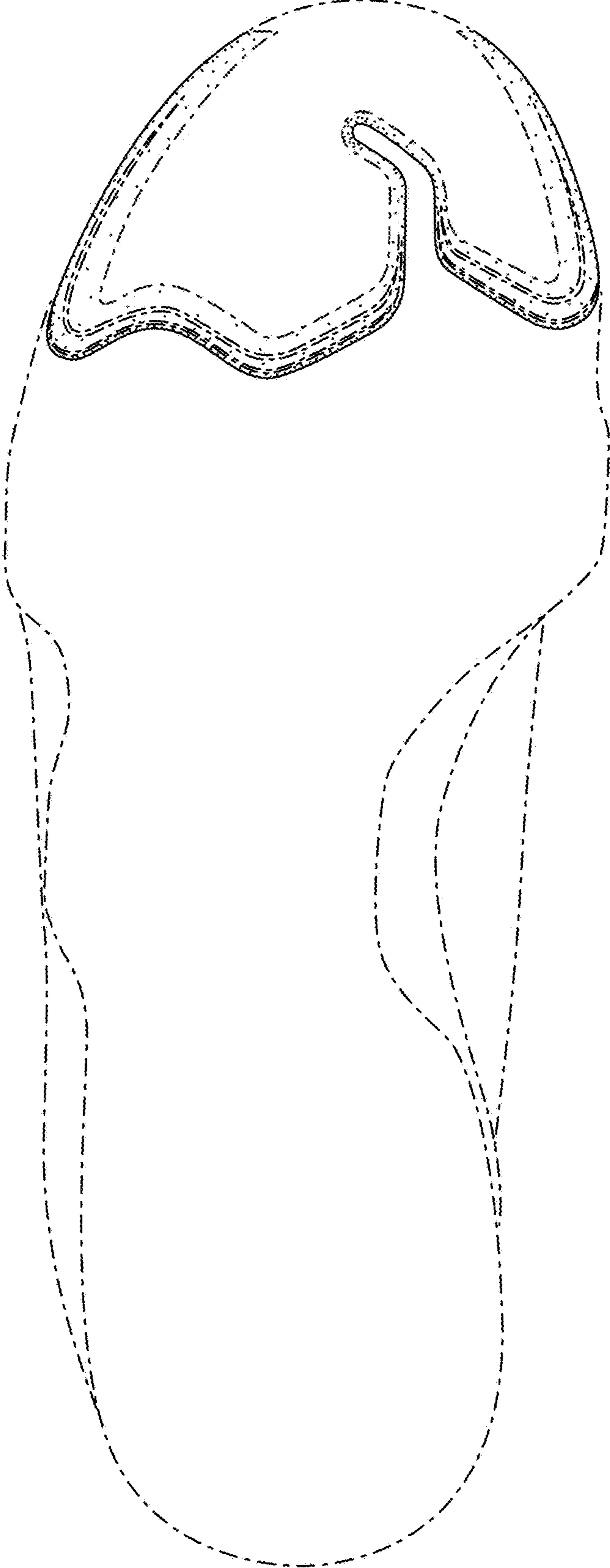

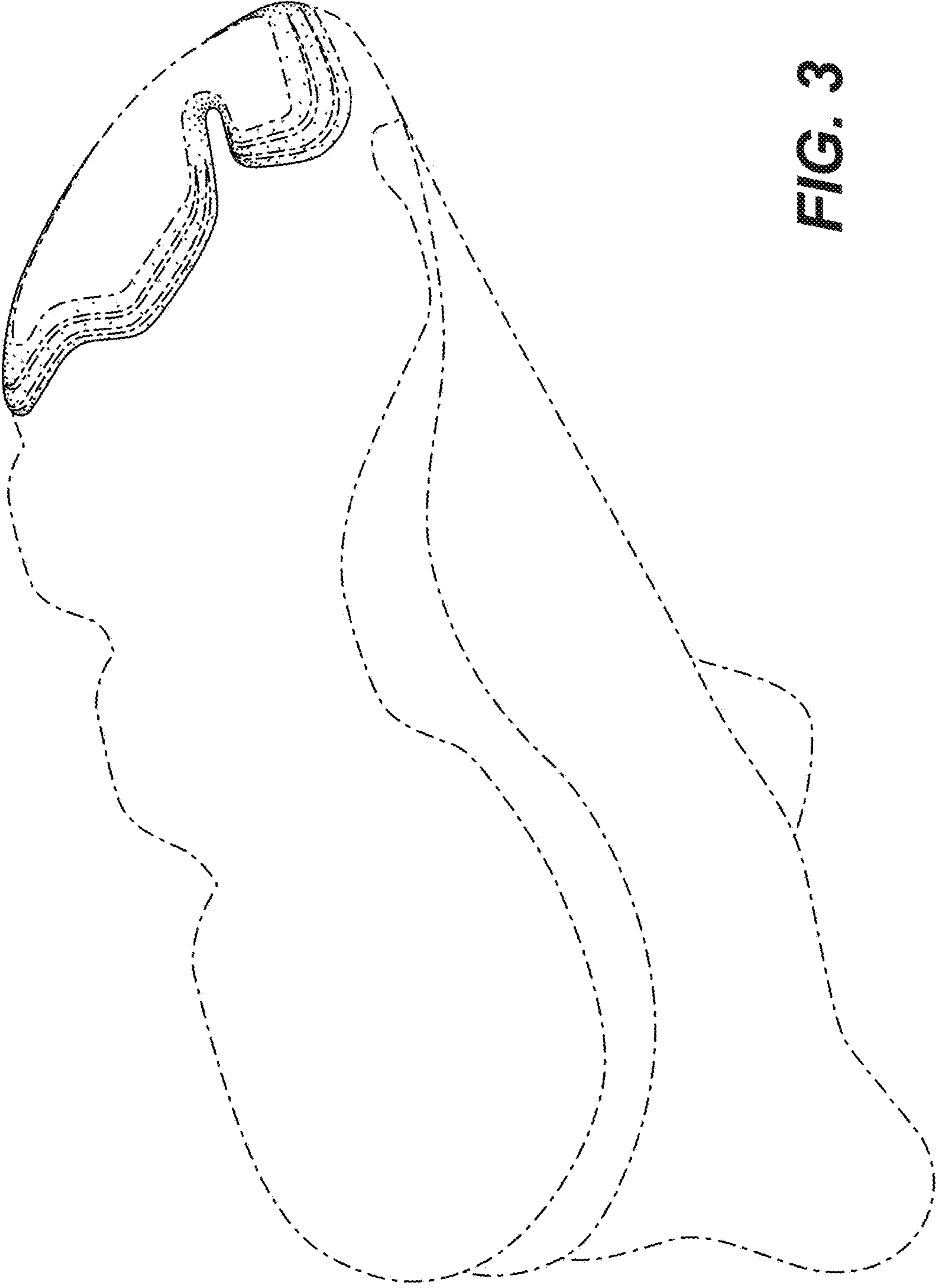
