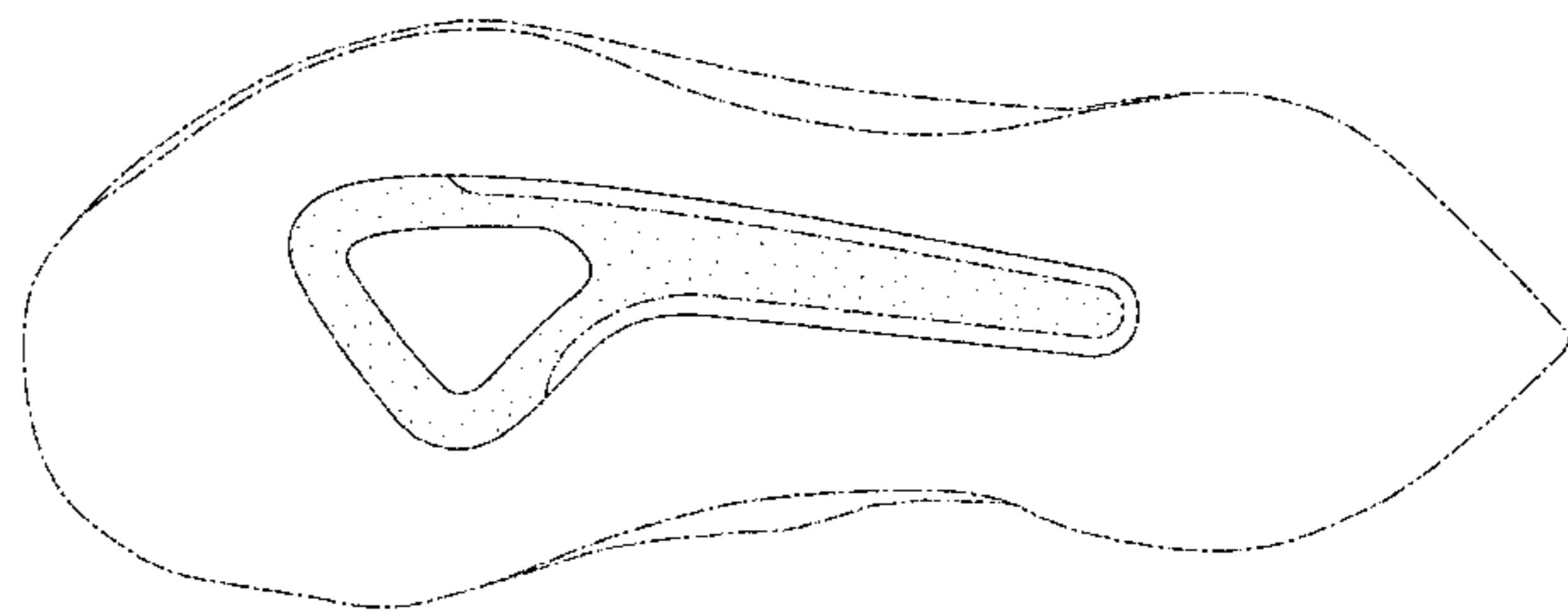
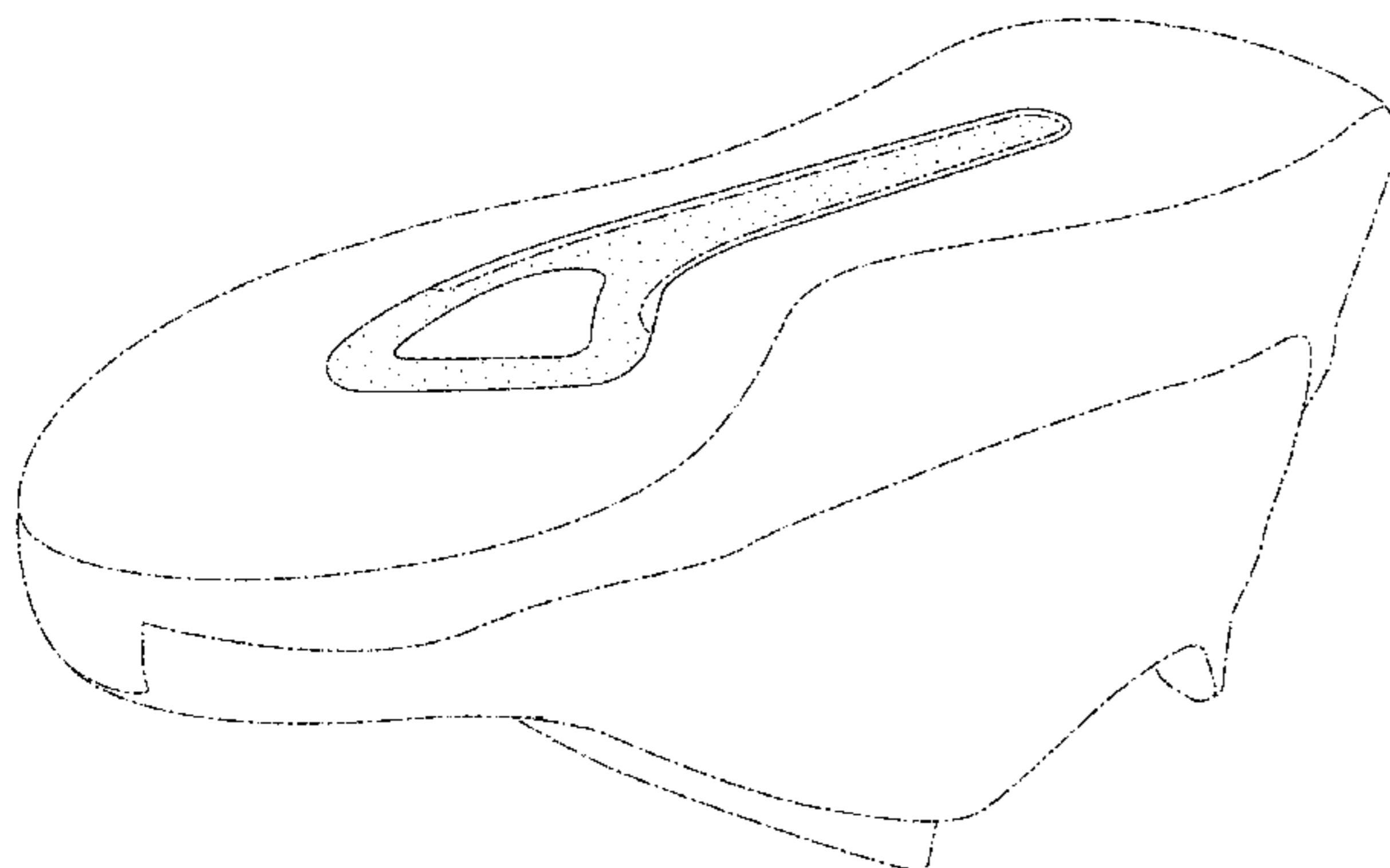
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
 FIG. 2 is a bottom view thereof; and,
 FIG. 3 is a rear perspective view thereof.
 The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The unshaded region within the shaded area that is demarcated by solid lines forms no part of the claimed design. The unshaded region adjacent to the shaded area that is demarcated by solid and broken lines forms no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

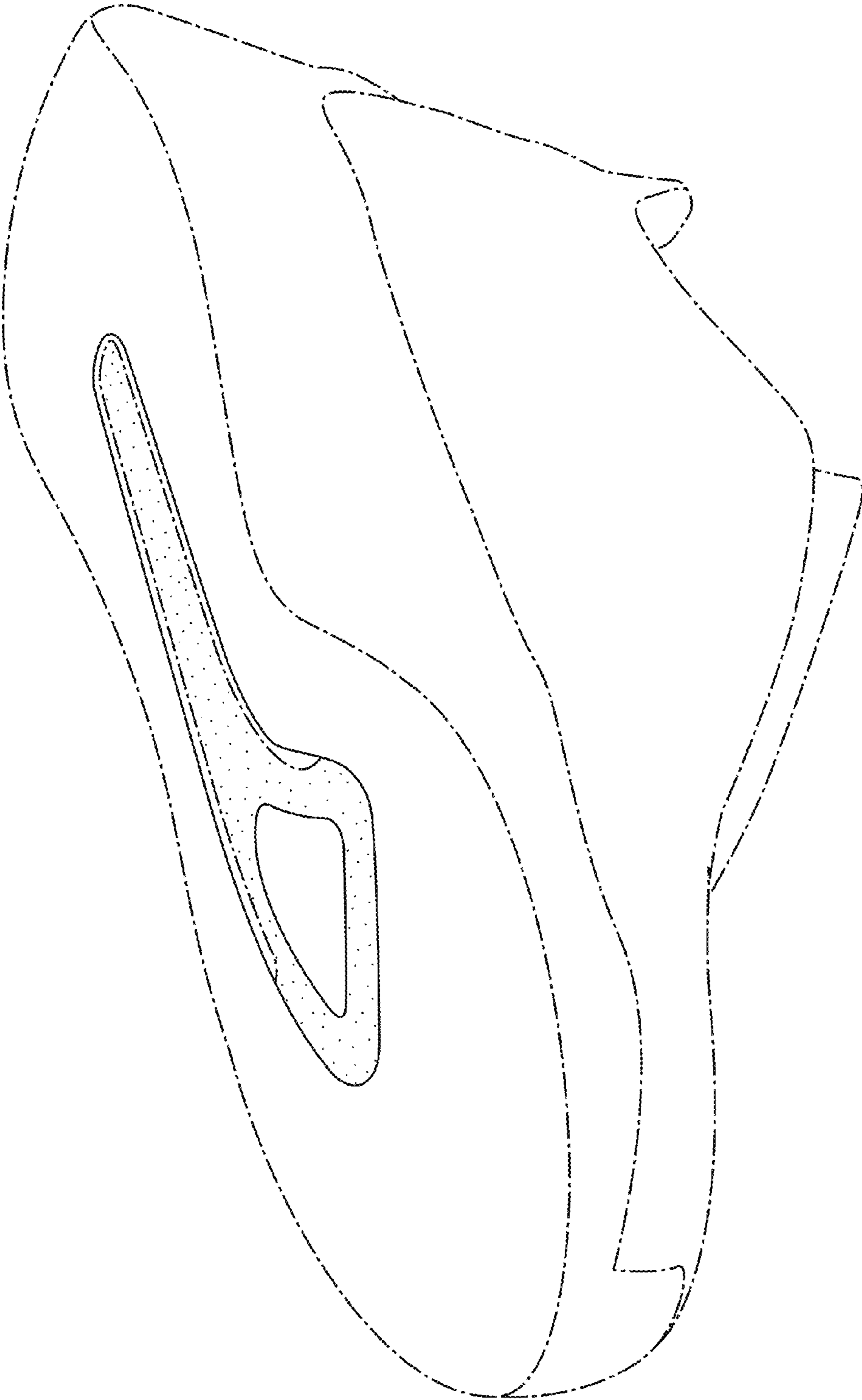

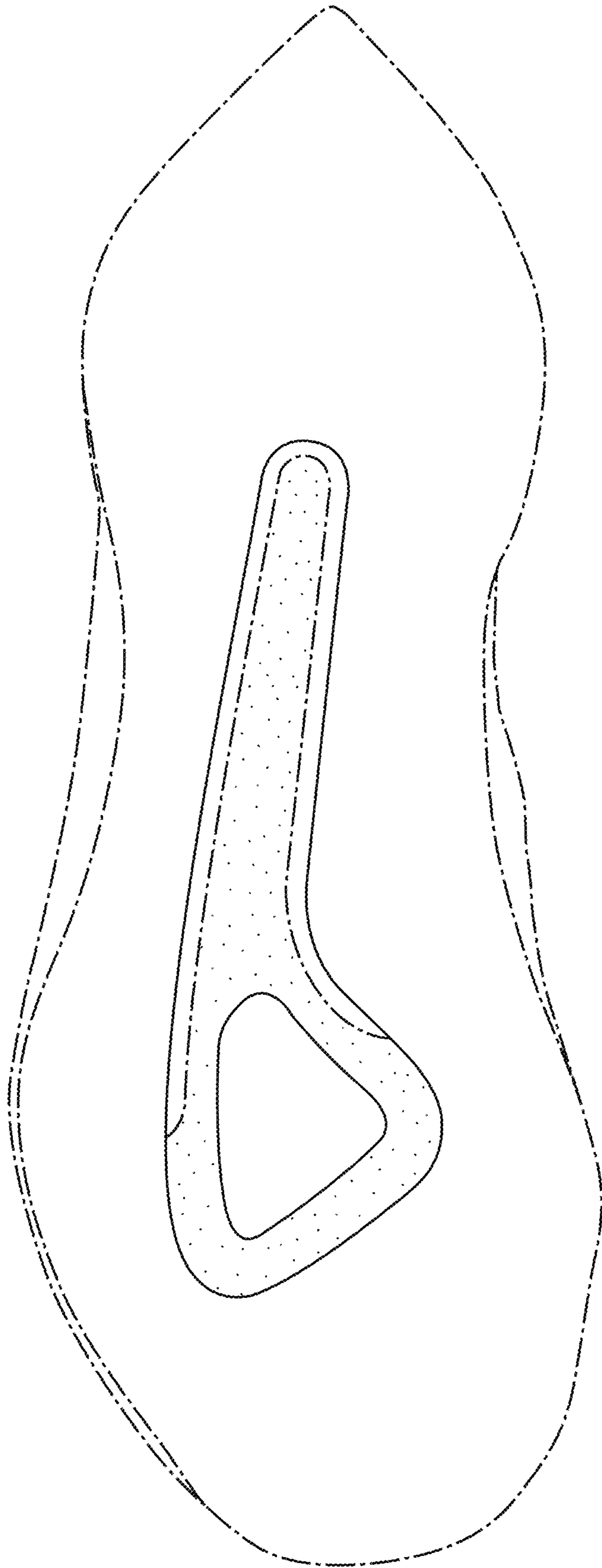

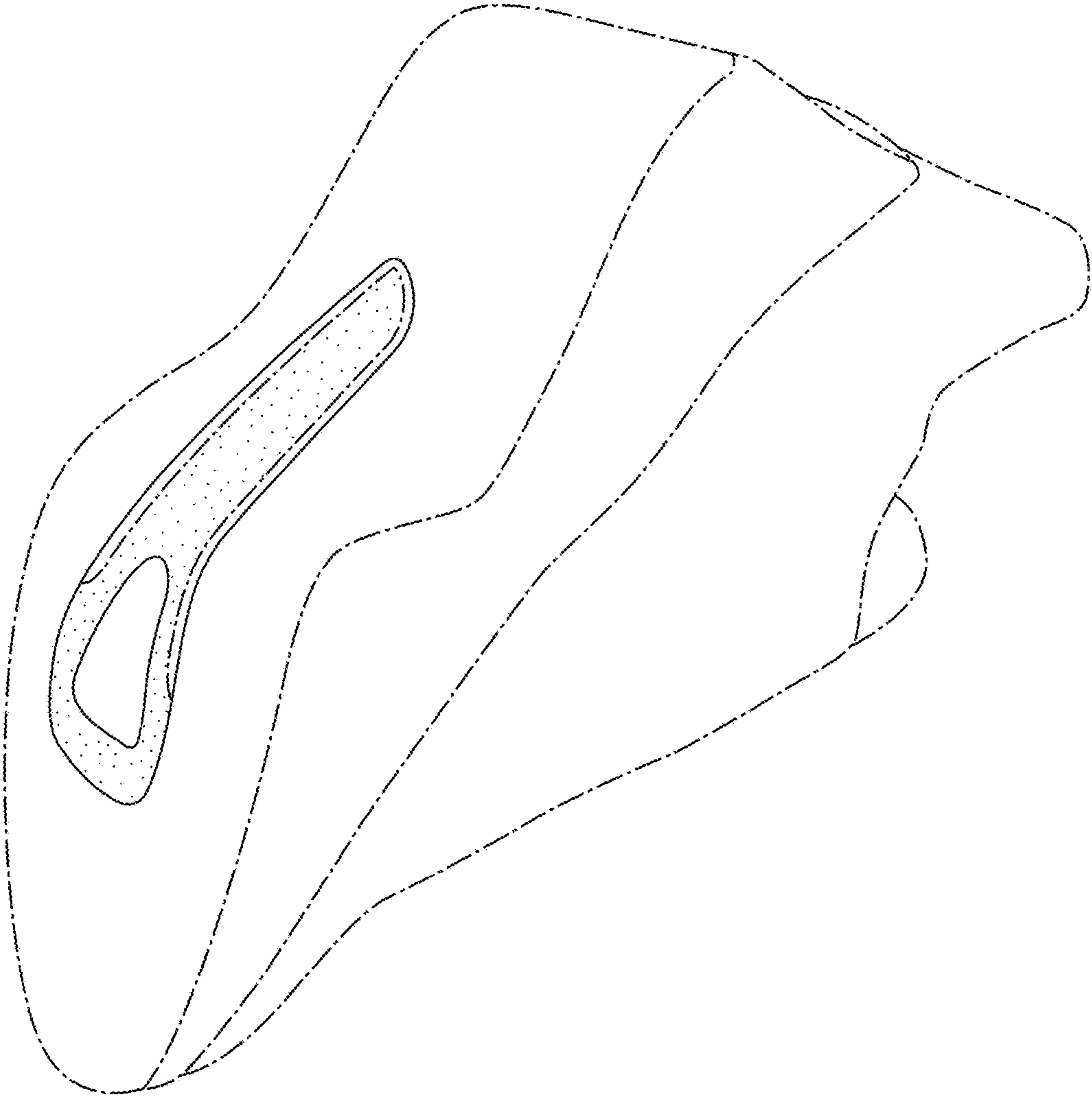
