footwear article;

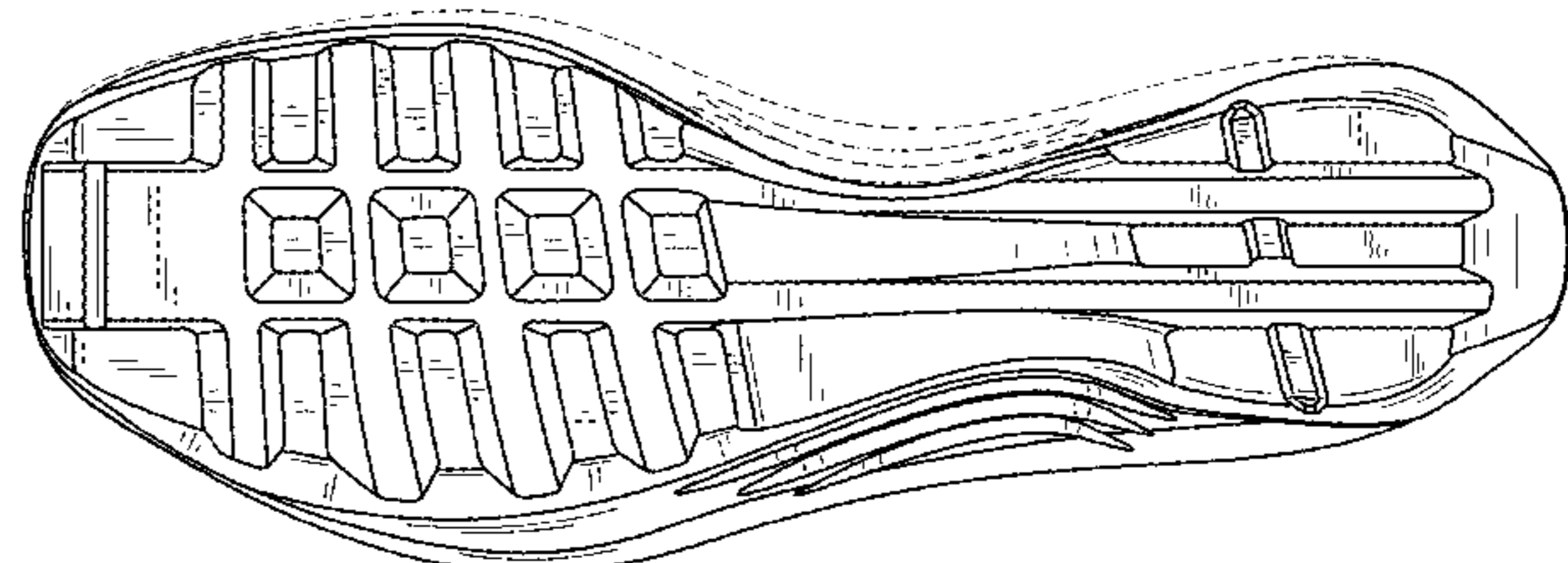
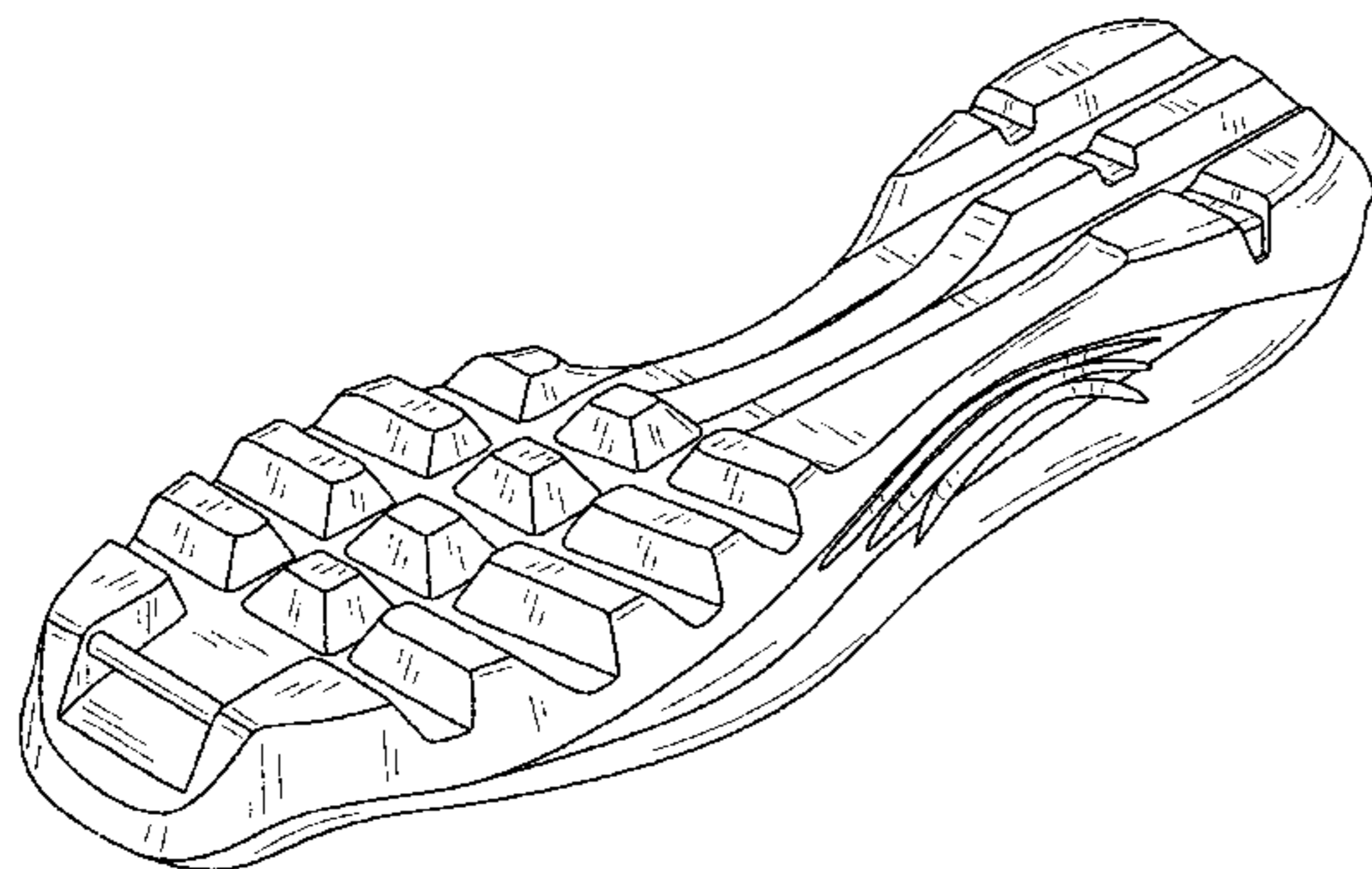
FIG. 2 is a bottom view of the sole of a footwear article of

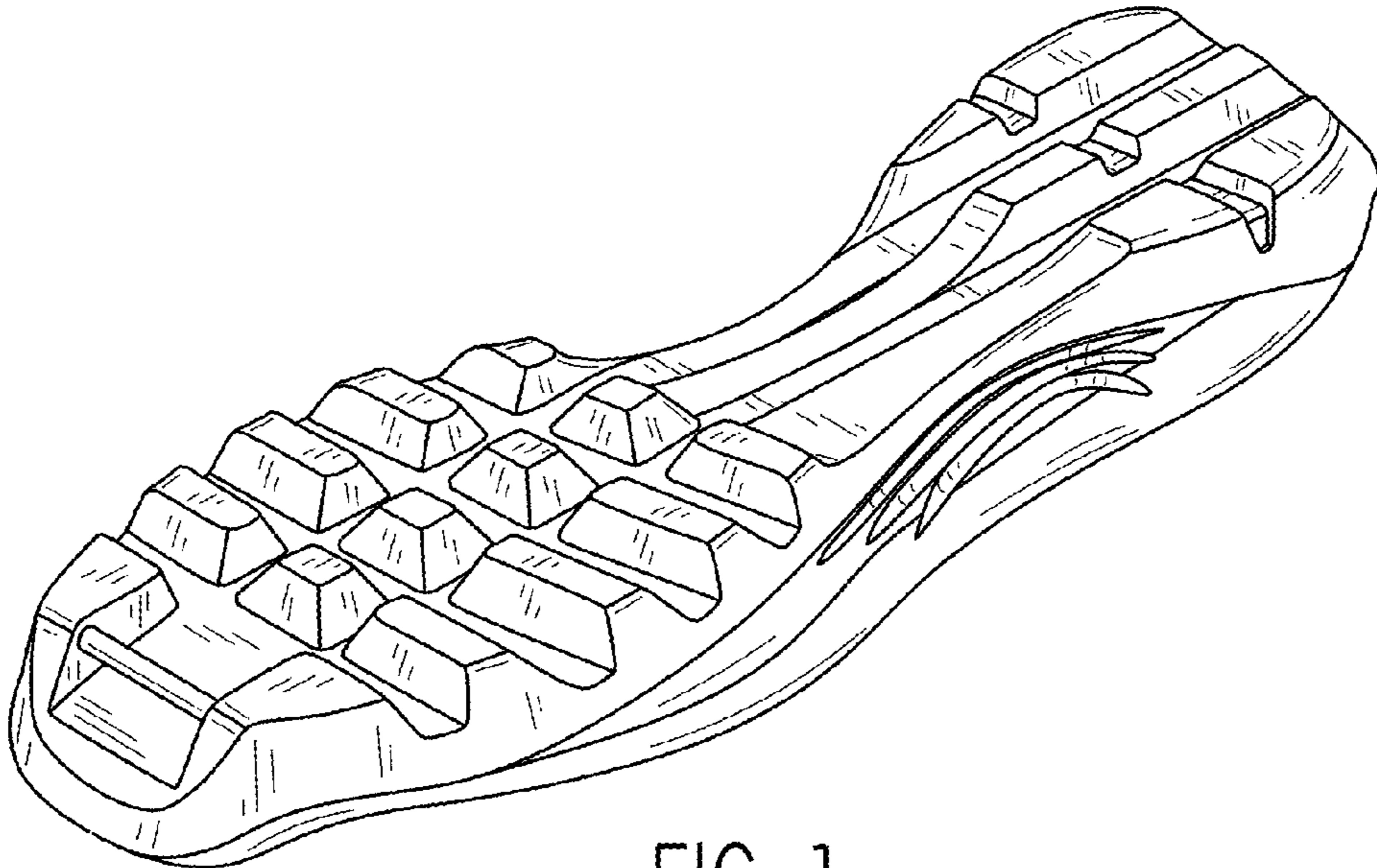

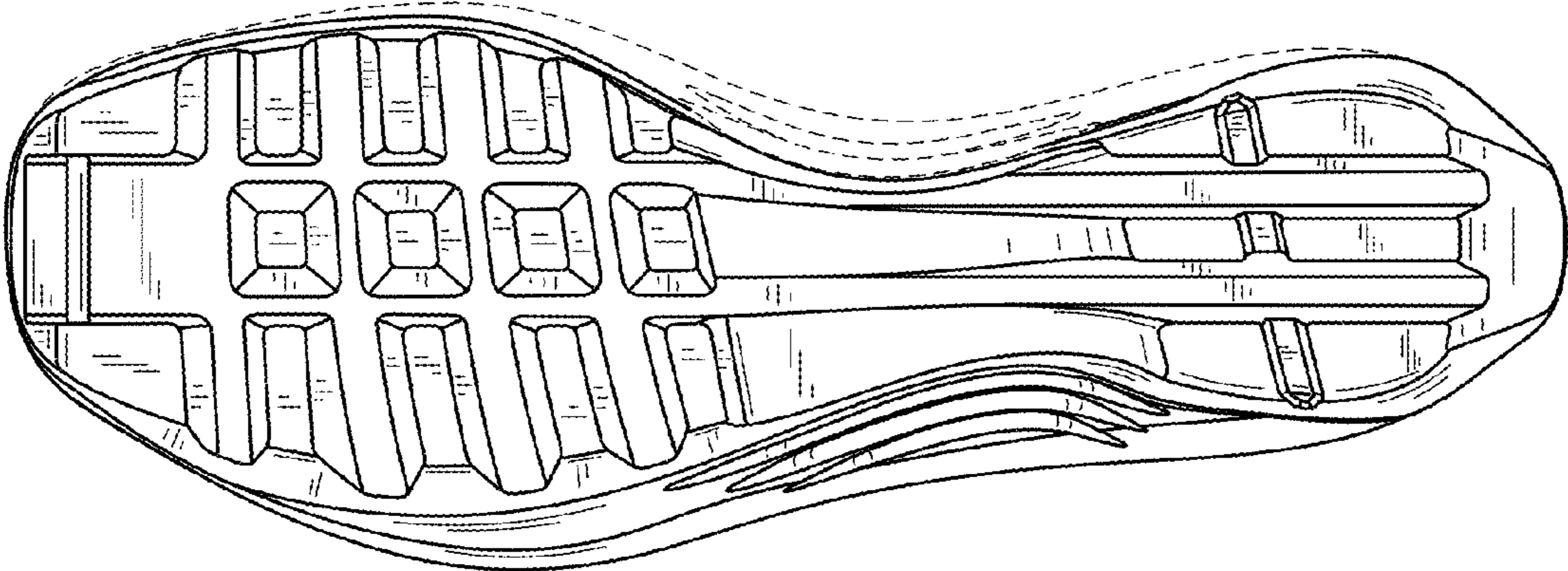

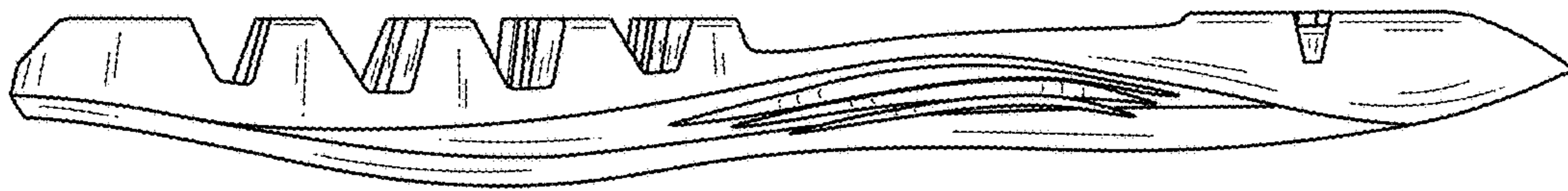
