The ornamental design for a pair of grip socks with open
tops, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pair of left and right grip
socks showing my new design;

FIG. 2 is a front elevational view of the left and right socks
of FIG. 1;

FIG. 3 is a rear elevational view of the left and right socks
of FIG. 1 thereof;

FIG. 4 is a right side elevational view of the right sock of
FIG. 1, the left side elevational view of the left sock of FIG.
1 being identical thereto;

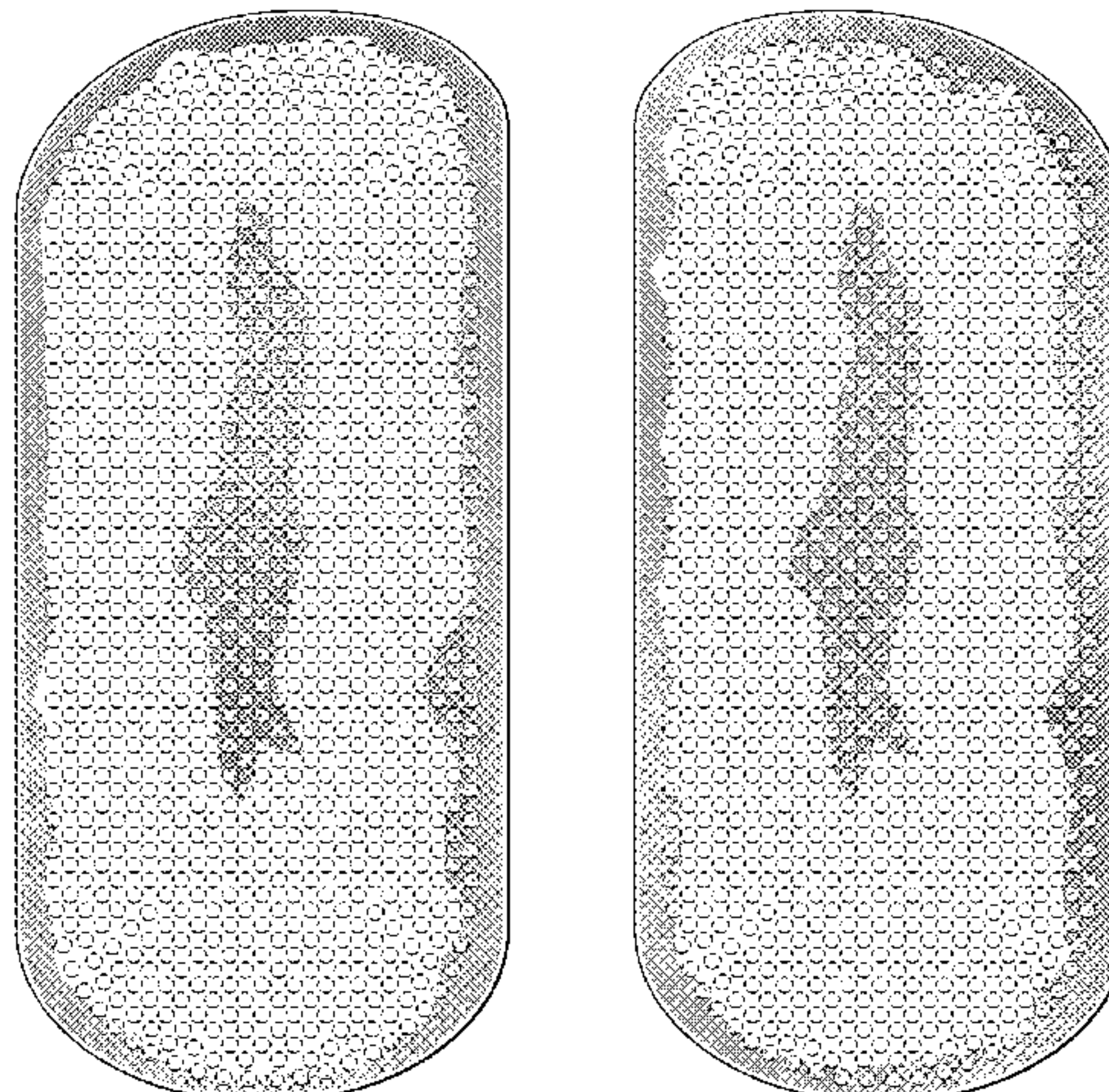
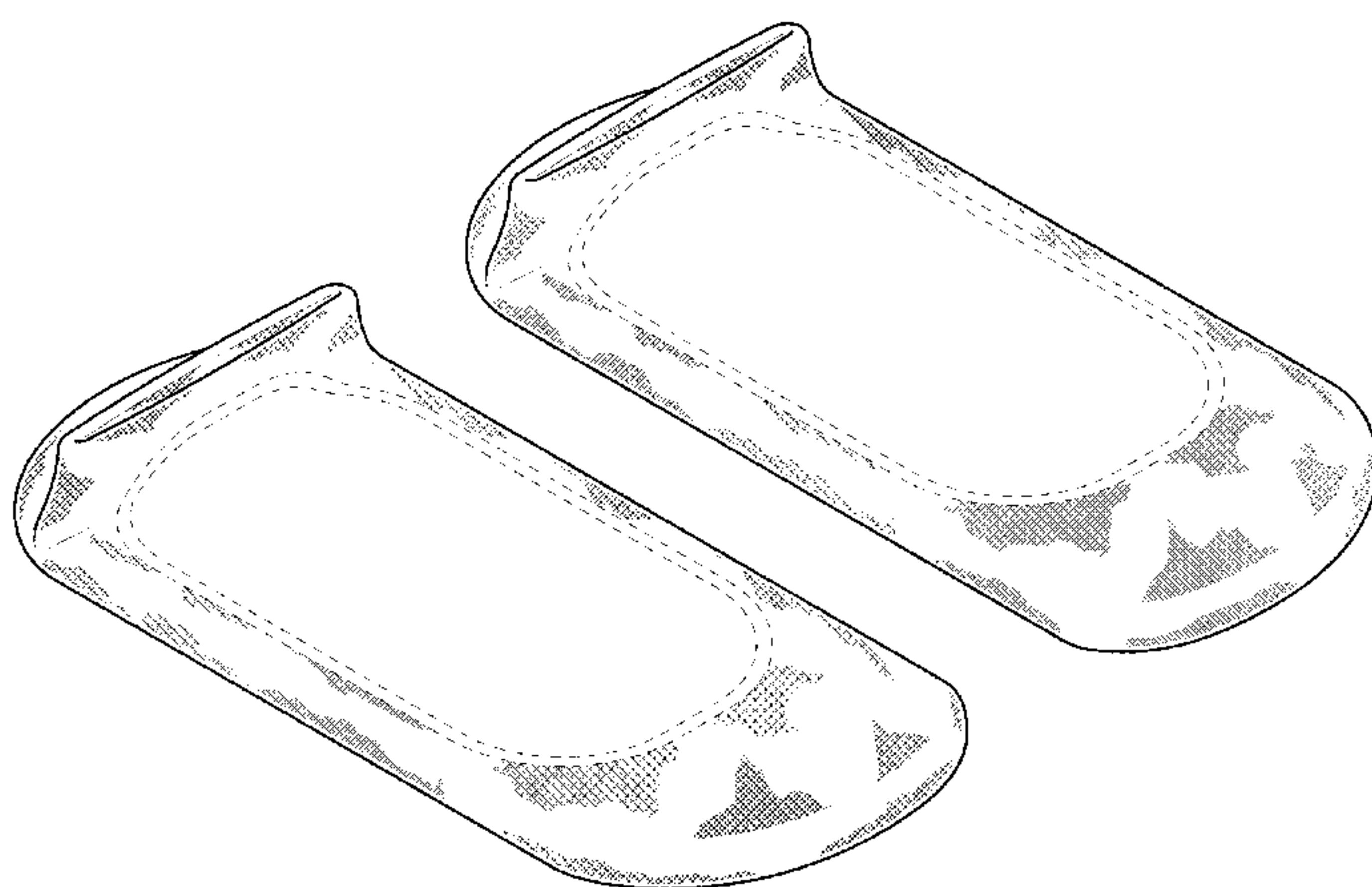
FIG. 5 is a left side elevational view of the right sock of FIG.

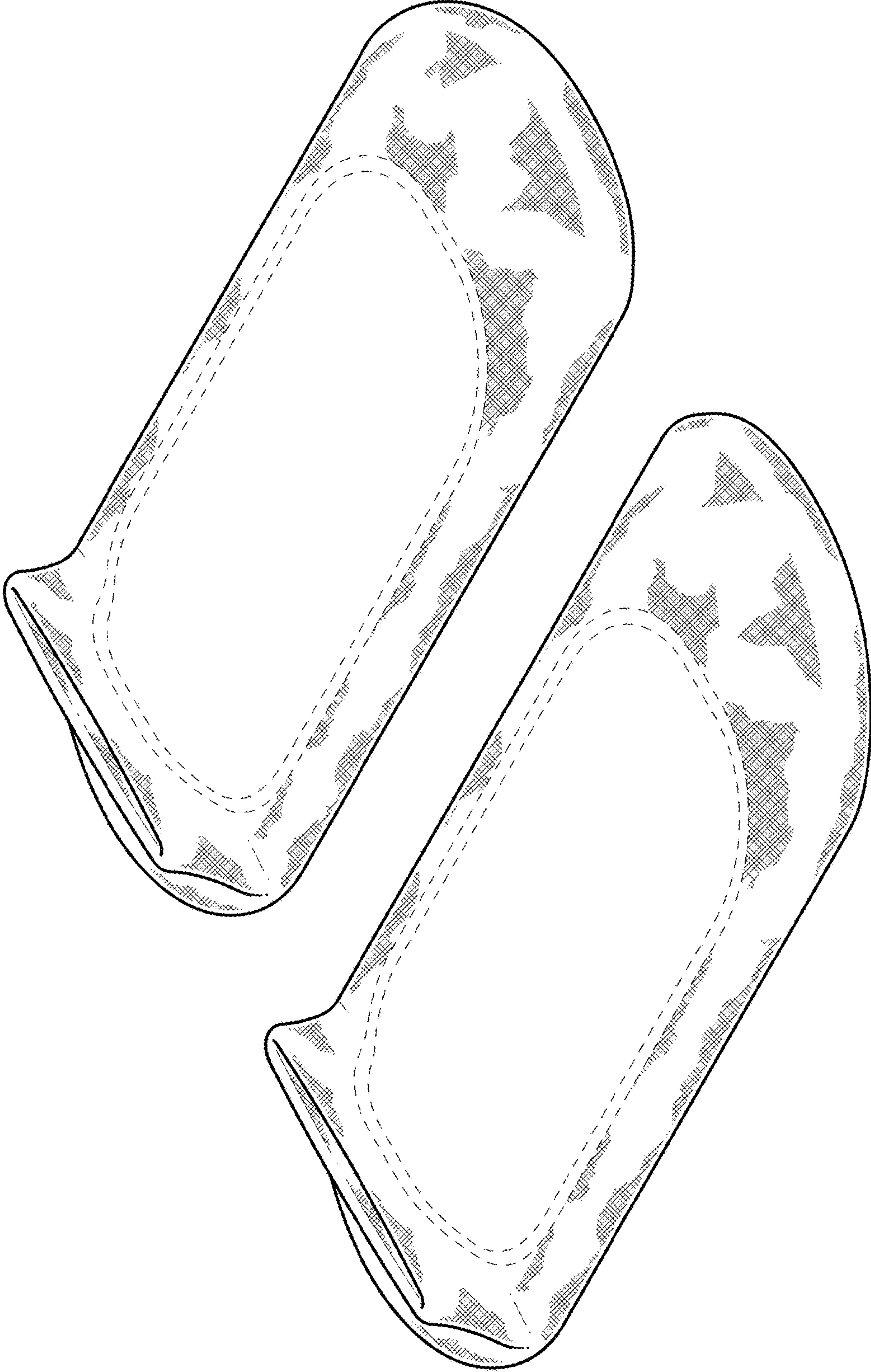

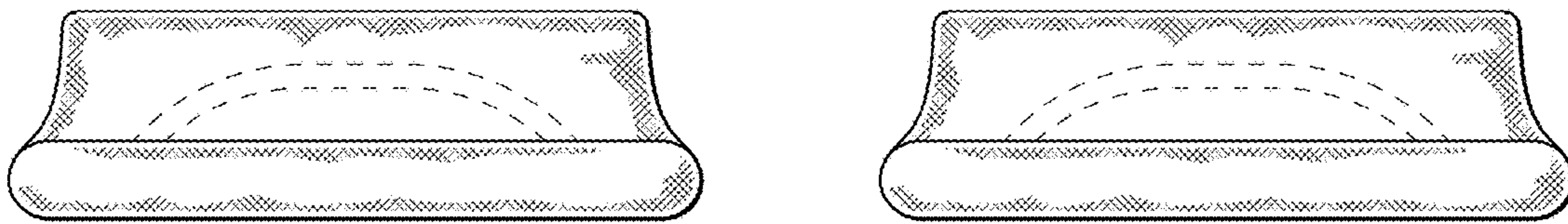

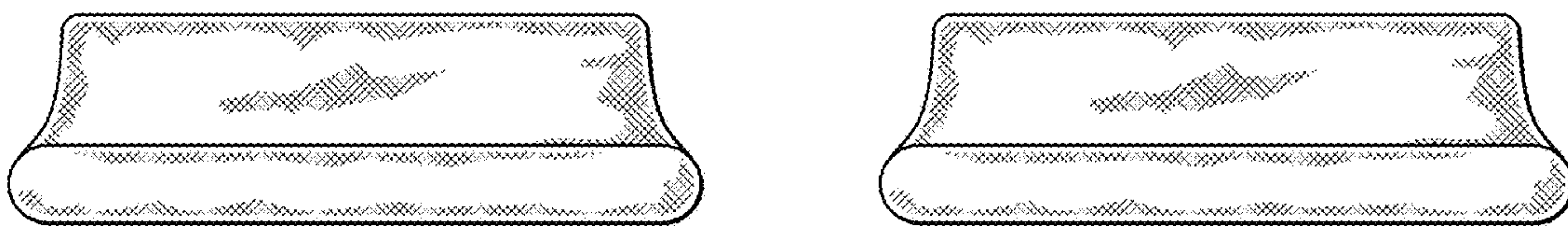

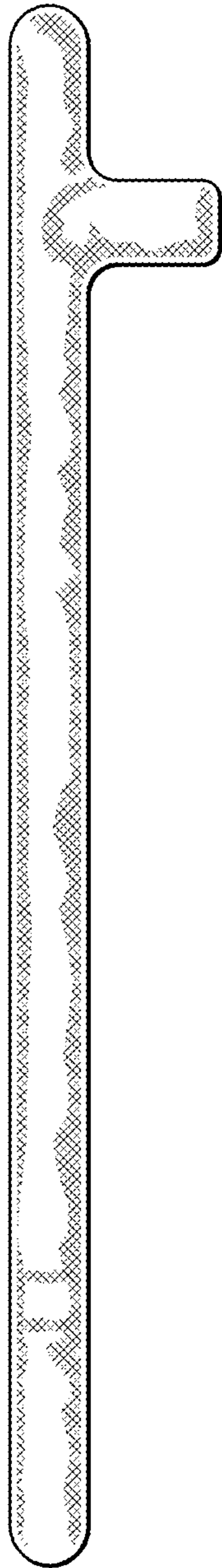

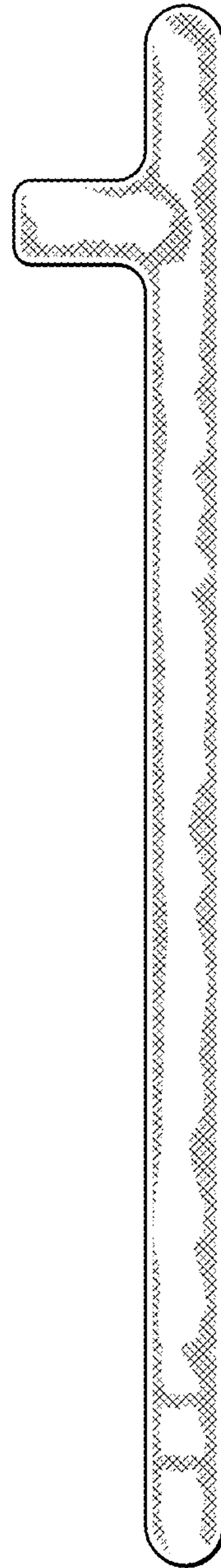

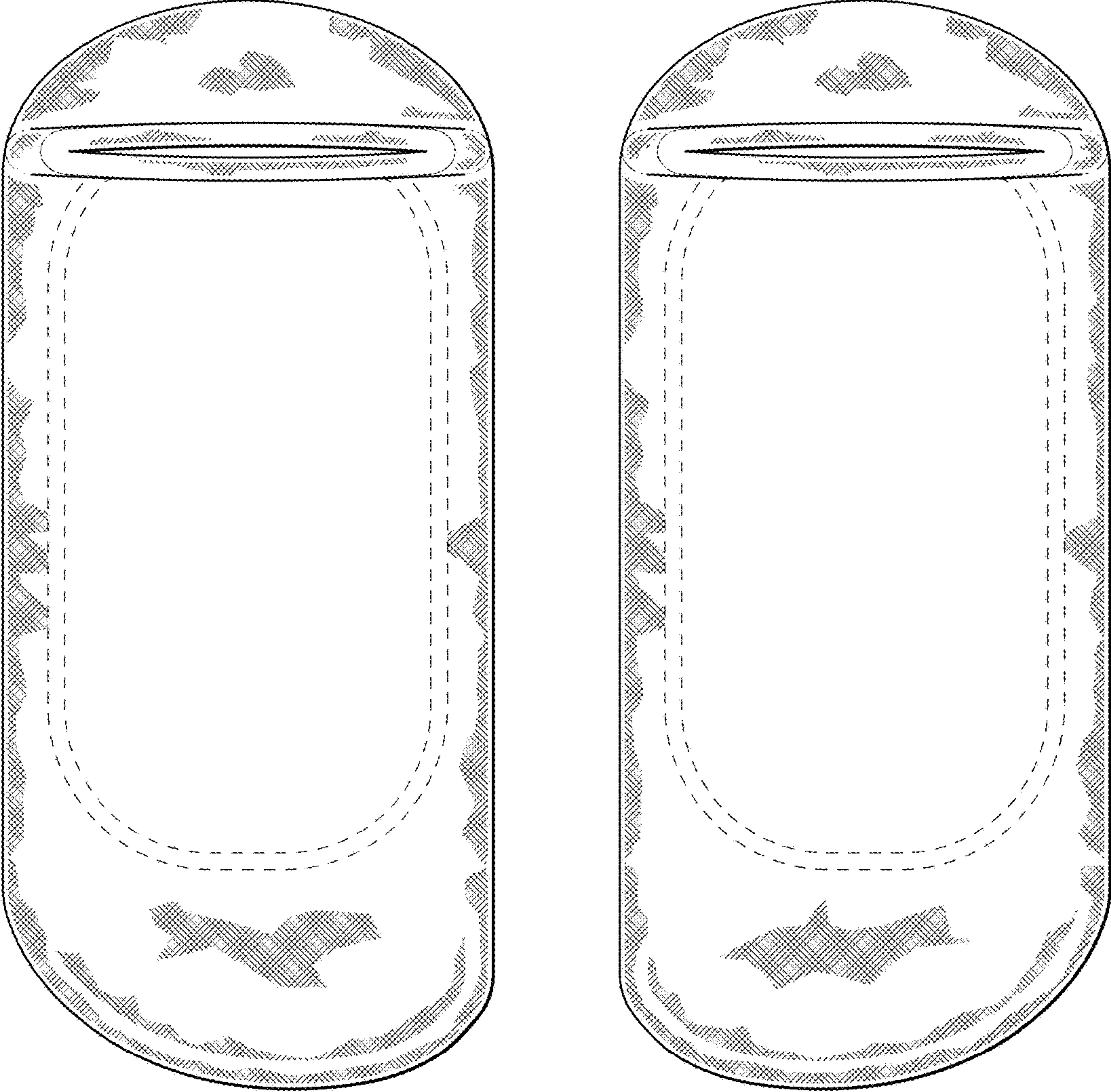

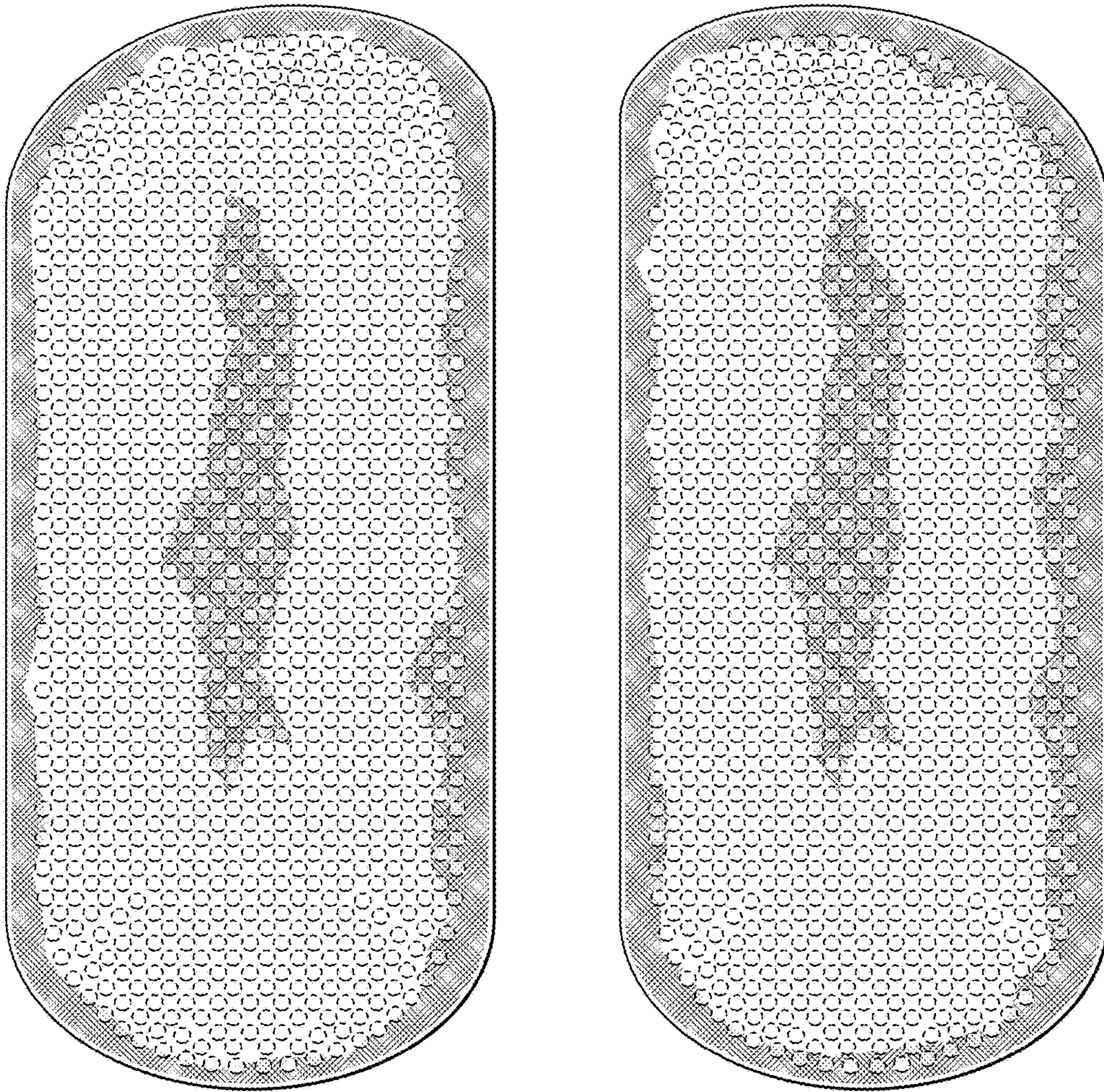
