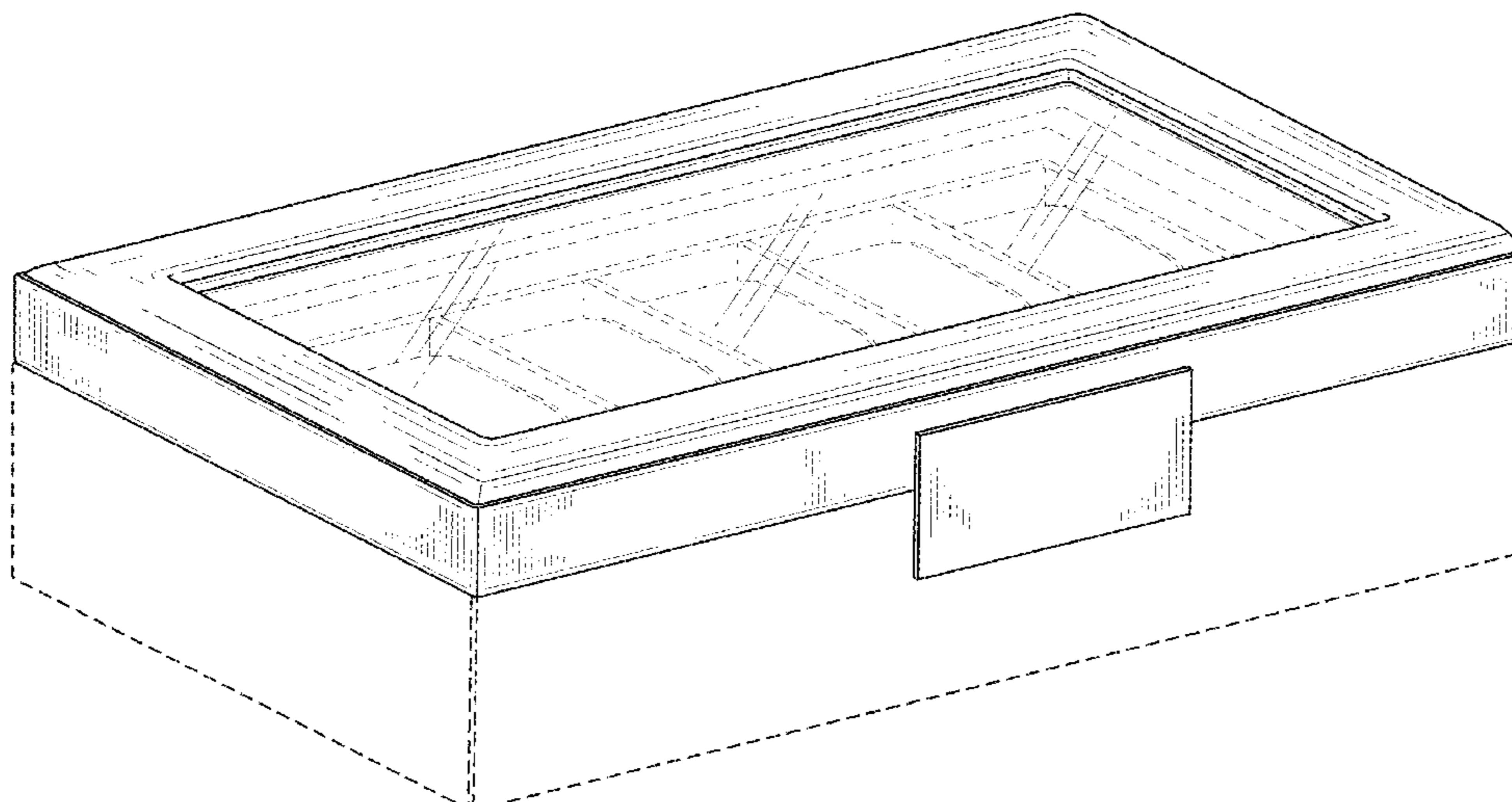
(57) **CLAIM**

The ornamental design for a lid for jewelry box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a lid for jewelry box in accordance with the new design, whereby the lid is in a closed position;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof, whereby, the opposite left side is a mirror image thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a perspective view of the first embodiment of a lid for jewelry box in accordance with the new design, whereby the lid is in an open position;
FIG. 8 is a top plan view thereof;
FIG. 9 is a perspective view of a second embodiment of a lid for jewelry box in accordance with the new design, whereby the lid is in a closed position;
FIG. 10 is a front elevational view thereof;
FIG. 11 is a rear elevational view thereof;
FIG. 12 is a right side elevational view thereof, whereby, the opposite left side is a mirror image thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a bottom view thereof;
FIG. 15 is a perspective view of the second embodiment of a lid for jewelry box in accordance with the new design, whereby the lid is in an open position; and,
FIG. 16 is a top plan view thereof.

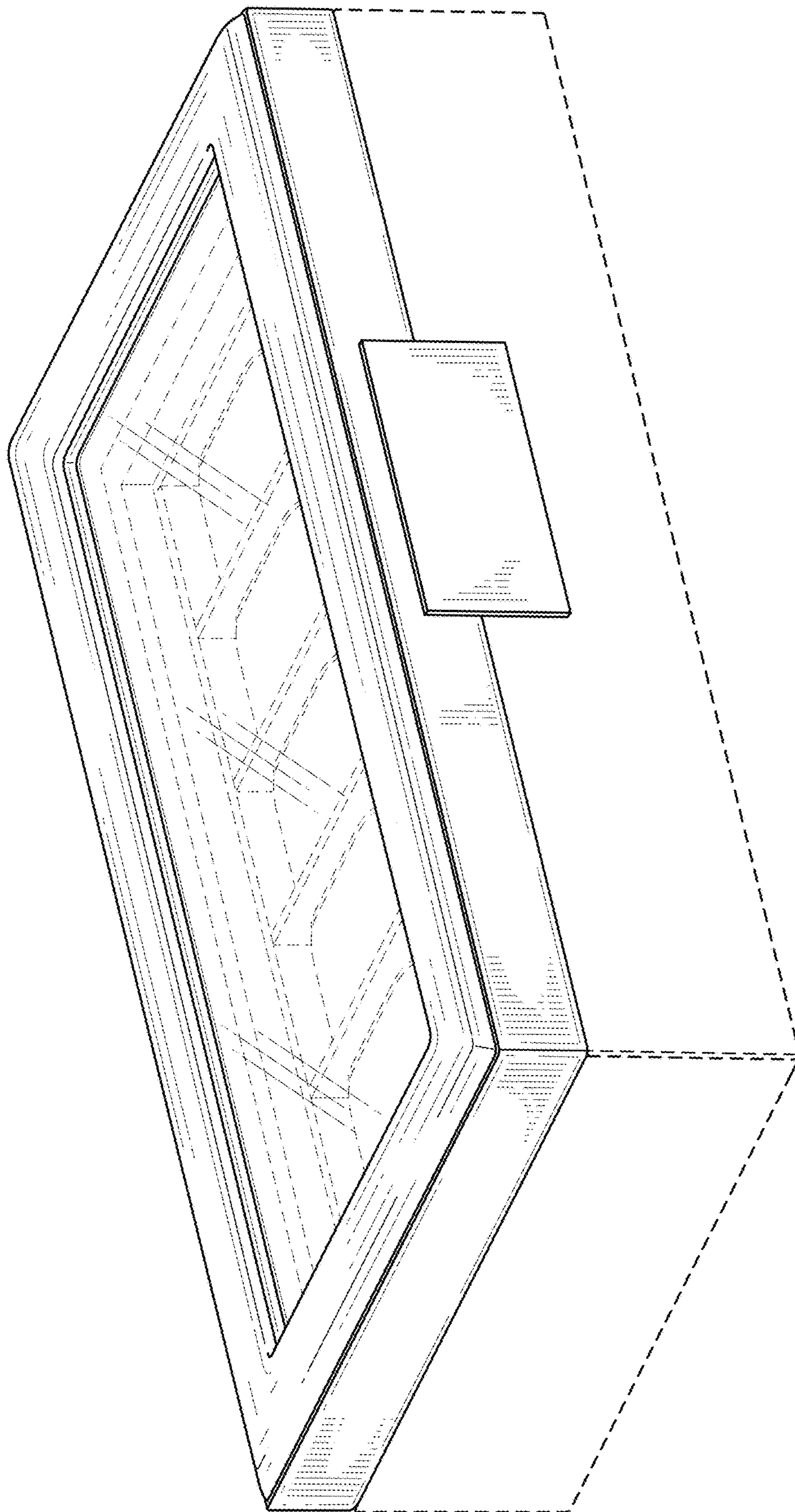

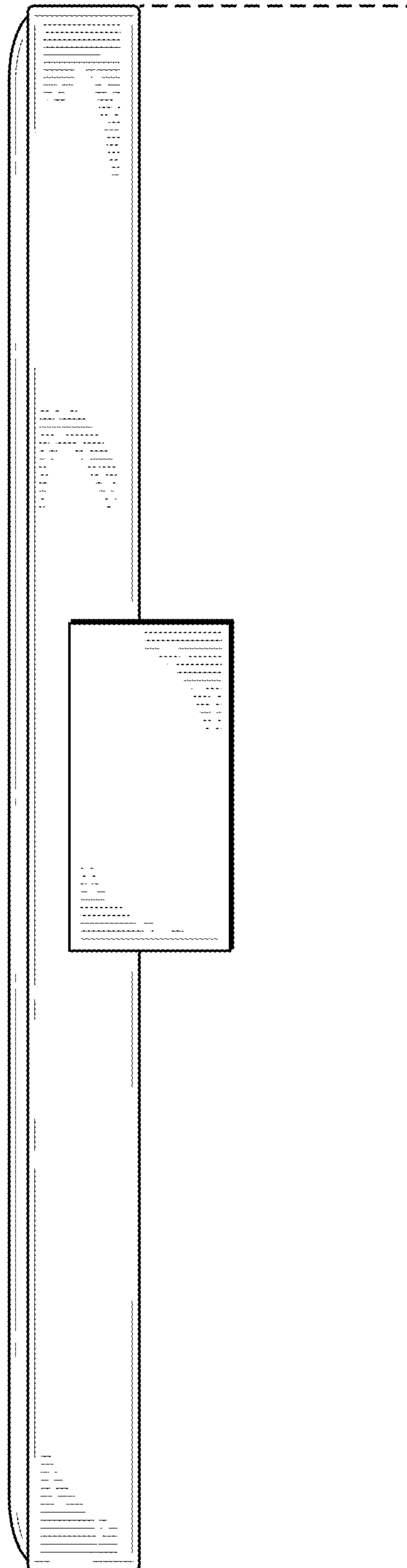

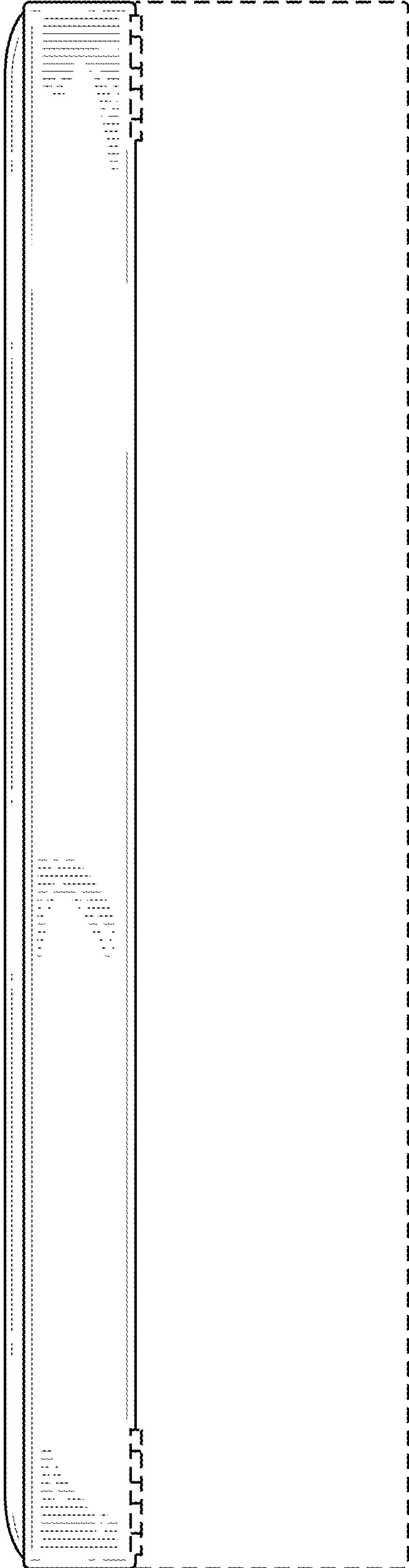

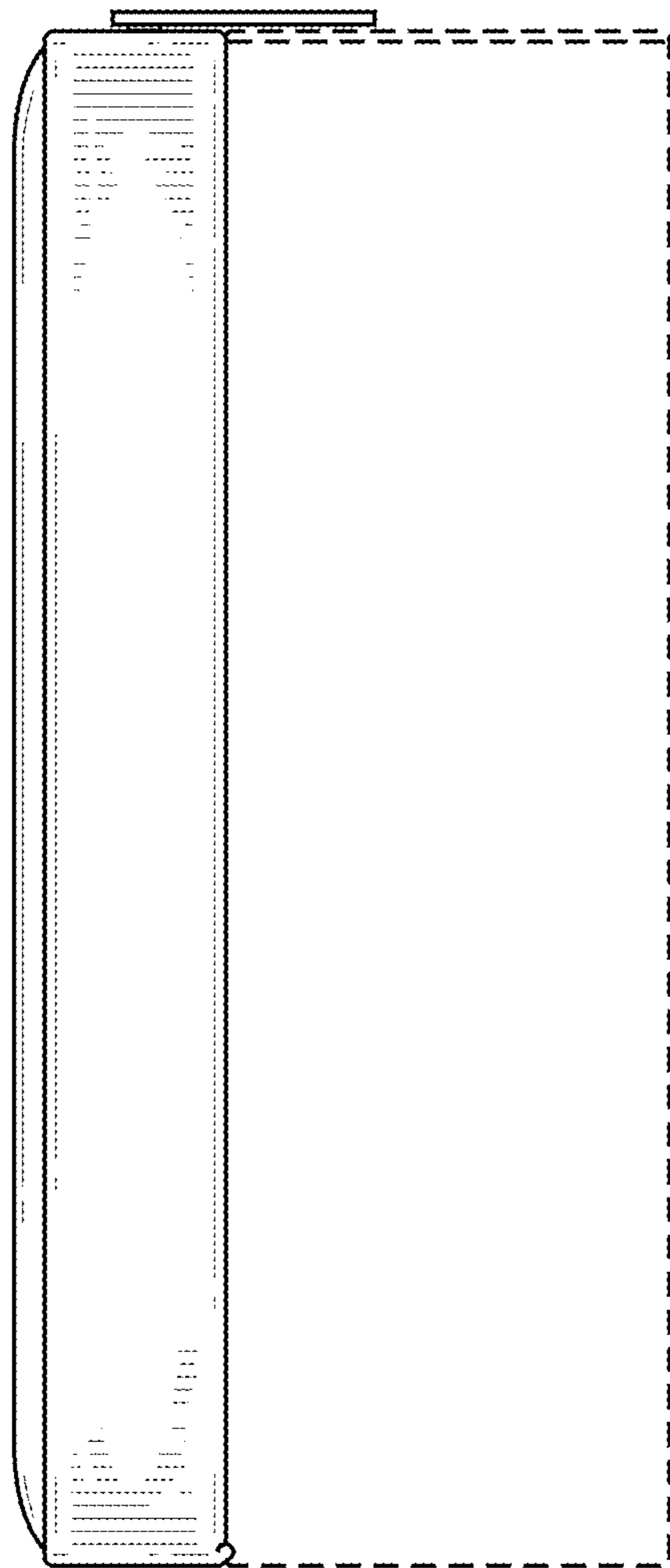

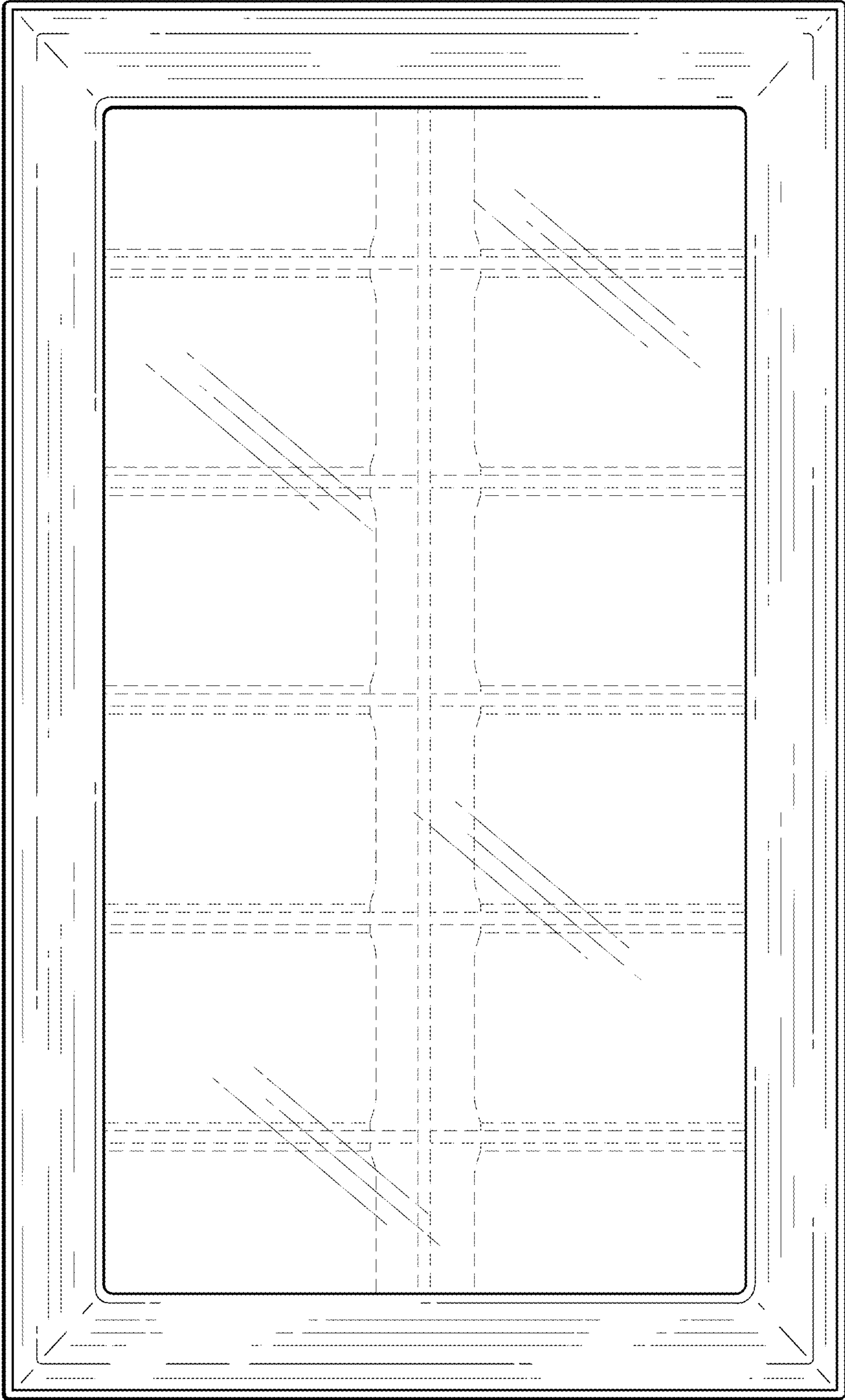

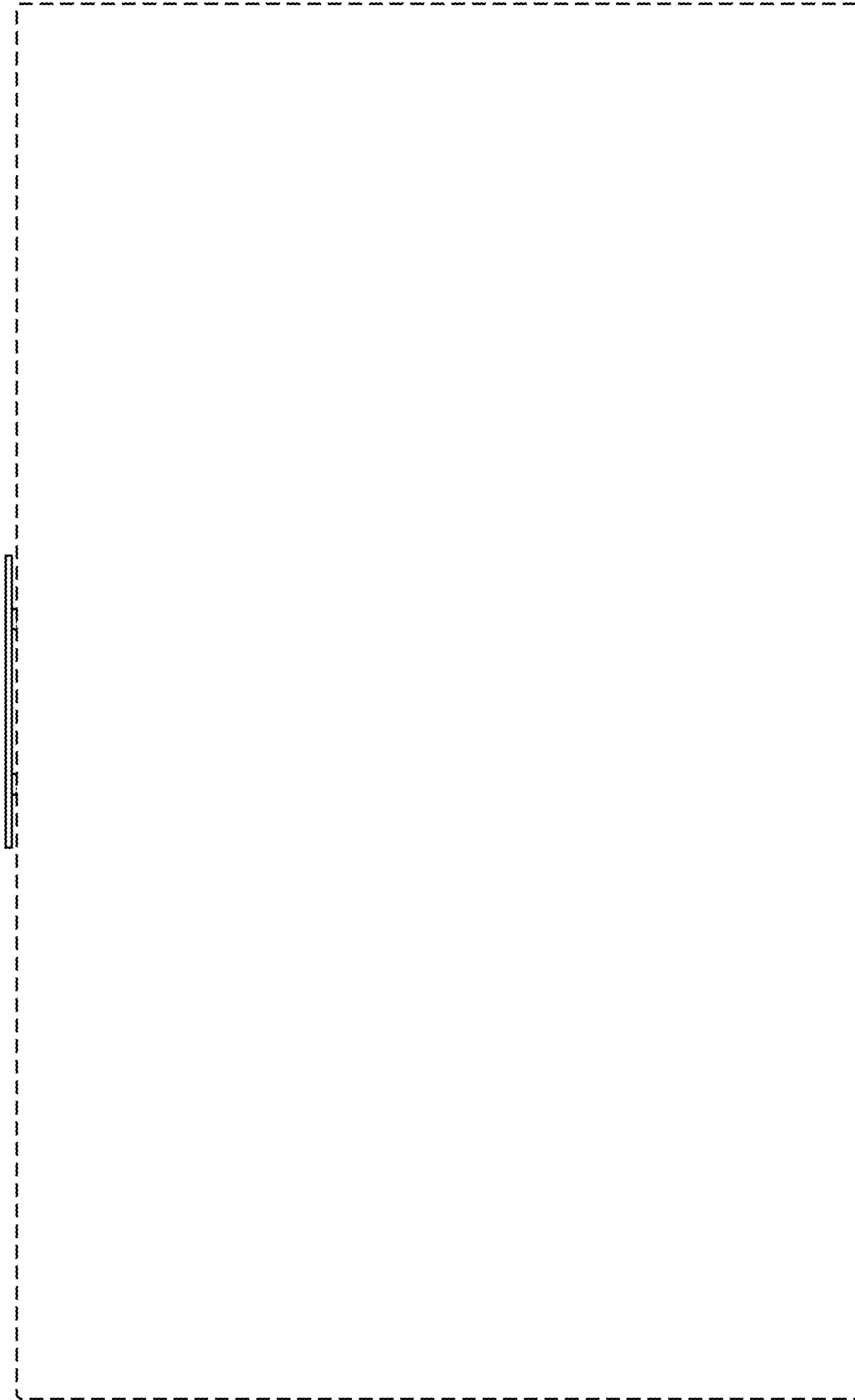

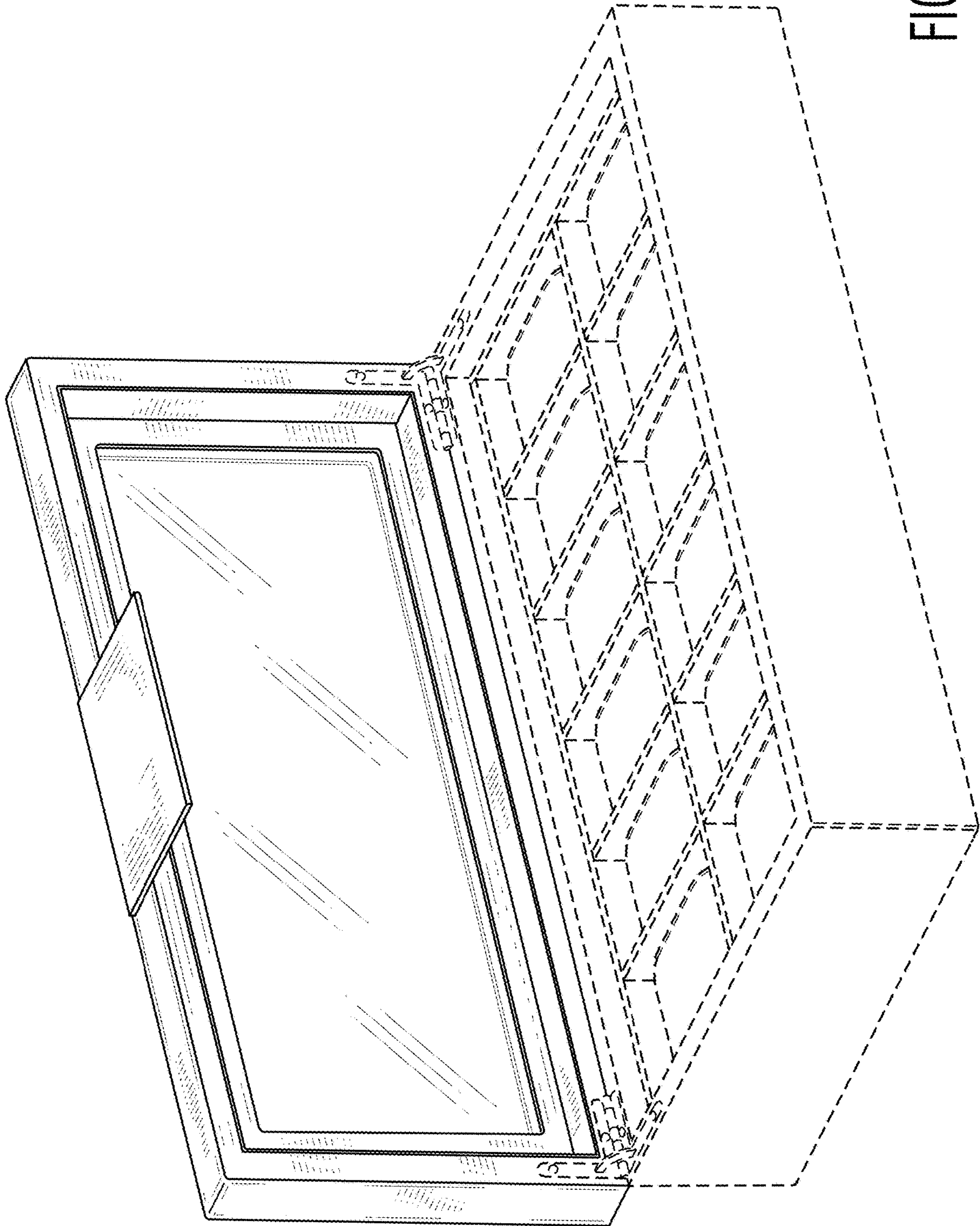

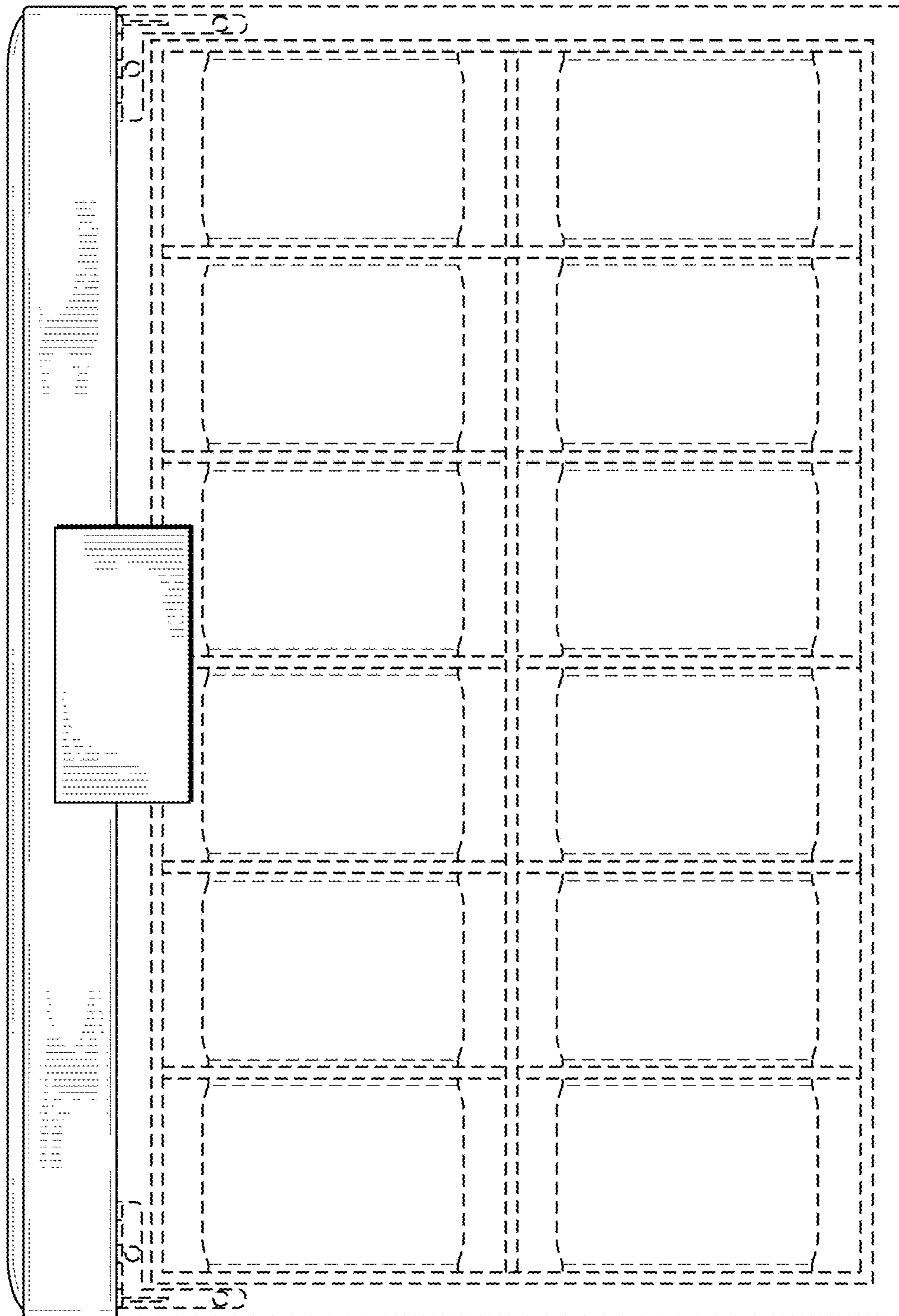

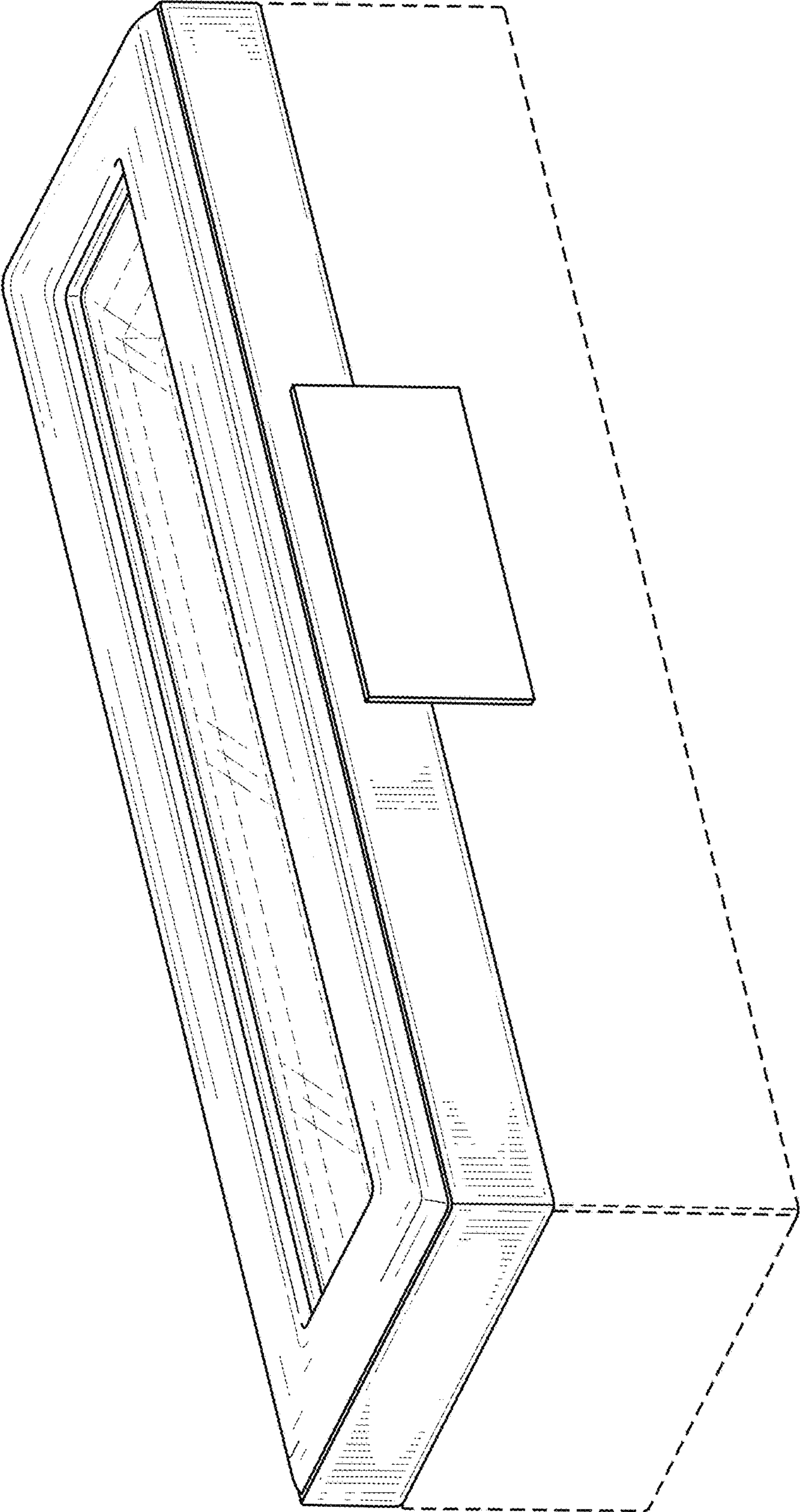

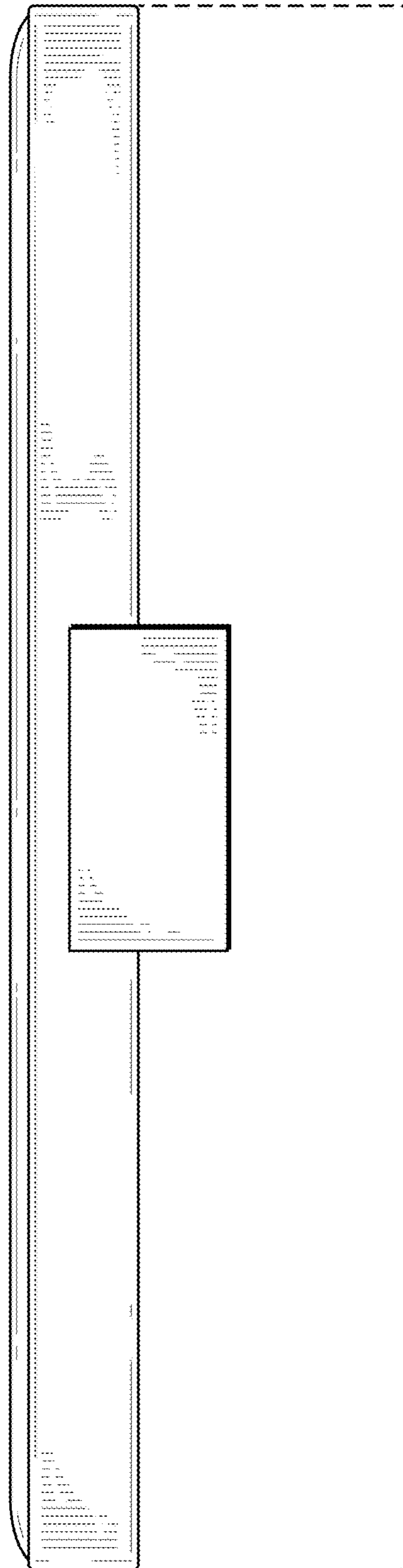

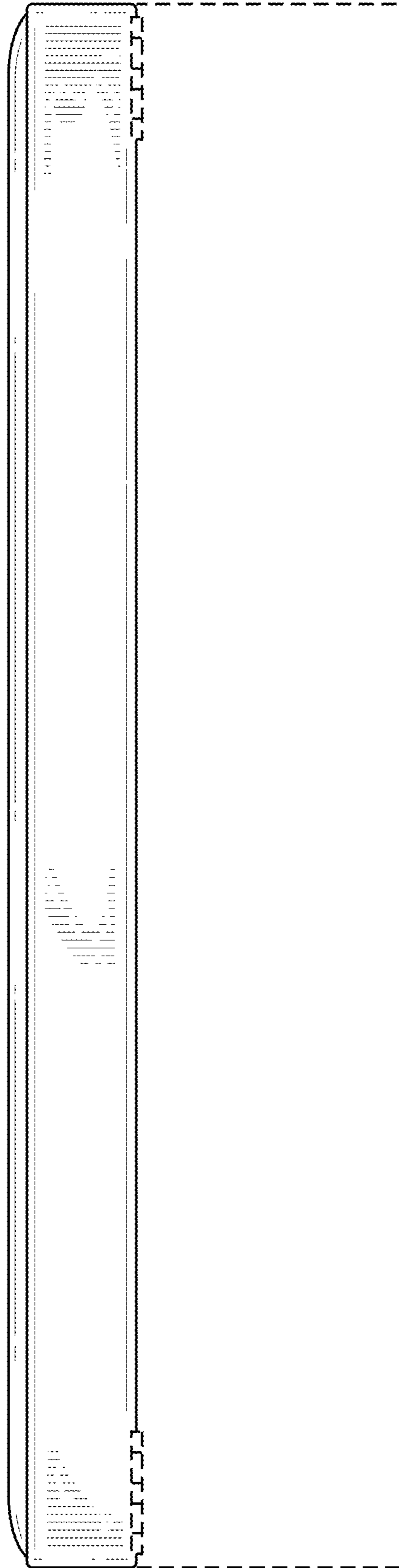

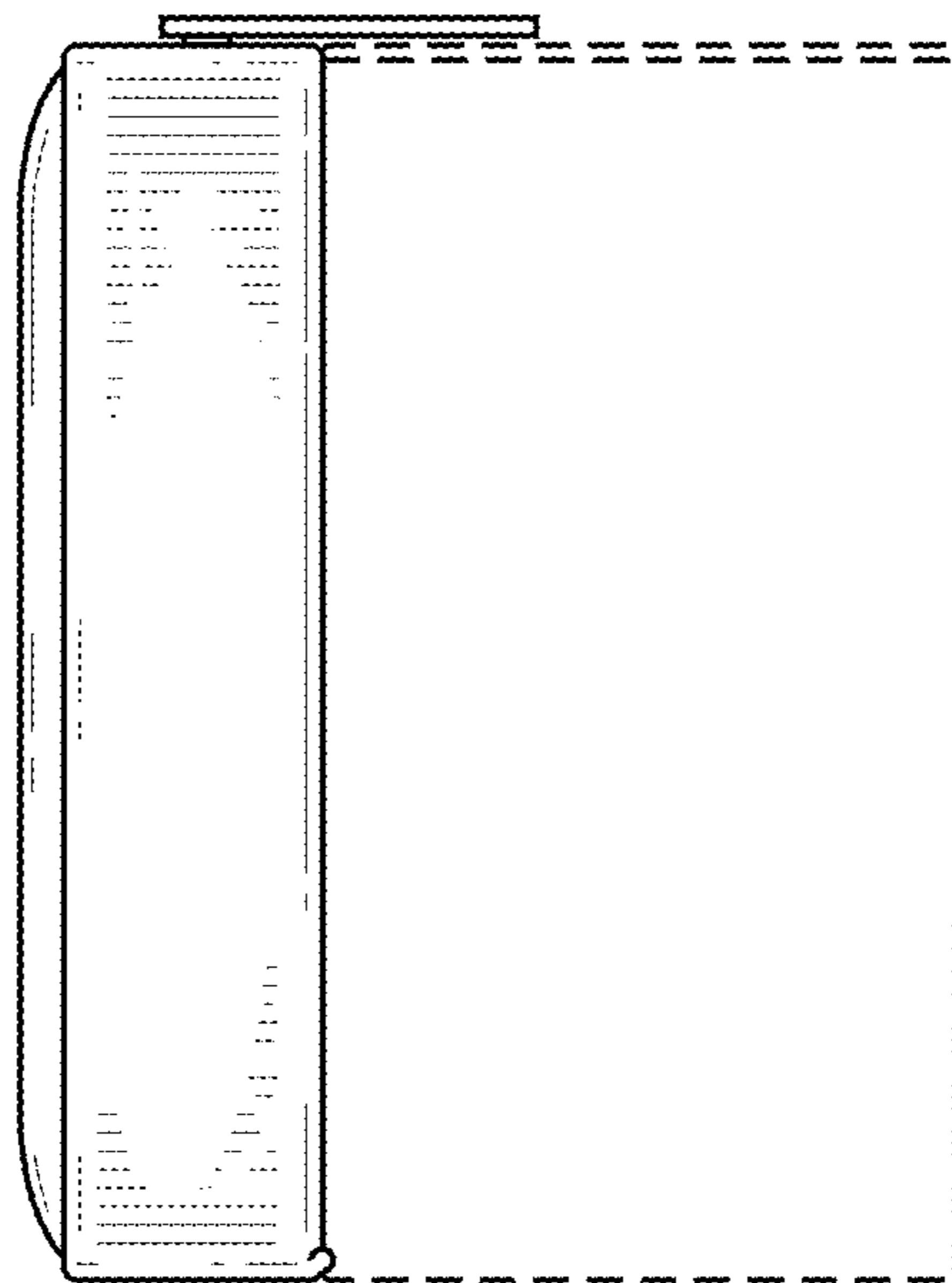

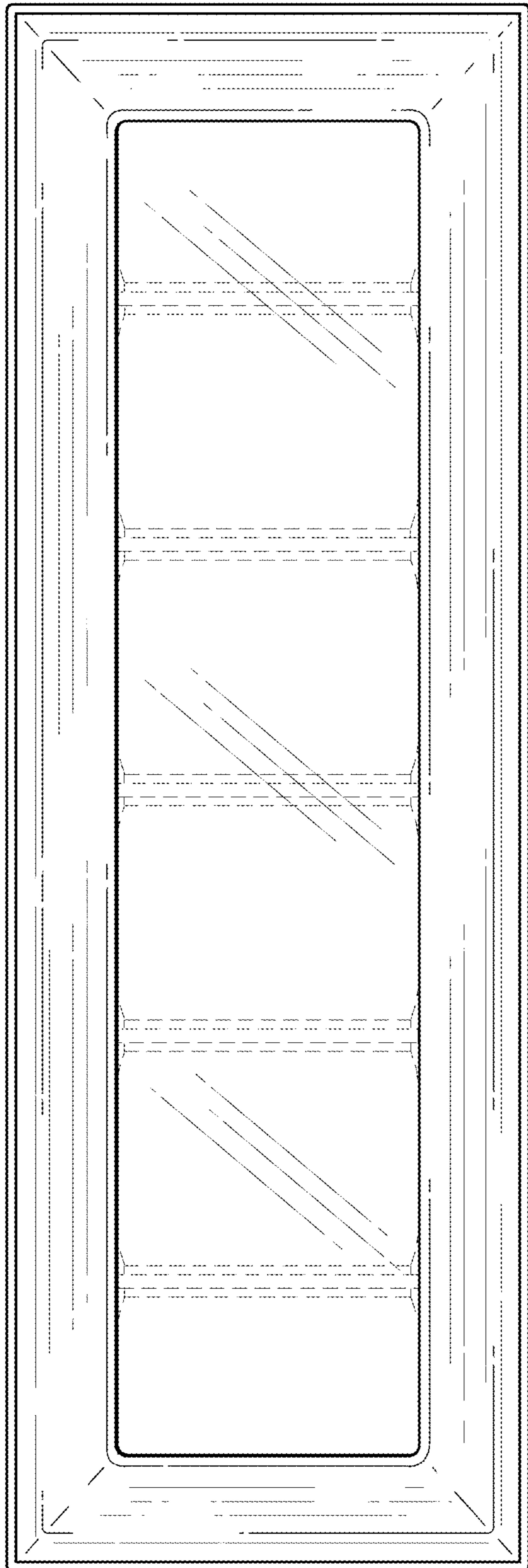

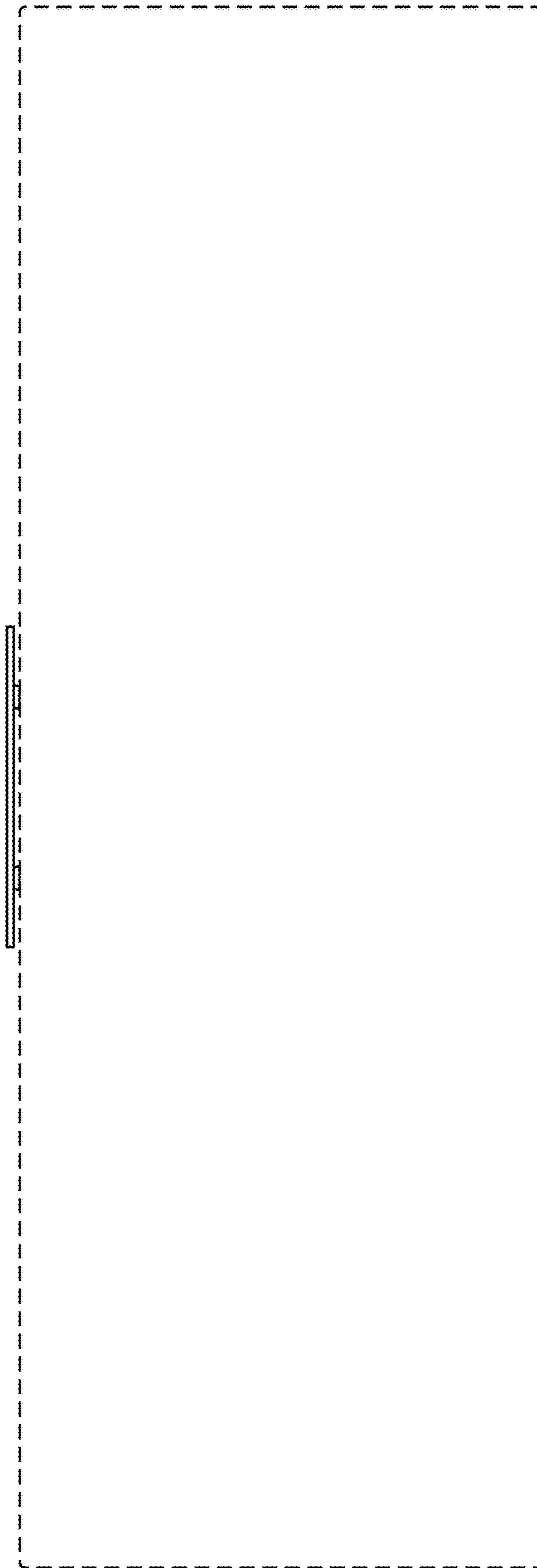

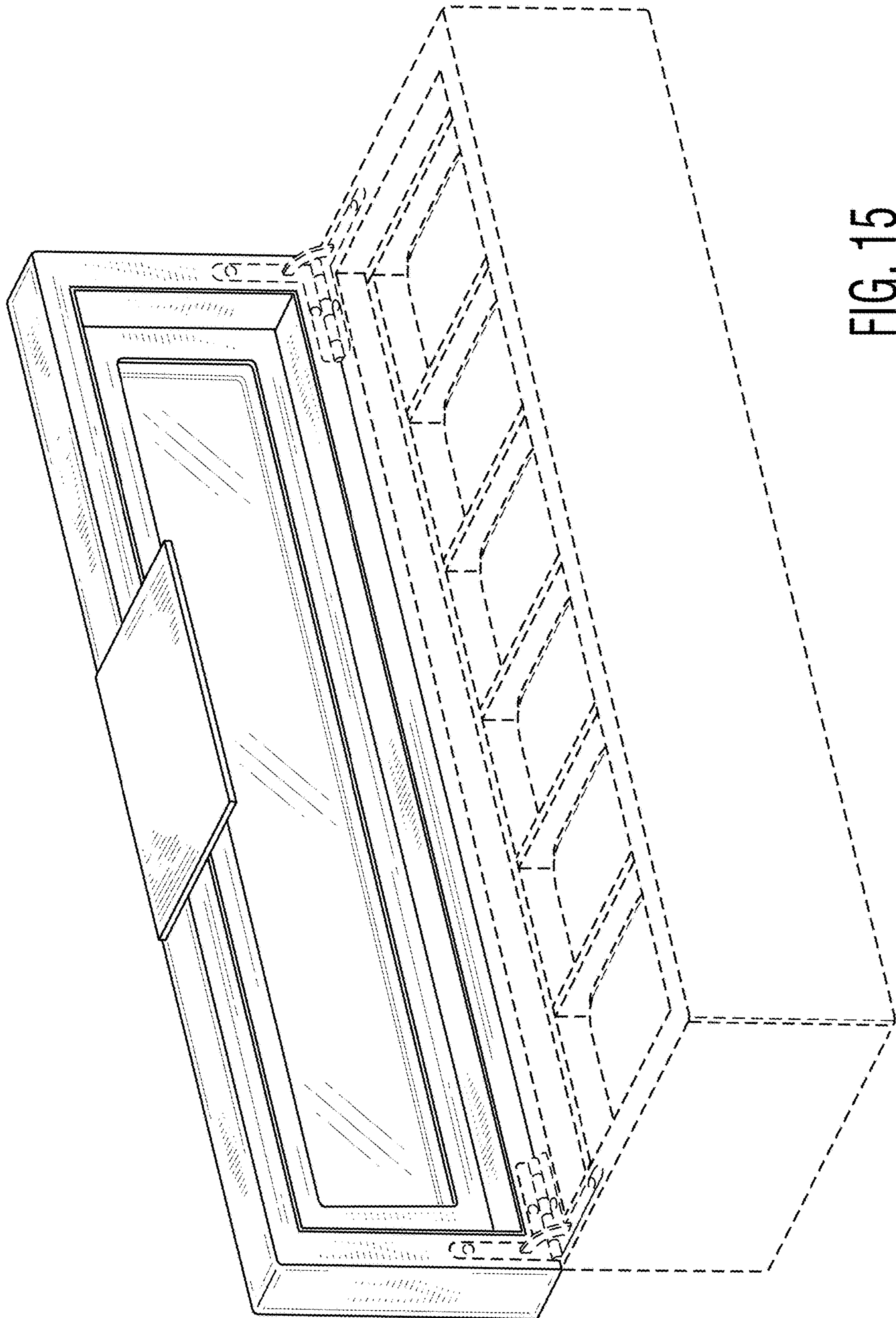

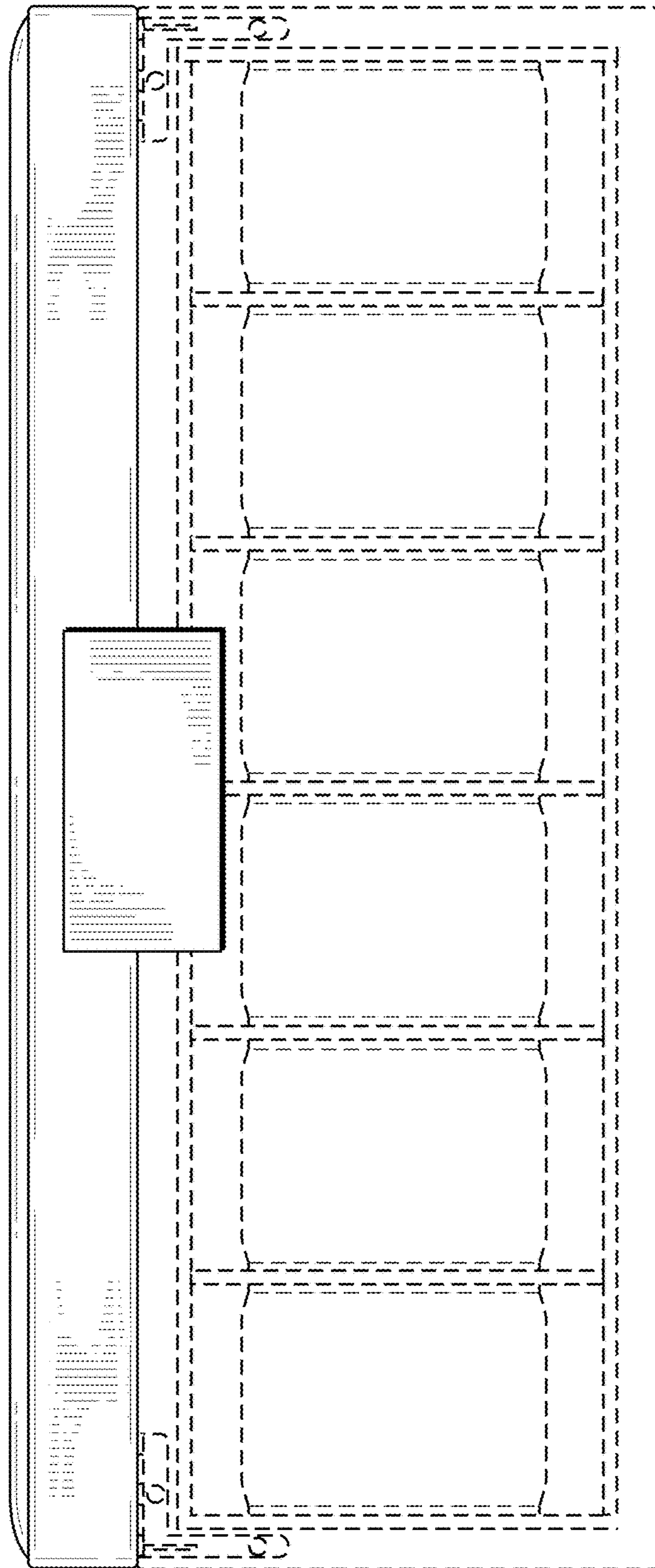
