The ornamental design for a beverage container lid, as shown and described.

DESCRIPTION

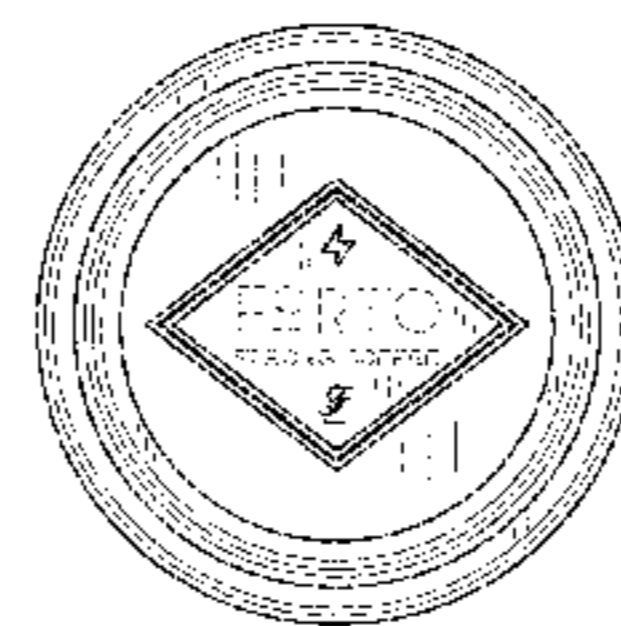
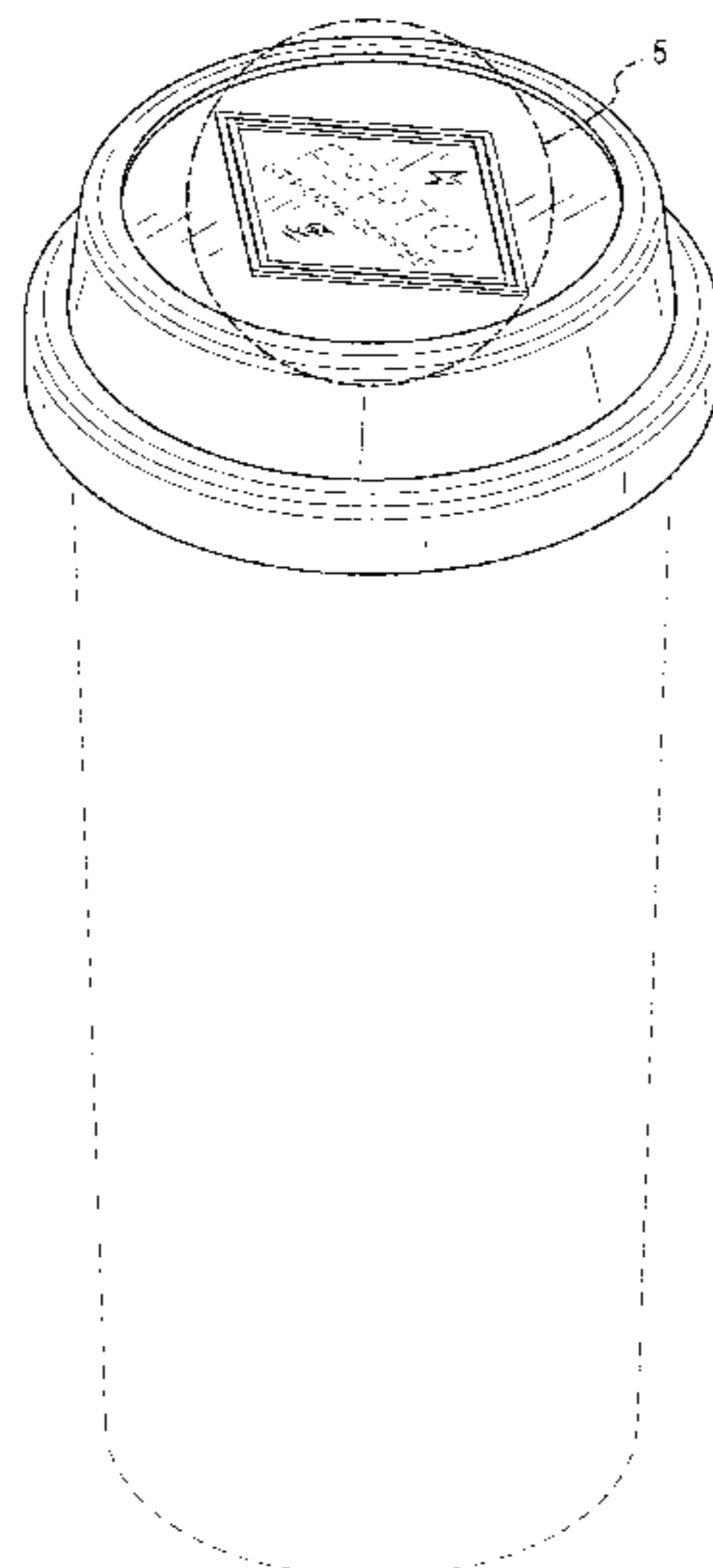
FIG. 1 is a top perspective view of my beverage container lid on a beverage container showing the novel lid design. FIG. 2 is a side elevational view, as viewed from any compass direction, of the beverage container lid shown in FIG. 1. FIG. 3 is a top plan view of the beverage container lid shown in FIG. 1. FIG. 4 is a bottom plan view of the beverage container lid shown in FIG. 3; and, FIG. 5 is an enlarged partial view of my beverage container lid shown in FIG. 1. The broken lines are shown for the purpose of illustrating environmental subject matter of a beverage container as well as parts of the lid, none of which form part of the claim. The “Forto Strong Coffee” logo shown in FIGS. 1 and 3 is a registered trademark of Dyla LLC and forms no part of the claim. The dot-dash broken lines are shown for the purpose of designating the enlargement view of FIG. 5, as well as the origin of this view on FIG. 1.

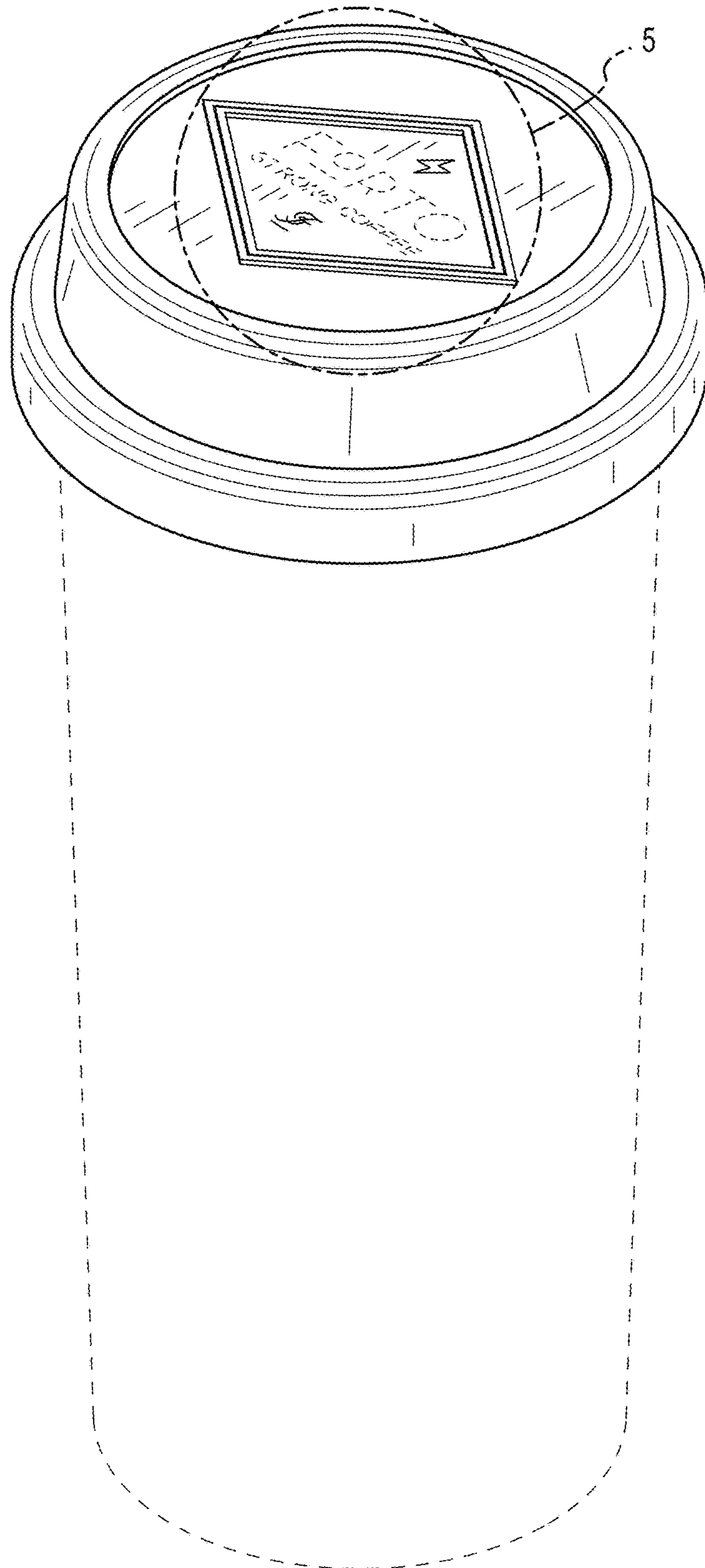

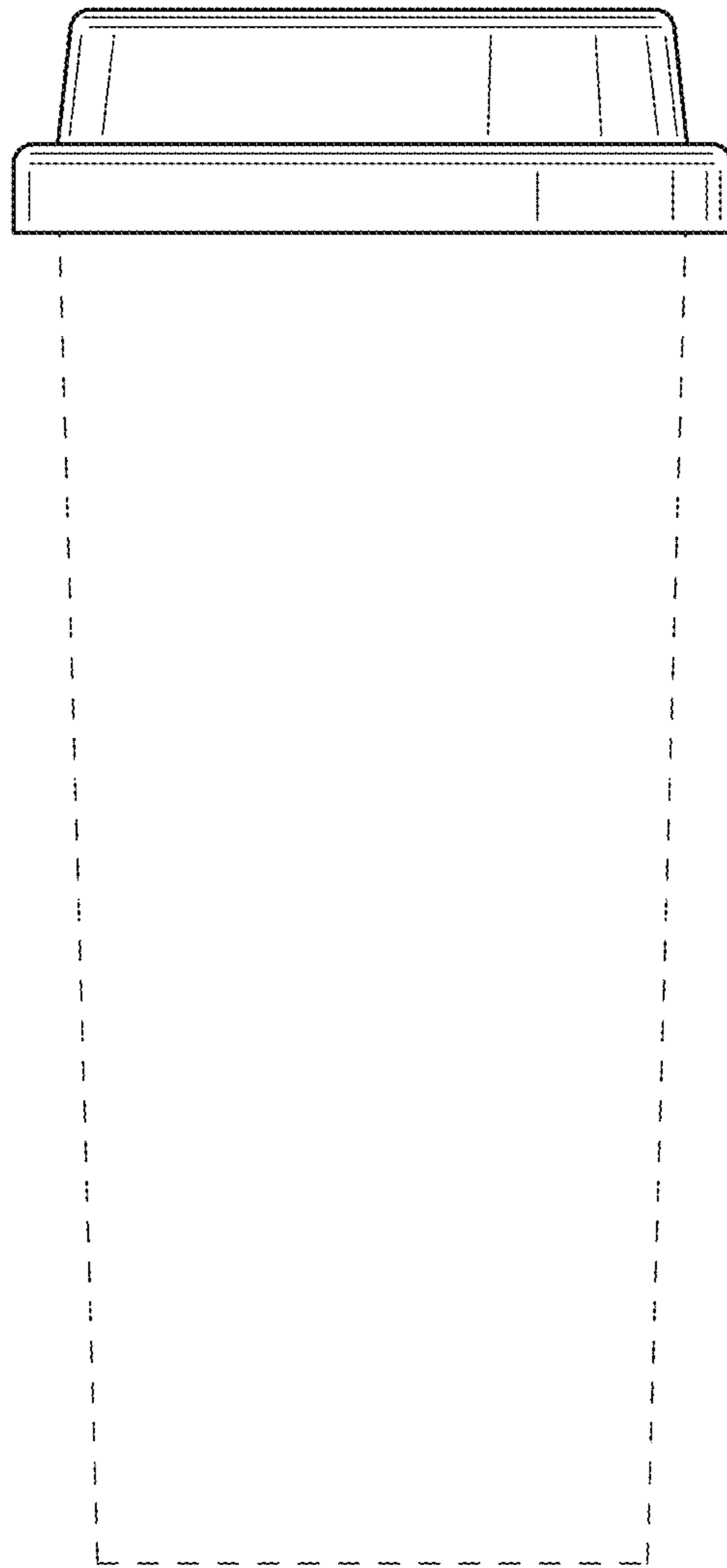

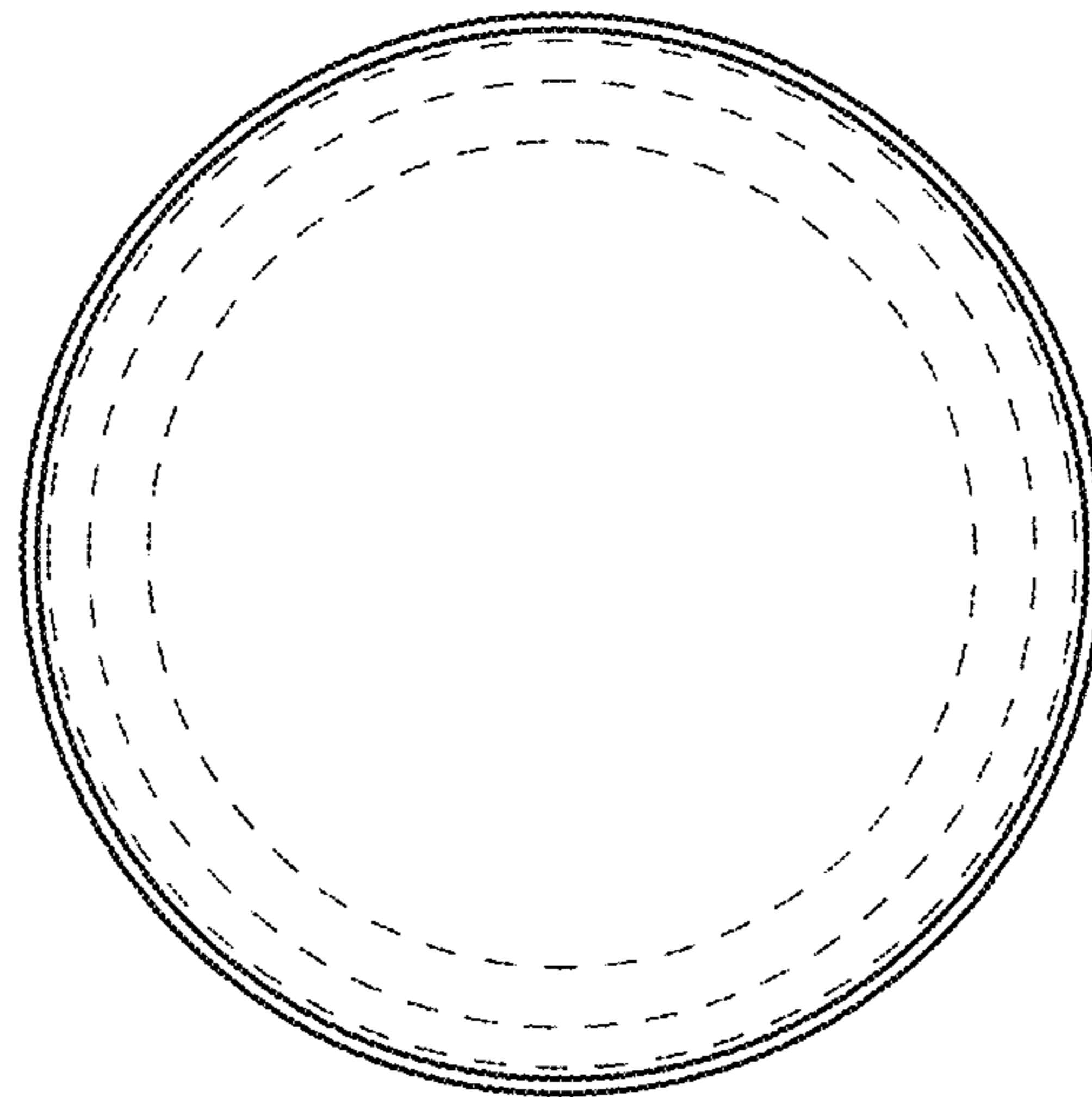

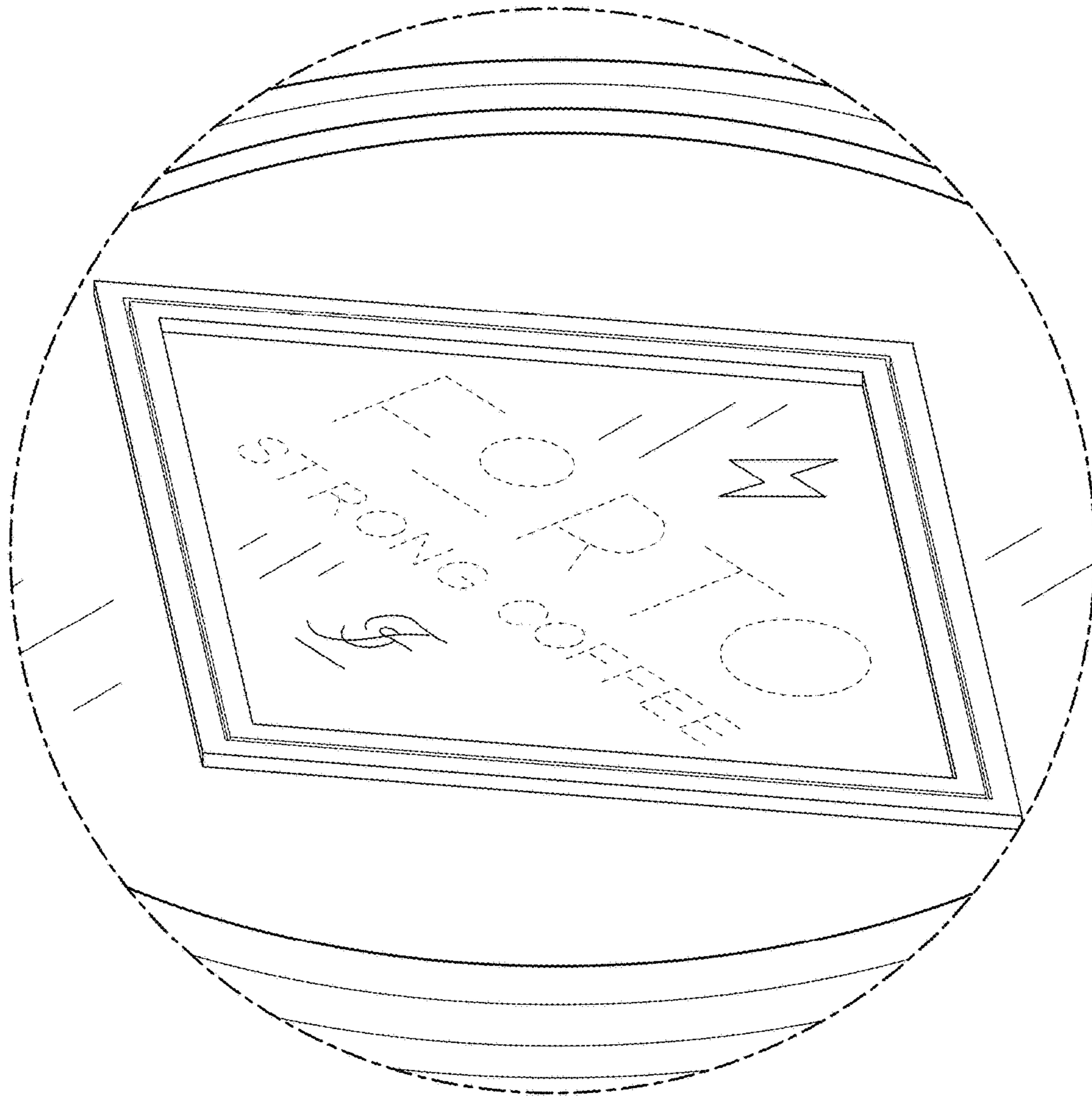
