We claim the ornamental design for a hinged coupling, as shown and described.

**DESCRIPTION**

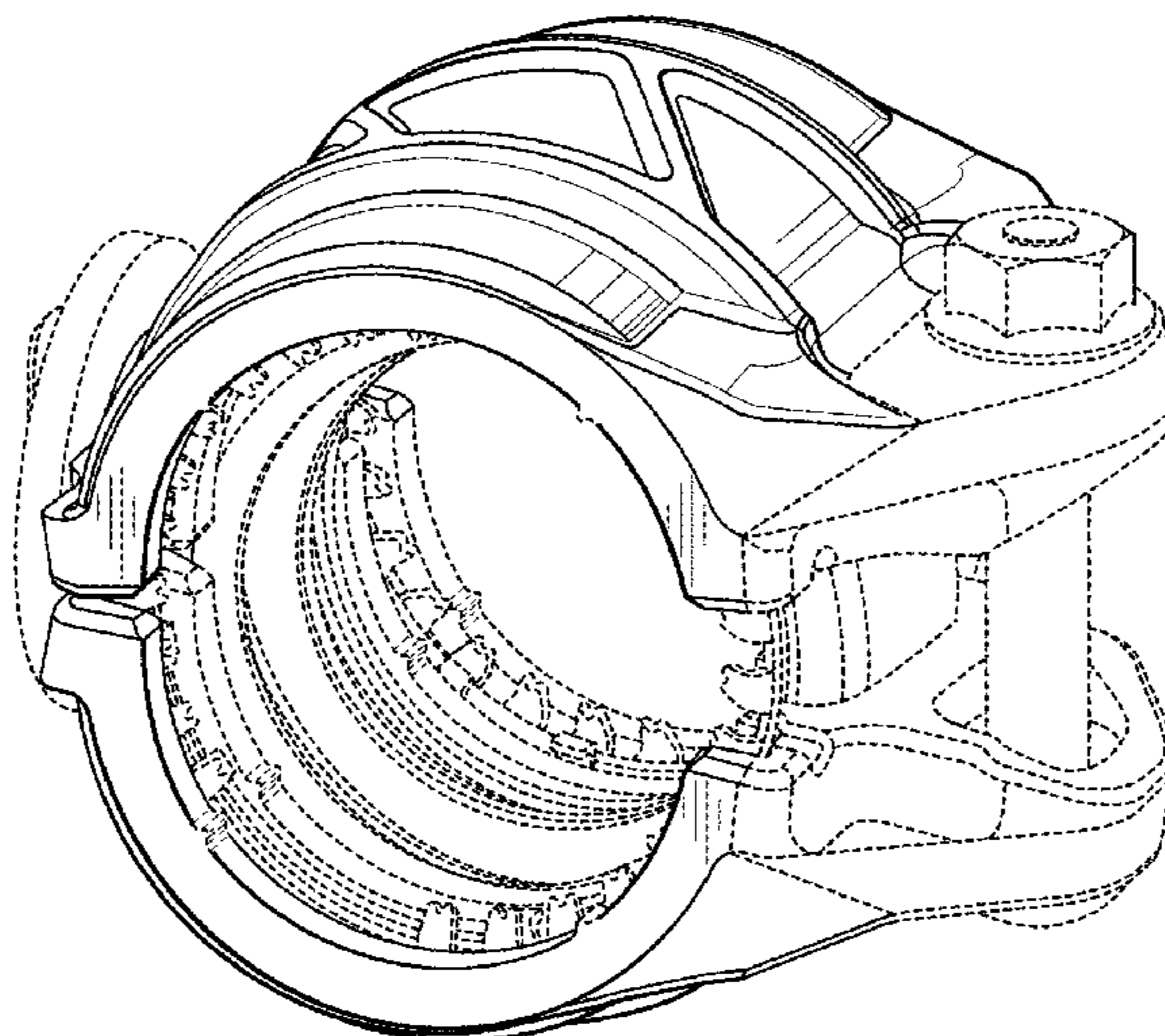
FIG. 1 is an isometric view of our design for a hinged coupling;  
FIG. 2 is a front view of the design of the hinged coupling shown in FIG. 1;  
FIG. 3 is a rear view of the design of the hinged coupling shown in FIG. 1;  
FIG. 4 is a bottom view of the design of the hinged coupling shown in FIG. 1;  
FIG. 5 is a top view of the design of the hinged coupling shown in FIG. 1; and,  
FIG. 6 is a left side view of the design of the hinged coupling shown in FIG. 1, the right side view being a mirror image thereof.  
The broken lines depict portions of the hinged coupling that form no part of the claimed design.

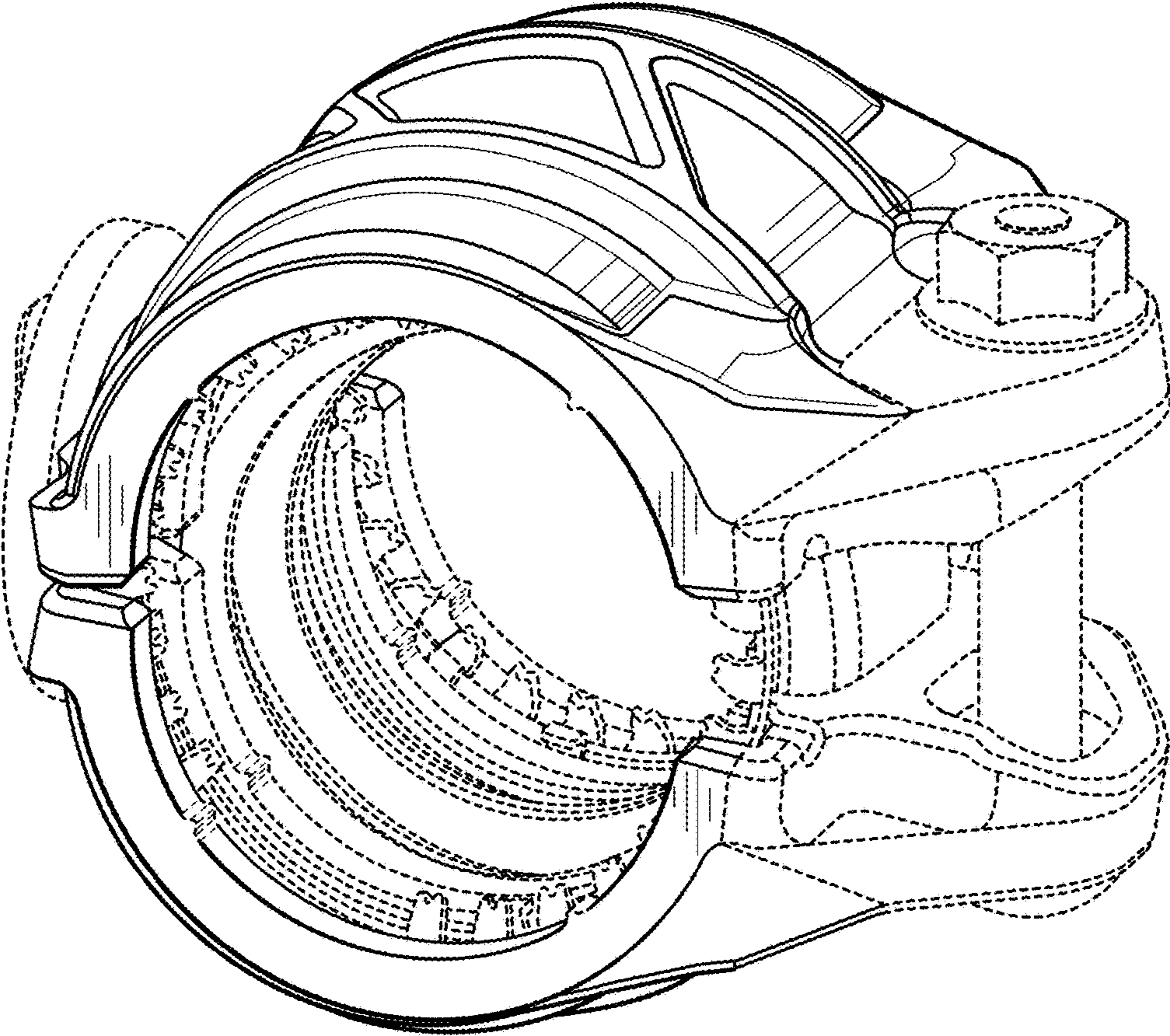

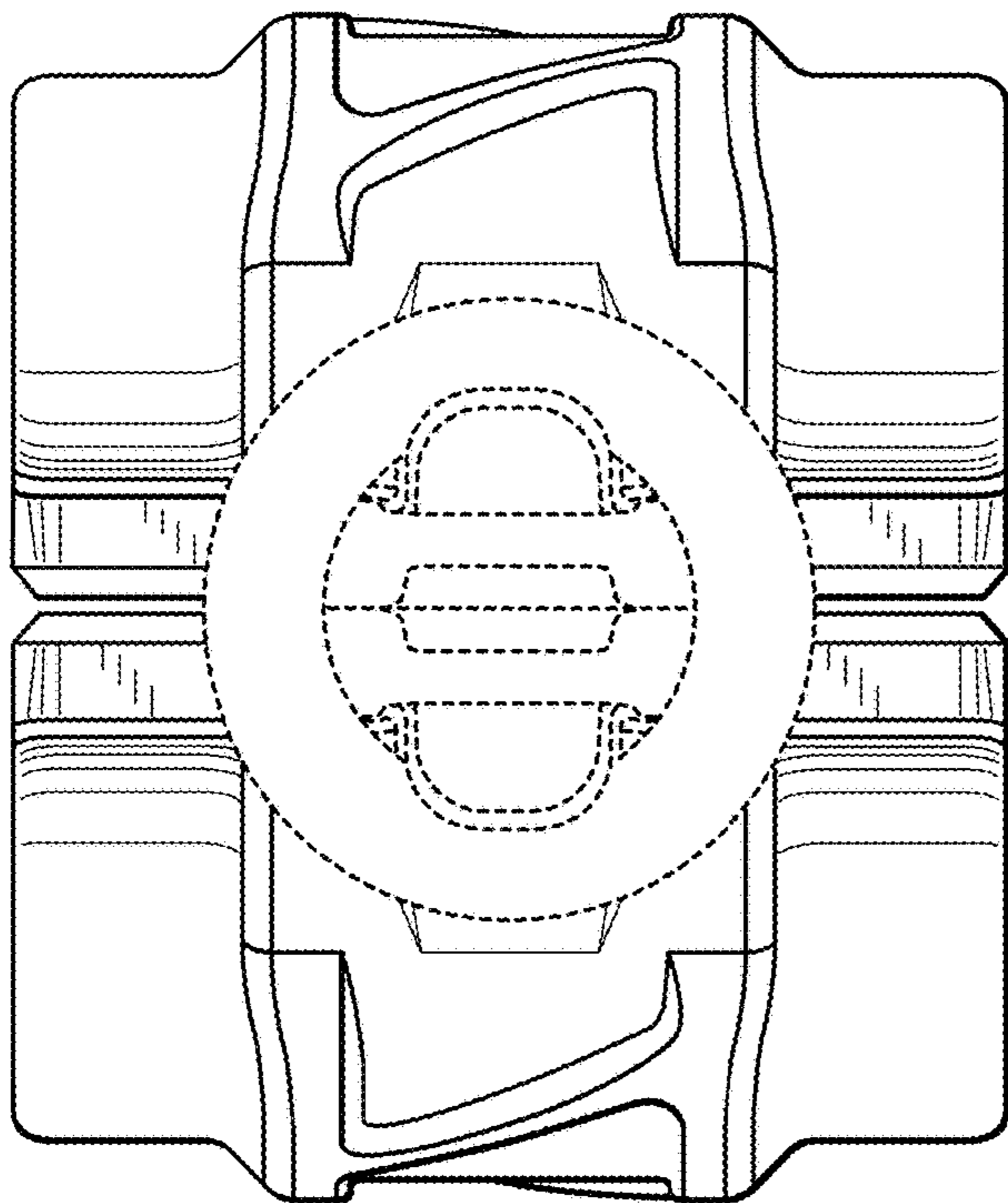
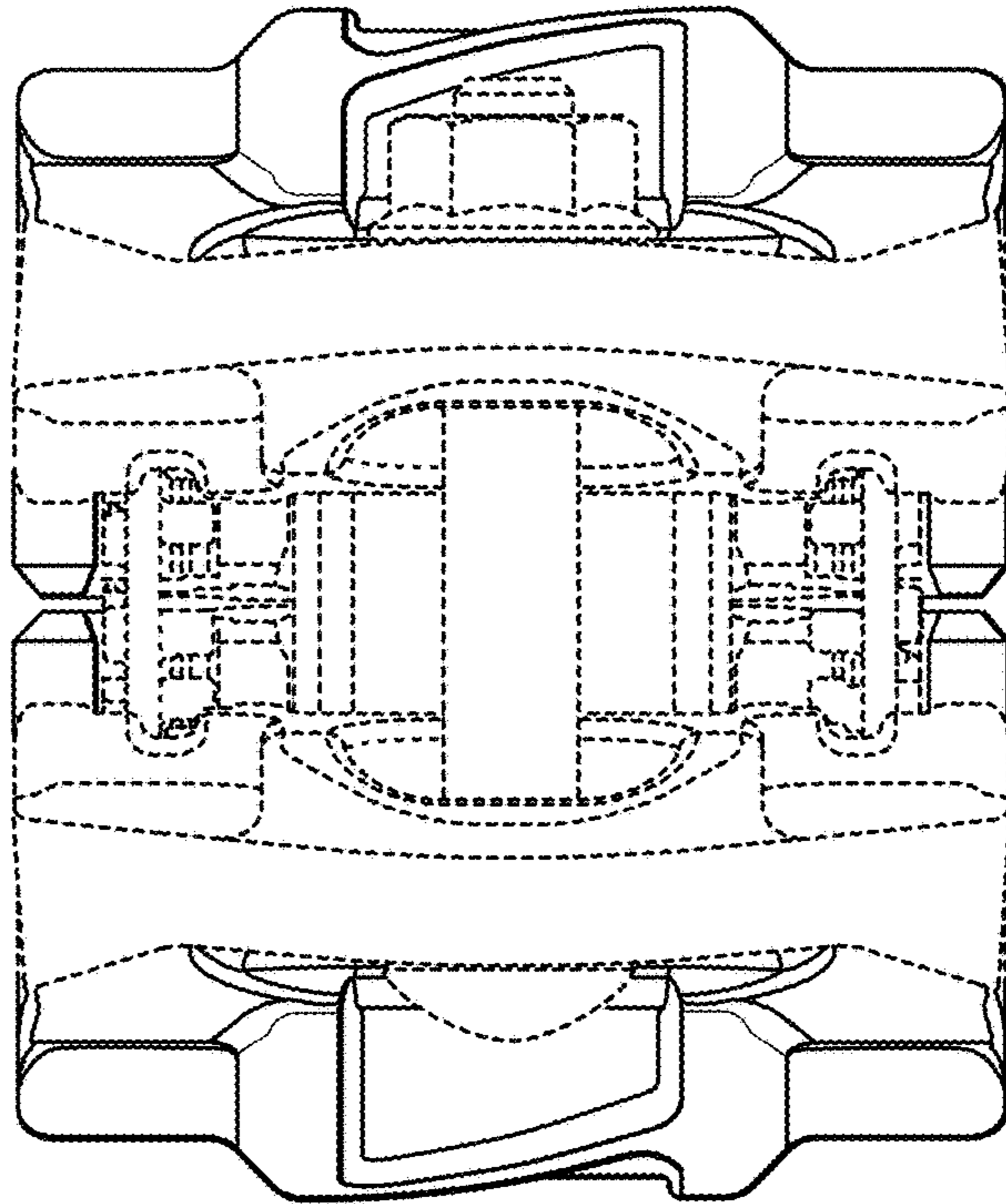

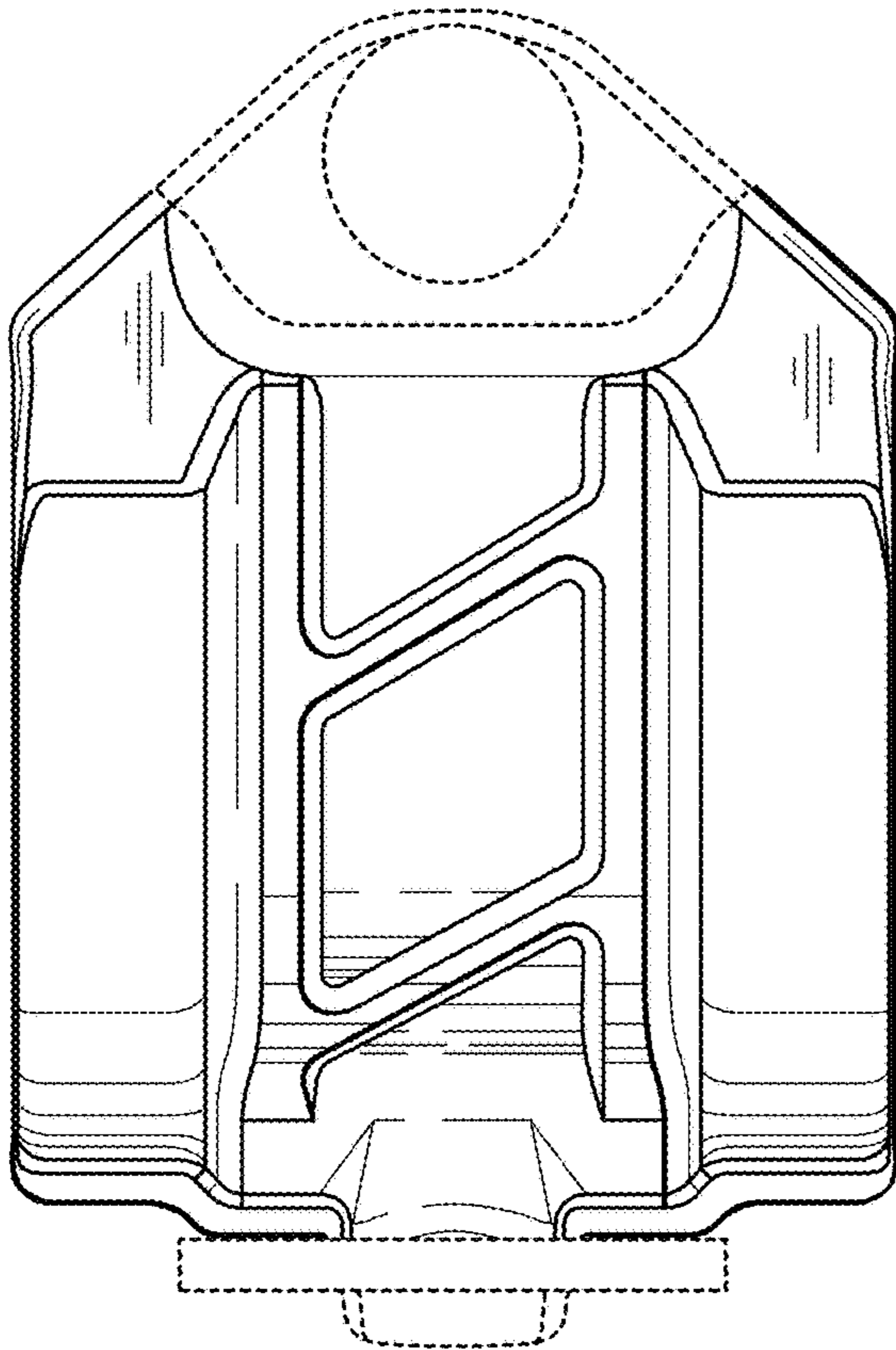
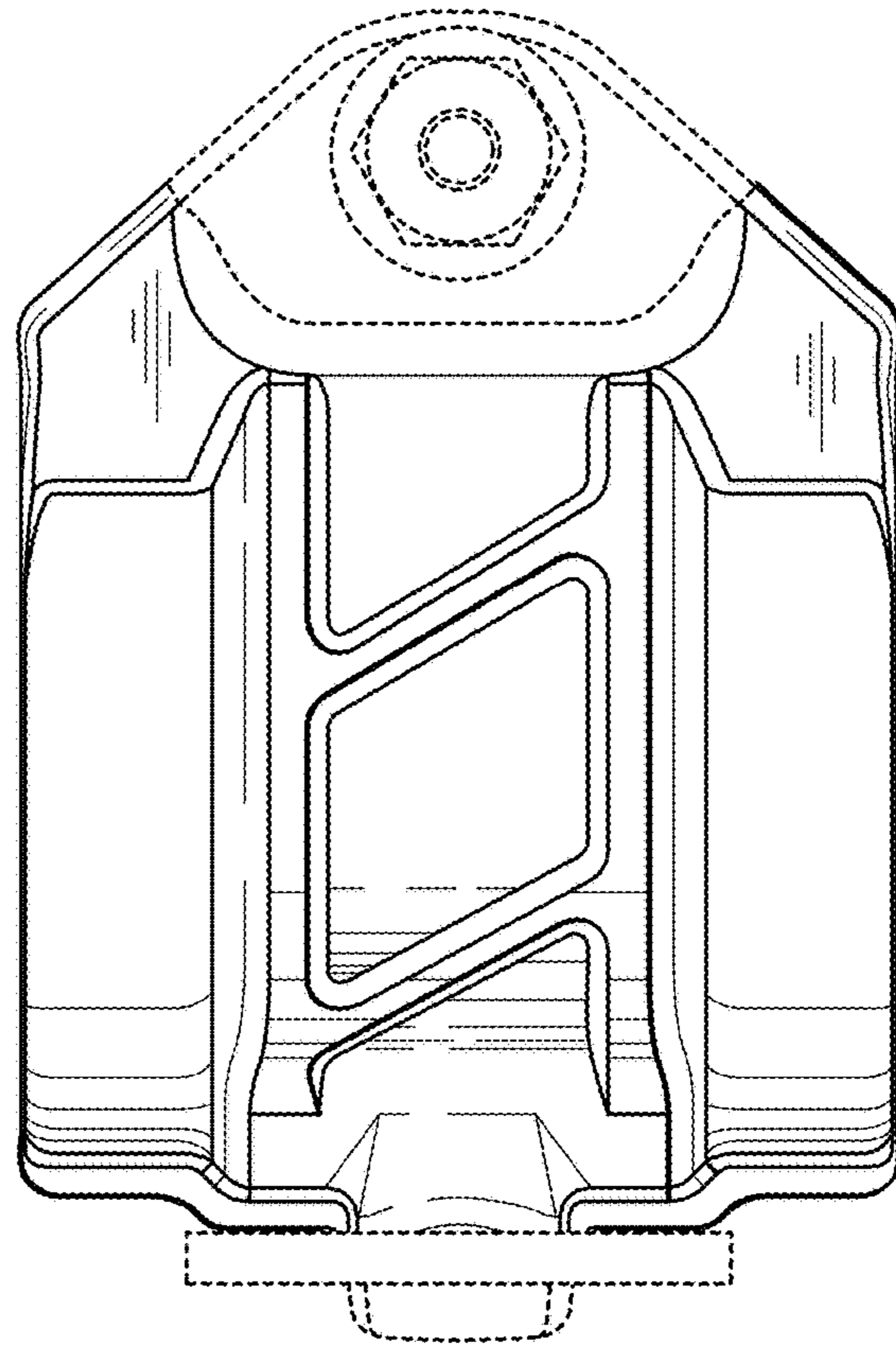
