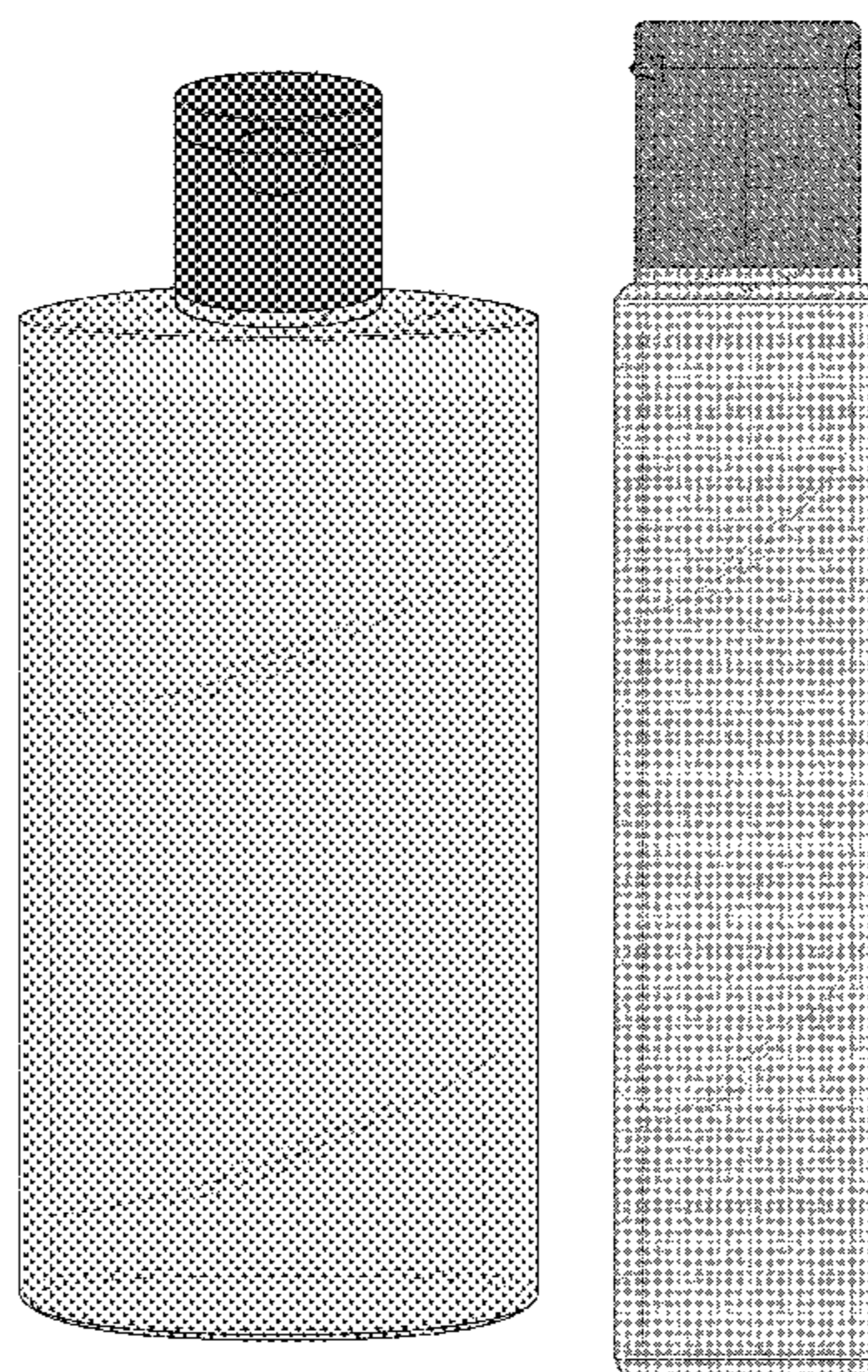

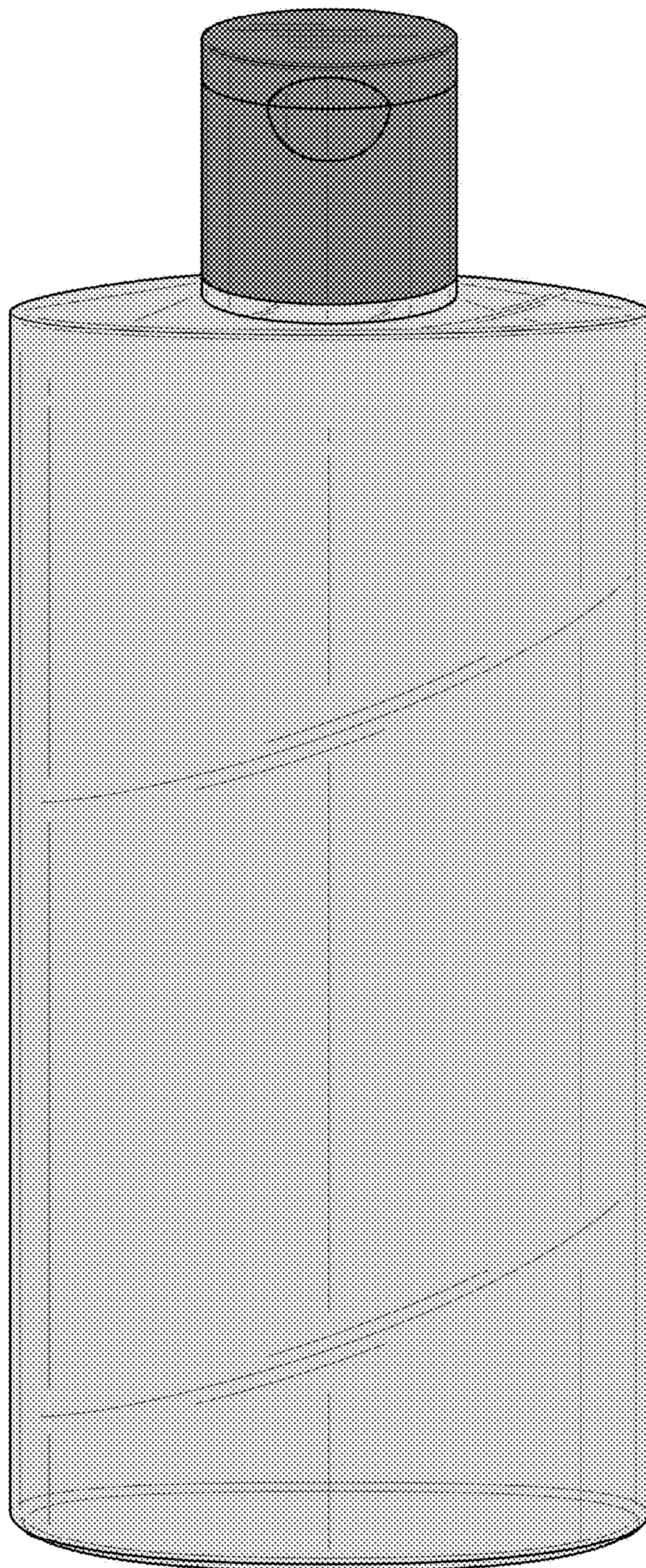

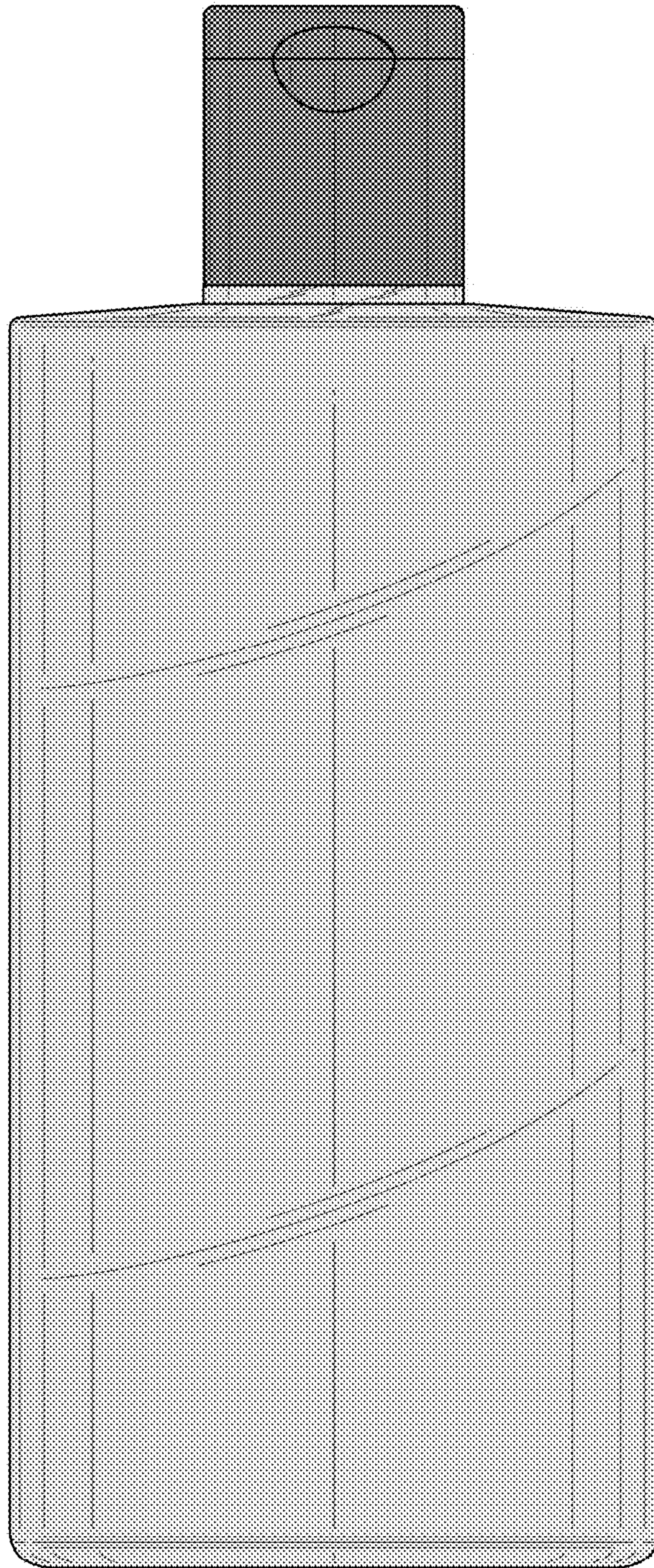

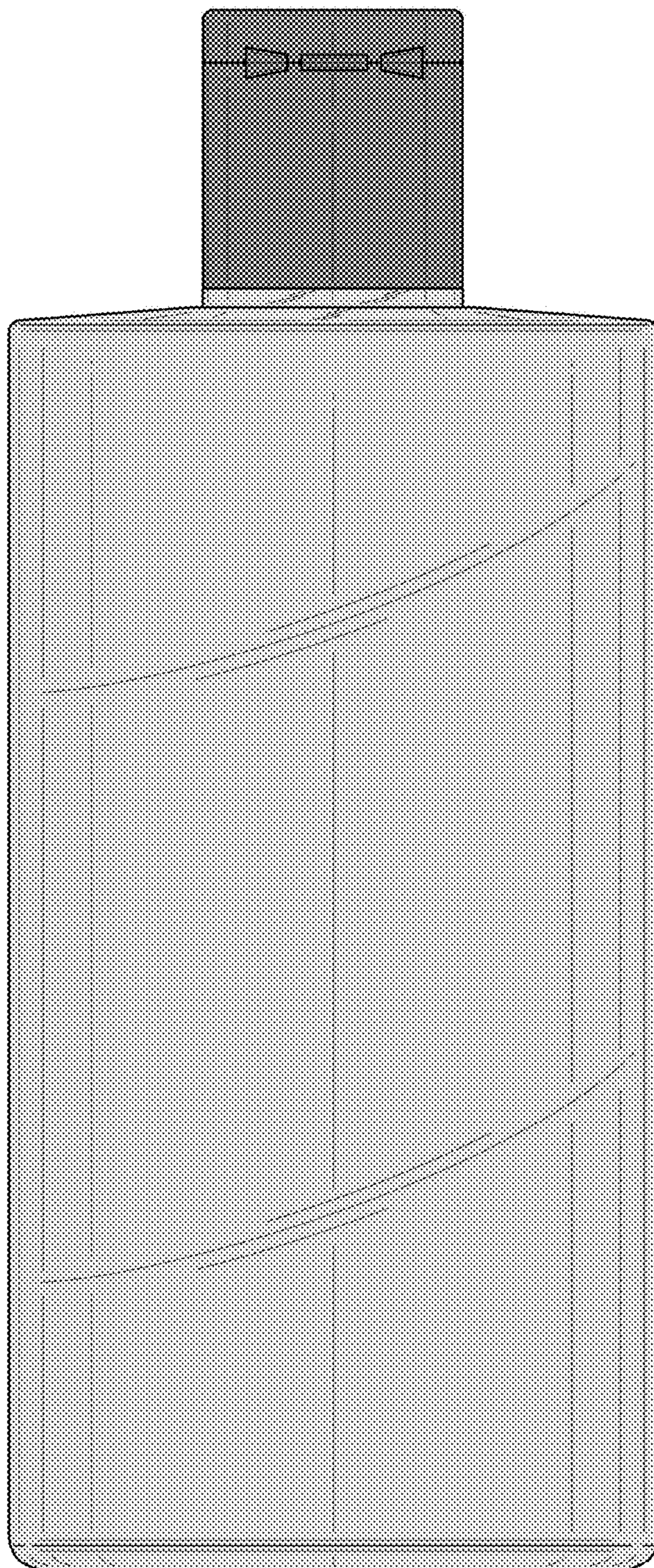

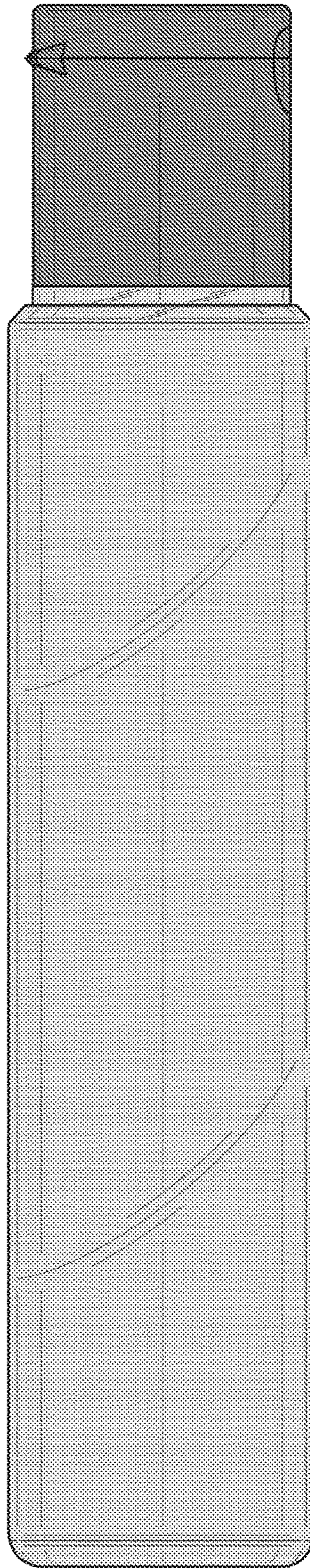

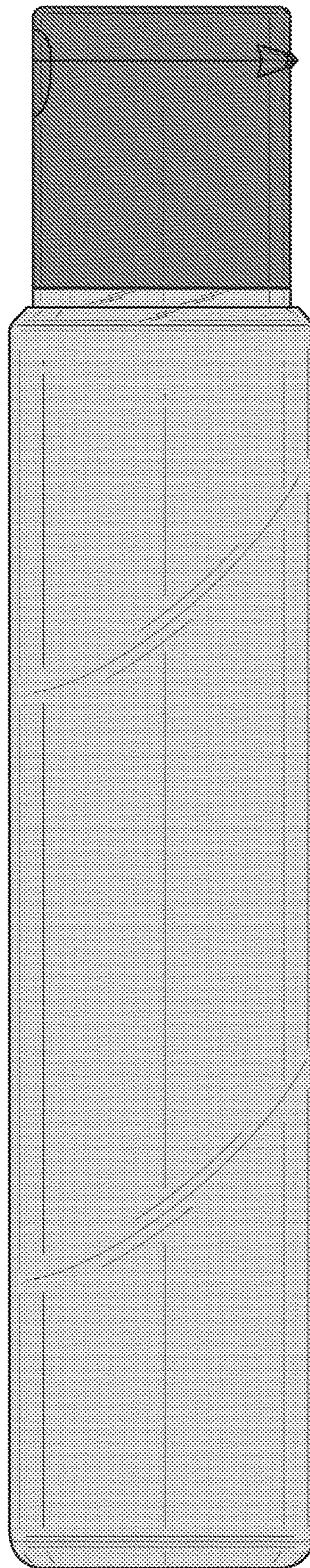

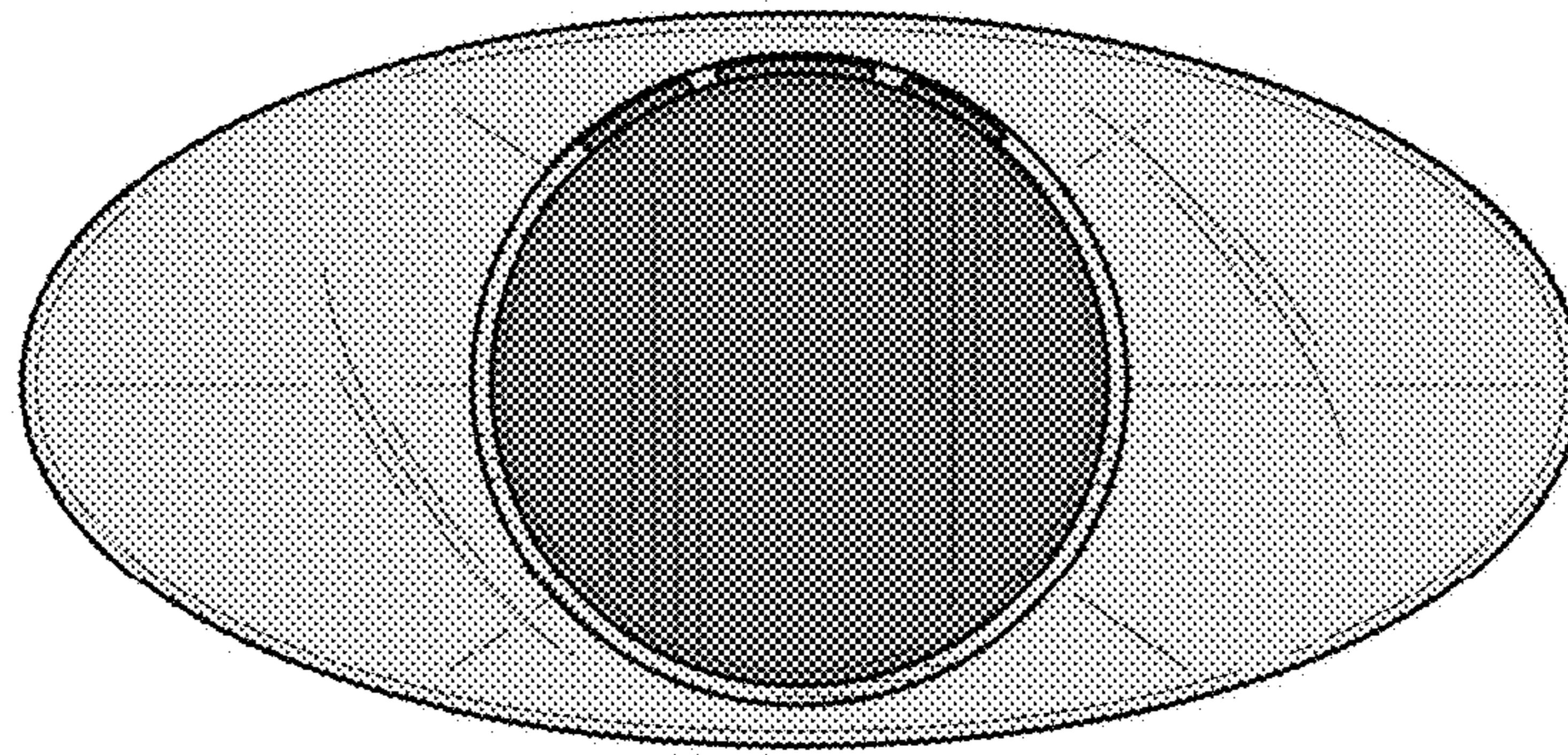

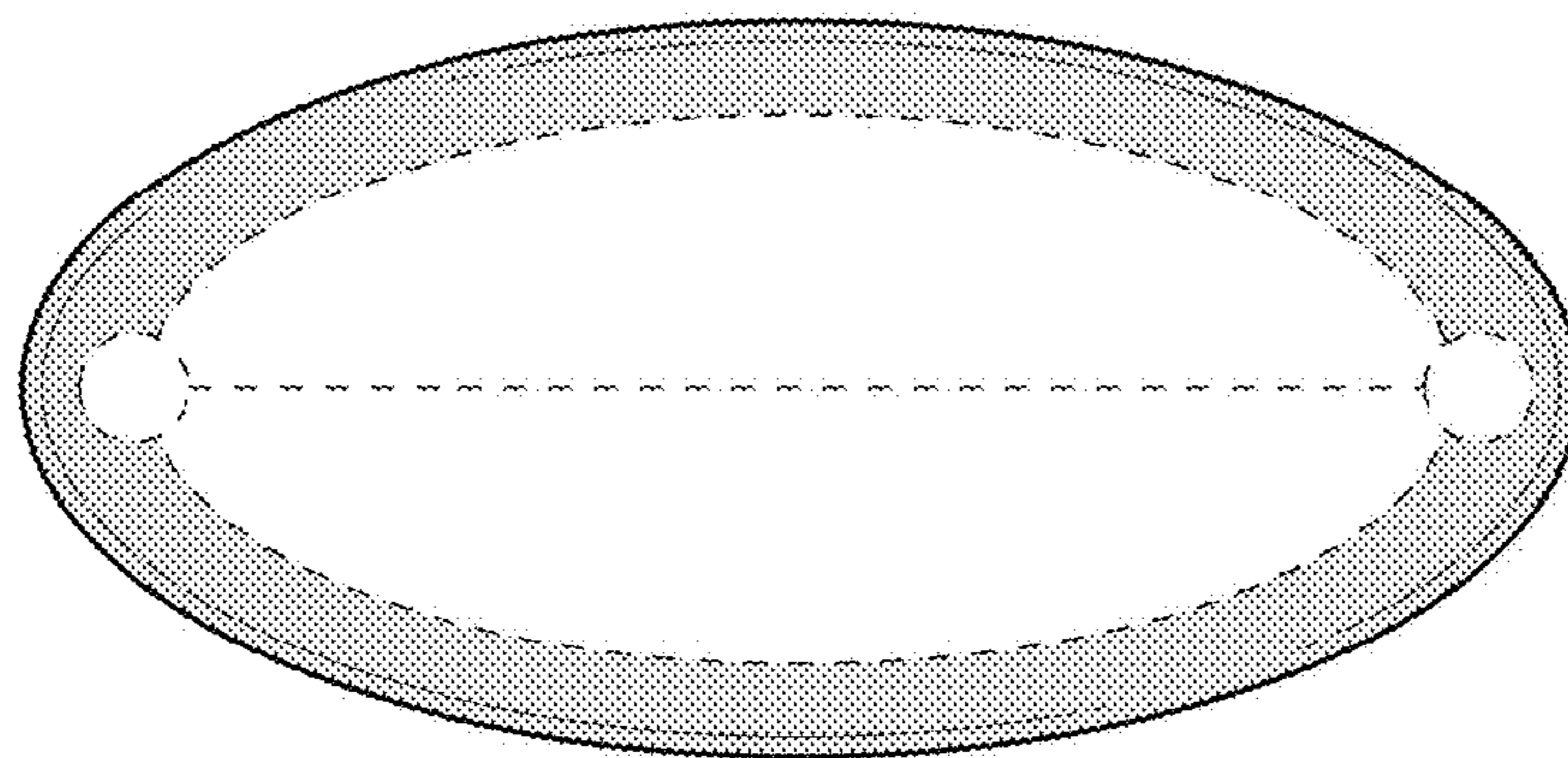

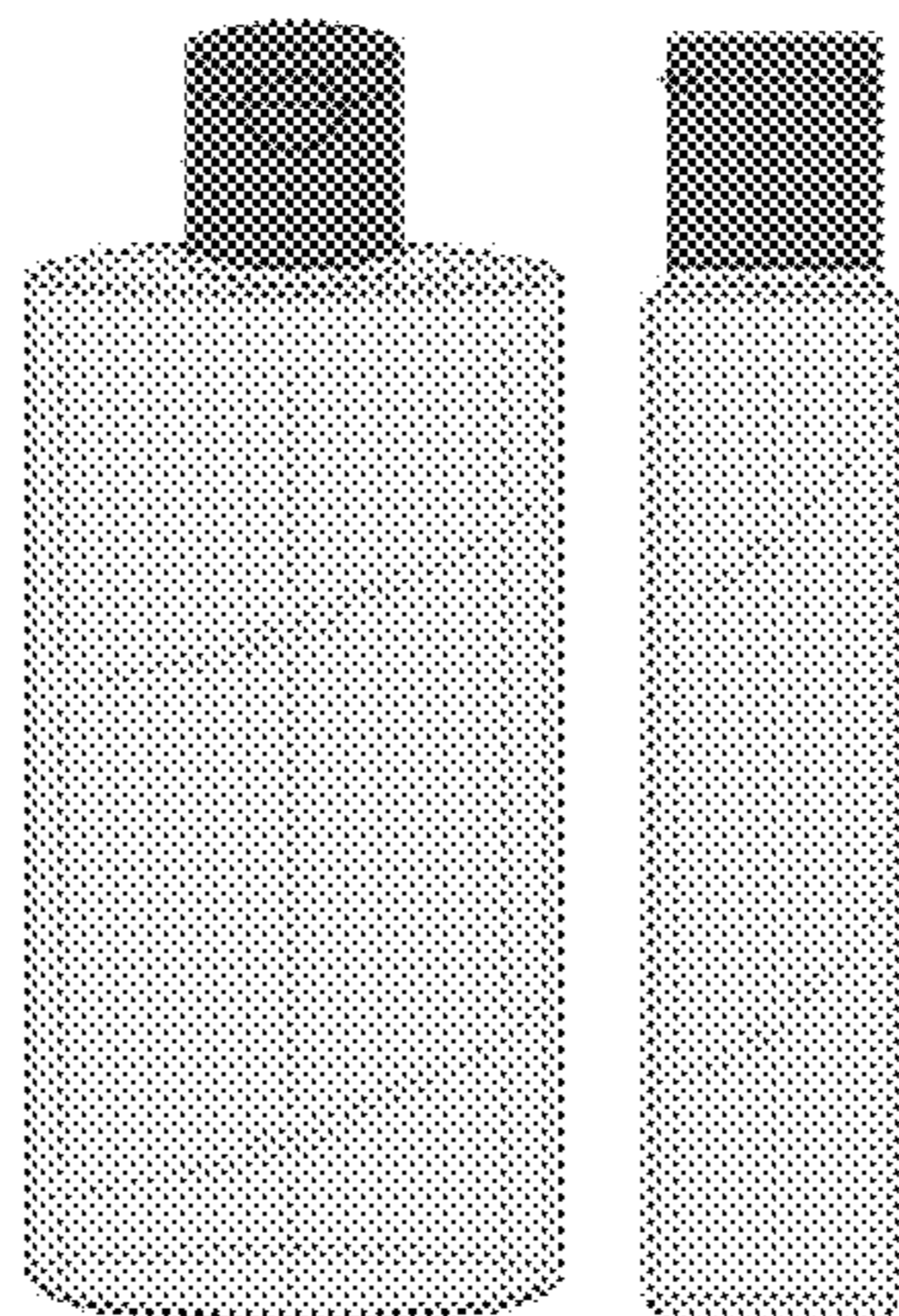
**DESCRIPTION**

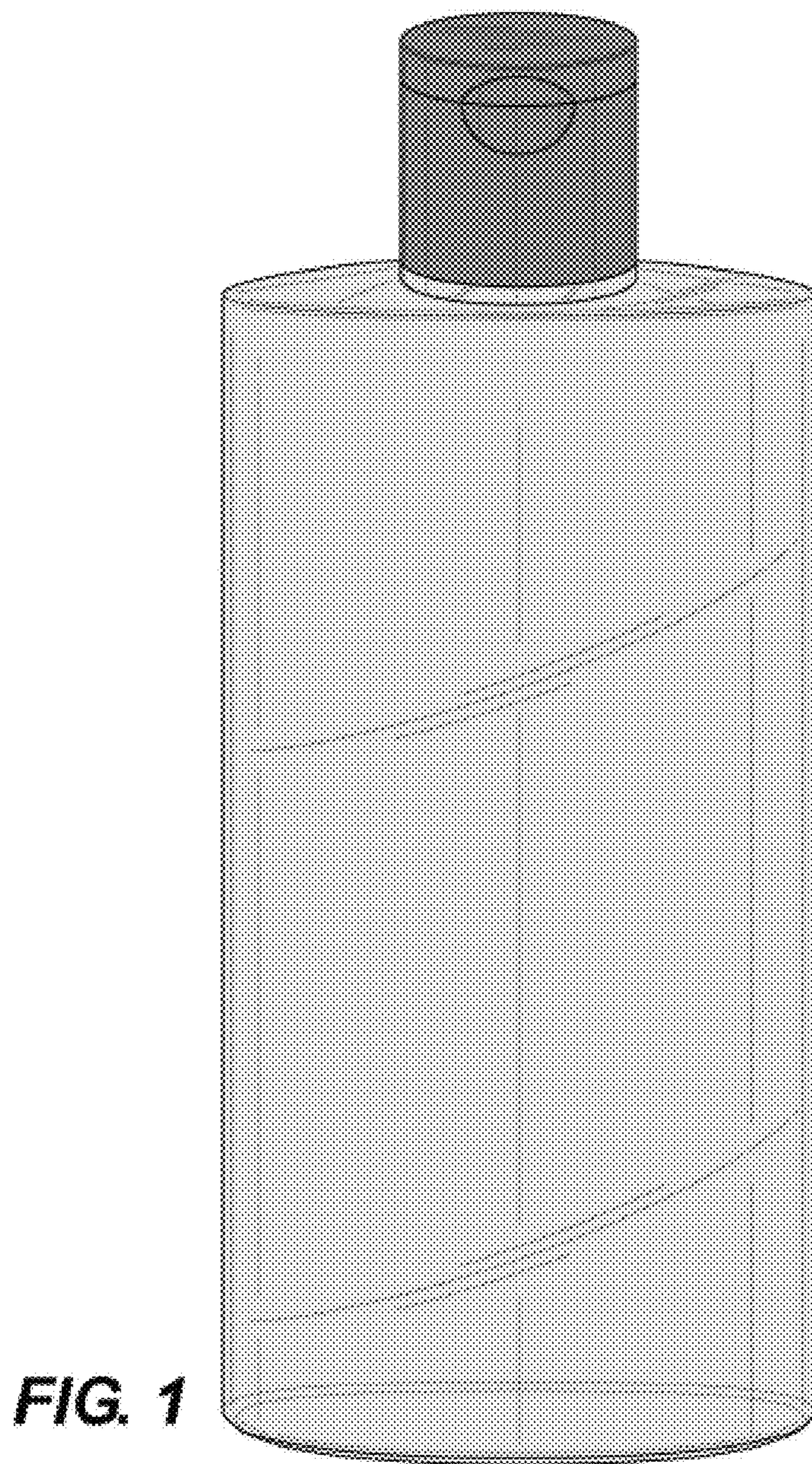

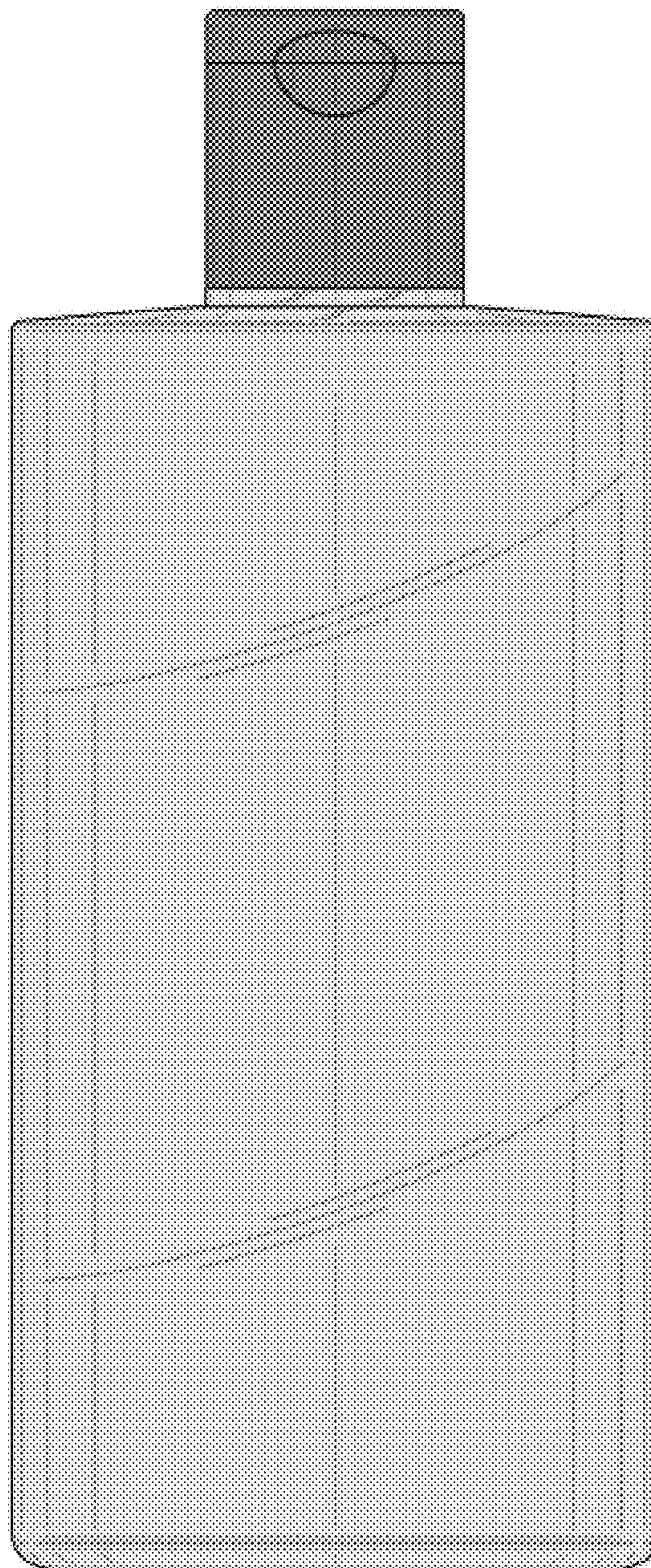

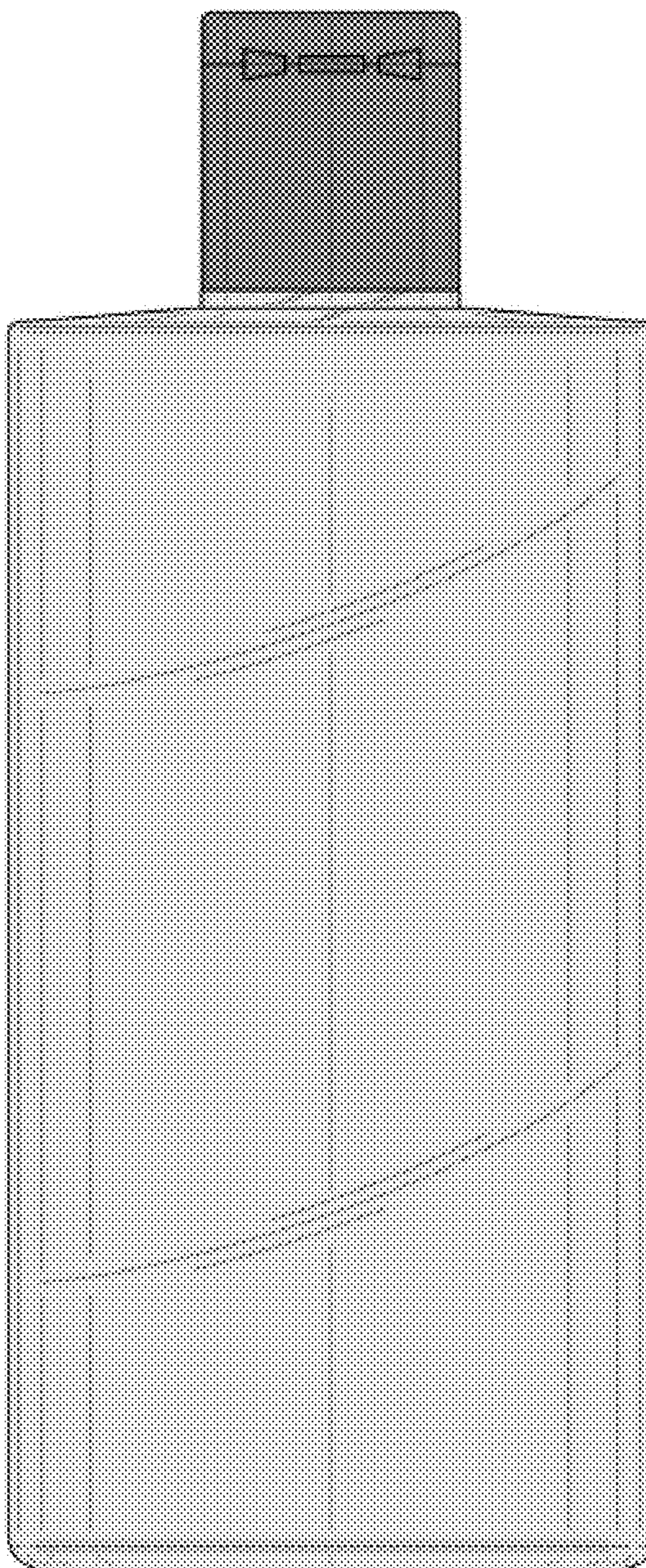

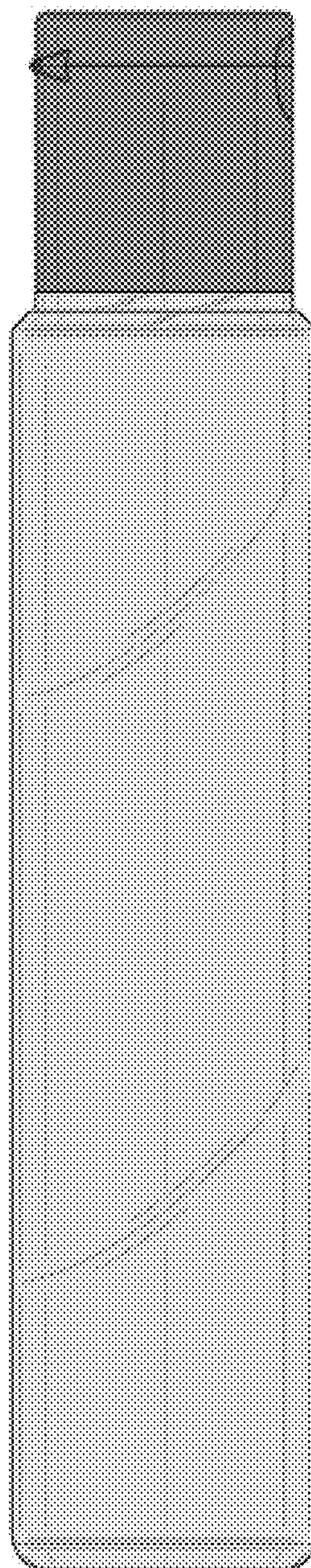

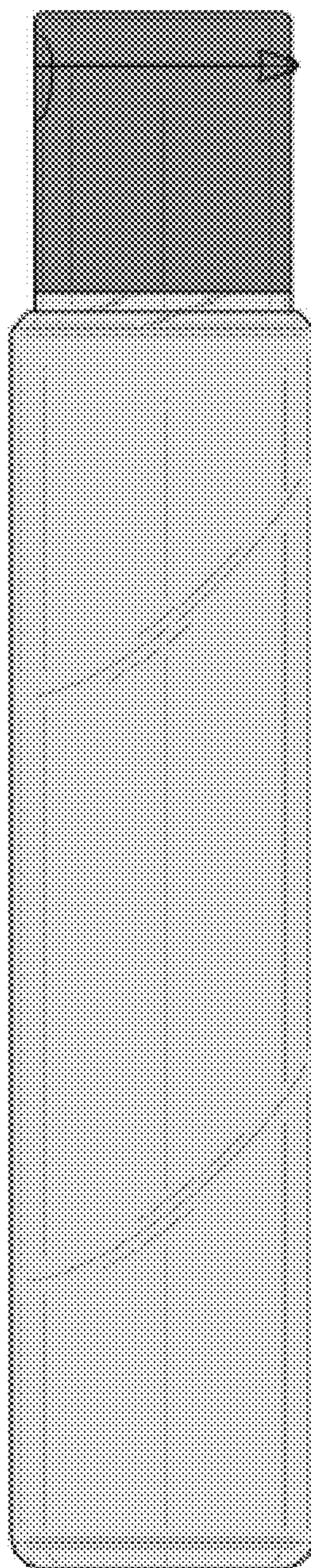

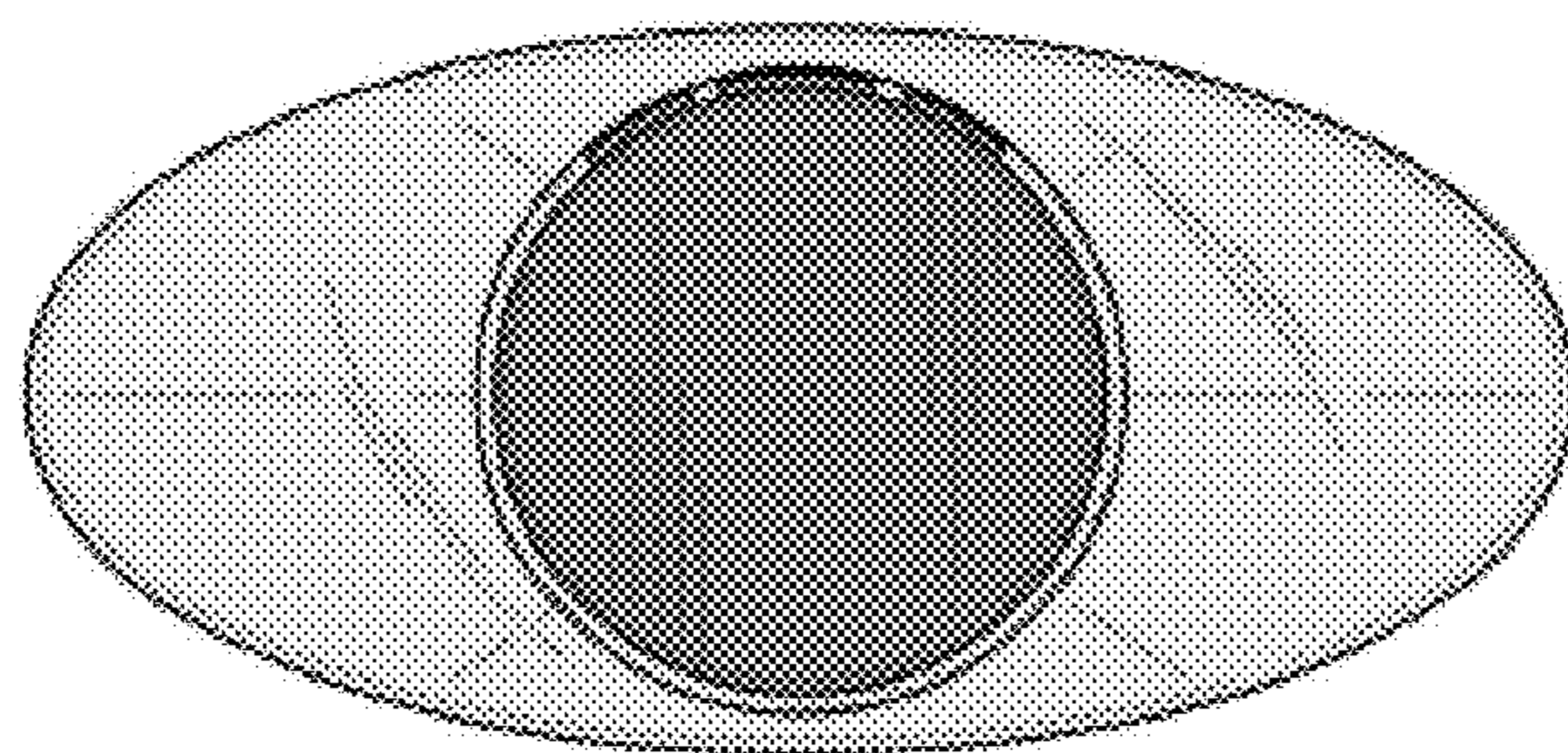

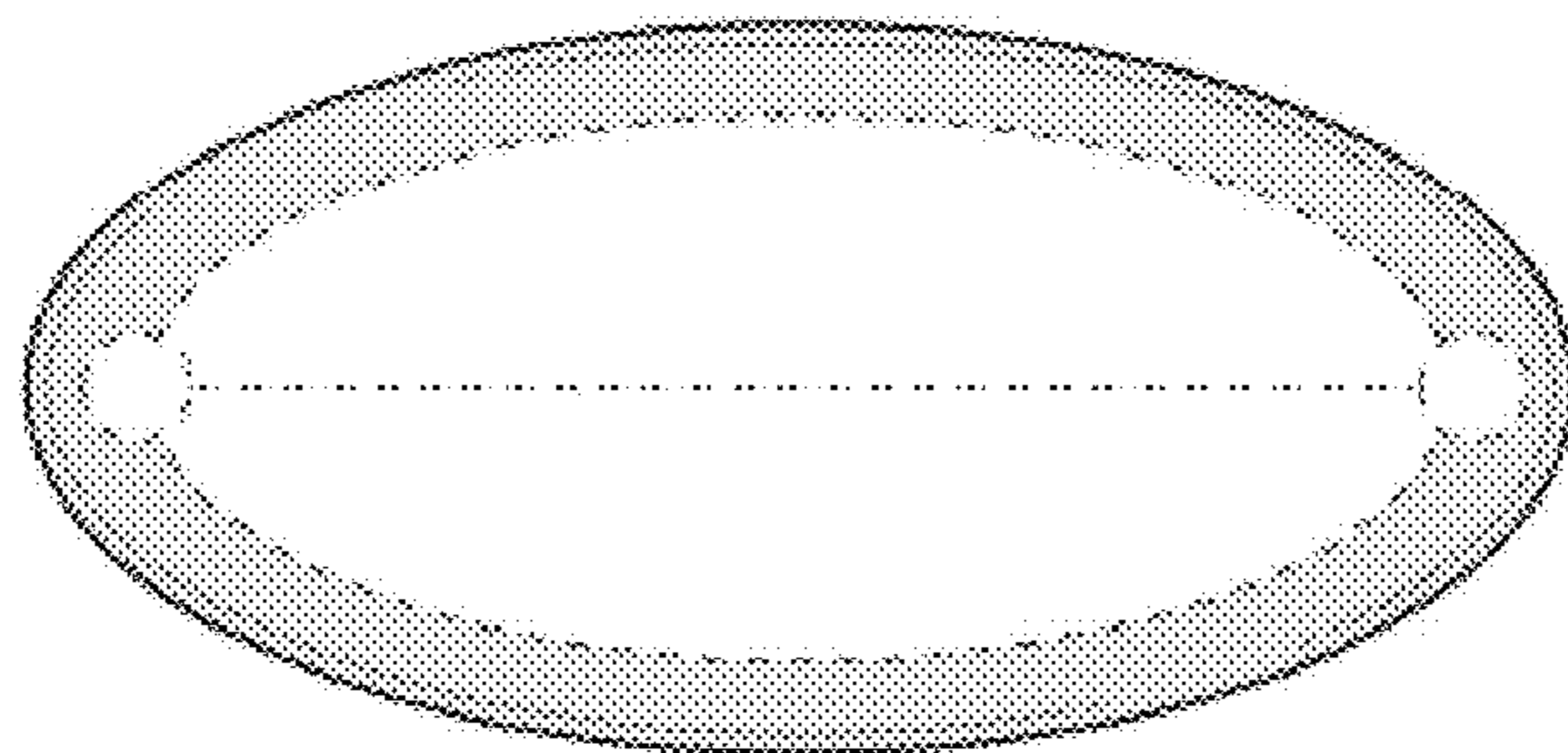
