The ornamental design for a frequency converter, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a frequency converter, showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;


FIG. 4 is a left side elevation view thereof;















