**DESCRIPTION**

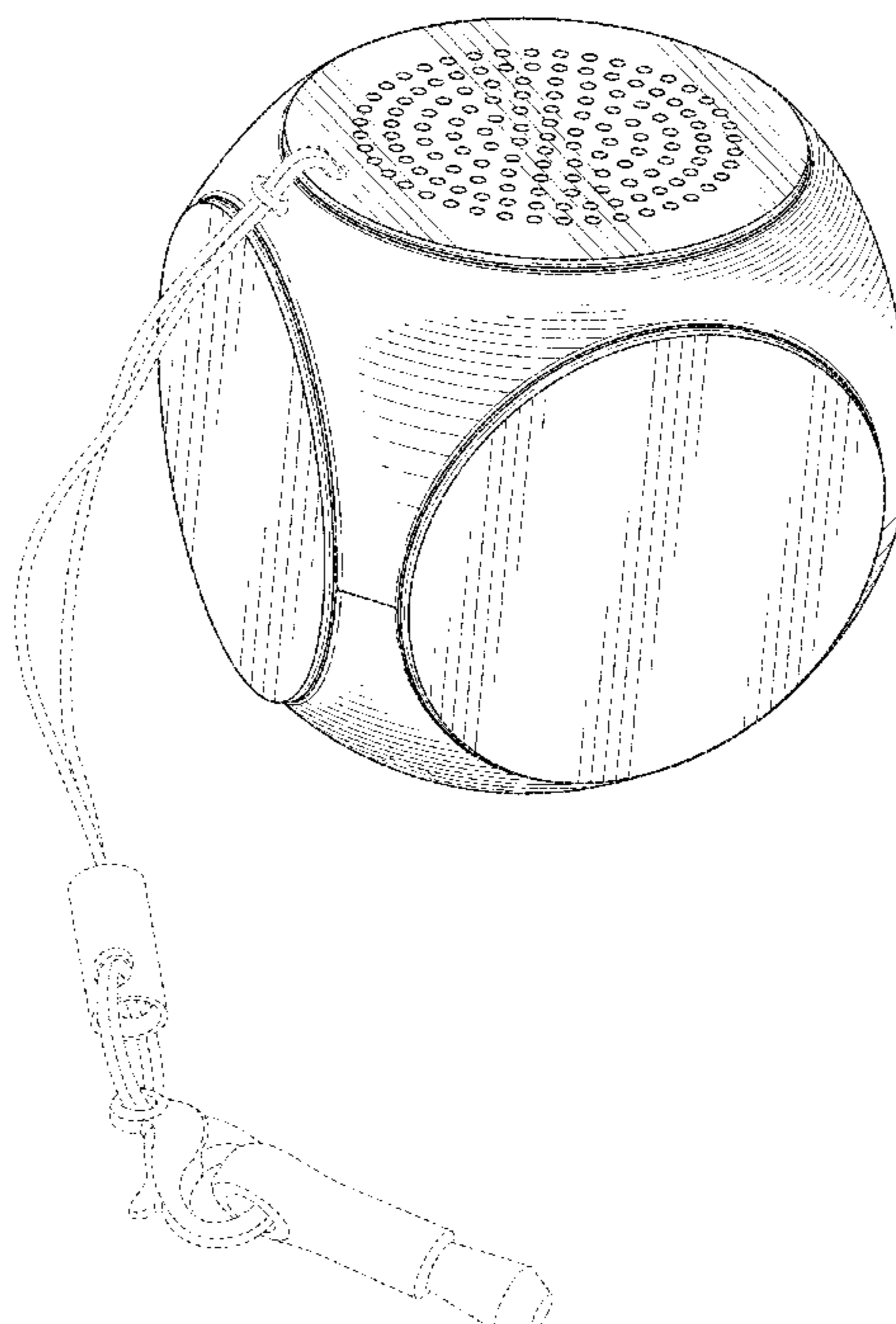
FIG. 1 is a perspective view of a speaker cube, shown in environmental use in enlarged scale, showing my new design;

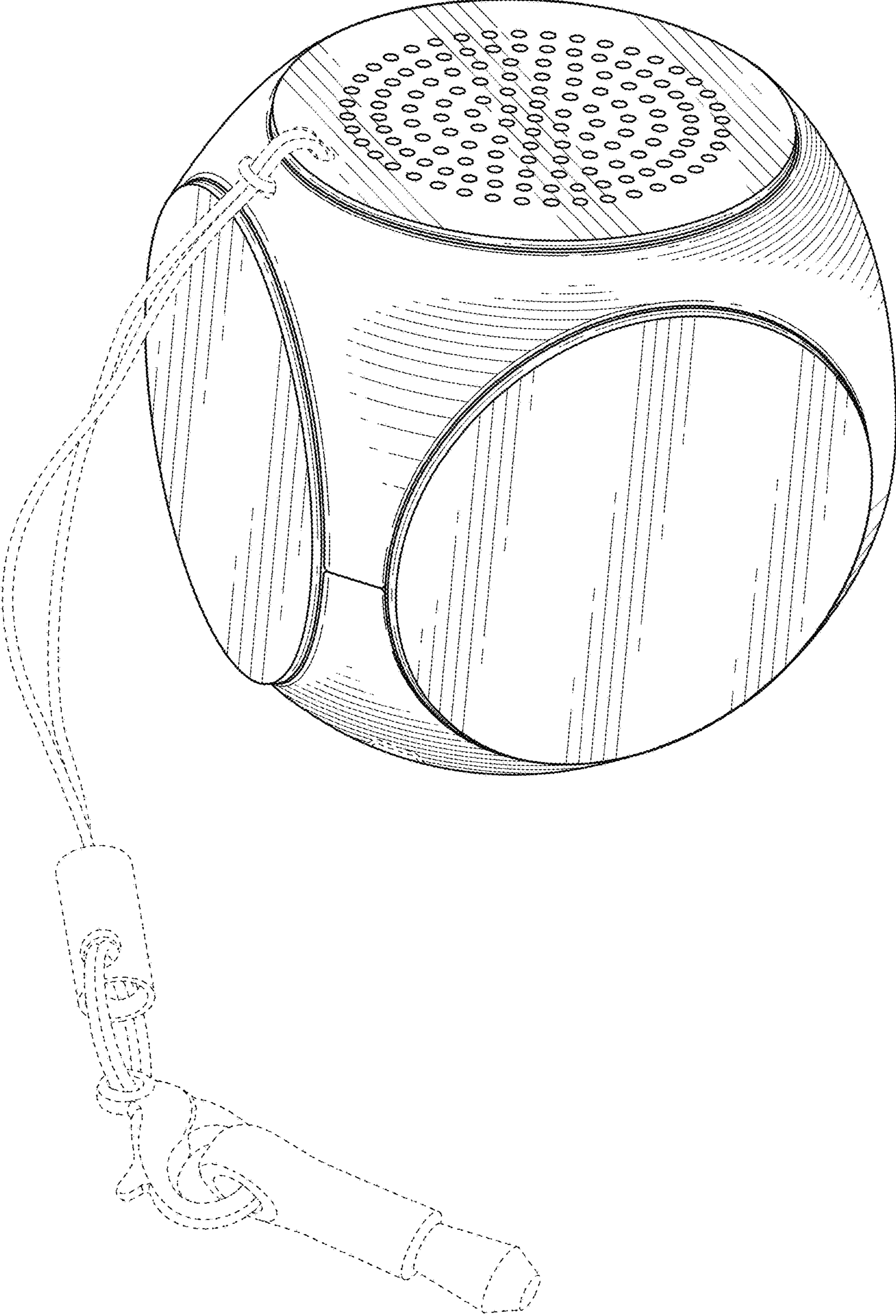

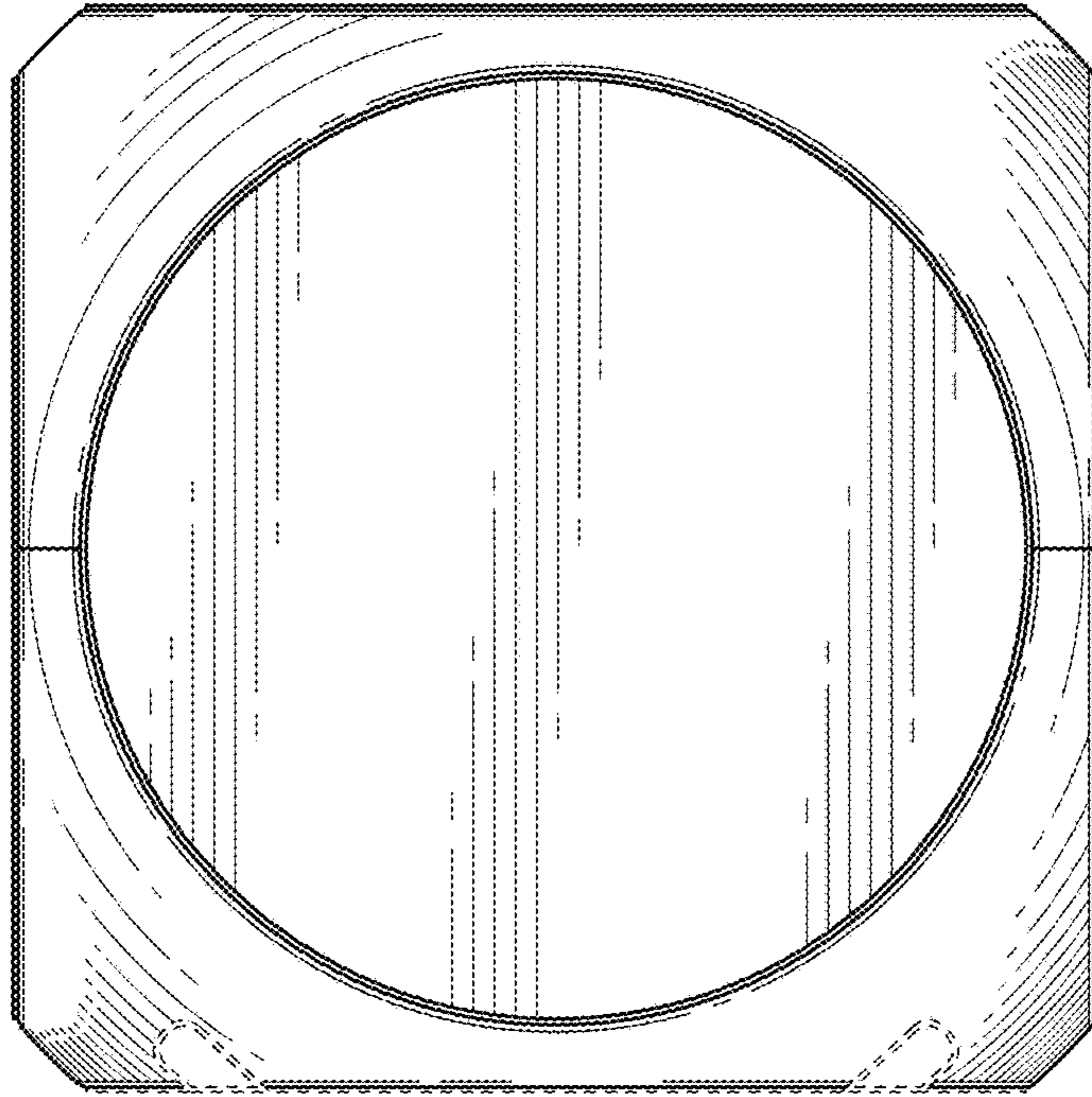

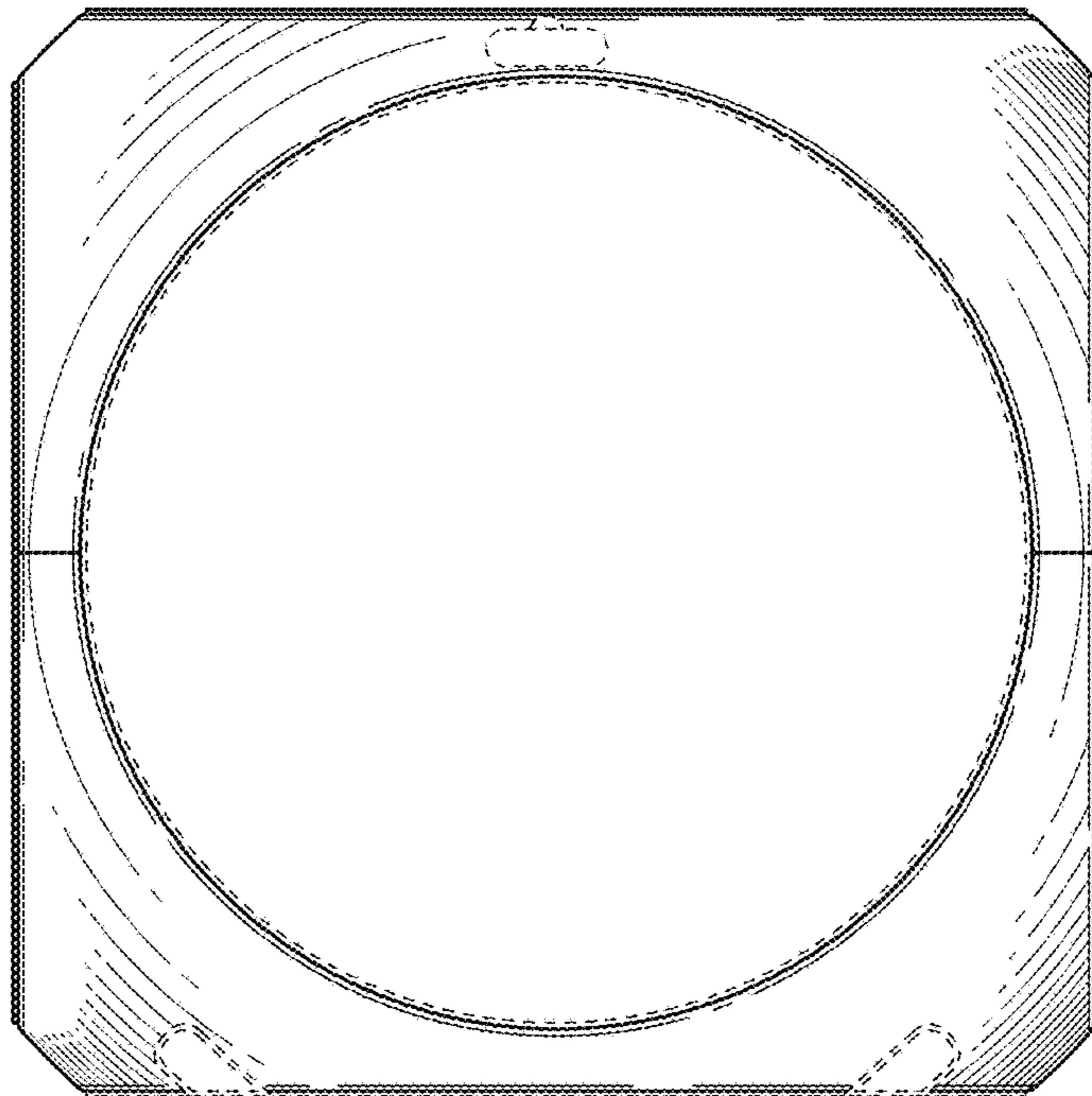

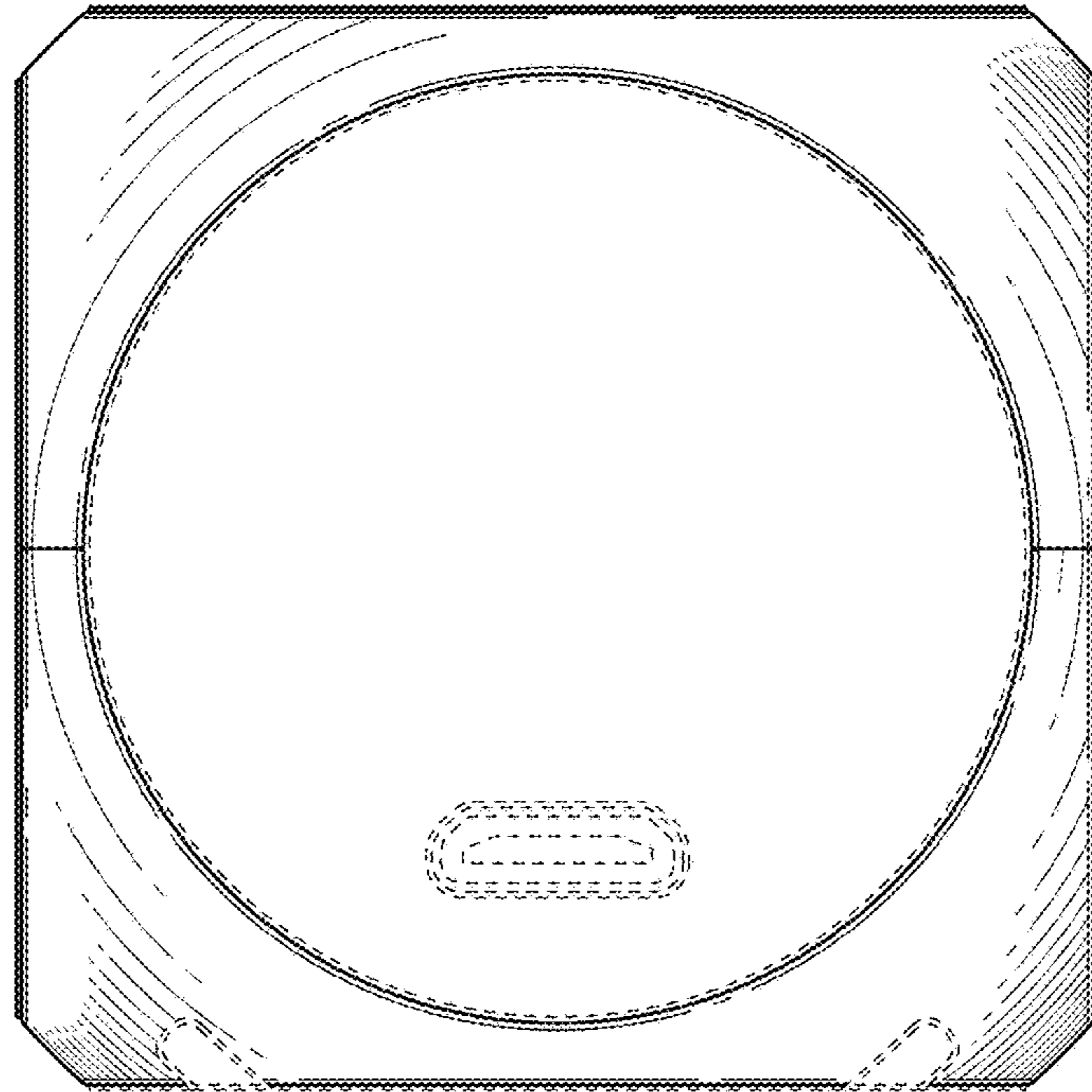

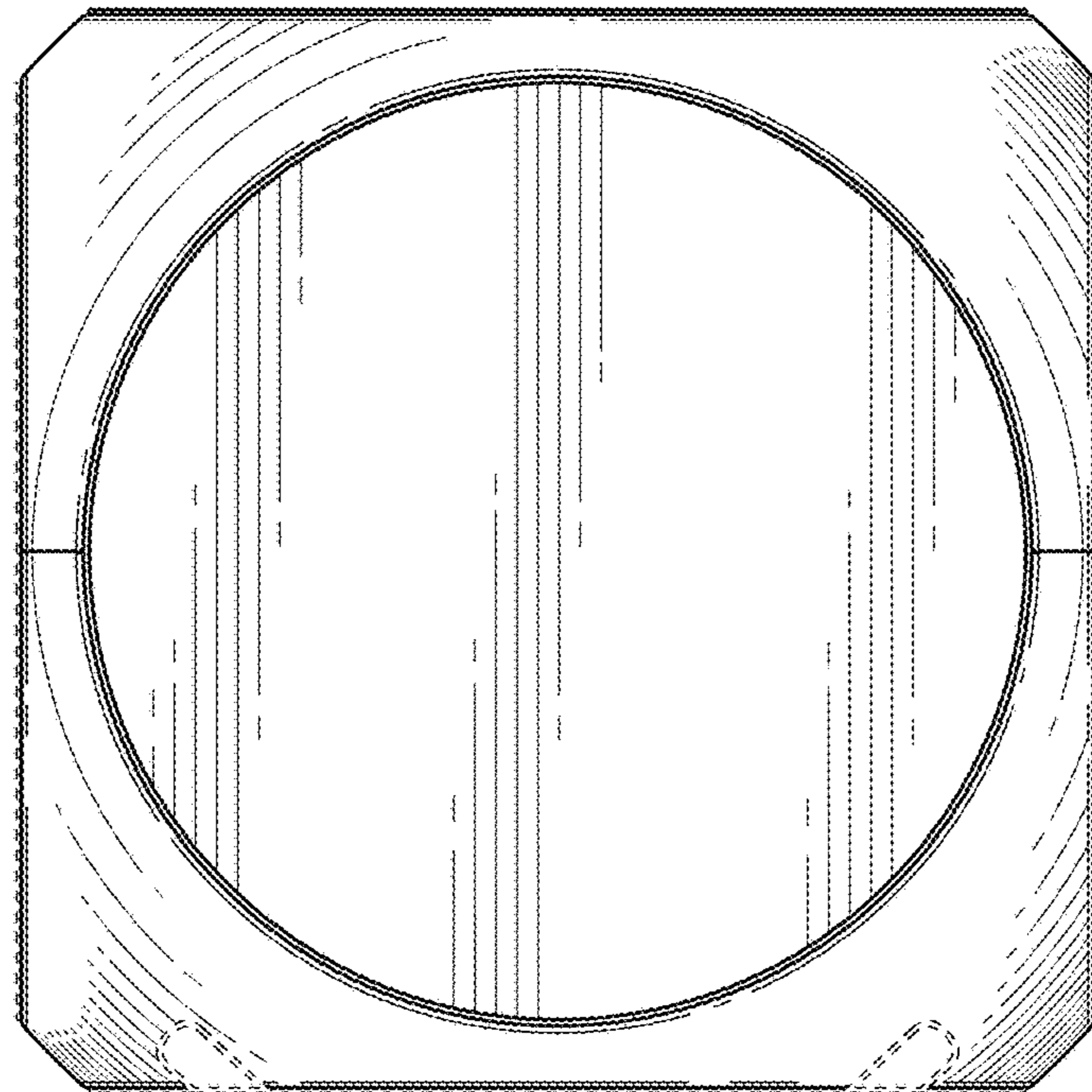

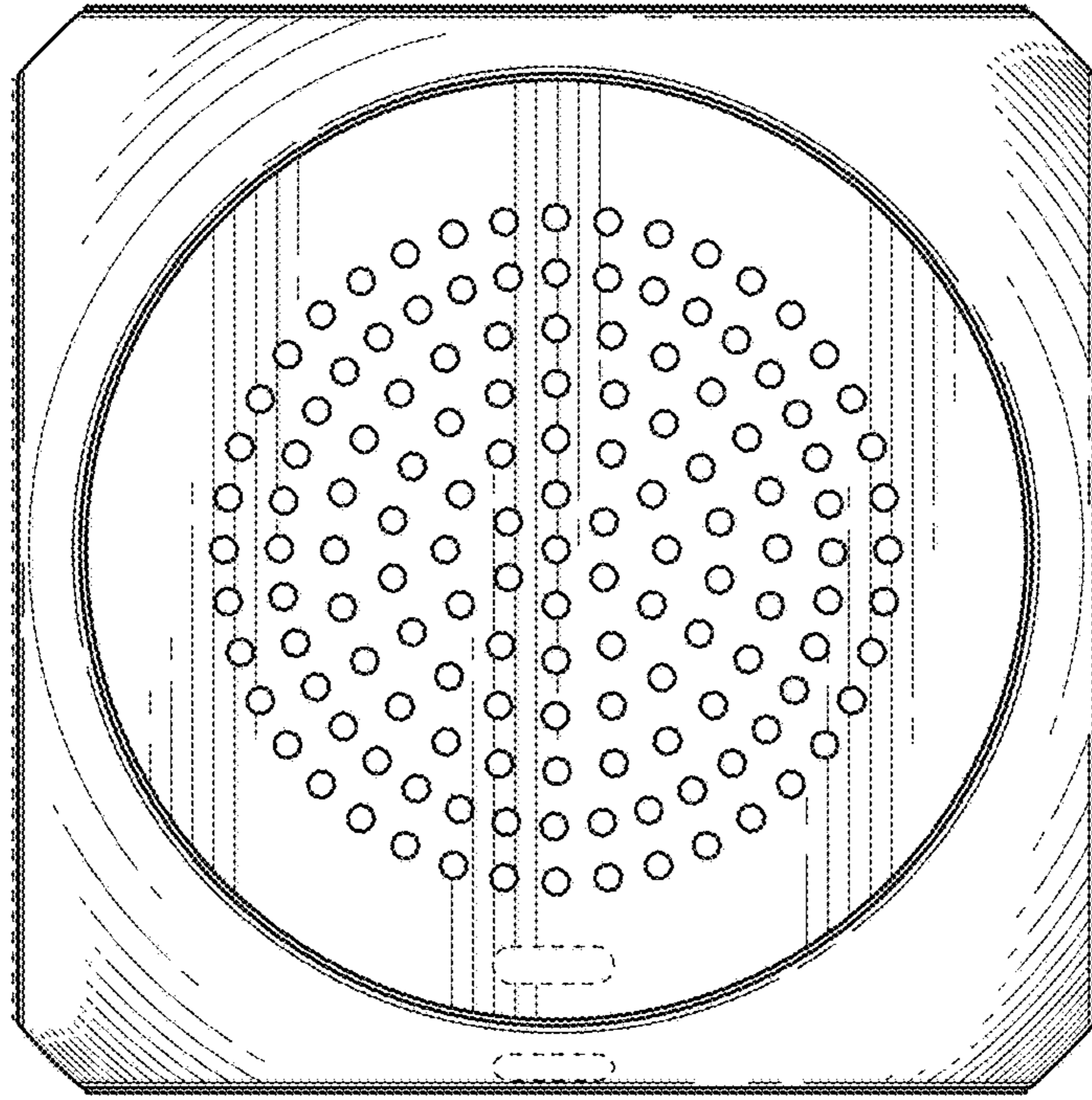

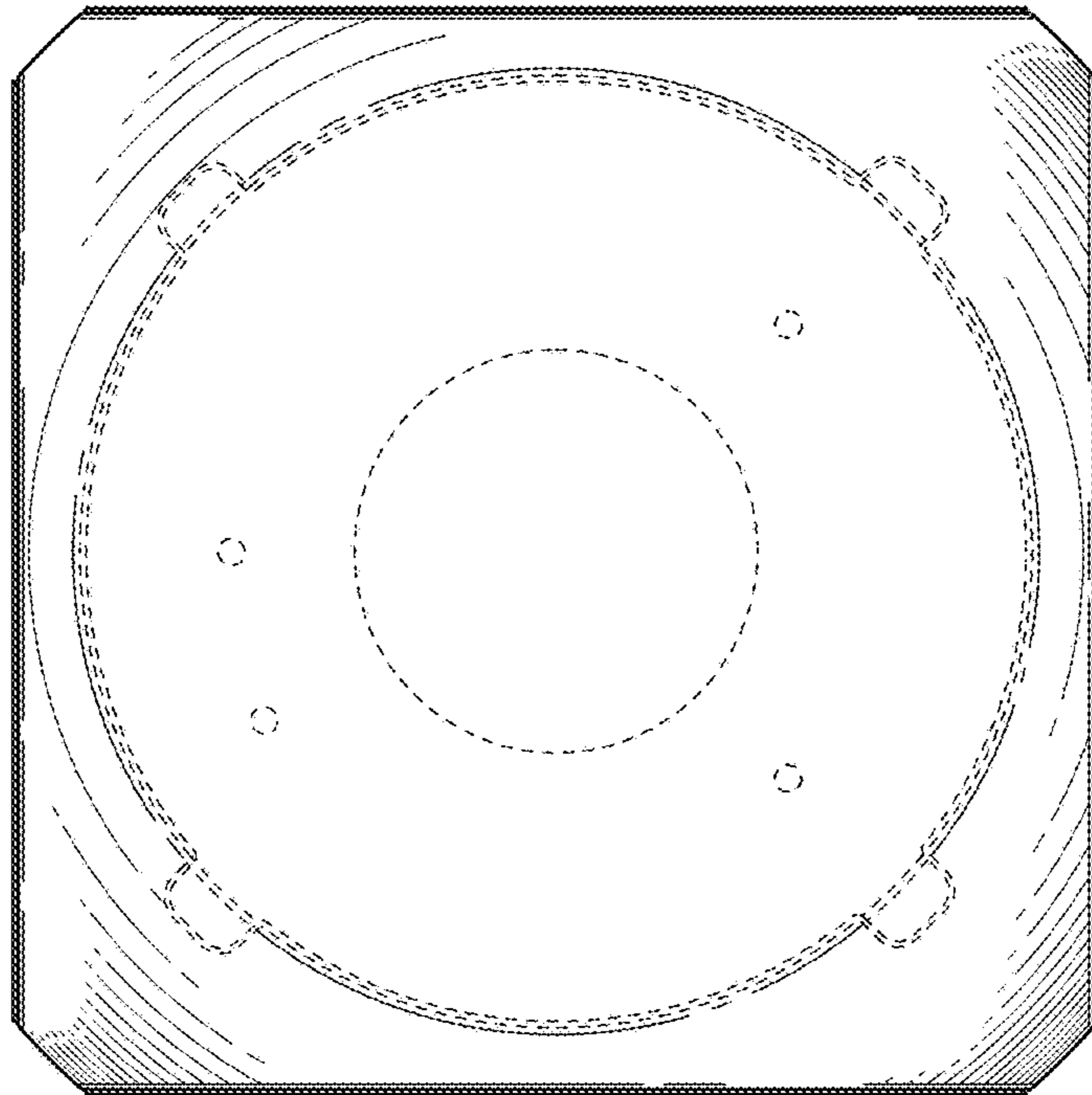
