FIG. 4 is a rear perspective view of FIG. 1 thereof;

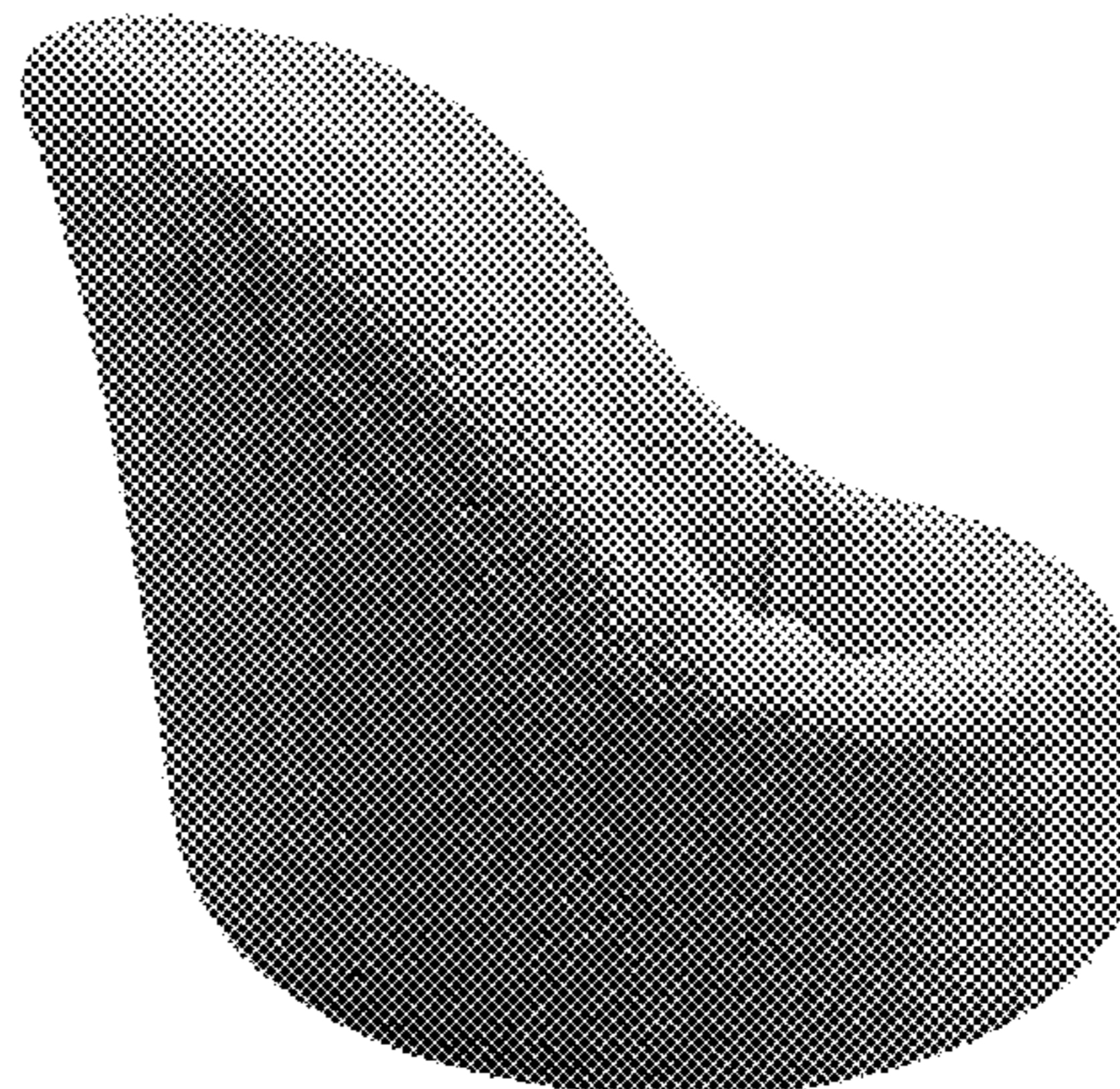
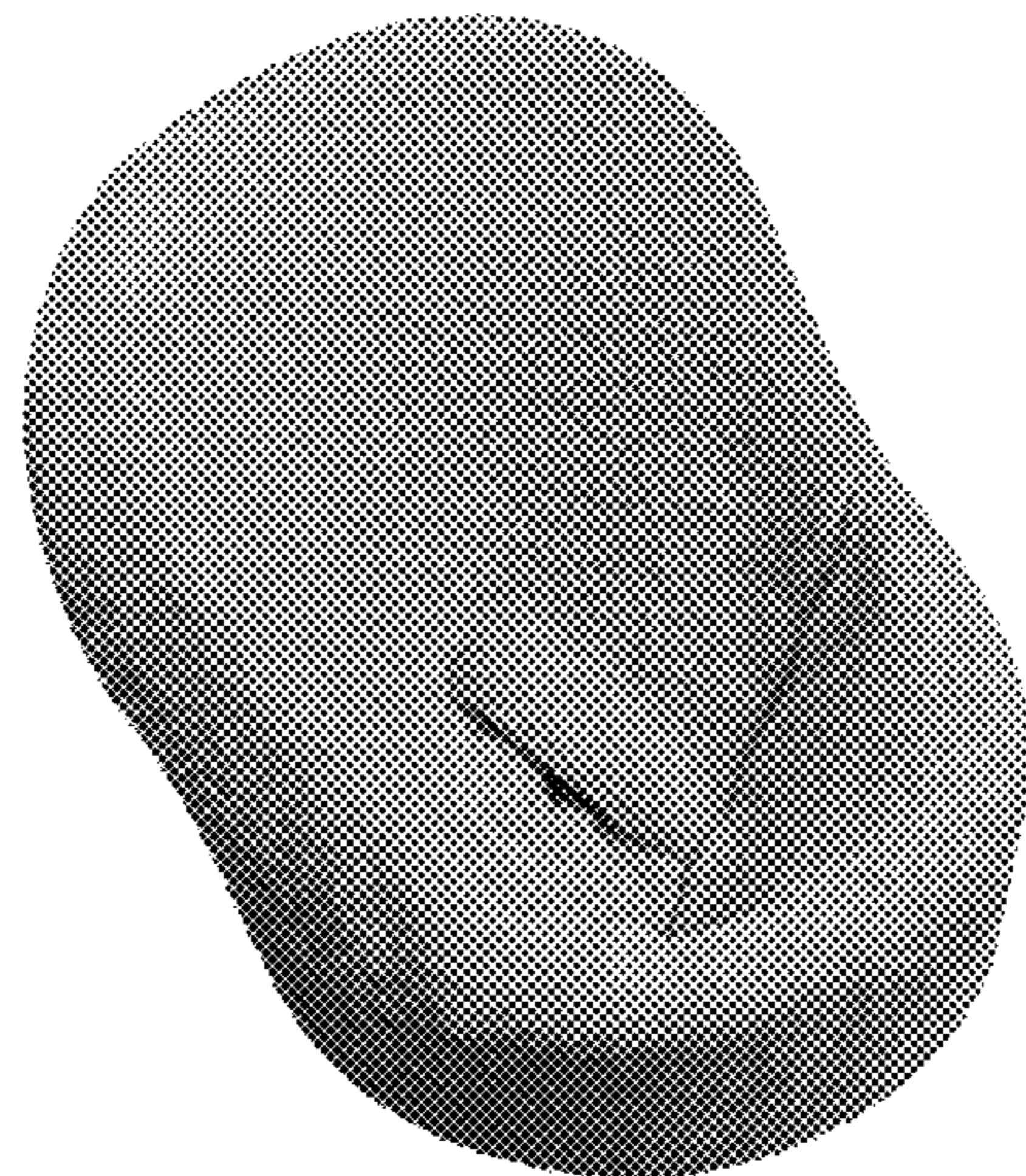
FIG. 5 is a left perspective view of FIG. 1 thereof;

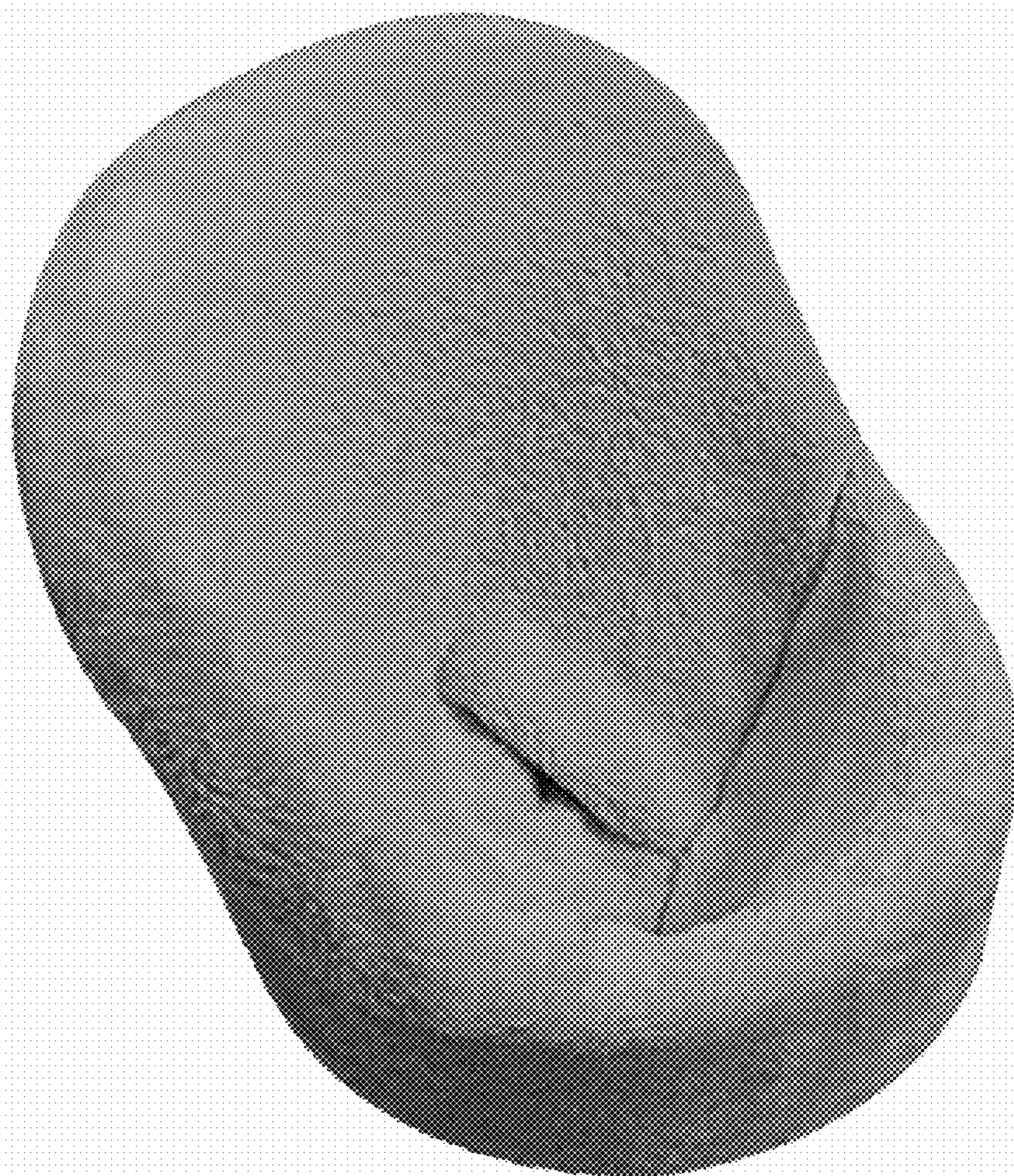

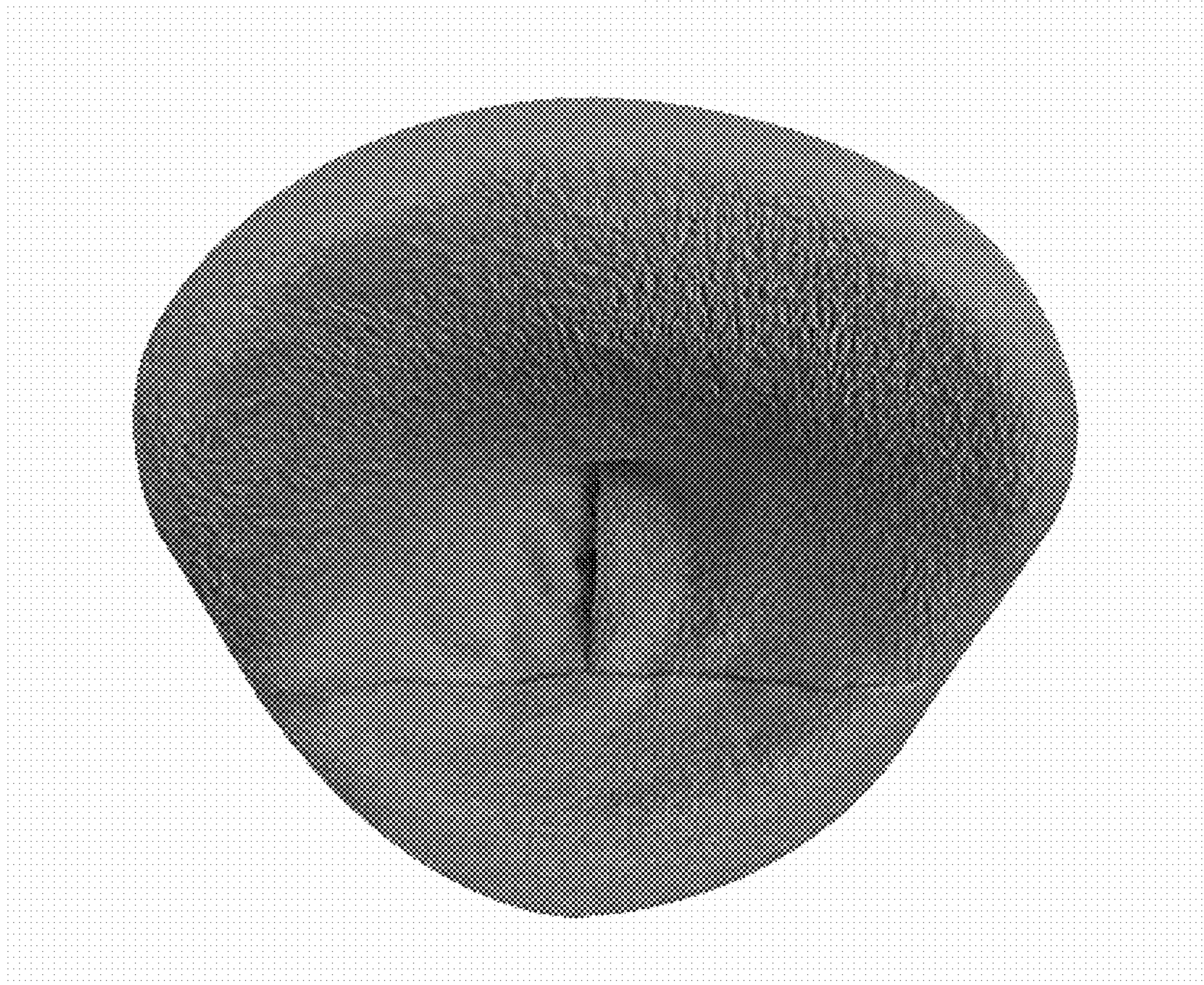
