DESCRIPTION

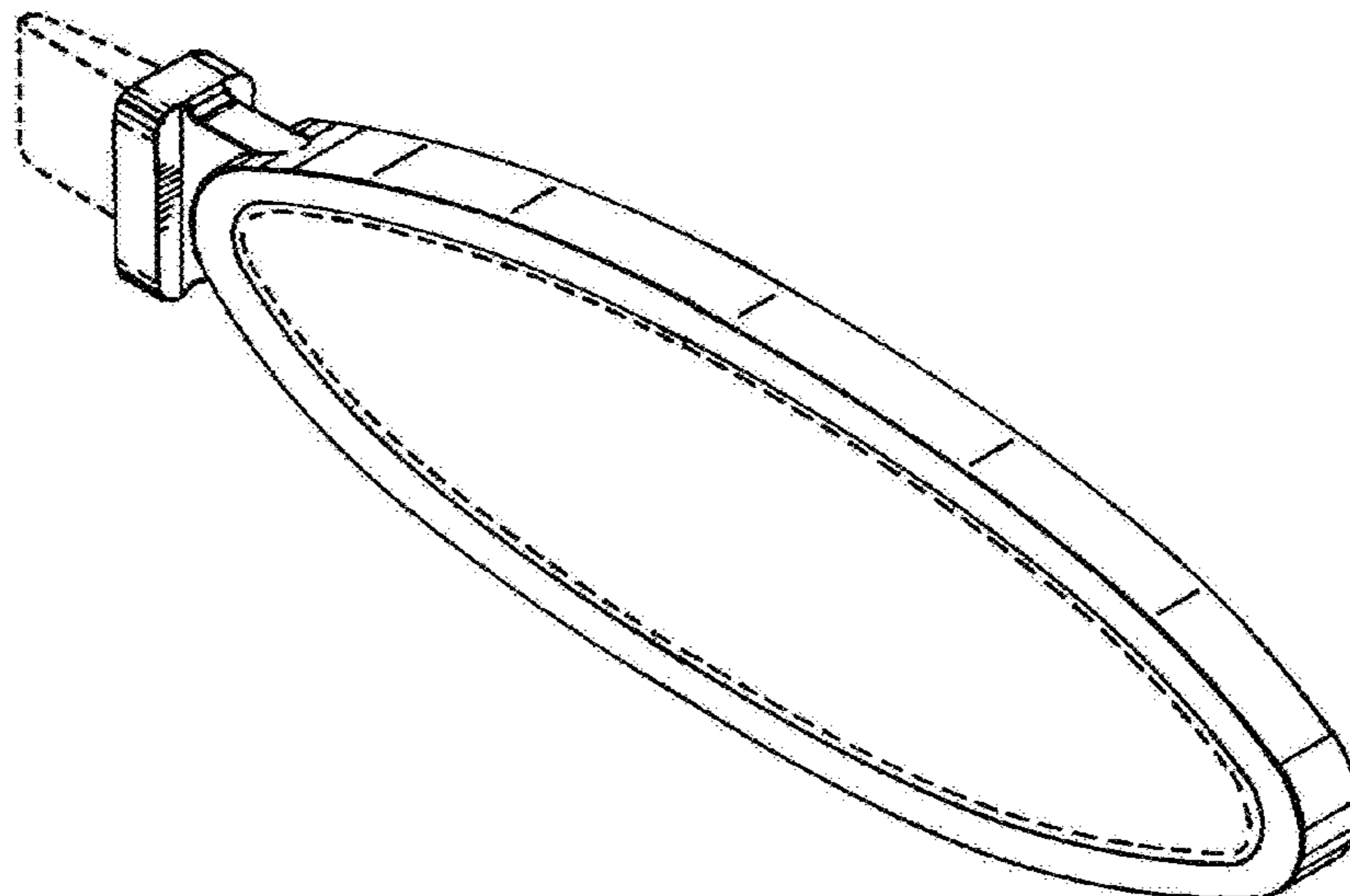
FIG. 1 is a perspective view of a tool for arts and crafts showing our new design; FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image of FIG. 2; FIG. 3 is a left side elevation view thereof, the right side elevation being a mirror image of FIG. 3; FIG. 4 is a front elevation view thereof; and, FIG. 5 is a rear elevation view thereof. 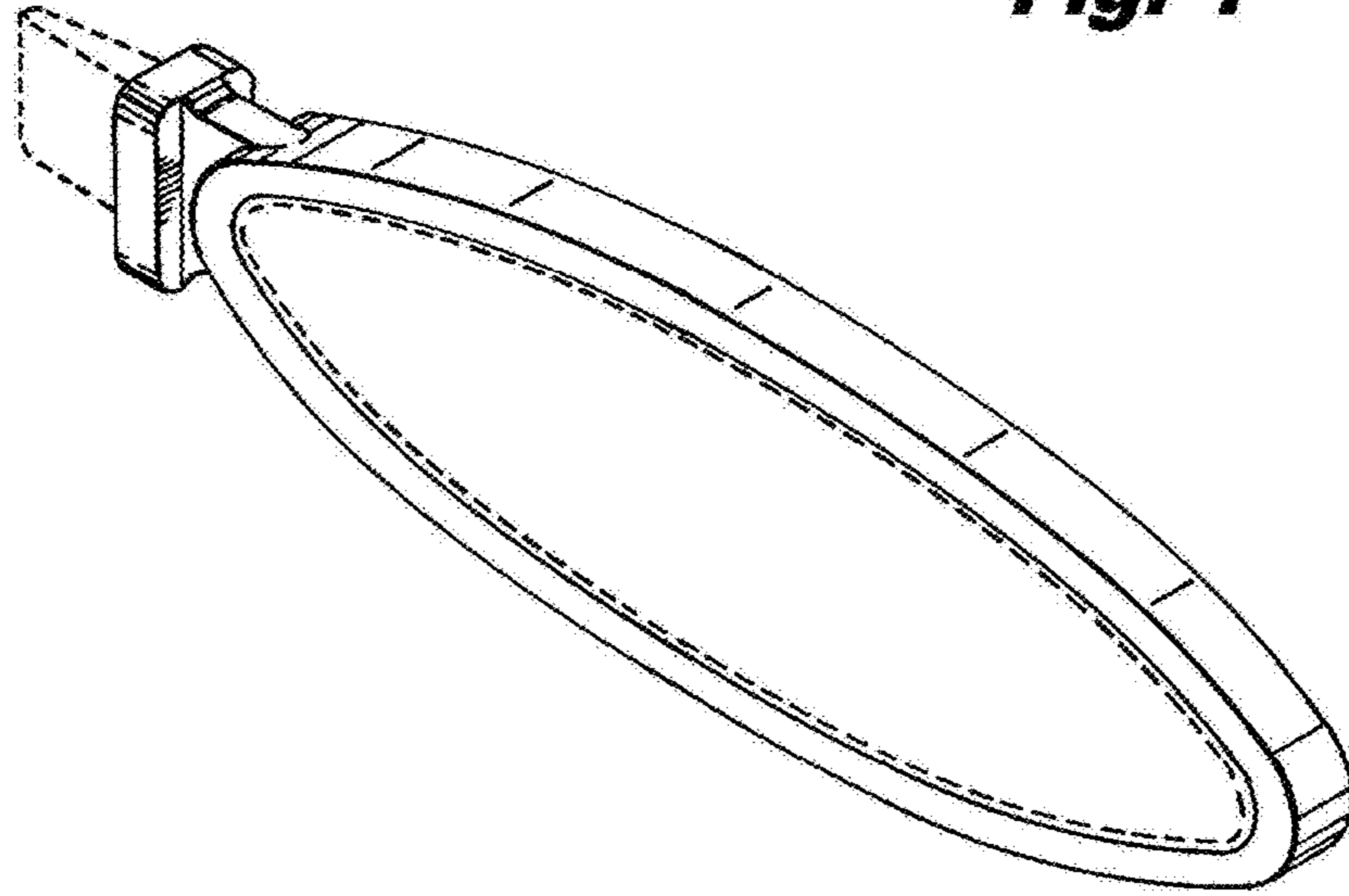

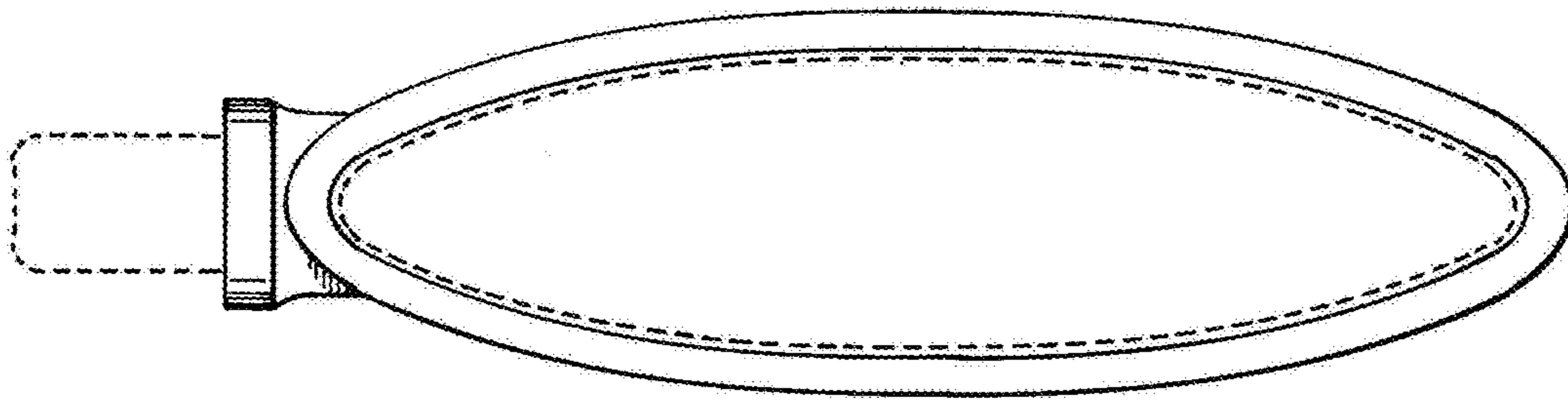

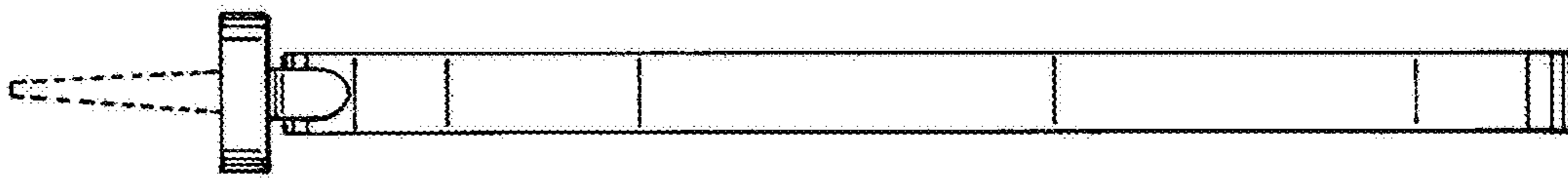
