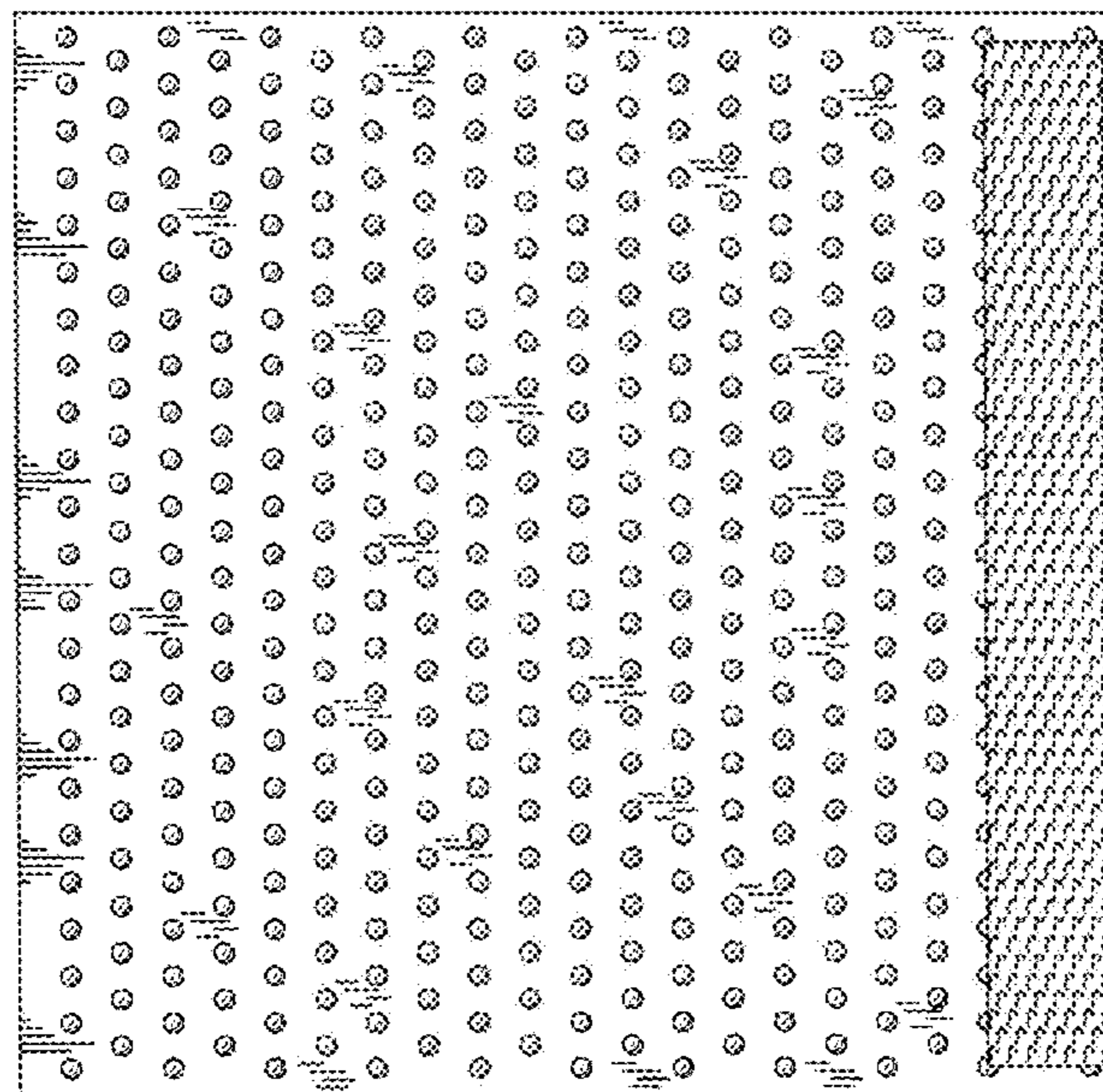
(57) **CLAIM**

The ornamental design for a cover for an exercise equipment handle, as shown and described.

DESCRIPTION

FIG. 1 is a plan view showing the interior of the cover for an exercise equipment handle showing my new design; FIG. 2 is a plan view showing the exterior thereof; FIG. 3 is a top perspective view thereof; and, FIG. 4 is a top perspective view of the cover for an exercise equipment handle in the environment of use thereof. The broken lines showing the exercise equipment are included for the purpose of illustrating environment and form no part of the claimed design.

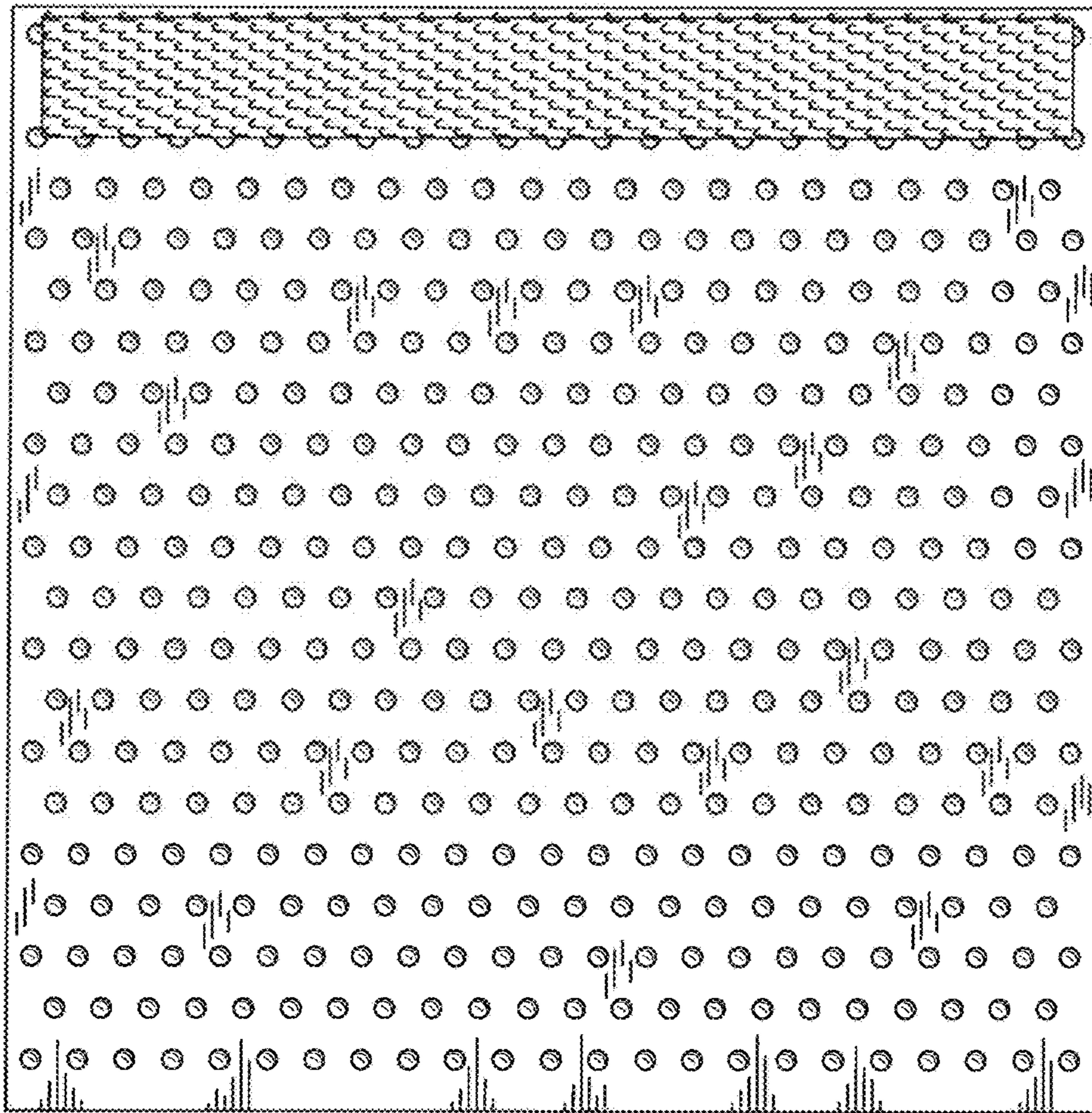

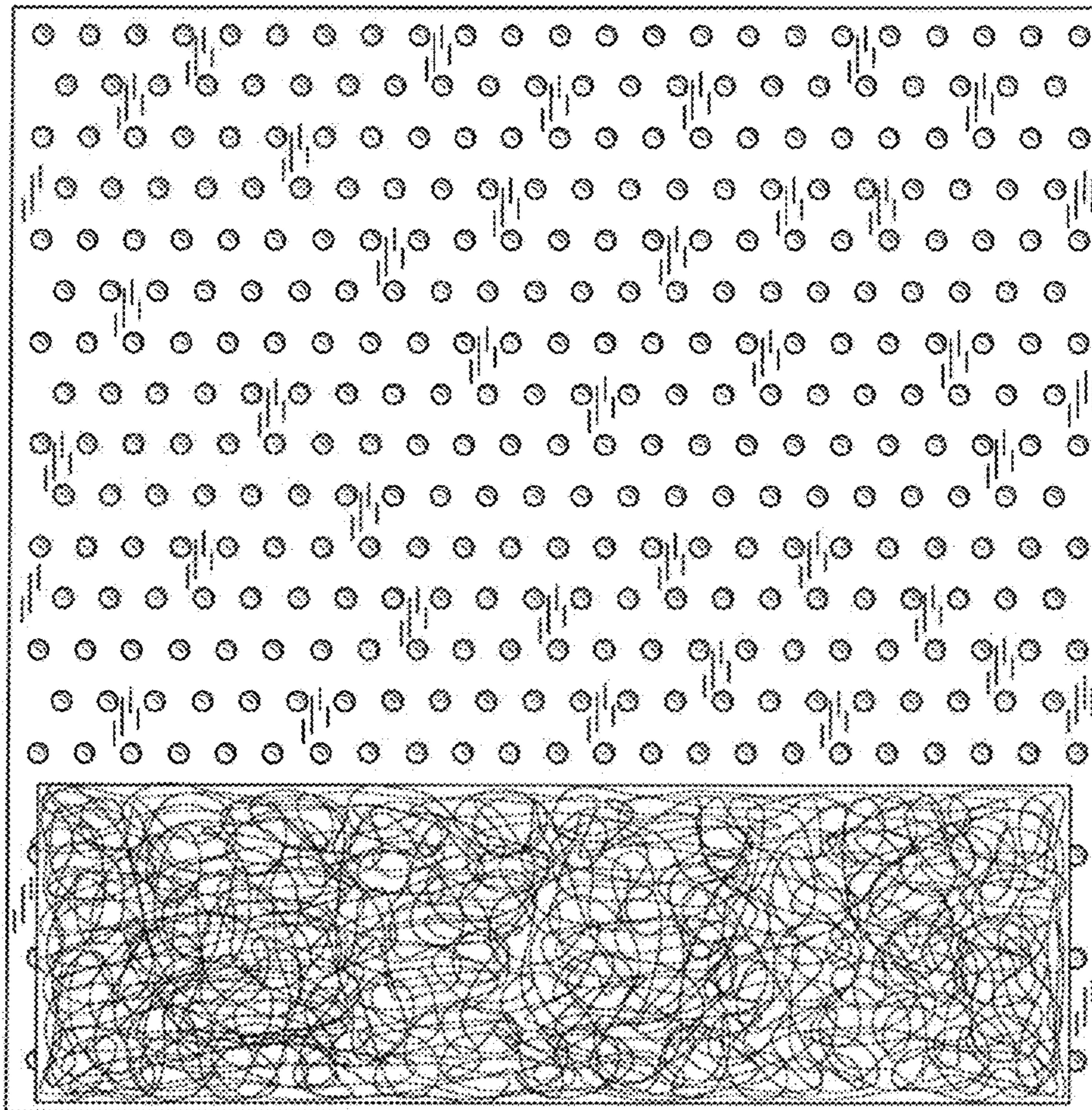

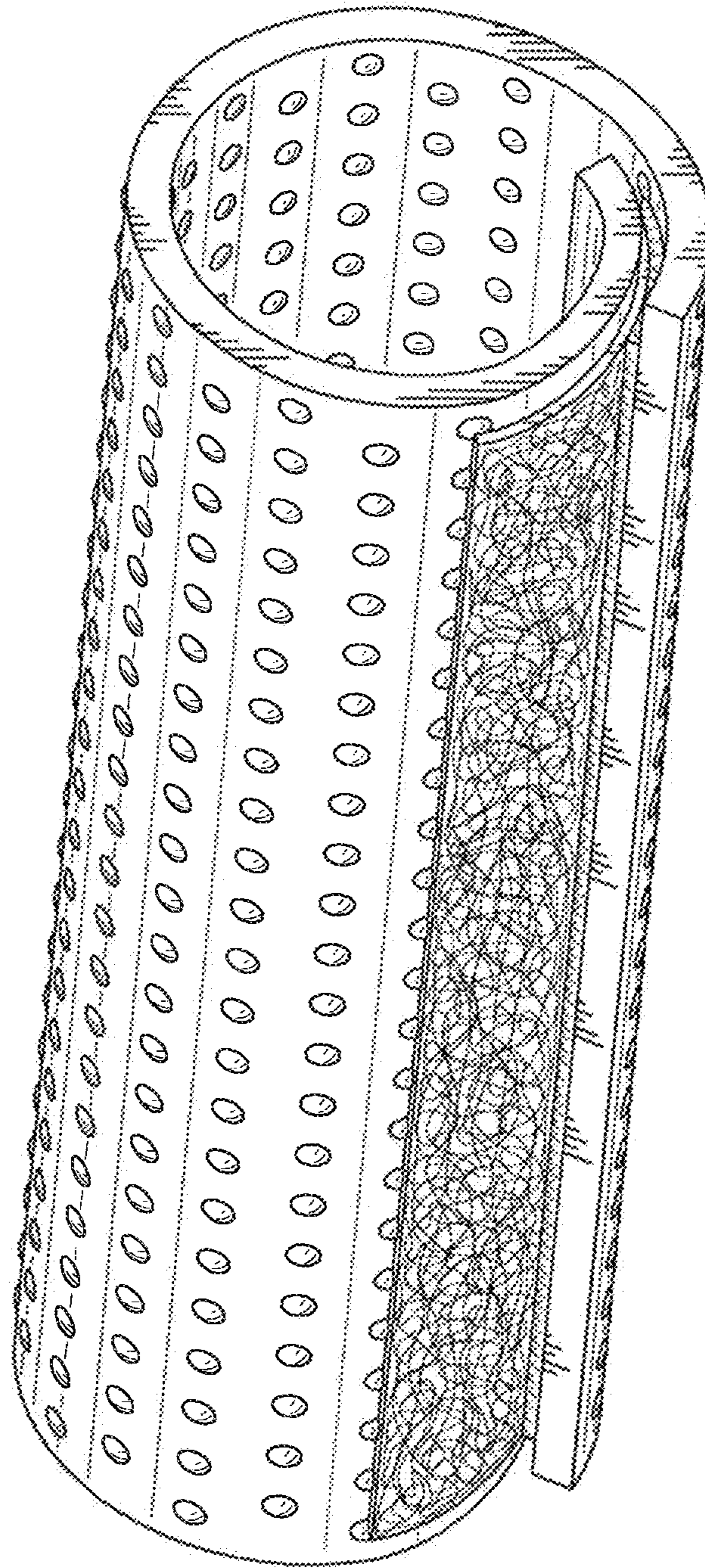

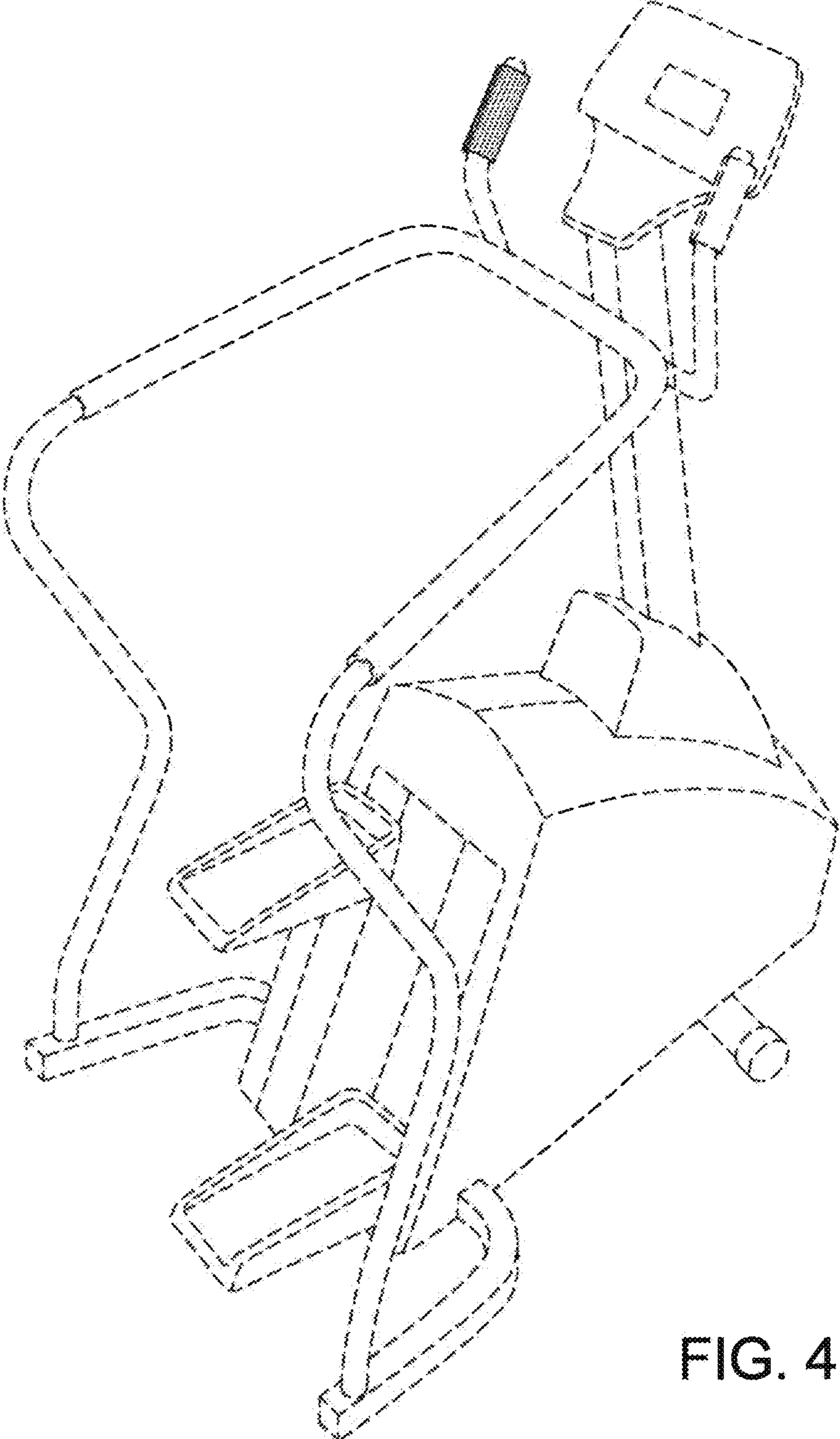
