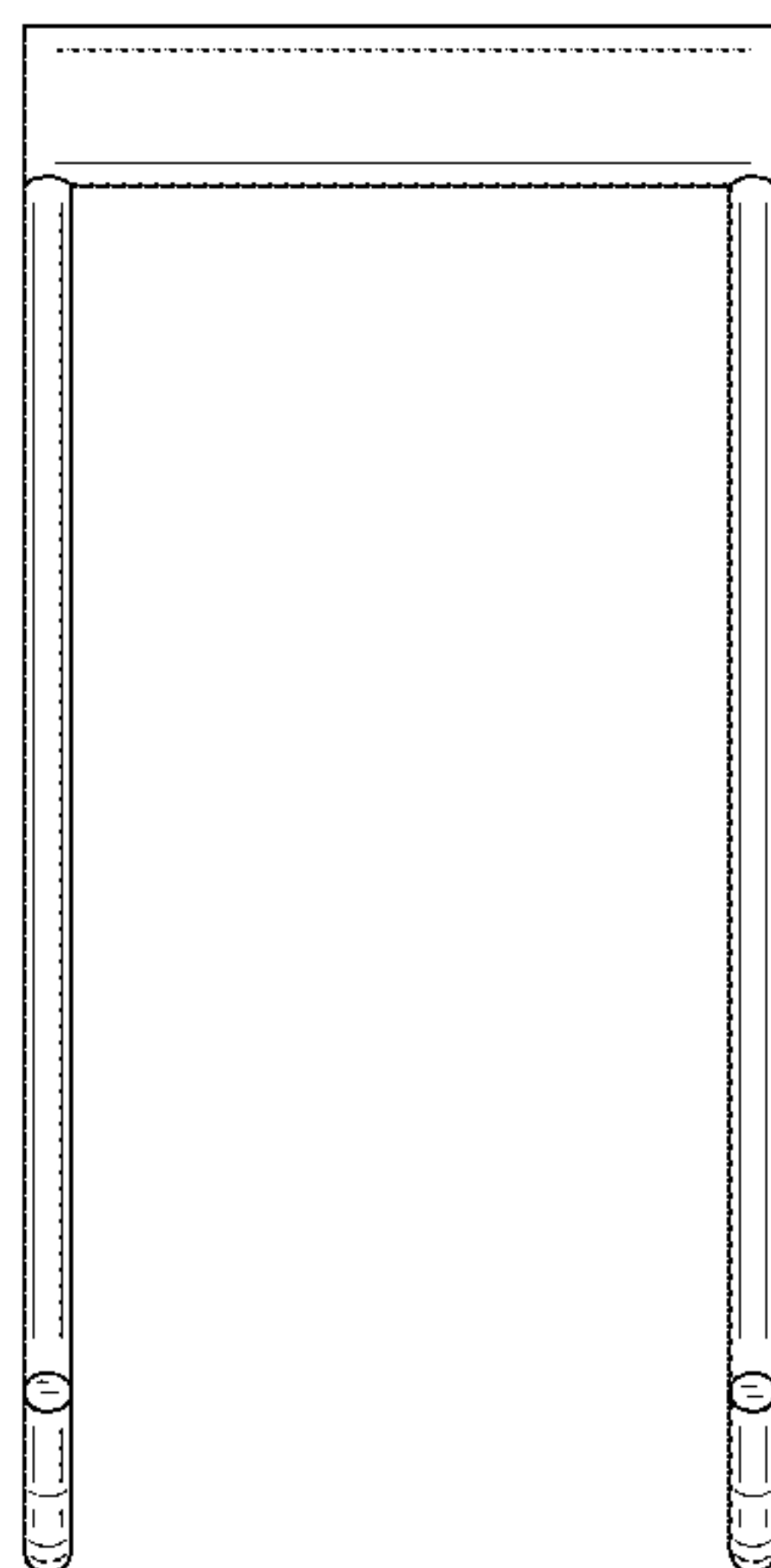
(57) **CLAIM**

The ornamental design for a hand weight extension grip, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a hand weight extension grip showing my new design;
 FIG. 2 is a rear view of the hand weight extension grip;
 FIG. 3 is a left side view of the hand weight extension grip, a right side view being a mirror image thereof;
 FIG. 4 is a top view of the hand weight extension grip;
 FIG. 5 is a bottom view of the hand weight extension grip;
 FIG. 6 is a top front side perspective view of the hand weight extension grip;
 FIG. 7 is a front view of a second embodiment of the hand weight extension grip;
 FIG. 8 is a rear view of the second embodiment of the hand weight extension grip;
 FIG. 9 is a left side view of the second embodiment of the hand weight extension grip, a right side view being a mirror image thereof;
 FIG. 10 is a top view of the second embodiment of the hand weight extension grip;
 FIG. 11 is a bottom view of the second embodiment of the hand weight extension grip; and,
 FIG. 12 is a top front side perspective view of the second embodiment of the hand weight extension grip.

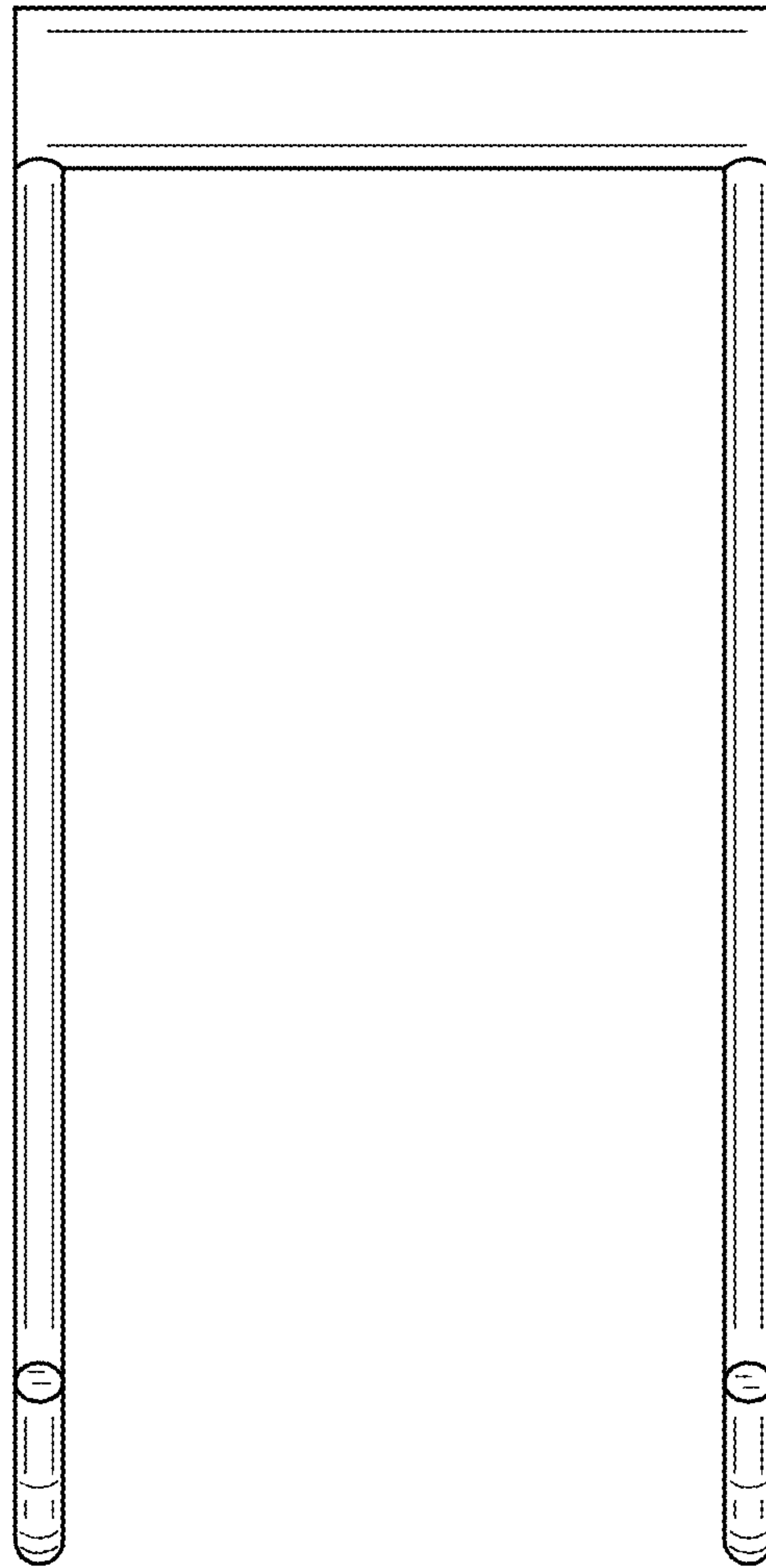

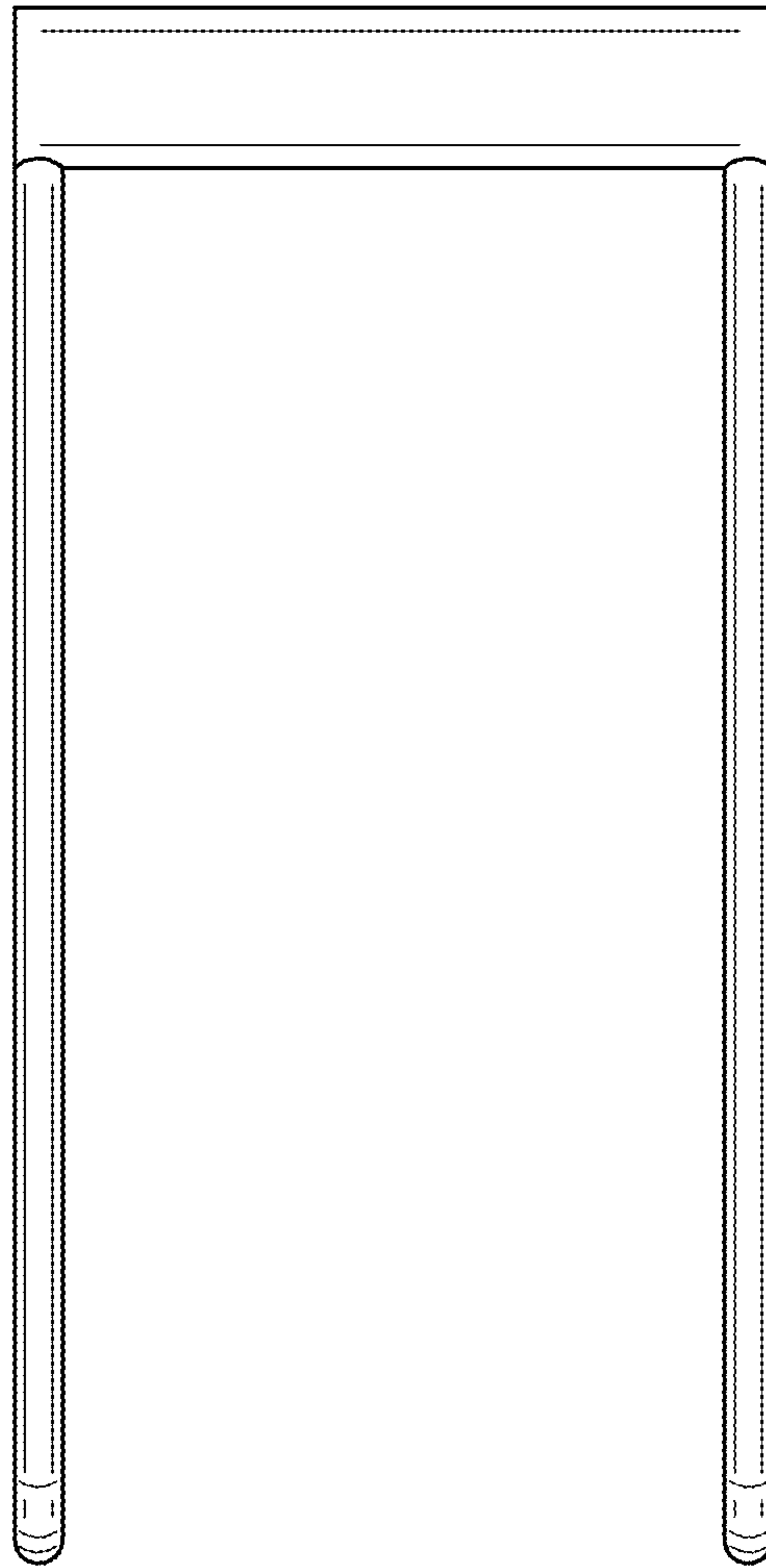

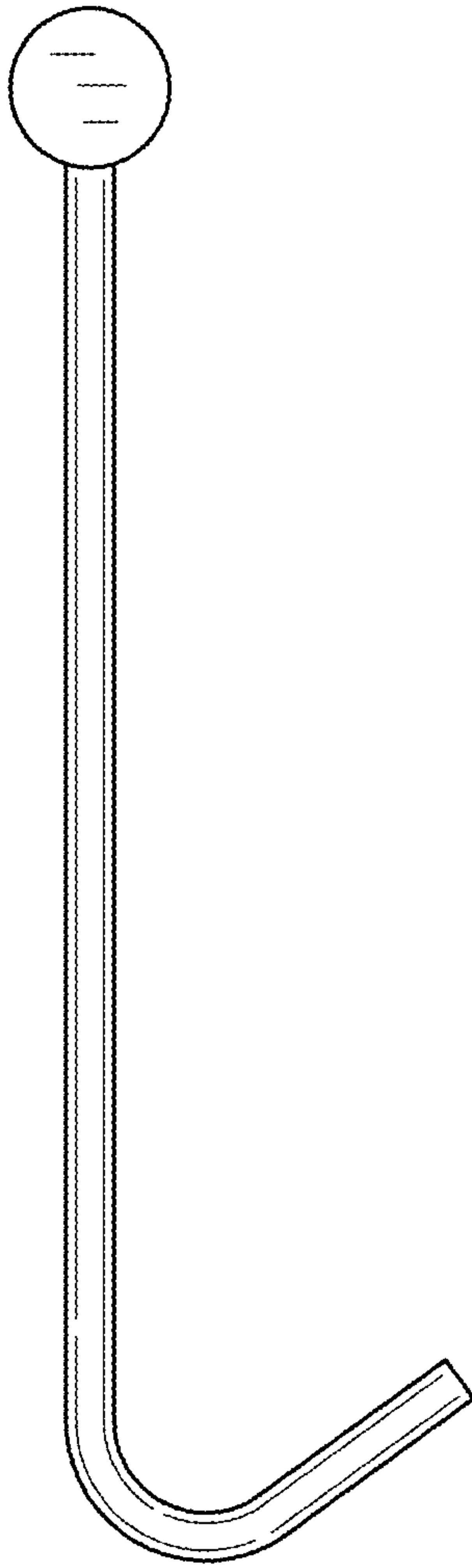

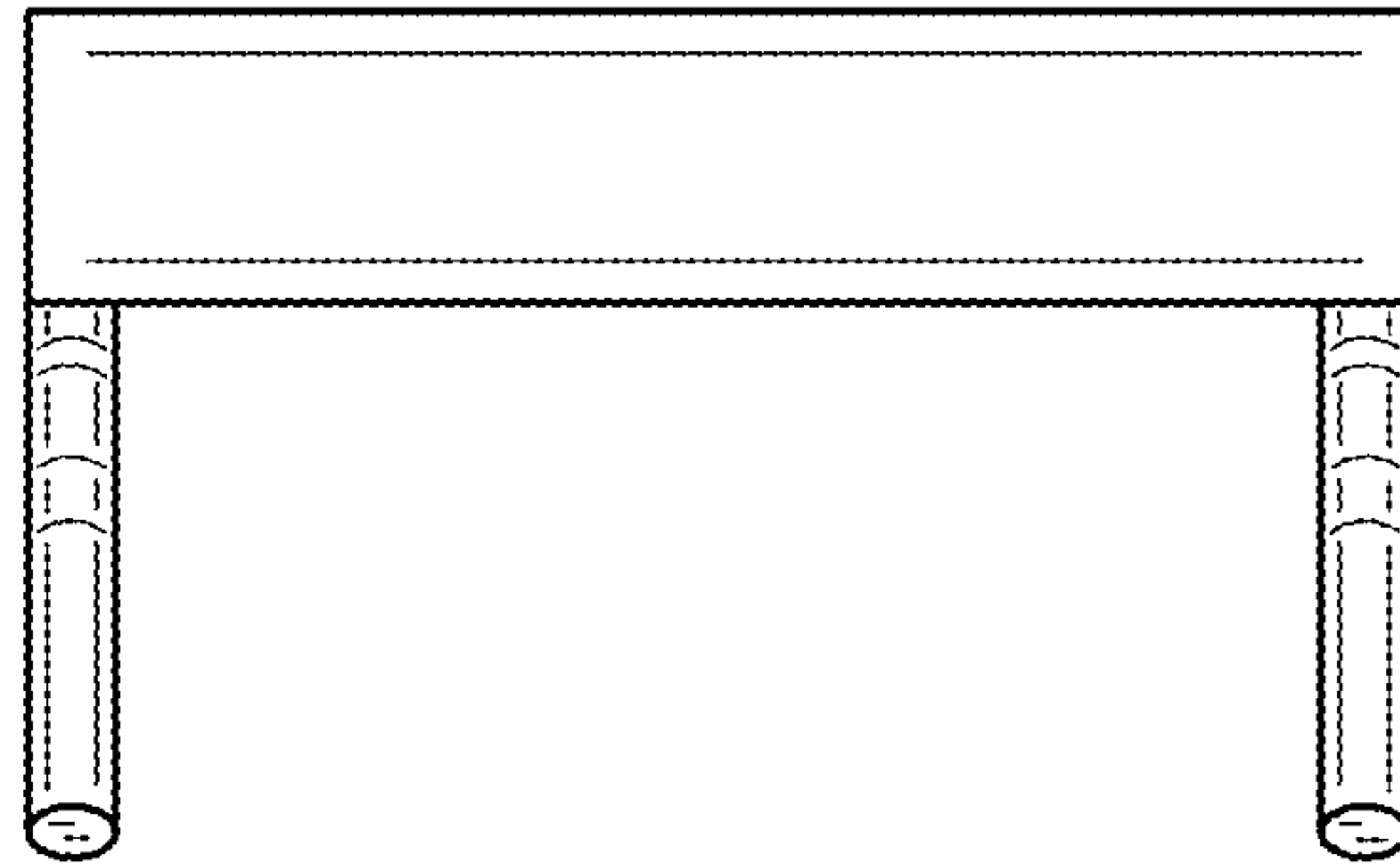

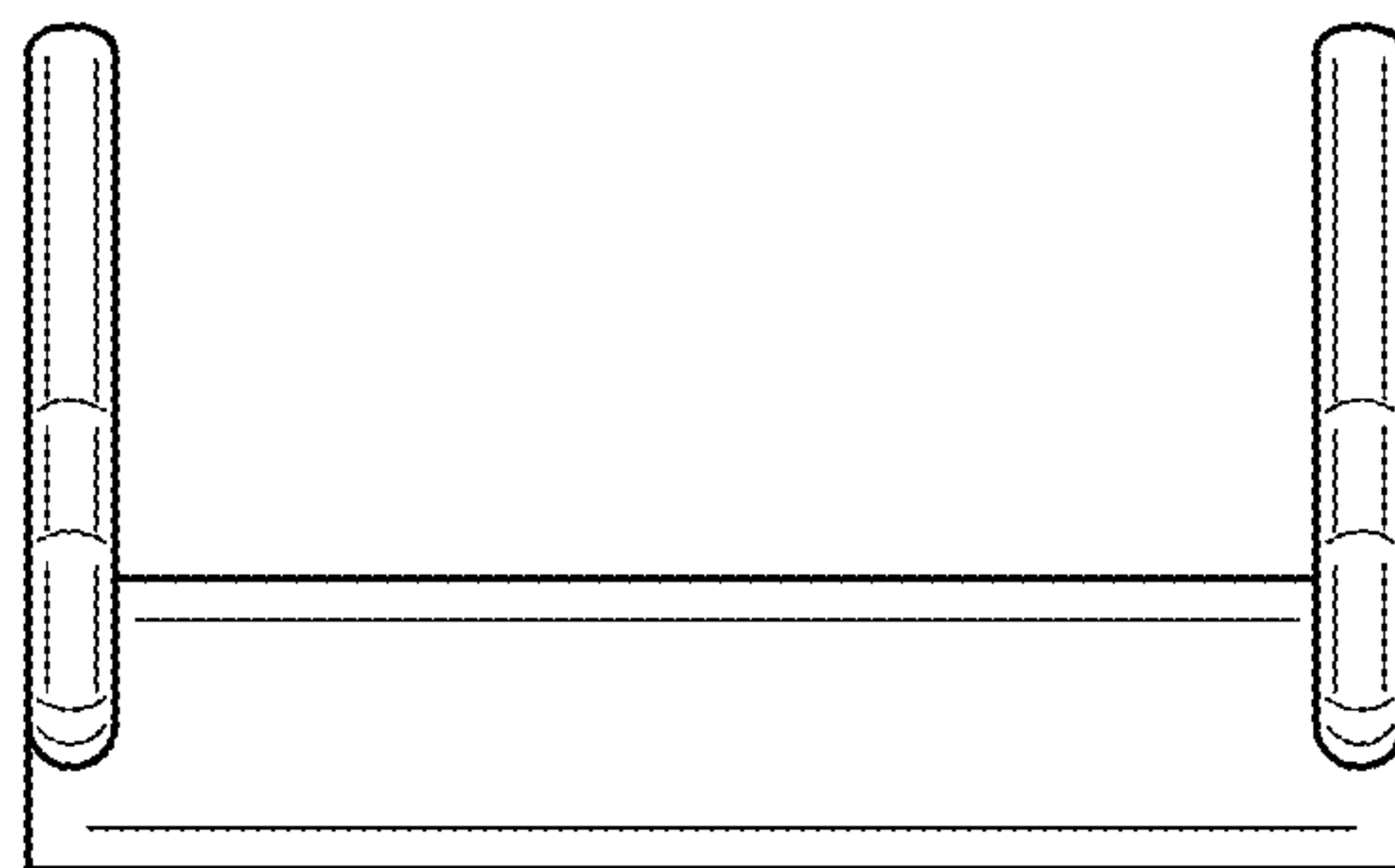

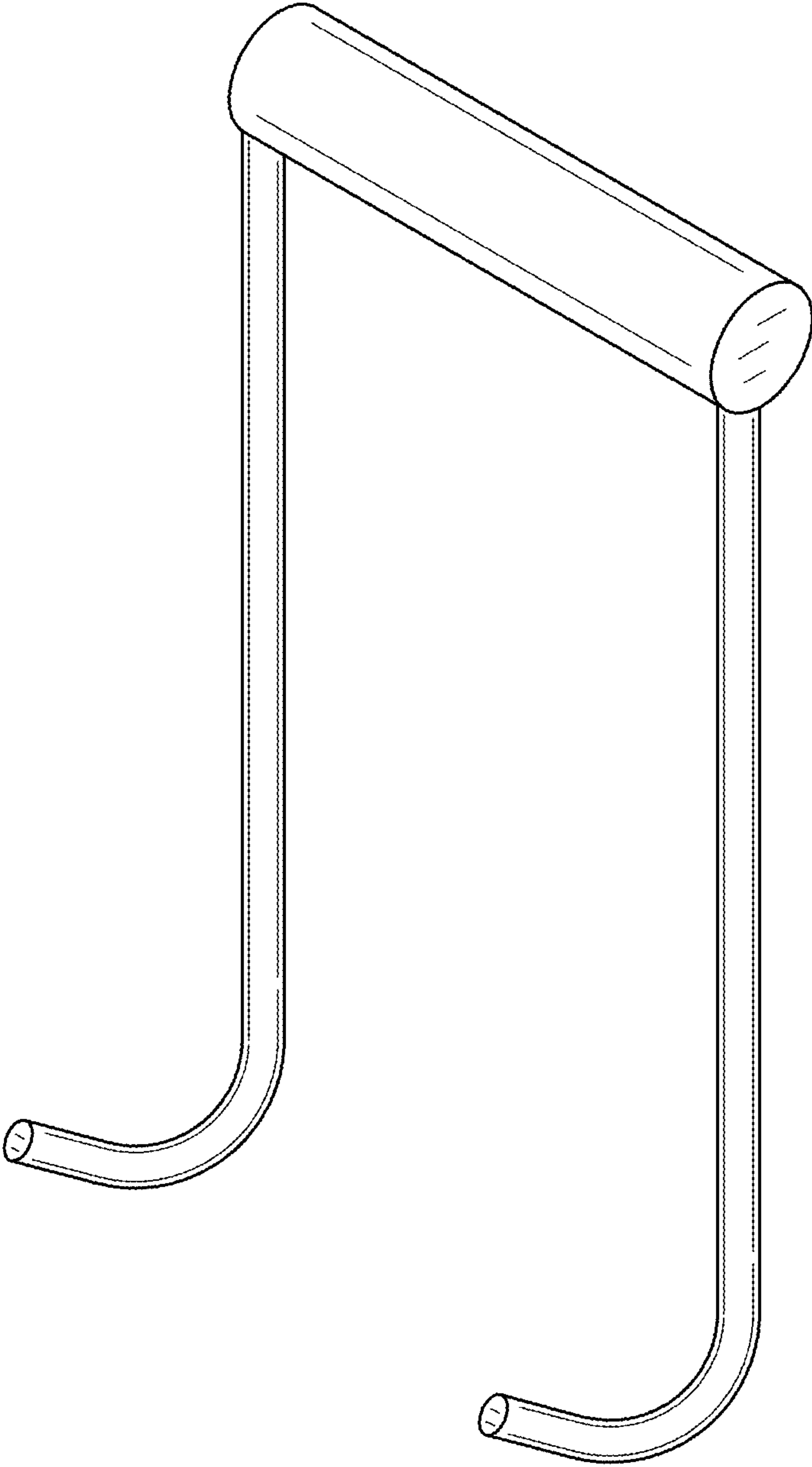

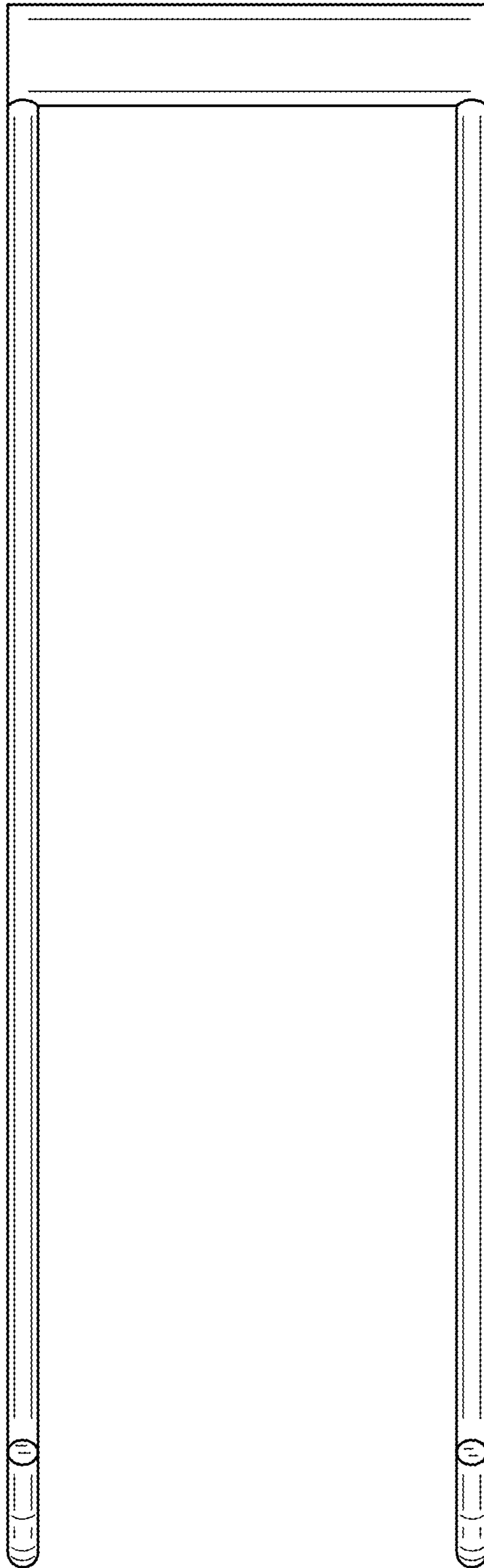

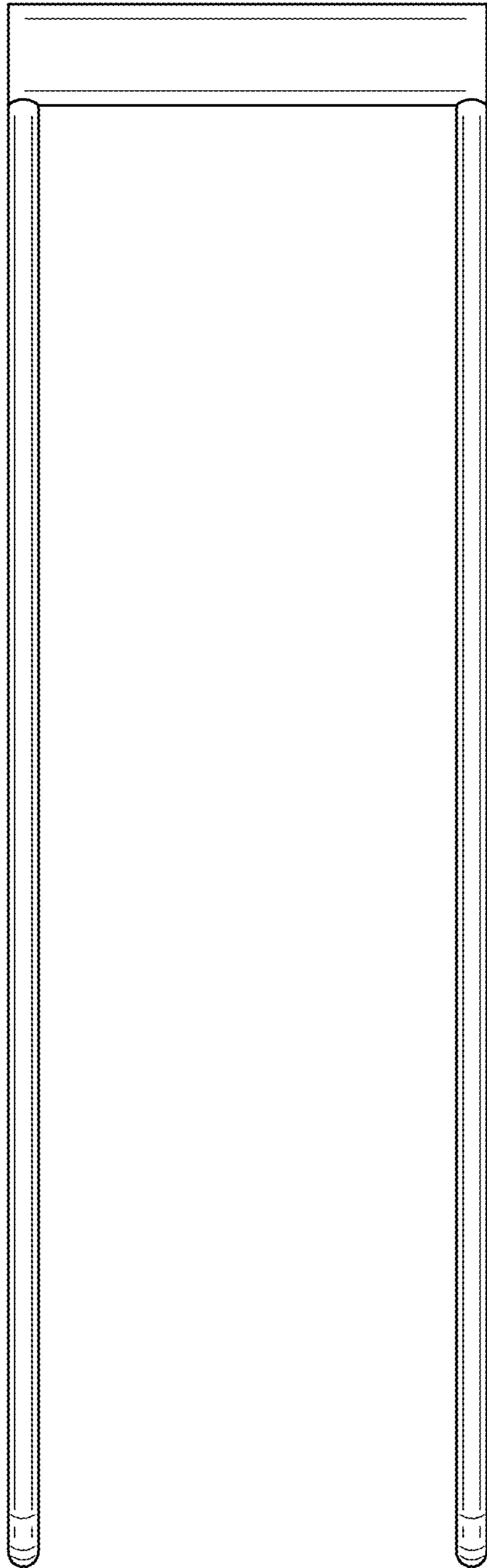

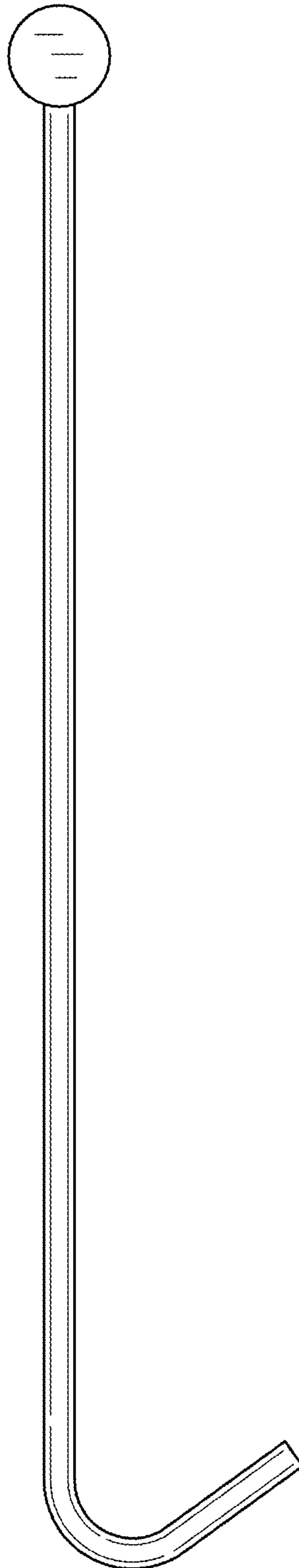

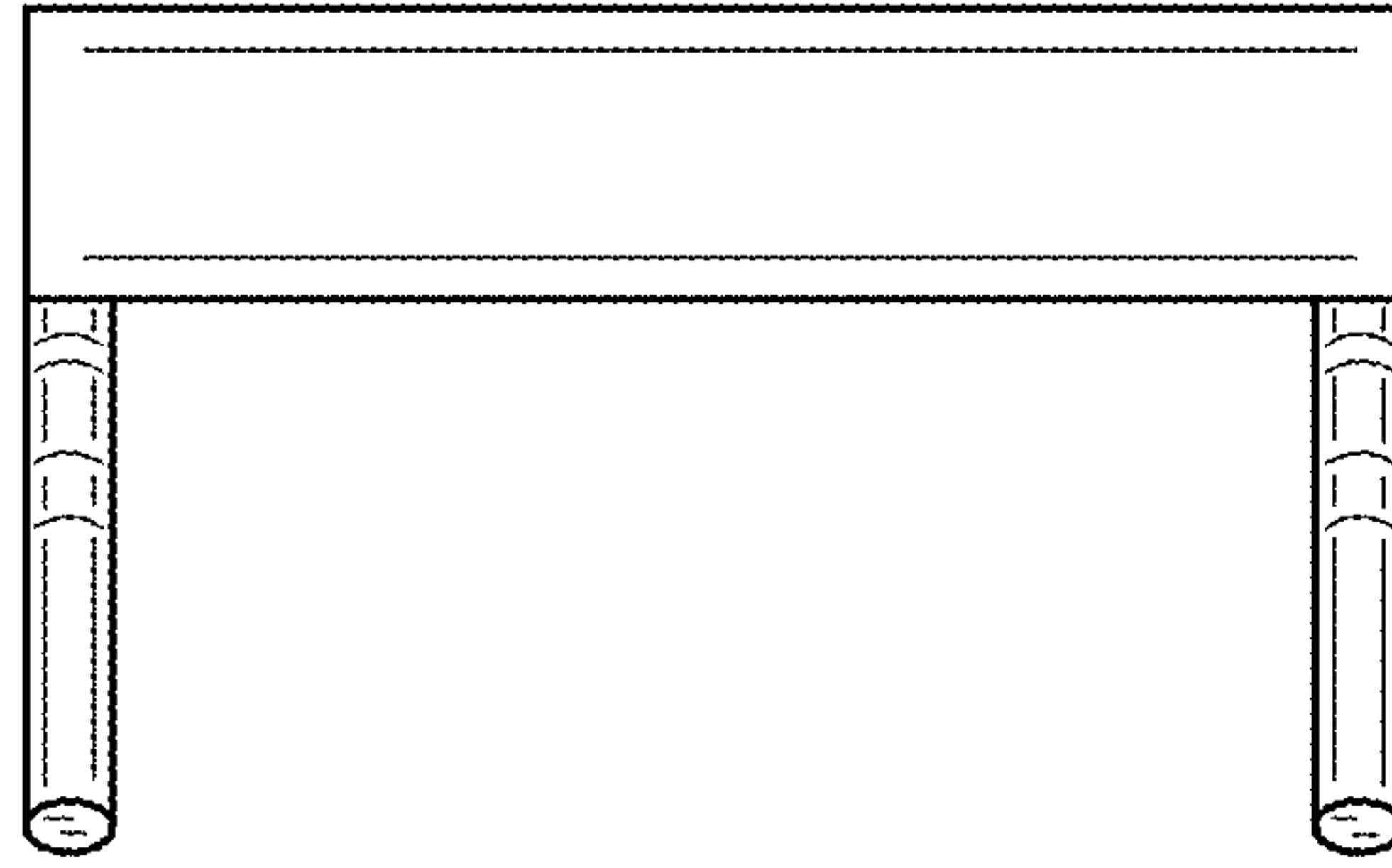

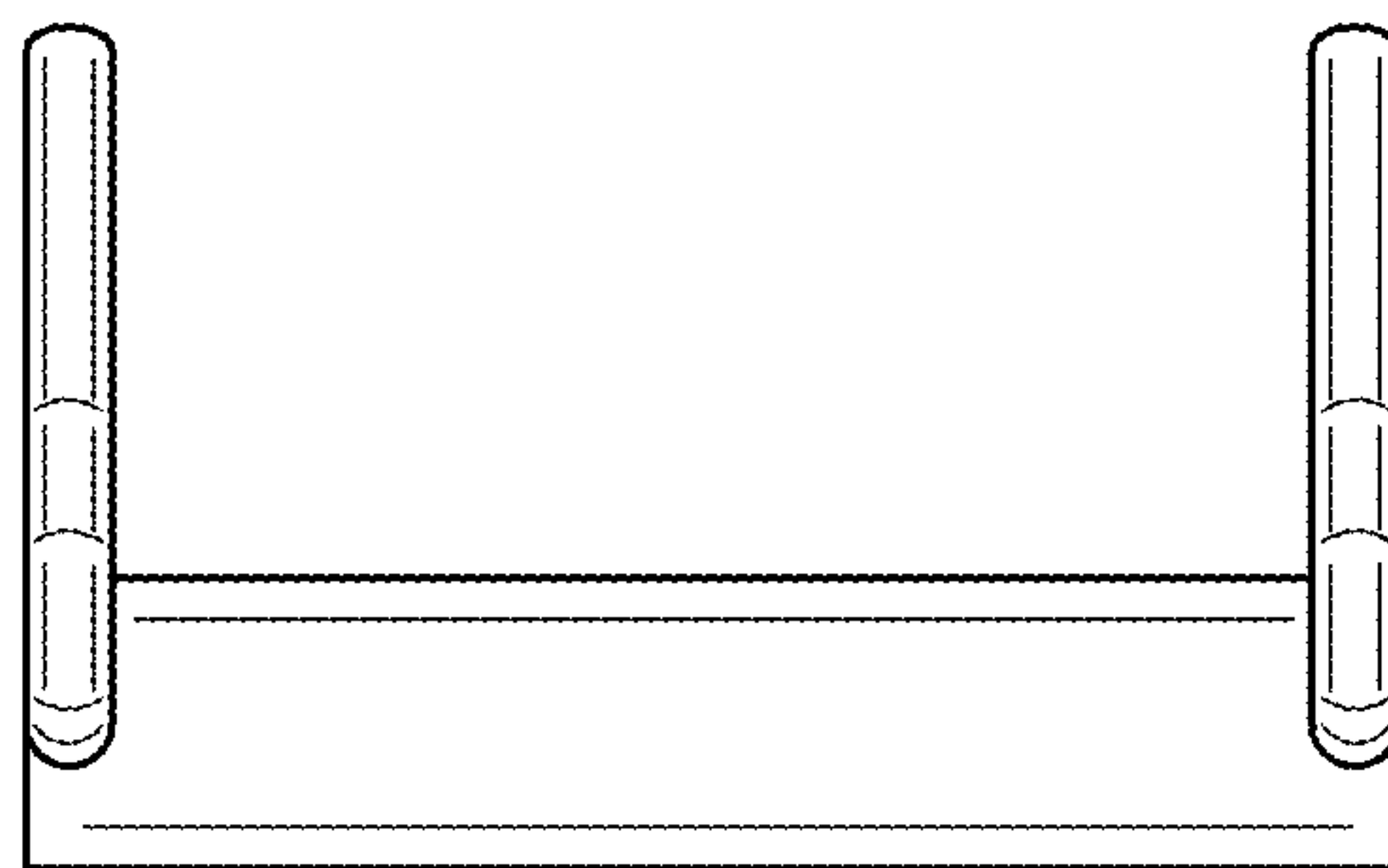

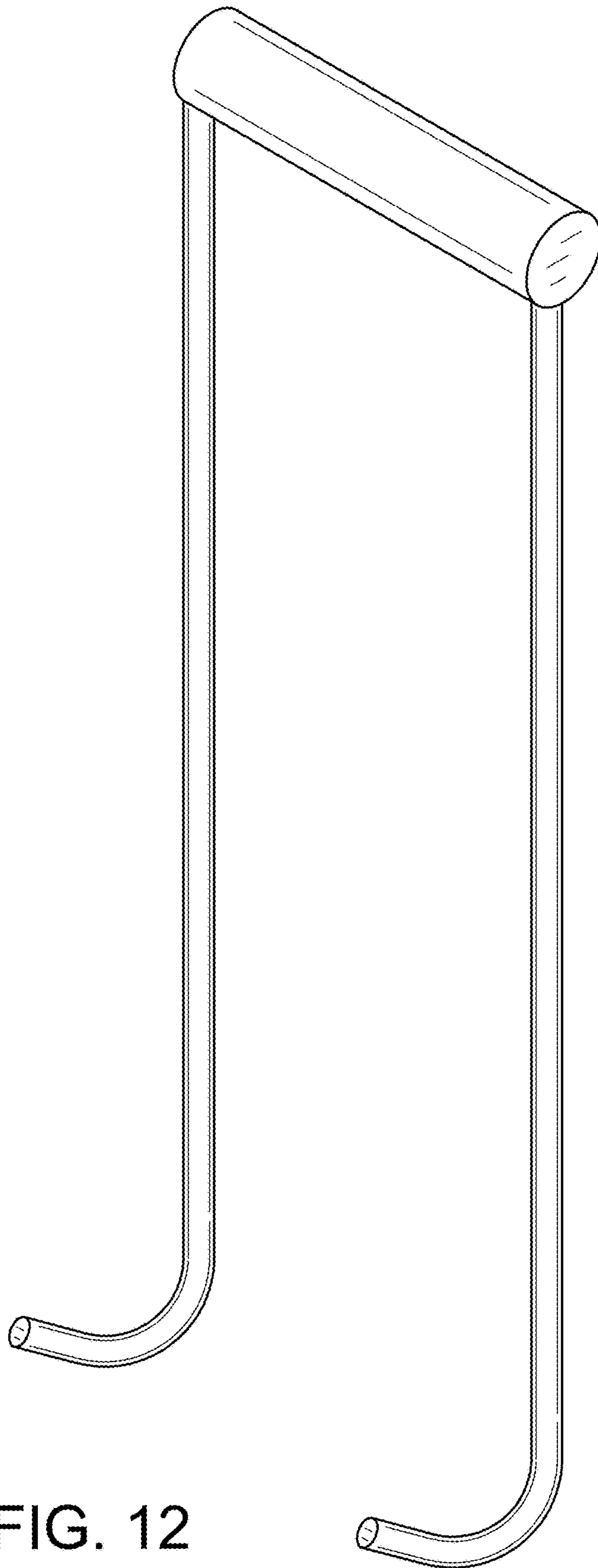
