(57) **CLAIM**

We claim the ornamental design for a riflescope turret, as shown and described.

DESCRIPTION

Applicant incorporates by reference, in its entirety, PCT patent publication WO2014/145288 A1 published Sep. 18, 2014, which is commonly owned by the owner of the present application.

FIG. 1 is a perspective view of the riflescope turret, according to an embodiment of the invention;

FIG. 2 is a right-side elevational view of the riflescope turret of FIG. 1;

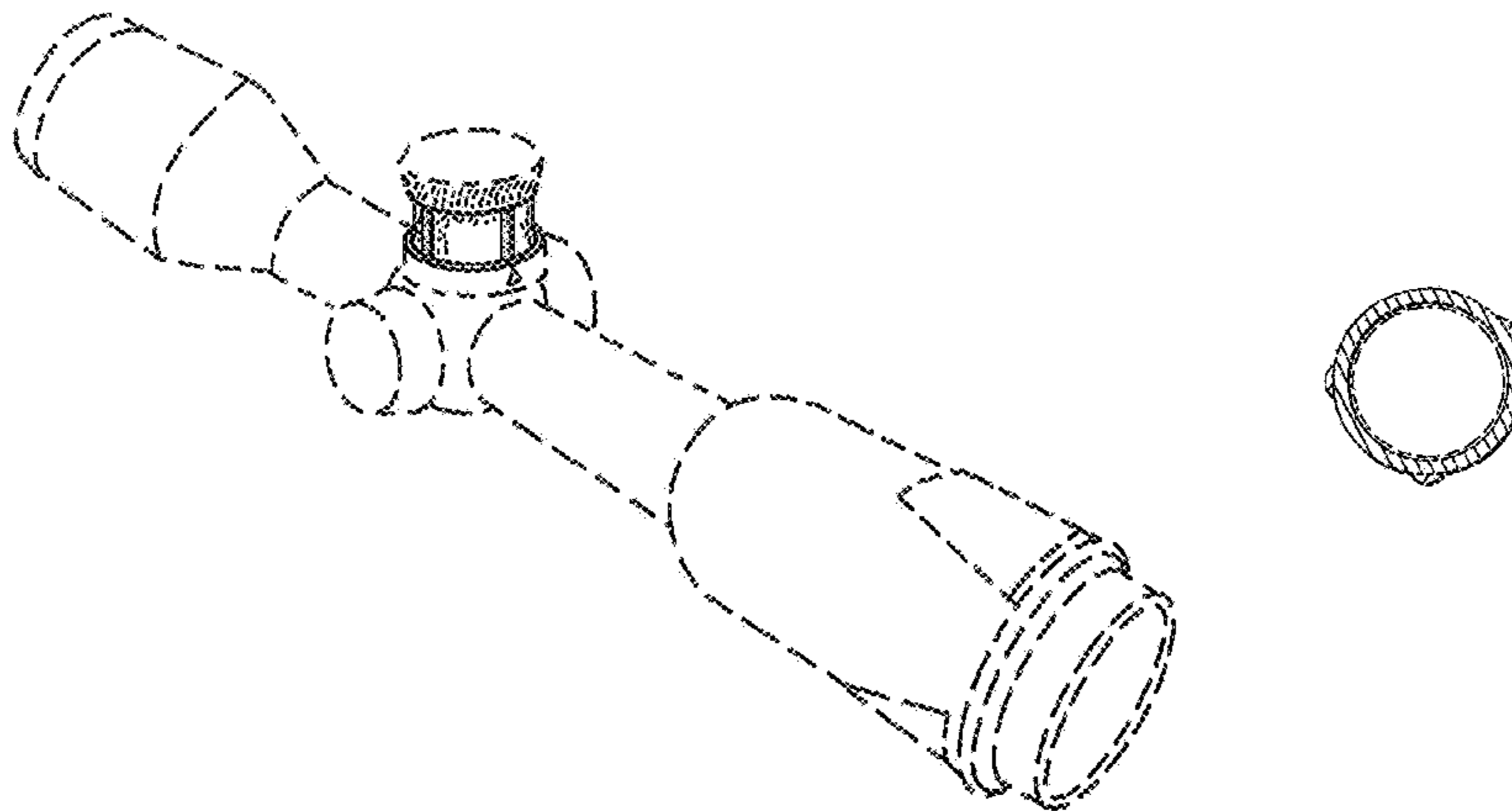
FIG. 3 is a cross-sectional view of the riflescope turret taken at line 3-3 of FIG. 2;

FIG. 4 is a cross-sectional view of the riflescope turret taken at line 4-4 of FIG. 2;

FIG. 5 is a cross-sectional view of the riflescope turret taken at line 5-5 of FIG. 3, depicting an embodiment having three turret pins; and,

FIG. 6 is a cross-sectional view of the riflescope turret taken at line 5-5 of FIG. 3, in an alternate embodiment having two turret pins.

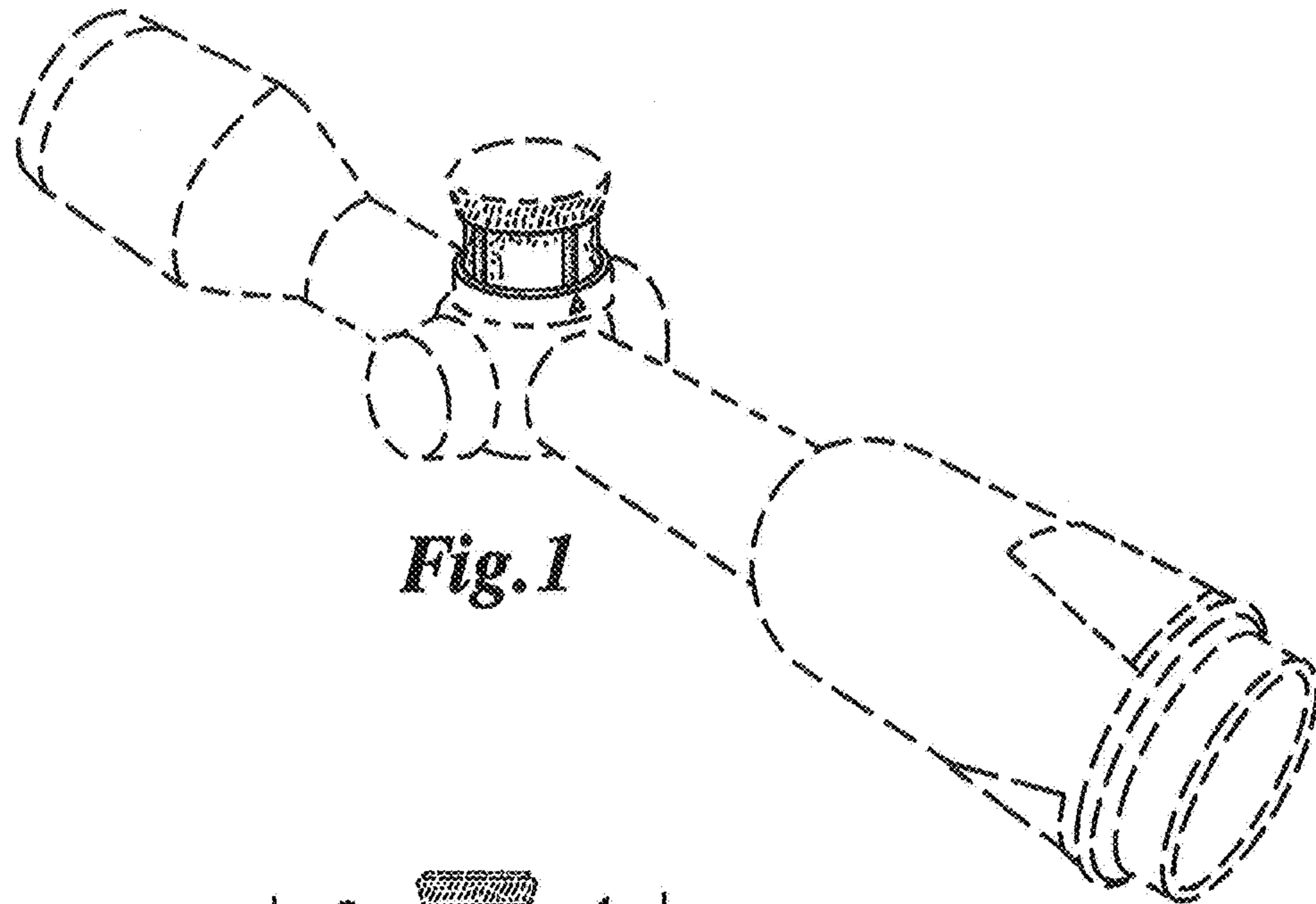

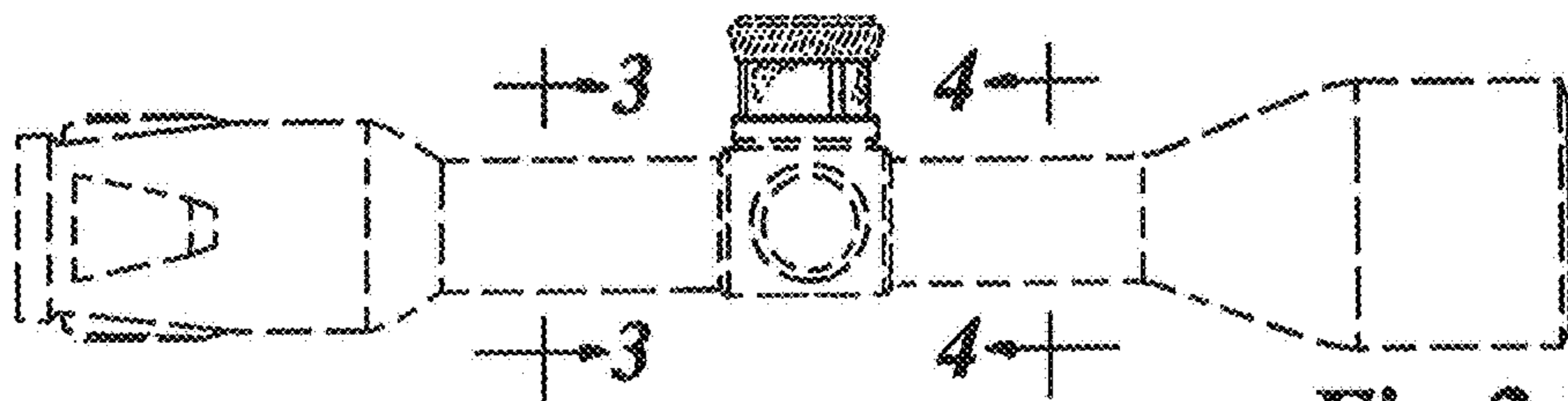

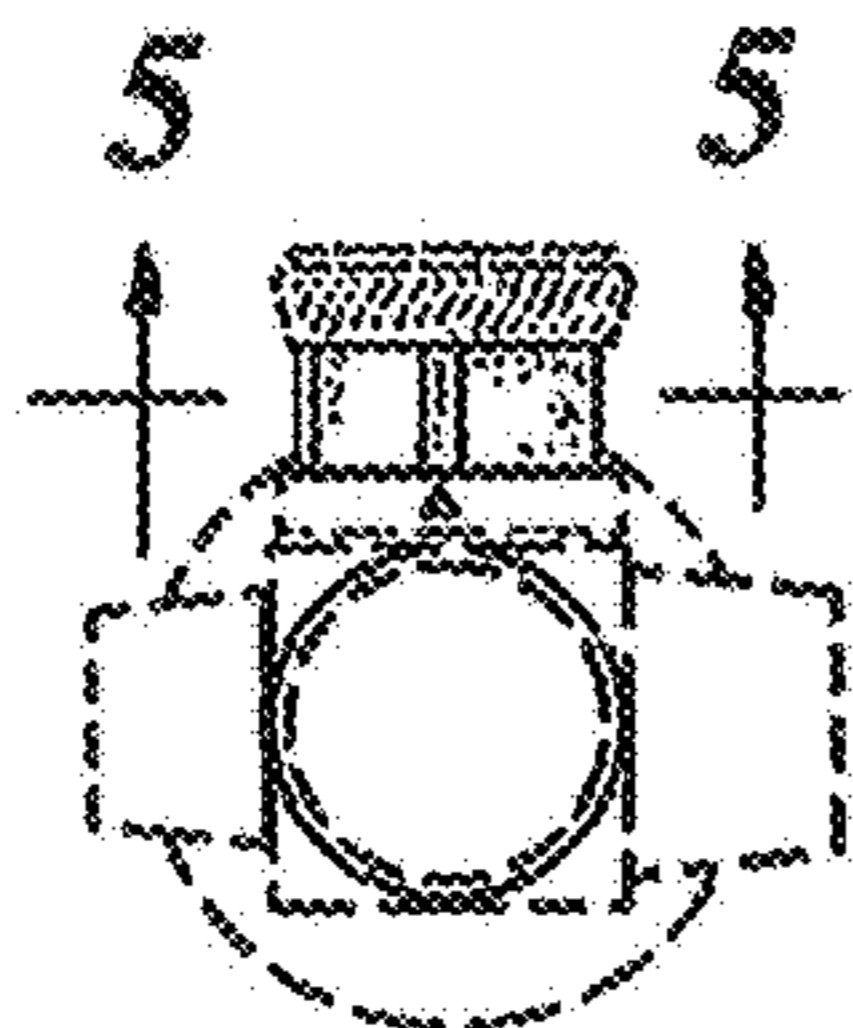

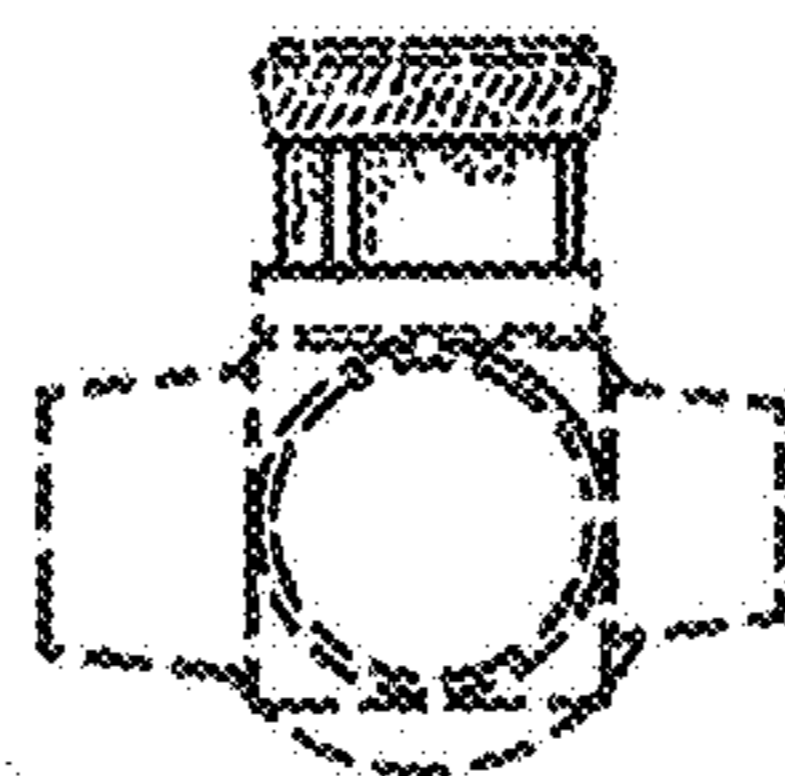

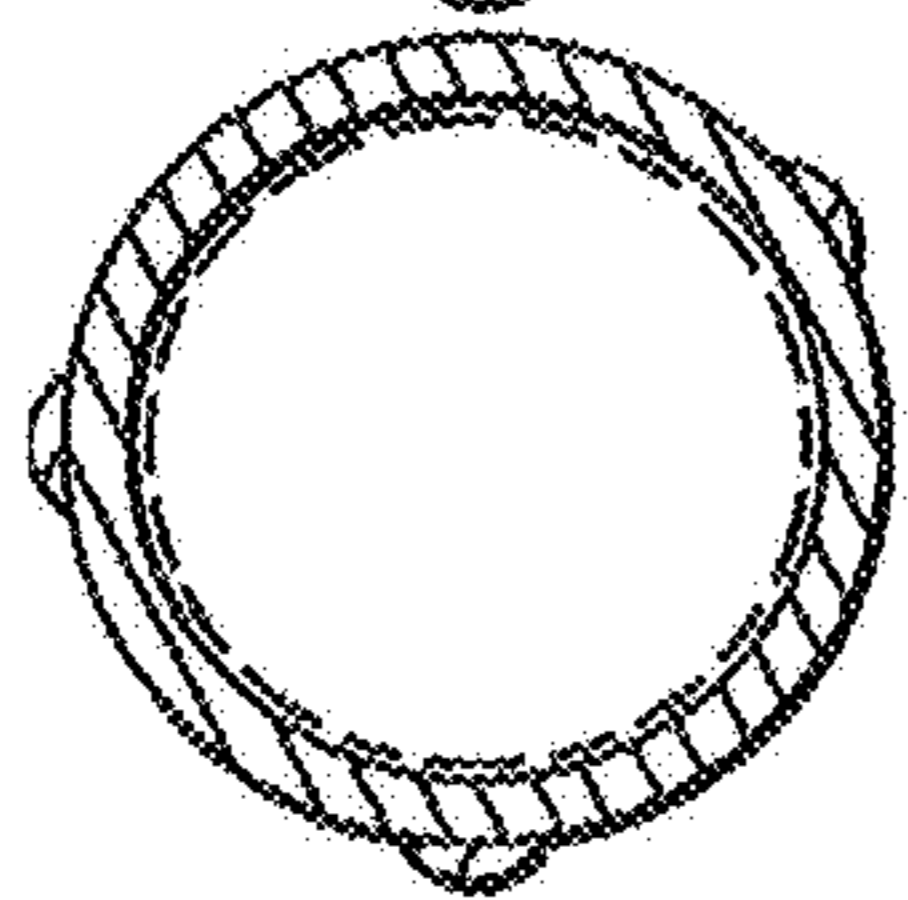

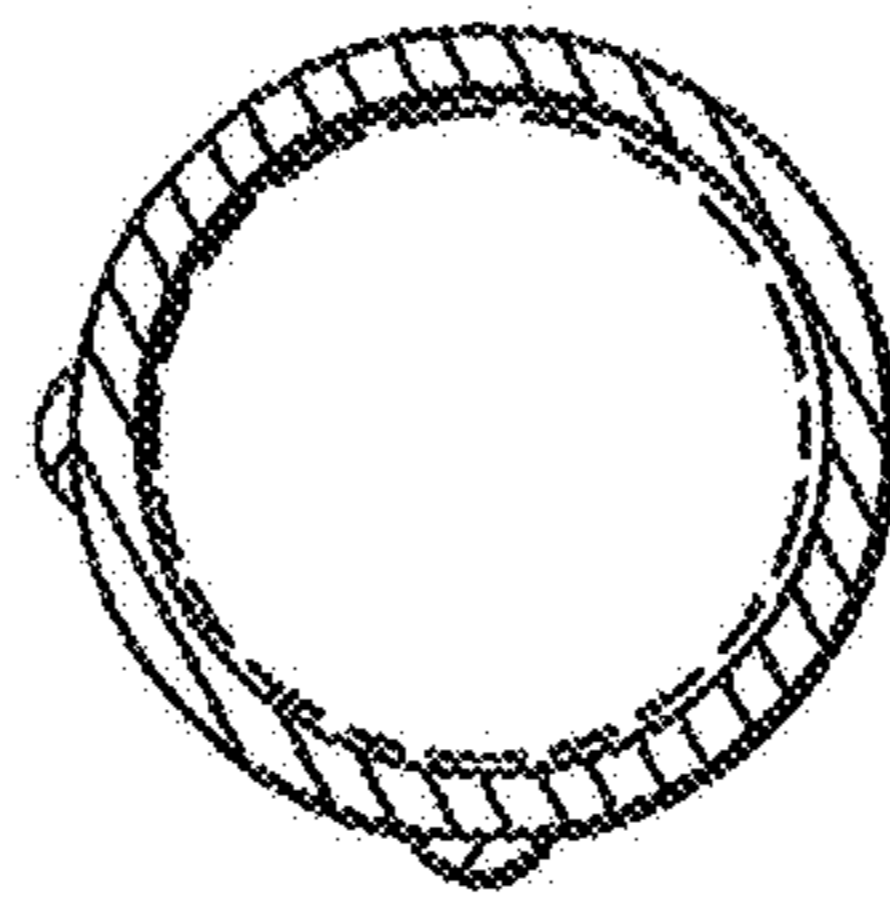
