(57) **CLAIM**

The ornamental design for a firearm grip sleeve, as shown
and described.

DESCRIPTION

position of use on a firearm according to the present design.

shown in FIG. 15.

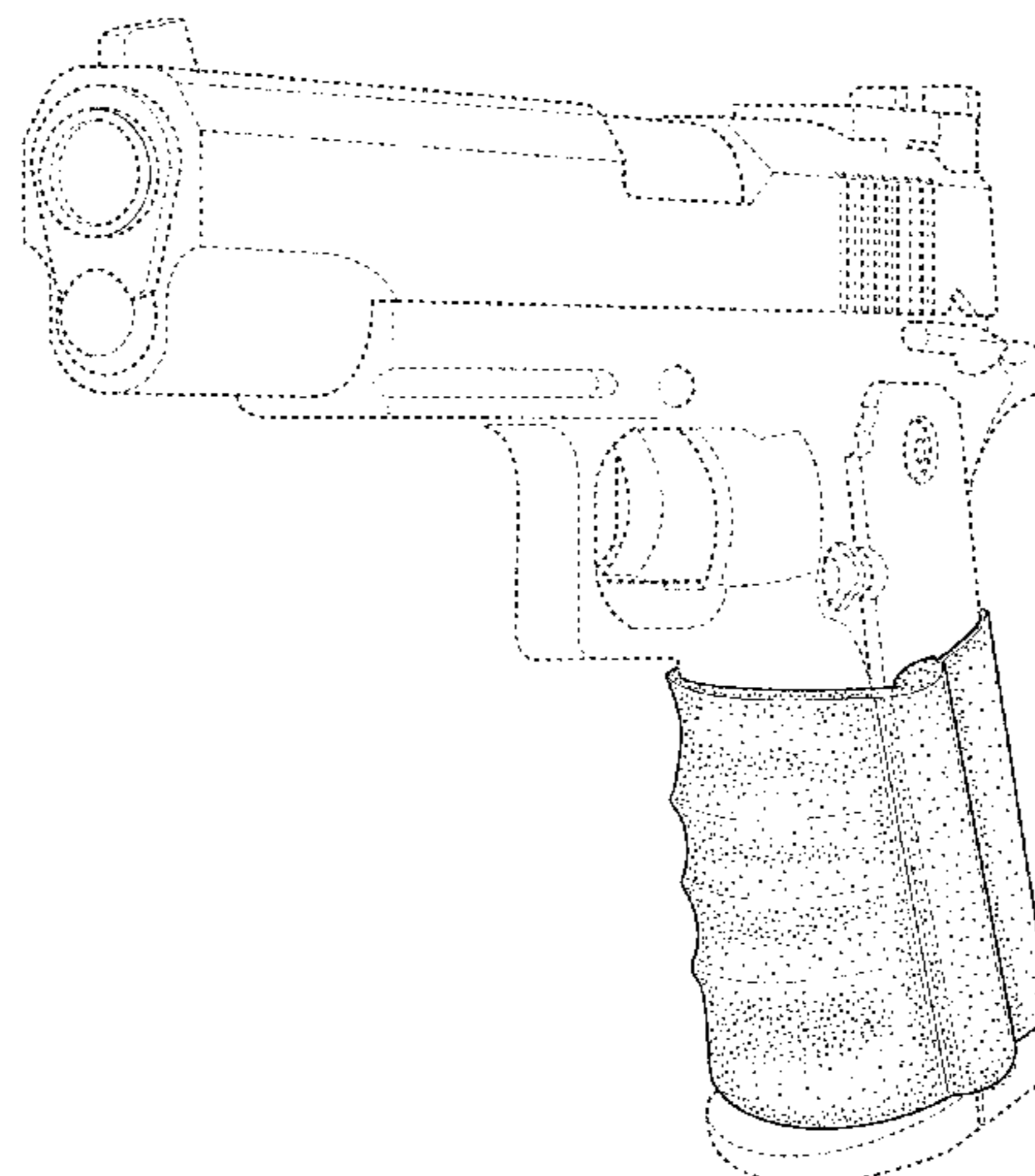
FIG. 18 is a right elevation view of the firearm grip sleeve

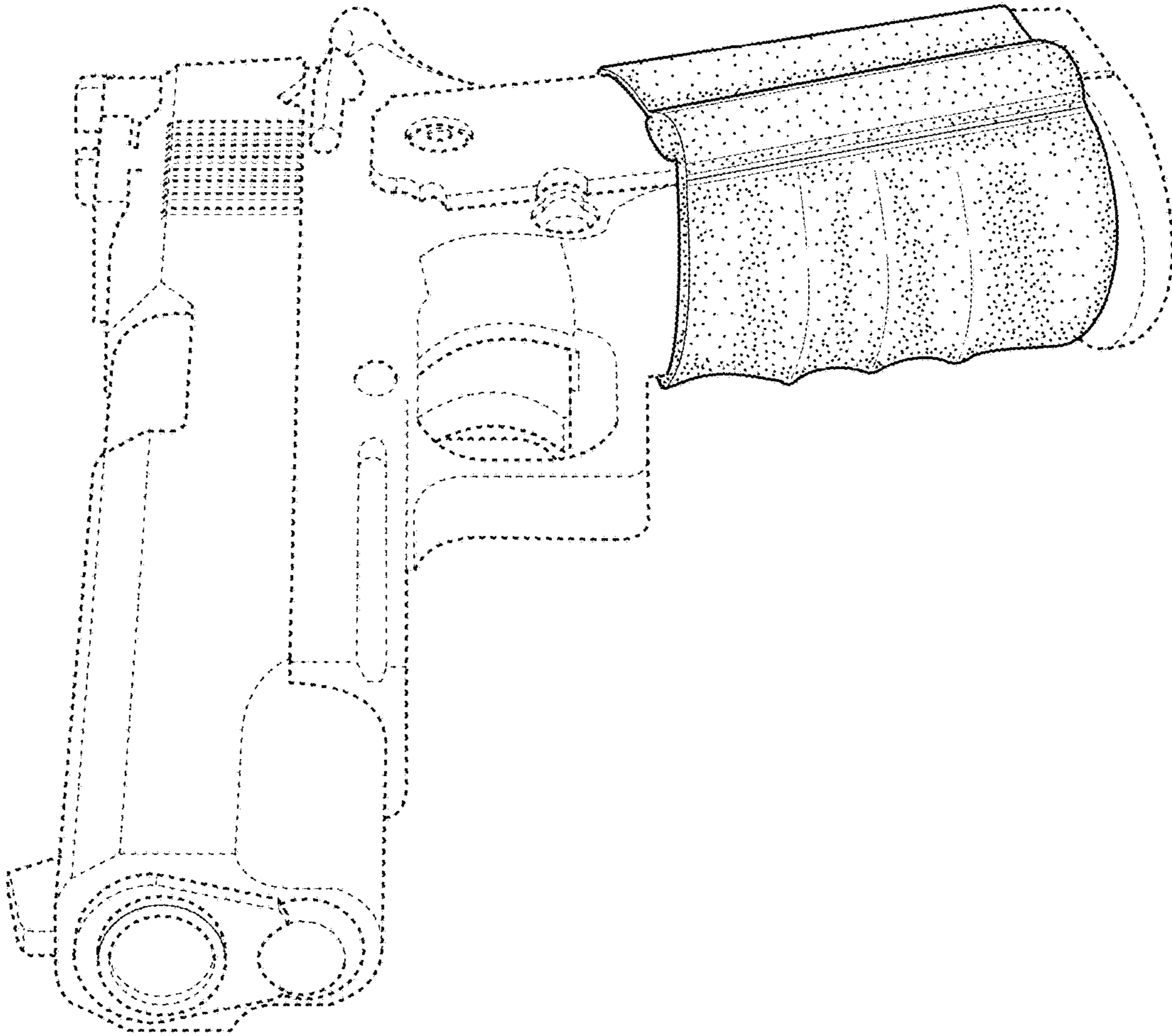

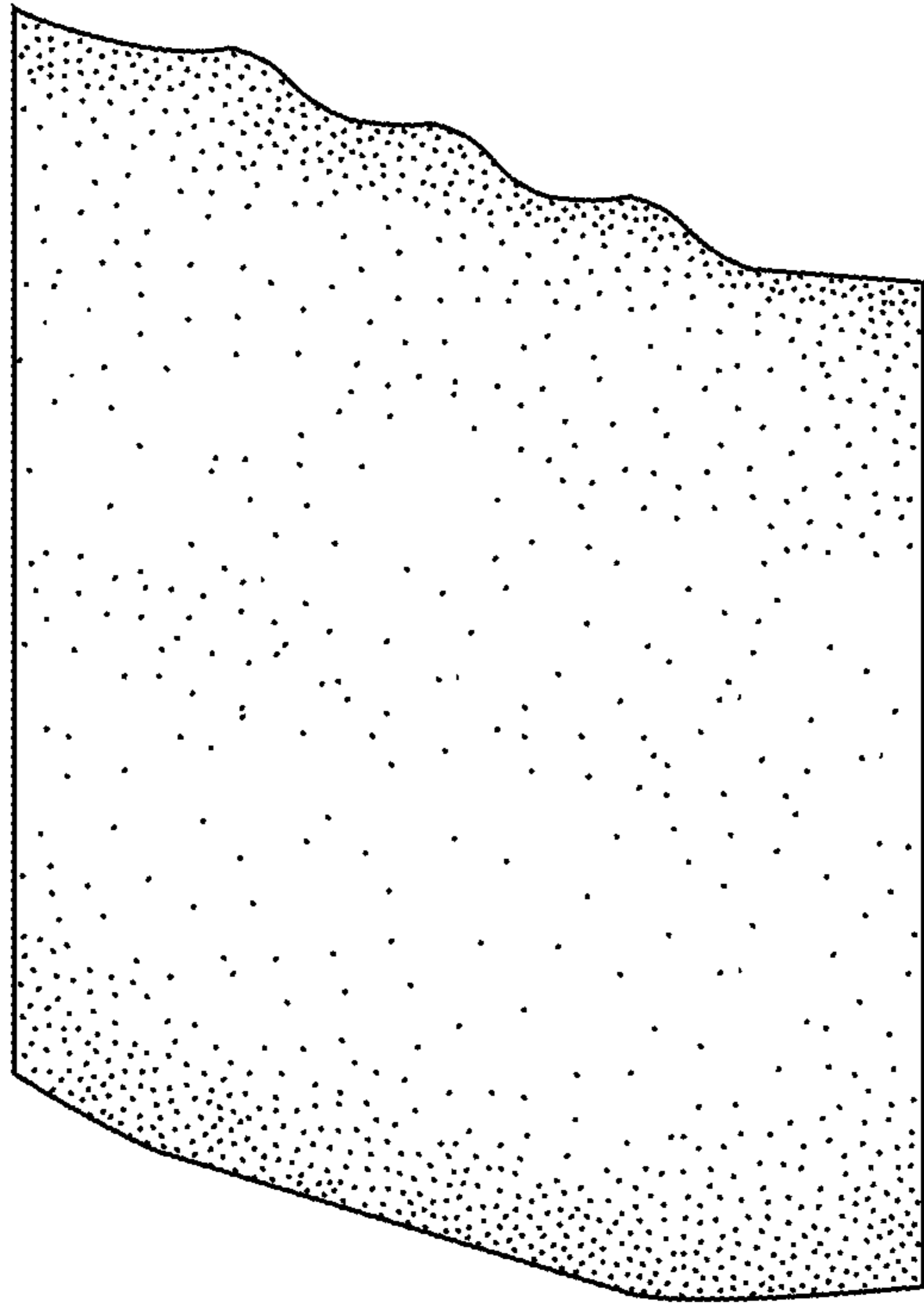

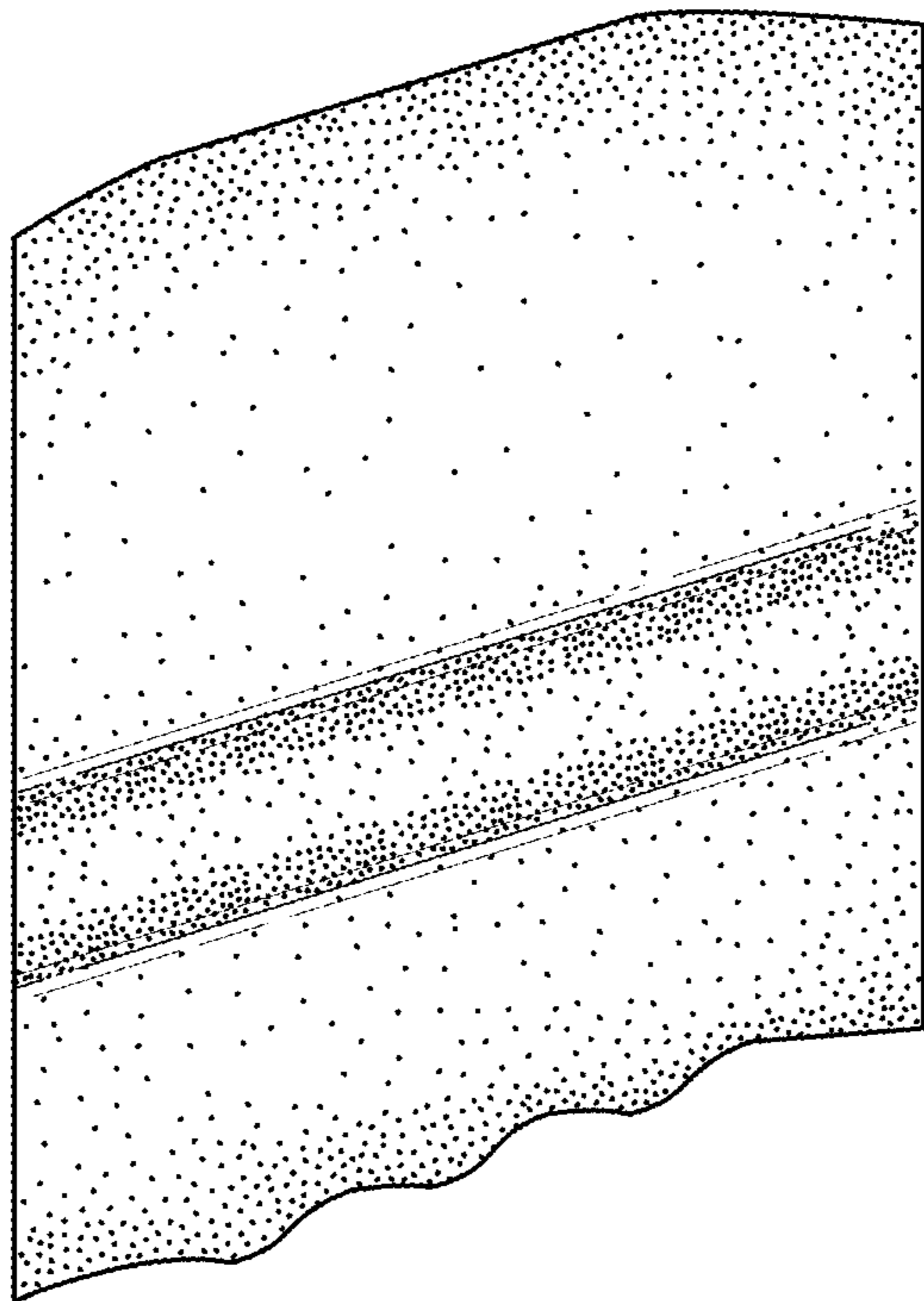

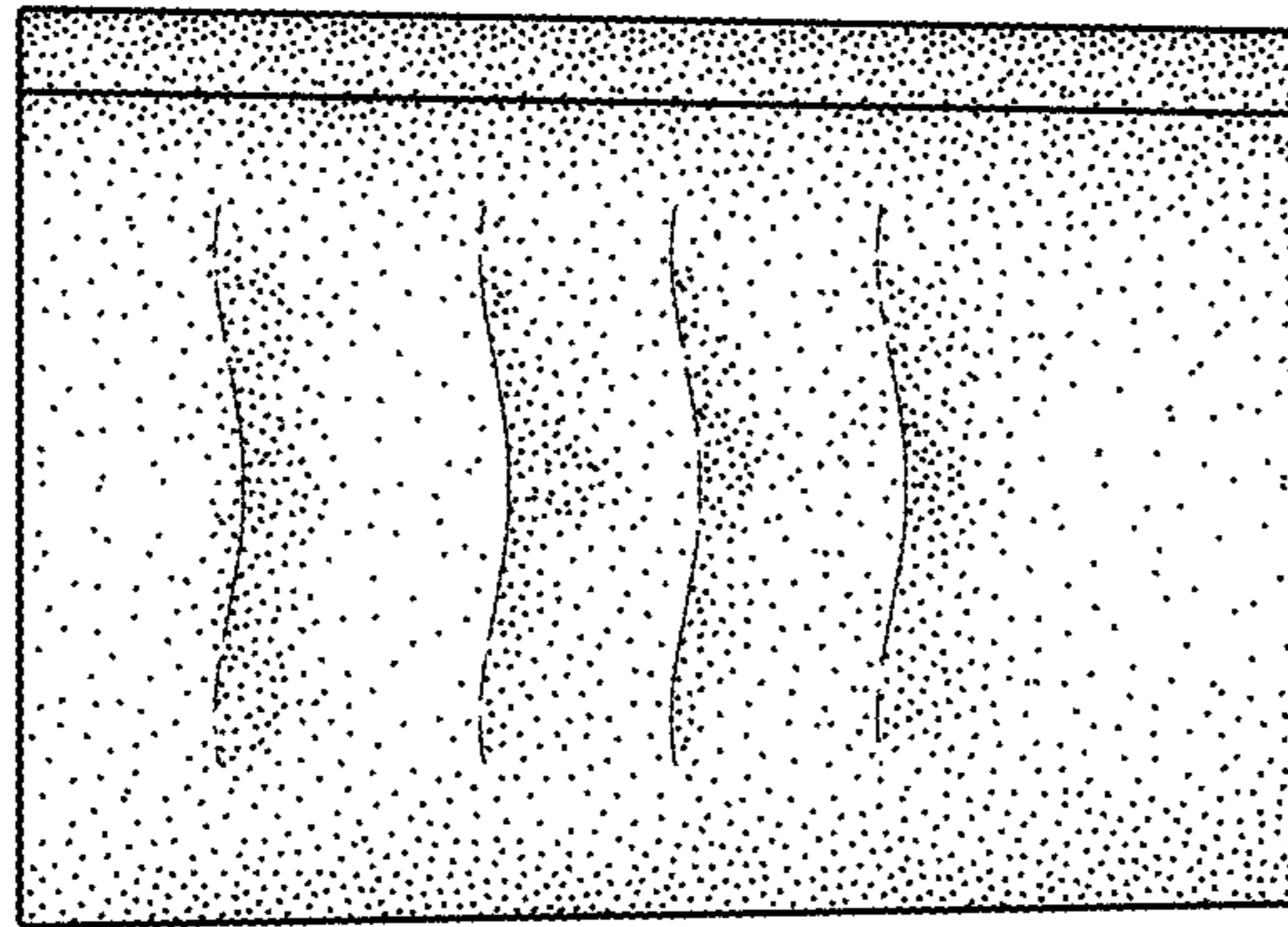

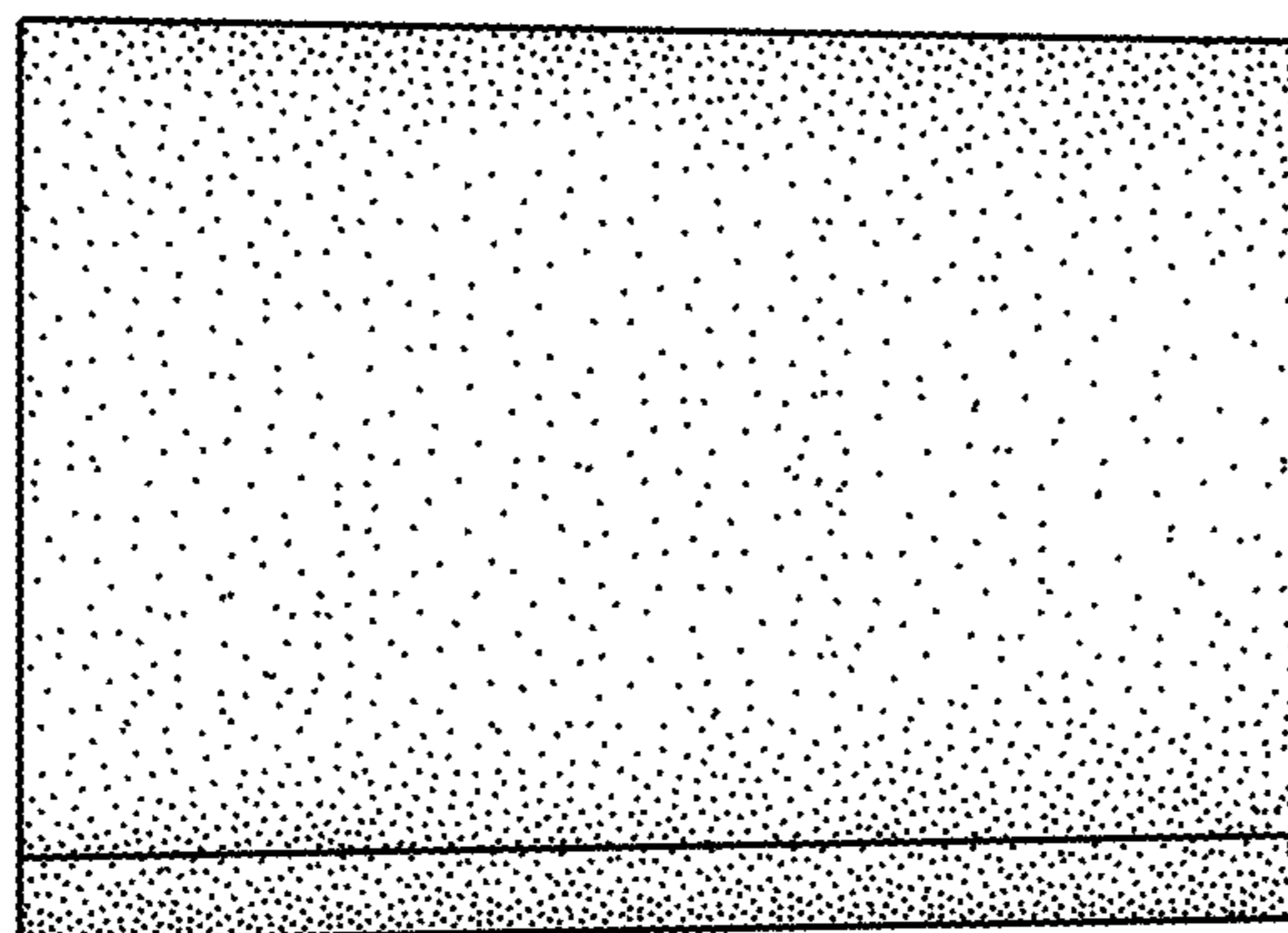

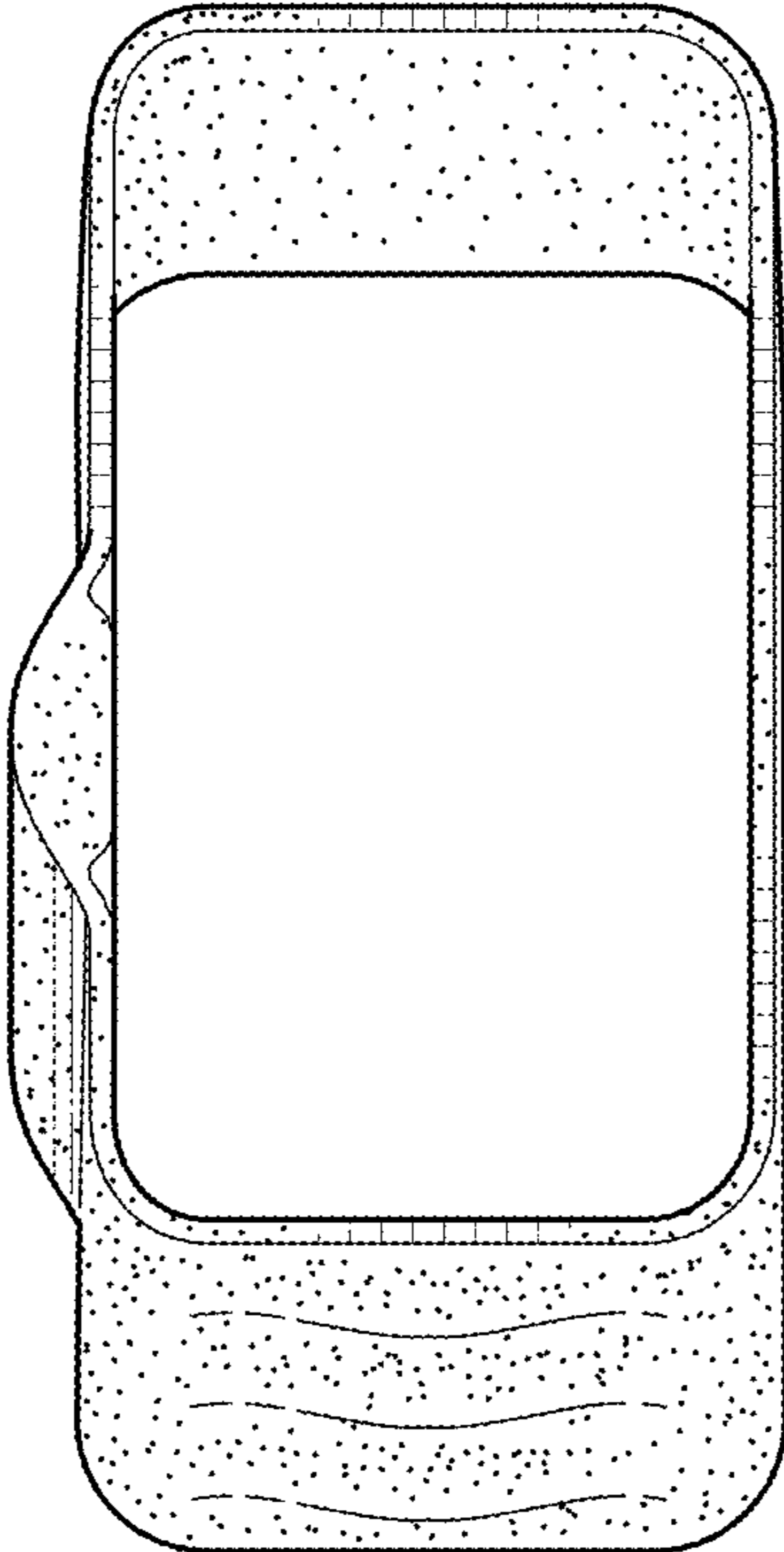

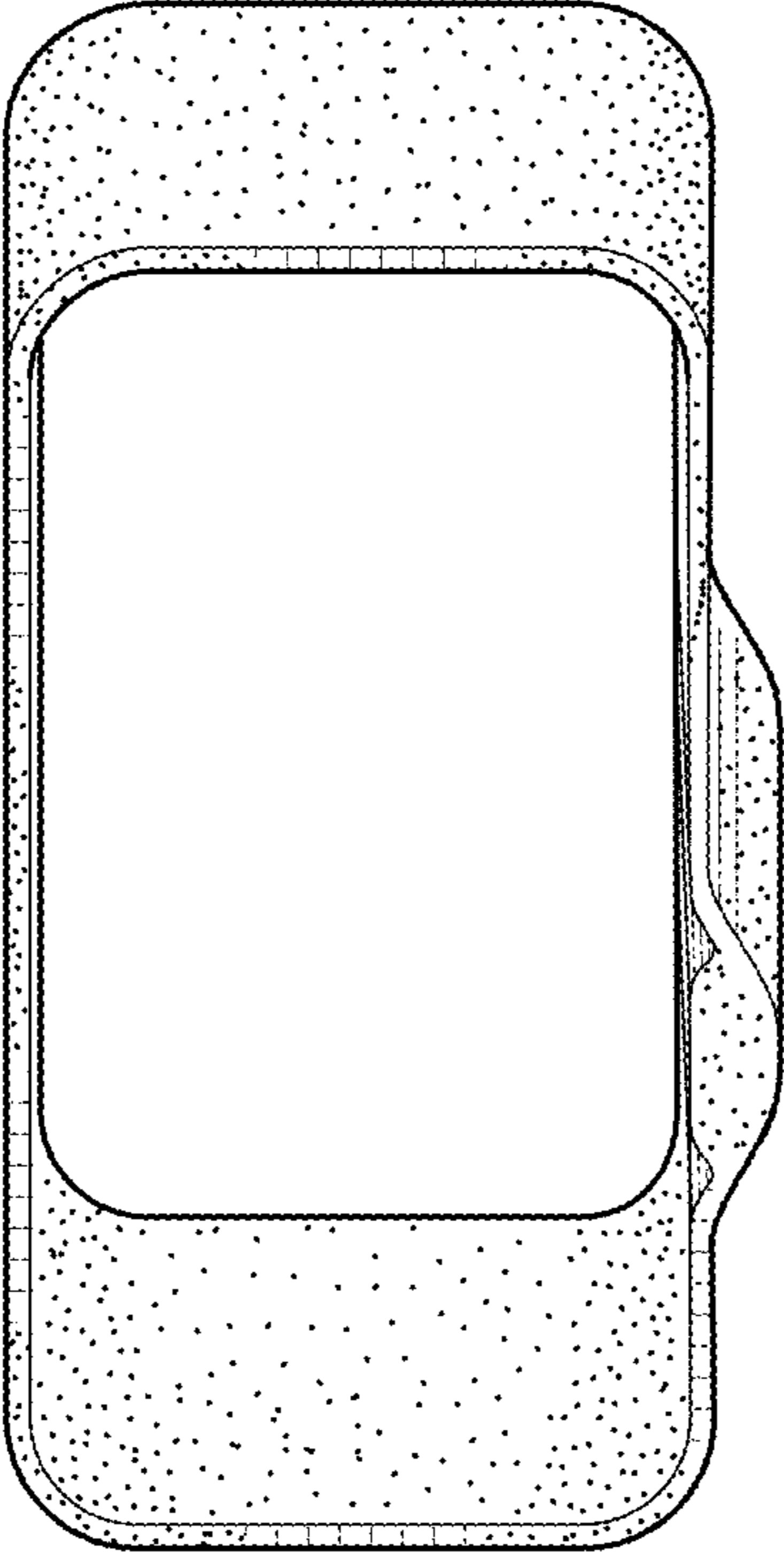

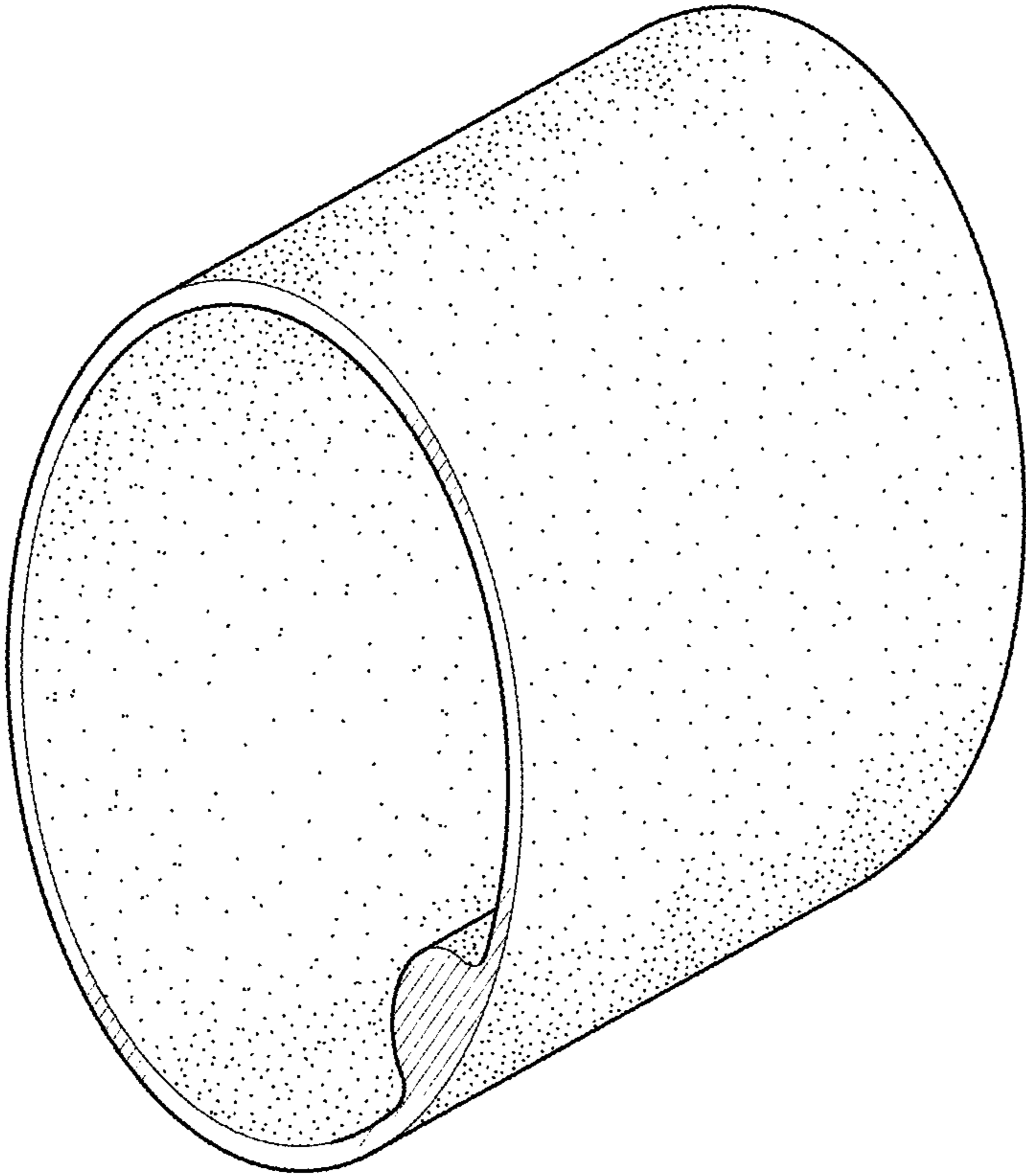

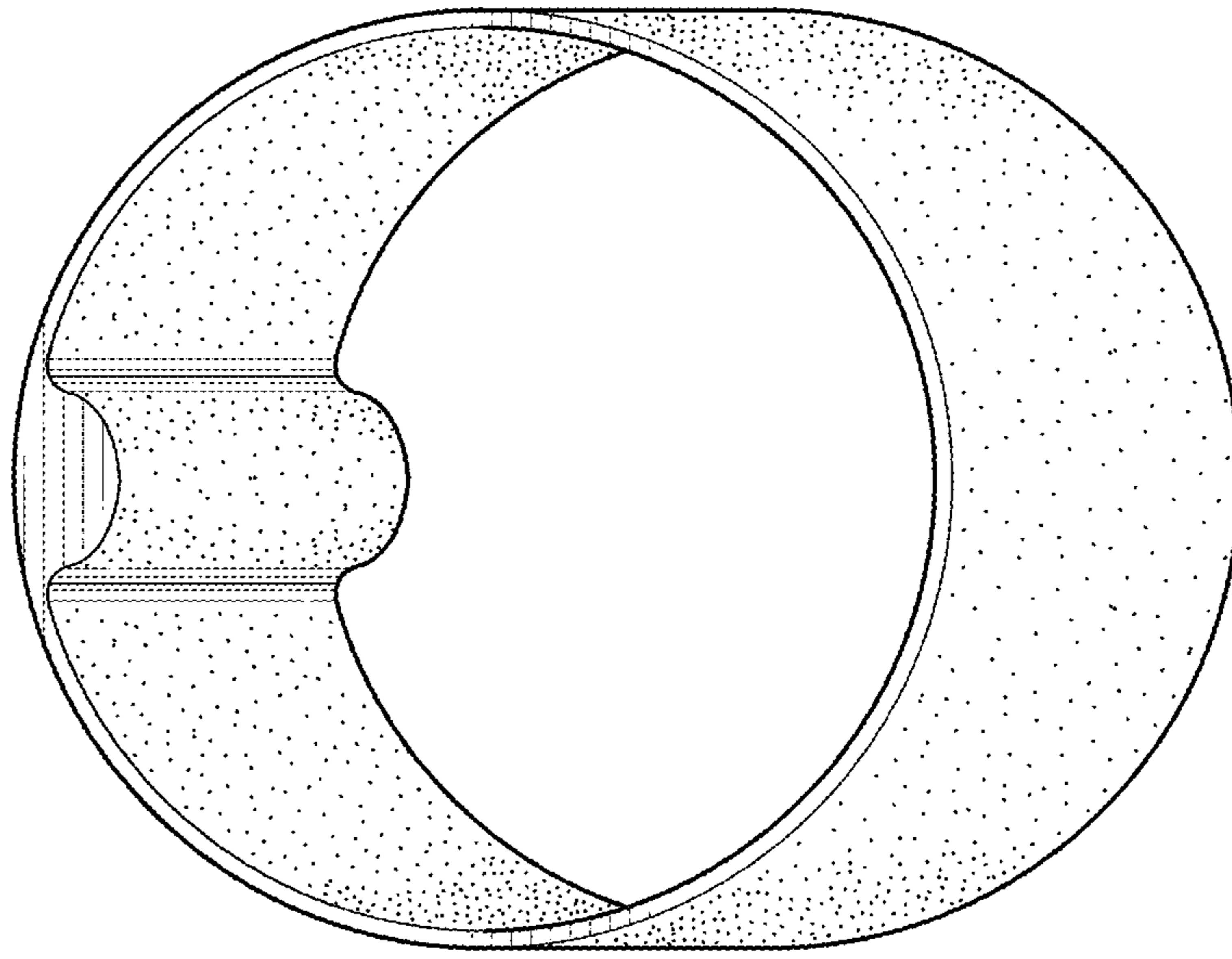

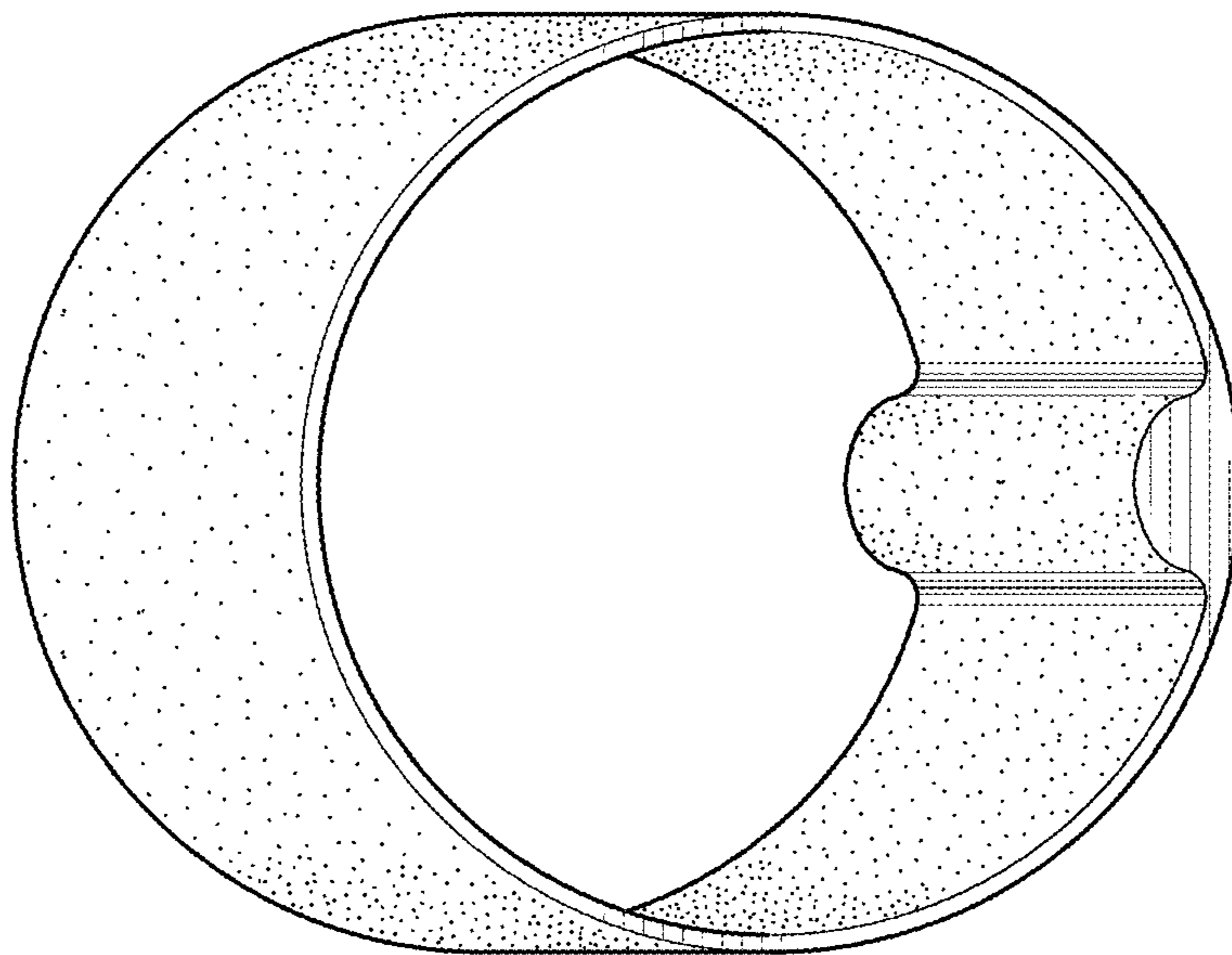

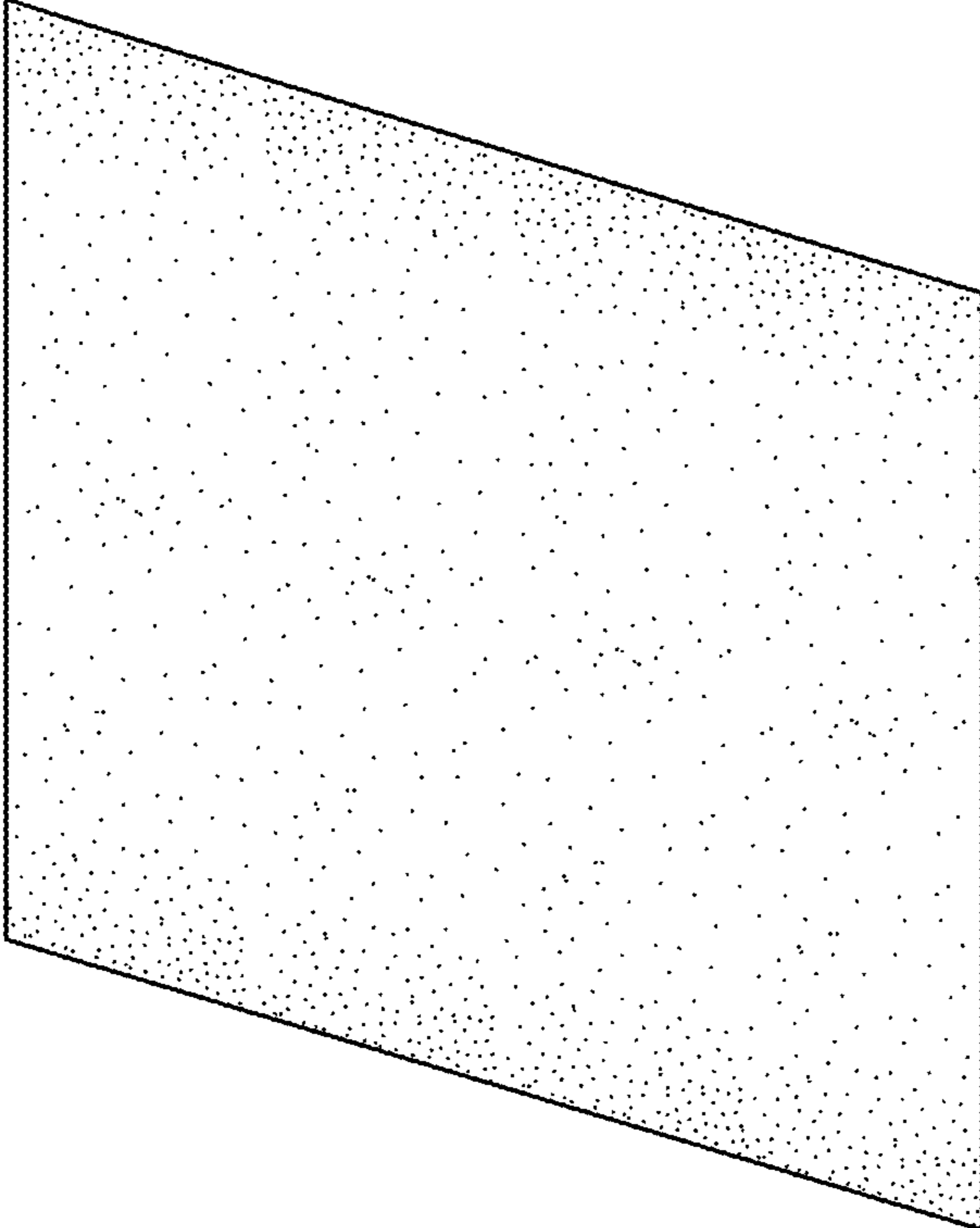

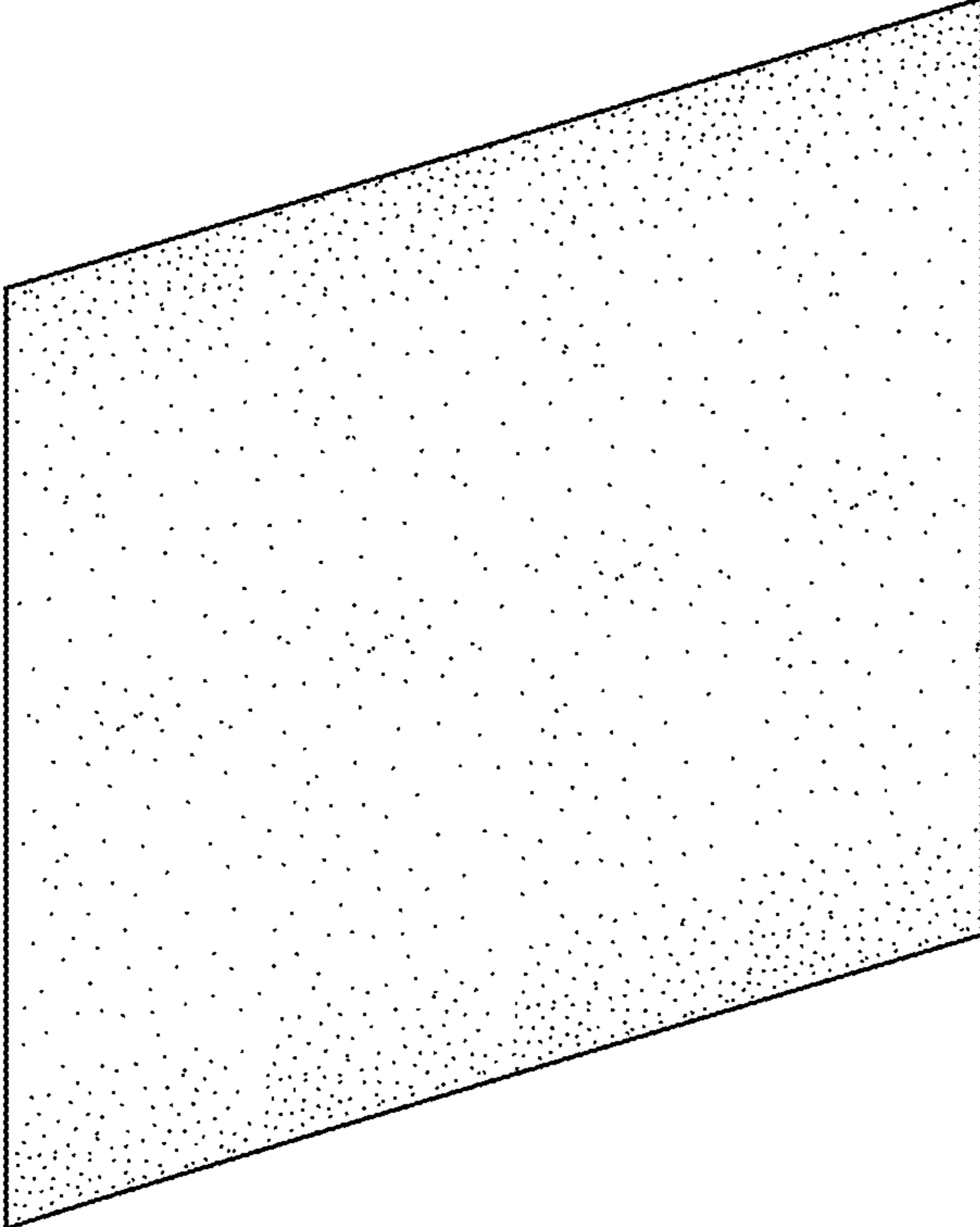

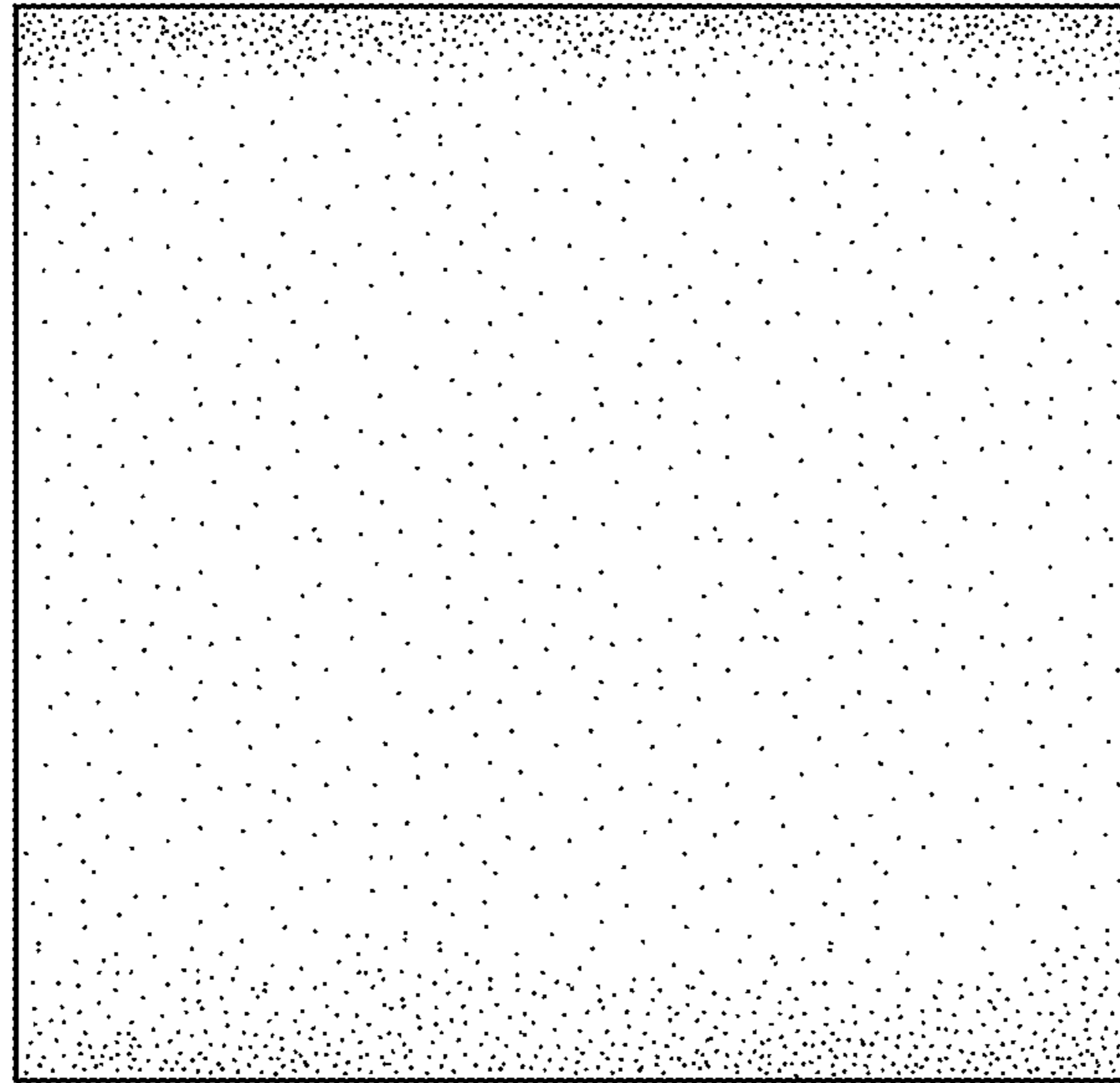

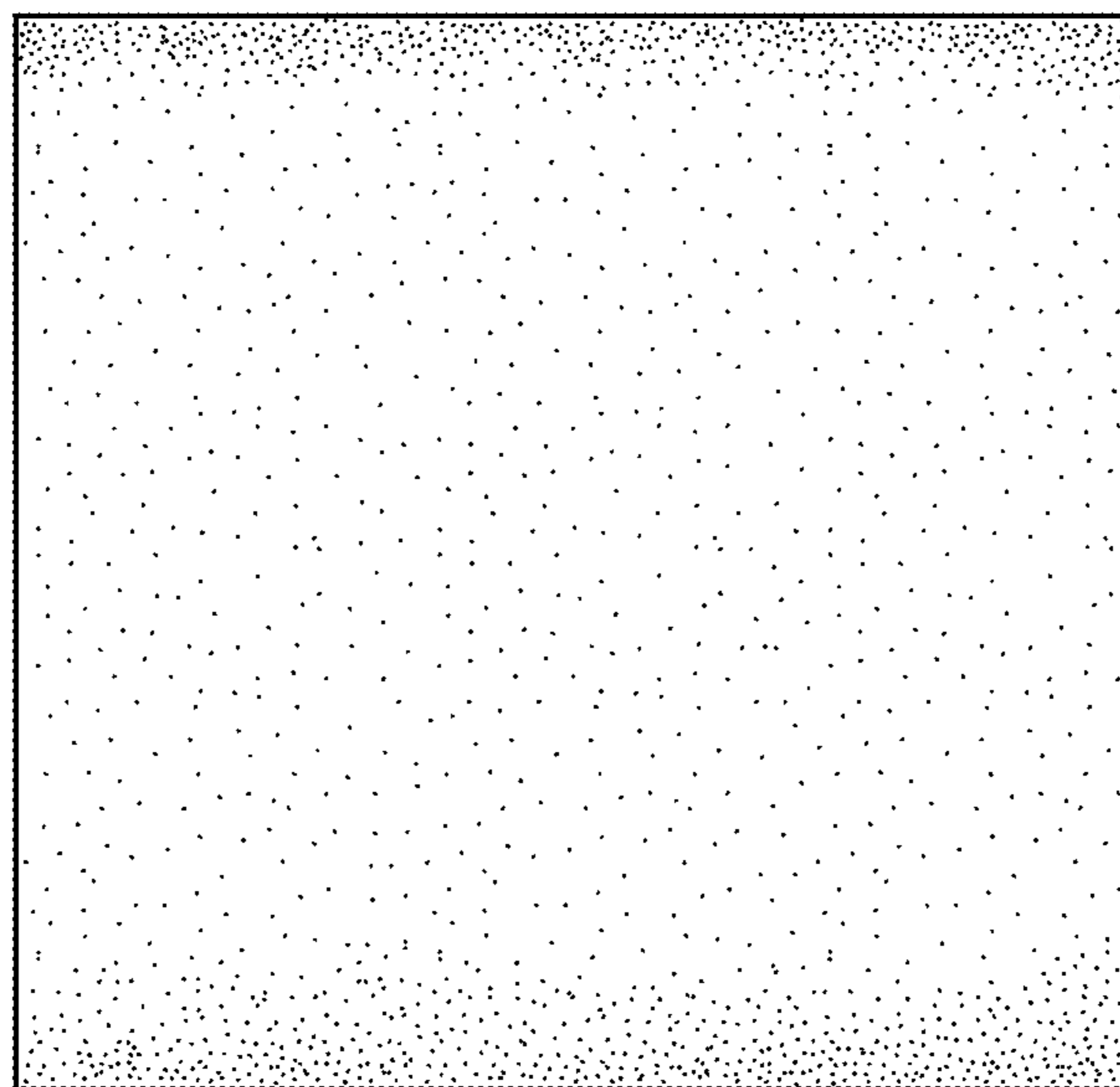

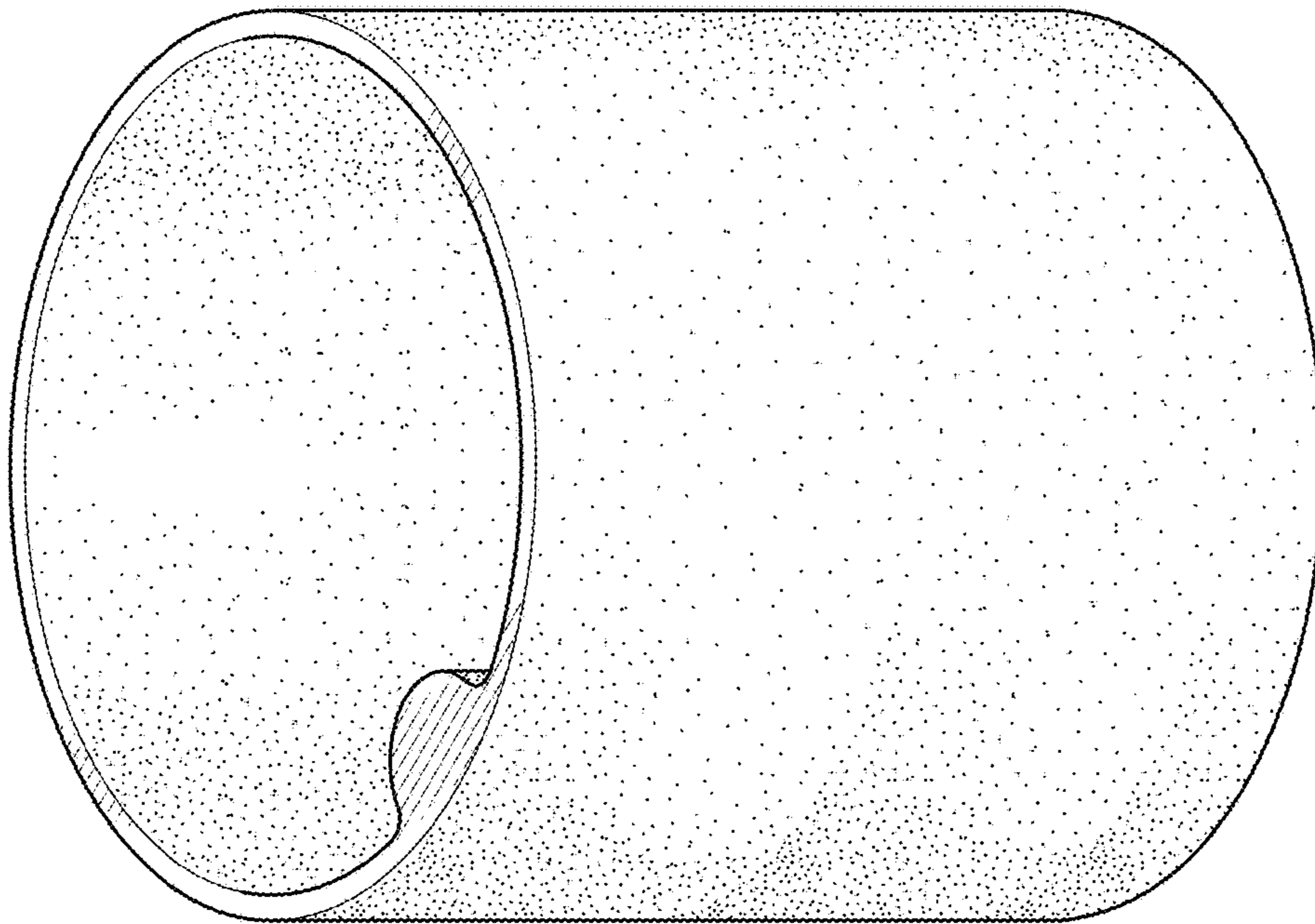

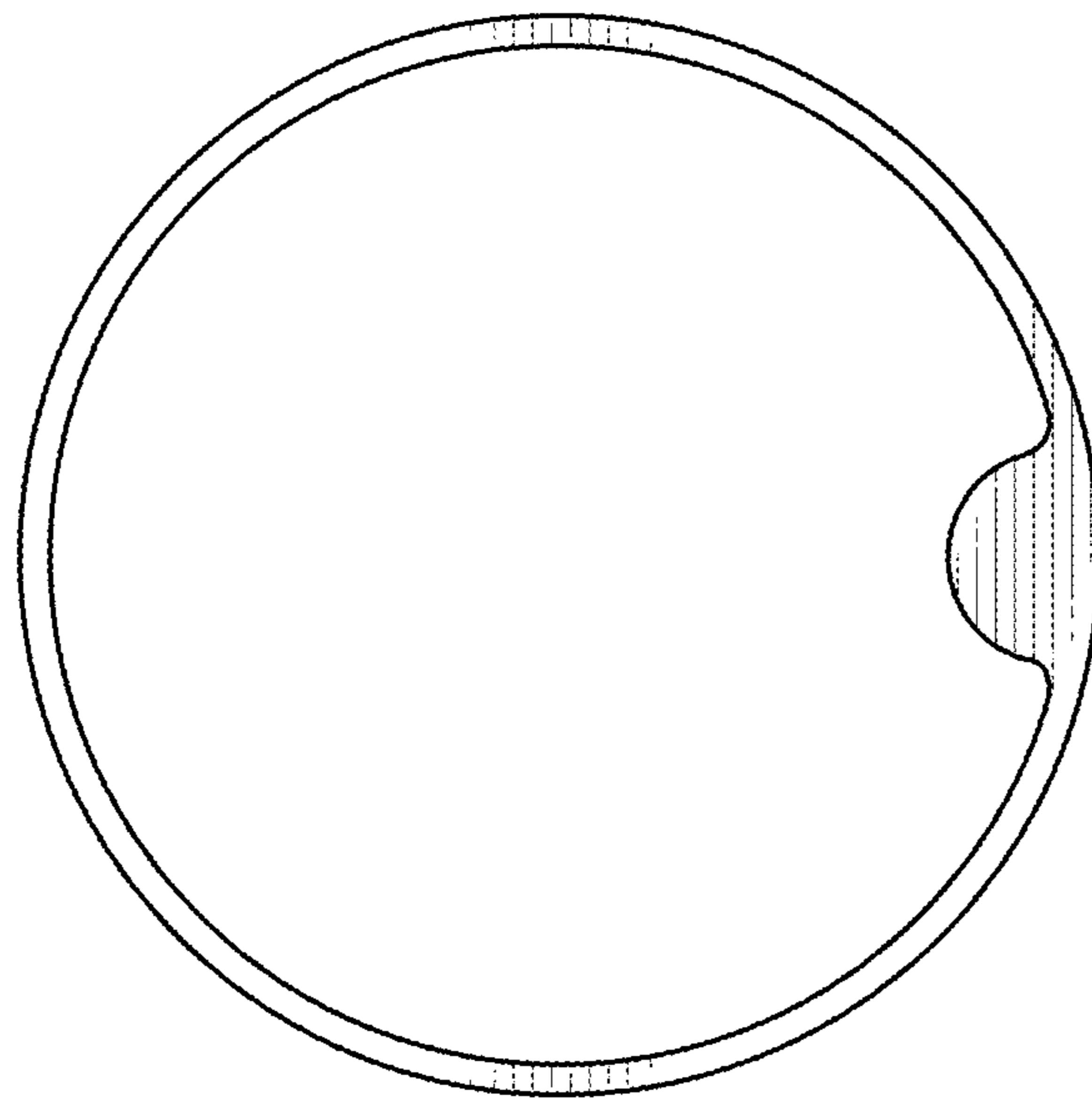

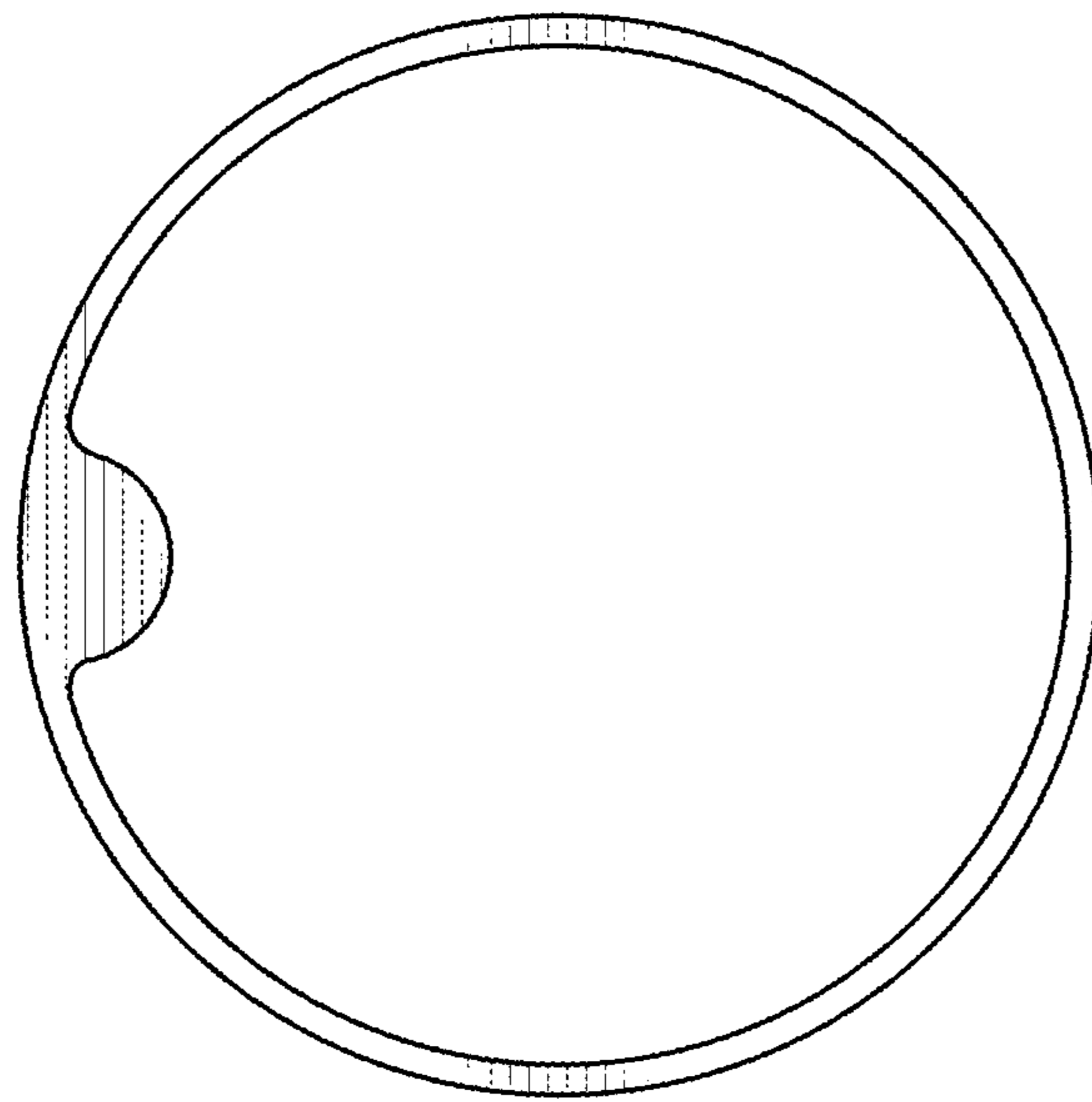

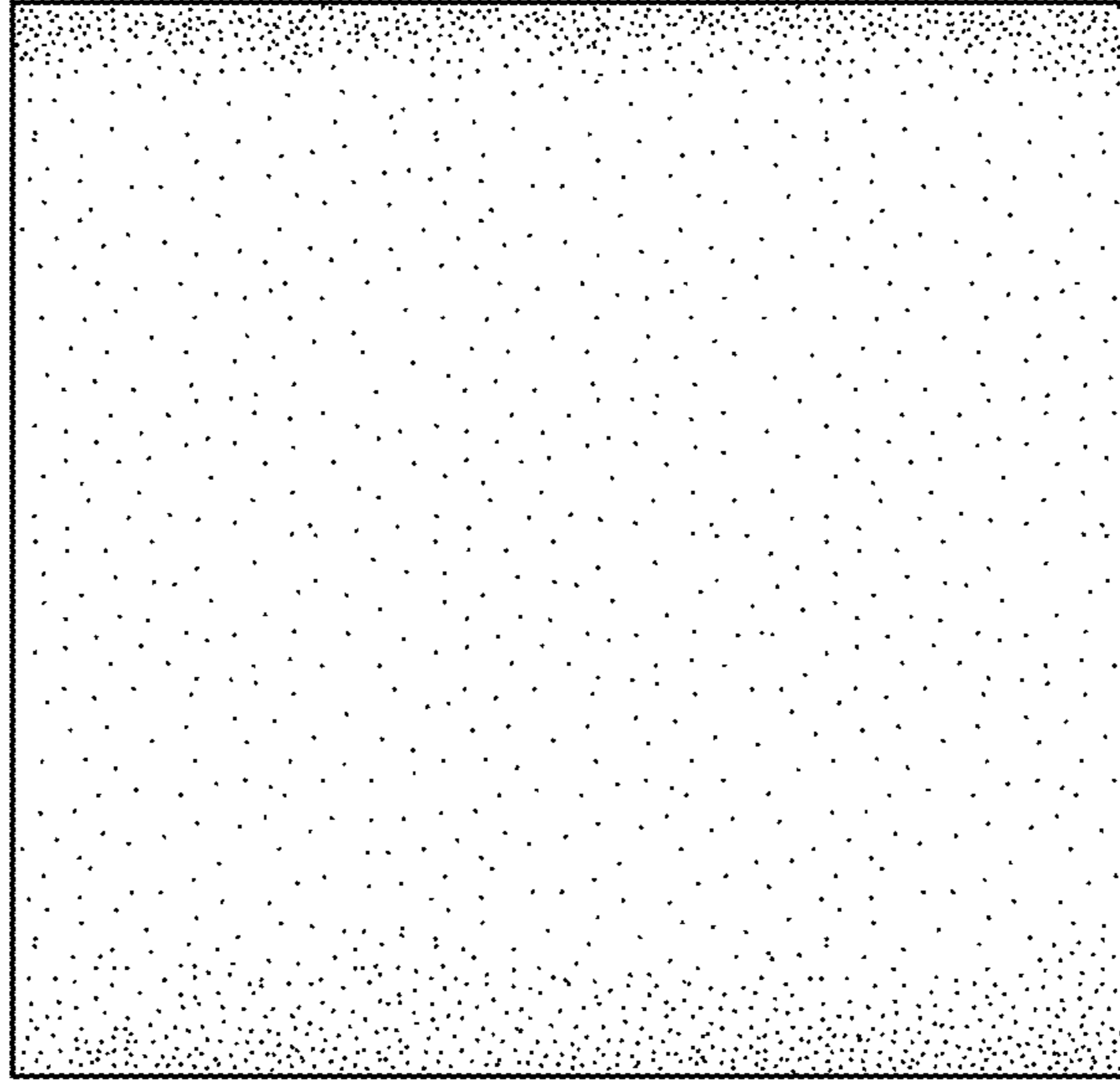

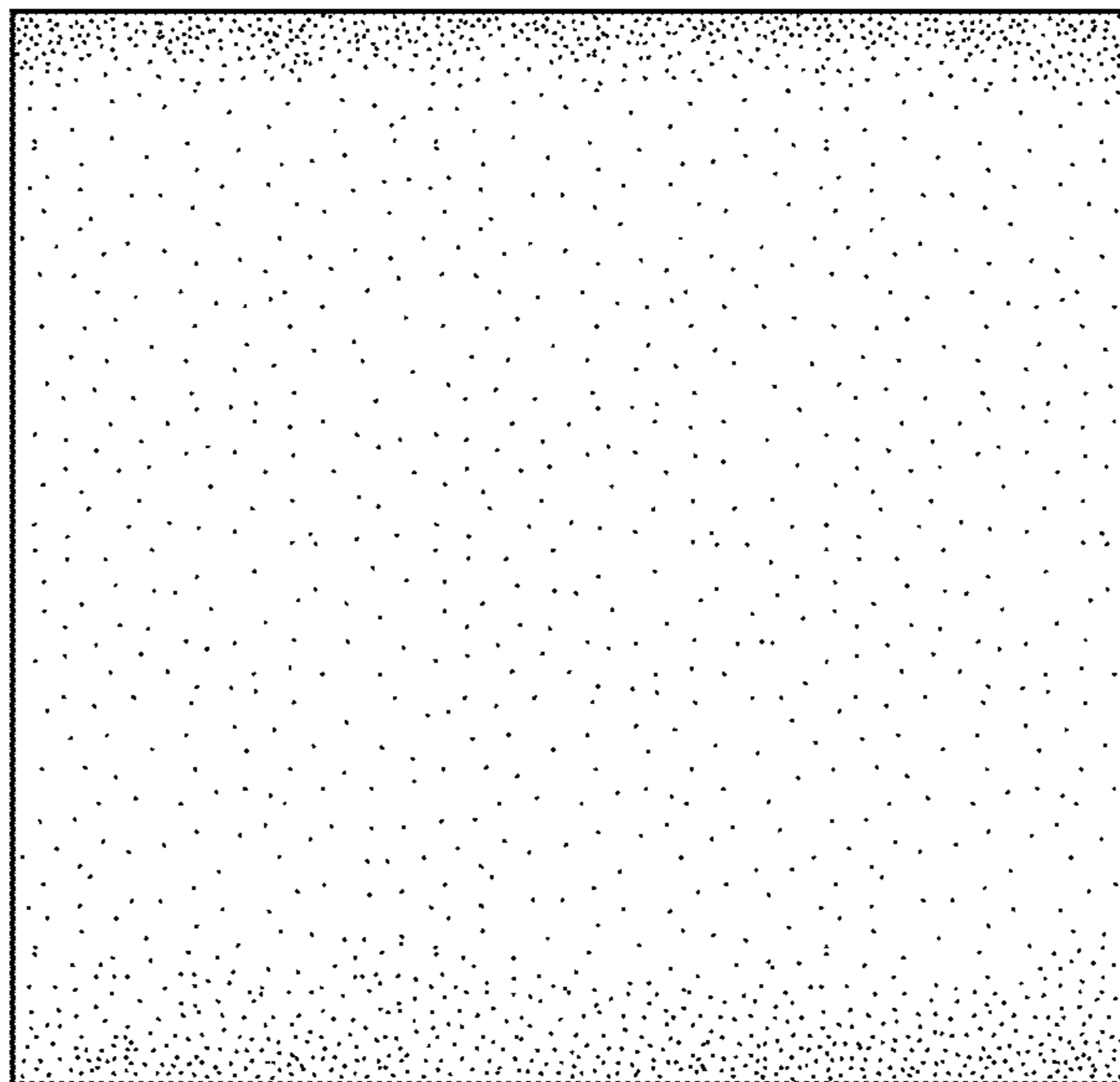

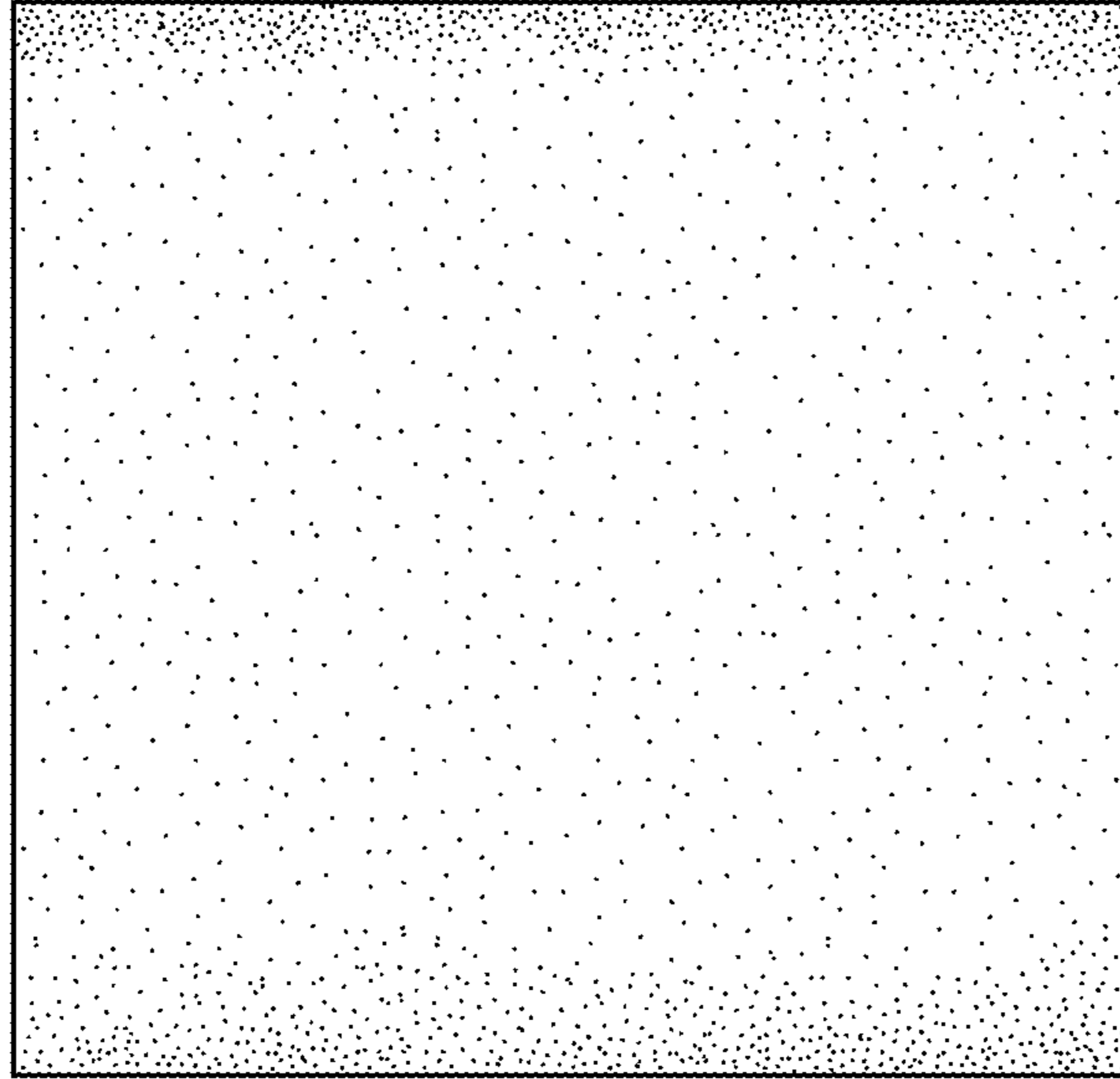

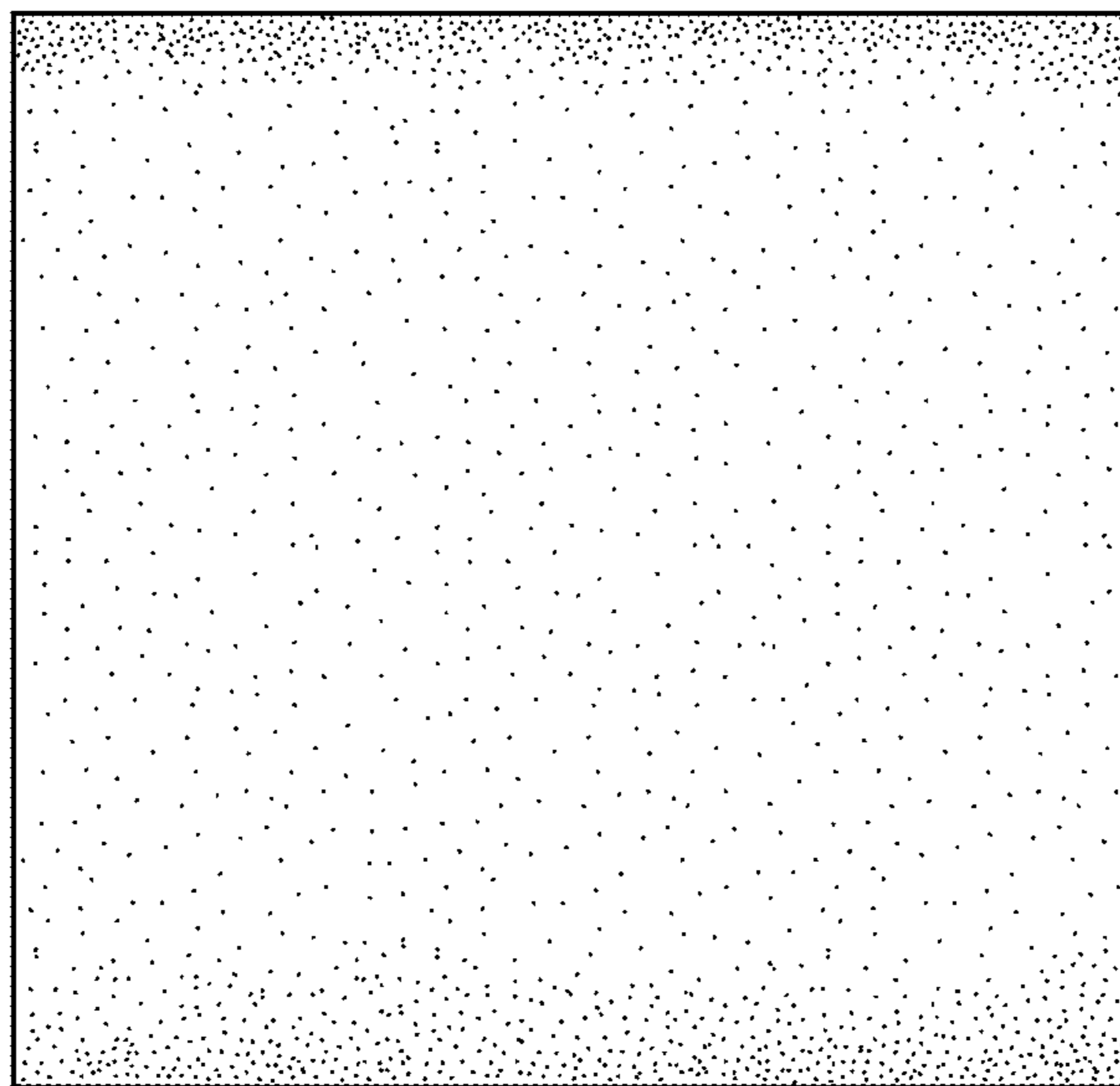
