The ornamental design for a room with retail arrangement, as shown and described.

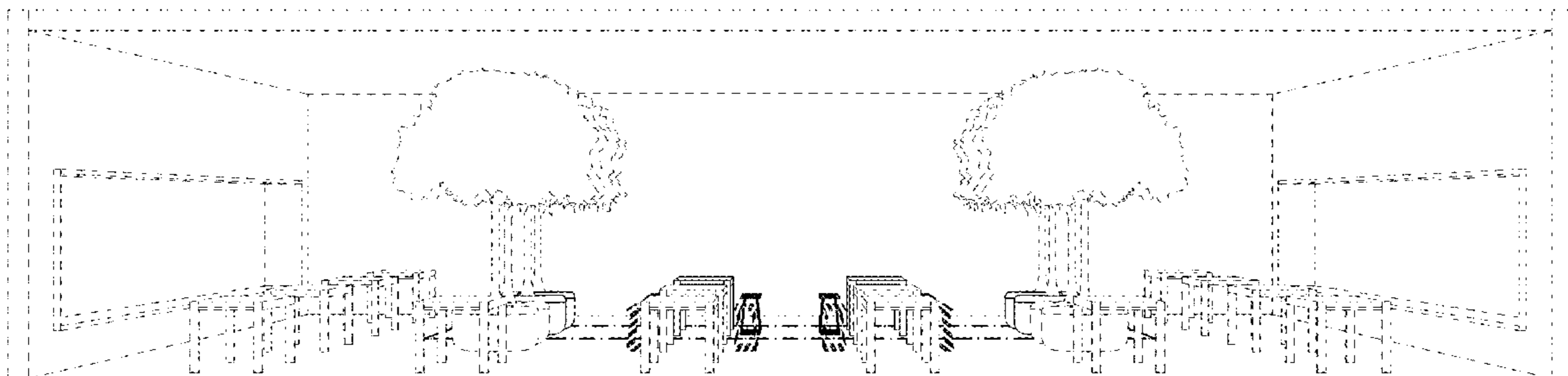
**DESCRIPTION**

FIG. 1 is an outer front perspective view of a room with retail arrangement showing the claimed design; FIG. 2 is an inner front view thereof; FIG. 3 is an inner rear view thereof; FIG. 4 is an inner left side view thereof; FIG. 5 is an inner right side view thereof; and, FIG. 6 is an inner top view thereof.

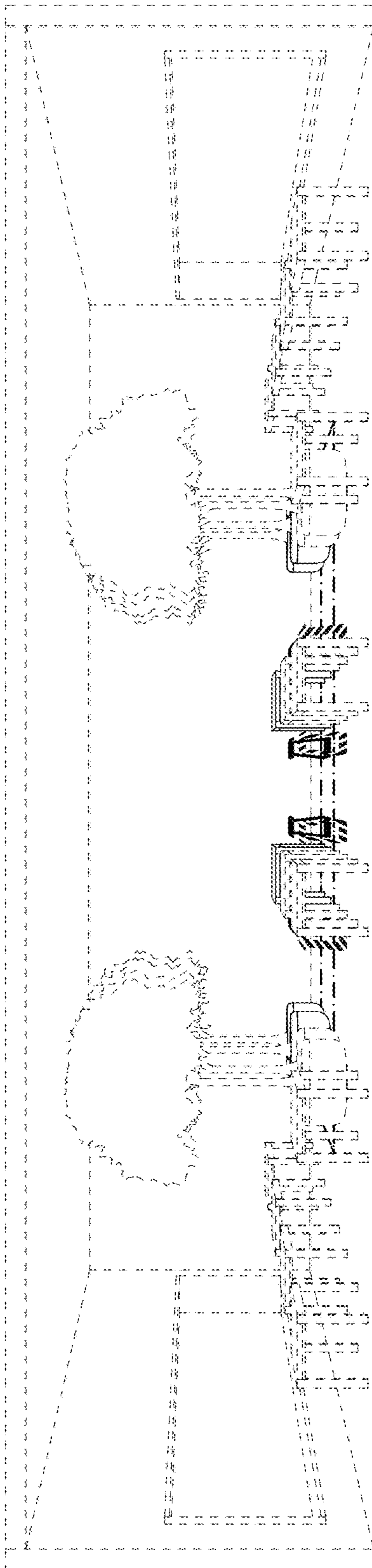
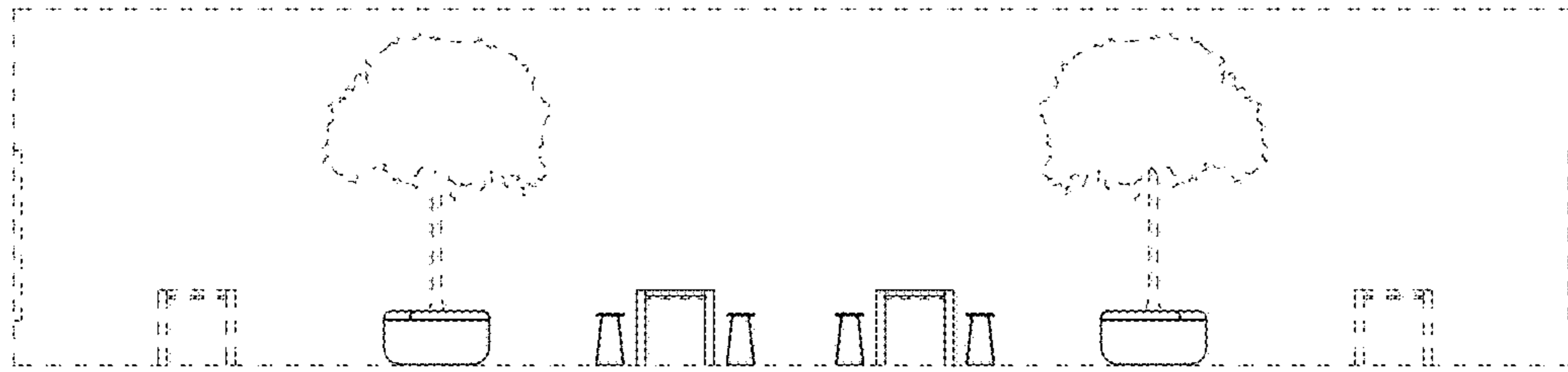
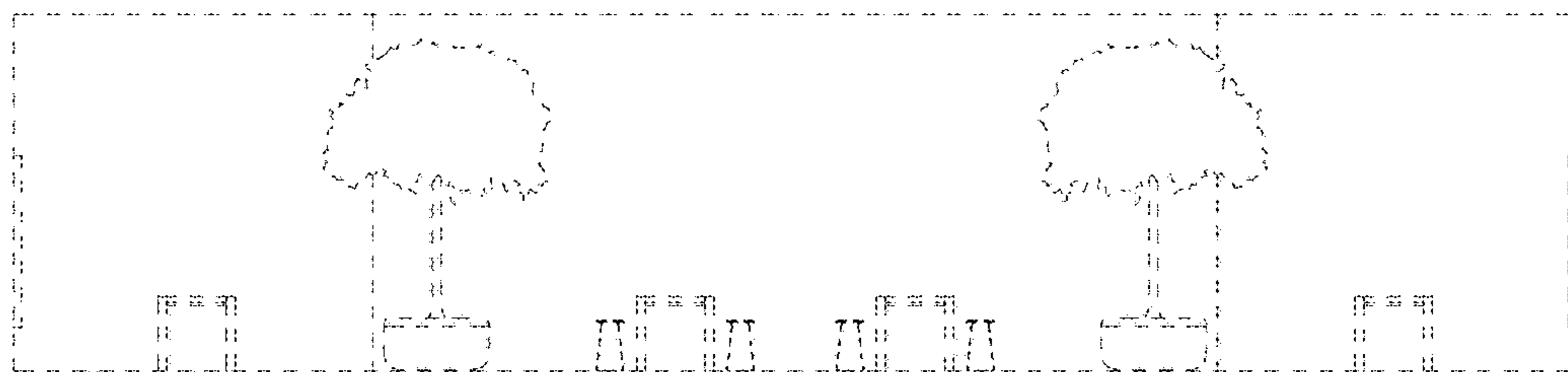

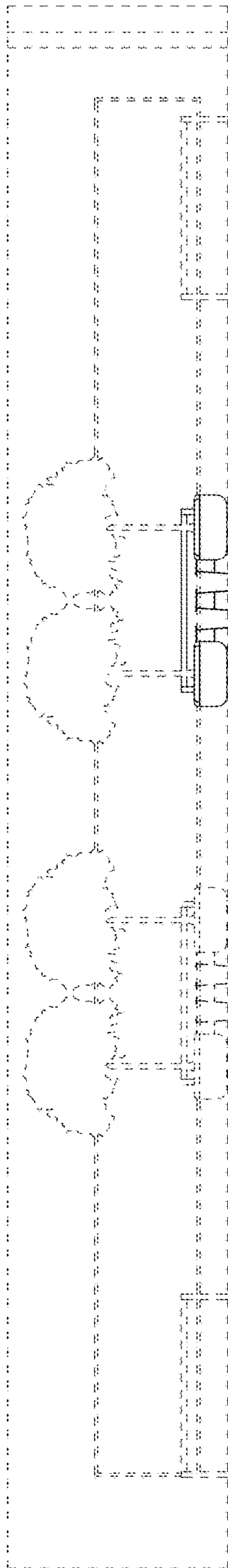

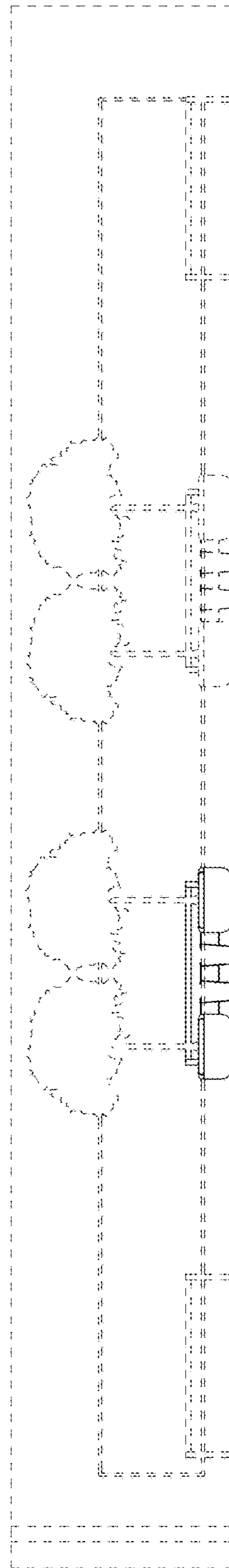

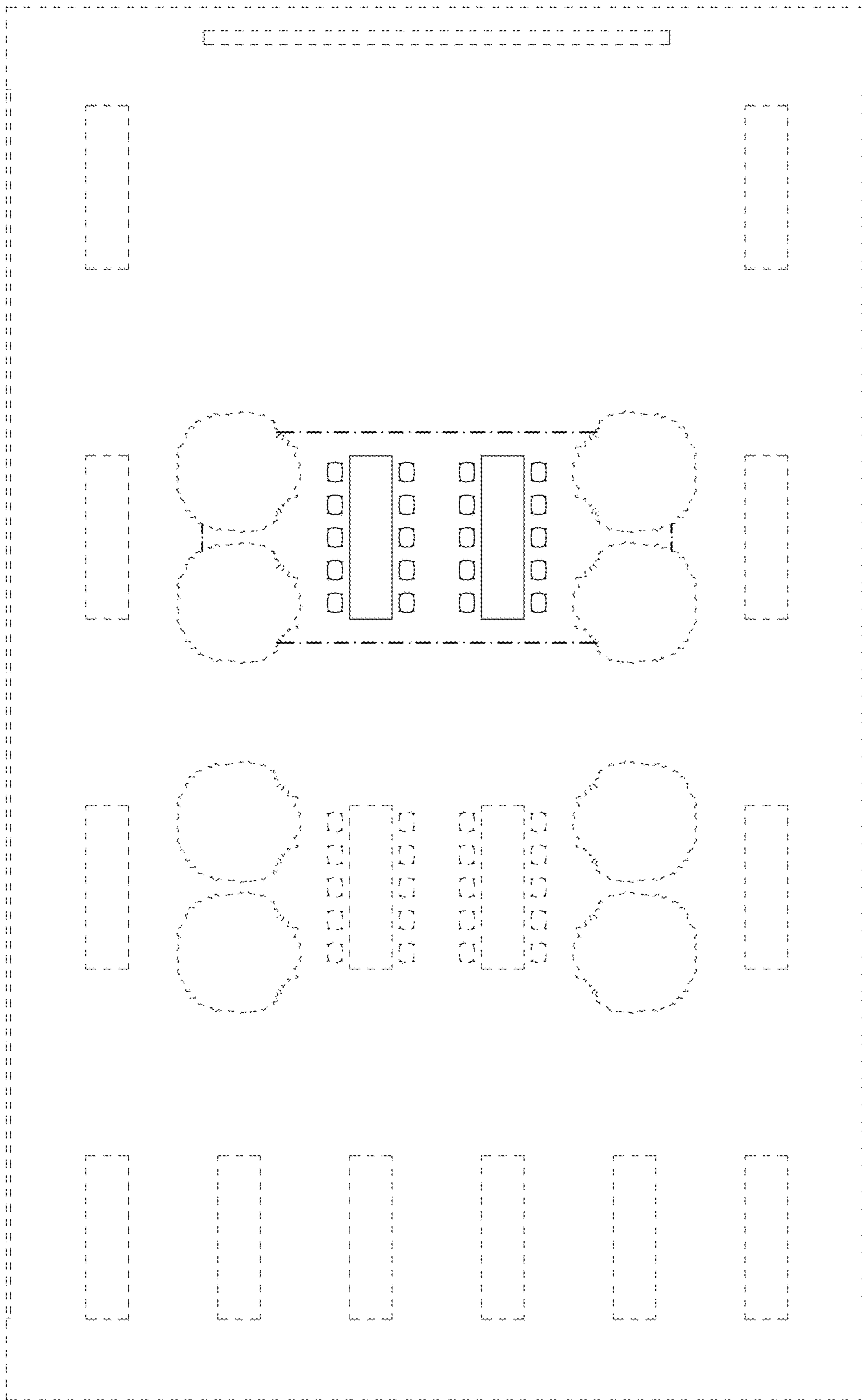
