(57) **CLAIM**

I claim the ornamental design for a cigar stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our new design for a cigar stand;

FIG. 2 is a front view thereof;

FIG. 3 is a top plan view thereof;

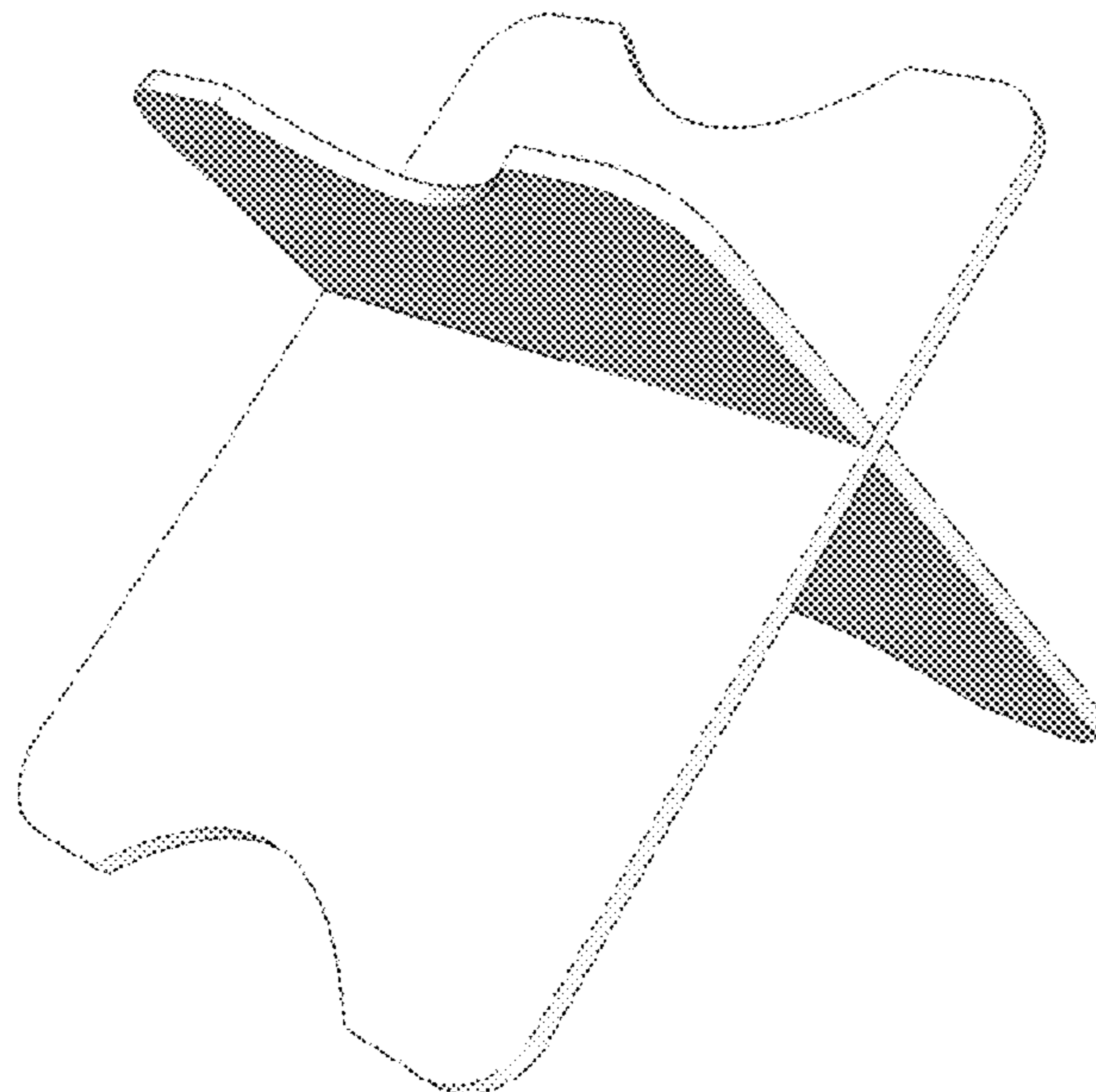
FIG. 4 is a bottom view thereof;

FIG. 5 is a left side thereof, the right side being a mirror image thereof.

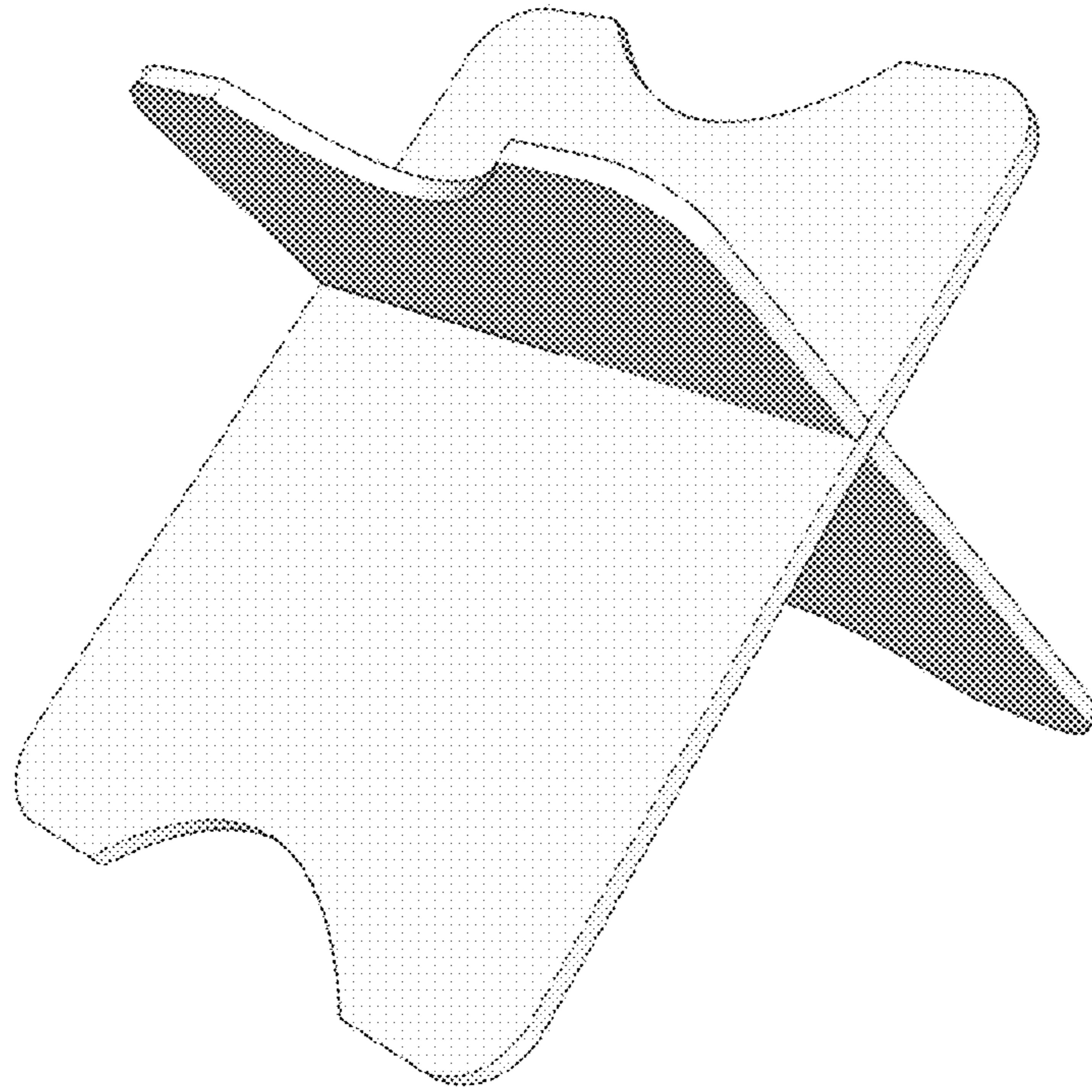

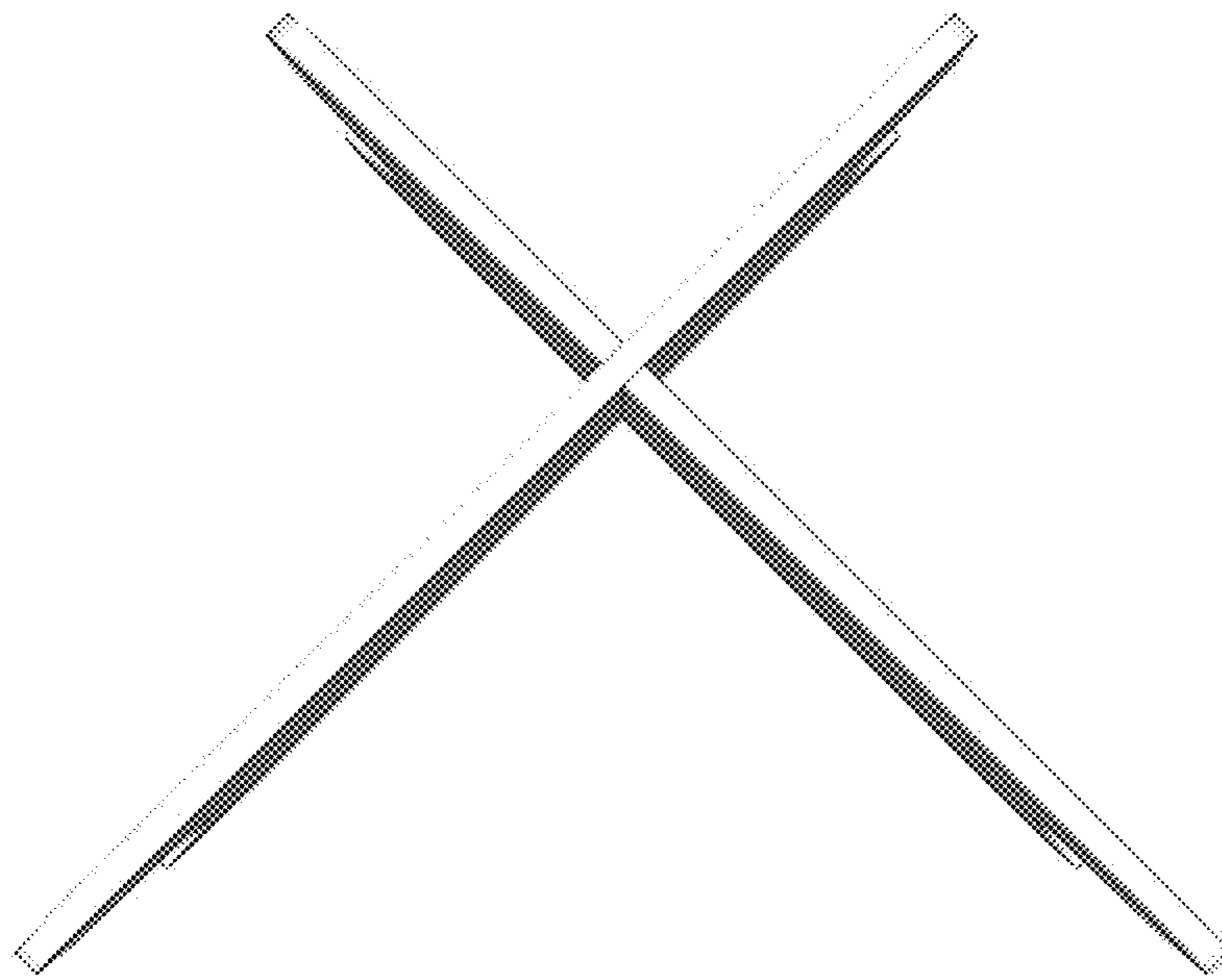

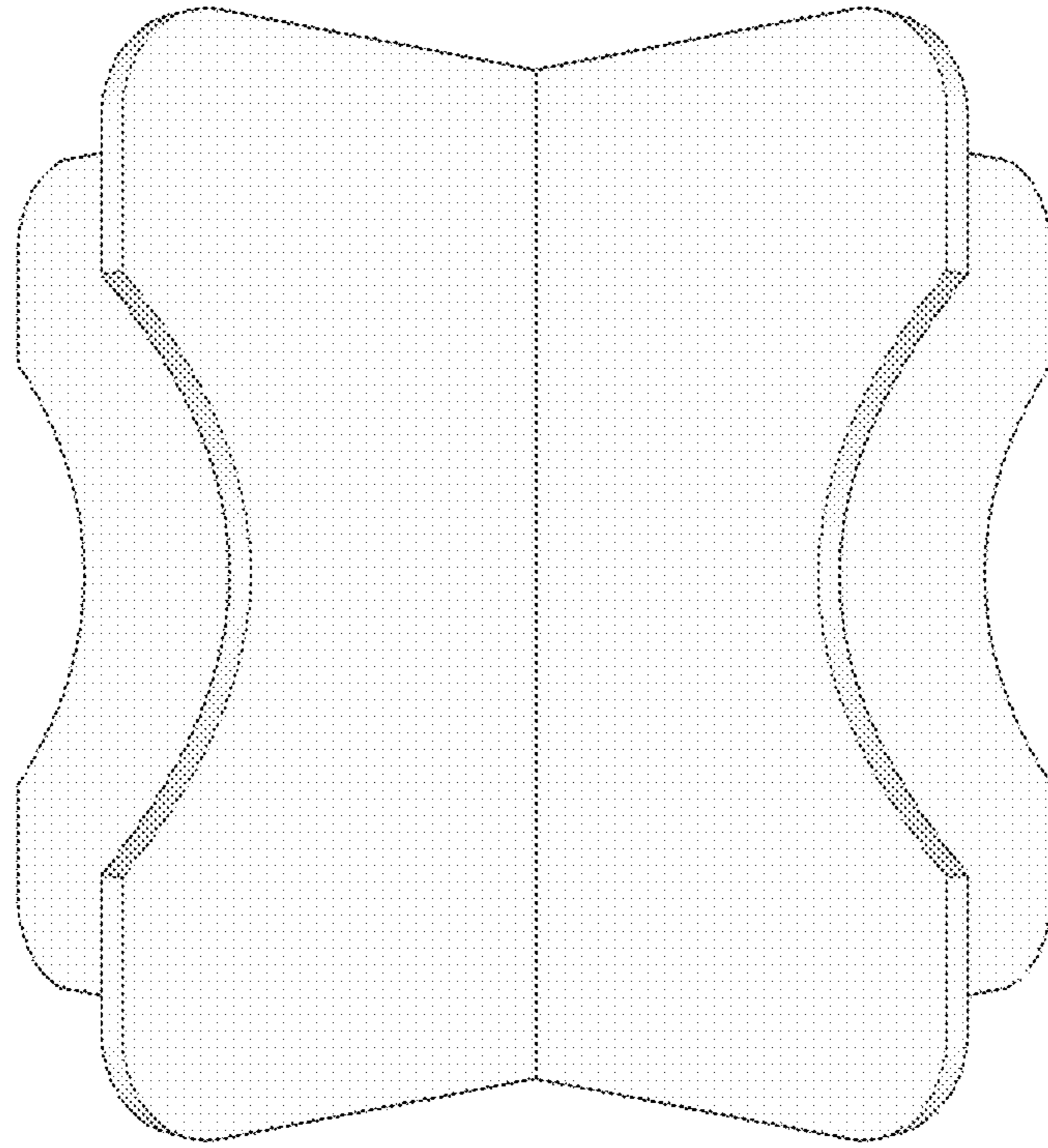

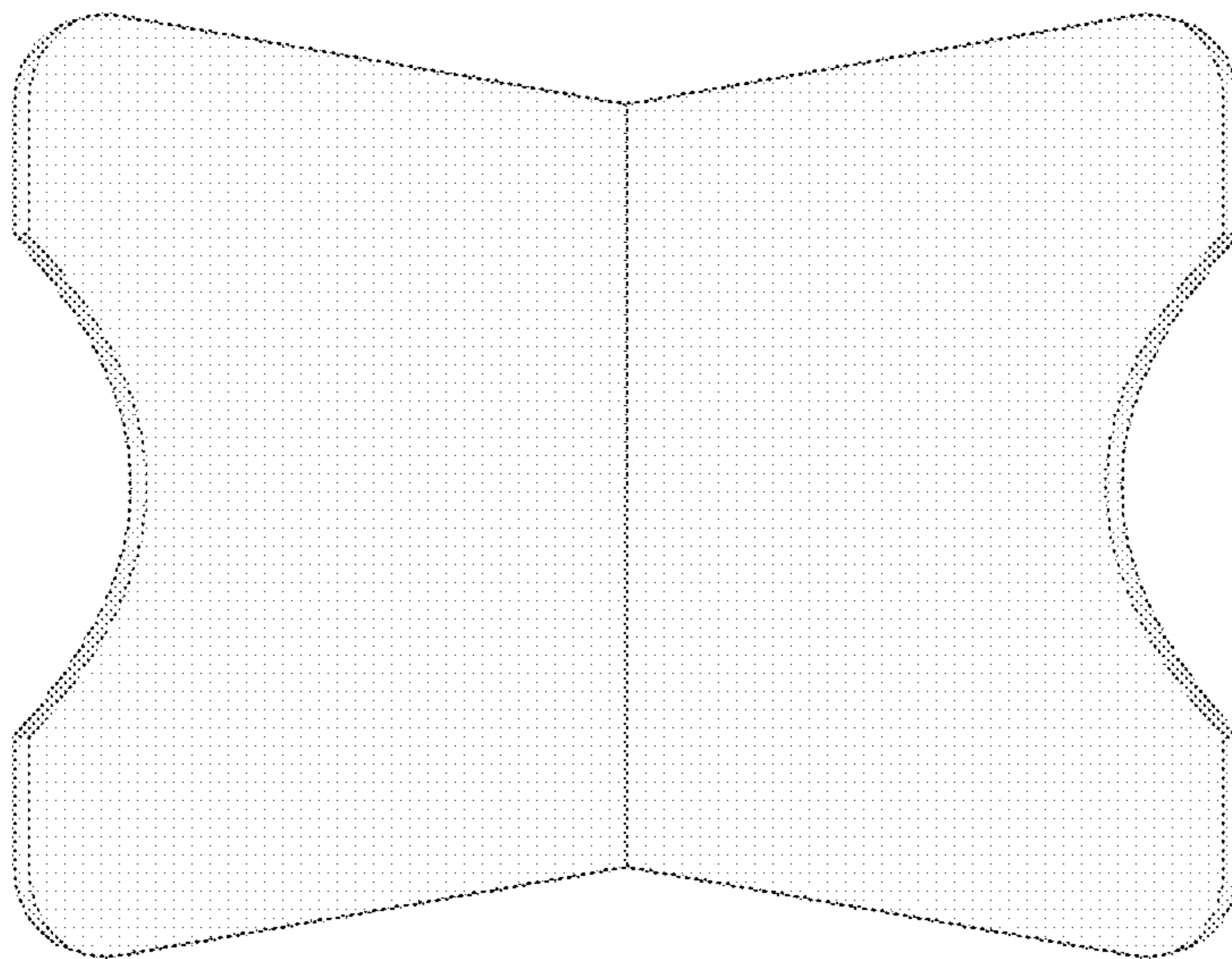

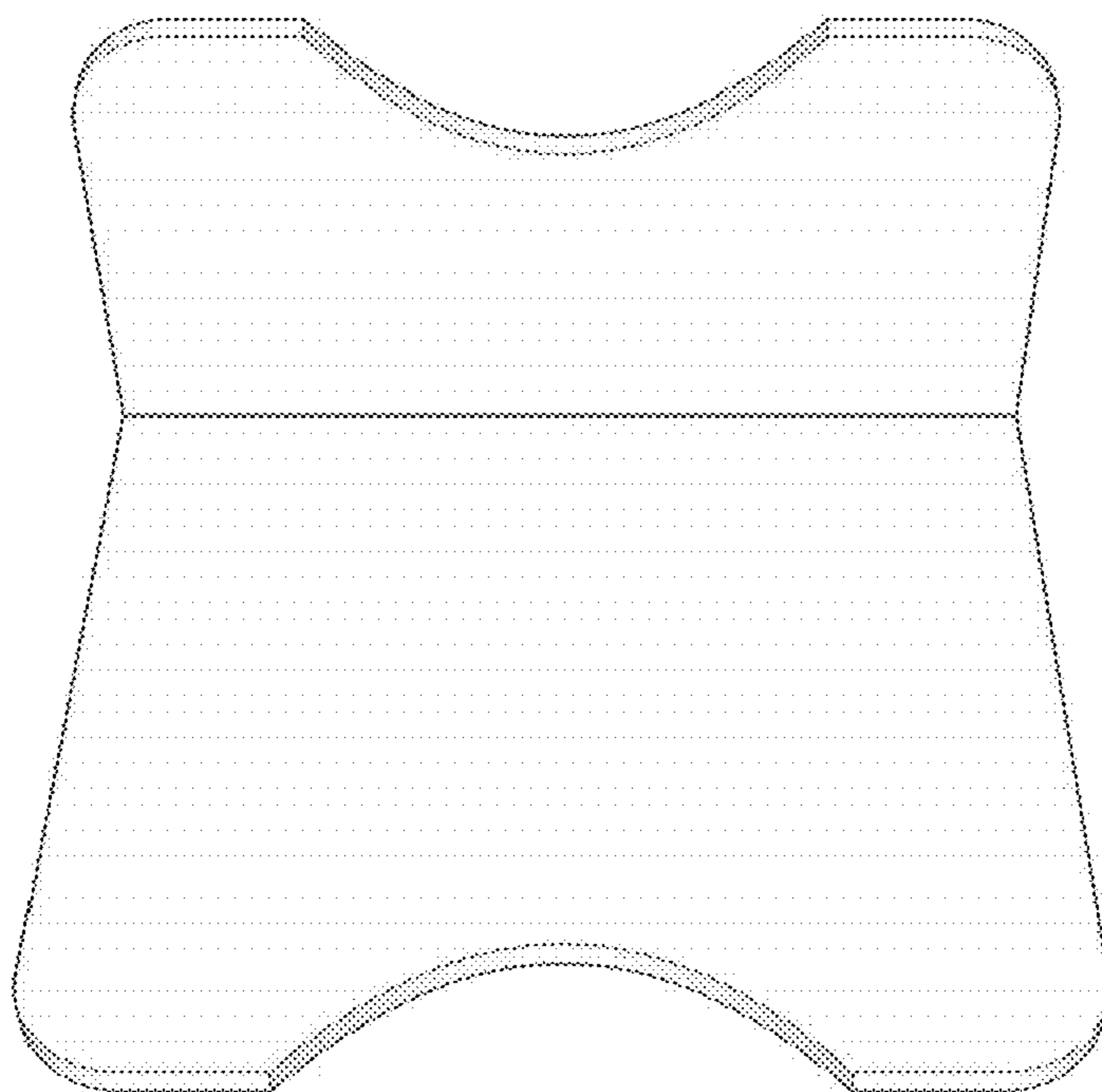

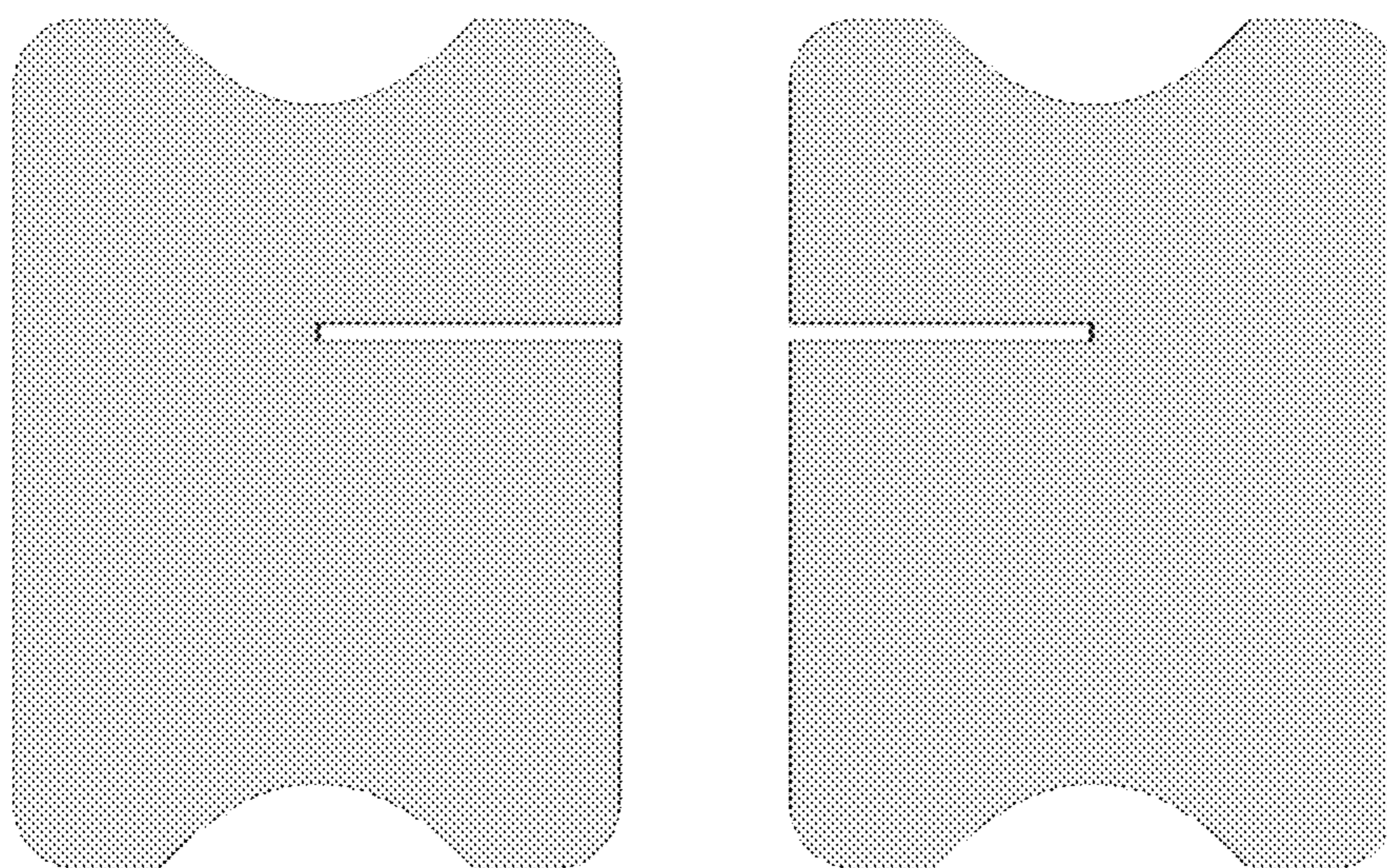

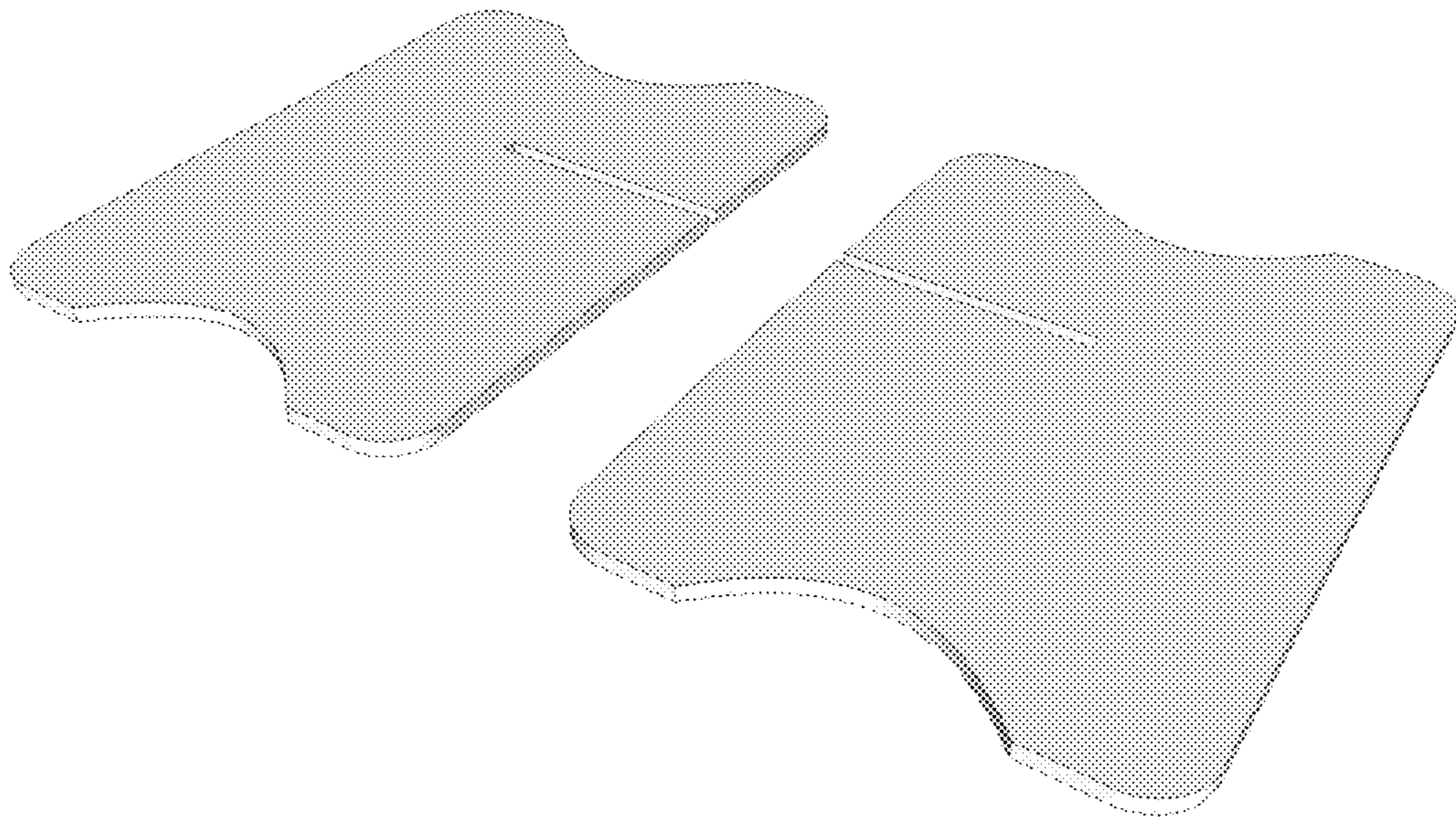
