DESCRIPTION

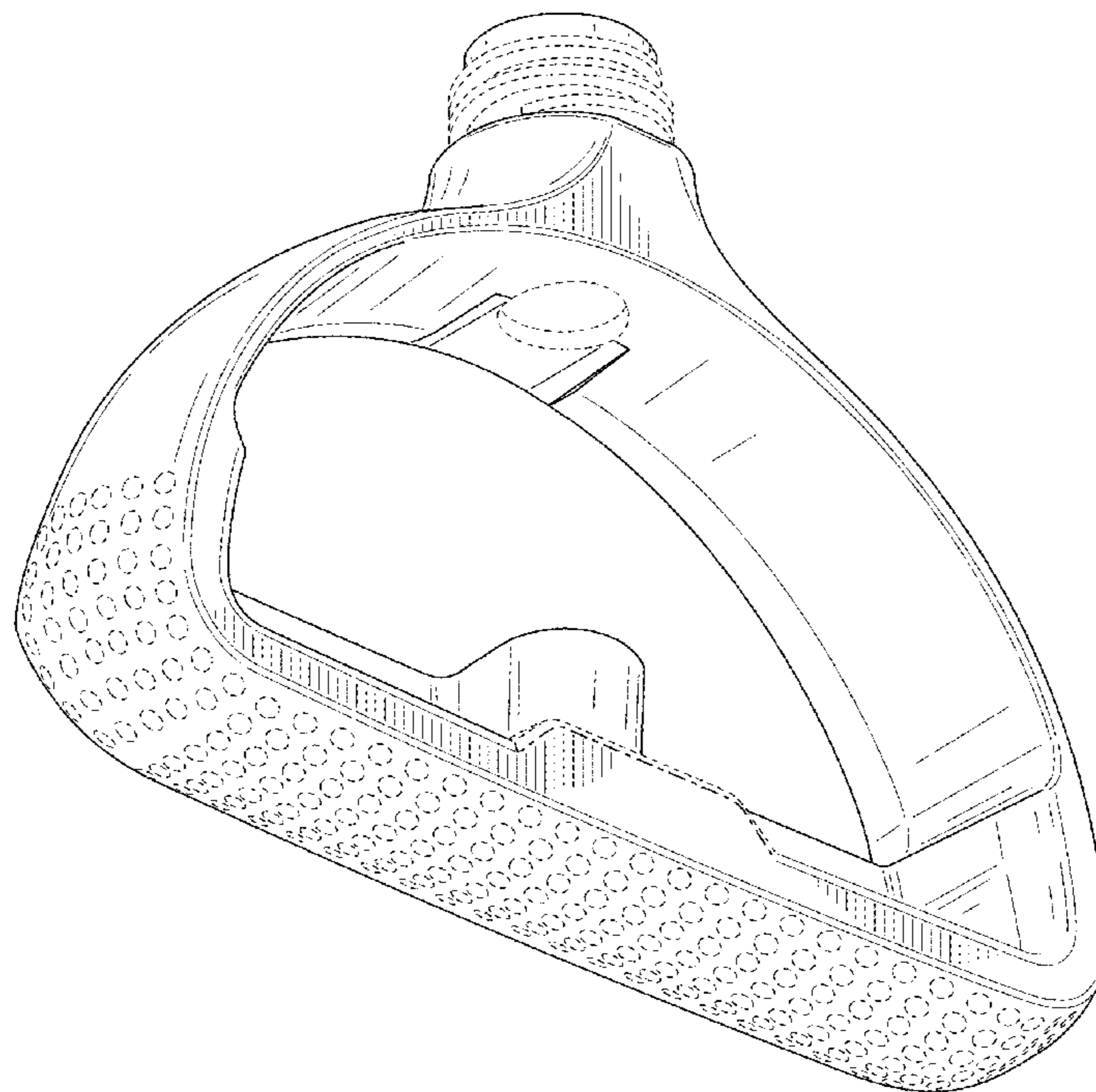
FIG. 1 is a front-bottom perspective view of the claimed design;

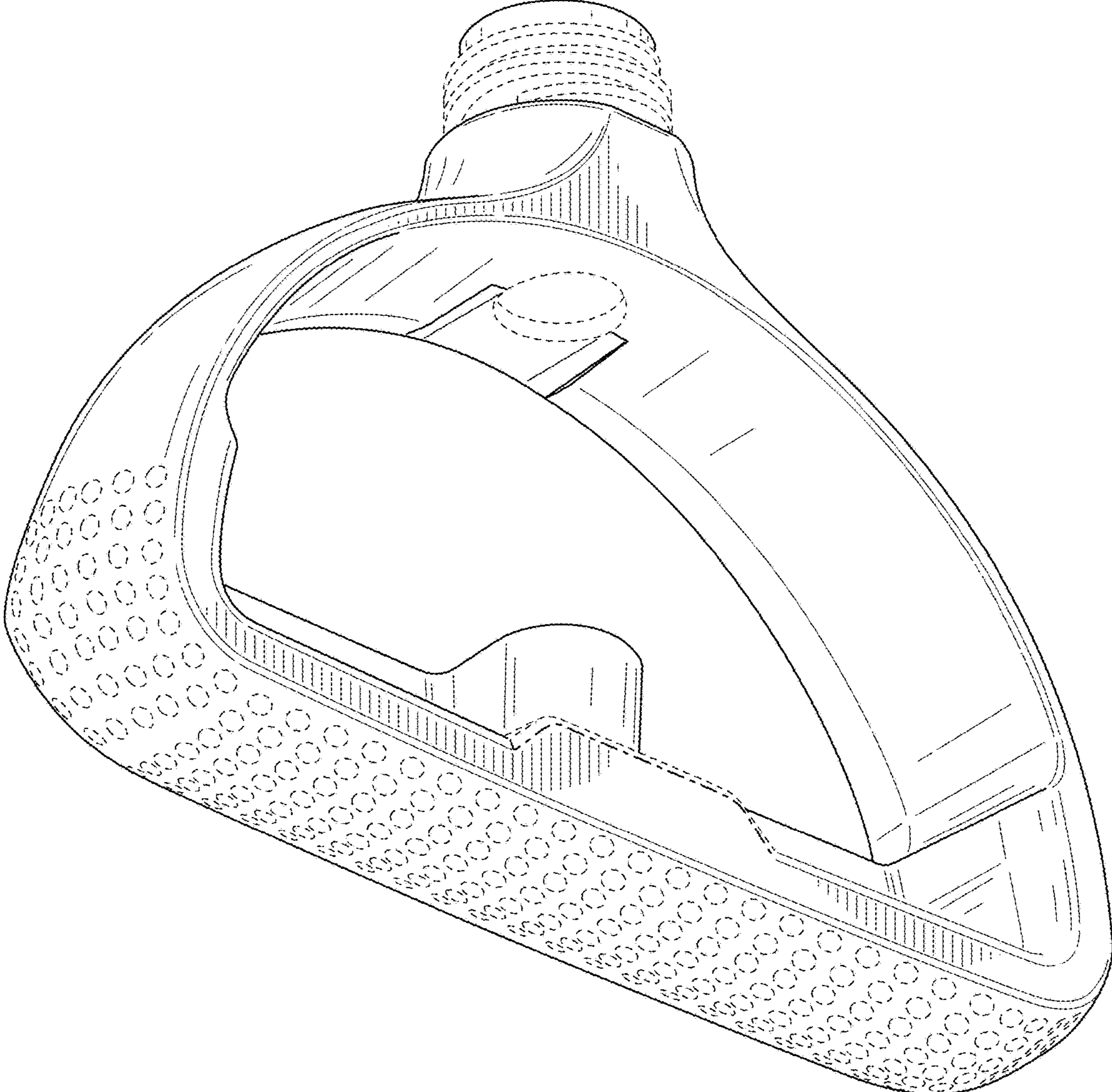

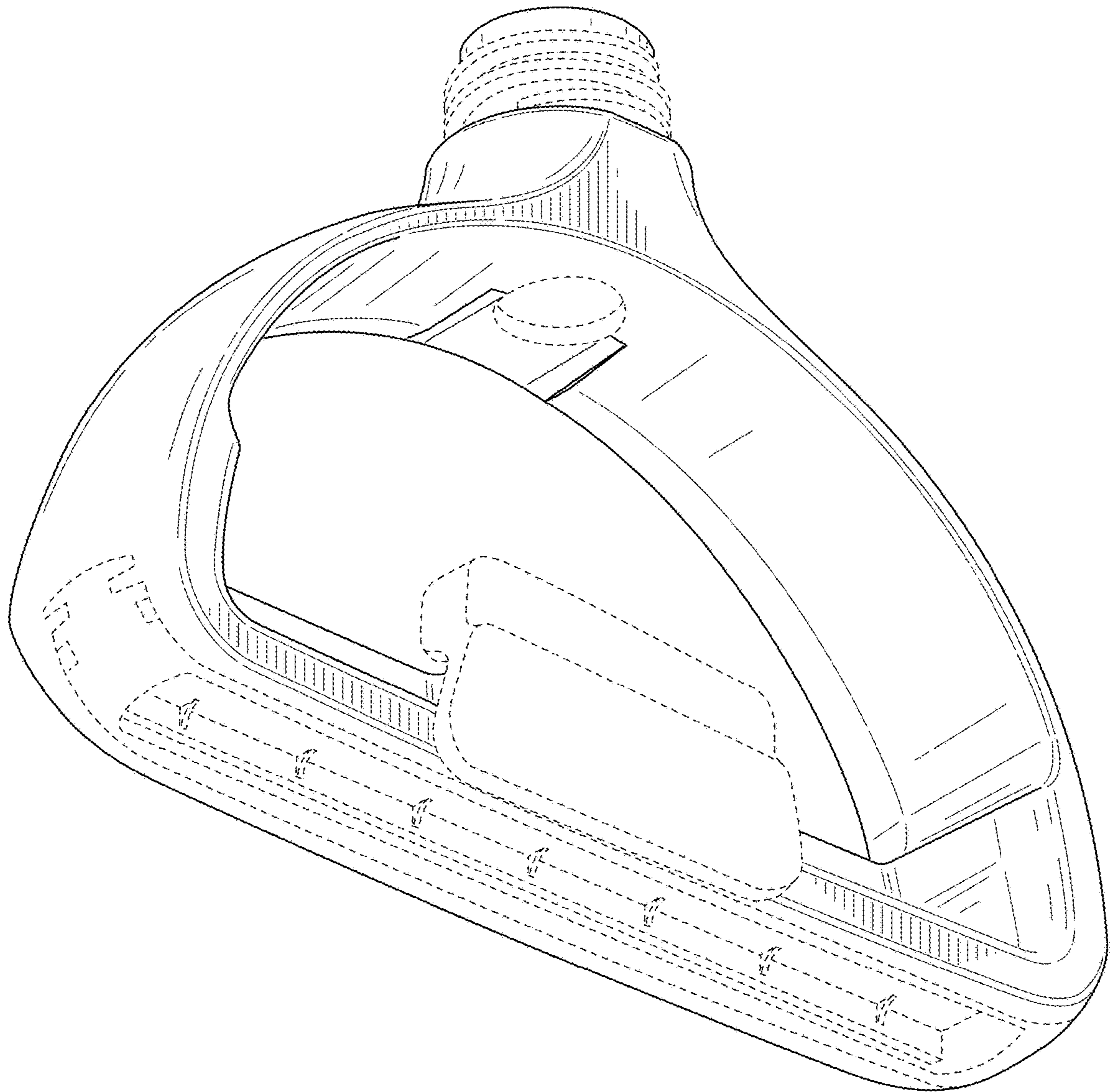

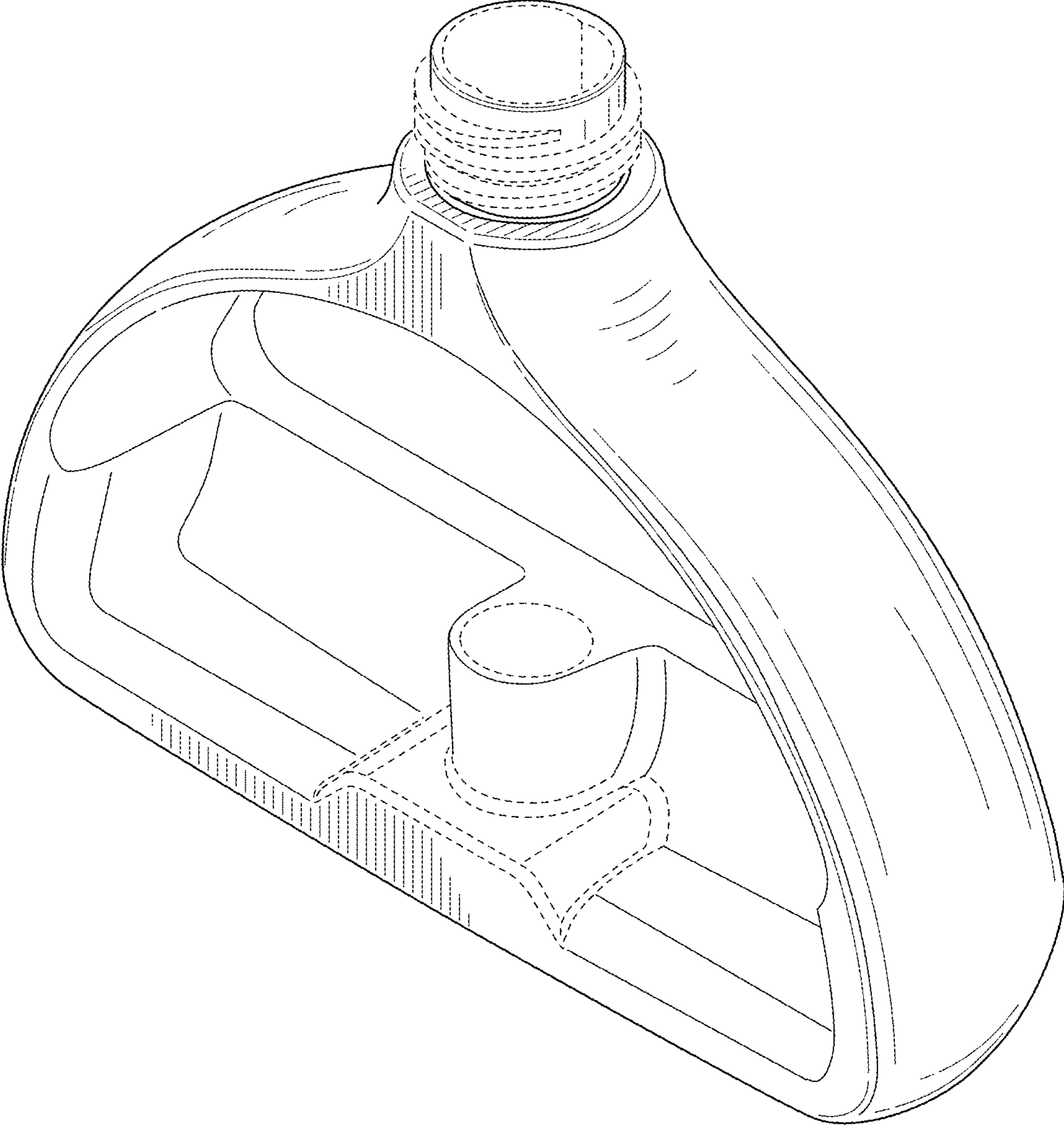

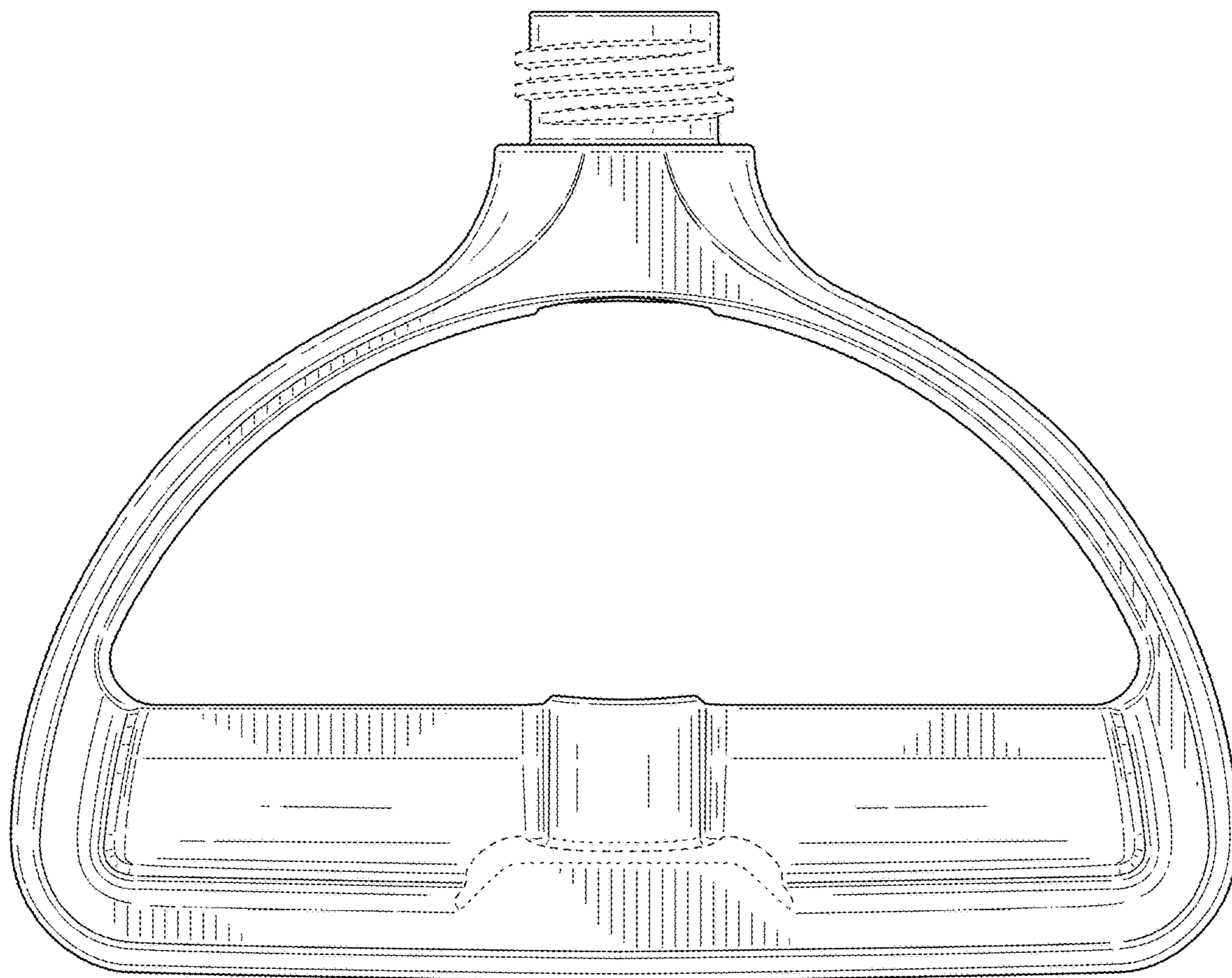

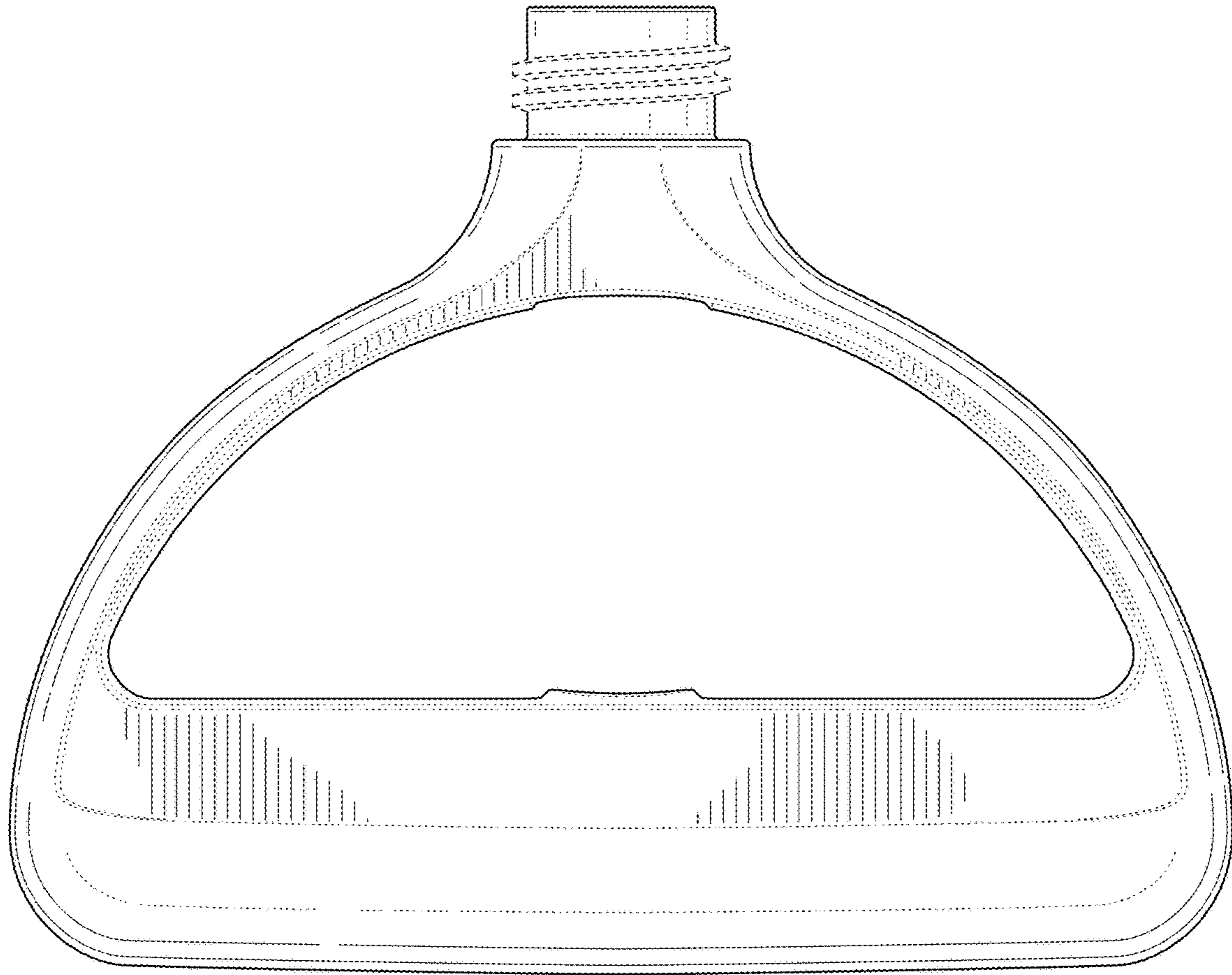

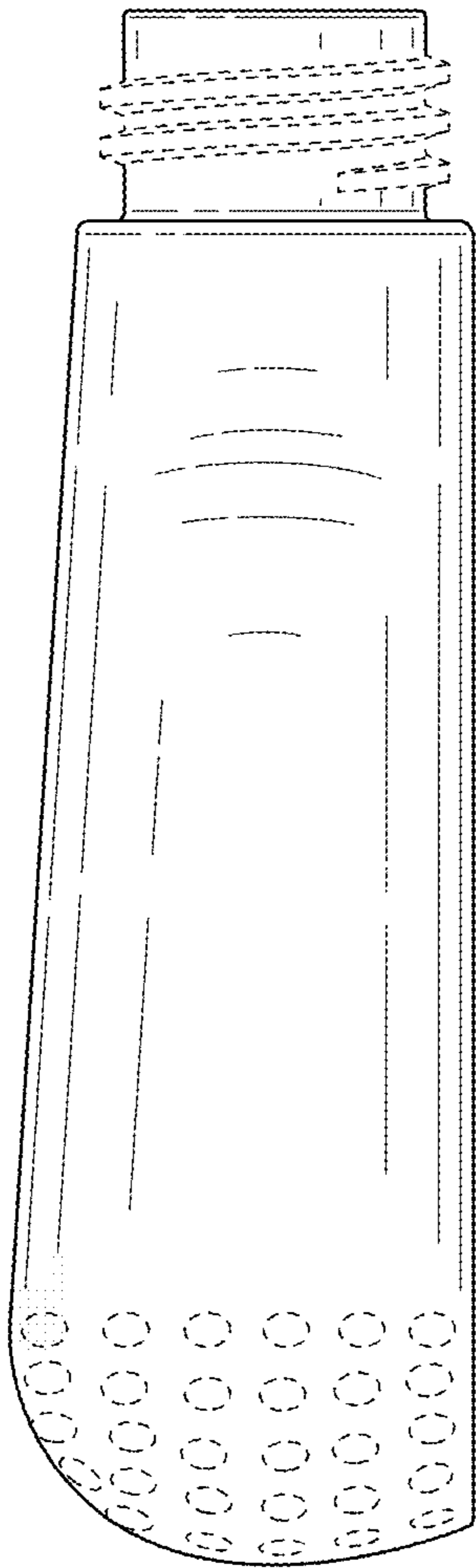

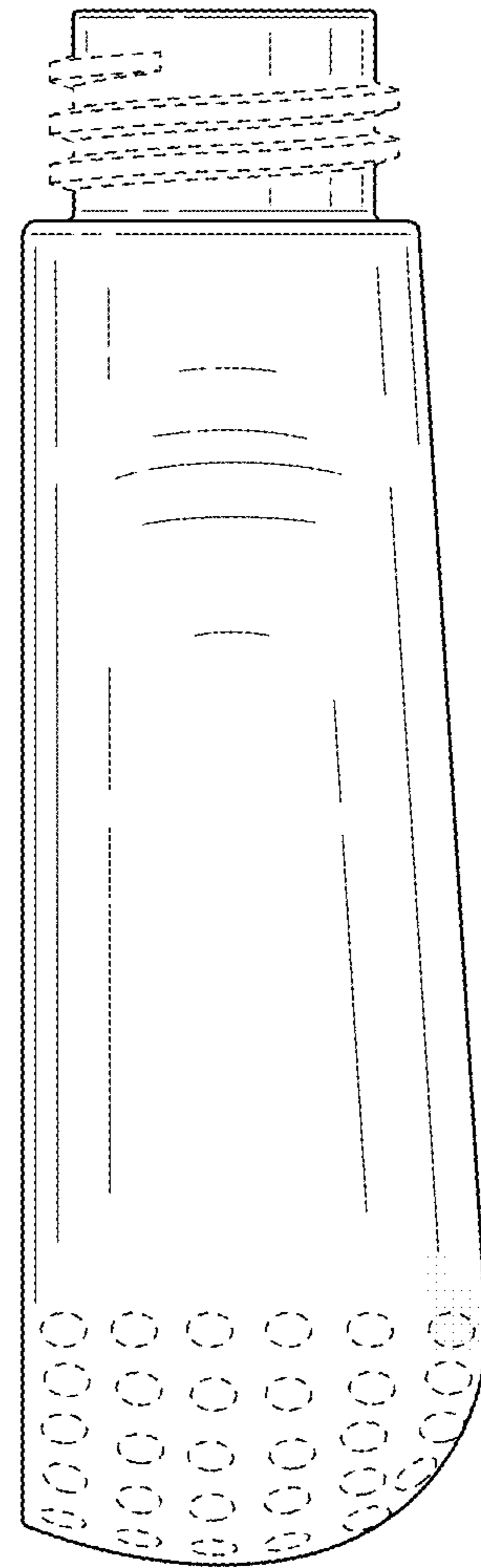

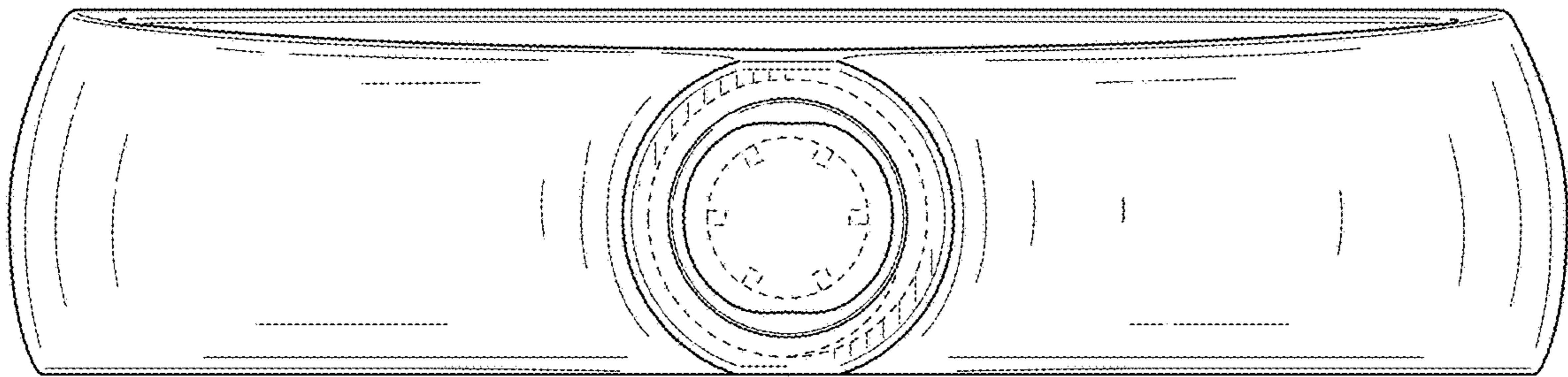

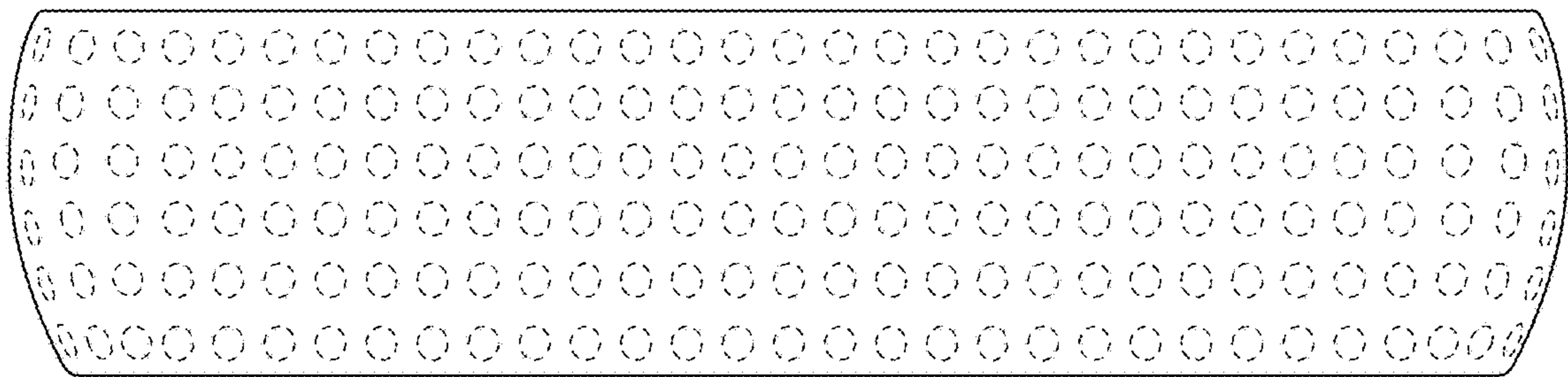
