FIG. 5 illustrates a left side view of the sports bra shown in FIG. 1.

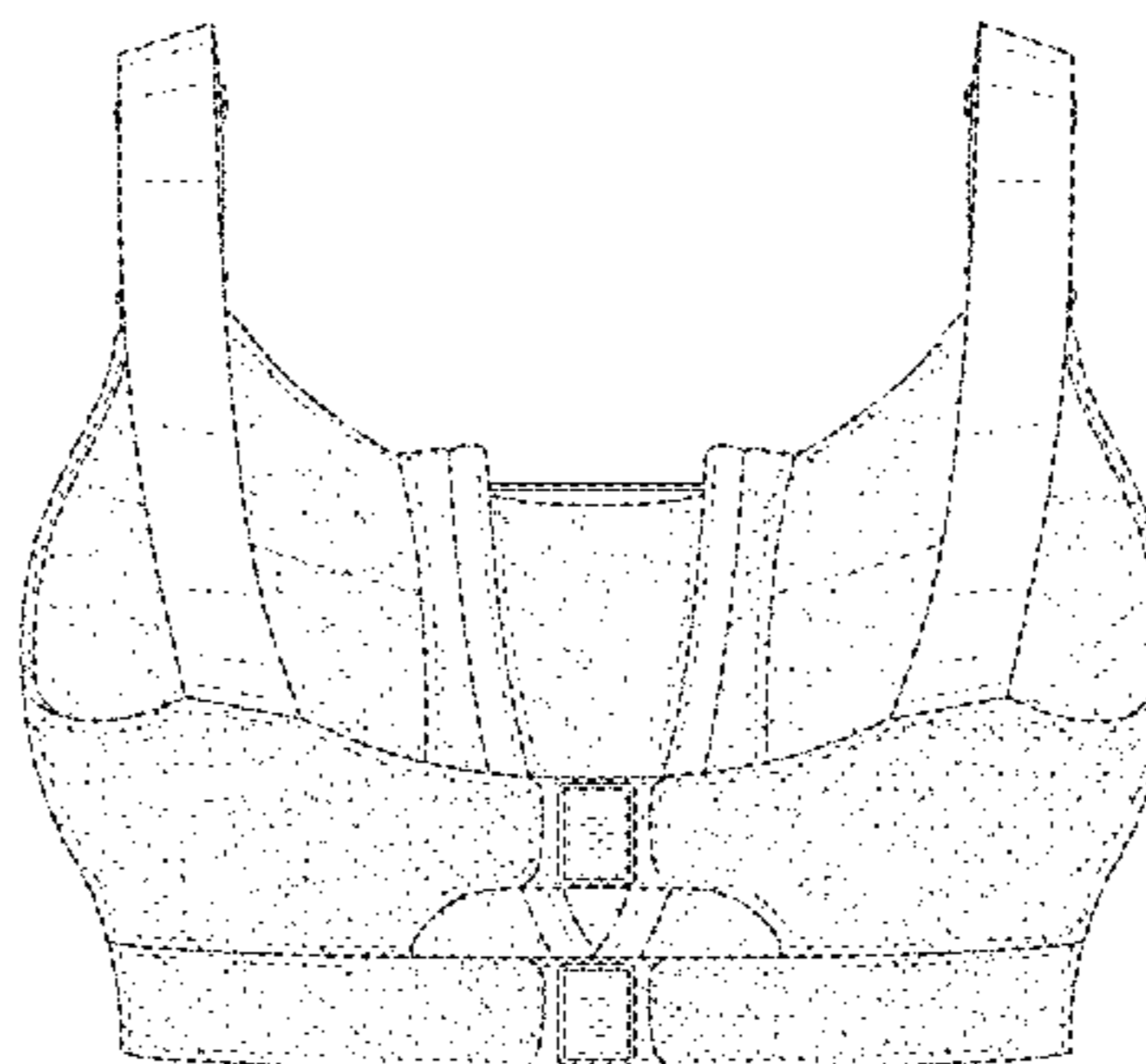
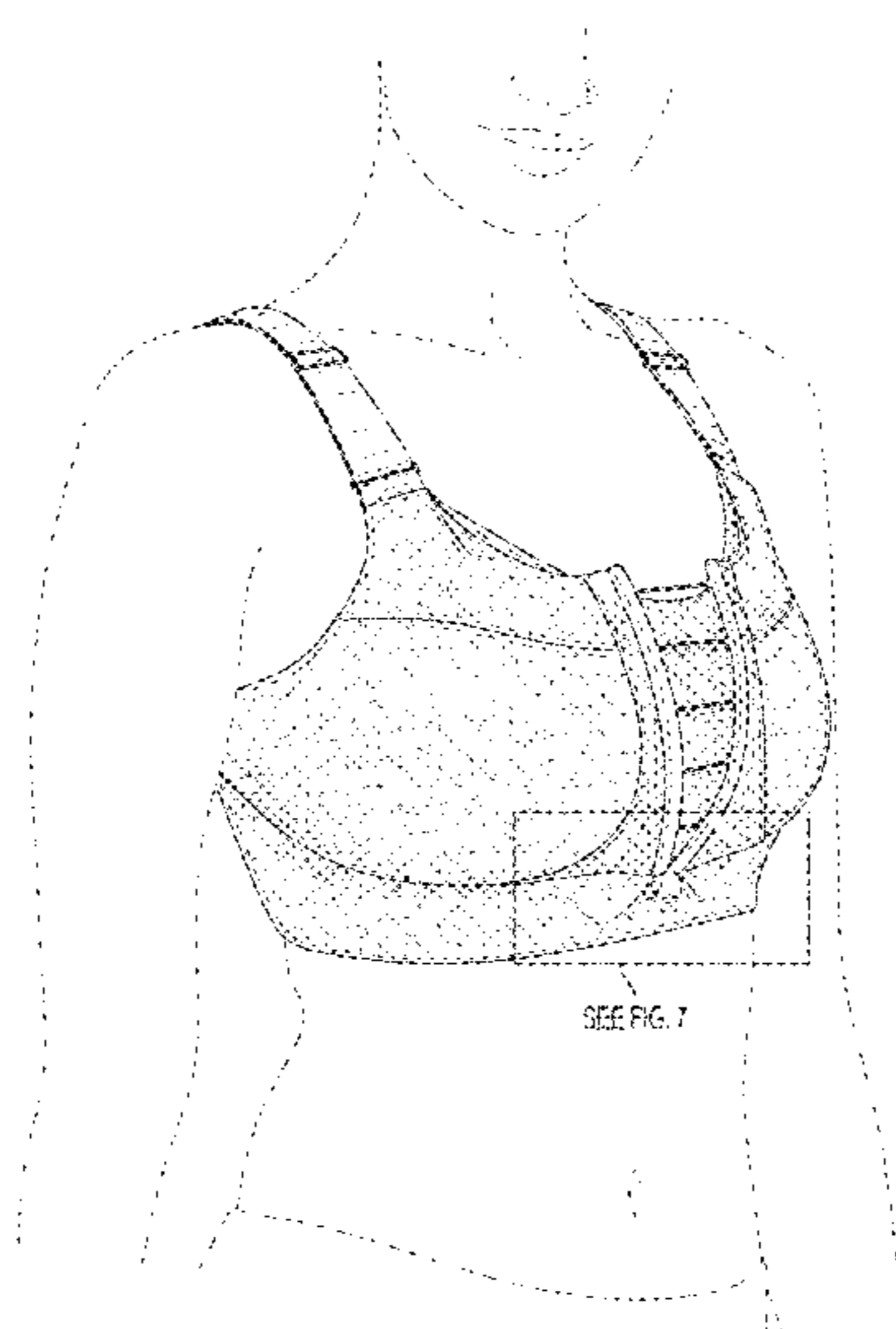
FIG. 6 illustrates a top view of the sports bra shown in FIG. 1.

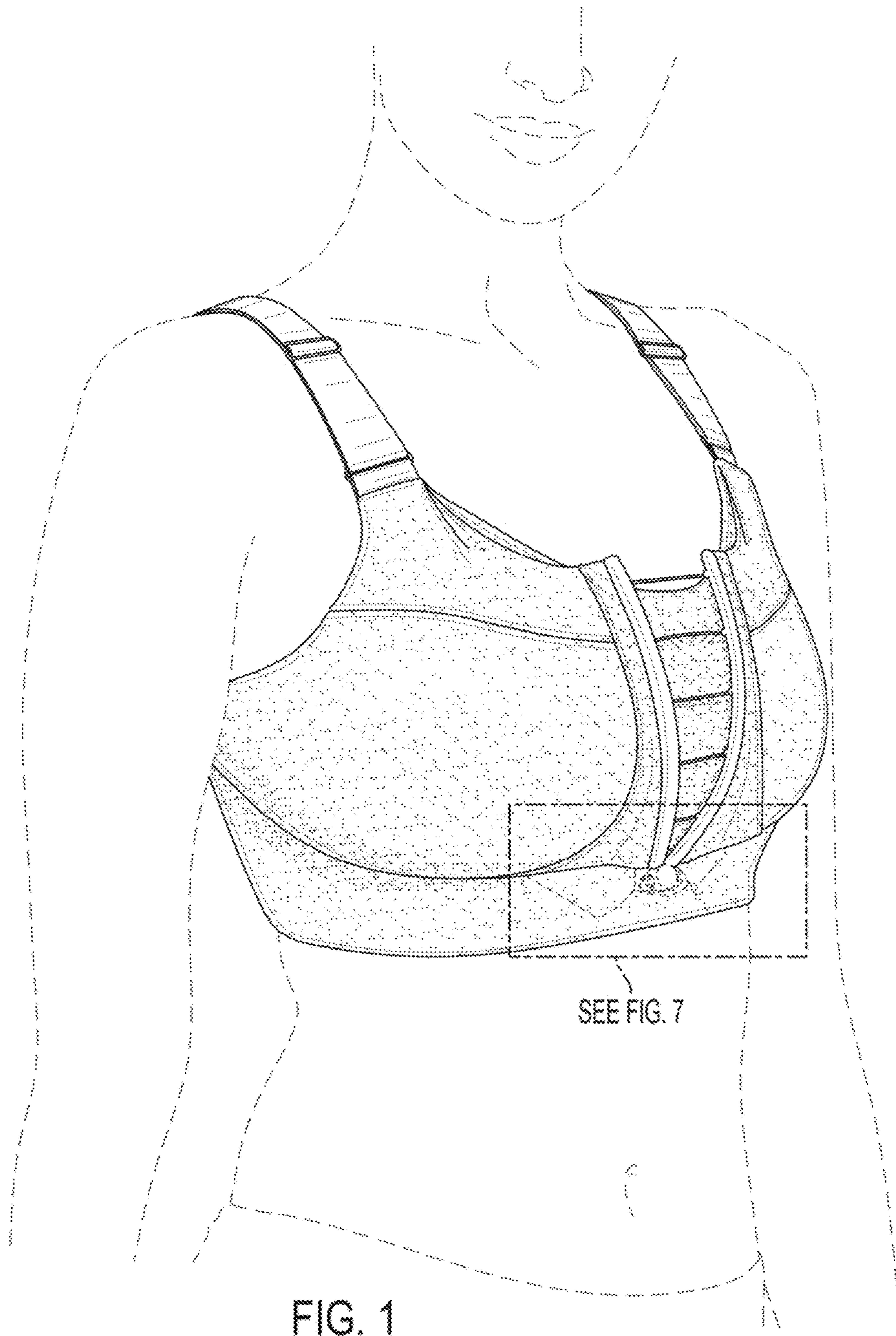
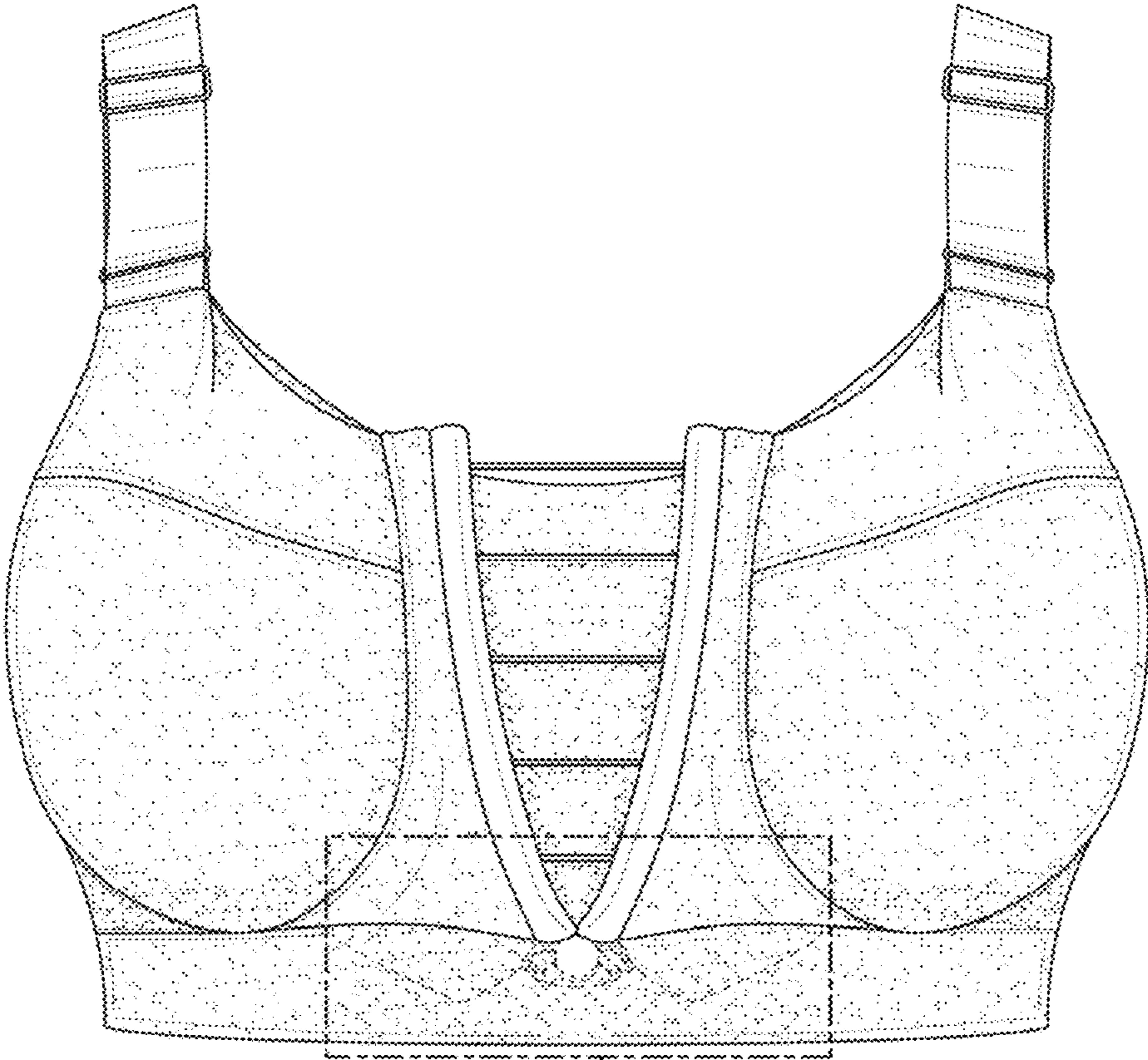

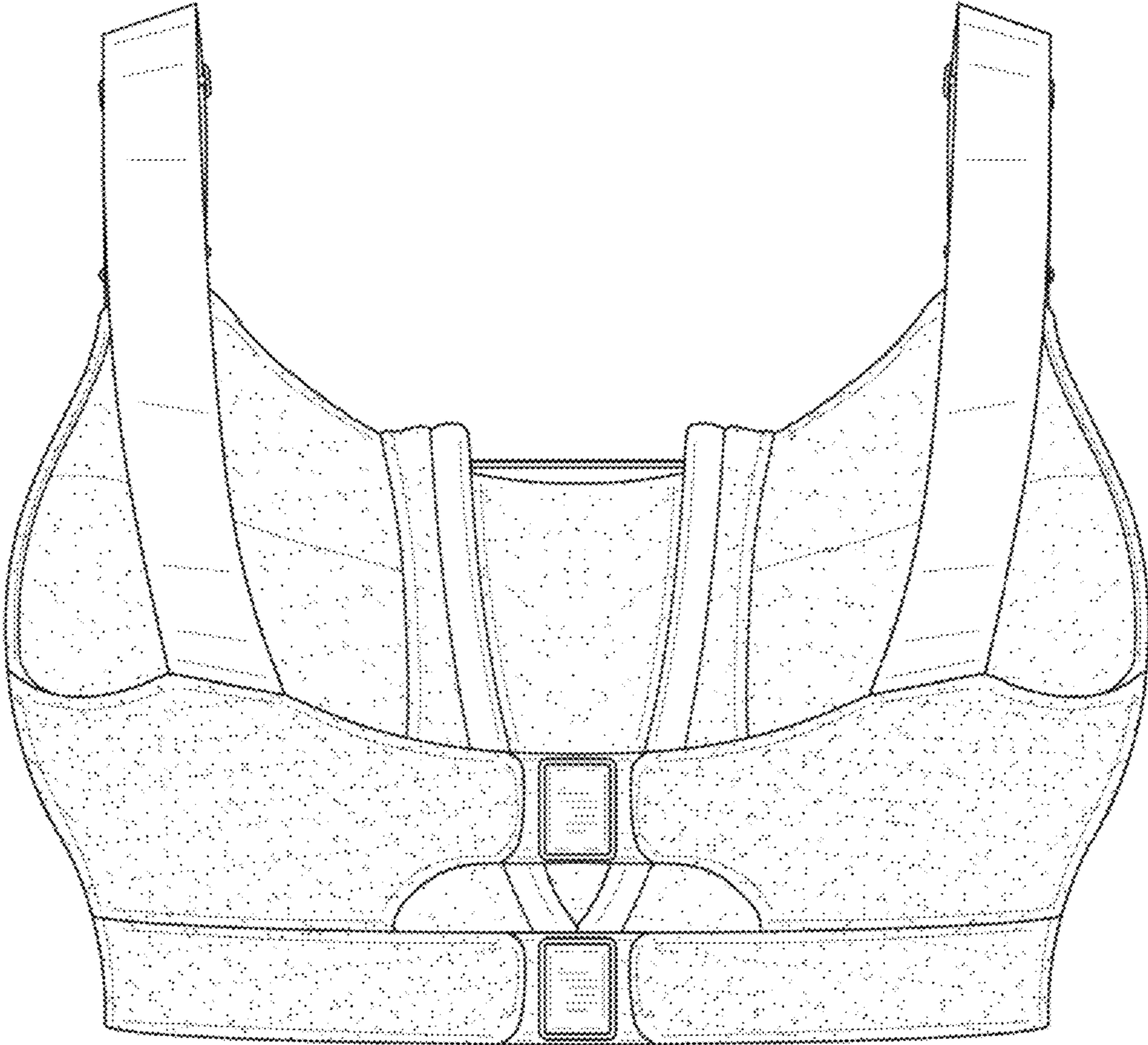

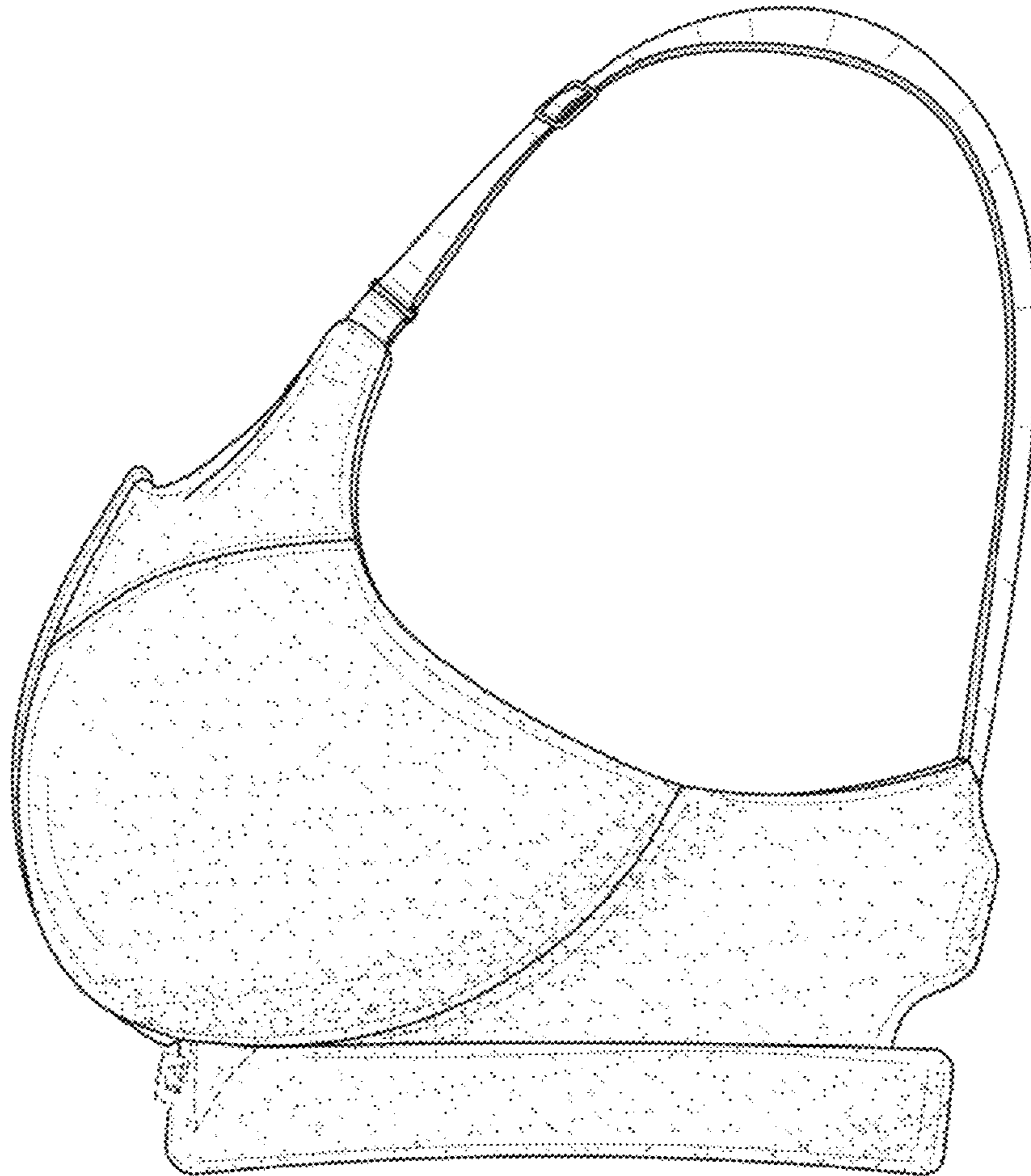

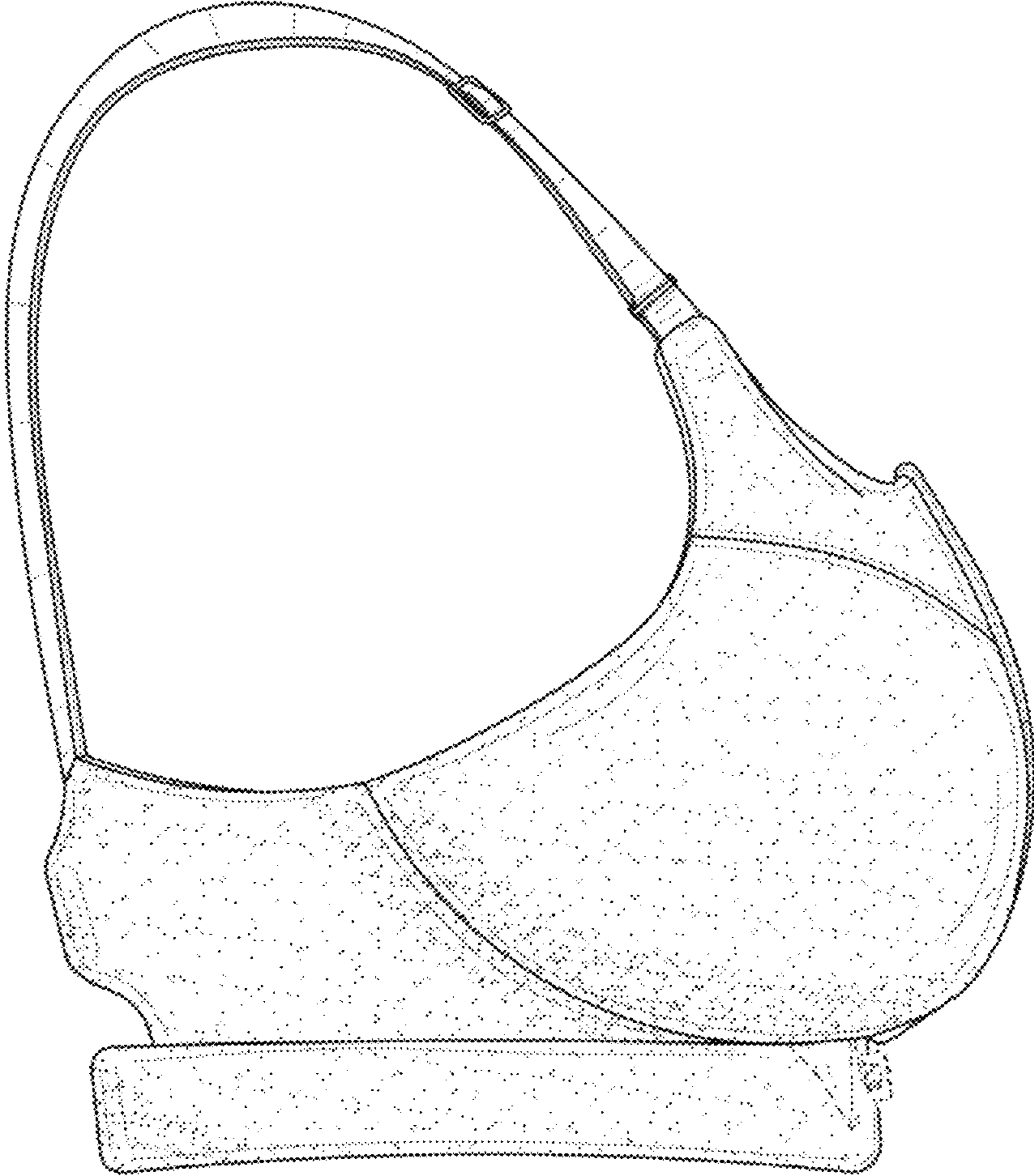

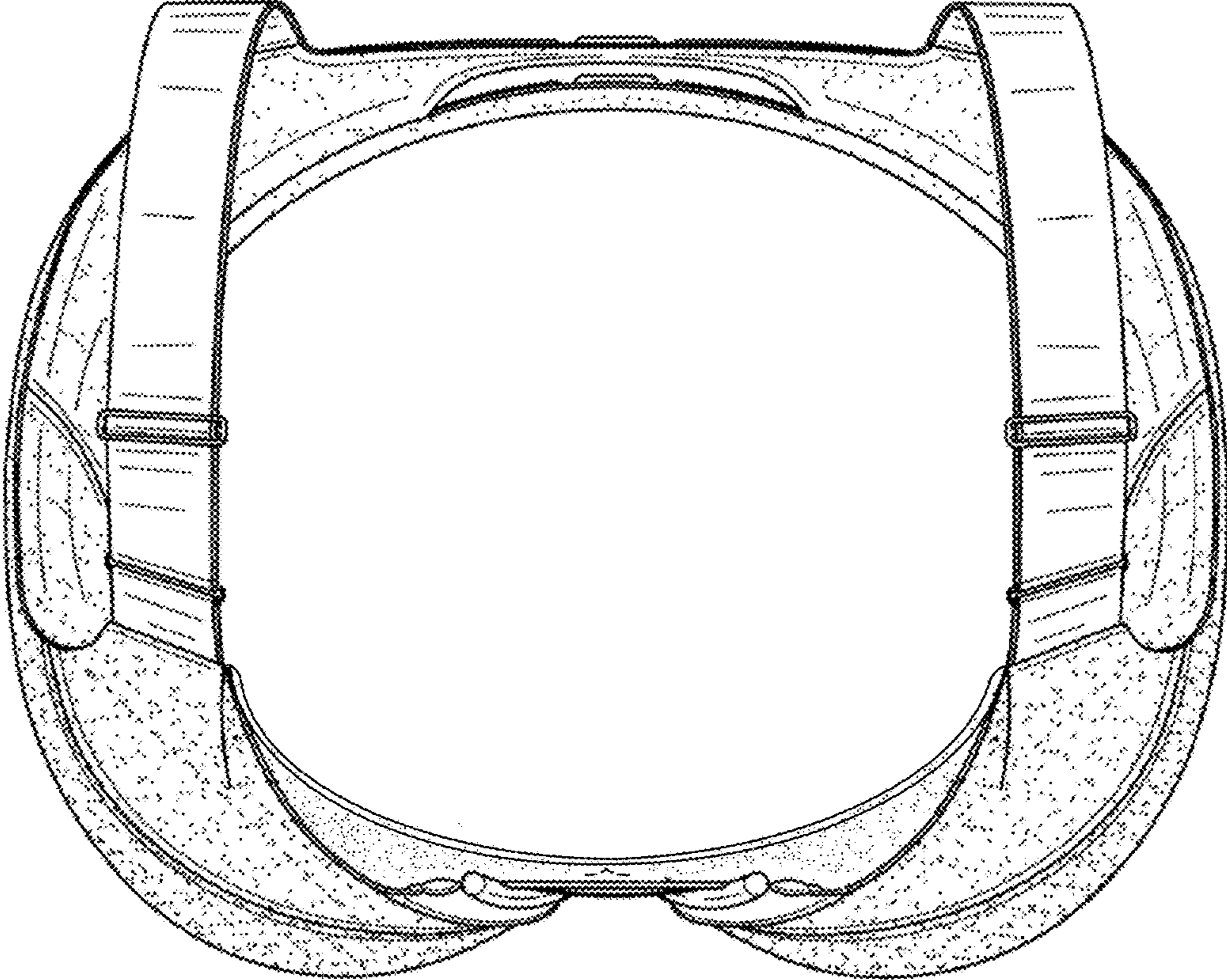

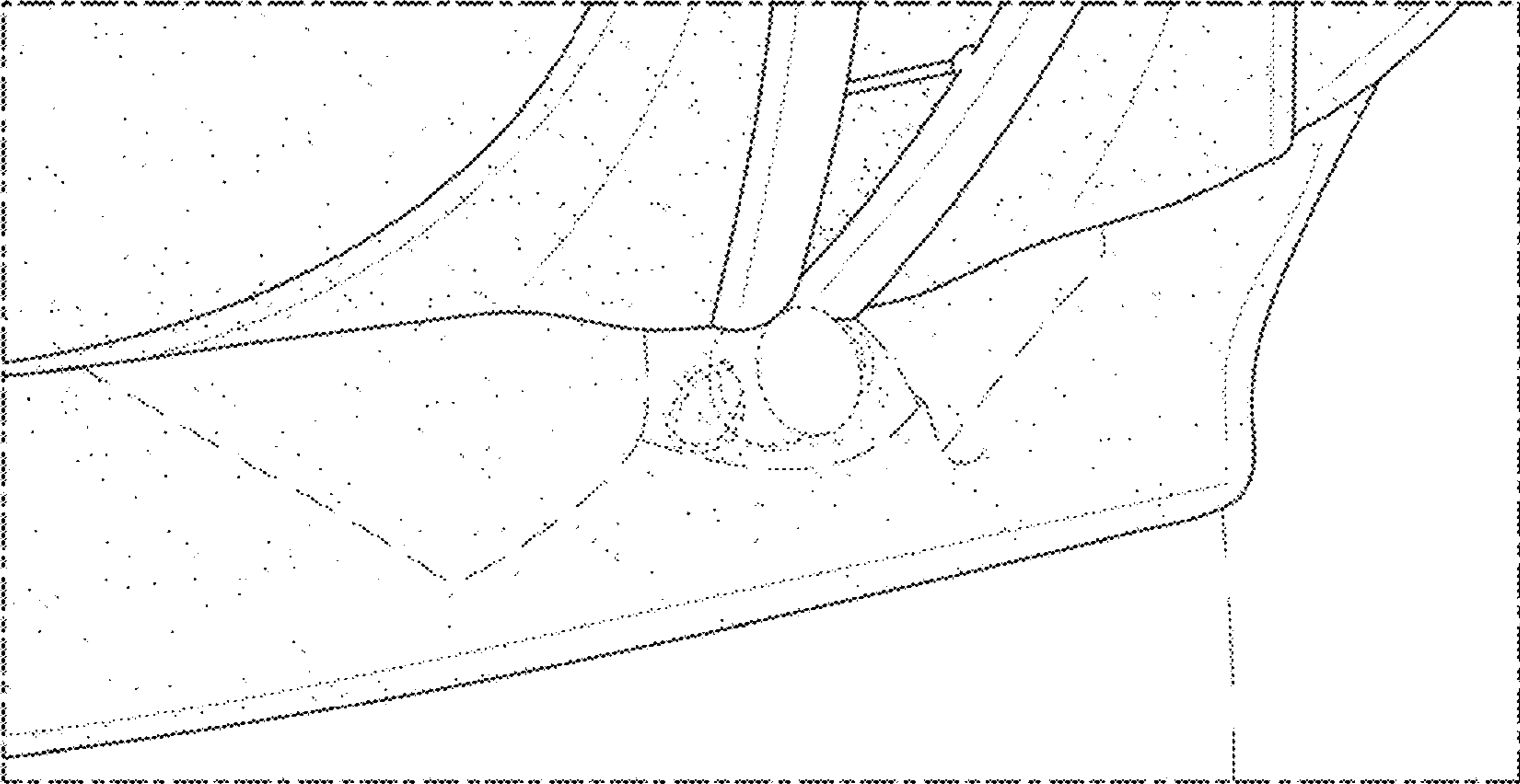

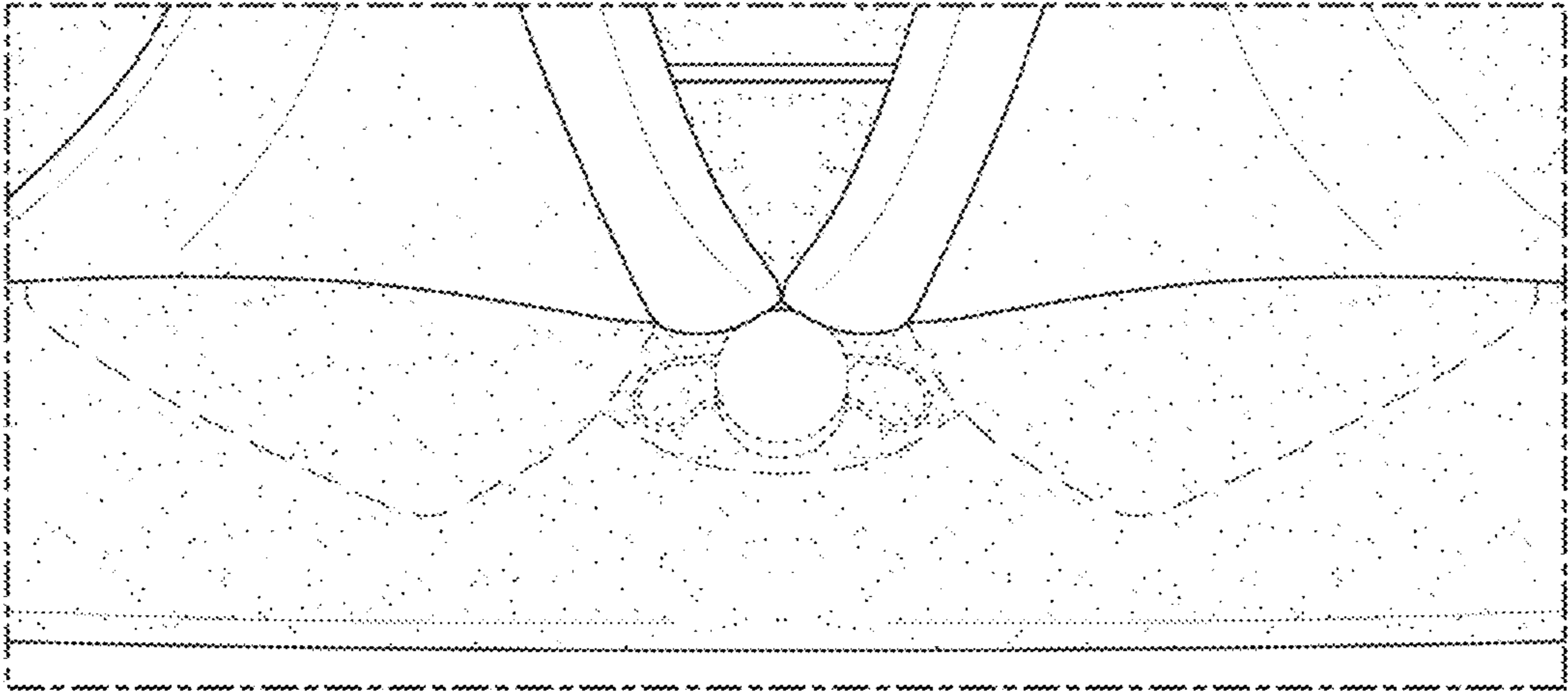
