DESCRIPTION

FIG. 1 is a perspective view of left and right breast support members showing our new design;

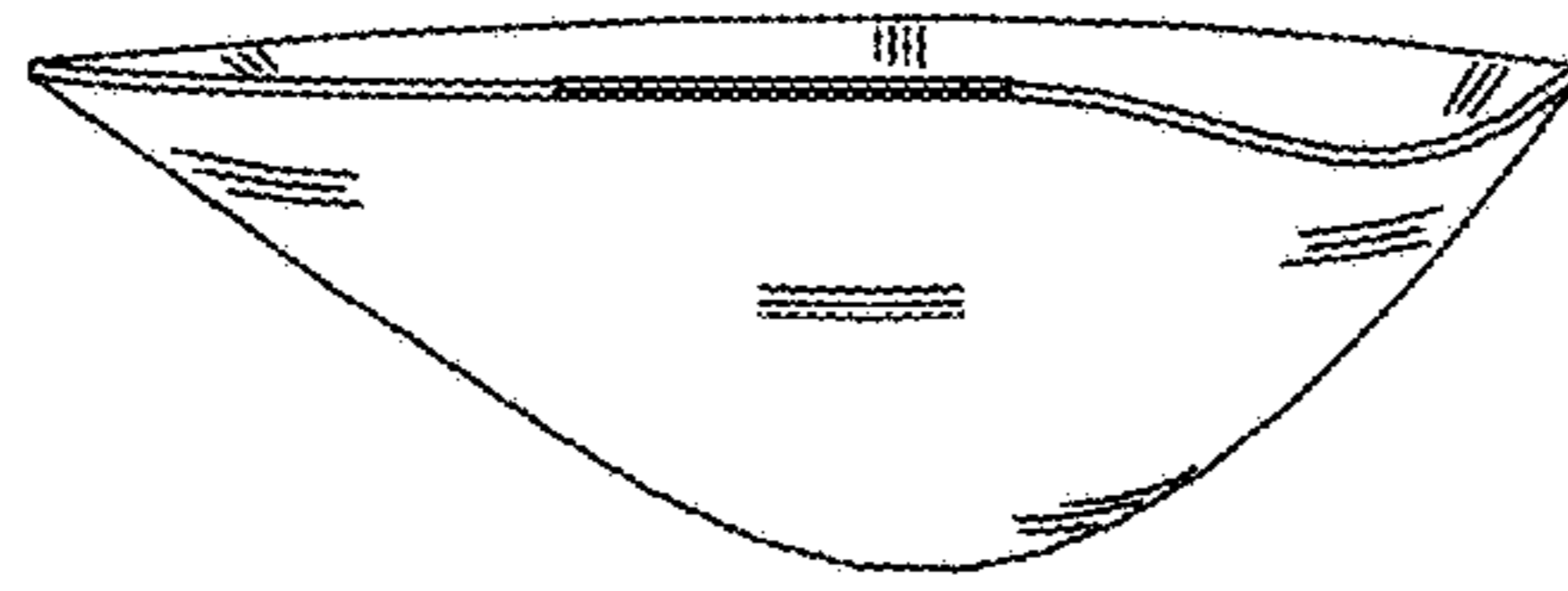

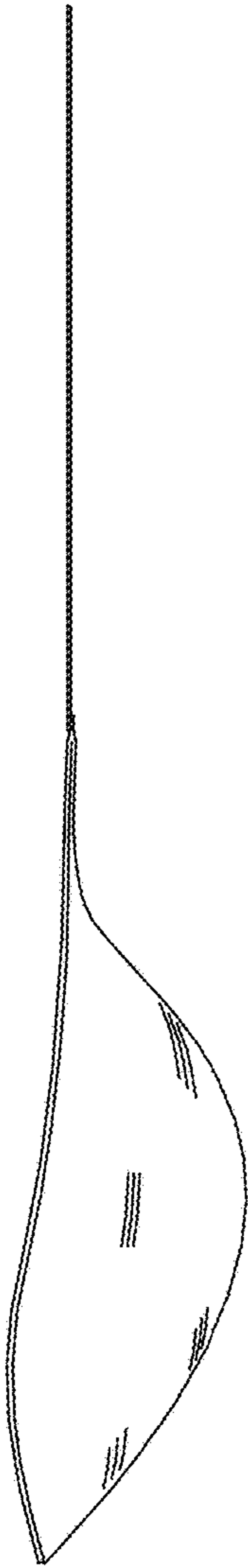

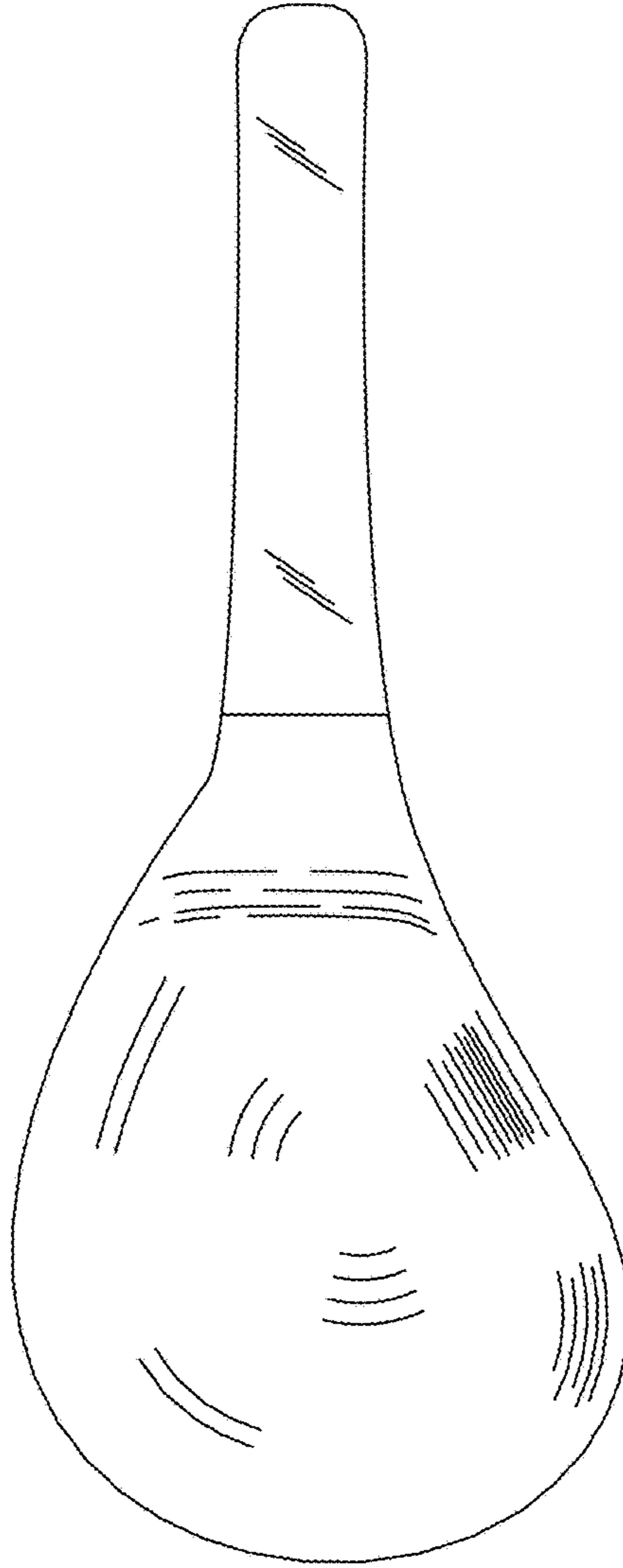

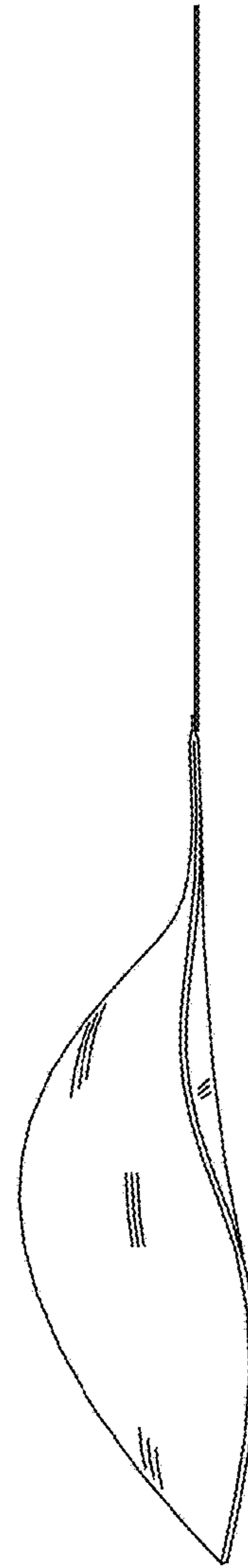

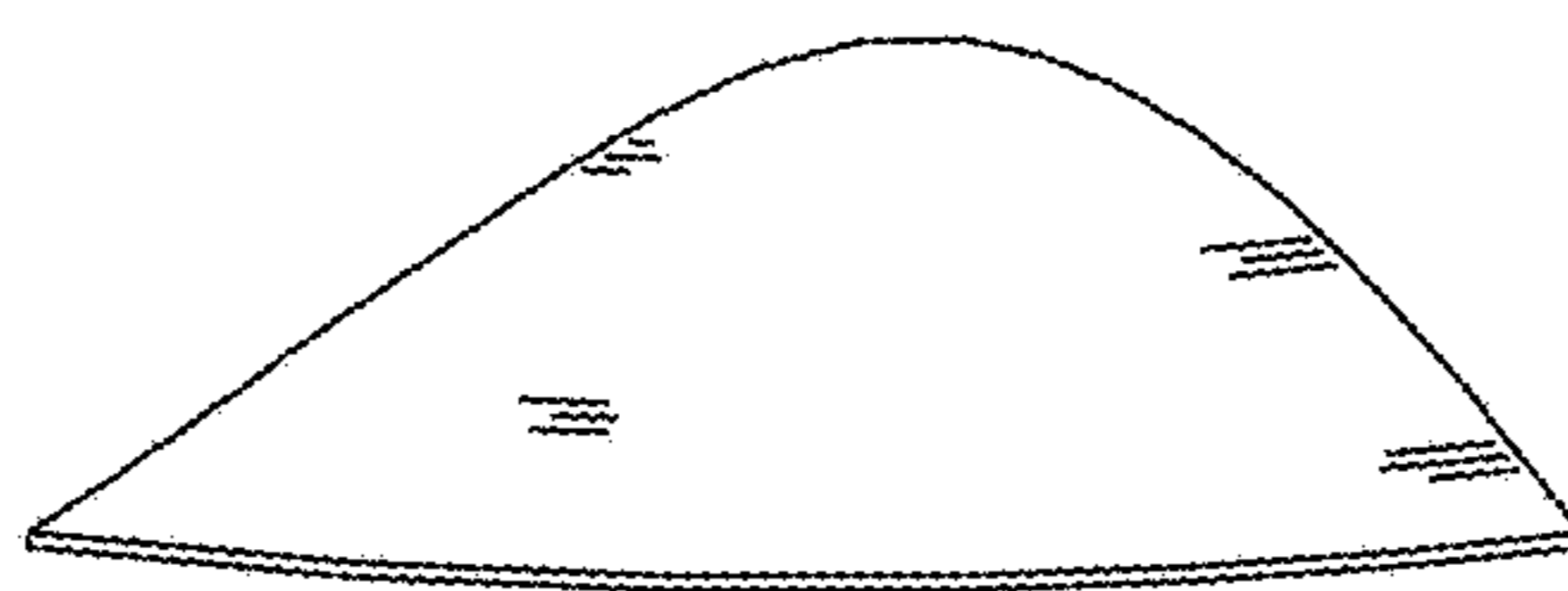

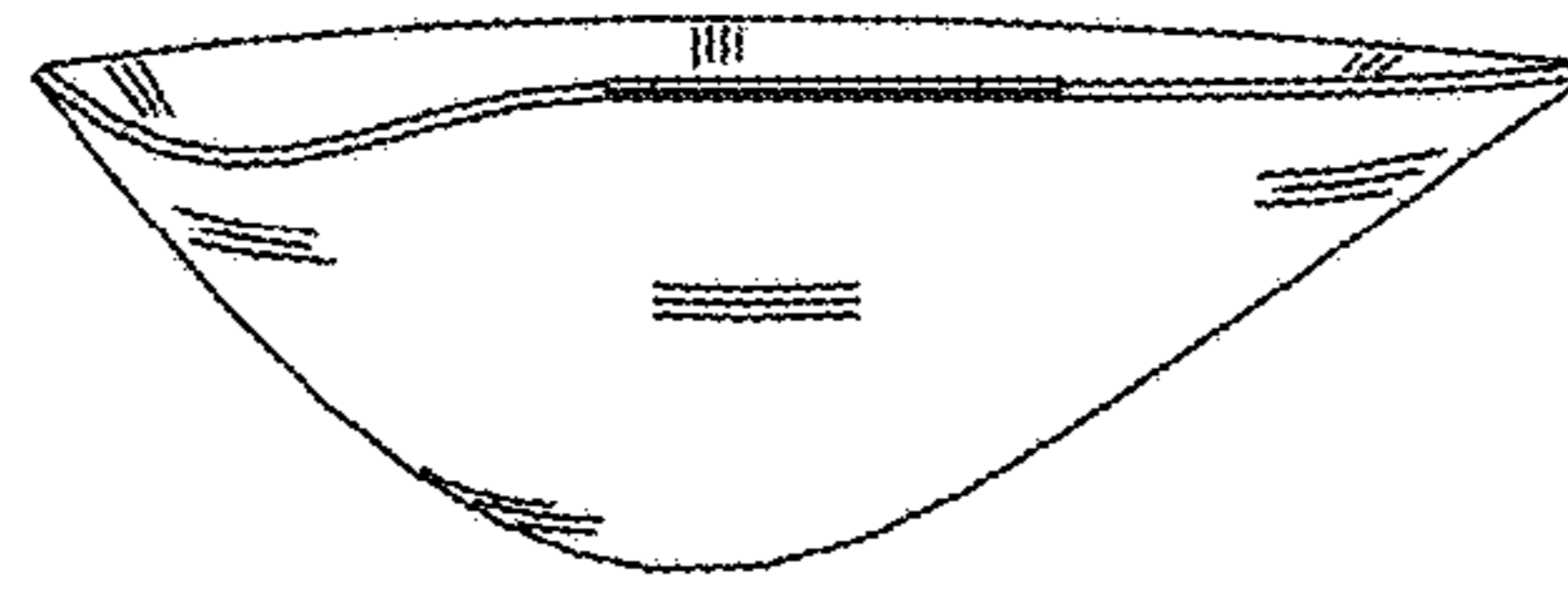

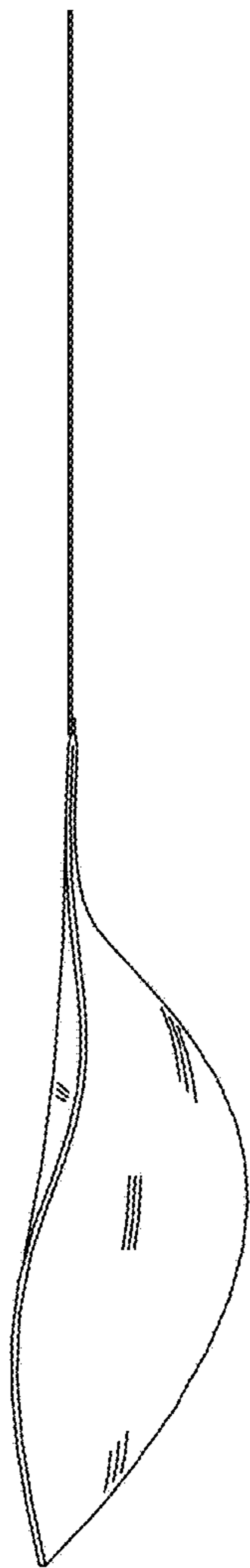

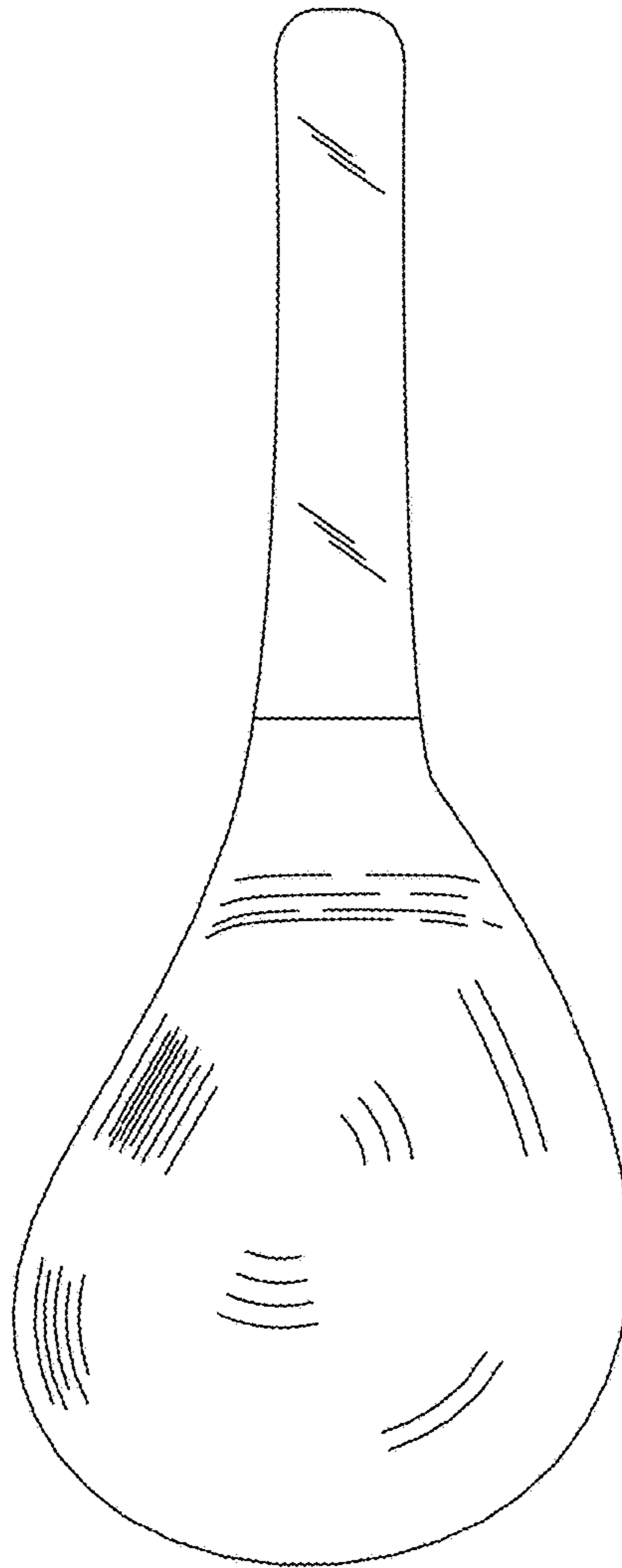

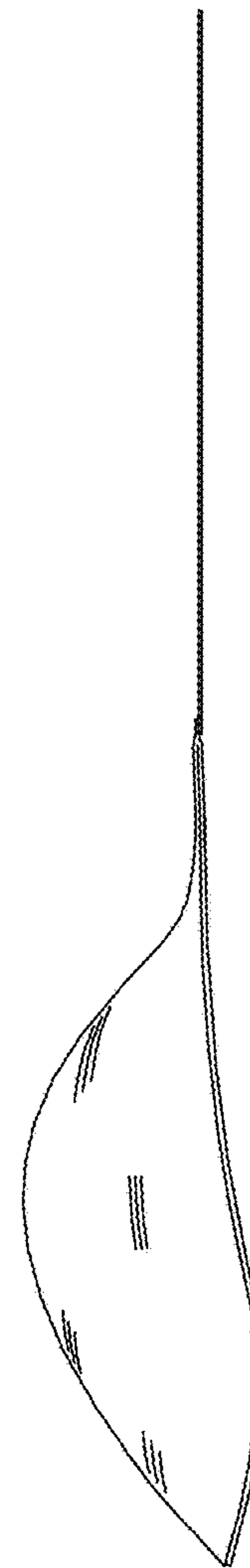

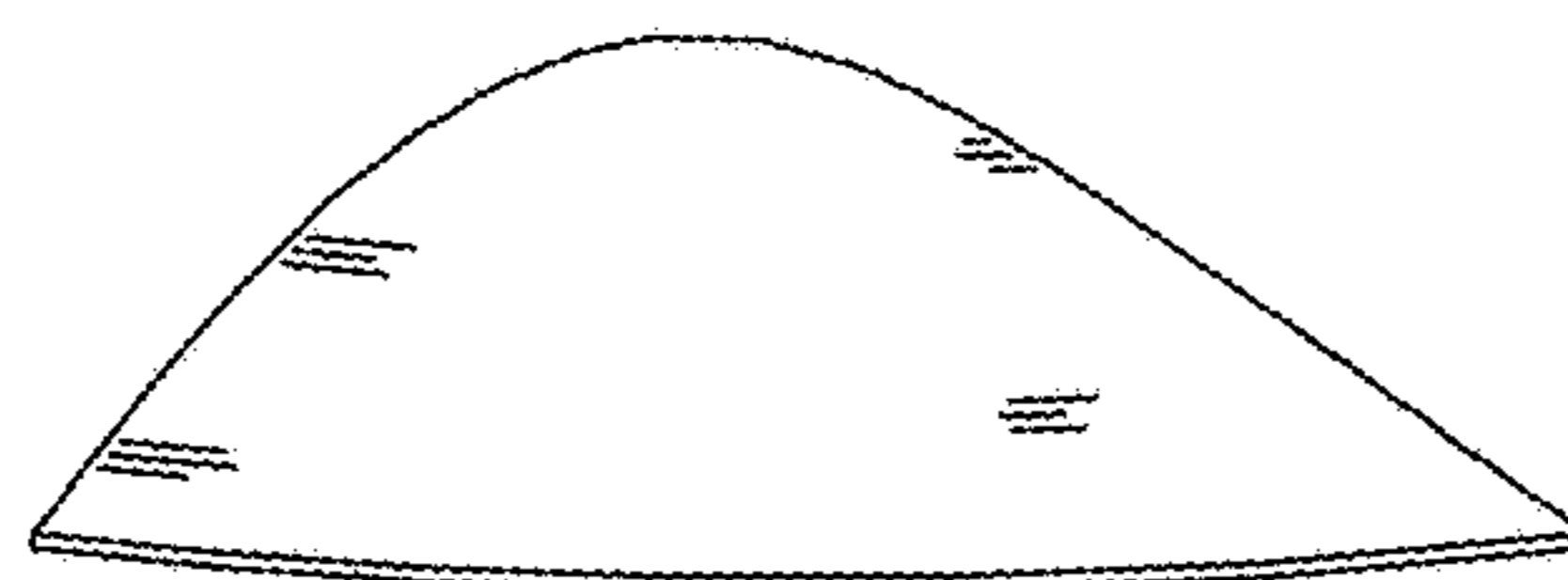

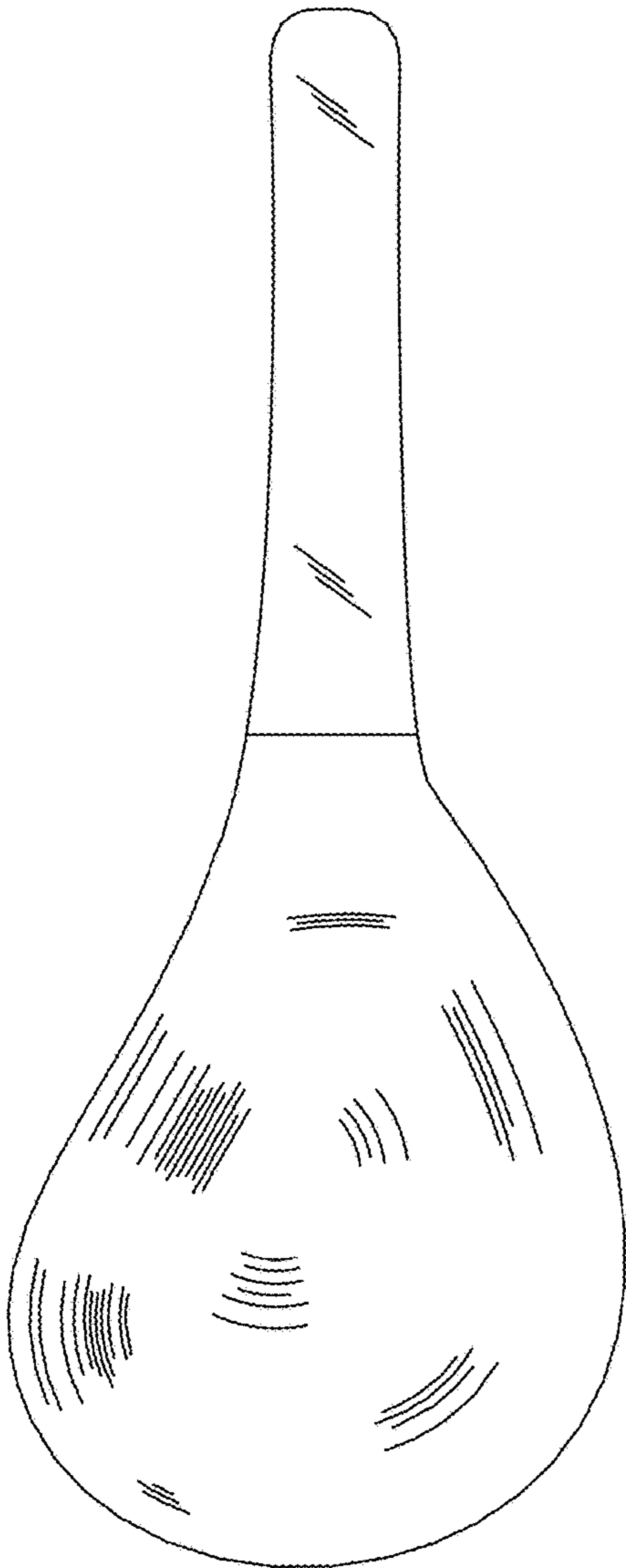

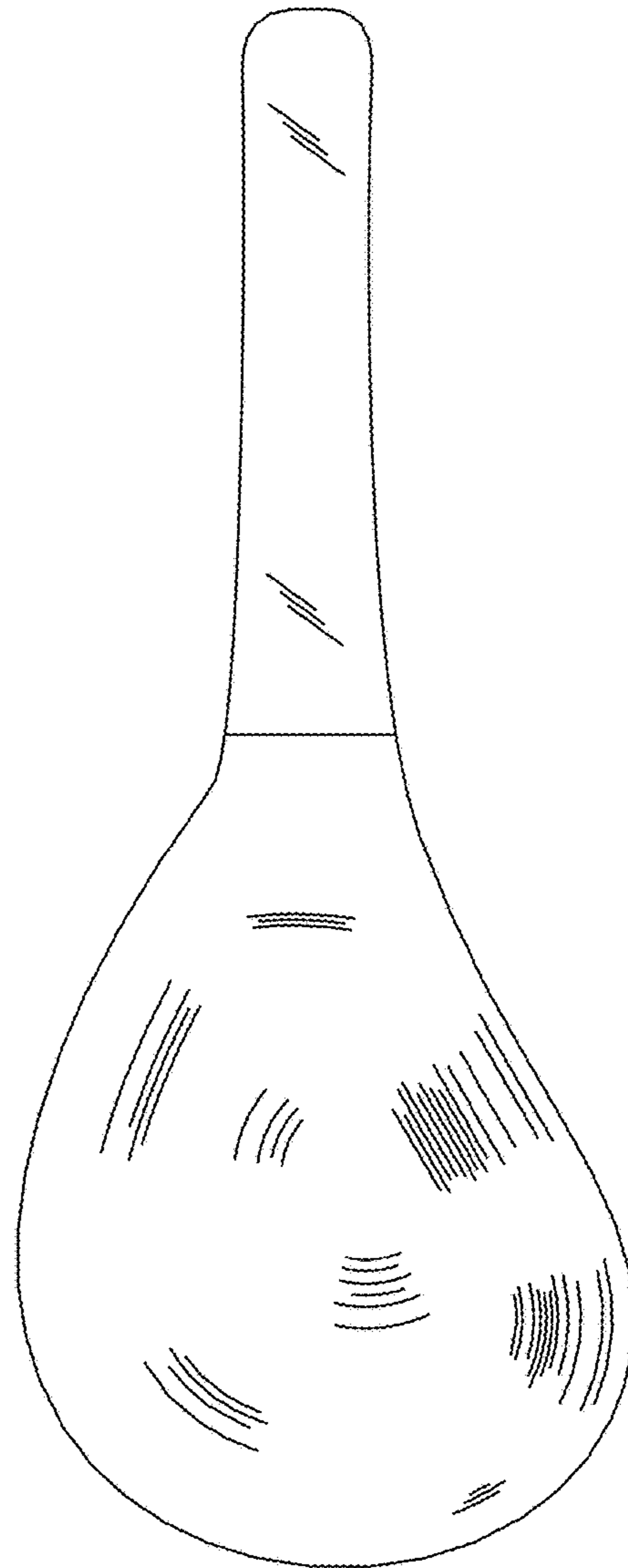
