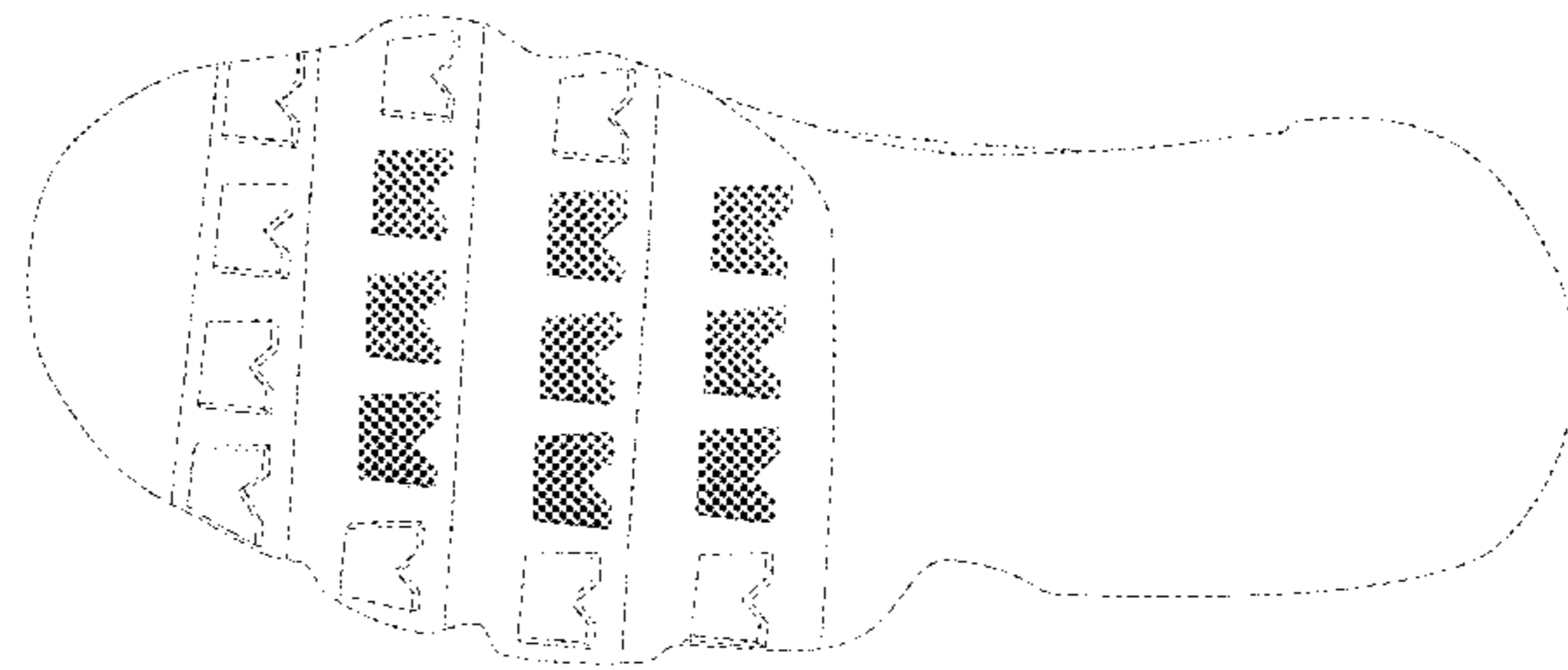
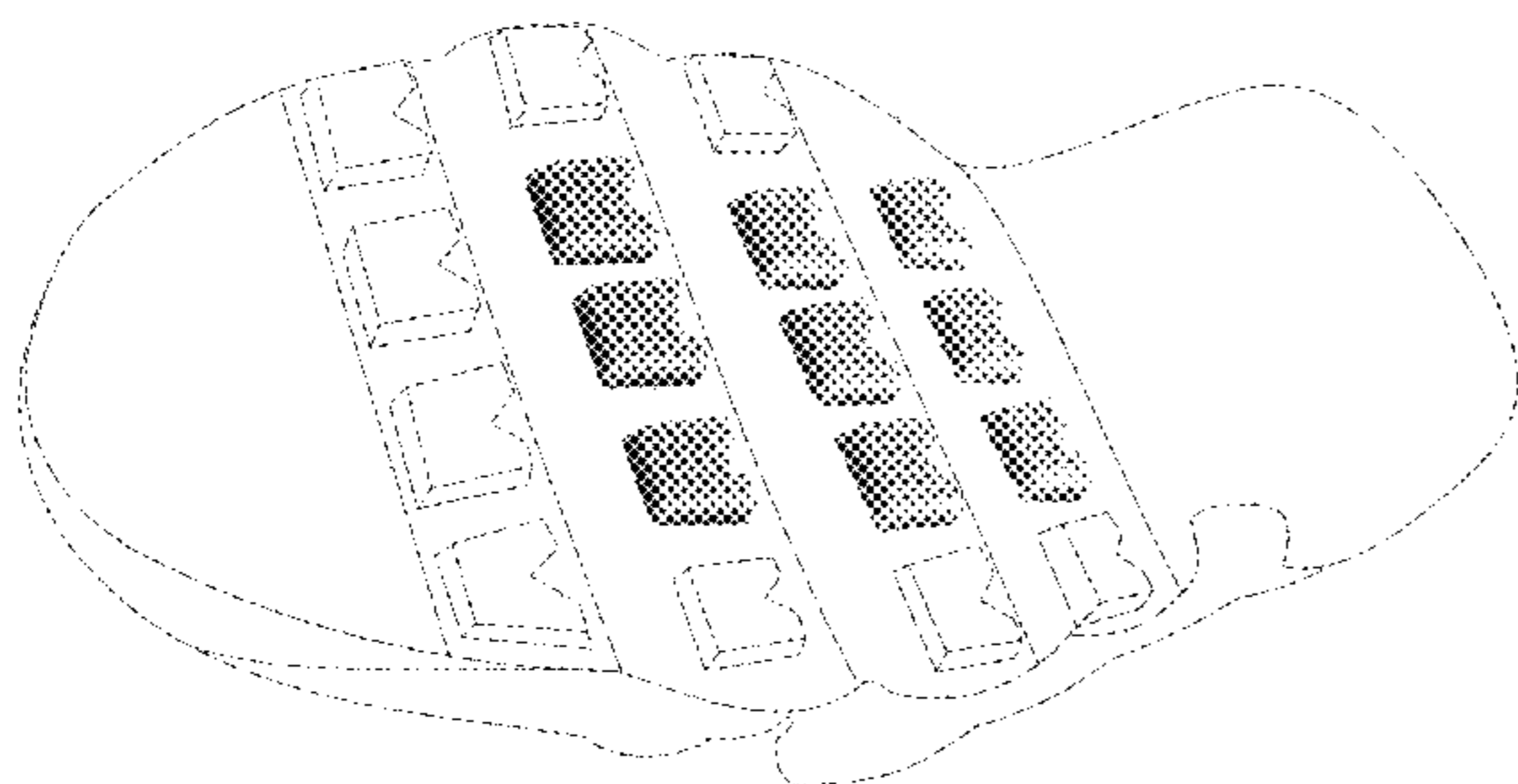
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
FIG. 2 is an opposite side front perspective view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a rear perspective view thereof; and,
FIG. 5 is an opposite side rear perspective view thereof.
Photographic areas are shown in the drawings. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

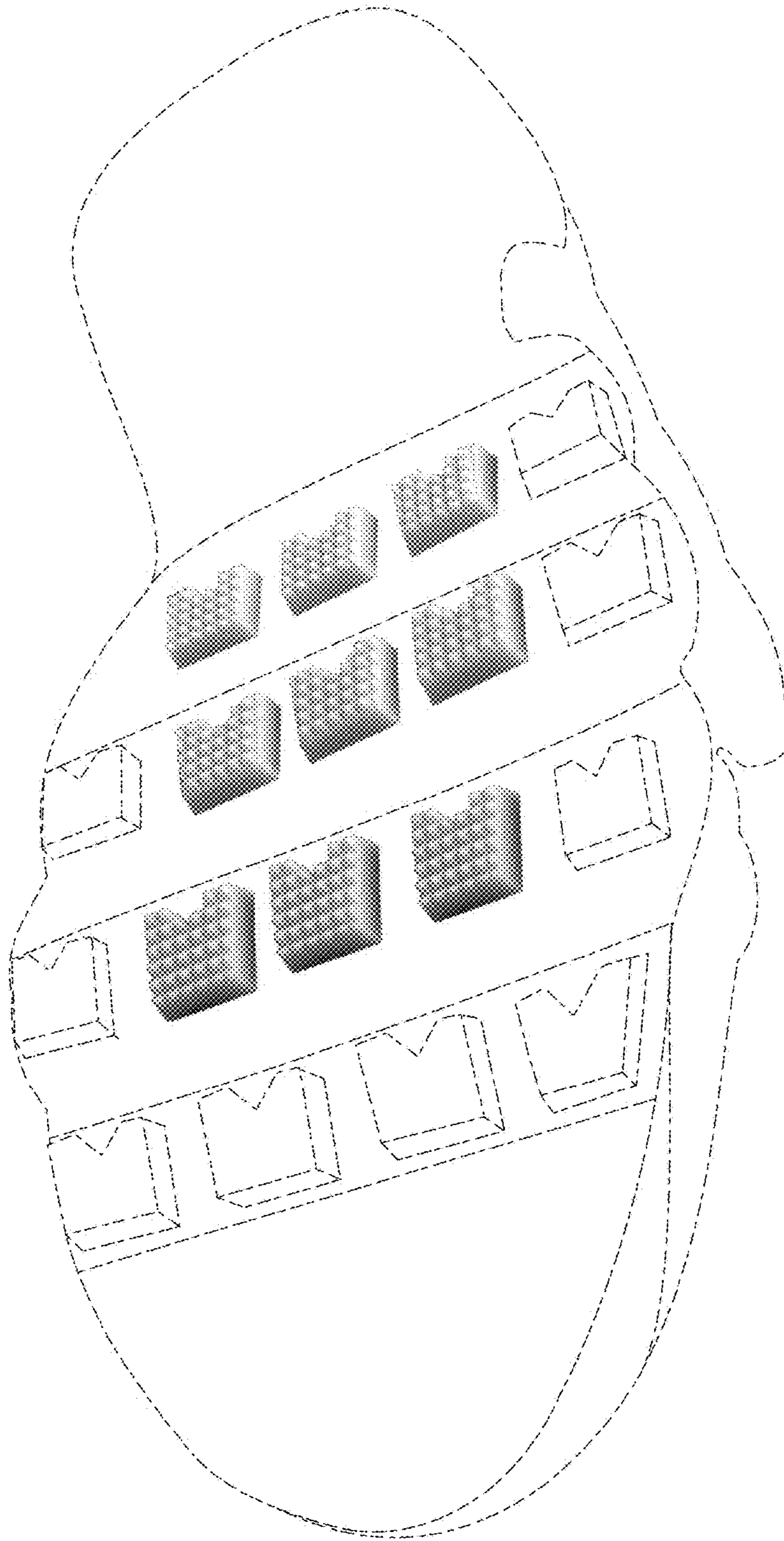

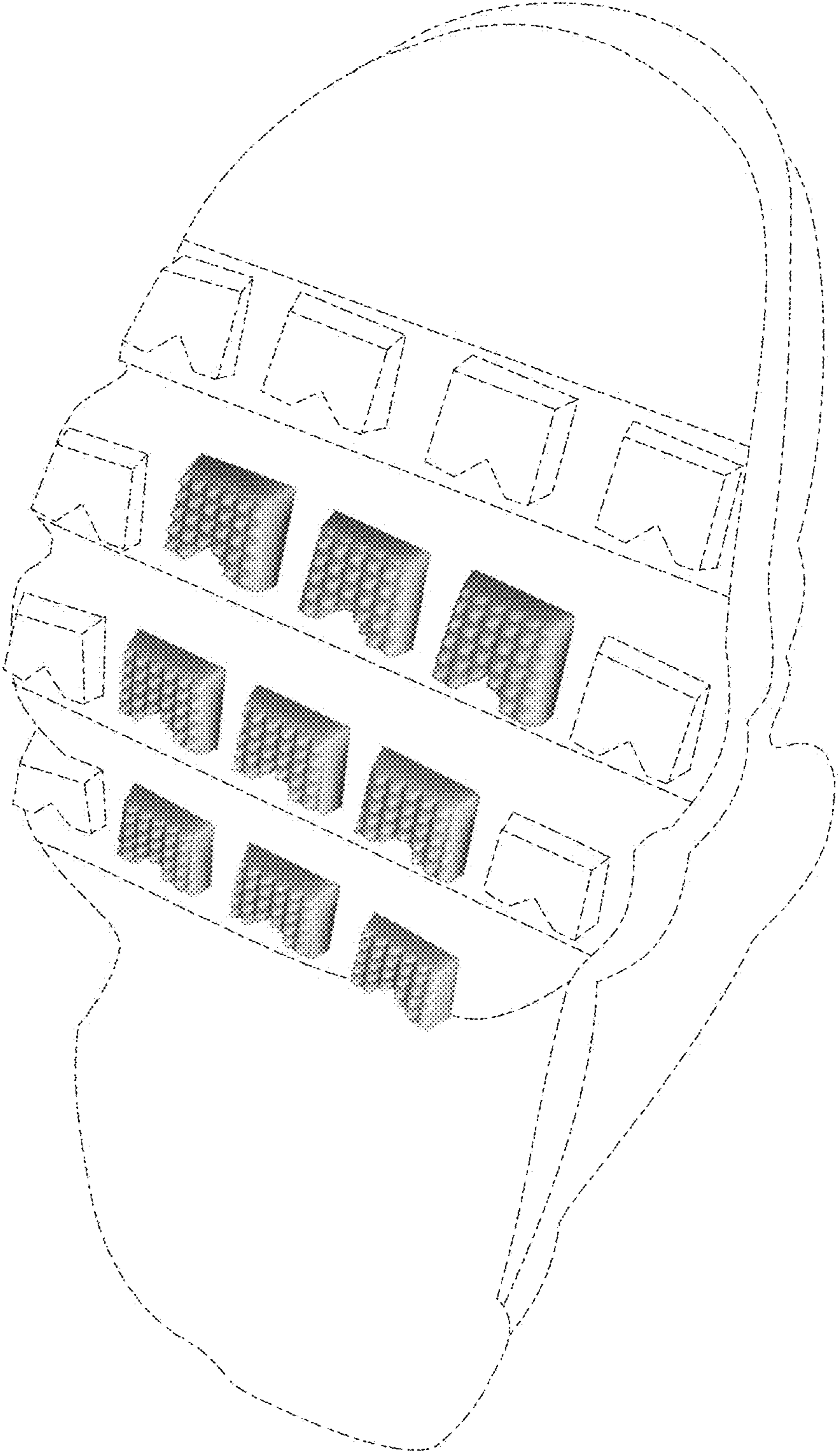

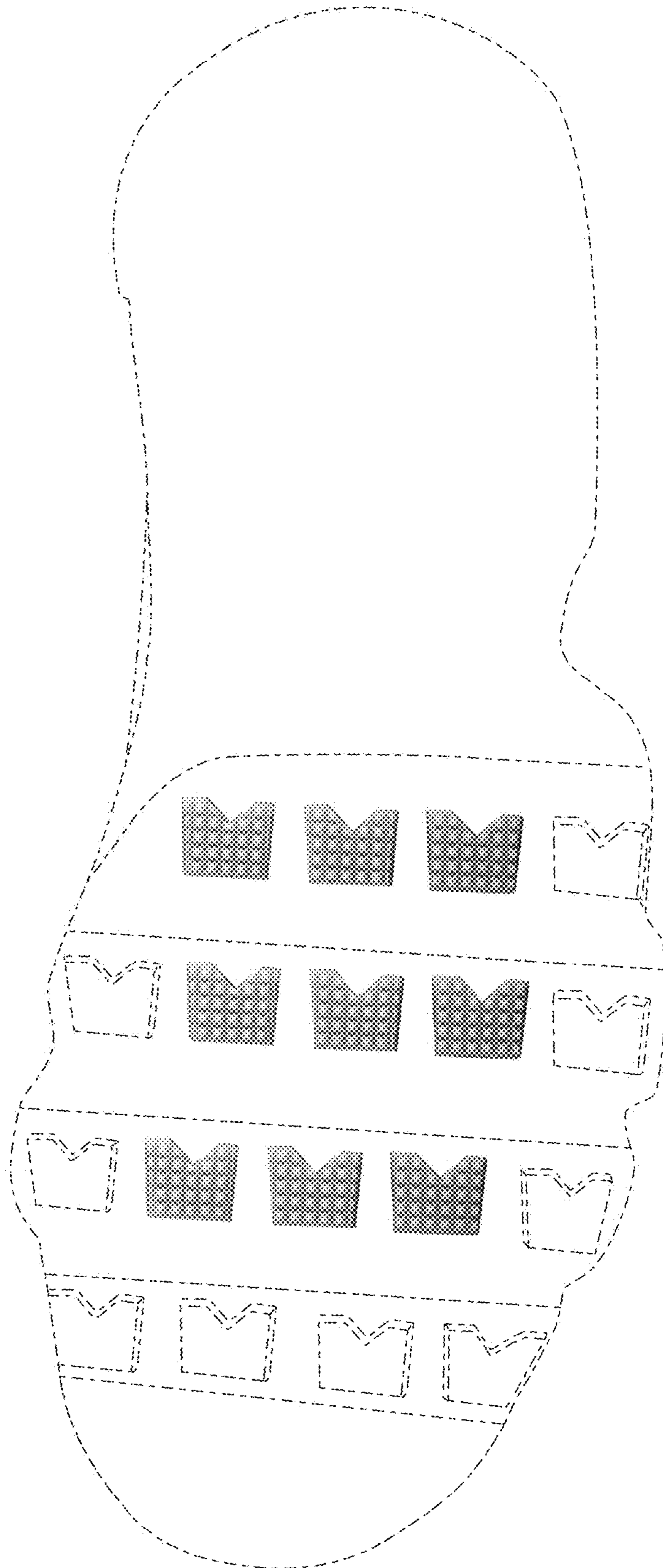

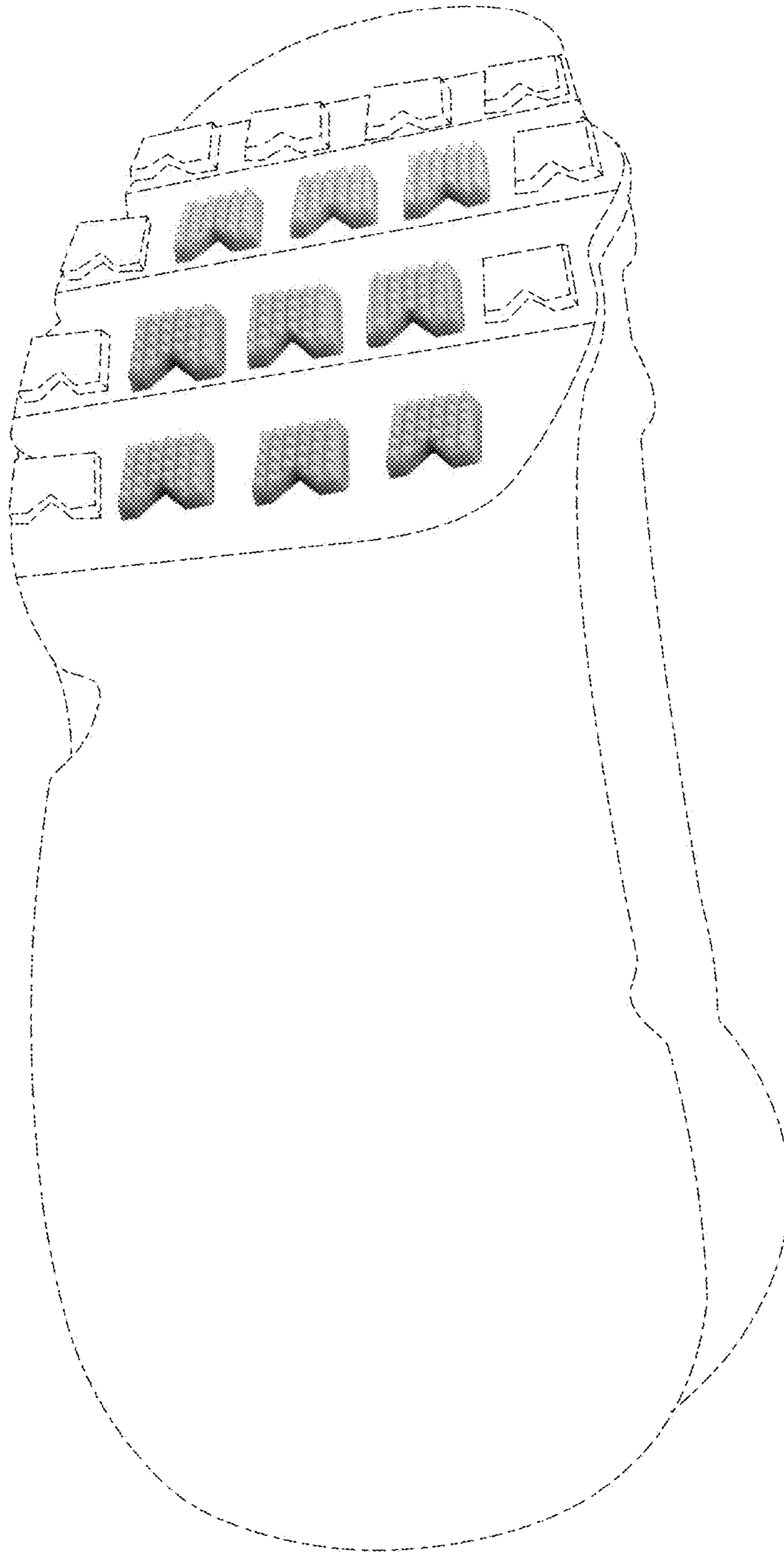

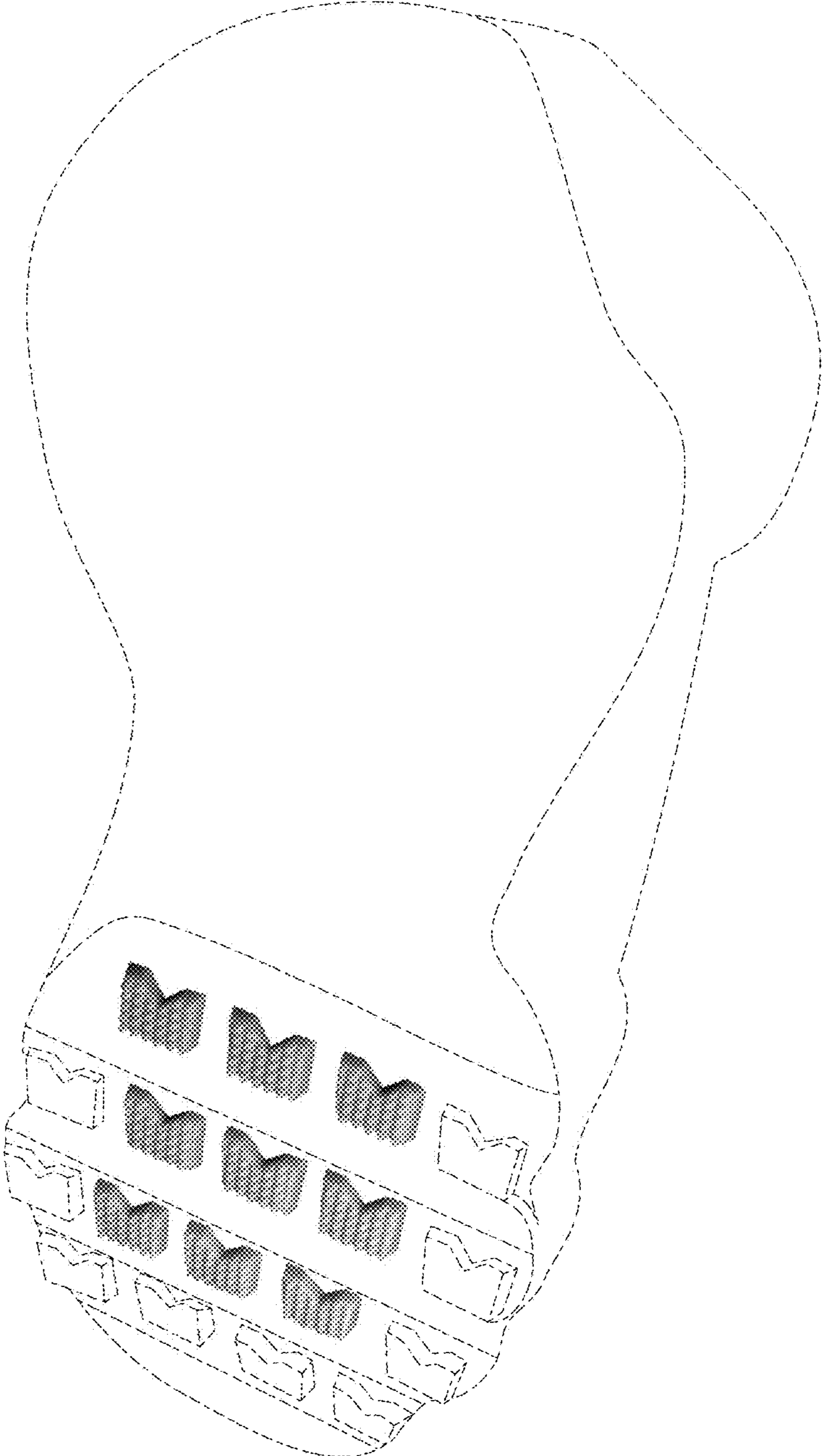
