DESCRIPTION

 FIG. 6 is a top view thereof; and,
 FIG. 7 is a bottom view thereof.
 The broken lines shown in the drawings represent portions of the shoe that form no part of the claimed design. In the figures, such stitching is disclaimed and is represented by broken lines of the same weight and frequency as all other broken lines.

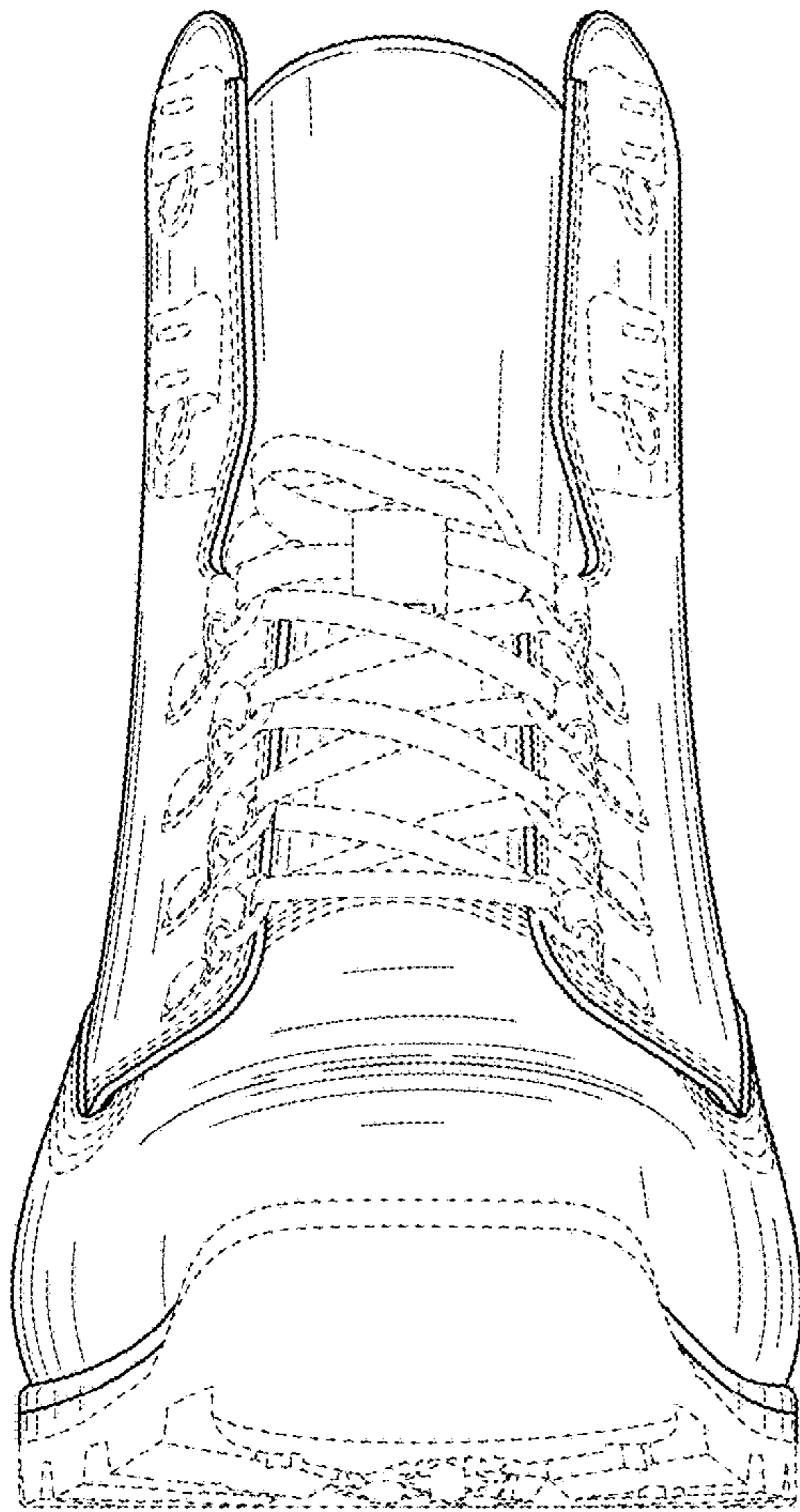

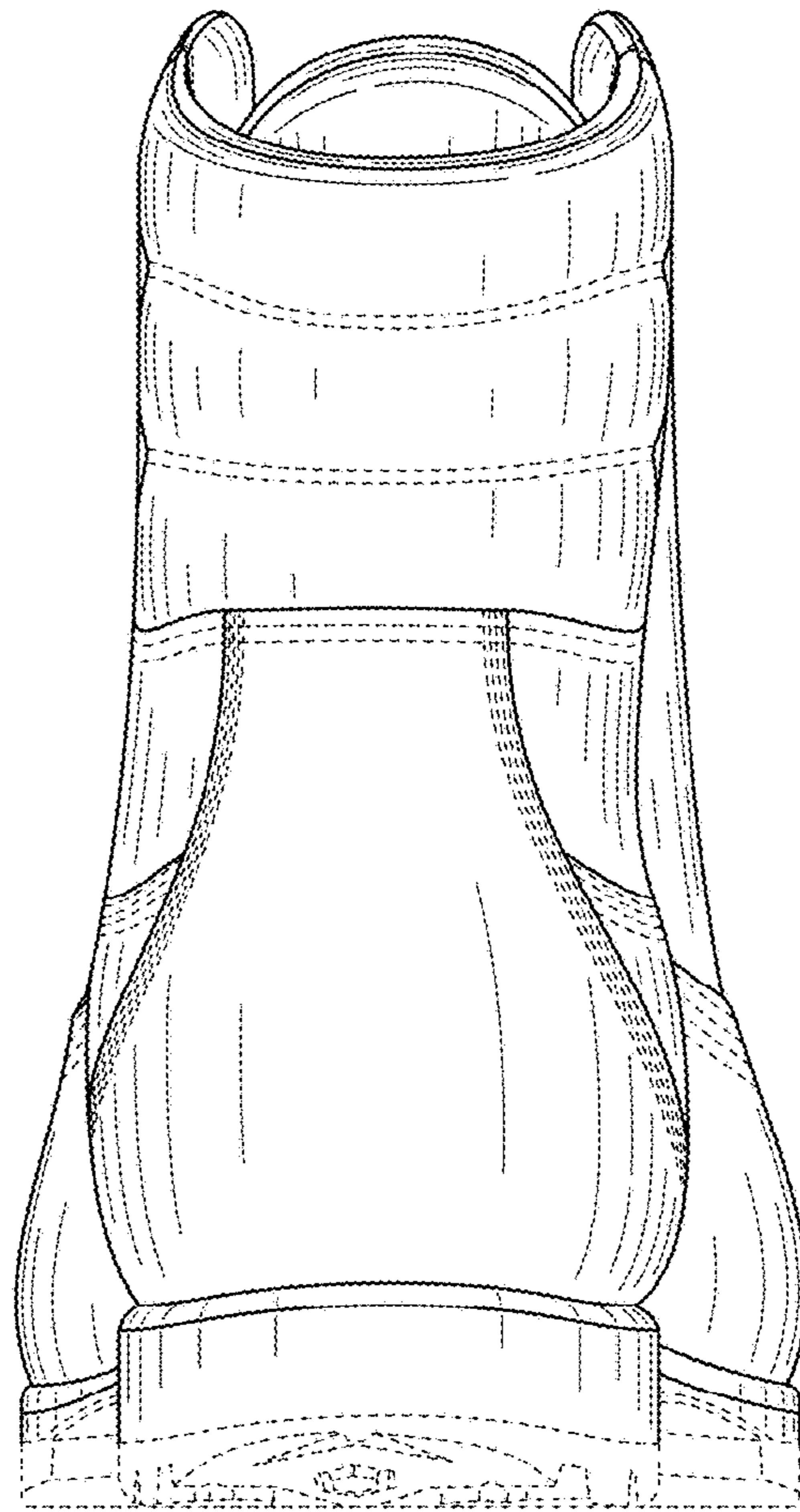

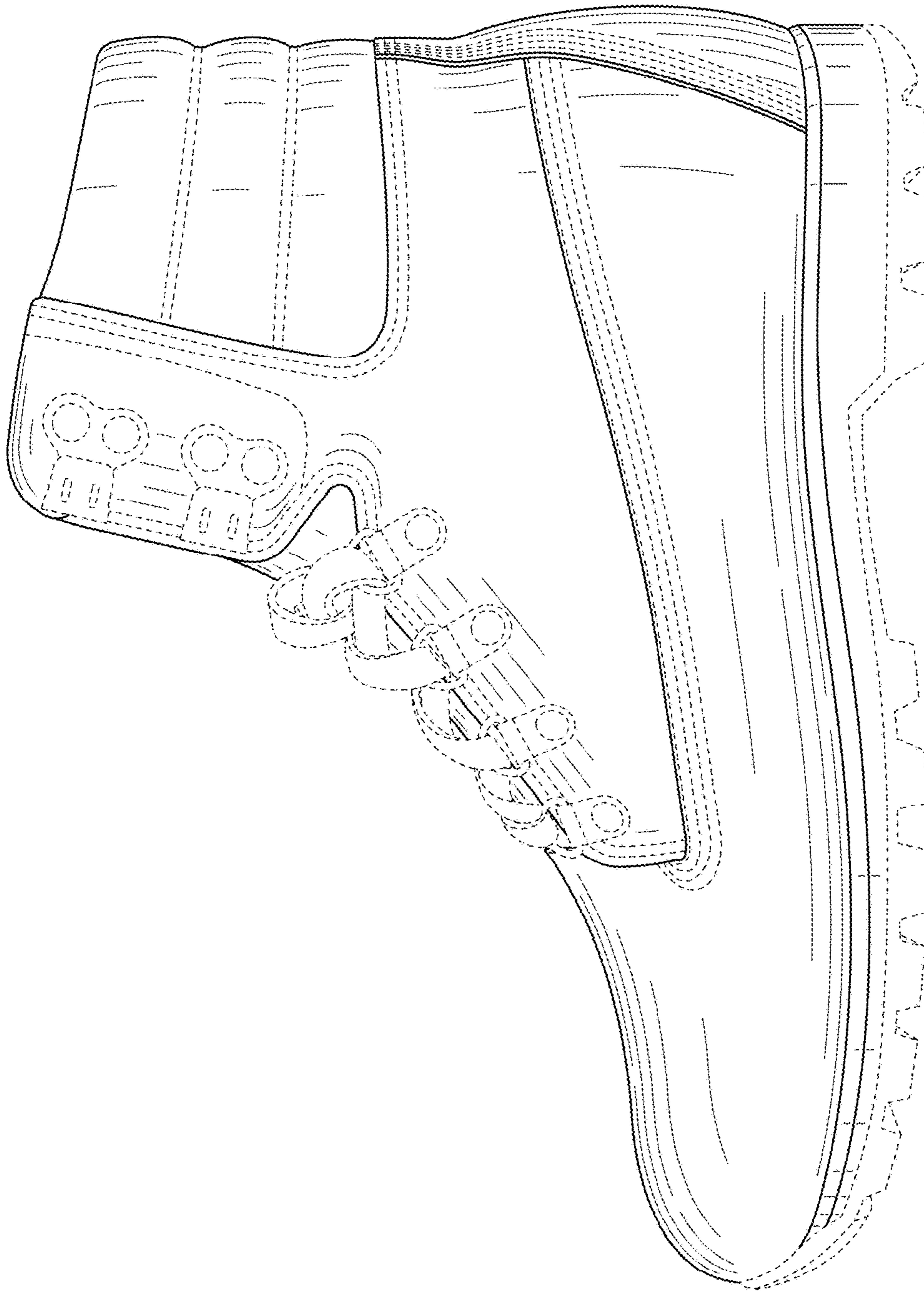

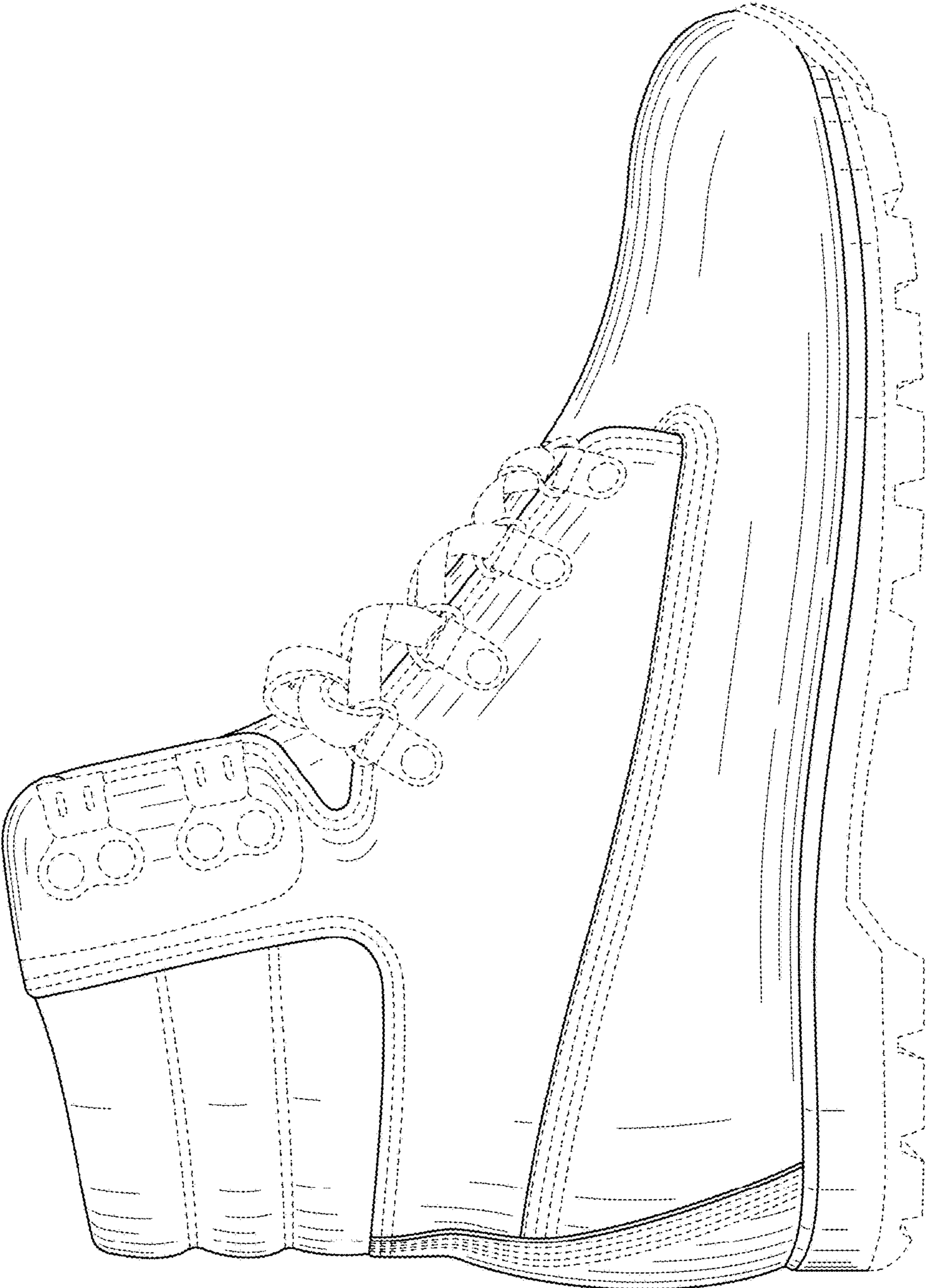

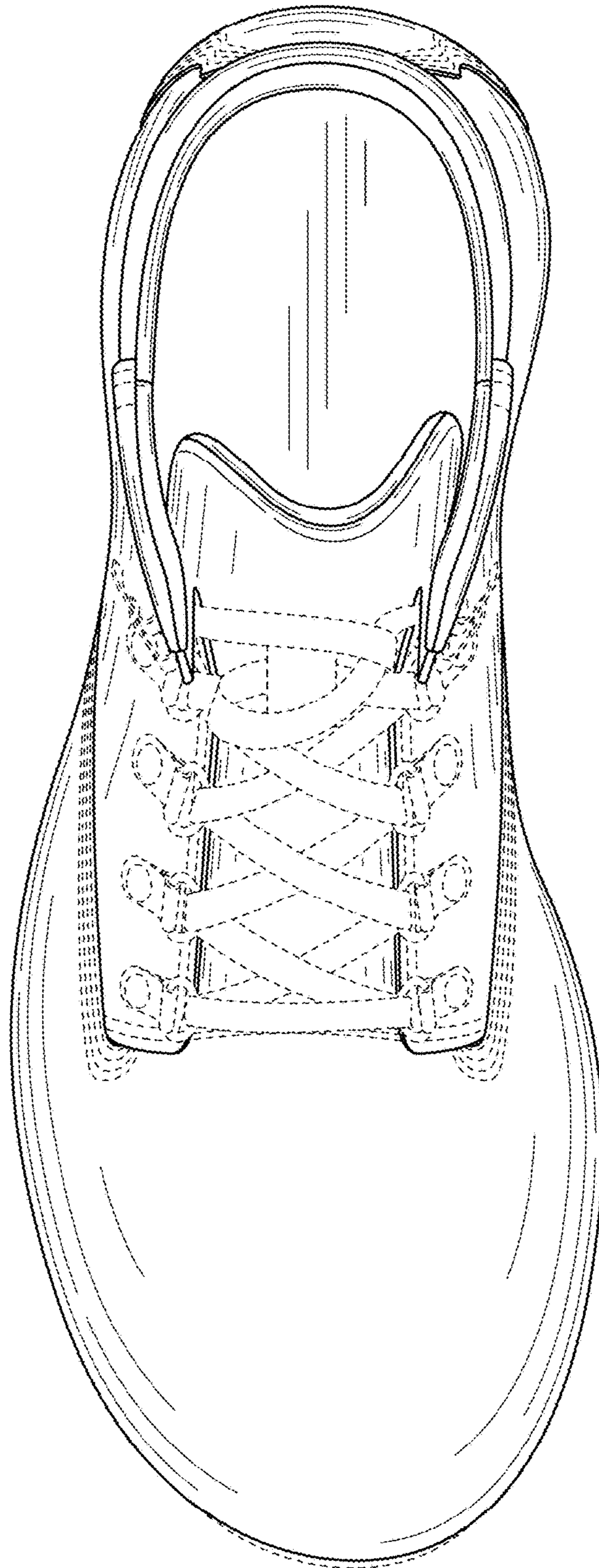

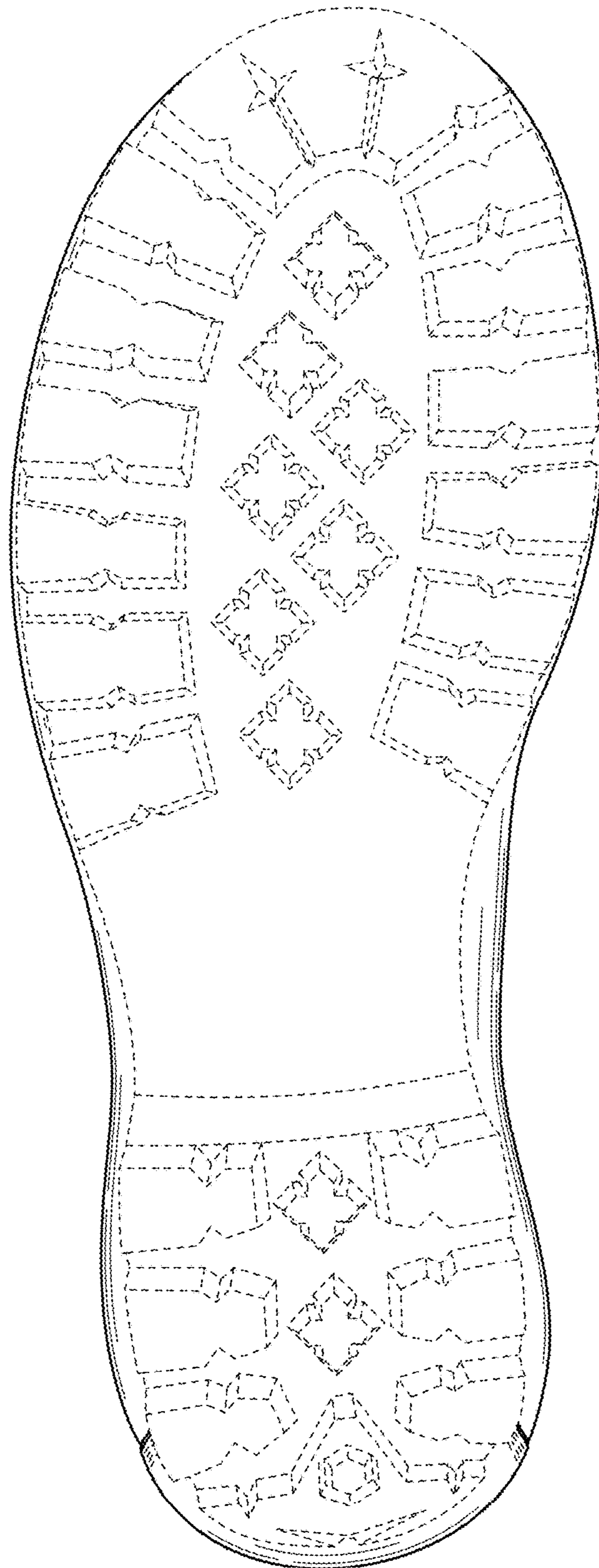
