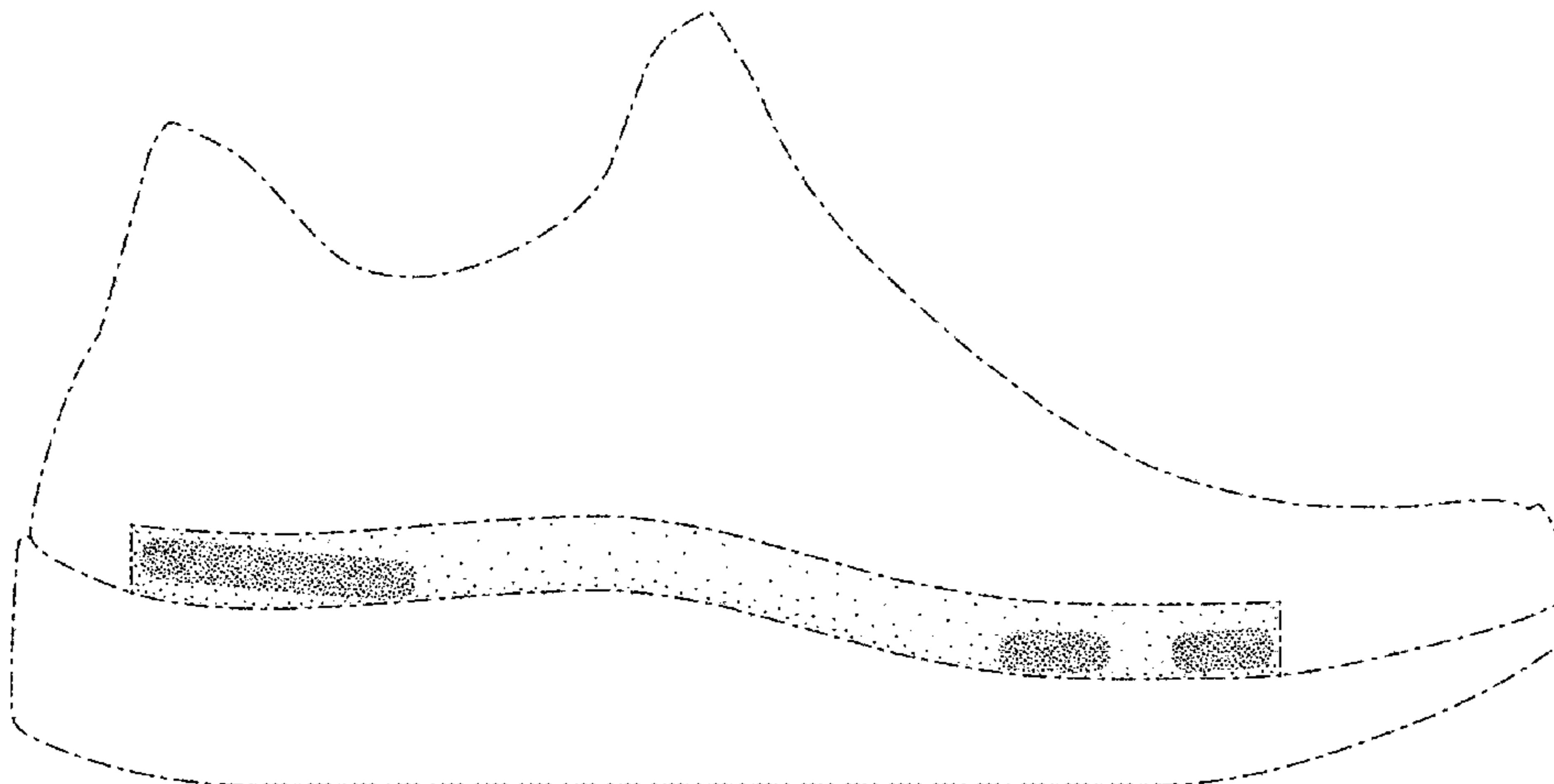
(57) **CLAIM**

The ornamental design for a shoe upper with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper with surface ornamentation showing my new design; FIG. 2 is a lateral side view thereof; and, FIG. 3 is a rear perspective view thereof. The contrast in stippling density represents a contrast in appearance only and does not represent any particular color. The broken lines immediately surrounding the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

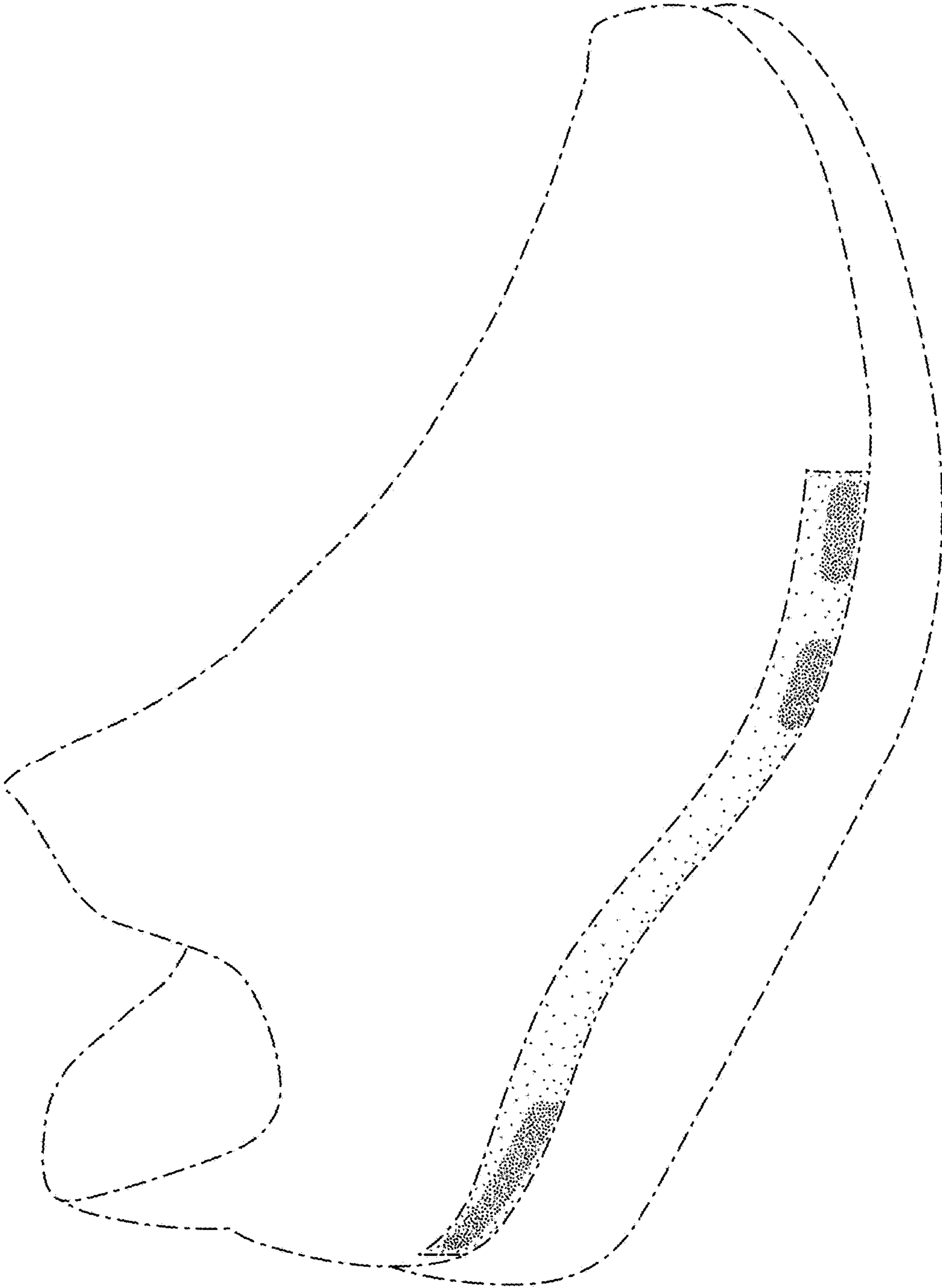

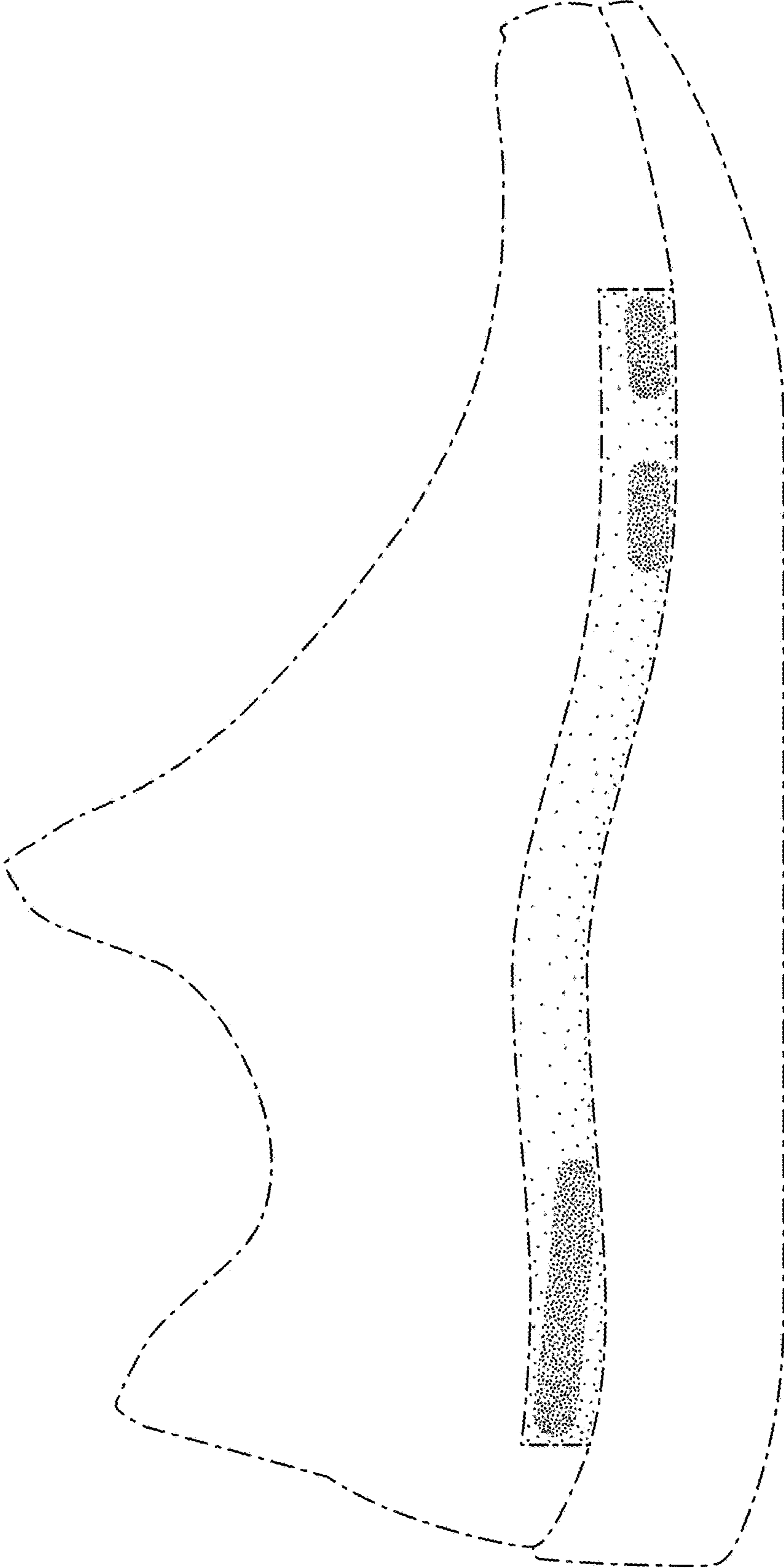

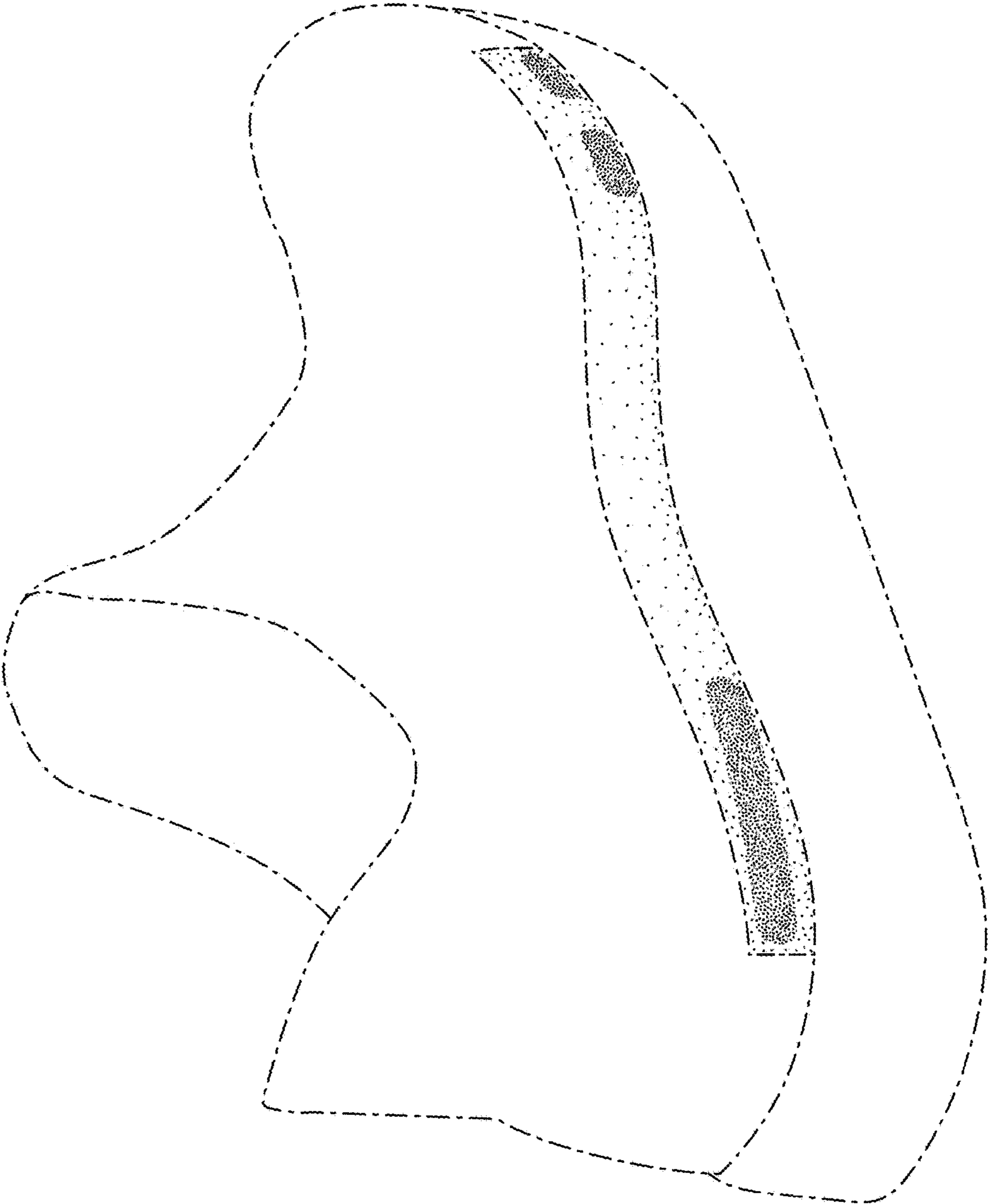
