DESCRIPTION

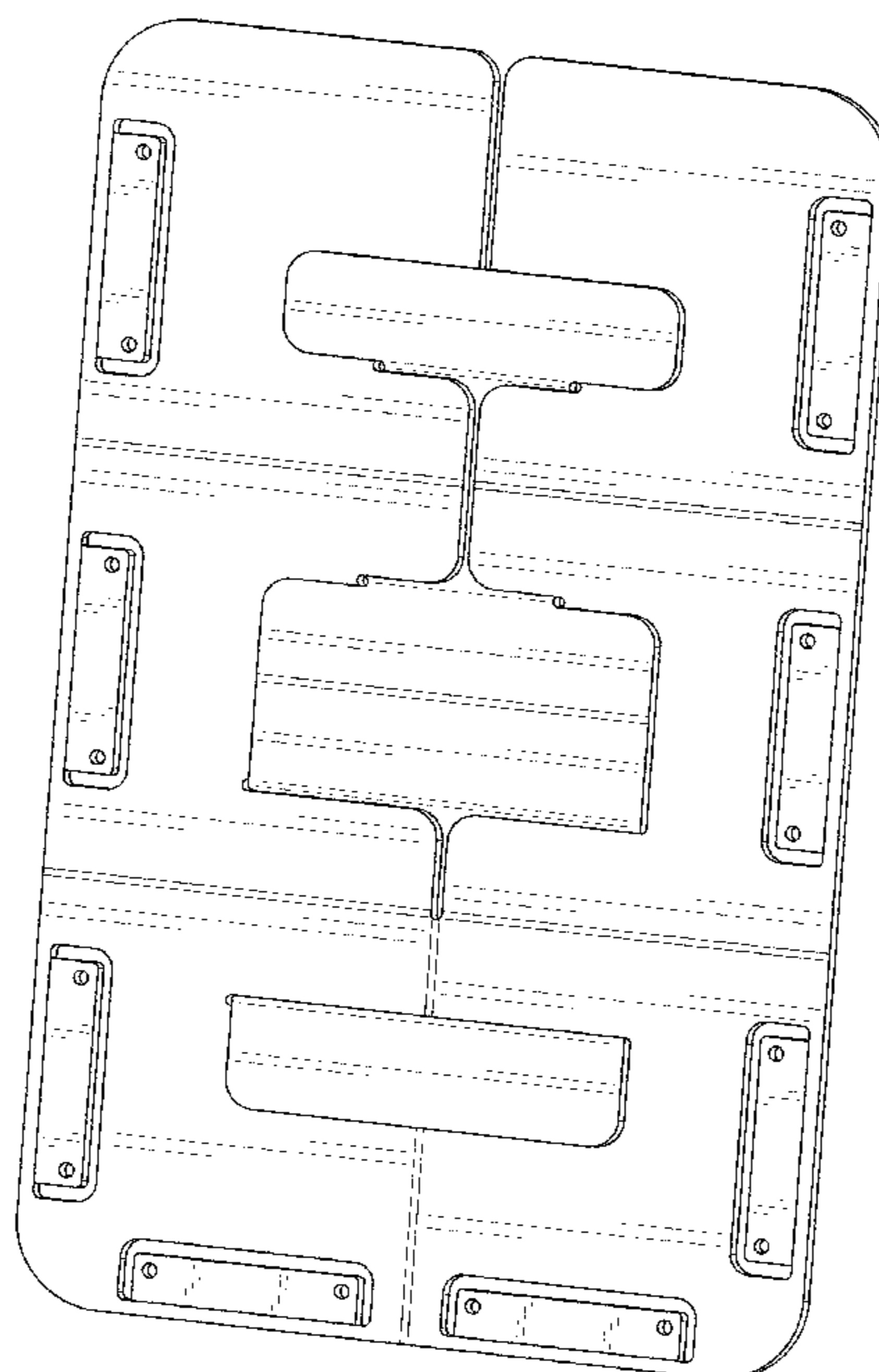
FIG. 1 is a perspective view including a front, top and one side of the foldable insert;

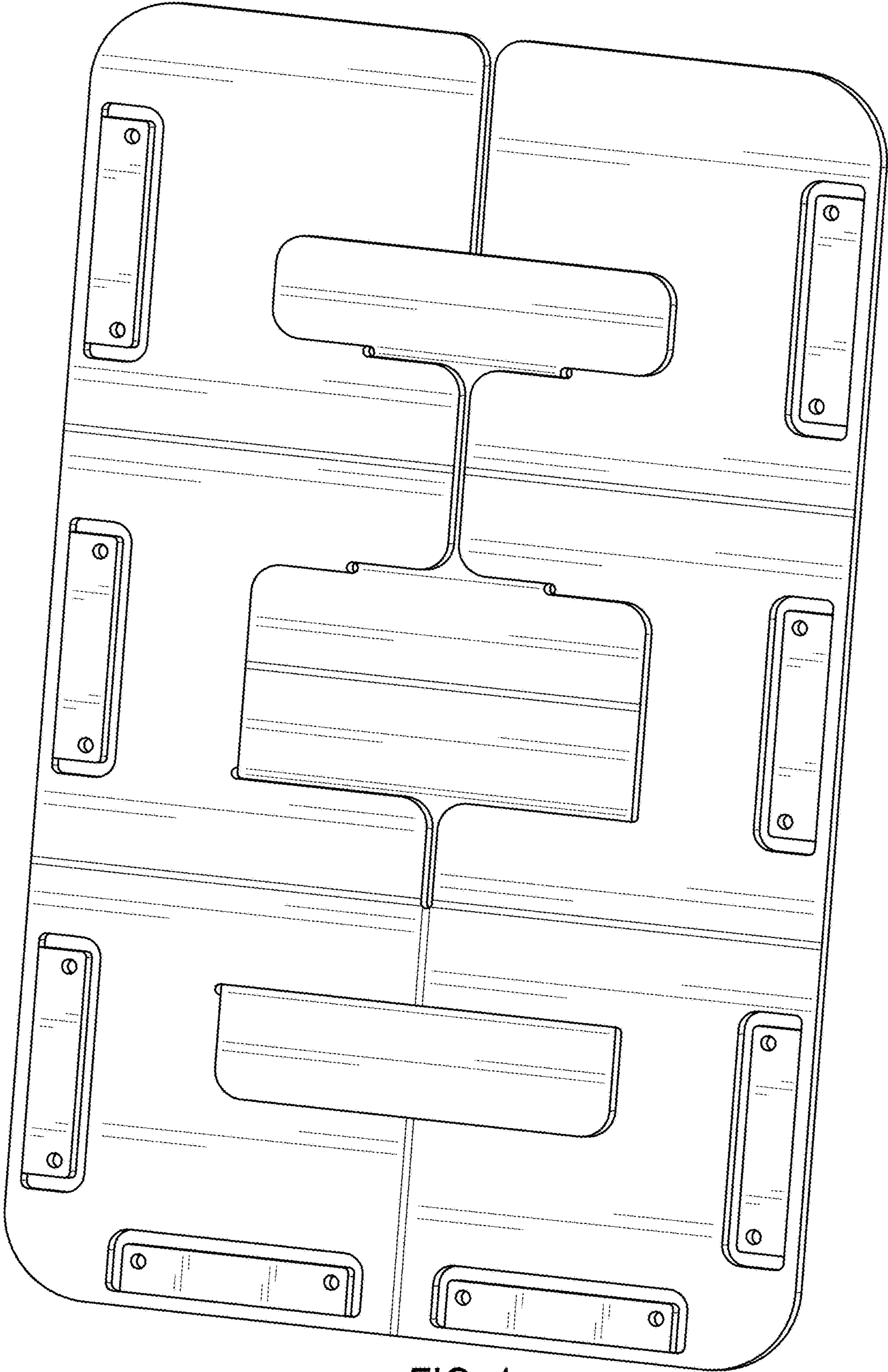

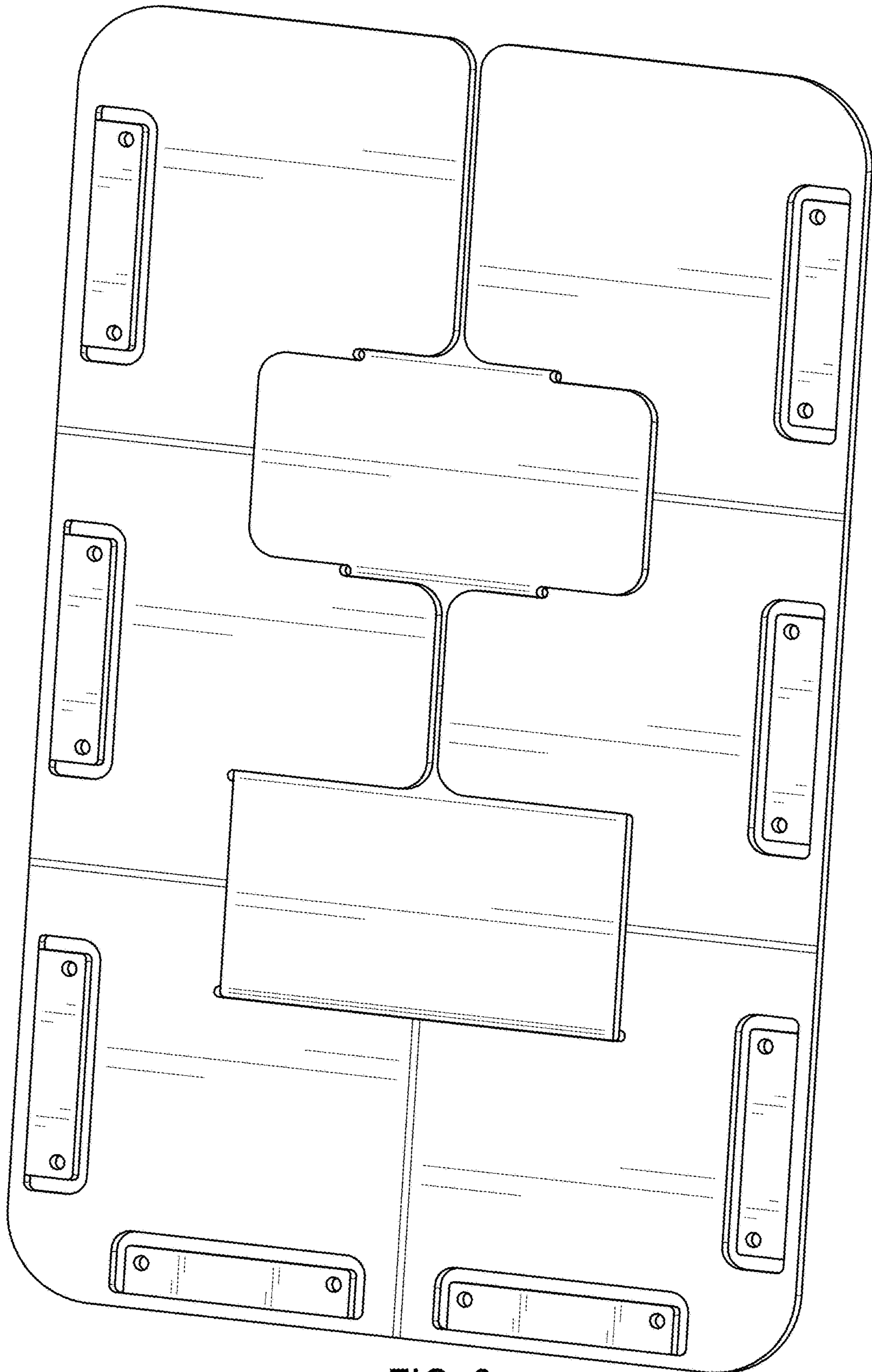

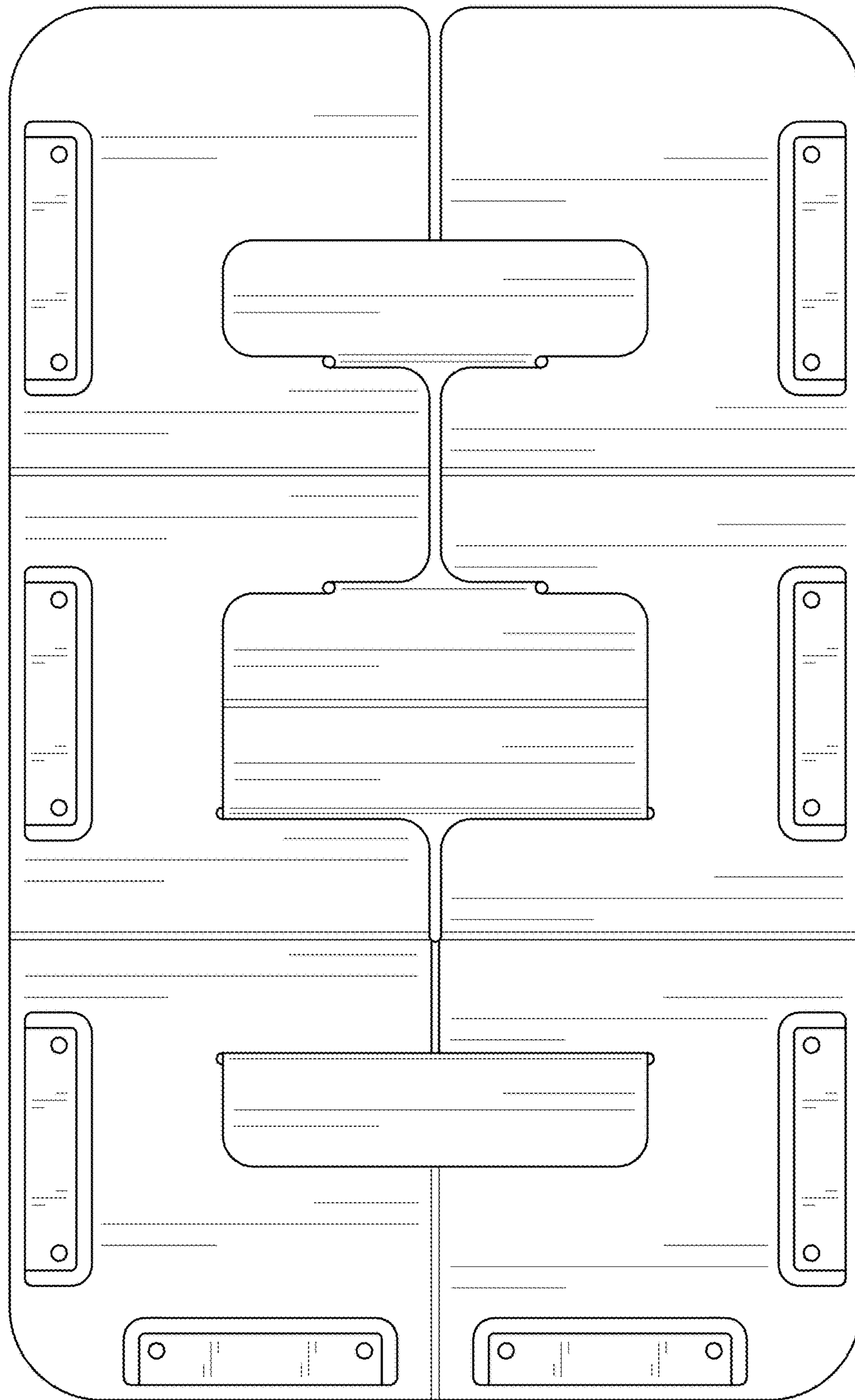

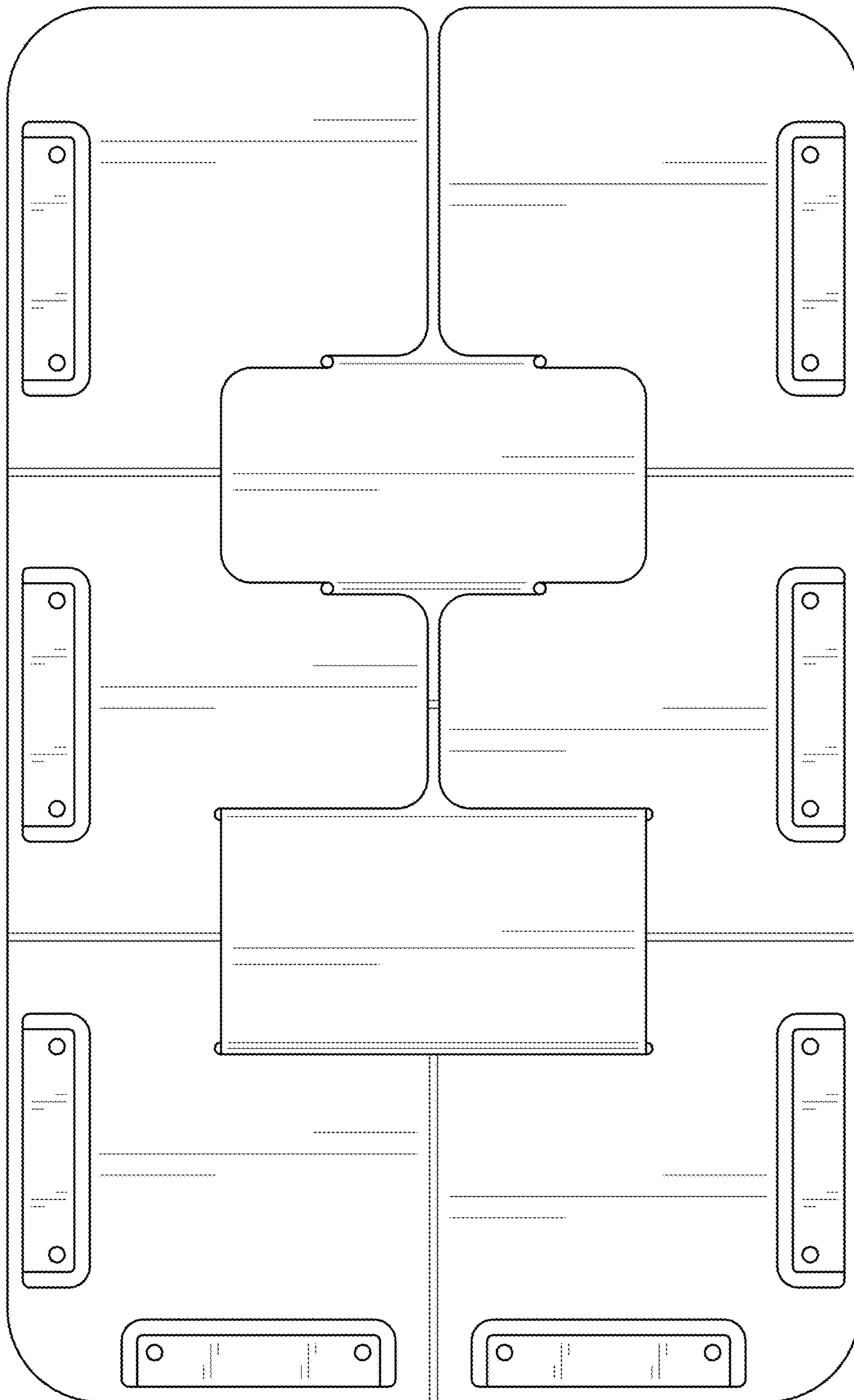

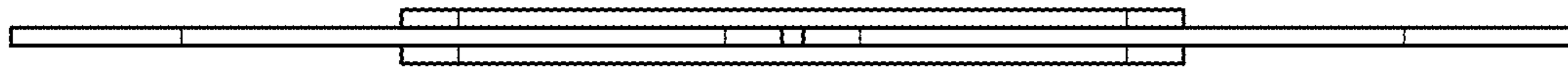

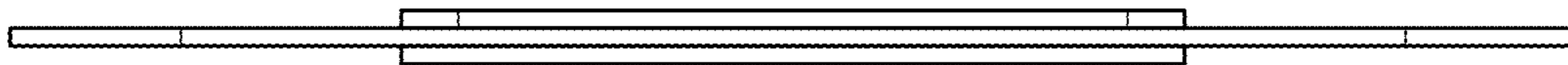

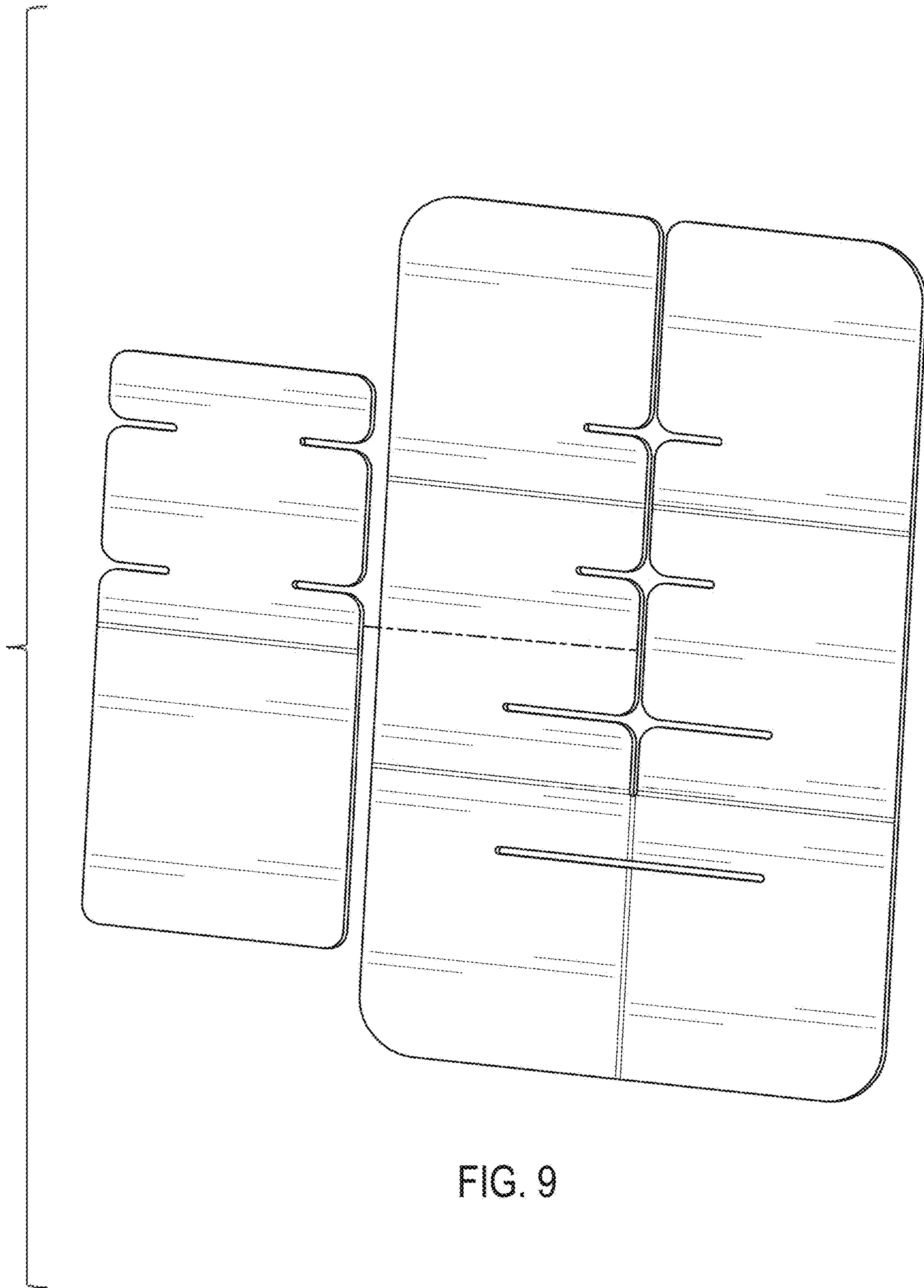
