**DESCRIPTION**

FIG. 1 is a perspective left side view of an embodiment of a boot cleaning tool;

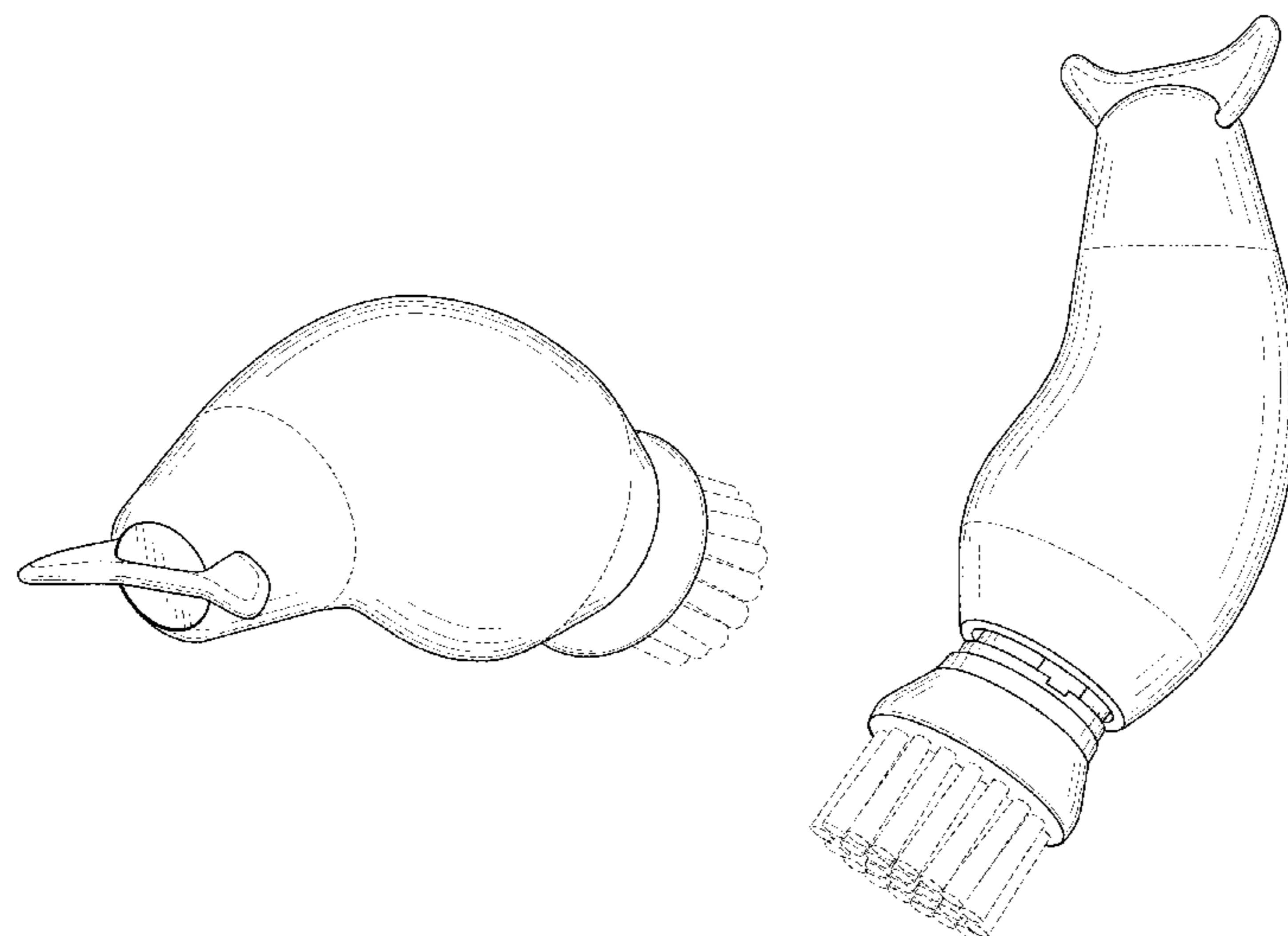
FIG. 2 is an enlarged perspective front view of the boot cleaning tool shown in FIG. 1;

FIG. 3 is a perspective rear view of the boot cleaning tool shown in FIG. 1; and,

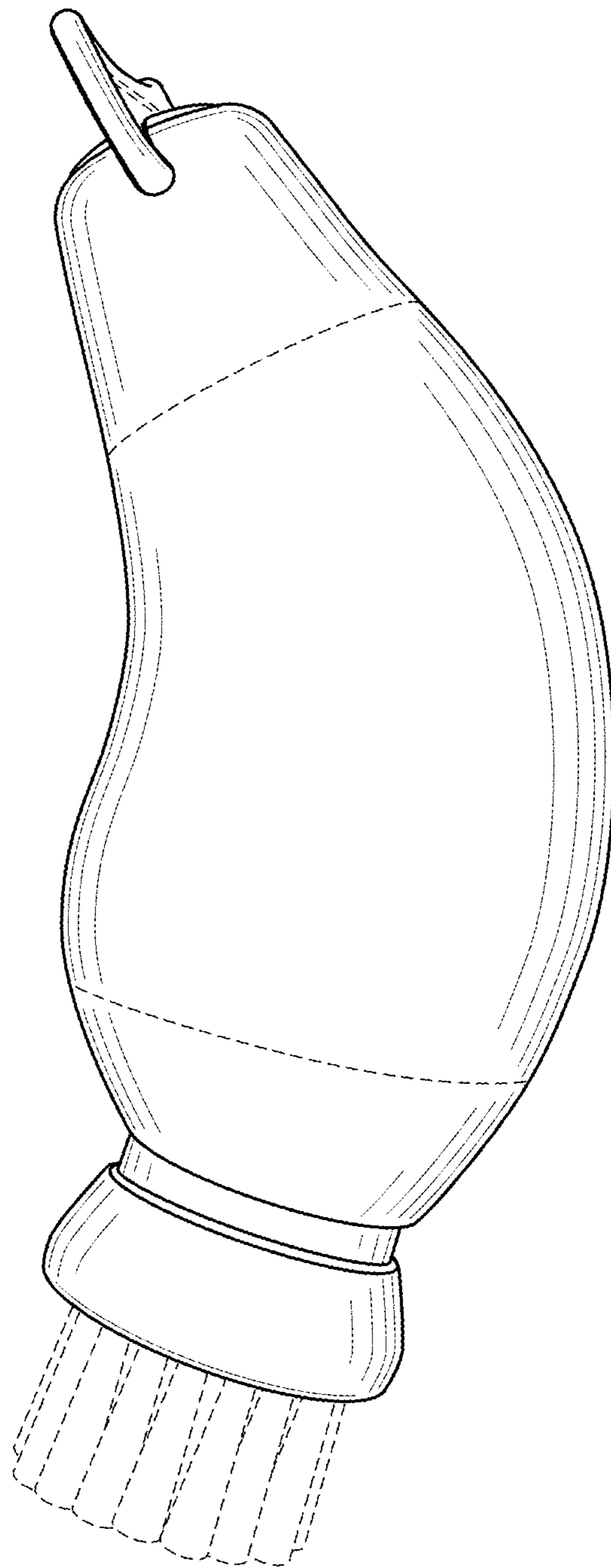

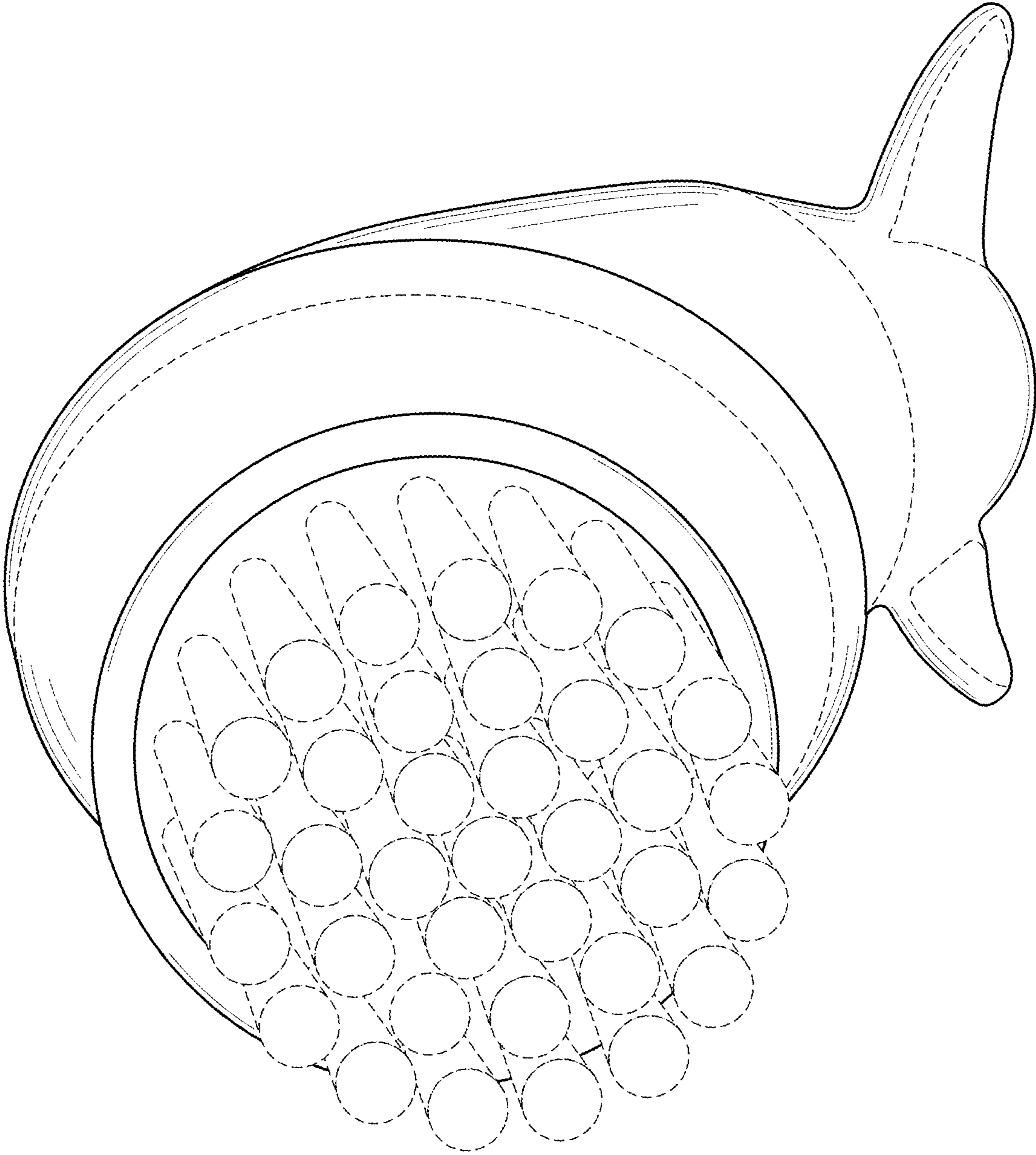

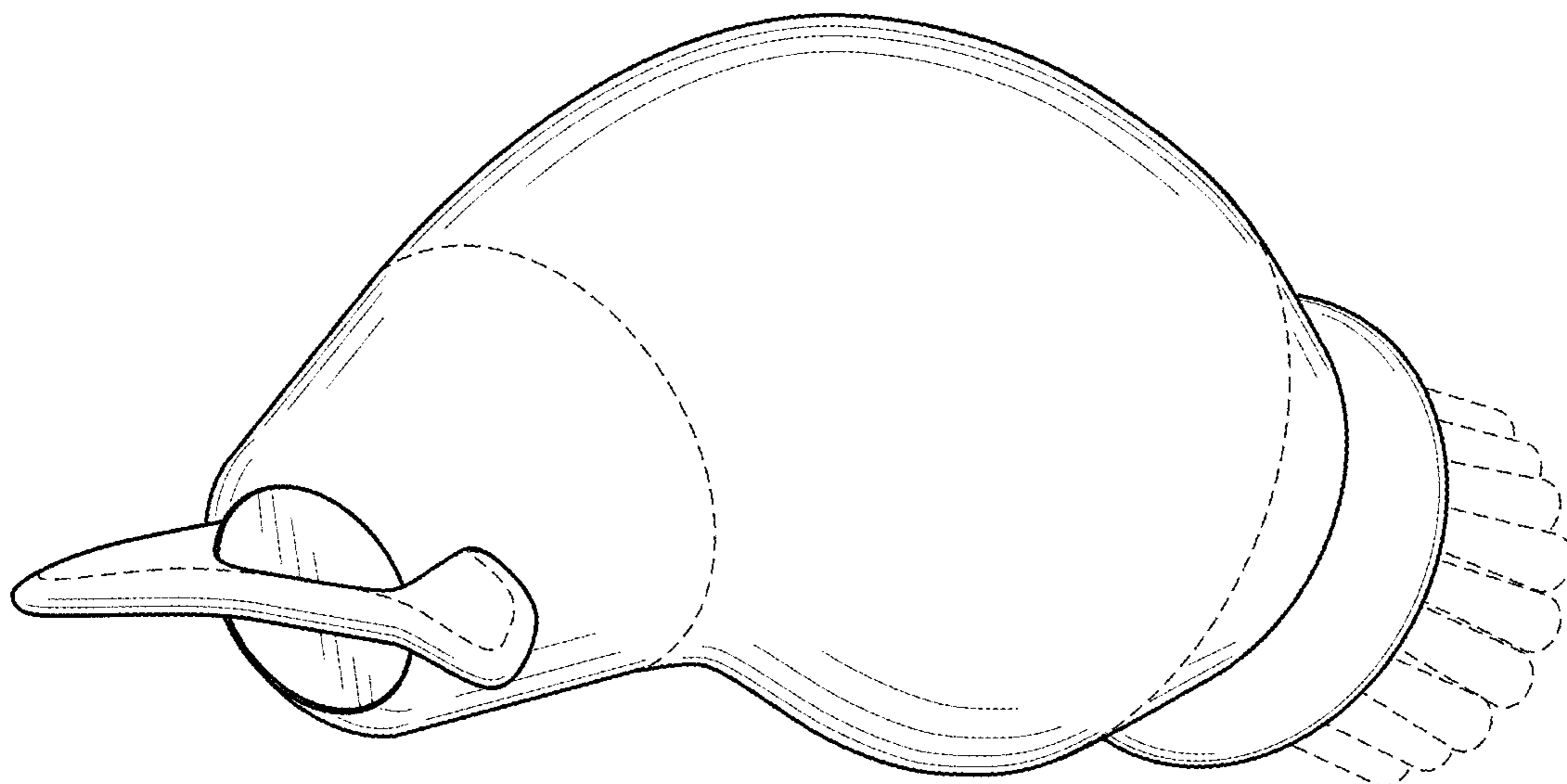

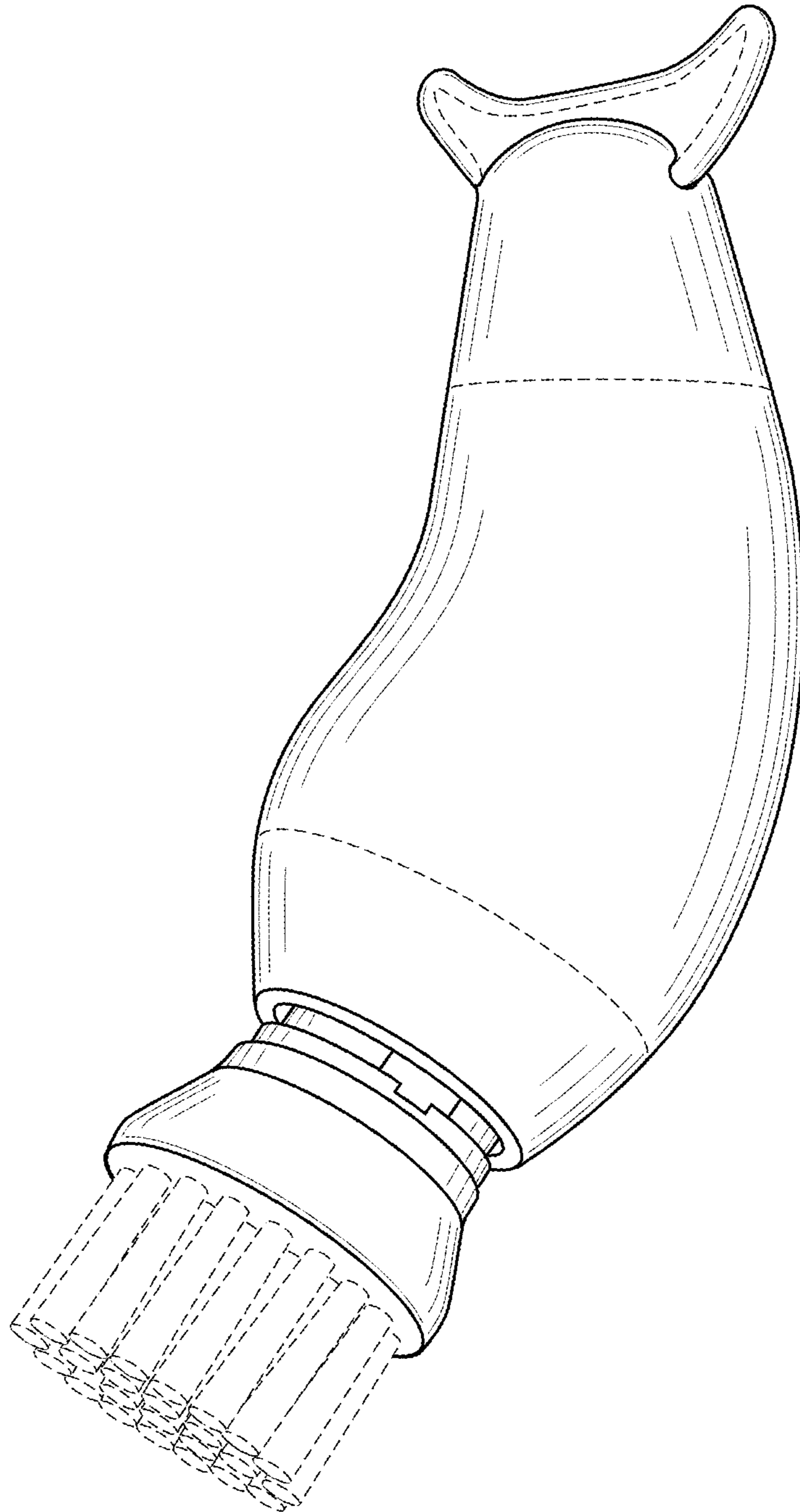
