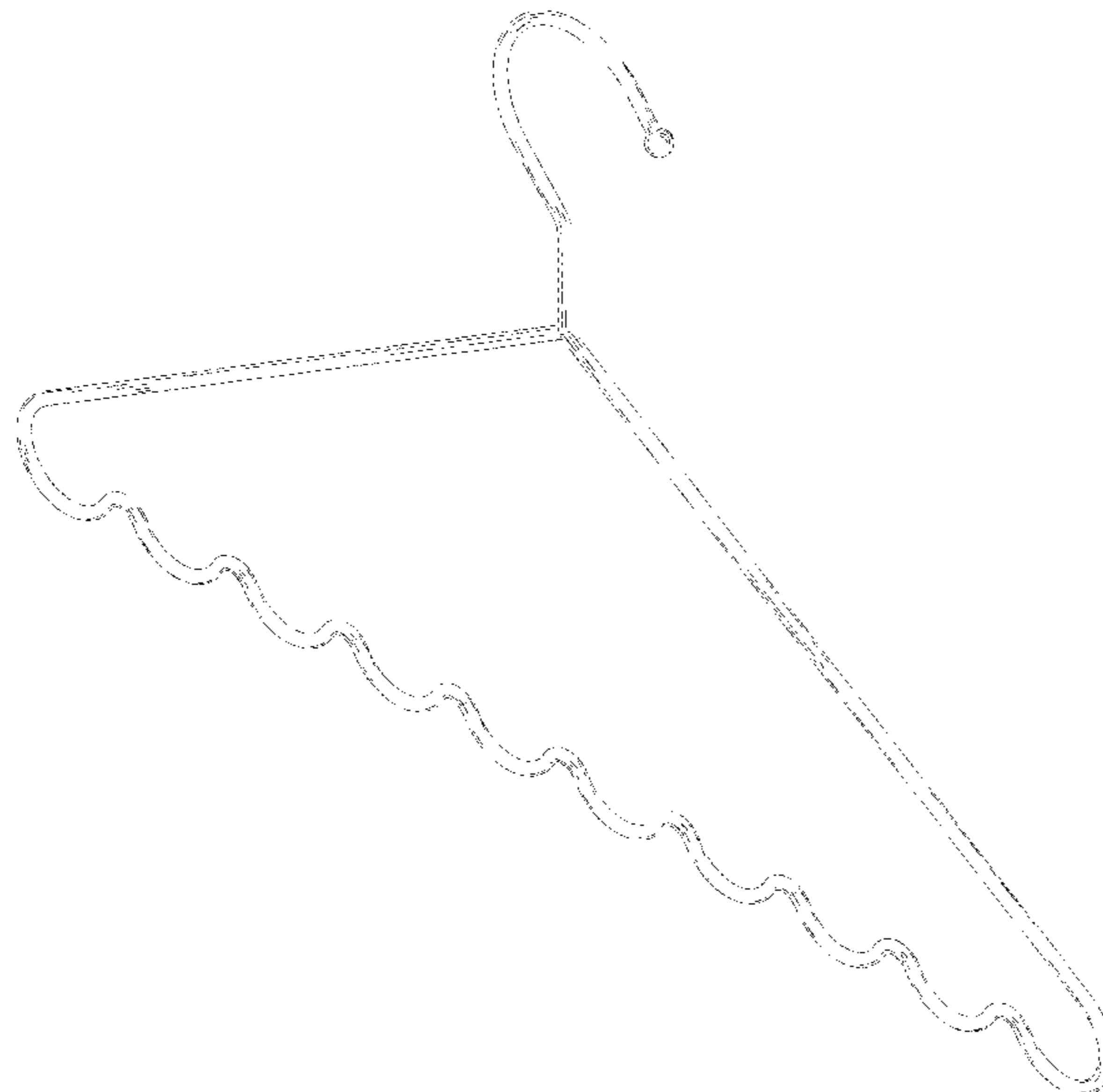
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a hat-organizing hanger showing my new design;

 FIG. 4 is a left side elevational view thereof;

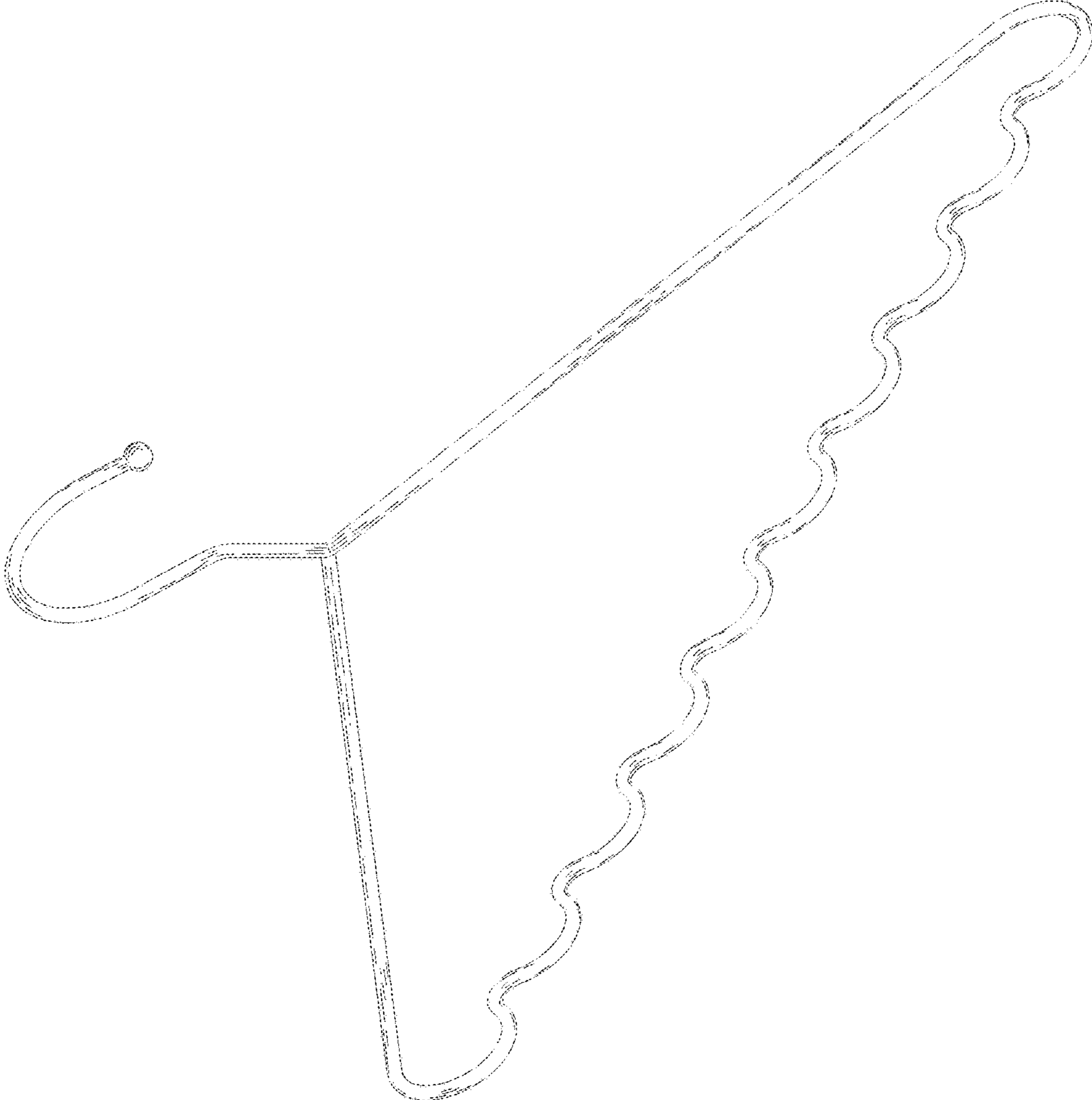

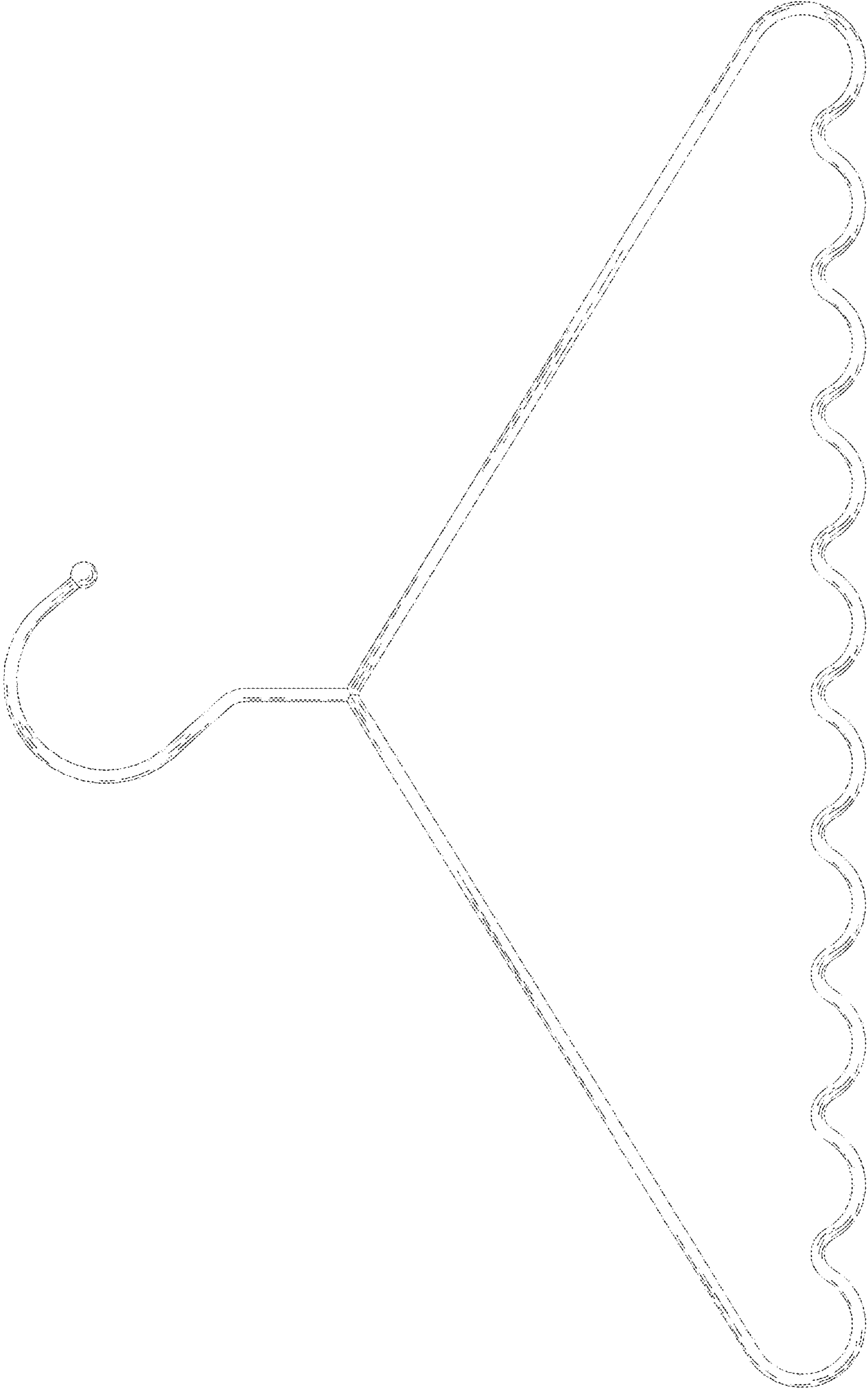

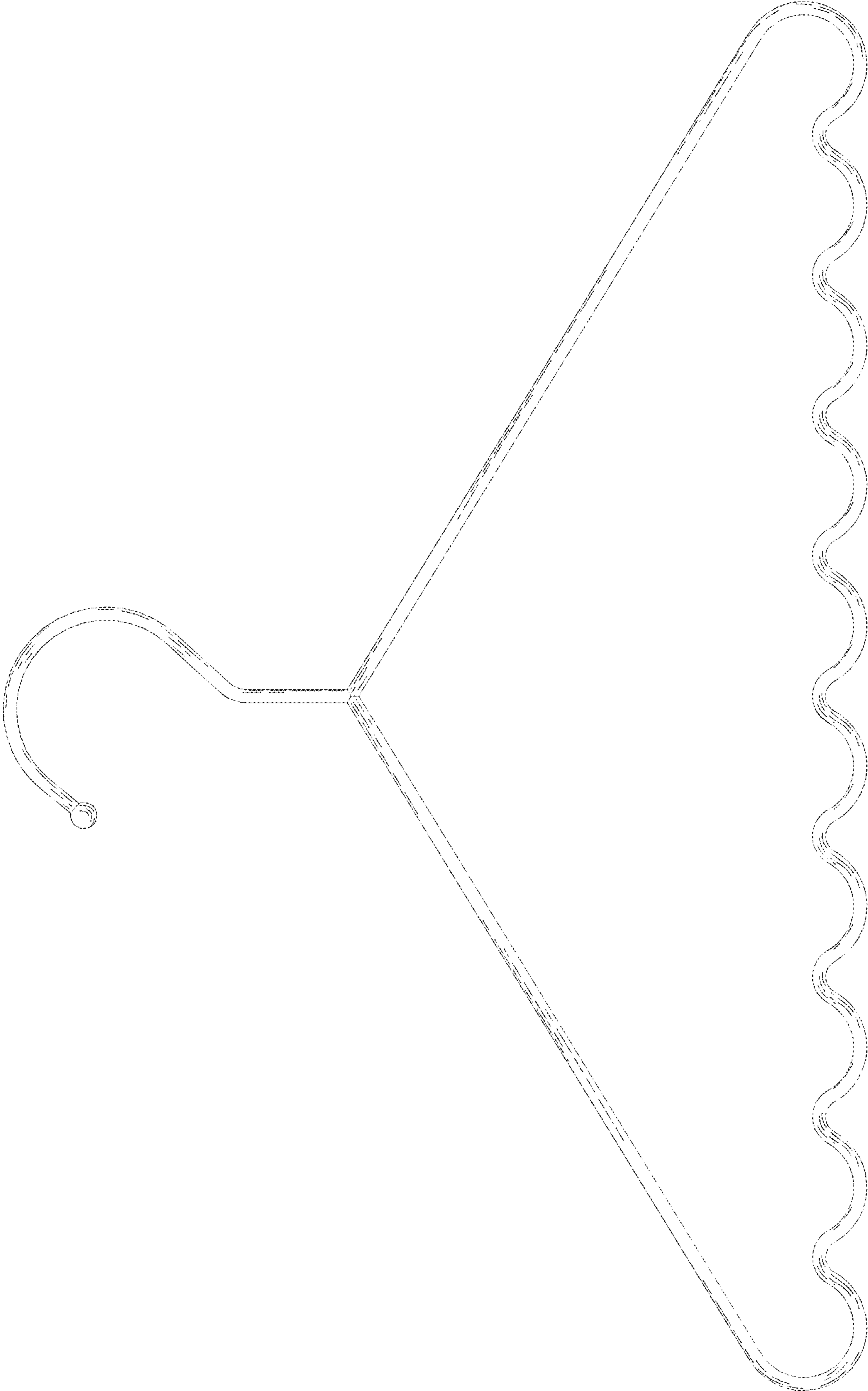

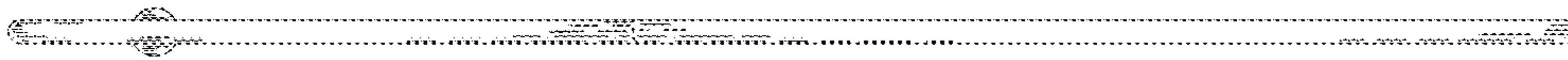

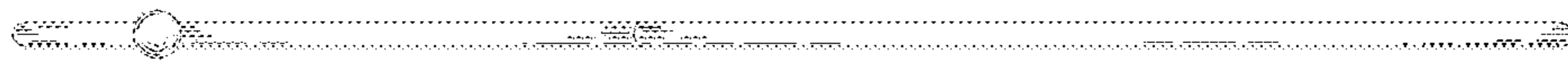

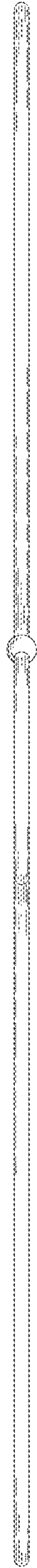

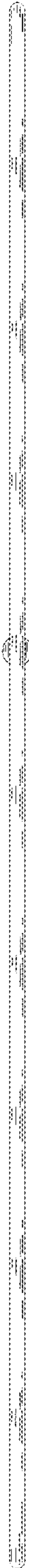

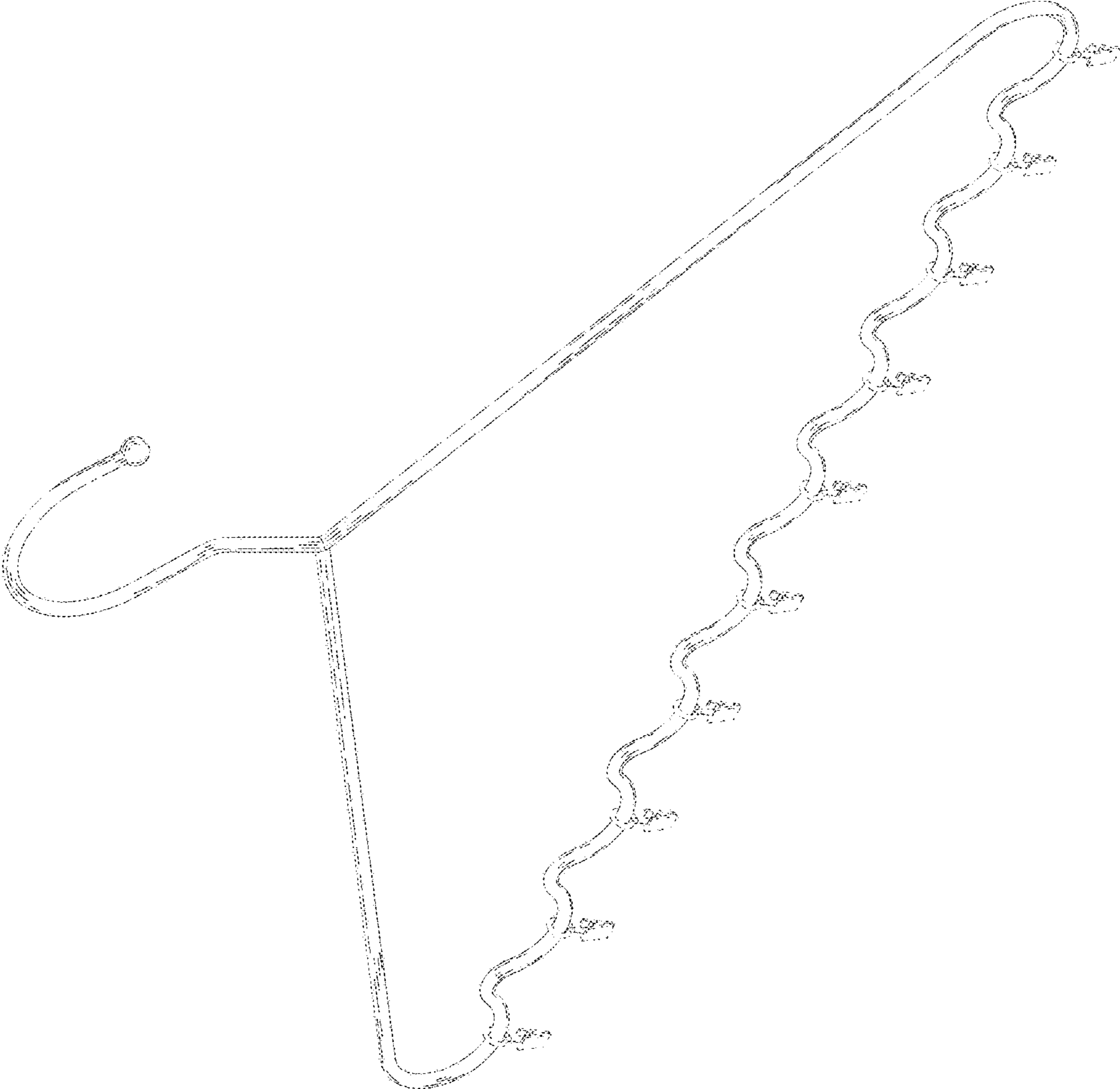
