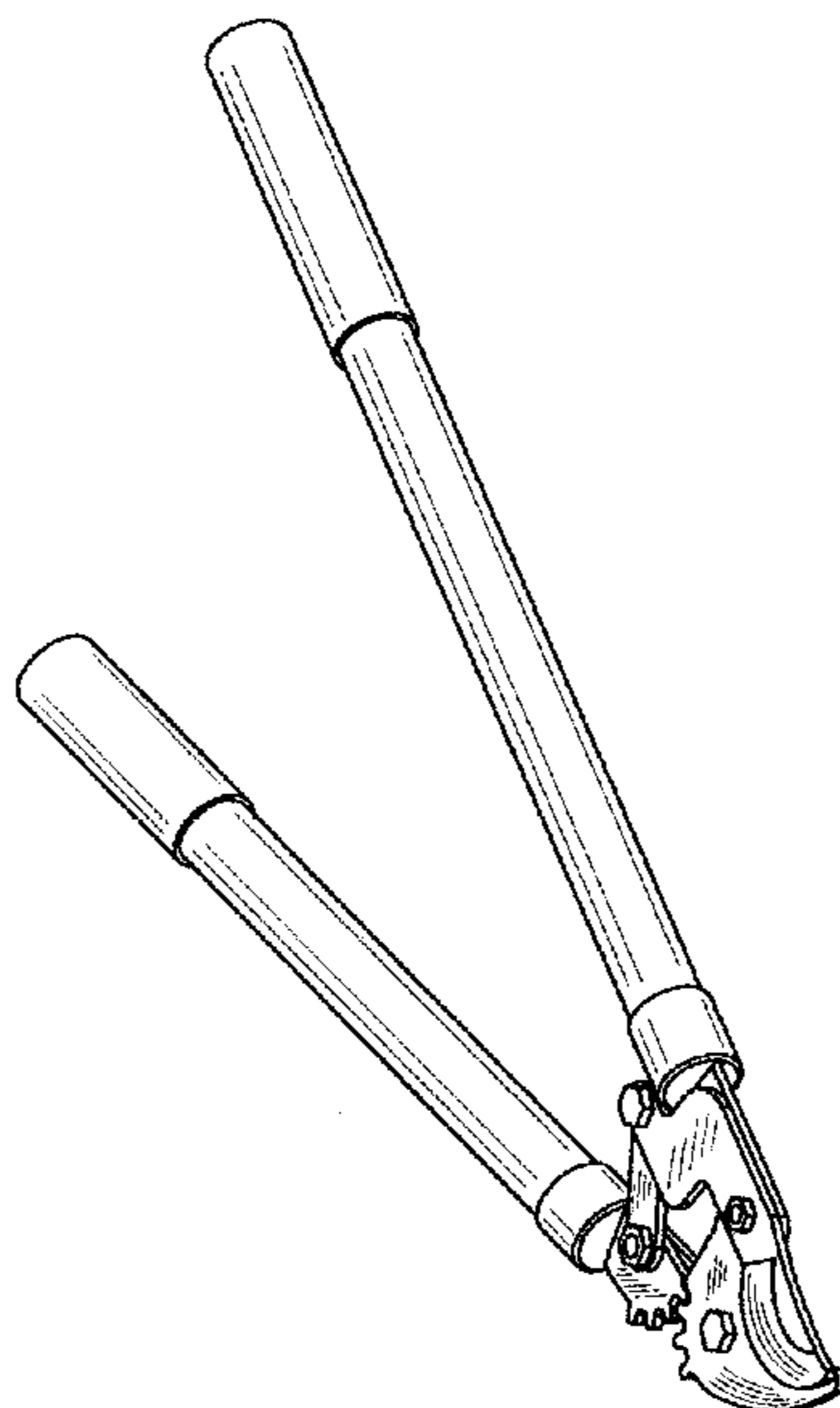
(57) **CLAIM**

The ornamental design for a compound gear lopper, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of a compound gear lopper showing my new design;
FIG. 2 is a right side view of the compound gear lopper showing my design; and,
FIG. 3 is left side view of the compound gear lopper showing my design.
The compound gear lopper has a pair of long handles attached to an arcuately curved cutting device with compound legs thereon.

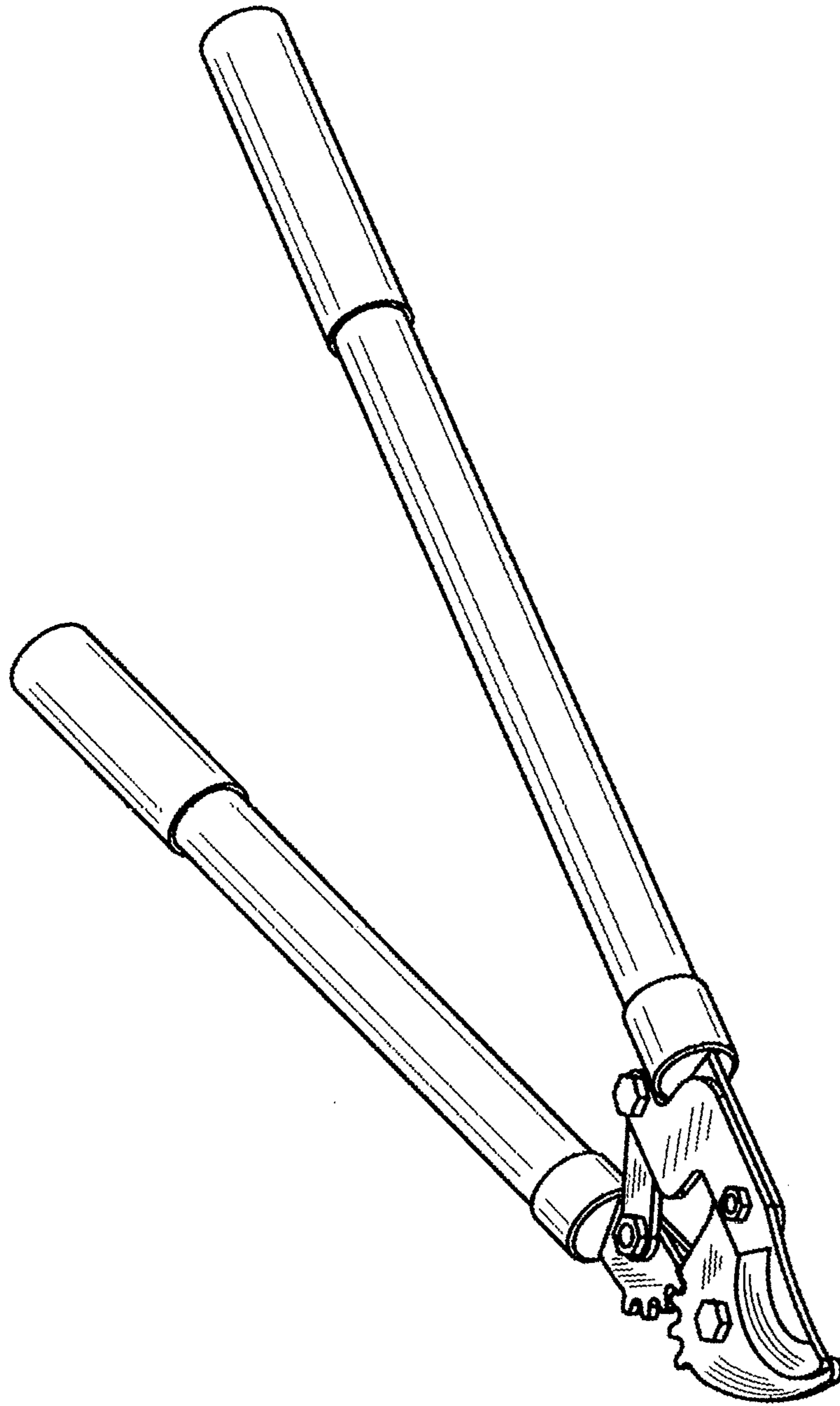

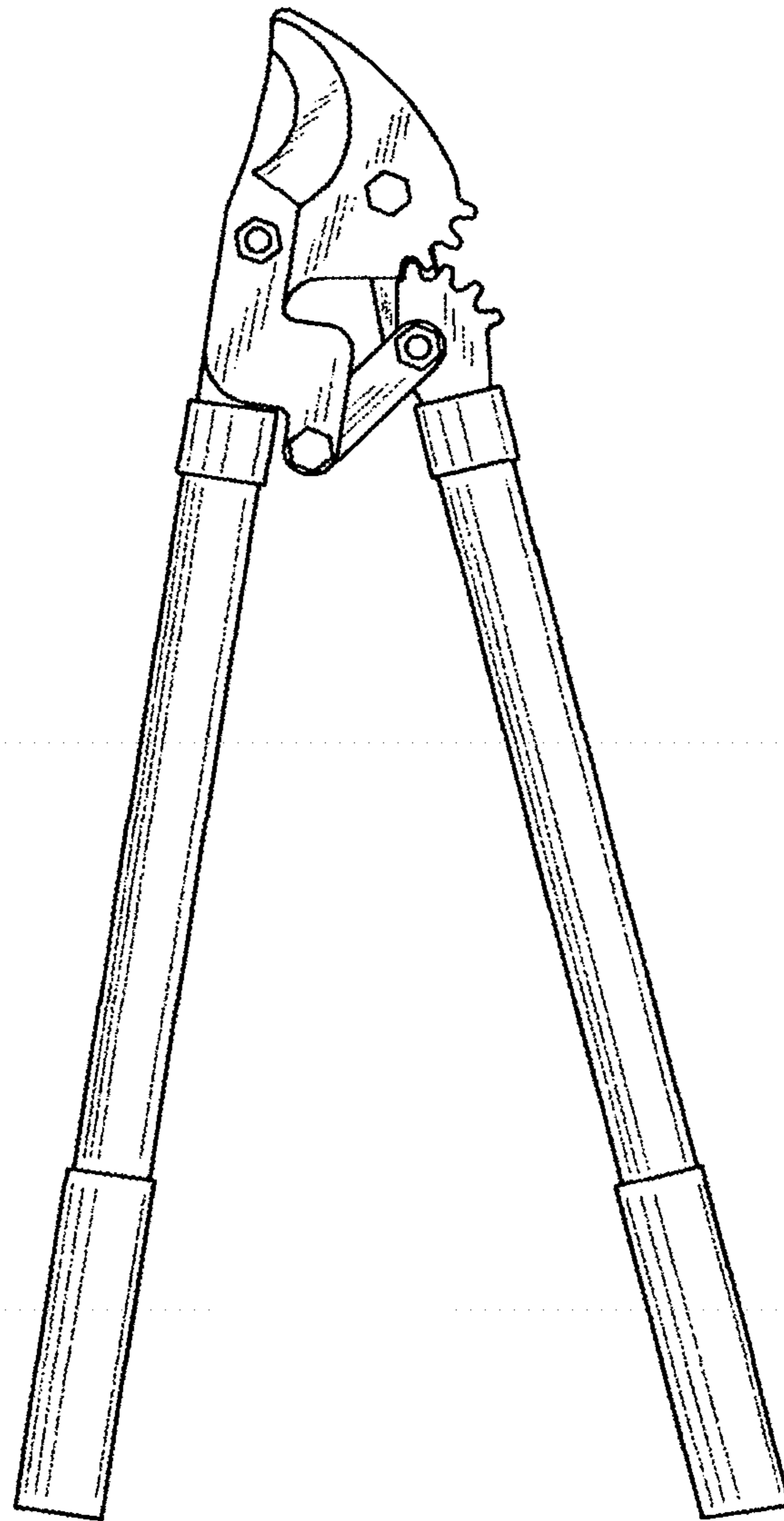

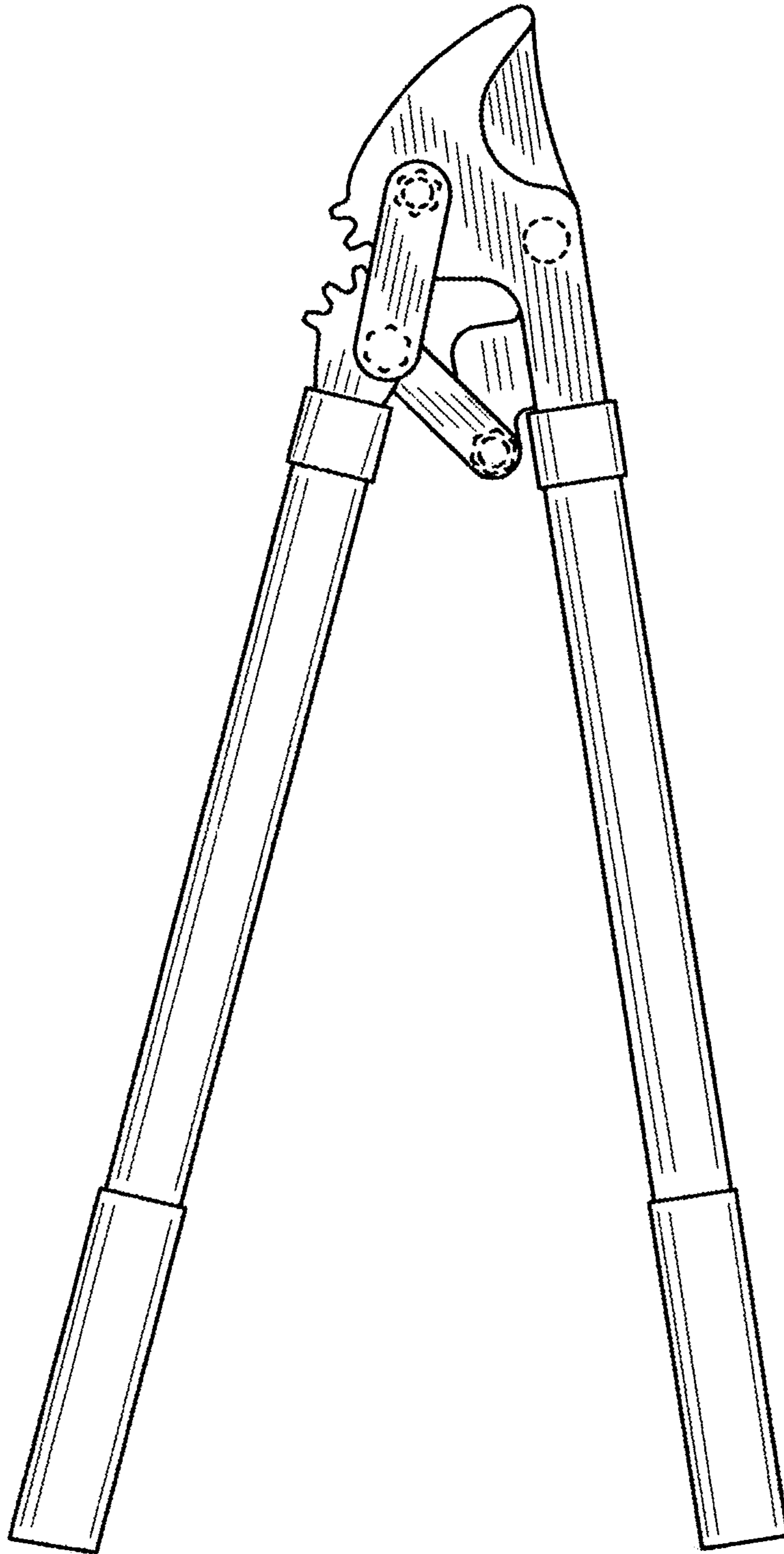
