The ornamental design for an applicator nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the applicator nozzle.
 FIG. 2 is a front elevation view of the applicator nozzle.
 FIG. 3 is right side elevation view of the applicator nozzle.
 FIG. 4 is a top end view of the applicator nozzle.
 FIG. 5 is a bottom end view of the applicator nozzle; and,
 FIG. 6 is a back elevation view of the applicator nozzle.
 The broken lines in the drawings depict portions of the applicator nozzle that form no part of the claimed design.
