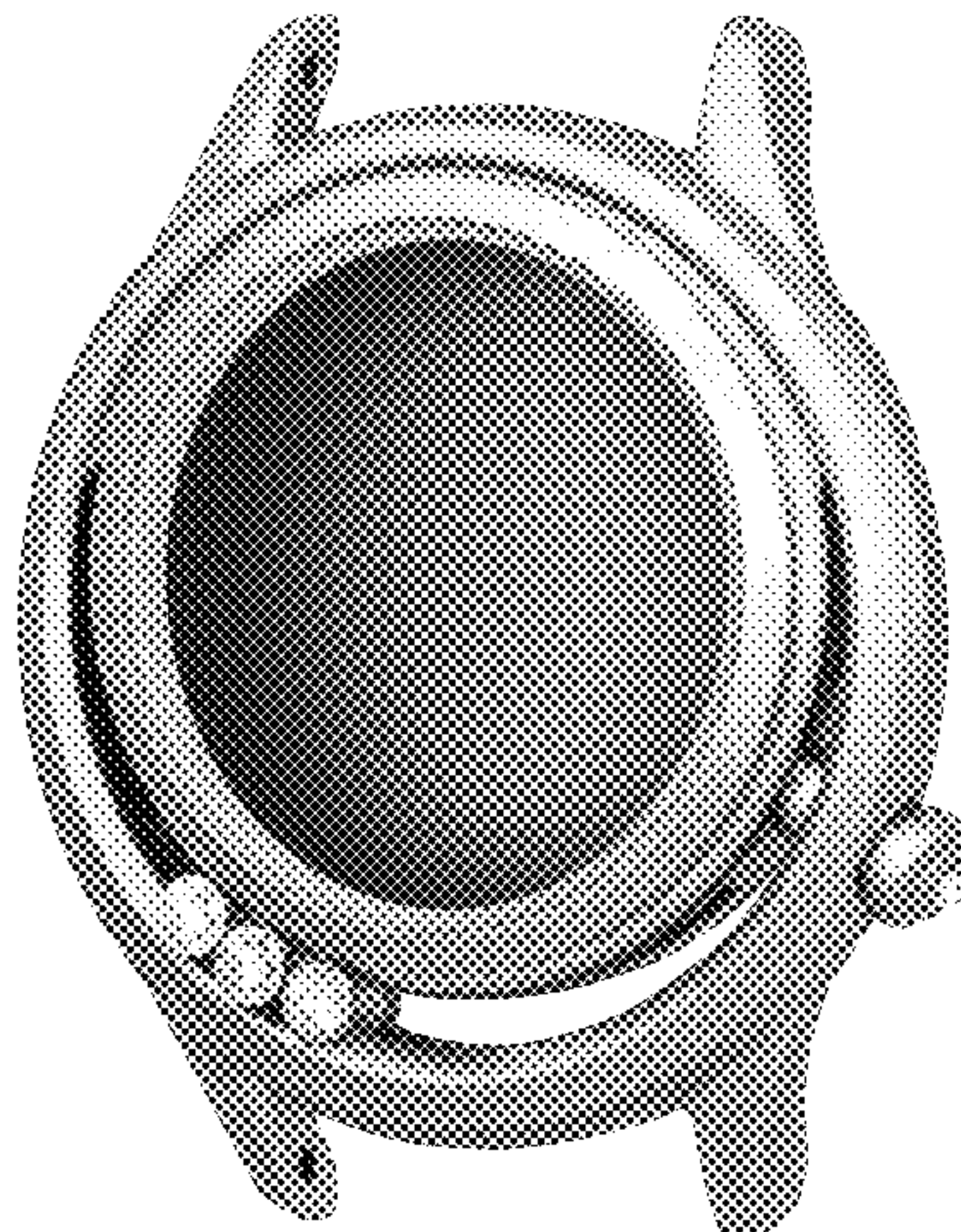
(57) **CLAIM**

The ornamental design for a watchcase, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged perspective view of a watchcase showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a front elevational view thereof showing the gems in alternate position.  
The broken lines shown in FIGS. 3-6 show portions of the watchcase that form no part of the claimed design.

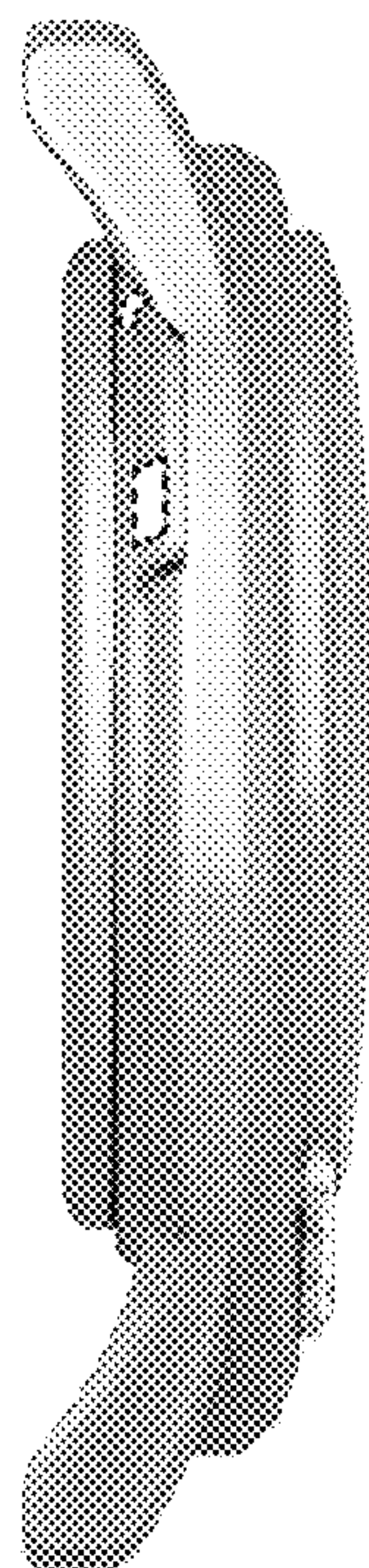

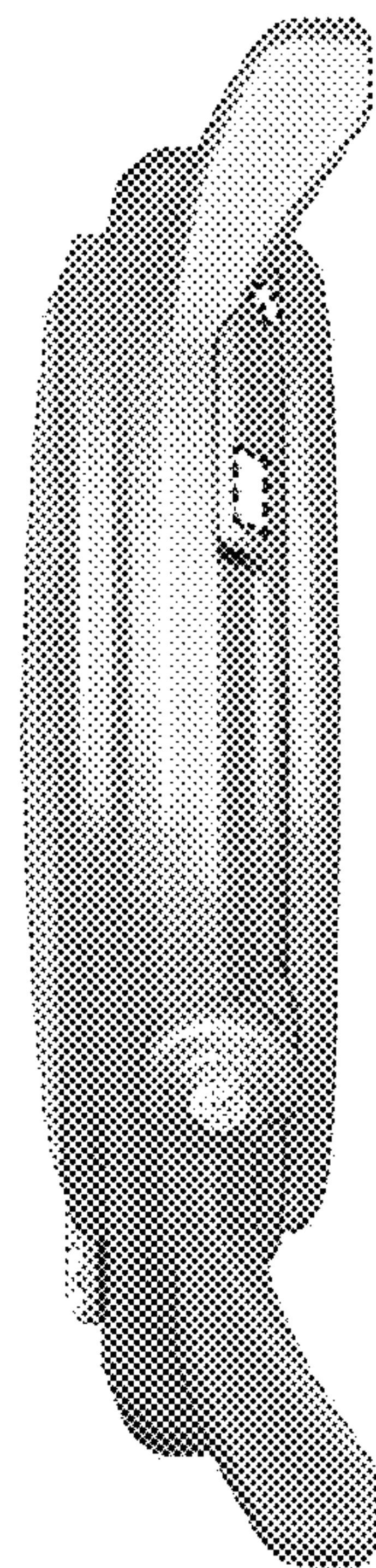

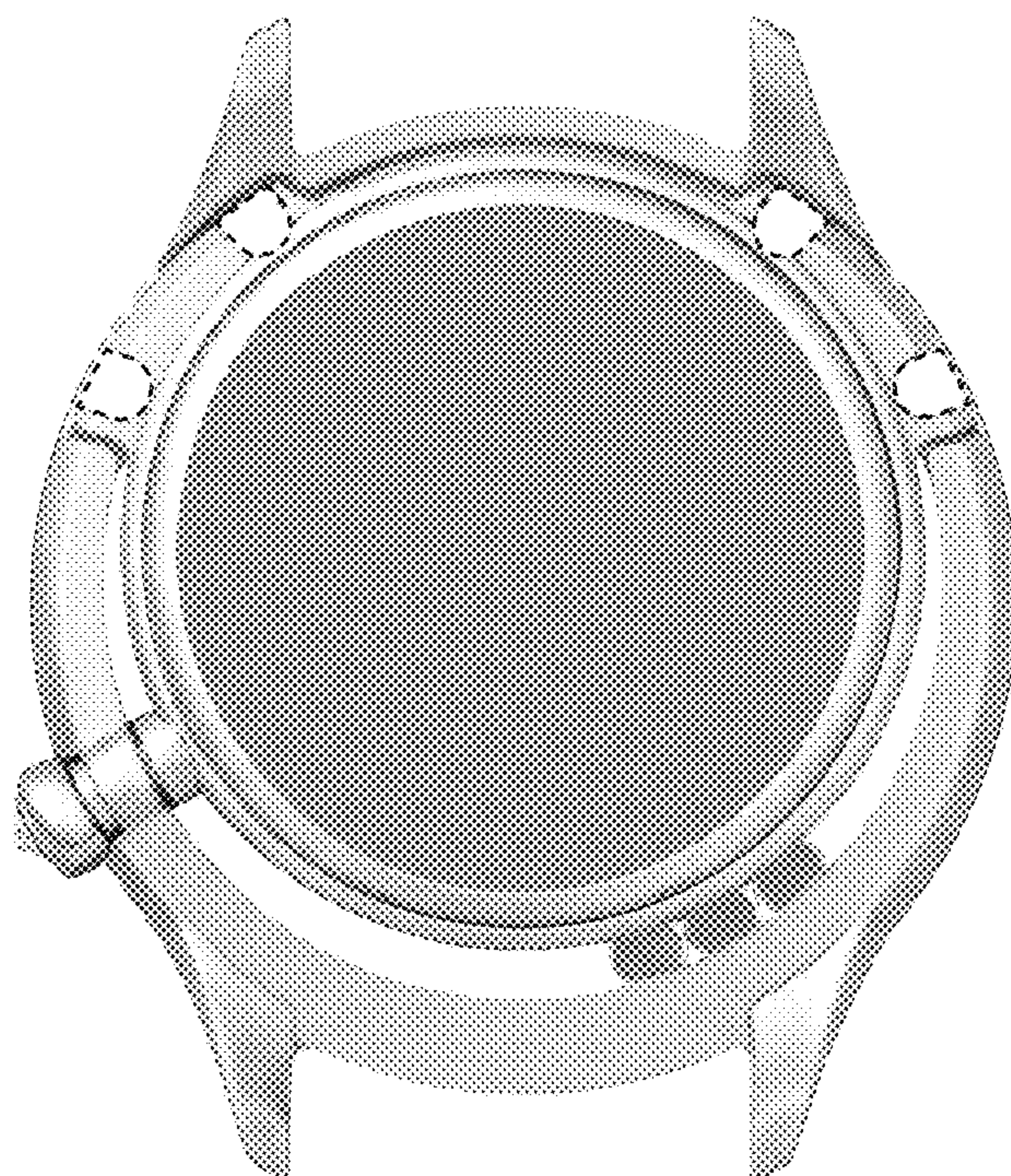

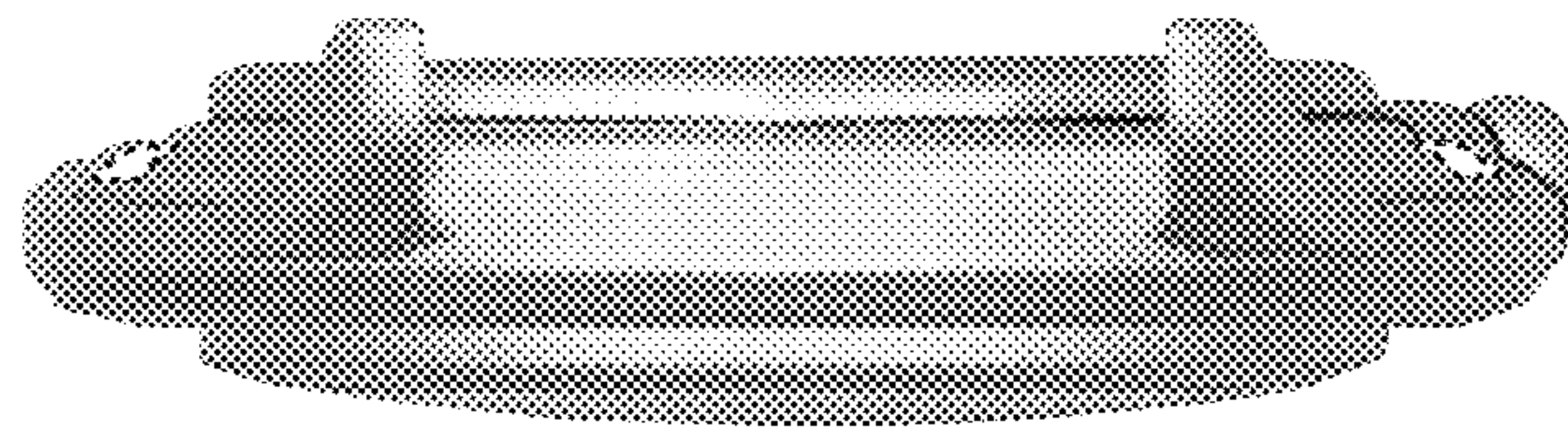

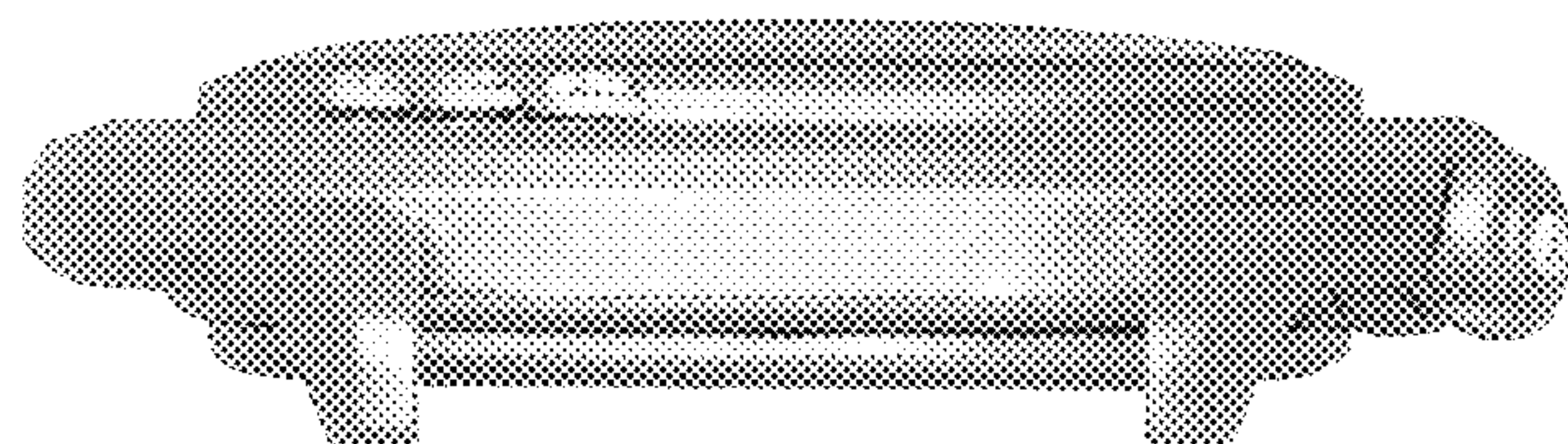
