The ornamental design for a front bumper for a motor vehicle, as shown and described.

FIG. 4 is a right side view thereof;

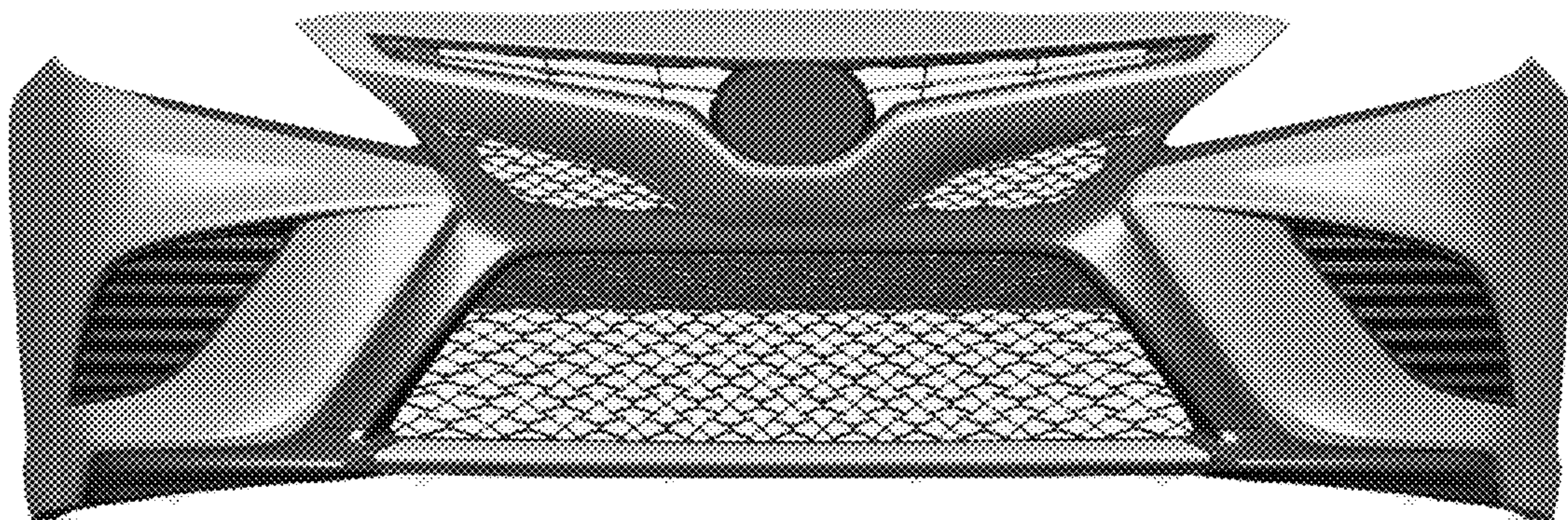
FIG. 5 is a left side view thereof;

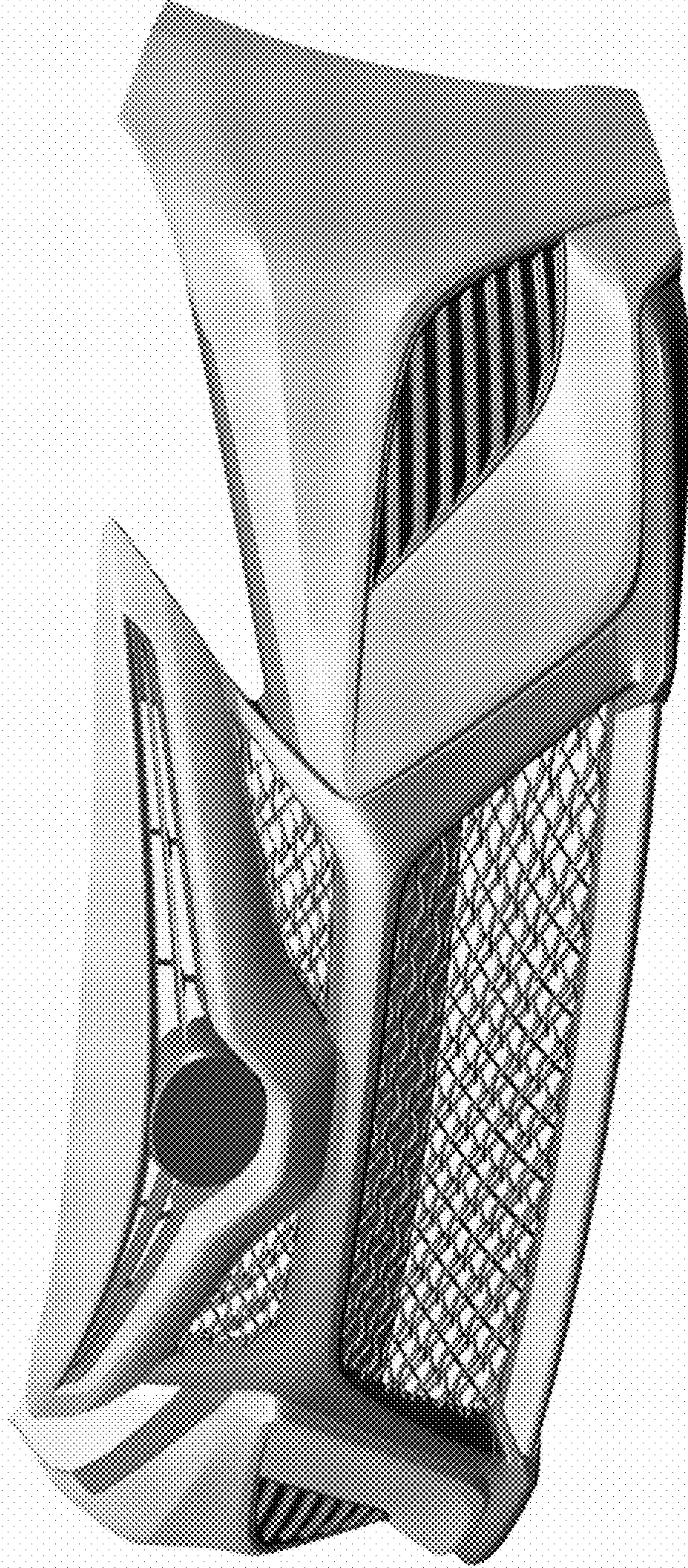

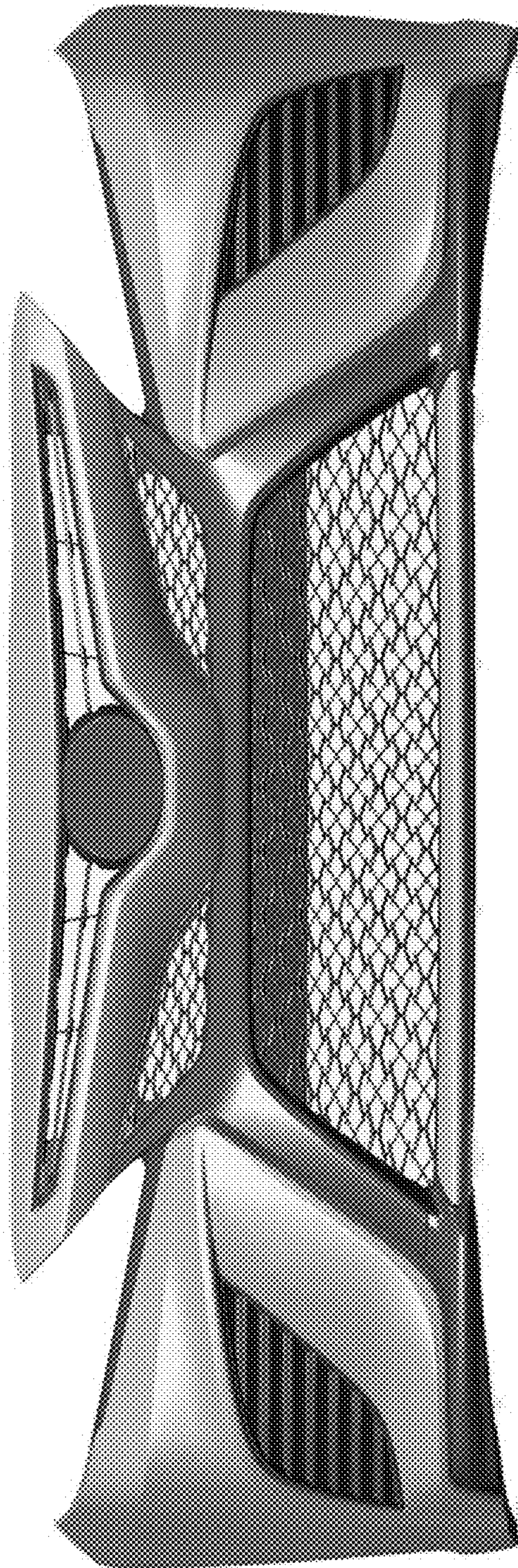

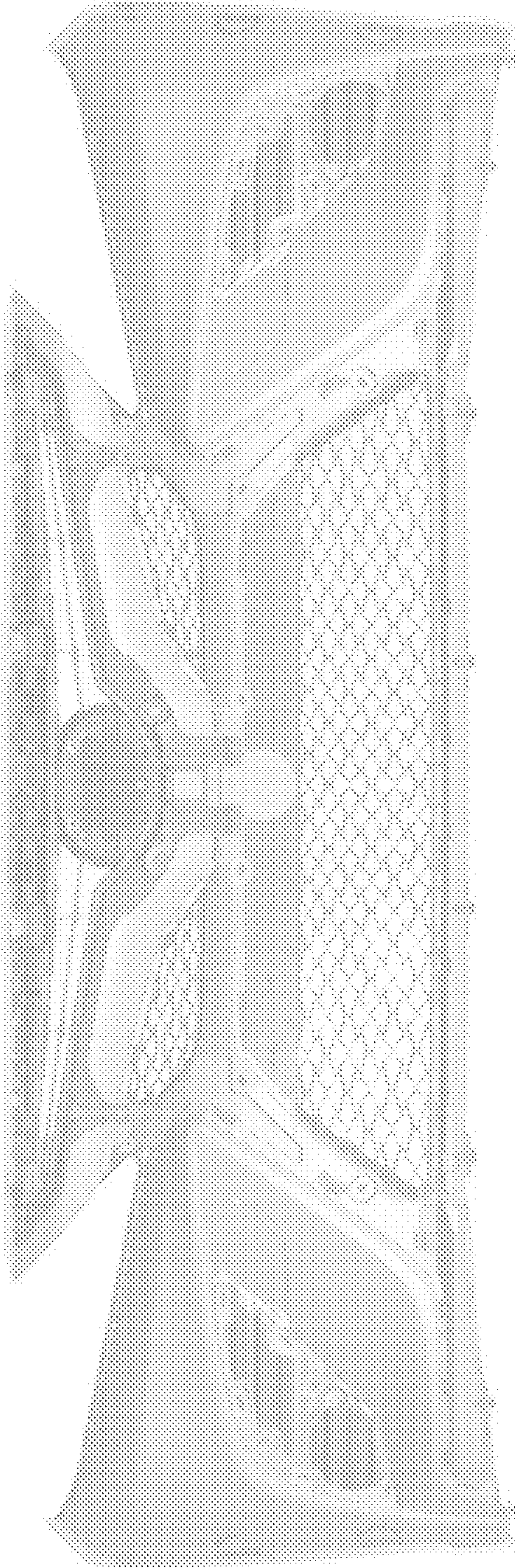

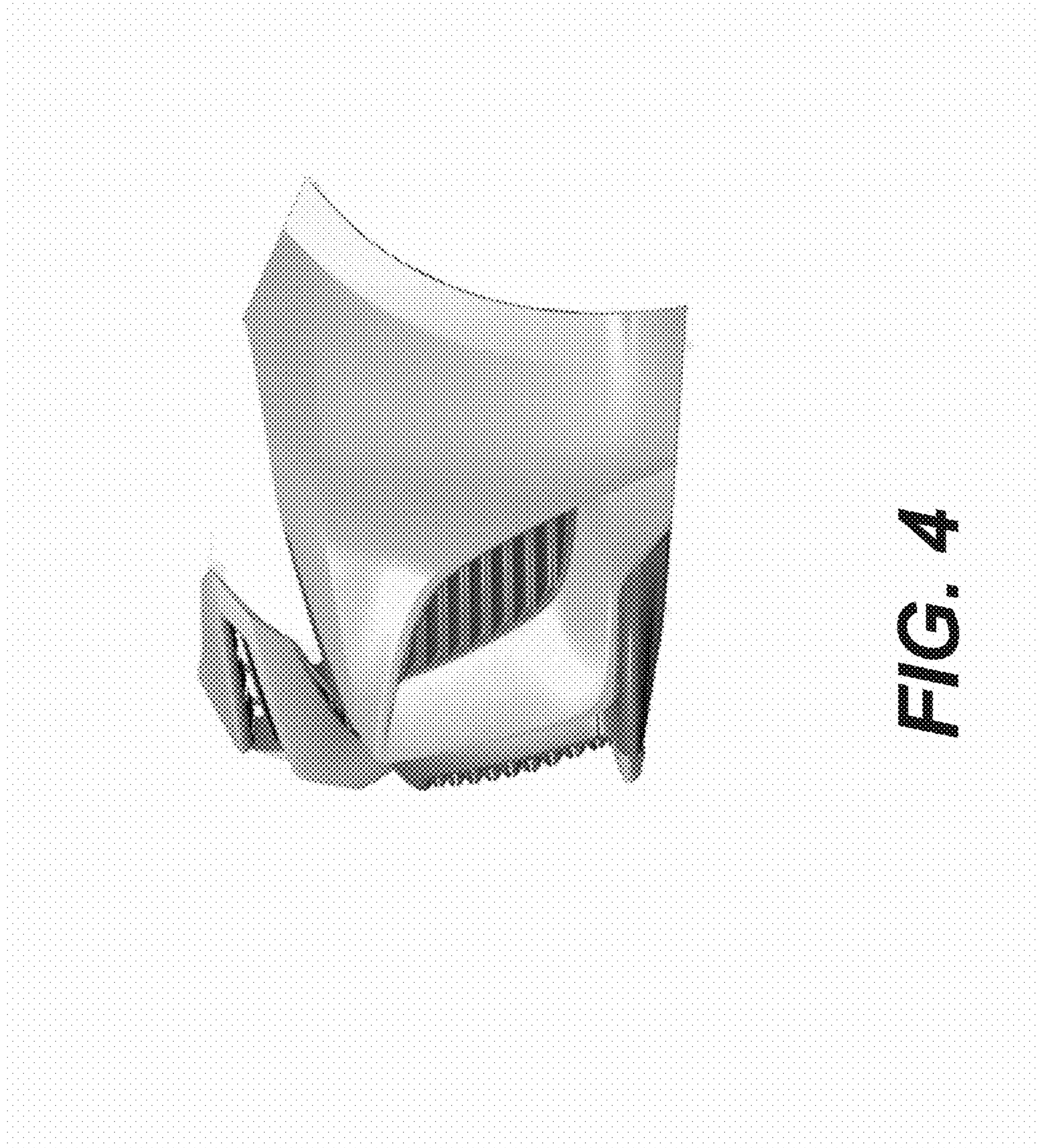

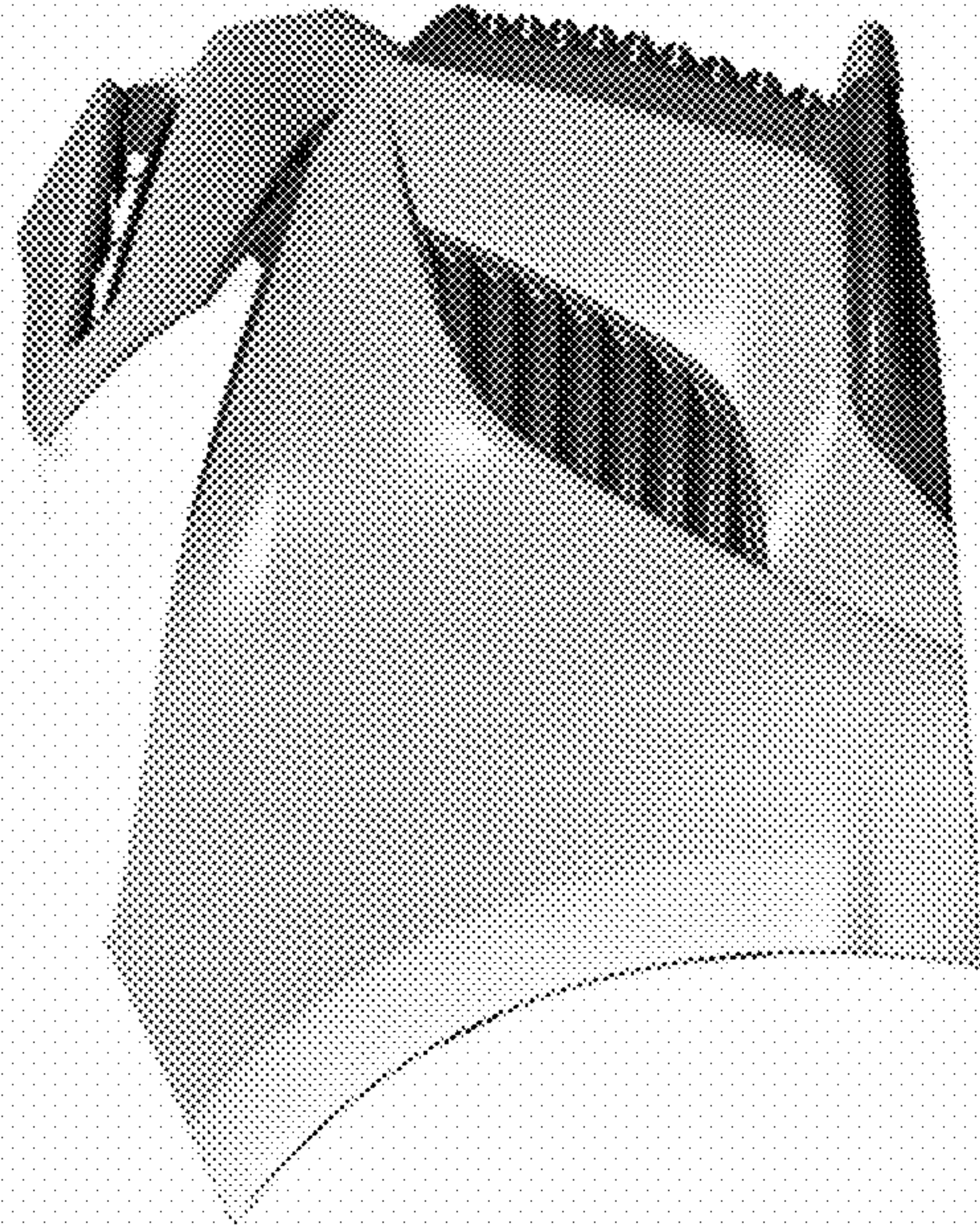

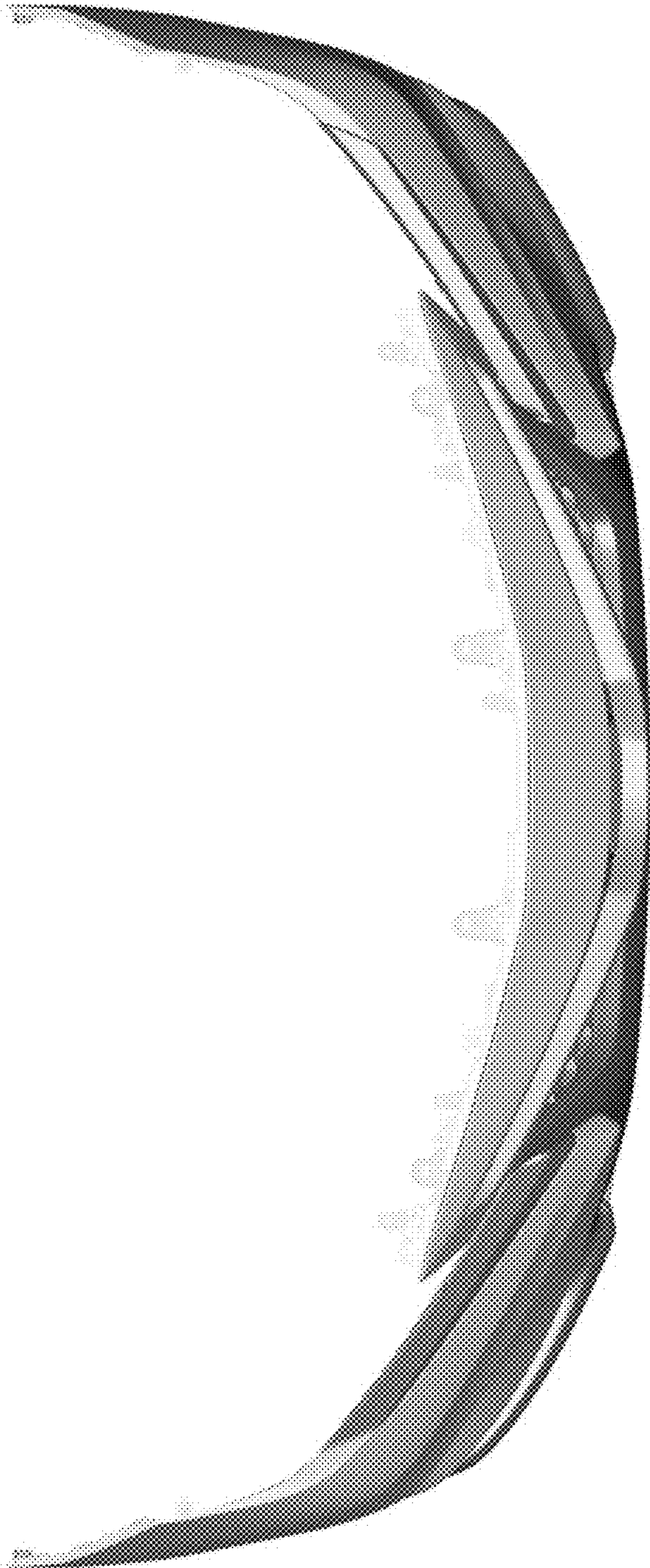

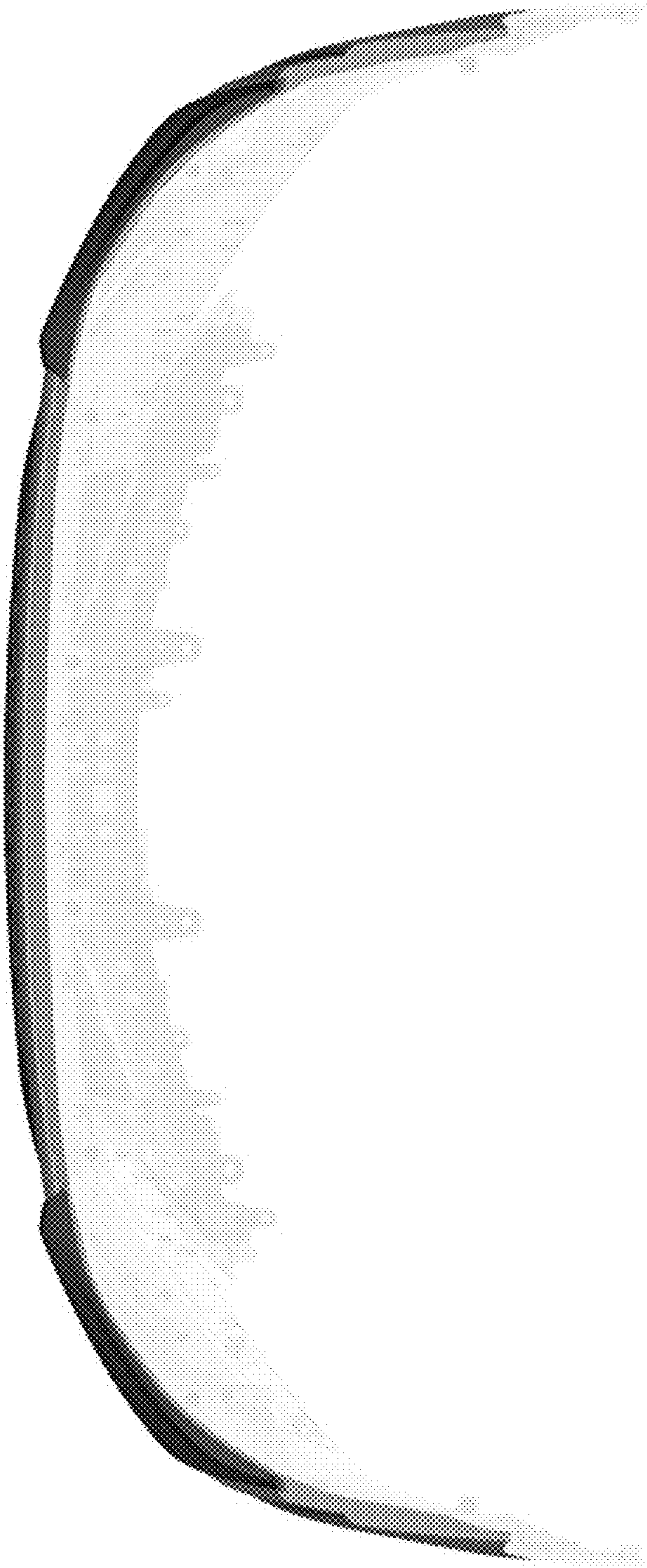
