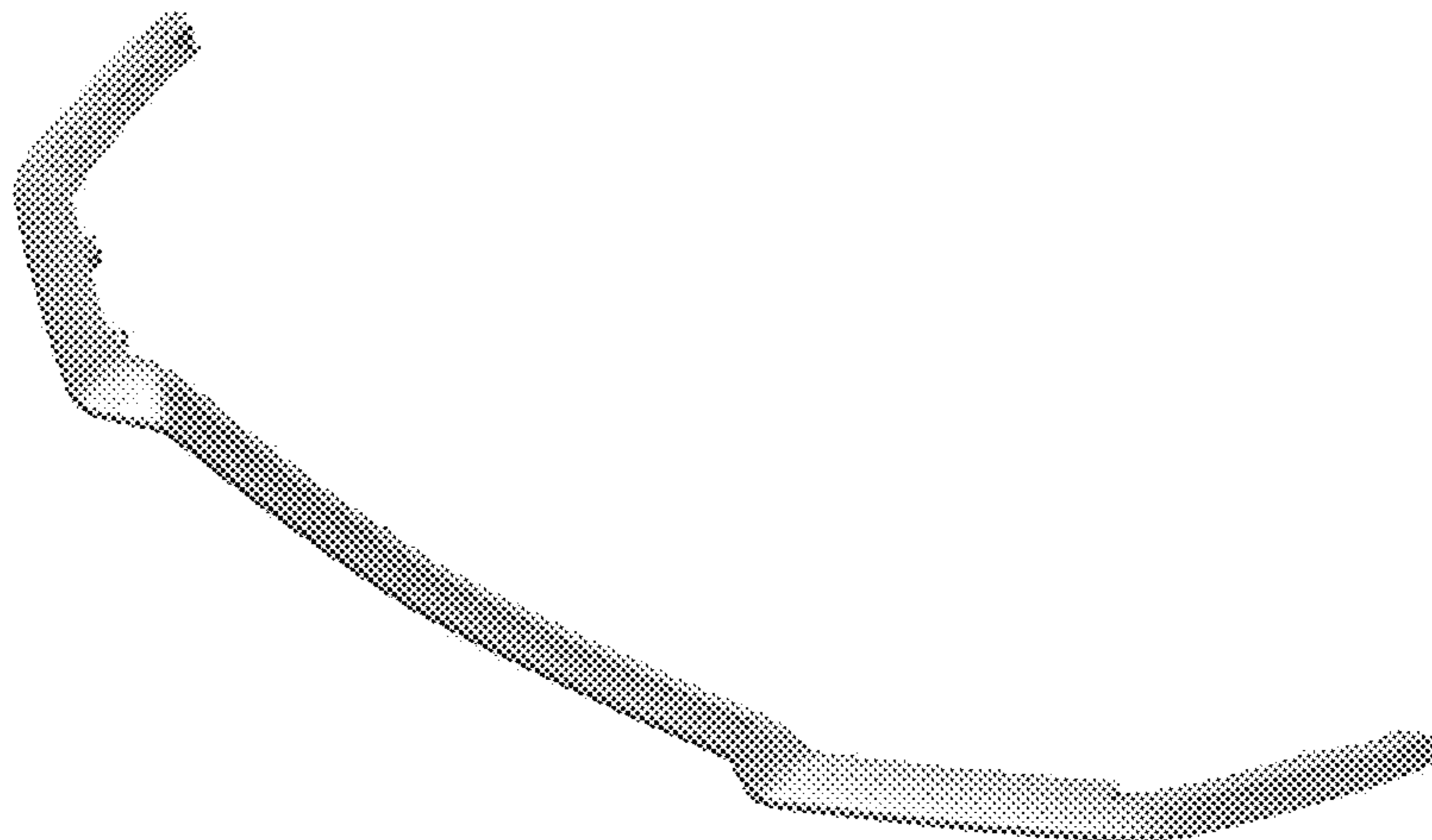
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top left perspective view of a vehicle front lower bumper cover, showing our new design;

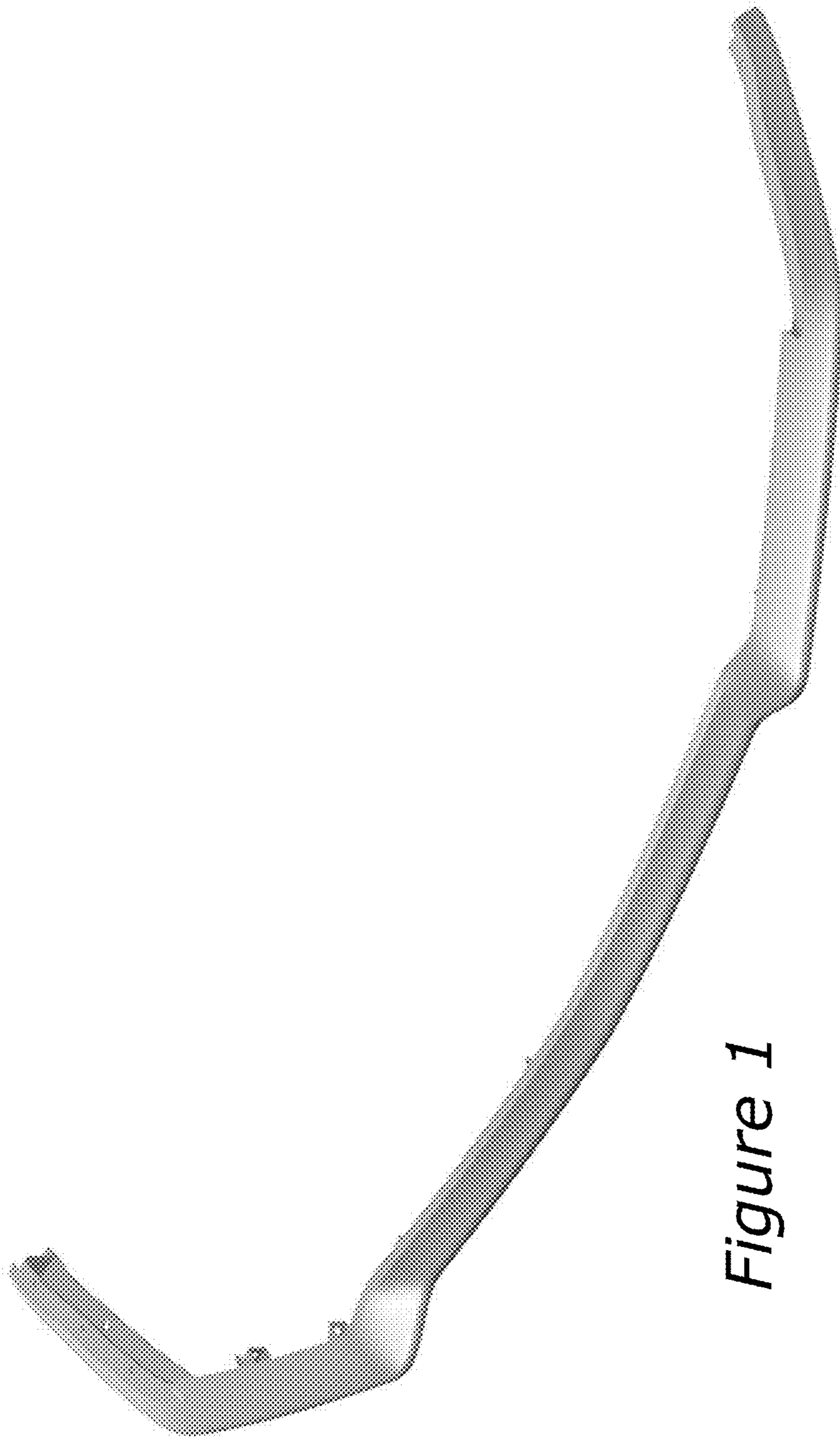

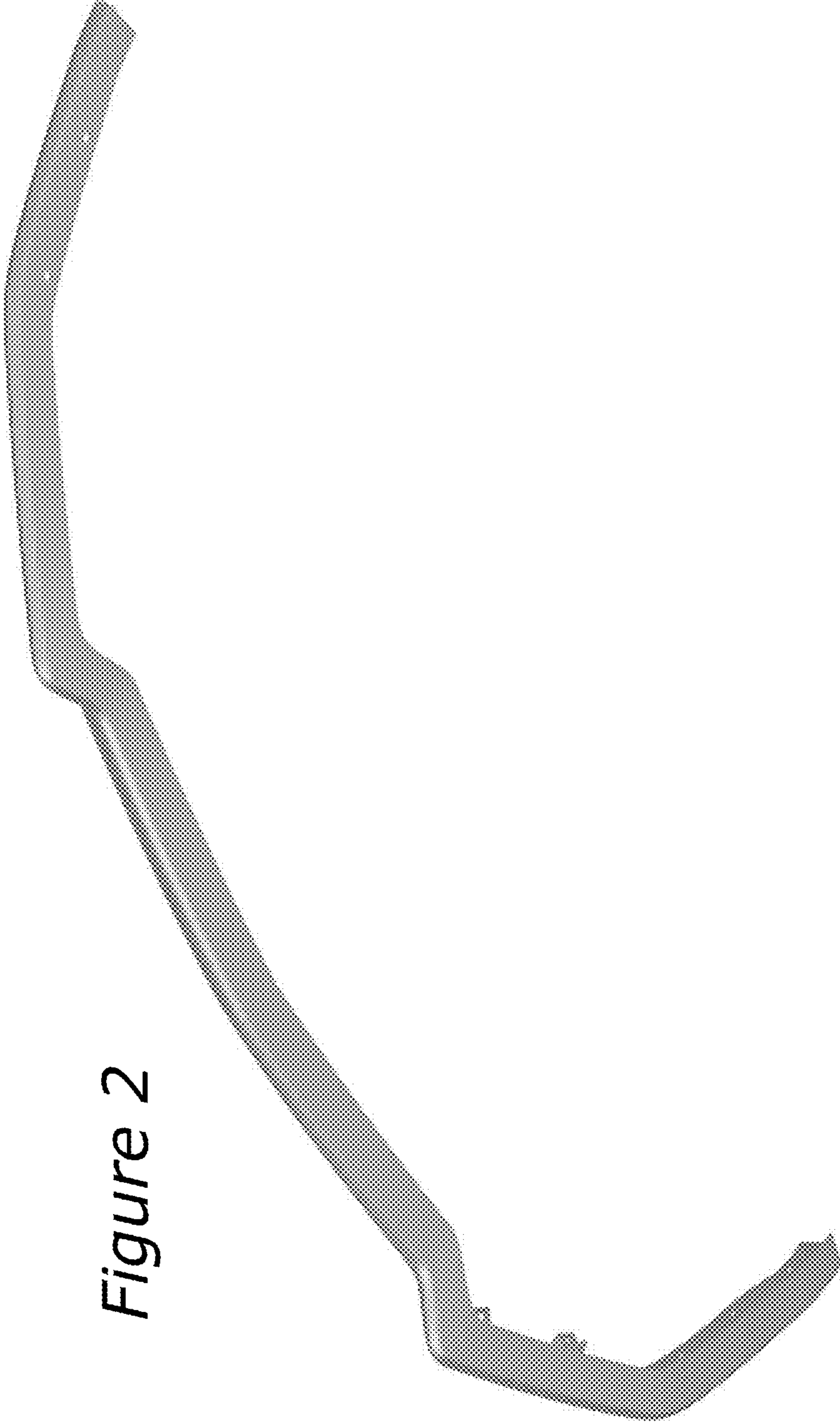

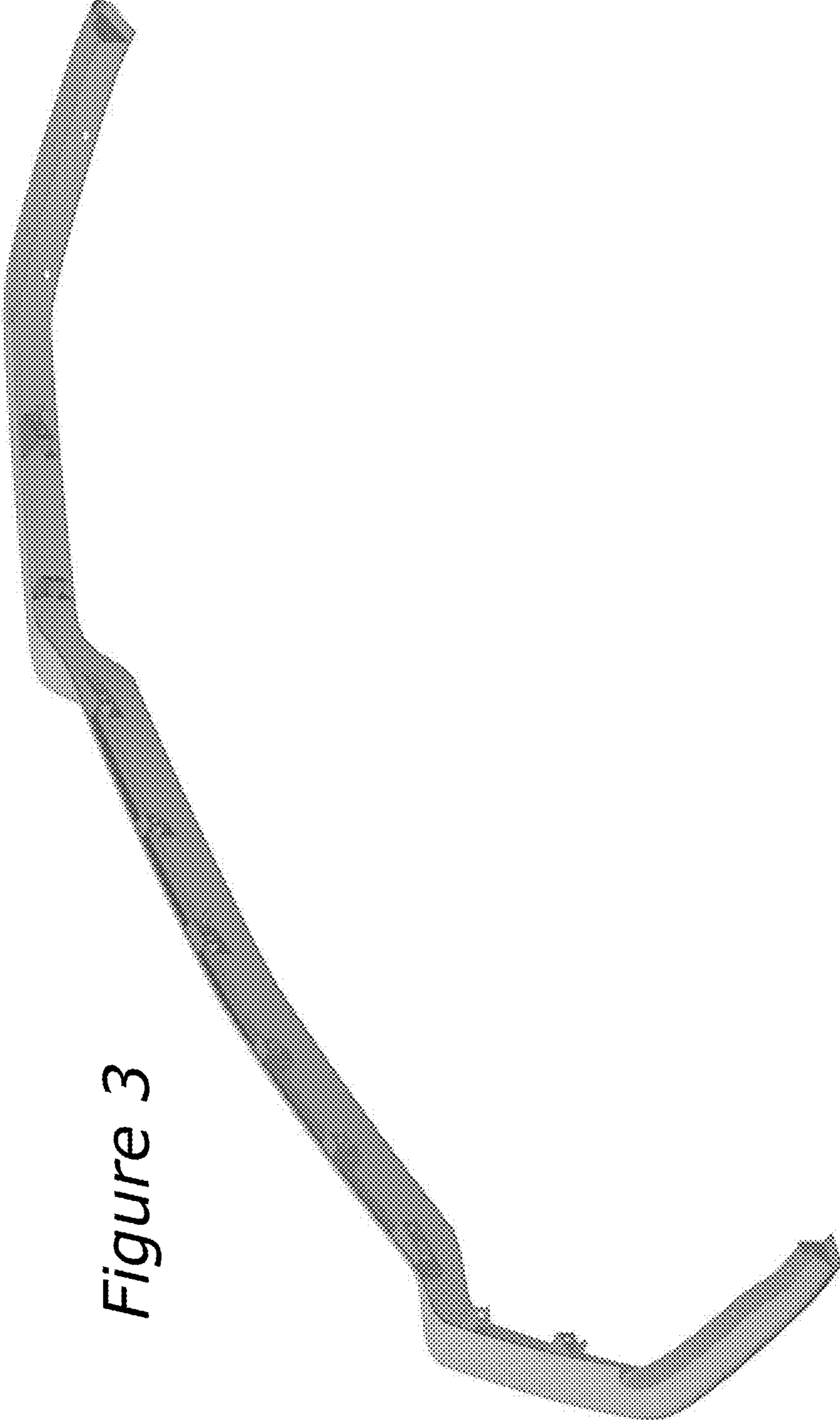

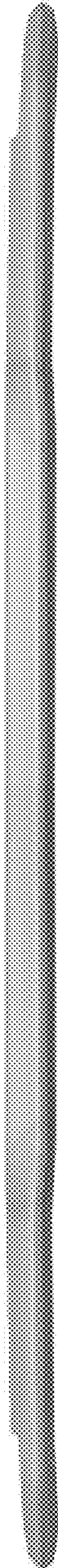

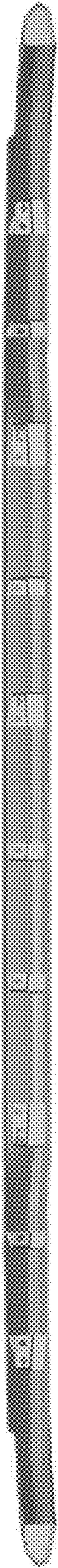
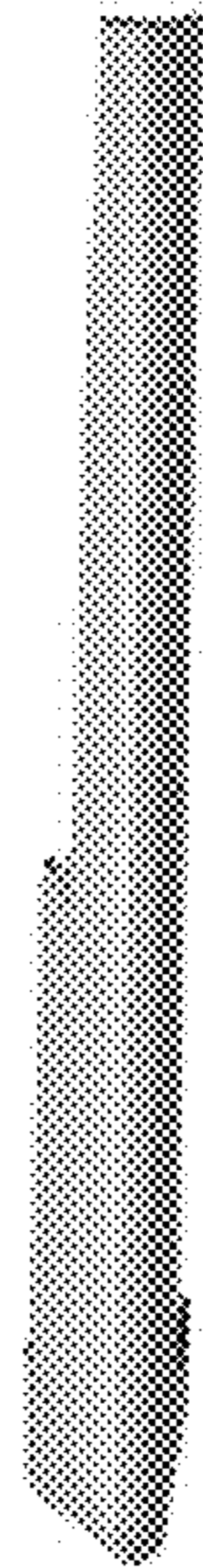

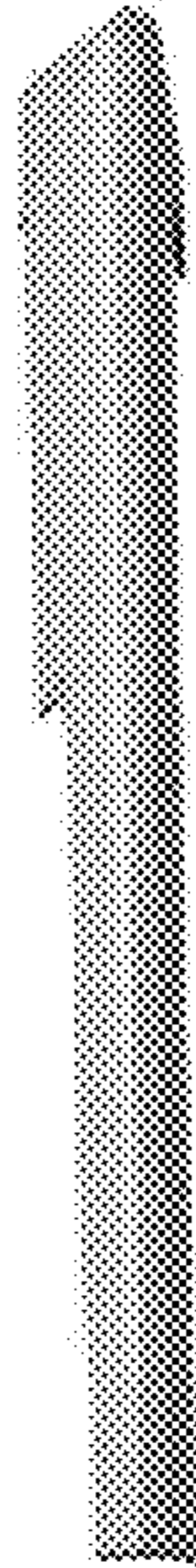

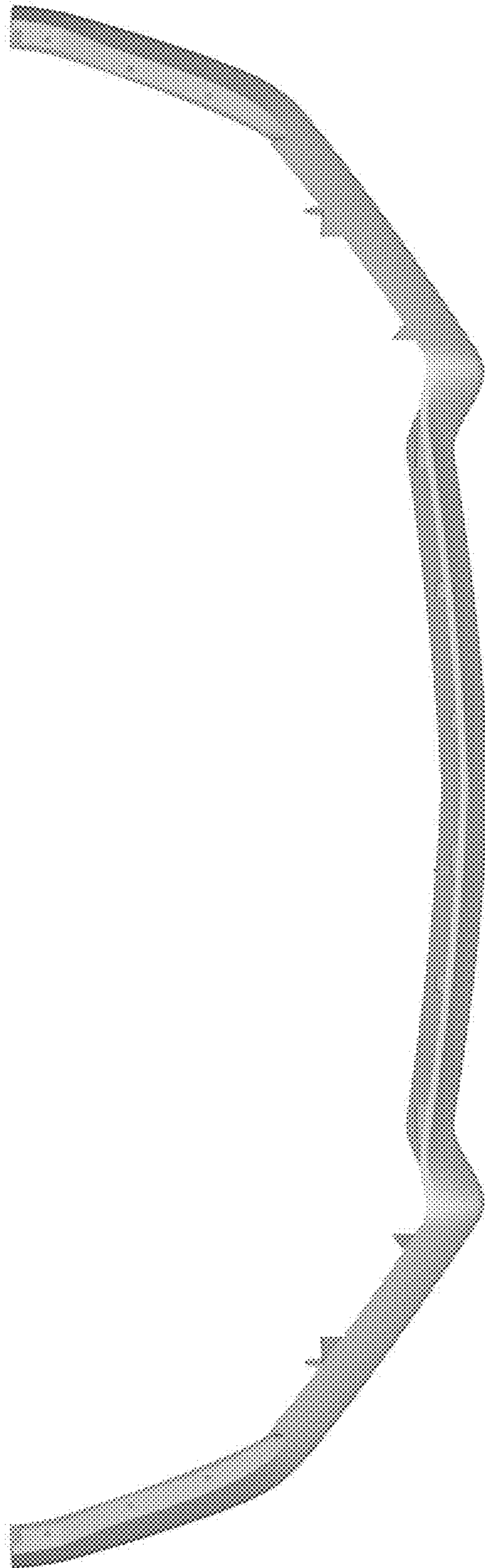
