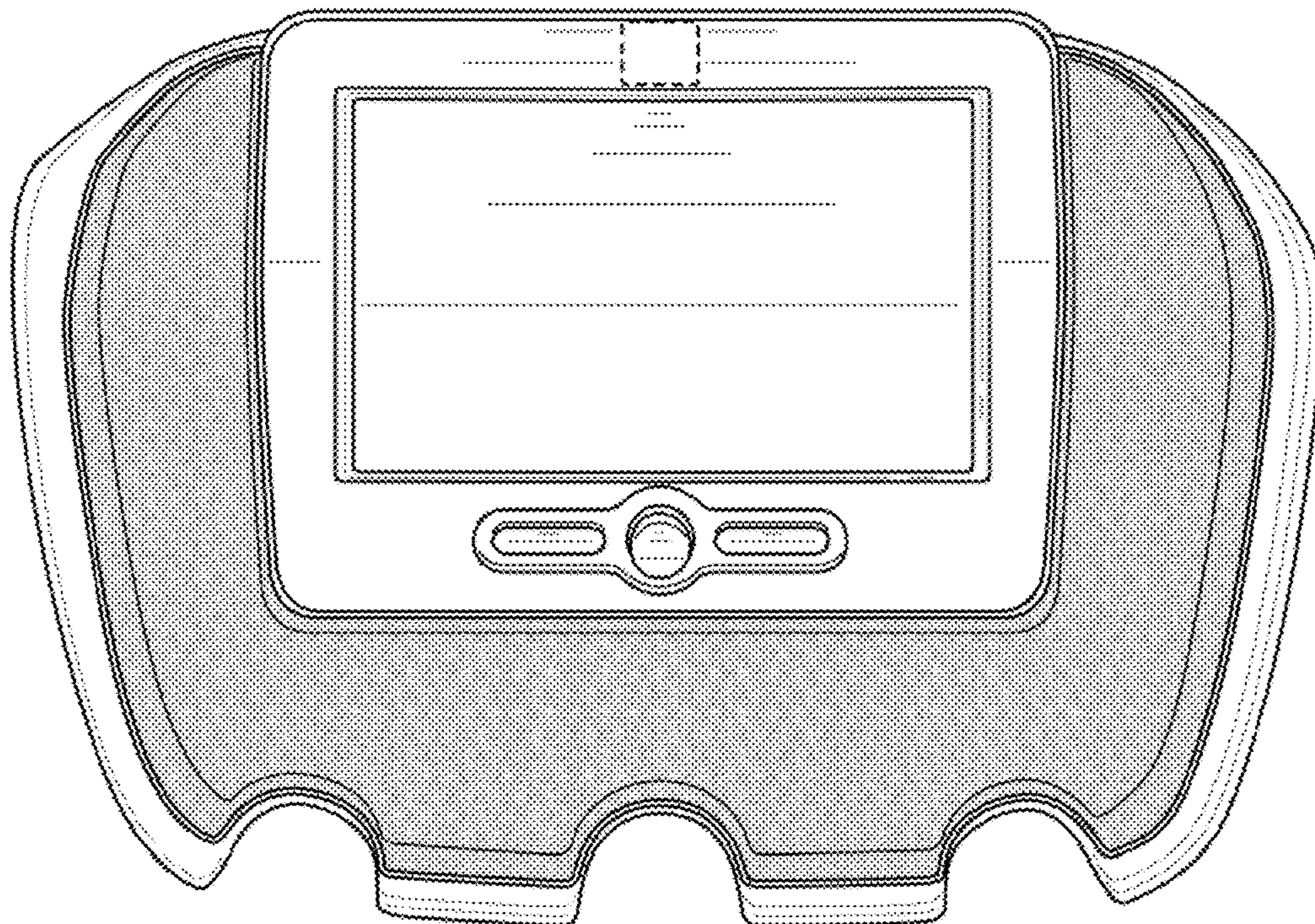
(57) **CLAIM**

The ornamental design for a vehicle display unit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a vehicle display unit showing the new design;
FIG. 2 is a back view of the vehicle display unit;
FIG. 3 is a top view of the vehicle display unit;
FIG. 4 is a side view of the vehicle display unit;
FIG. 5 is a front perspective view of the vehicle display unit;

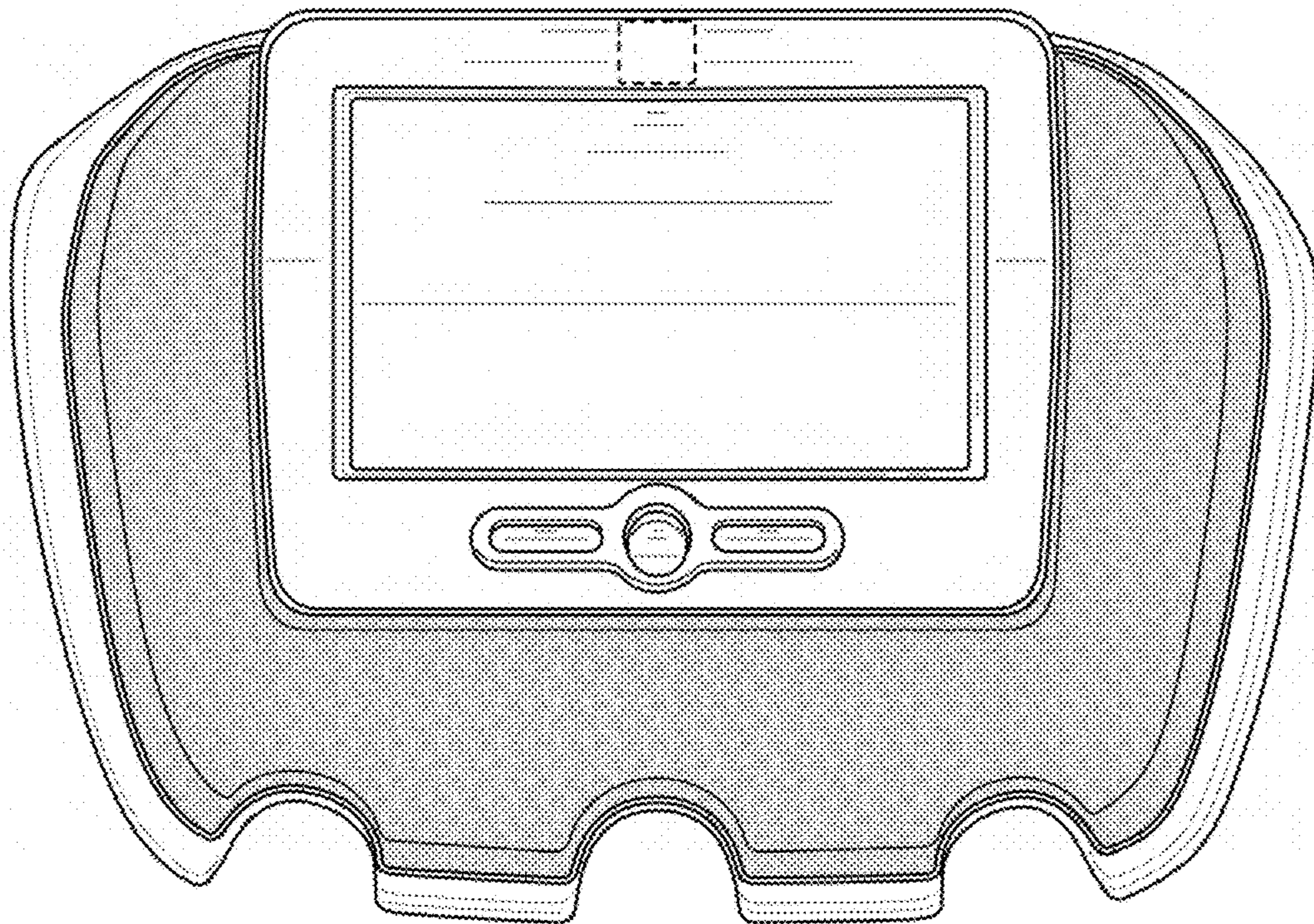

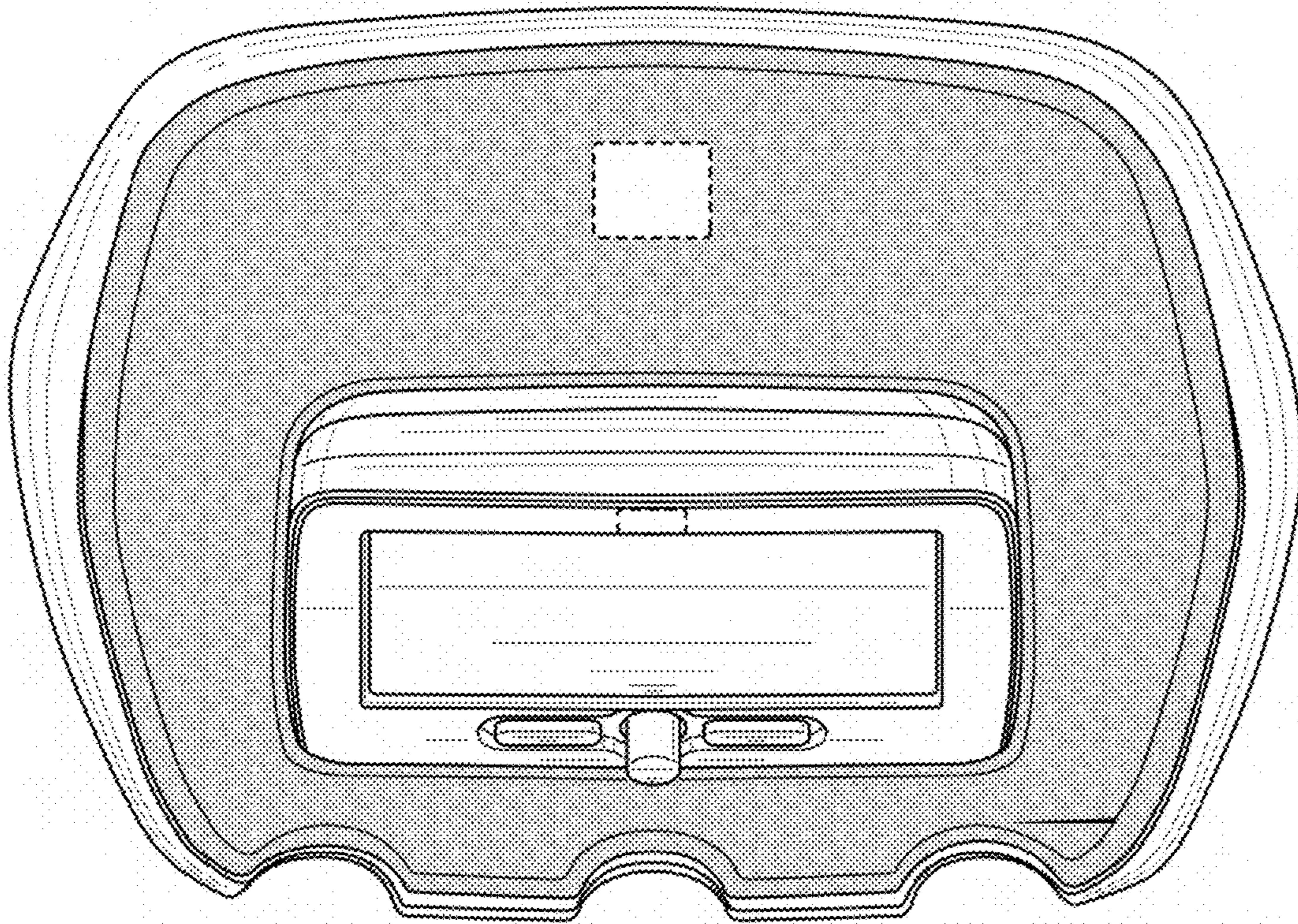

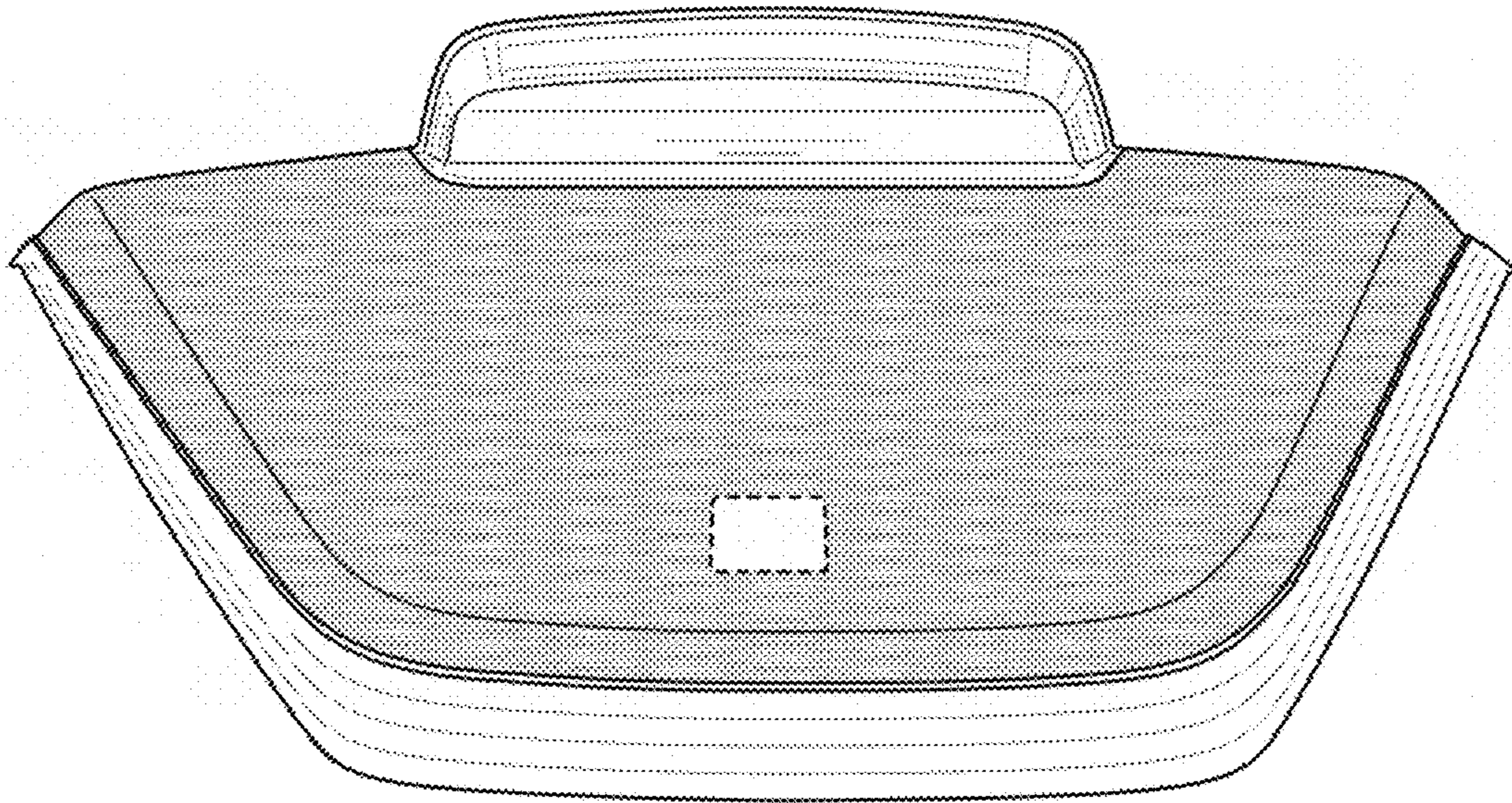

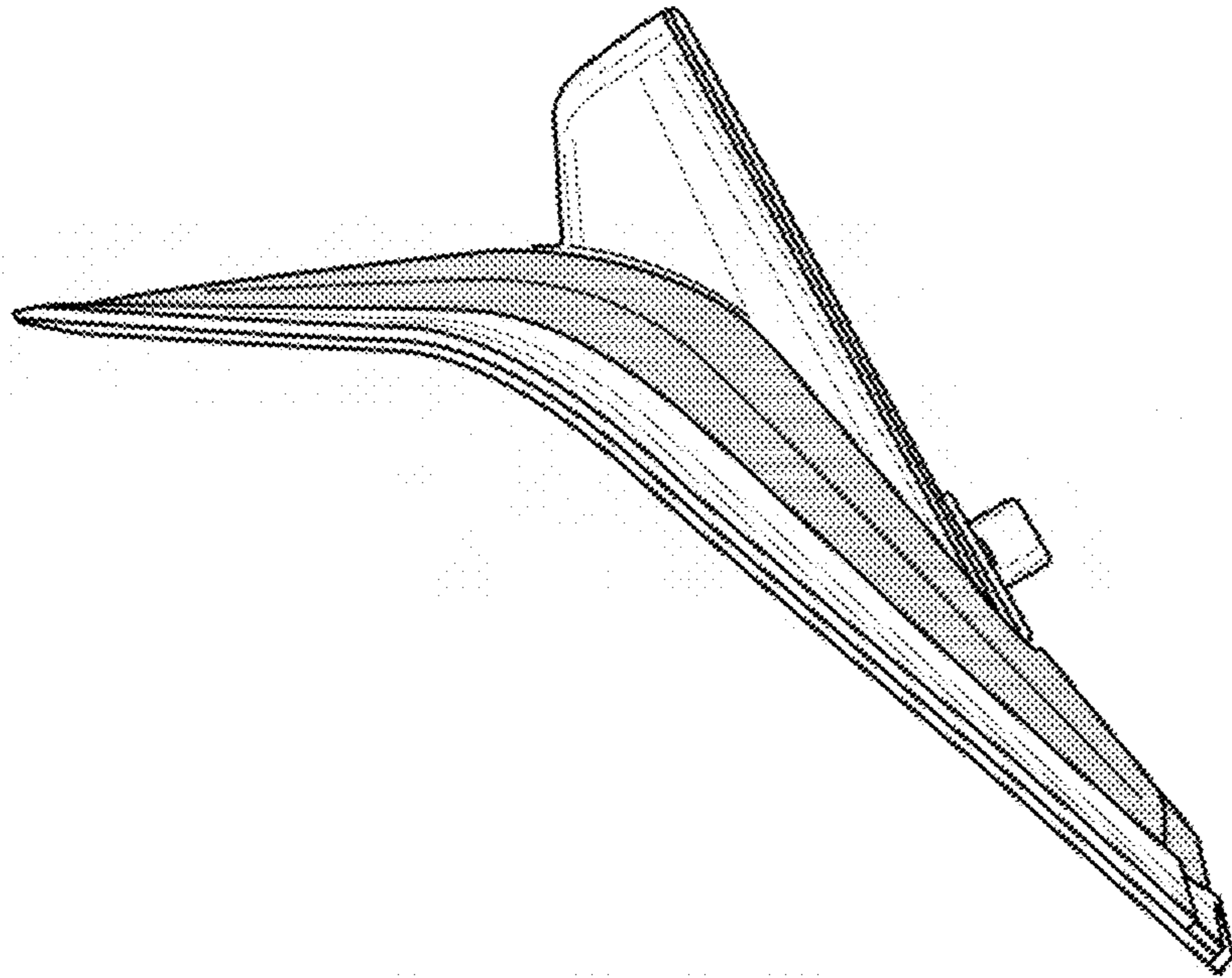

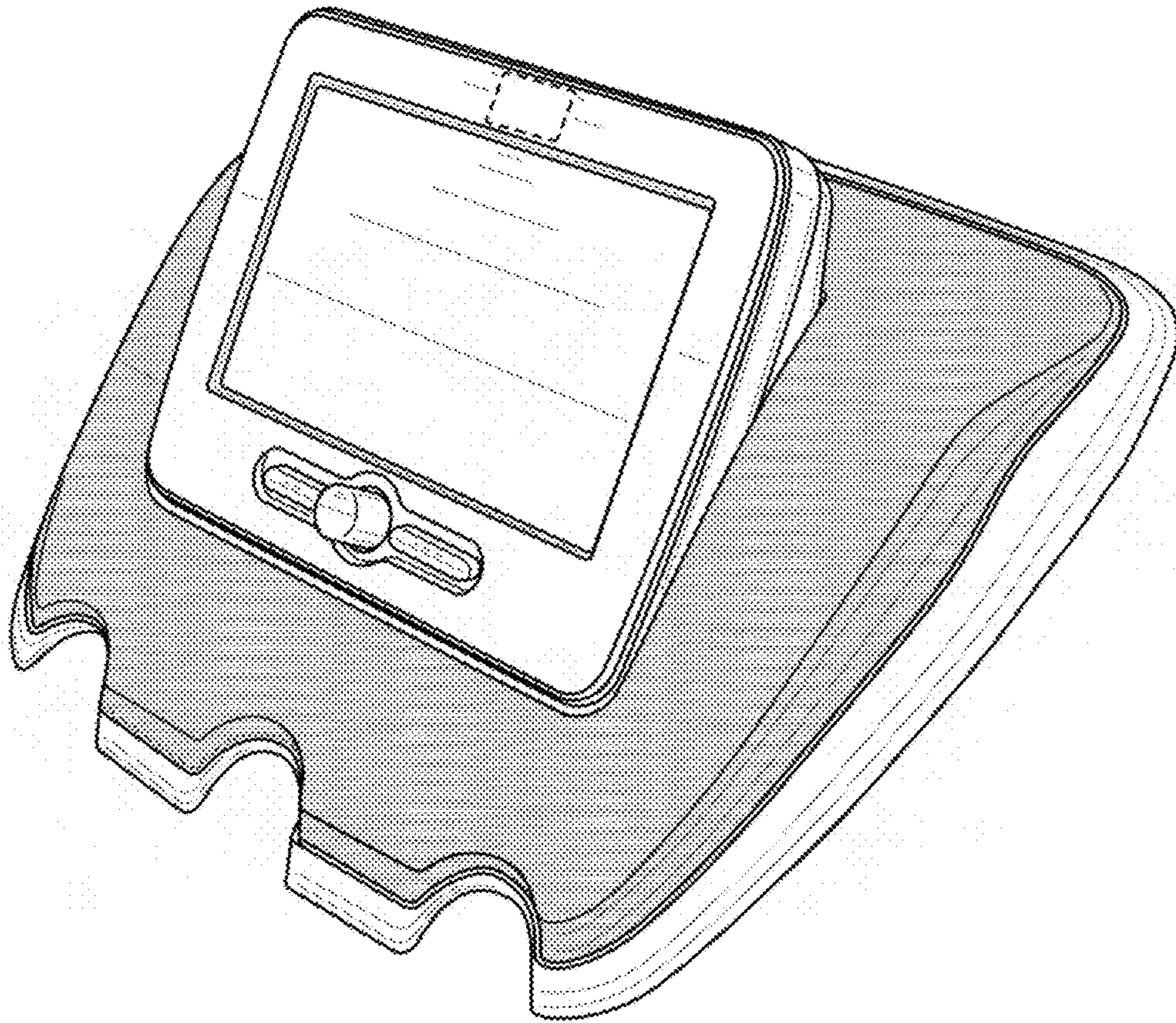

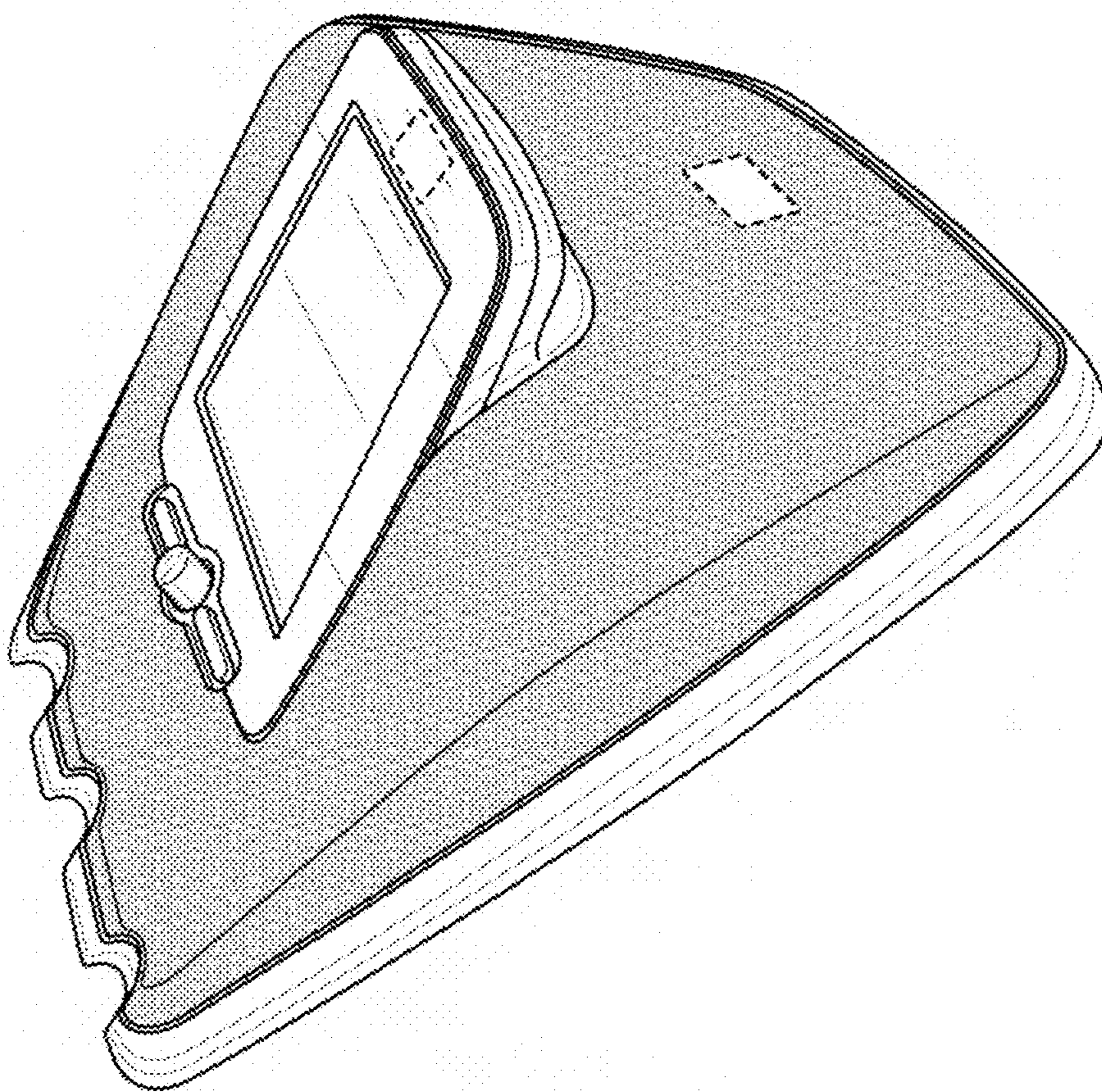

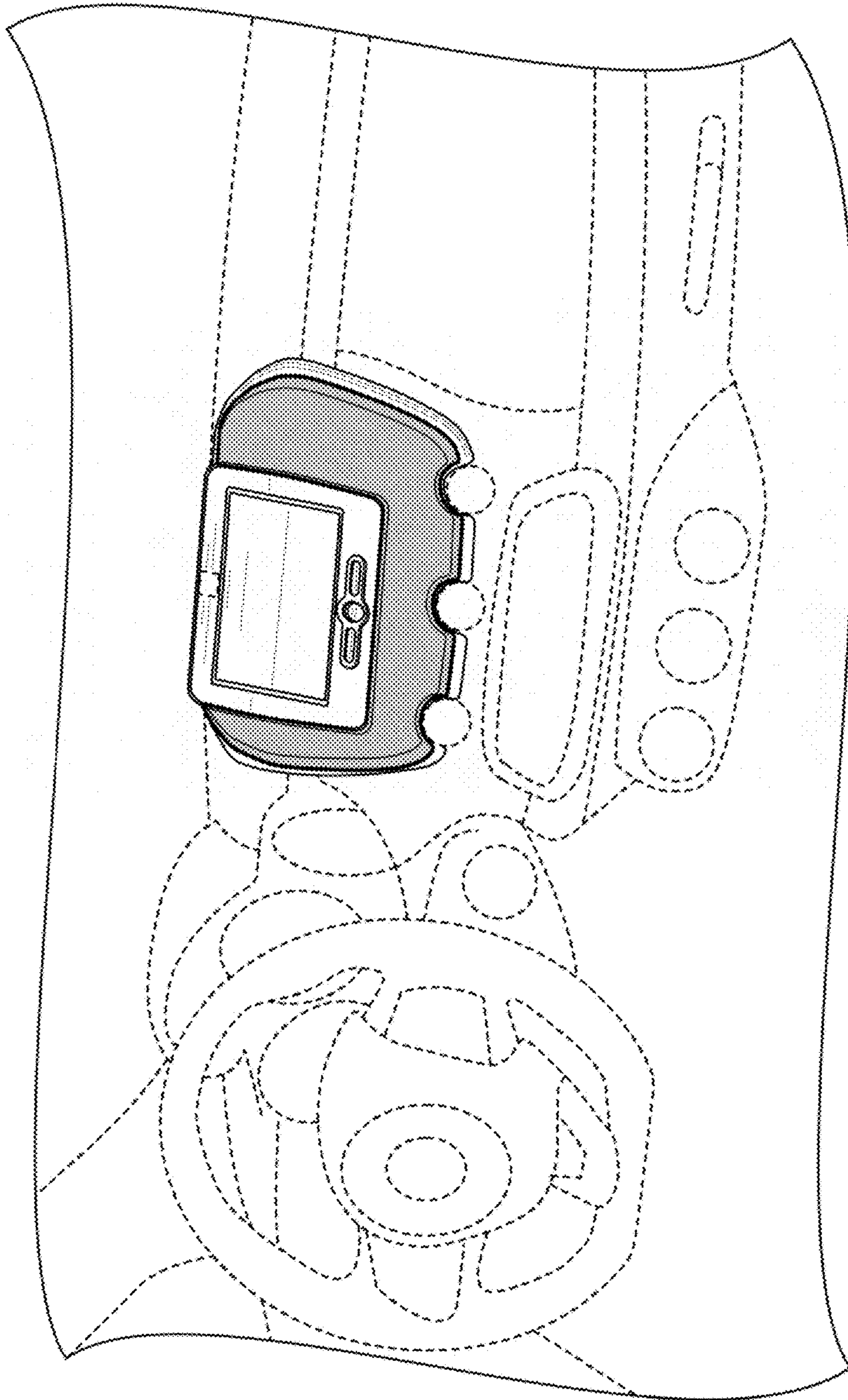
