(57) **CLAIM**

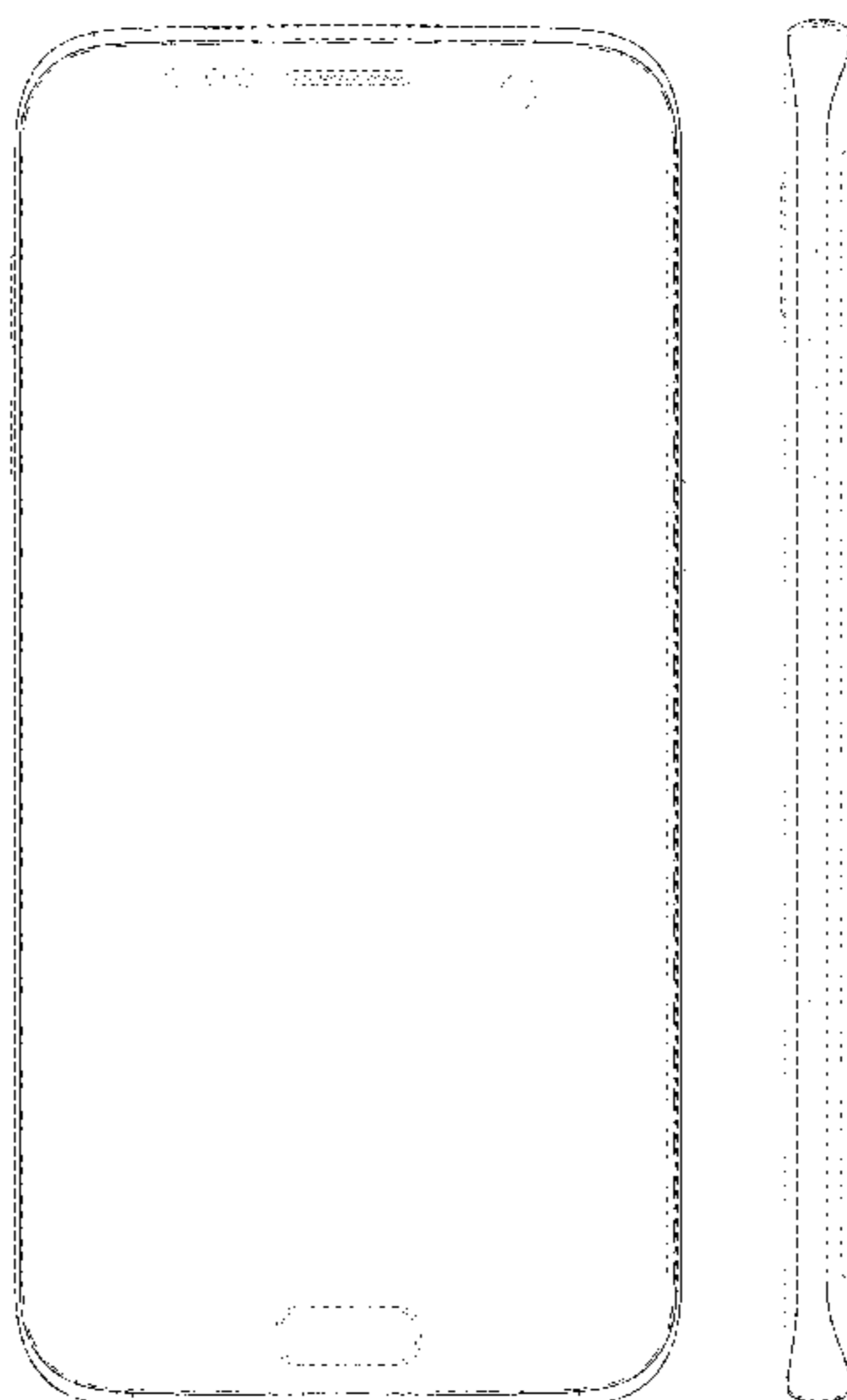
We claim the ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electronic device, showing our new design;

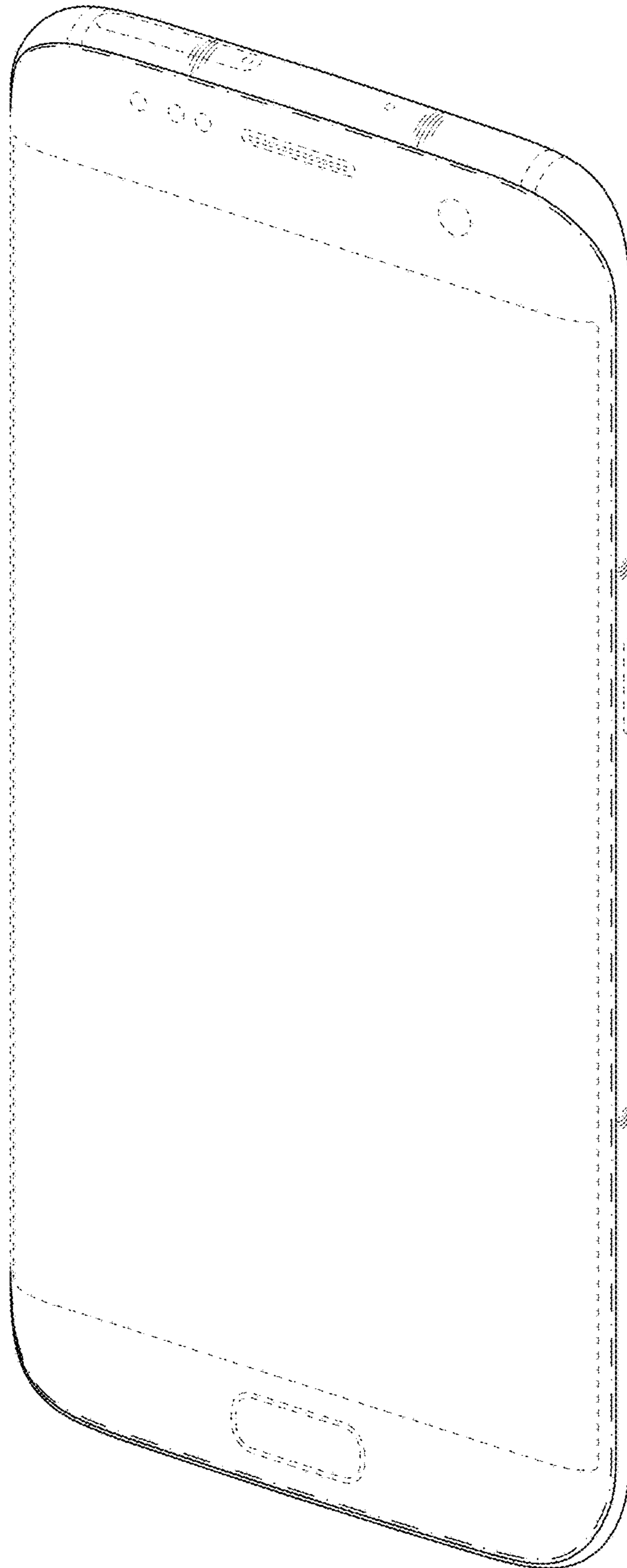

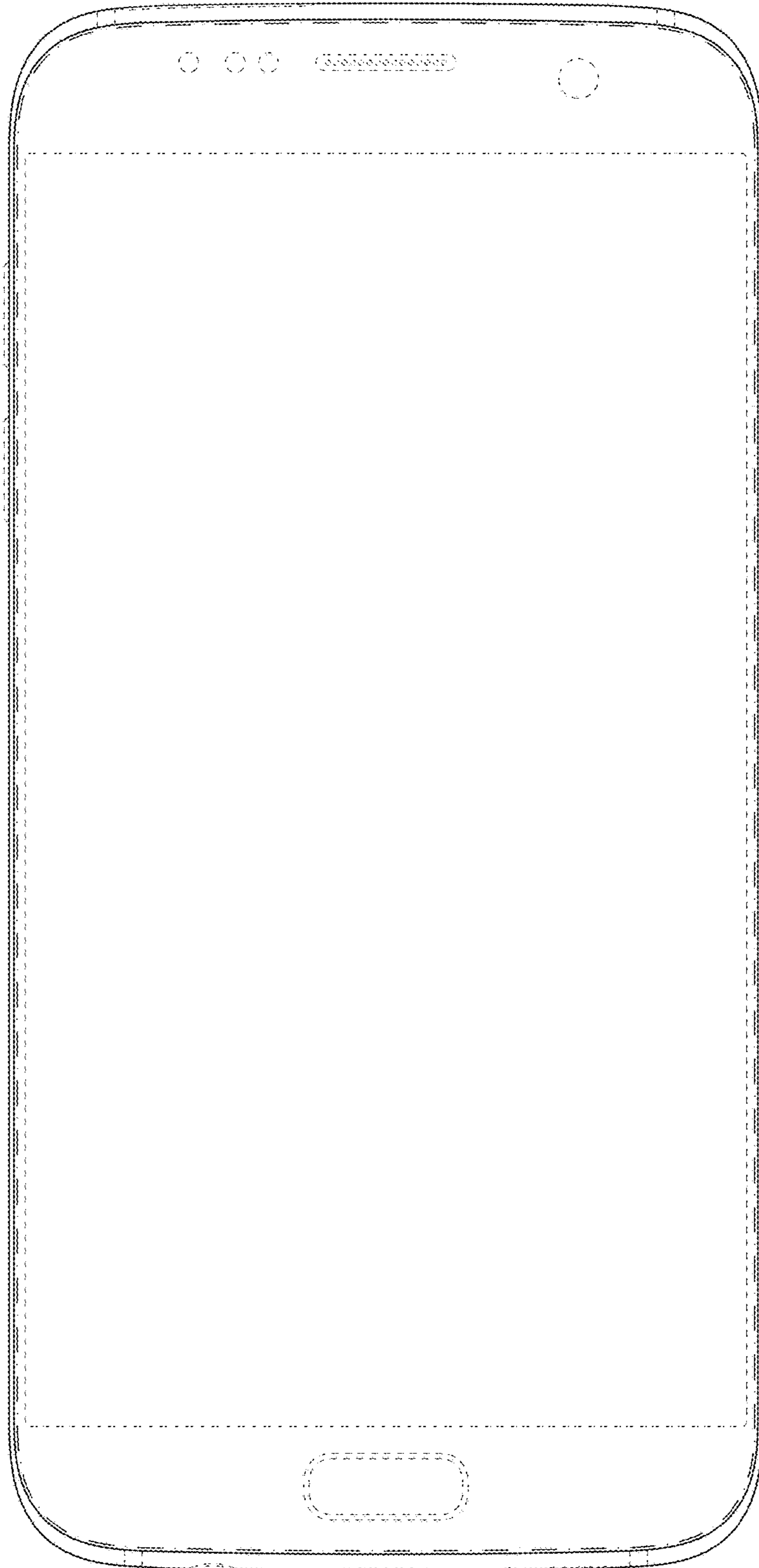

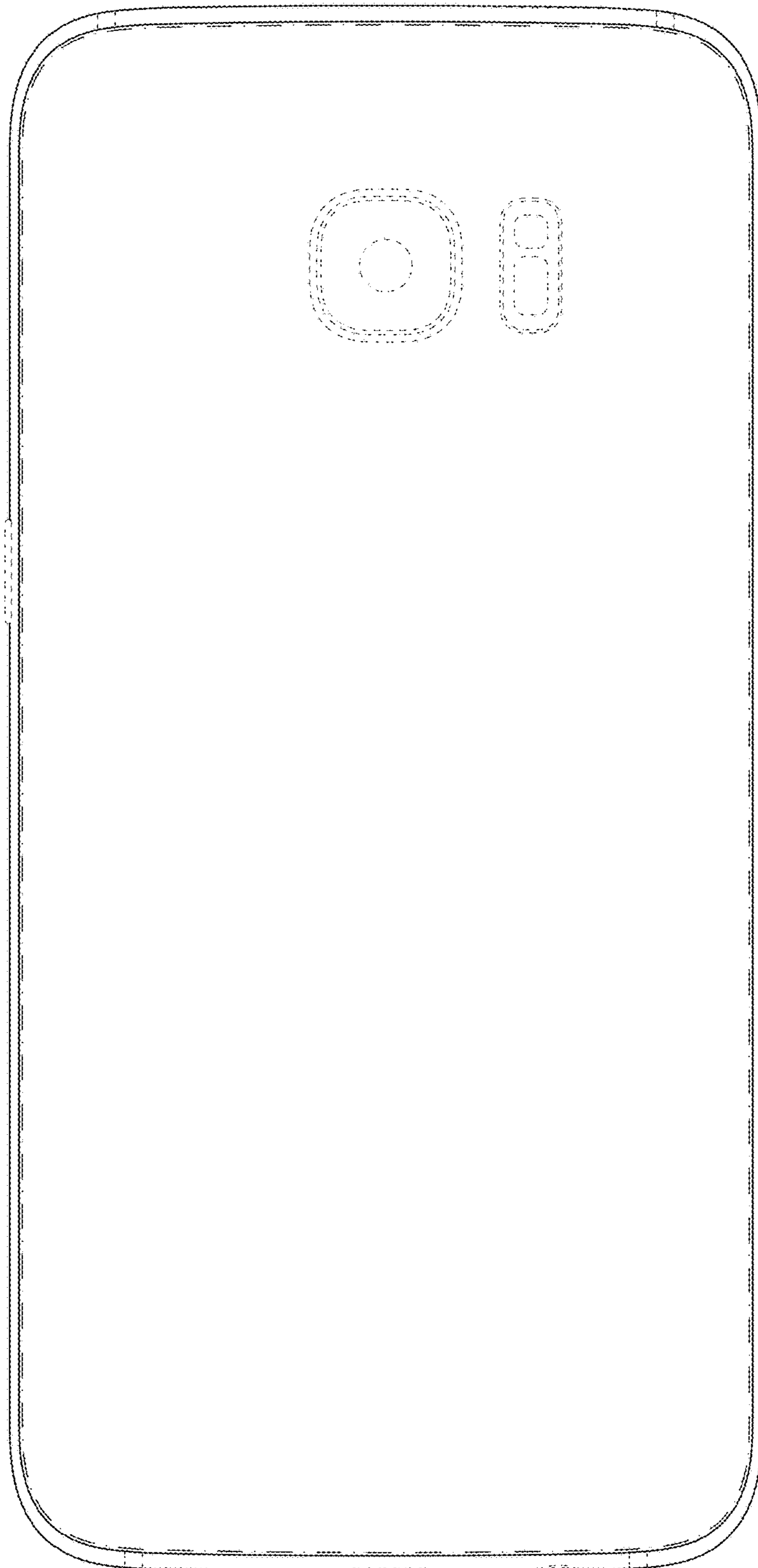

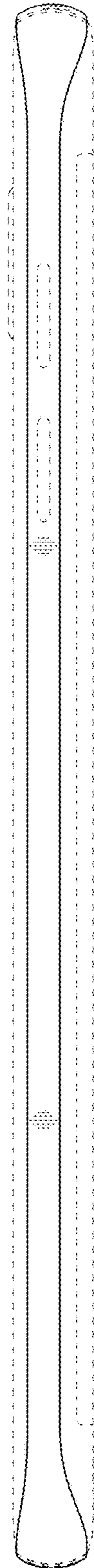

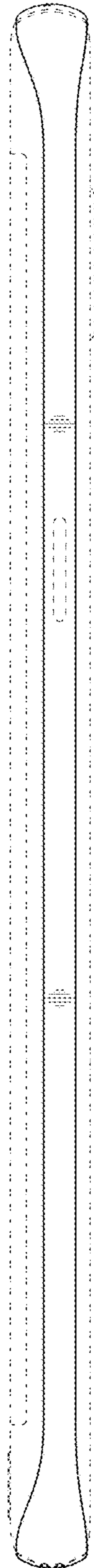

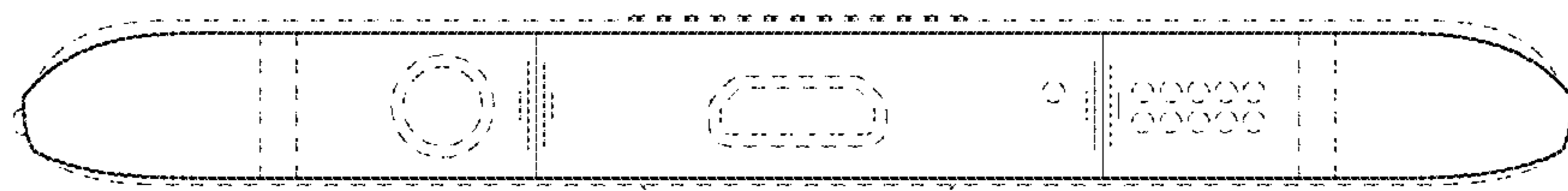
