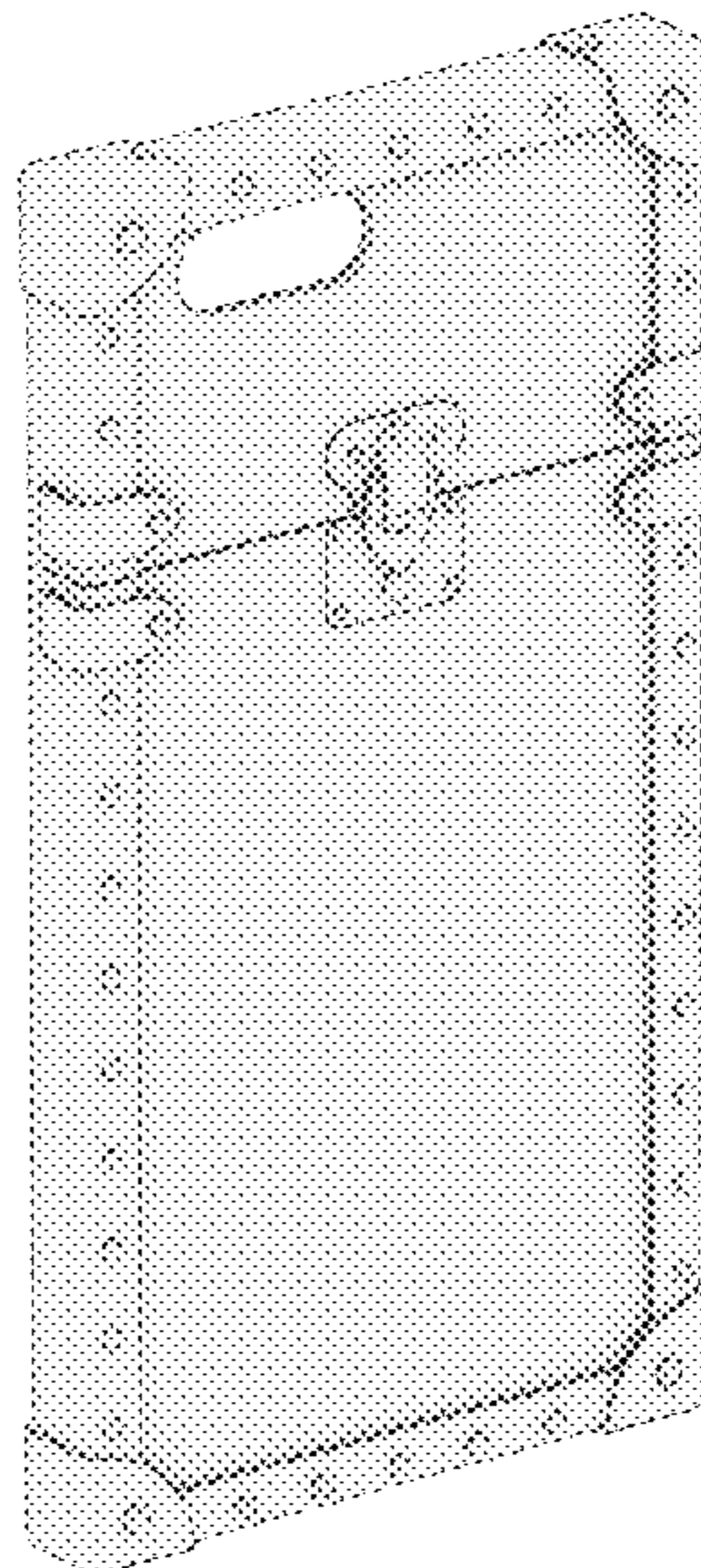

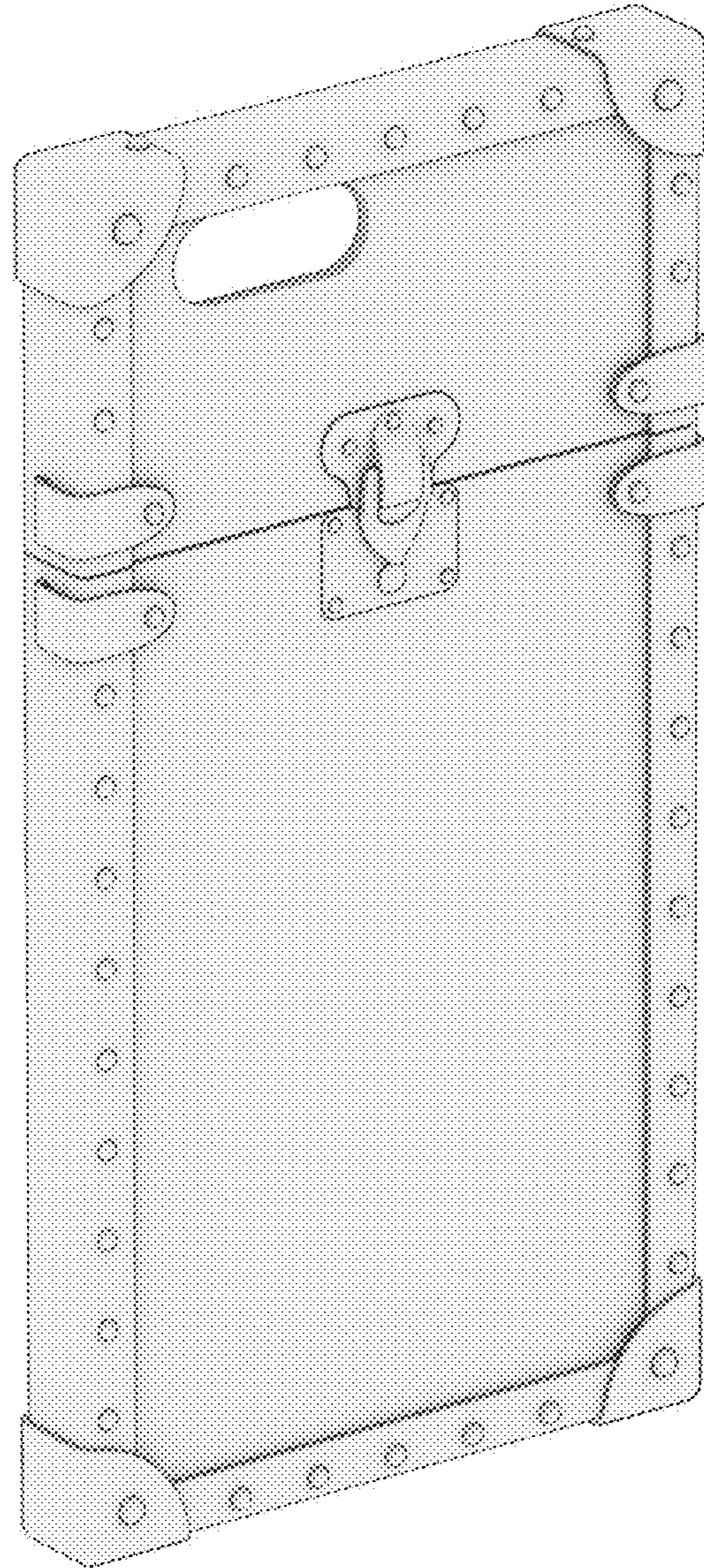
The ornamental design for a phone case, as shown and described.

FIG. 8 is a bottom plan view thereof.

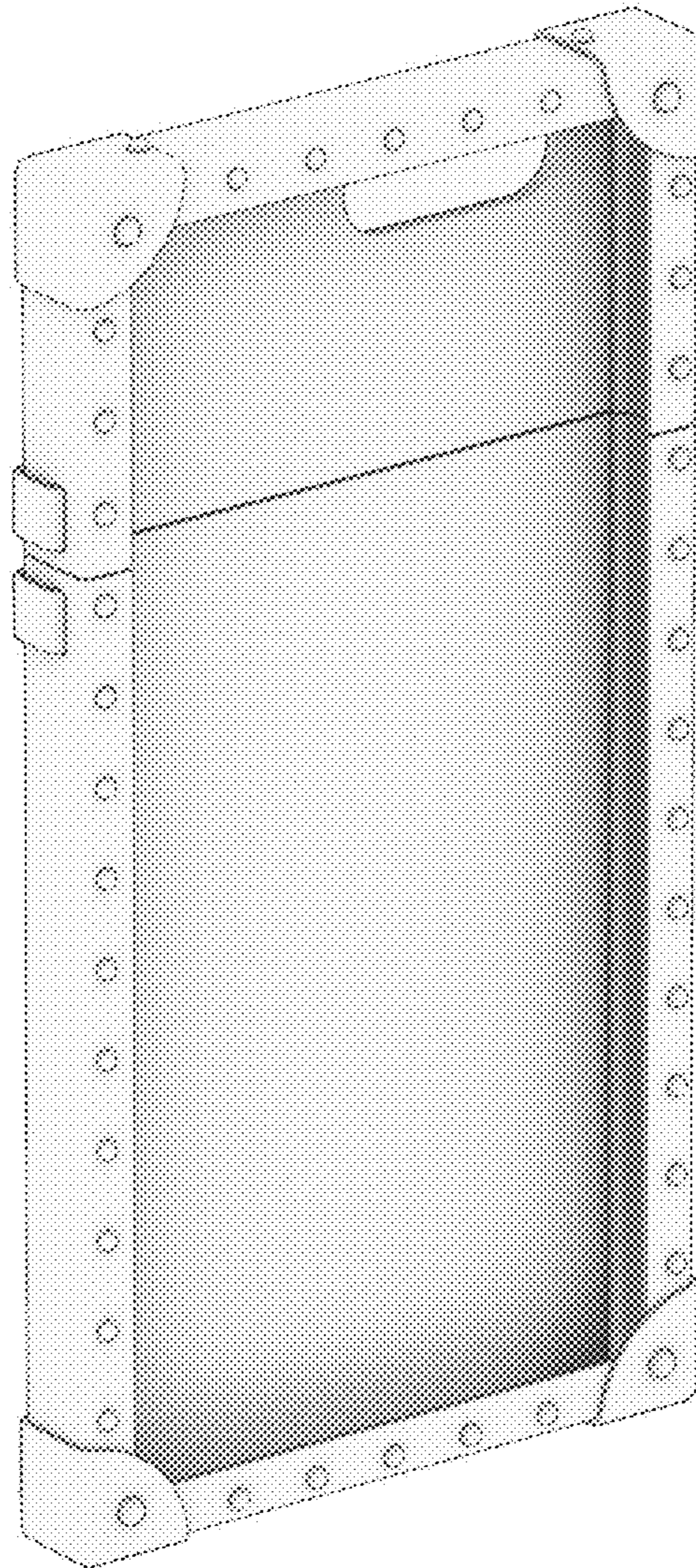

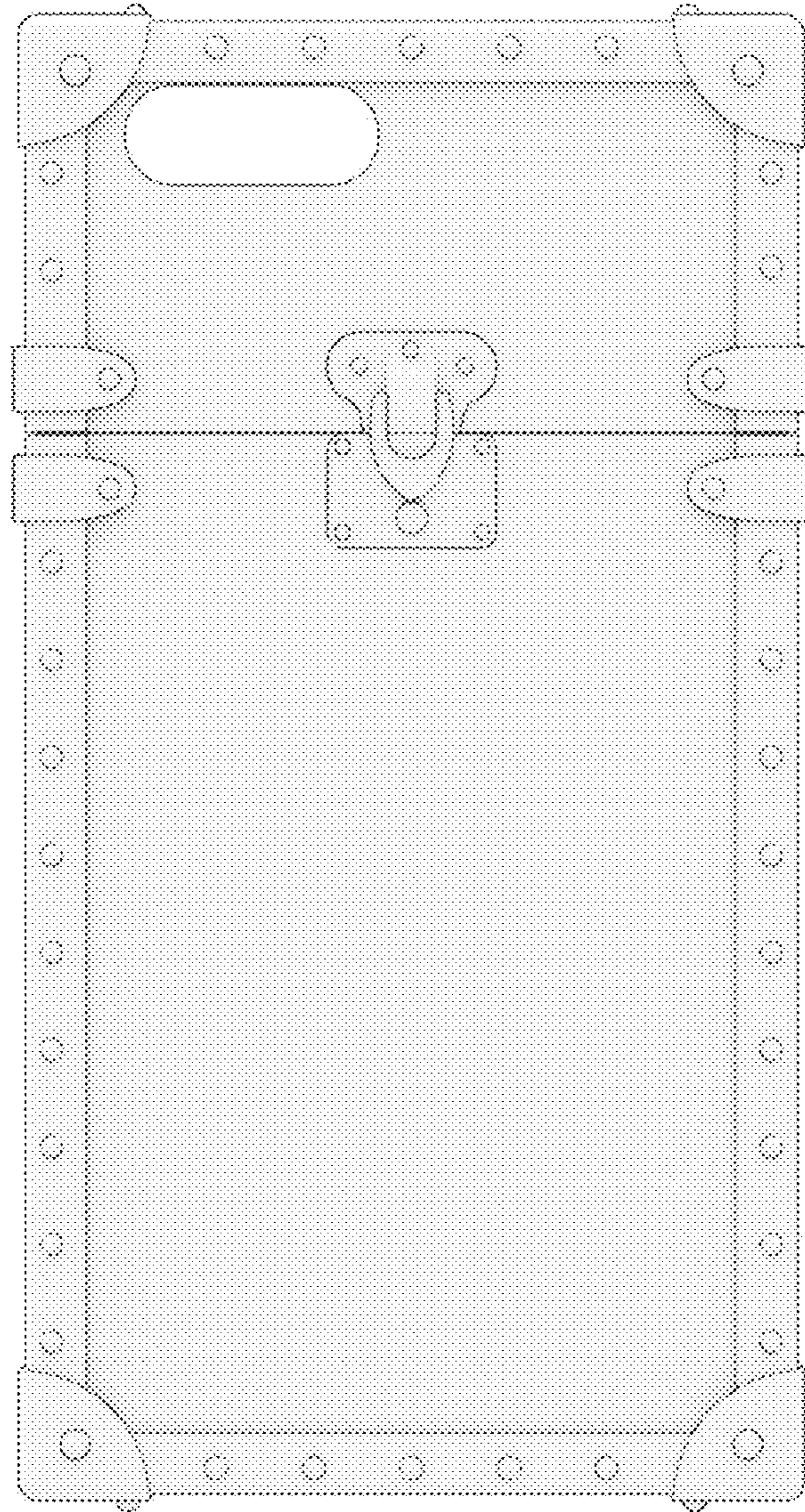

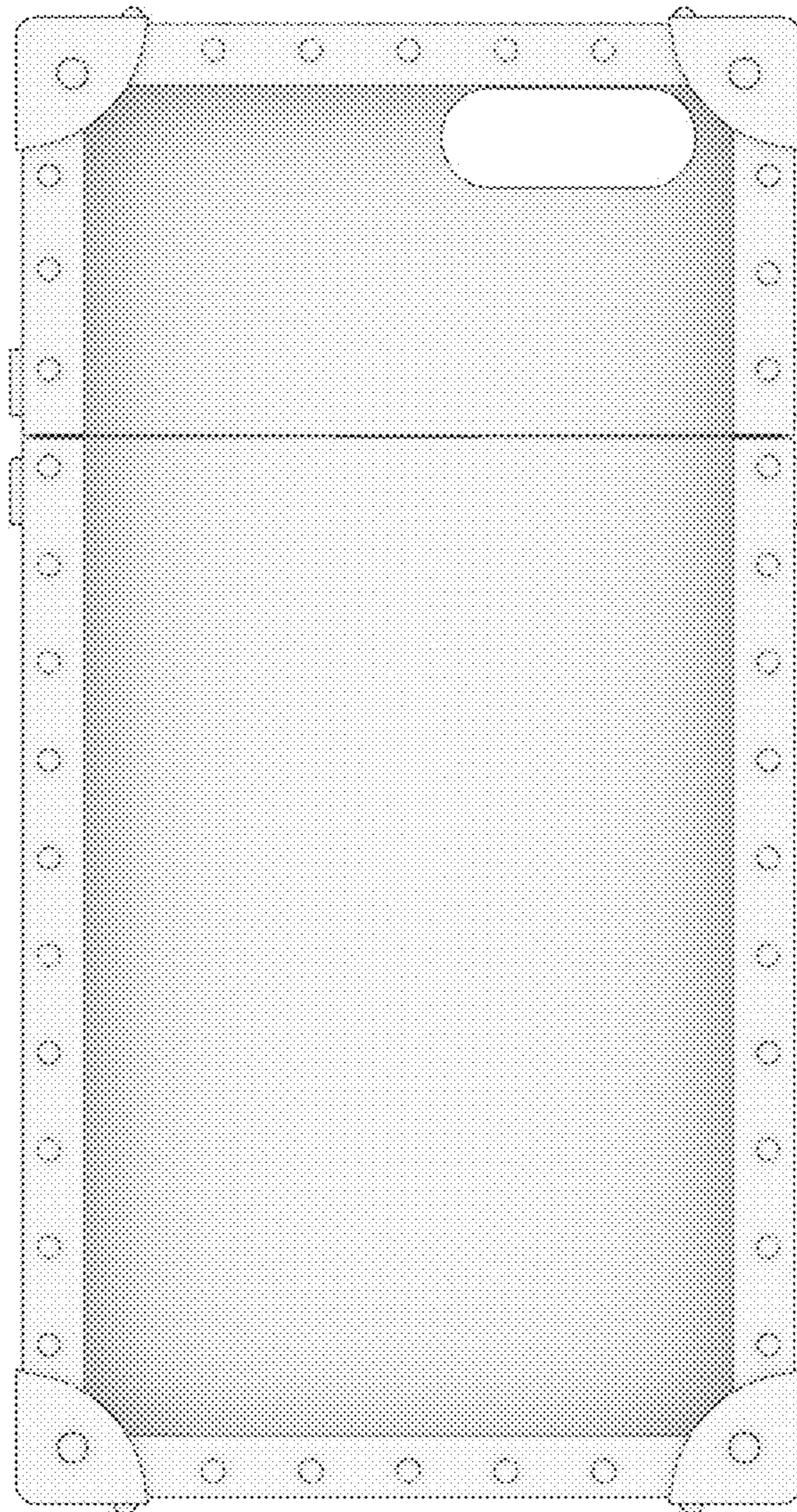

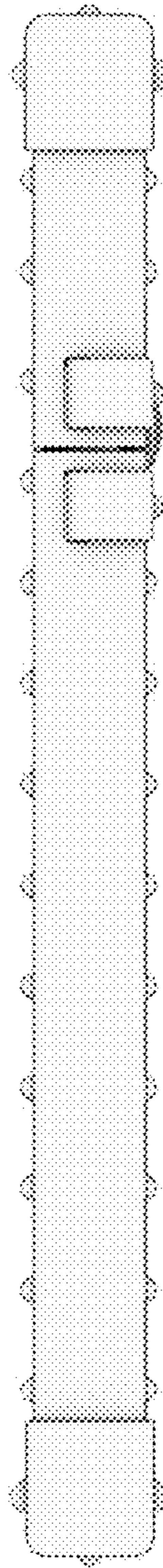

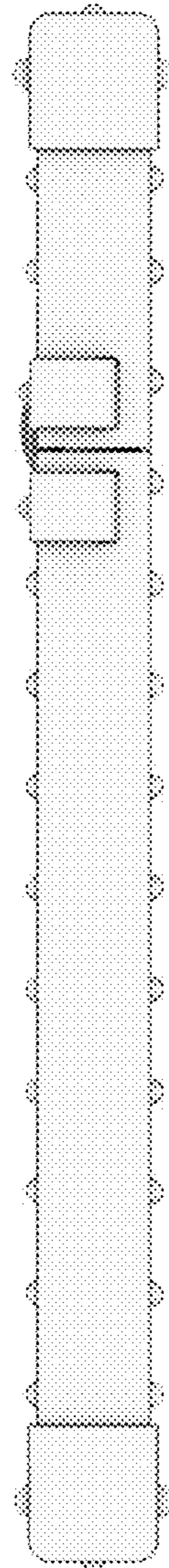

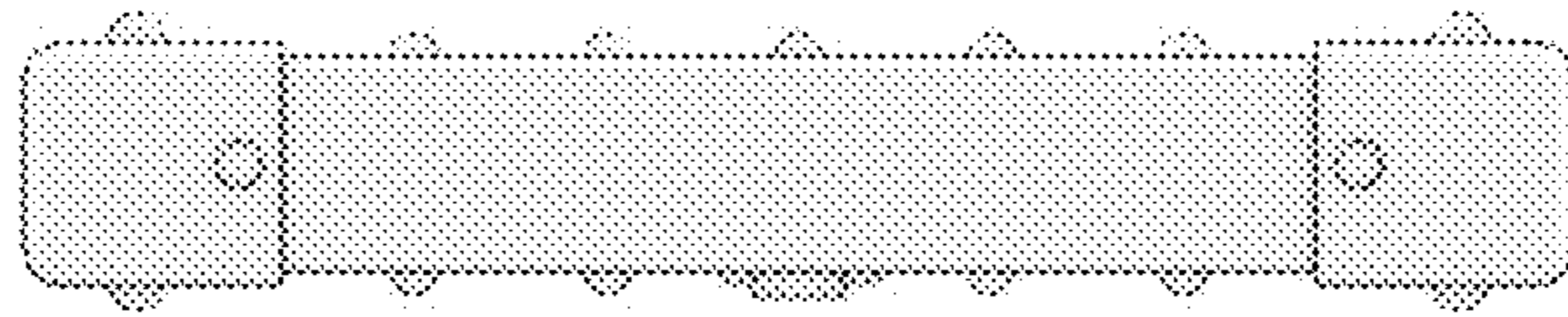

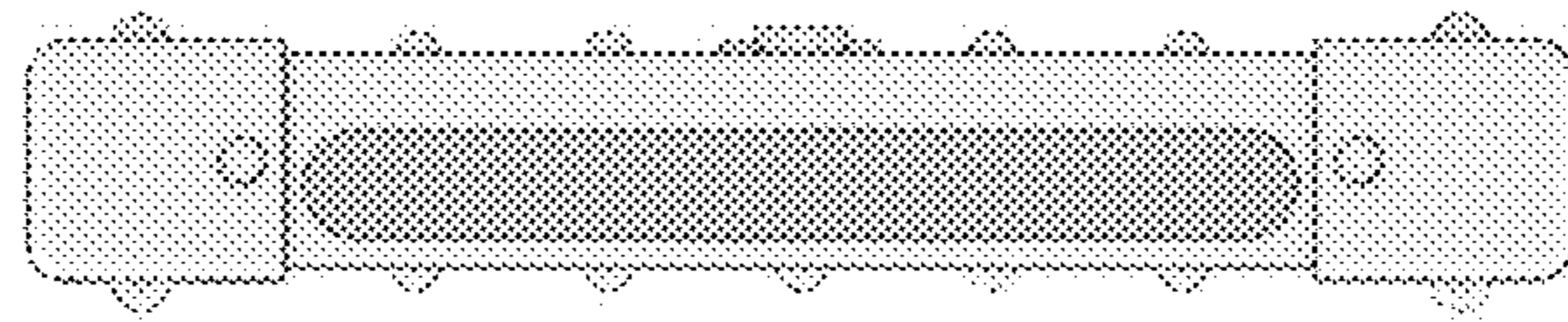
