The ornamental design for a display screen with graphical user interface, as shown and described.

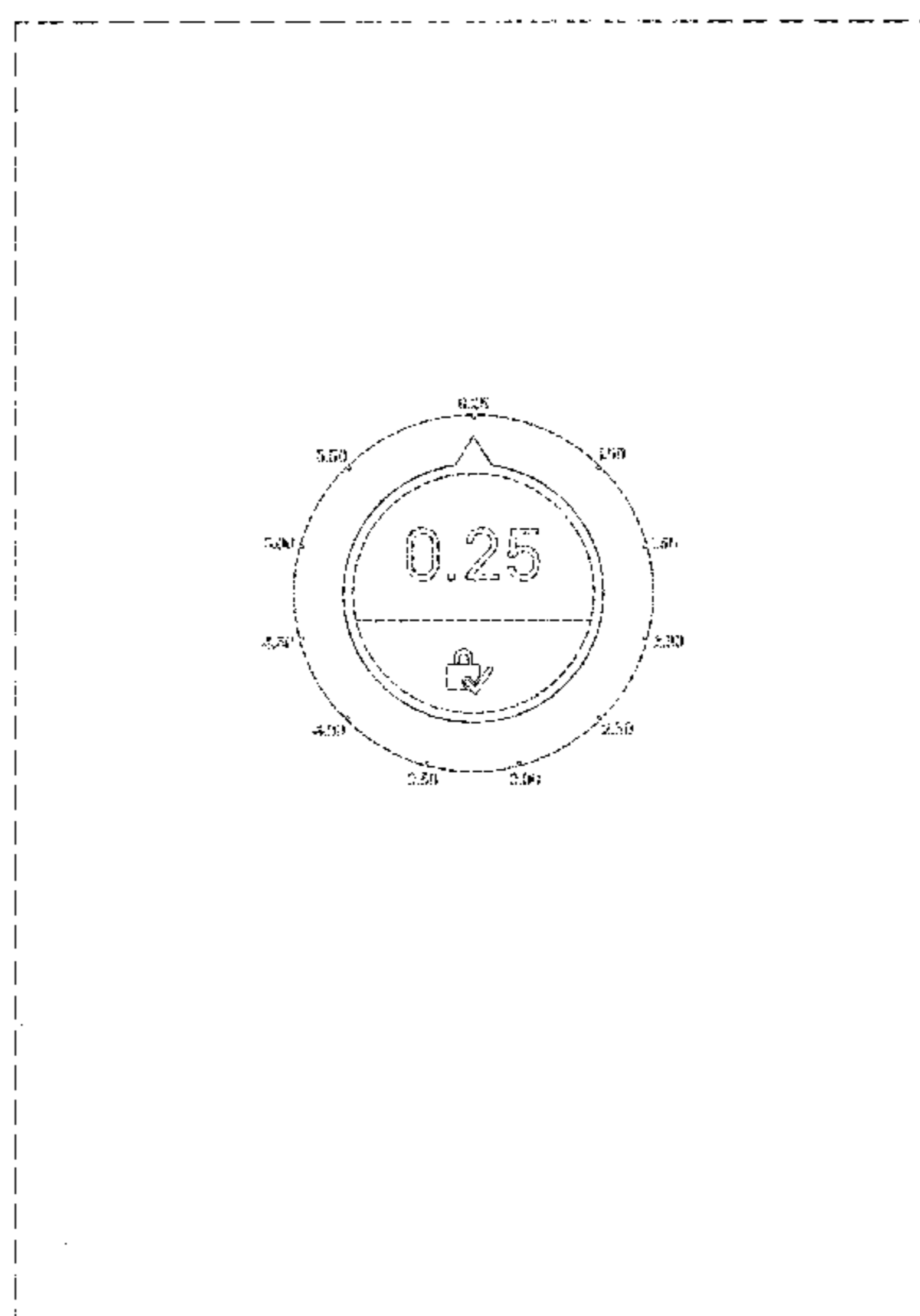
DESCRIPTION

FIG. 1 is a front view of the display screen with graphical user interface showing a first embodiment of the design; FIG. 2 is a variant of the design of FIG. 1; FIG. 3 is a variant of the design of FIG. 1; FIG. 8 is a variant of the design of FIG. 7; and, FIG. 9 is a variant of the design of FIG. 7.

The design consists of the feature of ornamentation of the display screen with graphical user interface shown in solid lines in the hereto annexed drawings.

The long-dashed broken line perimeter showing a display screen and the smaller dashed broken lines within showing portions of the graphical user interface are provided for the purpose of illustrating aspects of the article and forms no part of the claimed design.

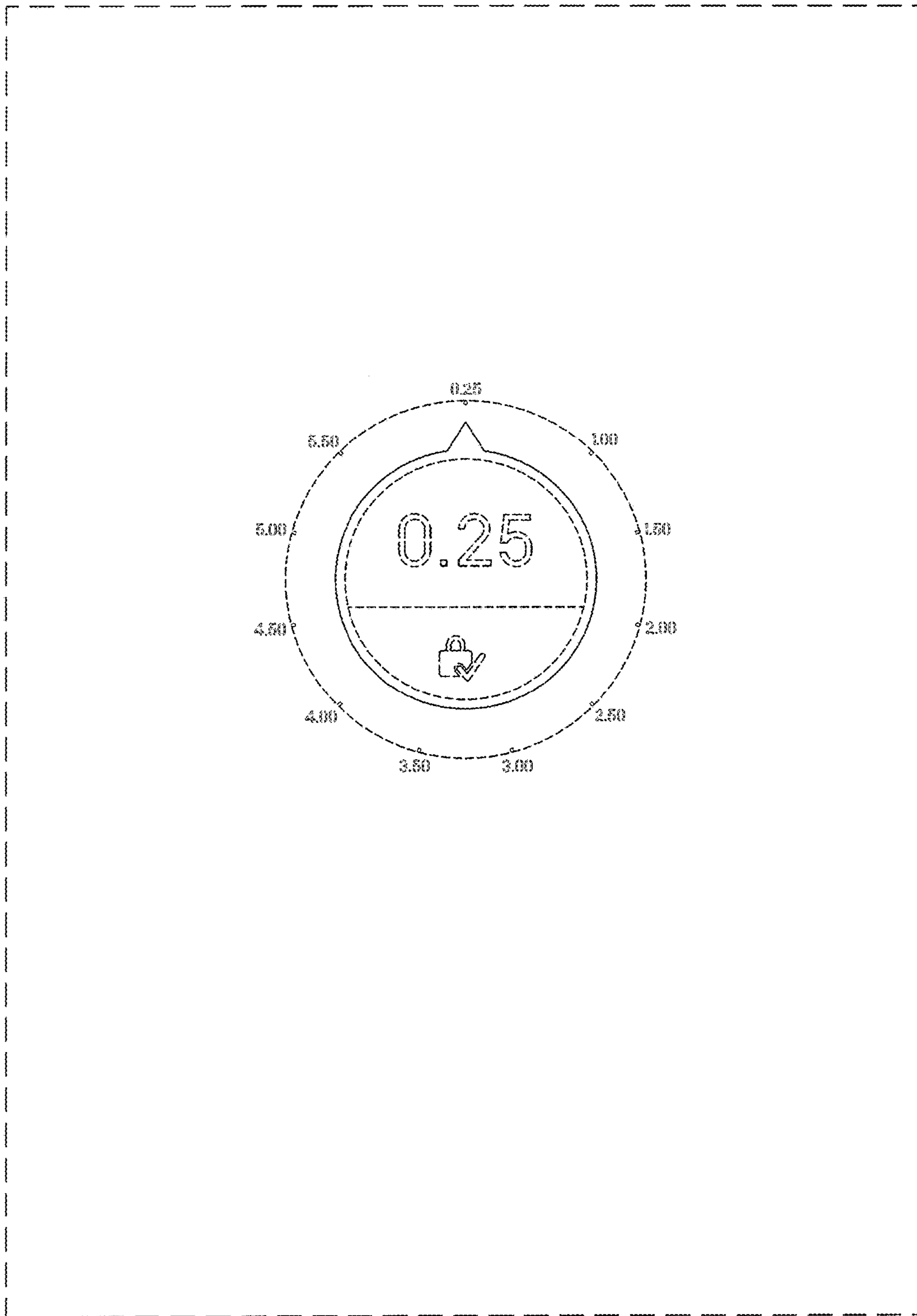

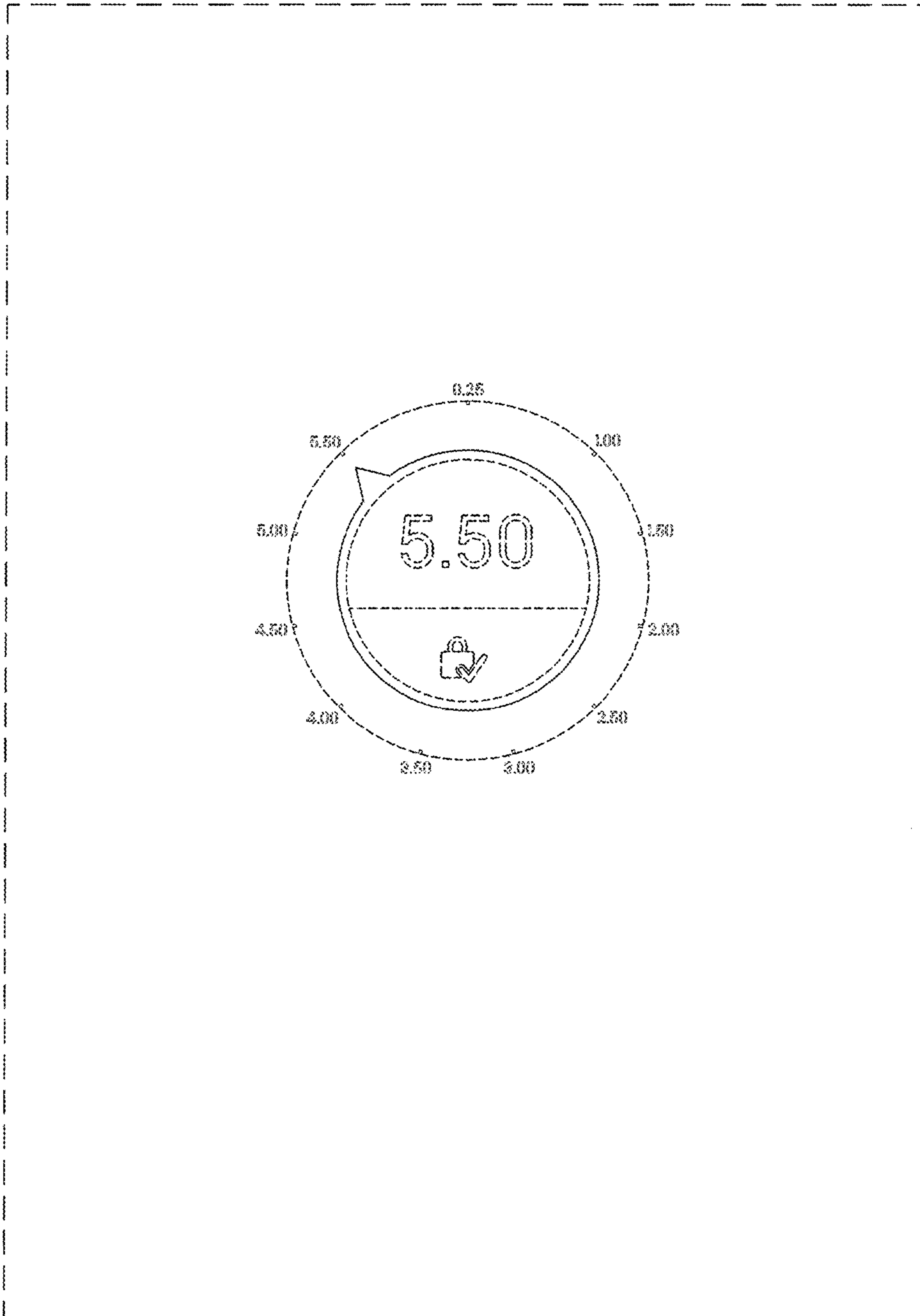

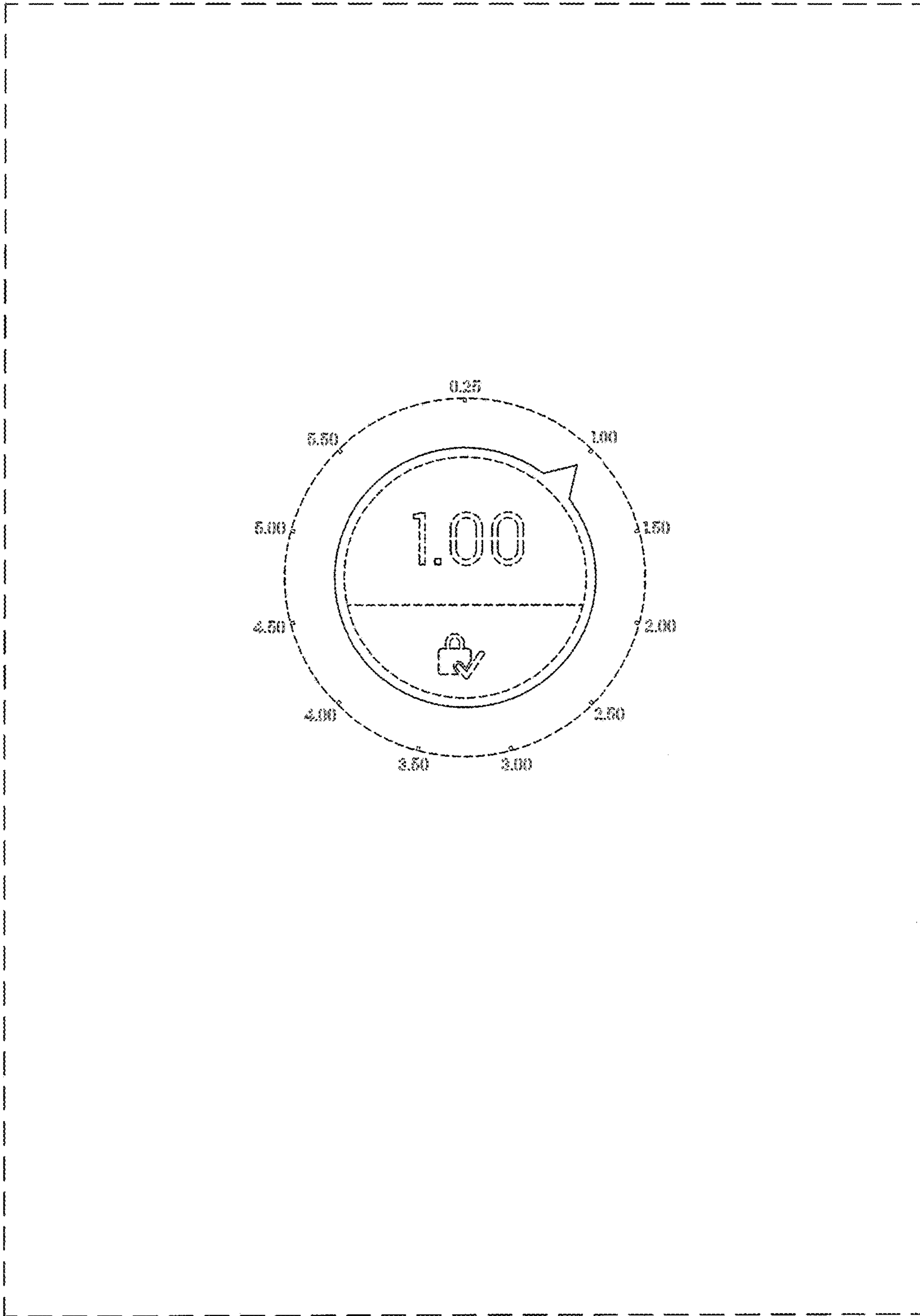
