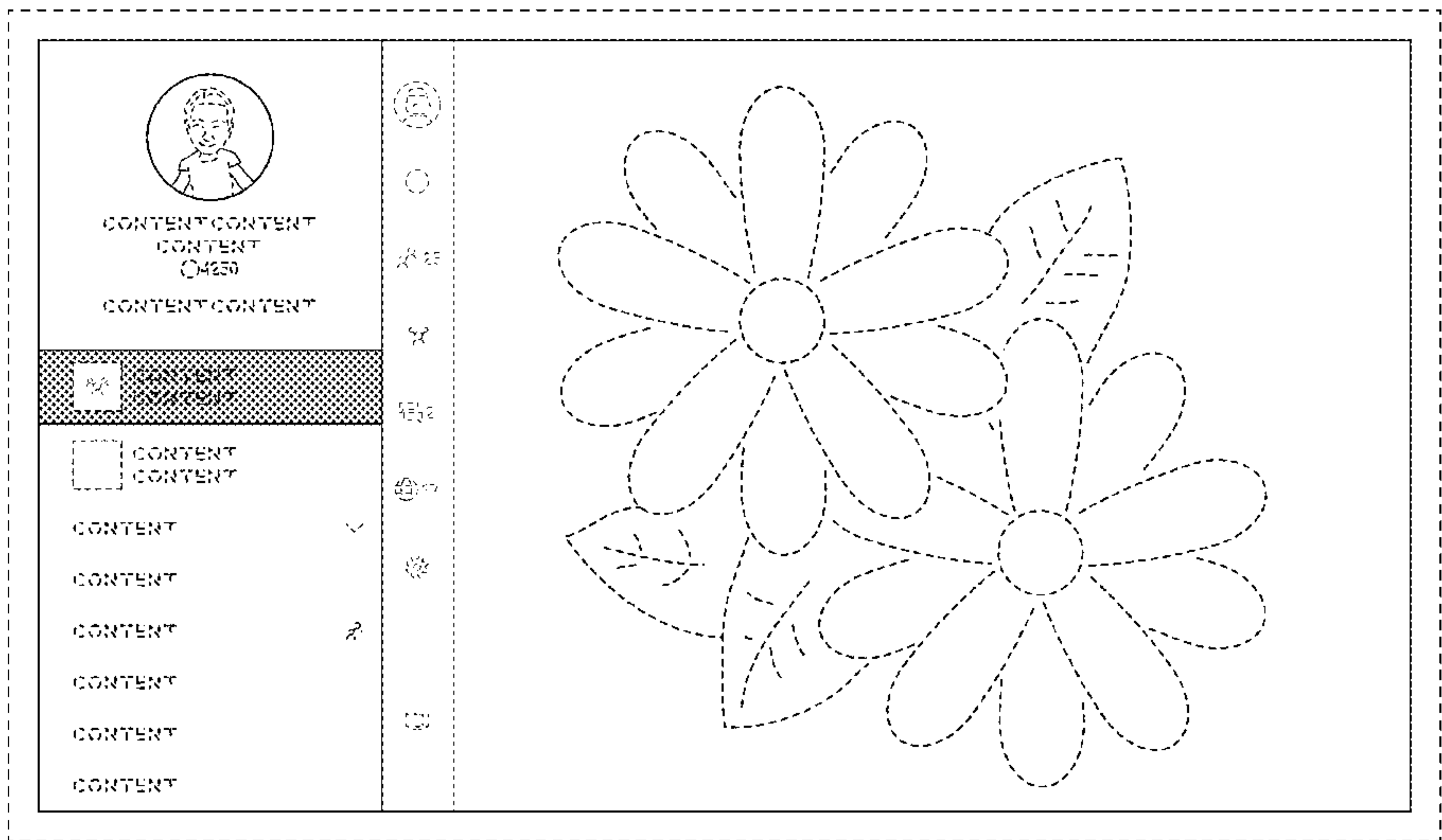
CLAIM
