computer-generated icon, as shown and described.

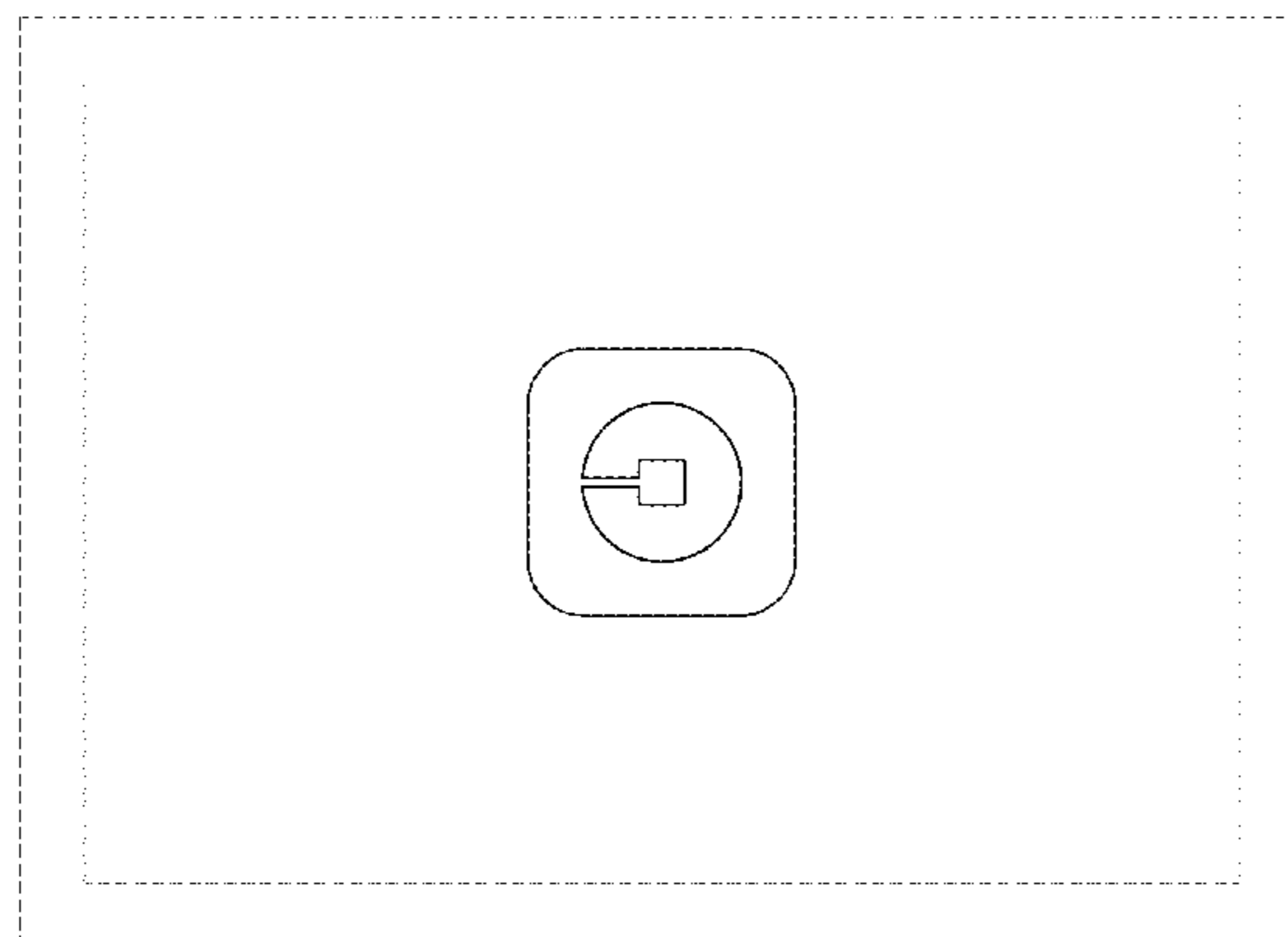
DESCRIPTION

FIG. 1 is a front view of a display panel with a computer-
generated icon showing an embodiment of my new design;
and,

FIG. 2 is a front view of the same embodiment, shown in a
different environment.

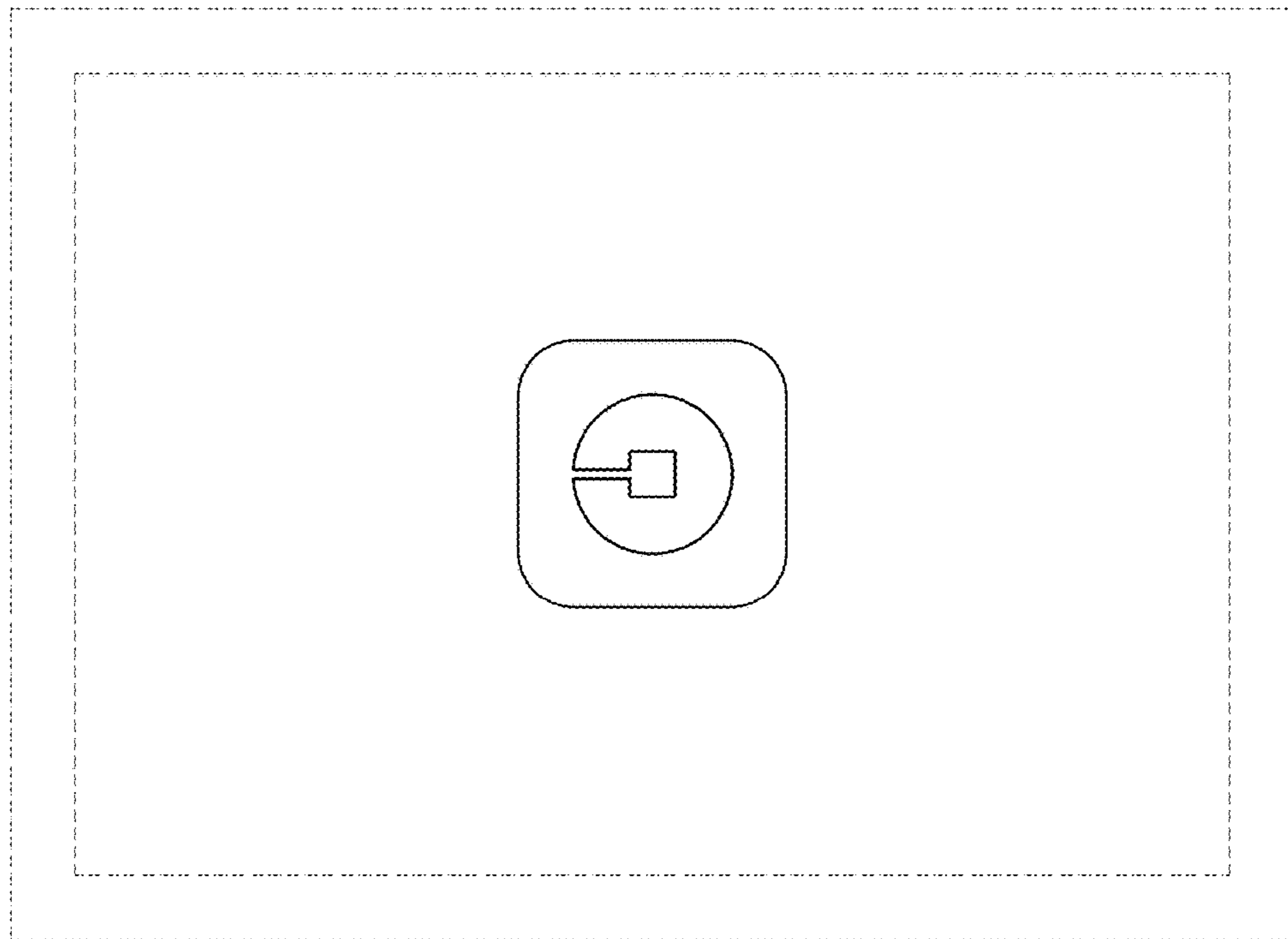

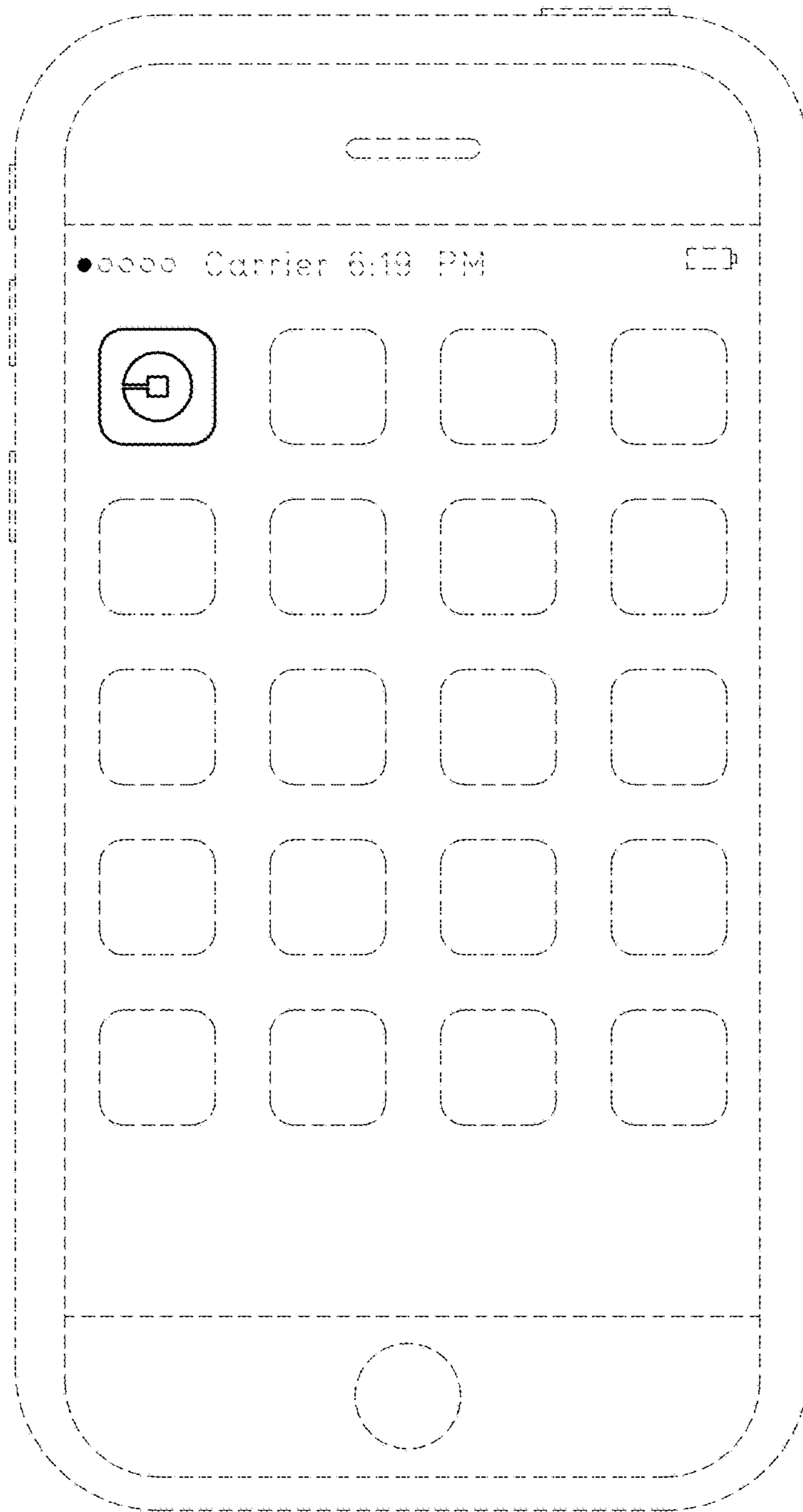
