FIG. 7 is a perspective view thereof in an exemplary environment.

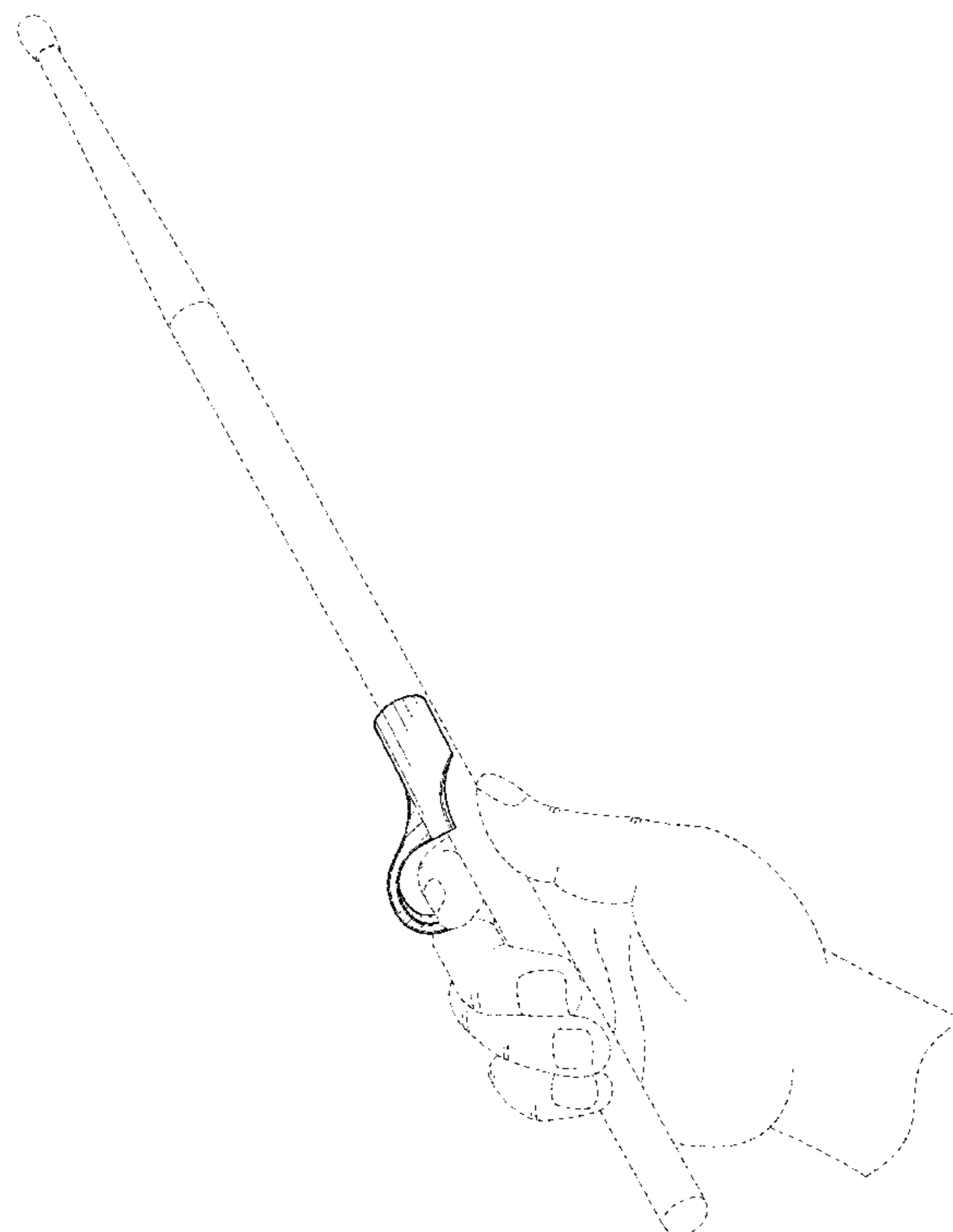
The broken lines in the drawing in FIG. 7 showing the hand of a person and the drum stick represent environmental matter and form no part of the claimed design.

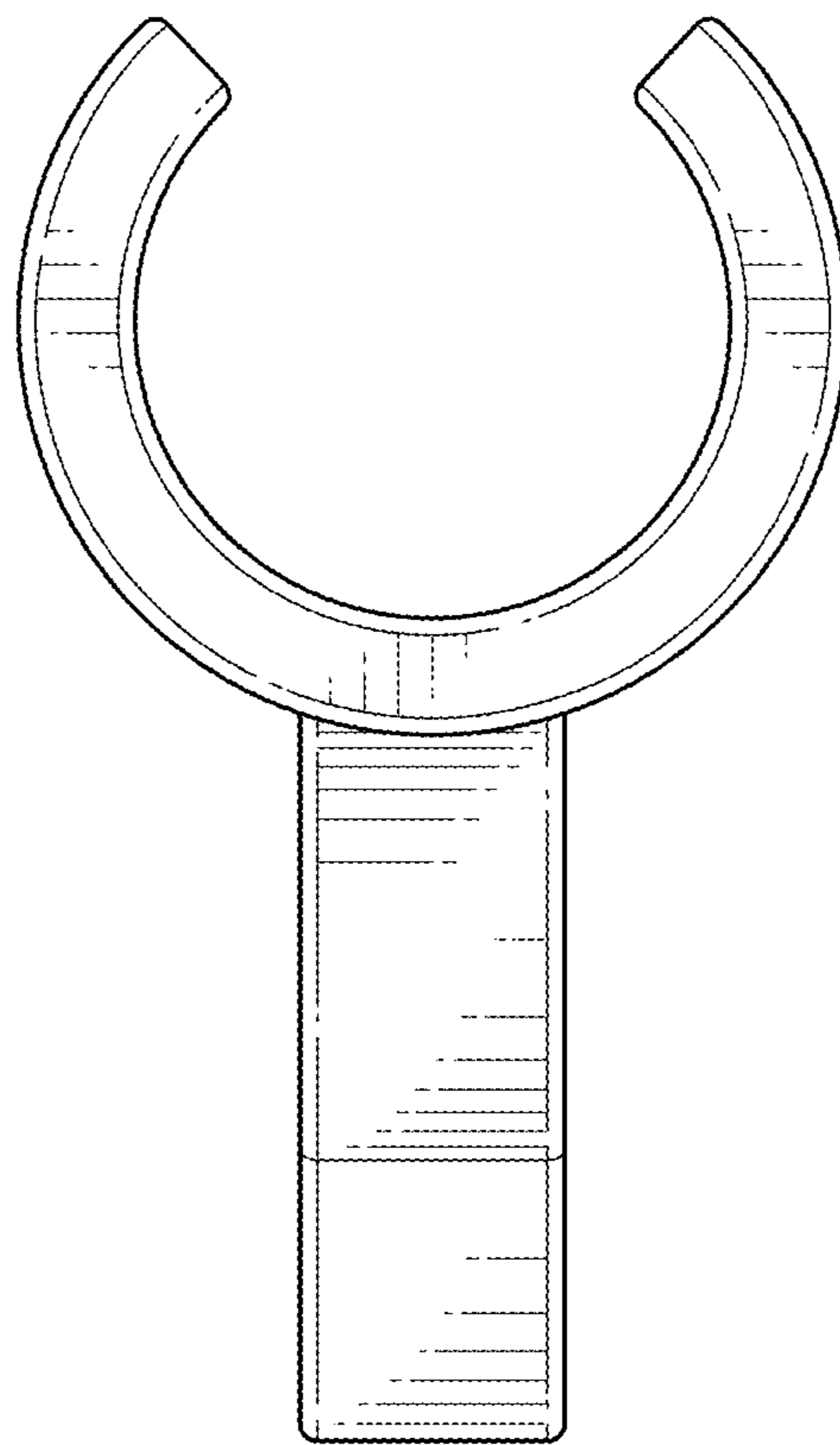

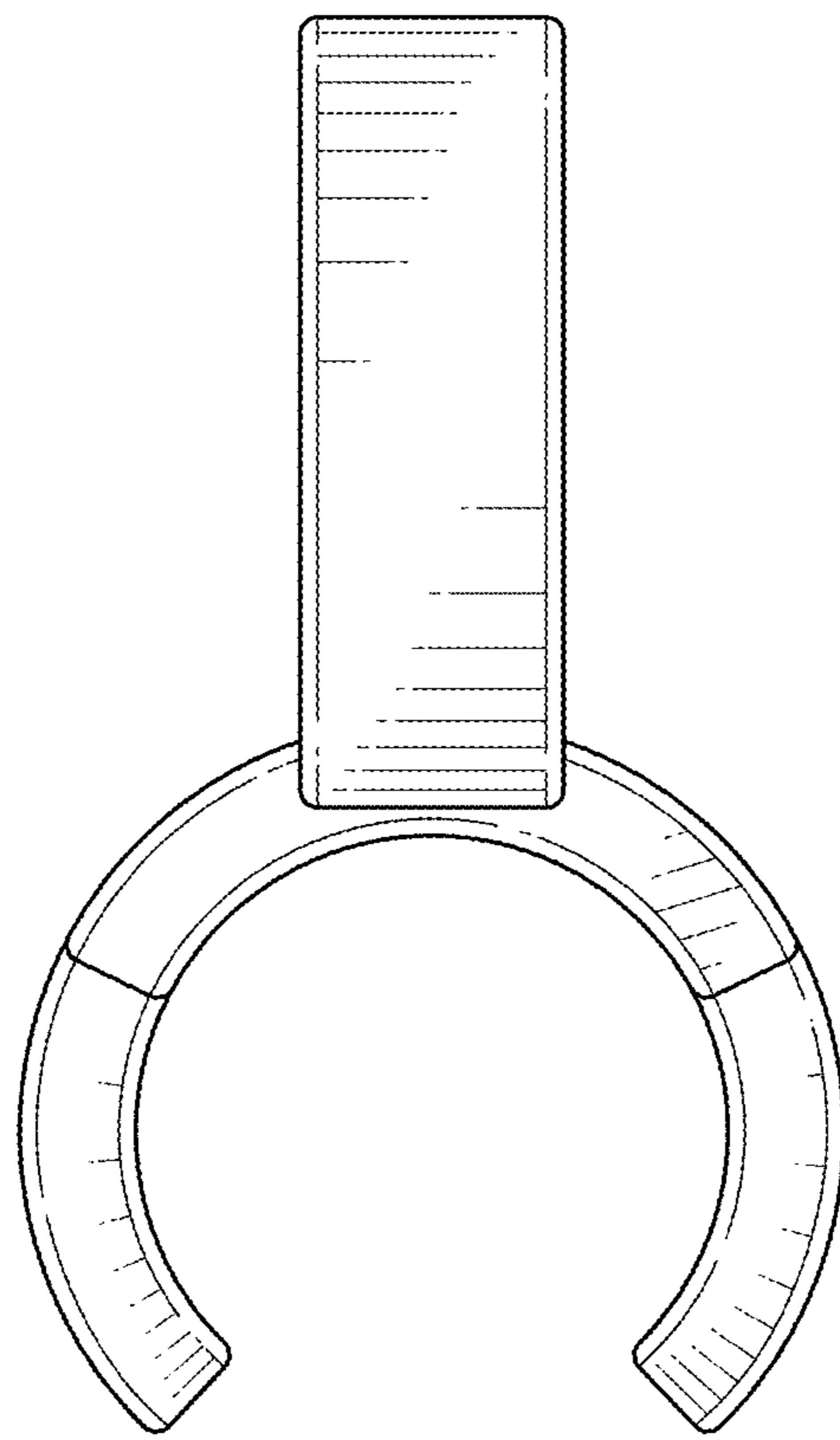

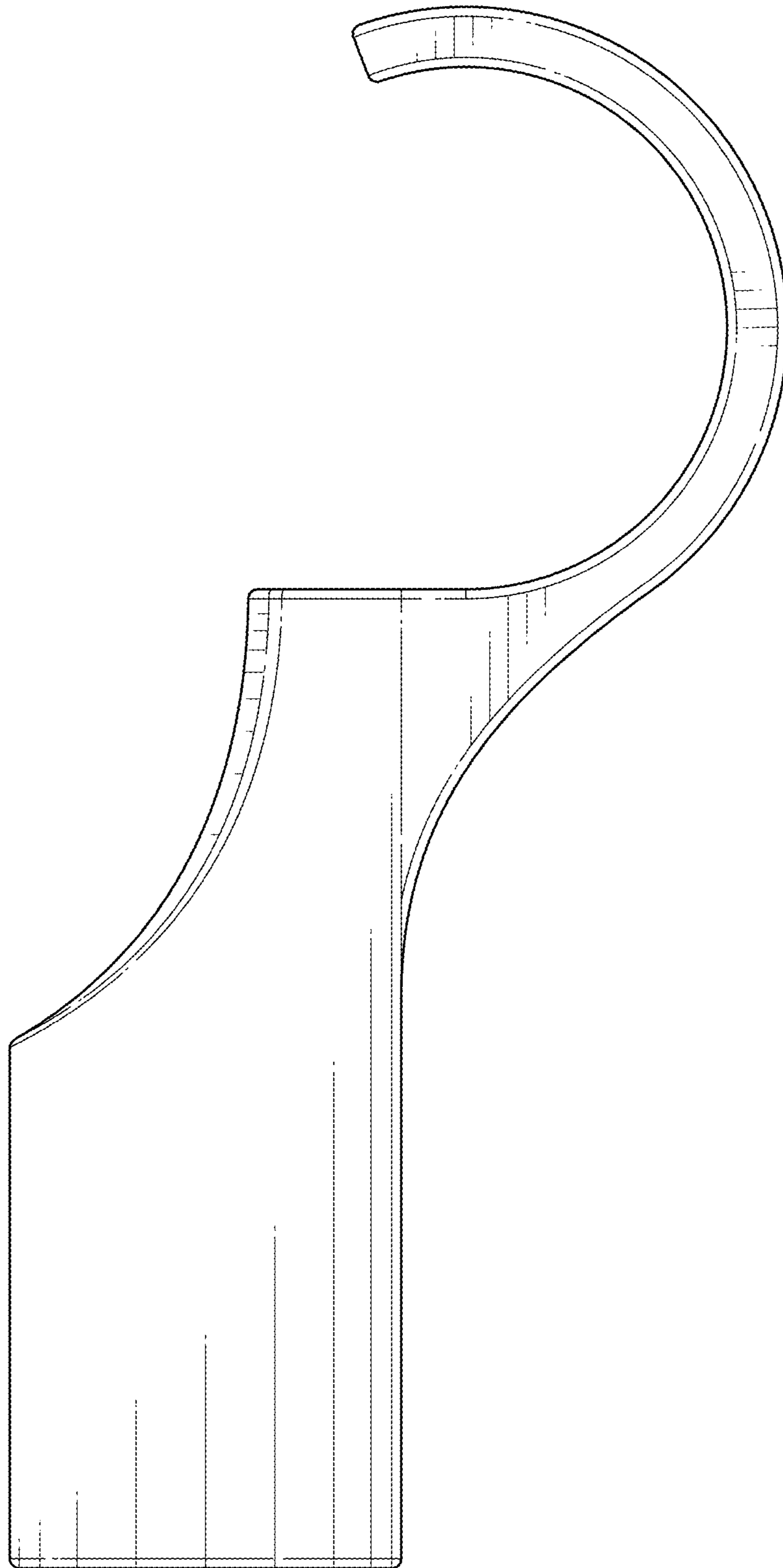

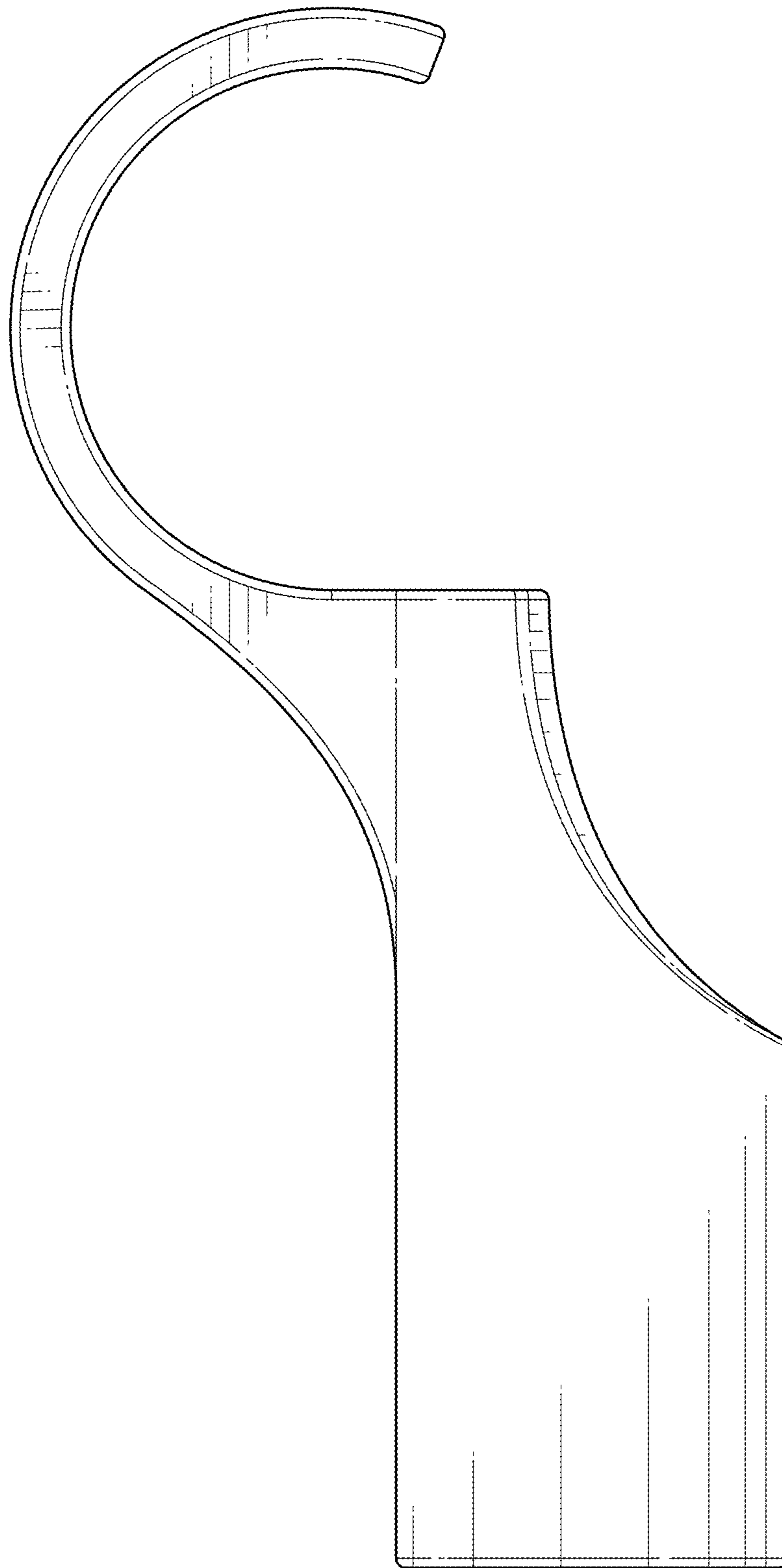

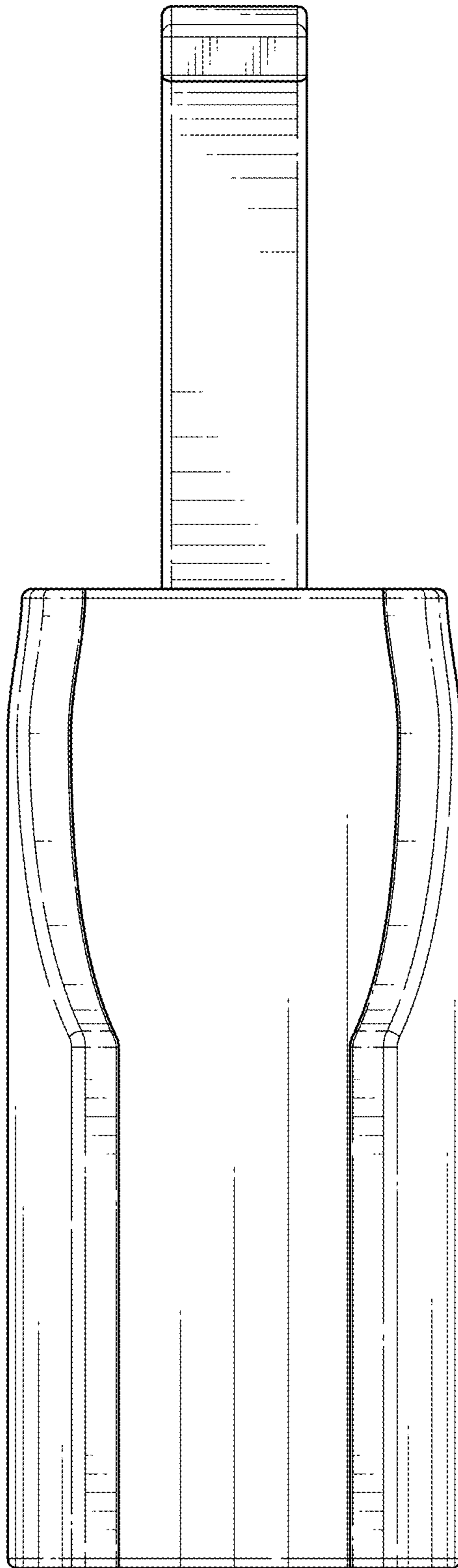

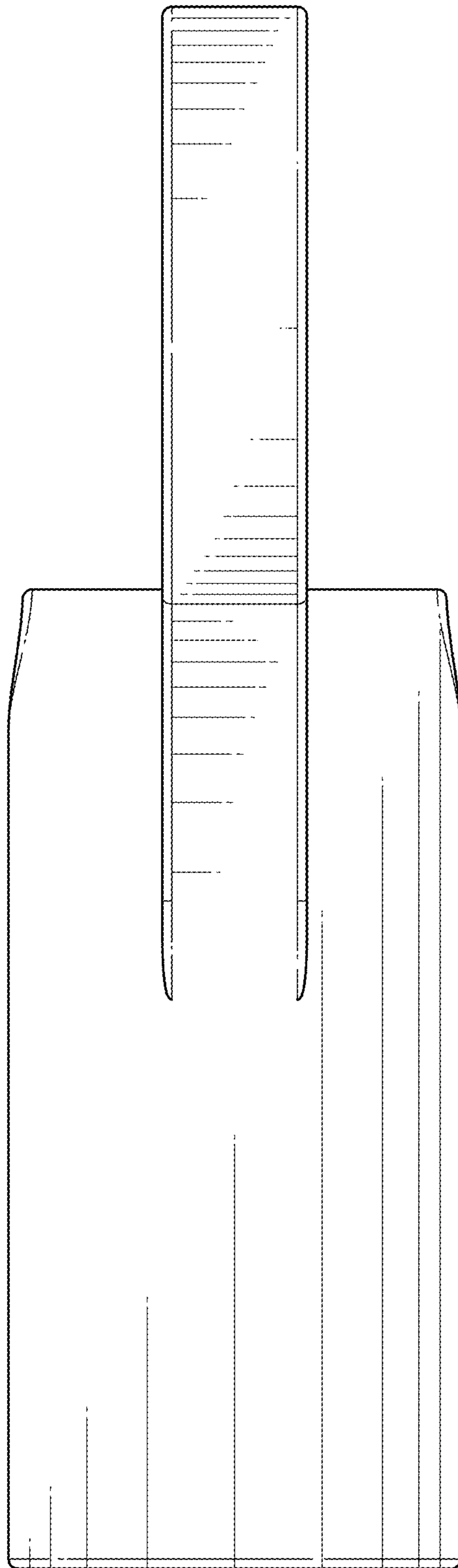

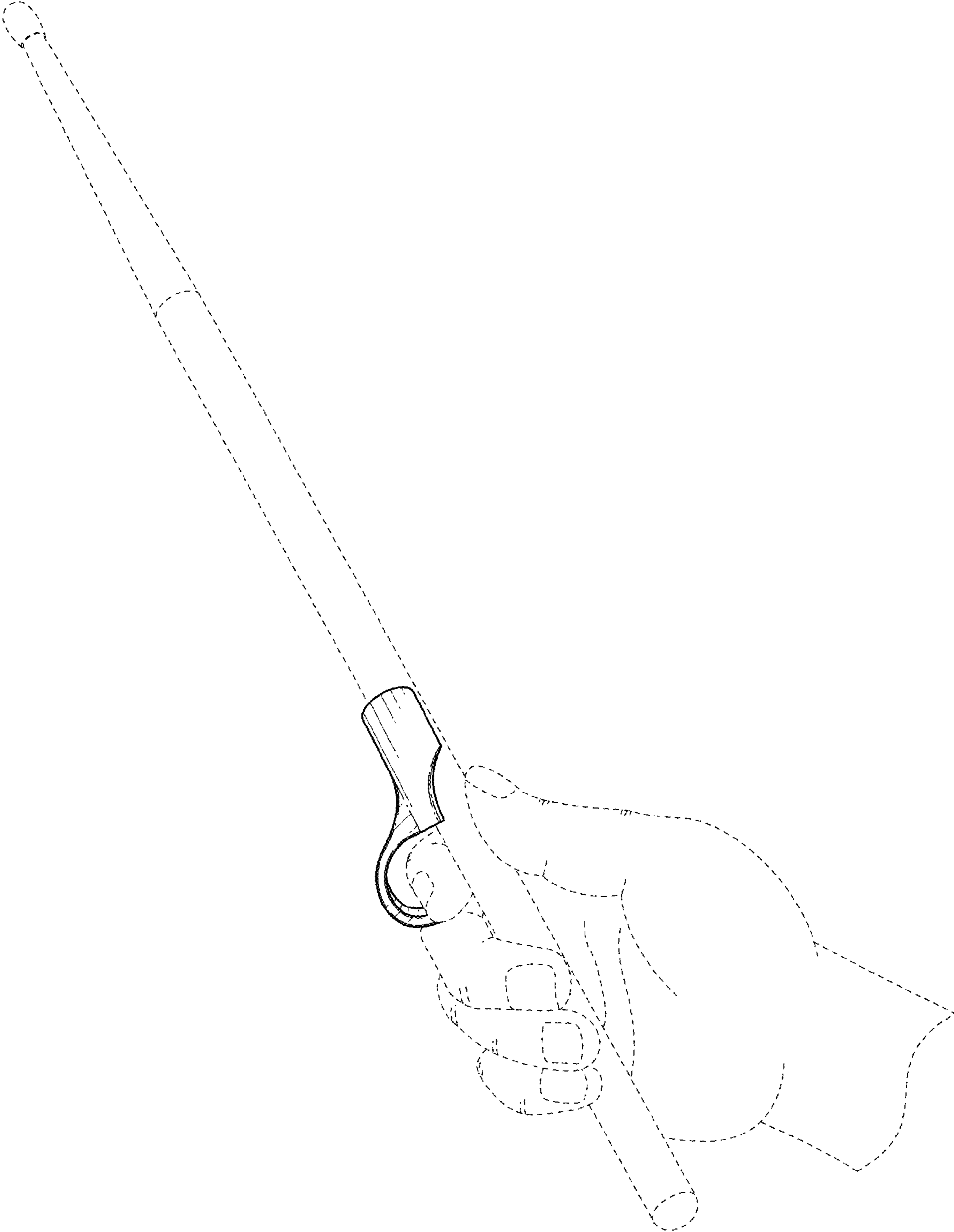
