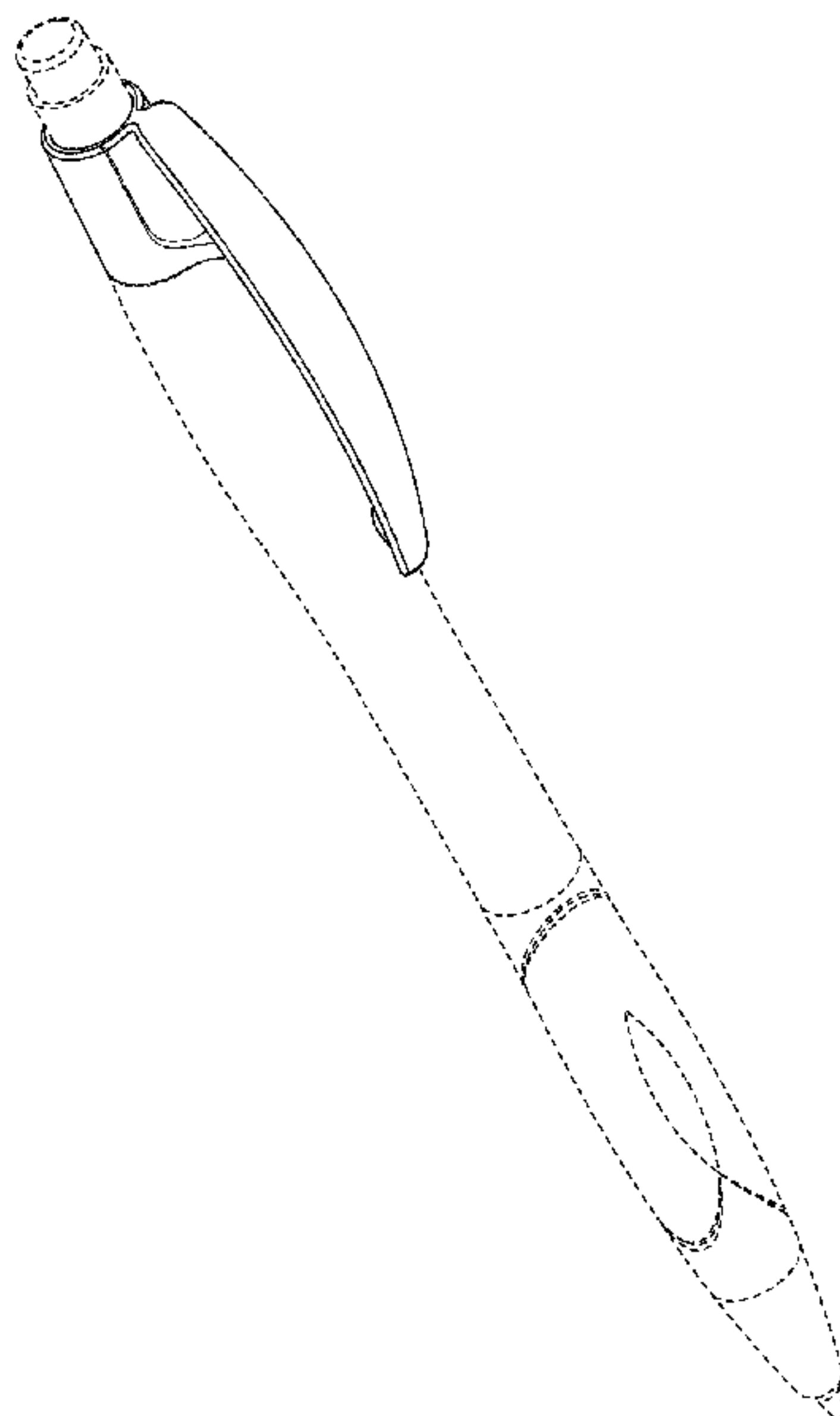
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a writing instrument according to the present design;
FIG. 2 is a front view of the writing instrument of FIG. 1;
FIG. 3 is a rear view of the writing instrument of FIG. 1;
FIG. 4 is a right side view of the writing instrument of FIG. 1;

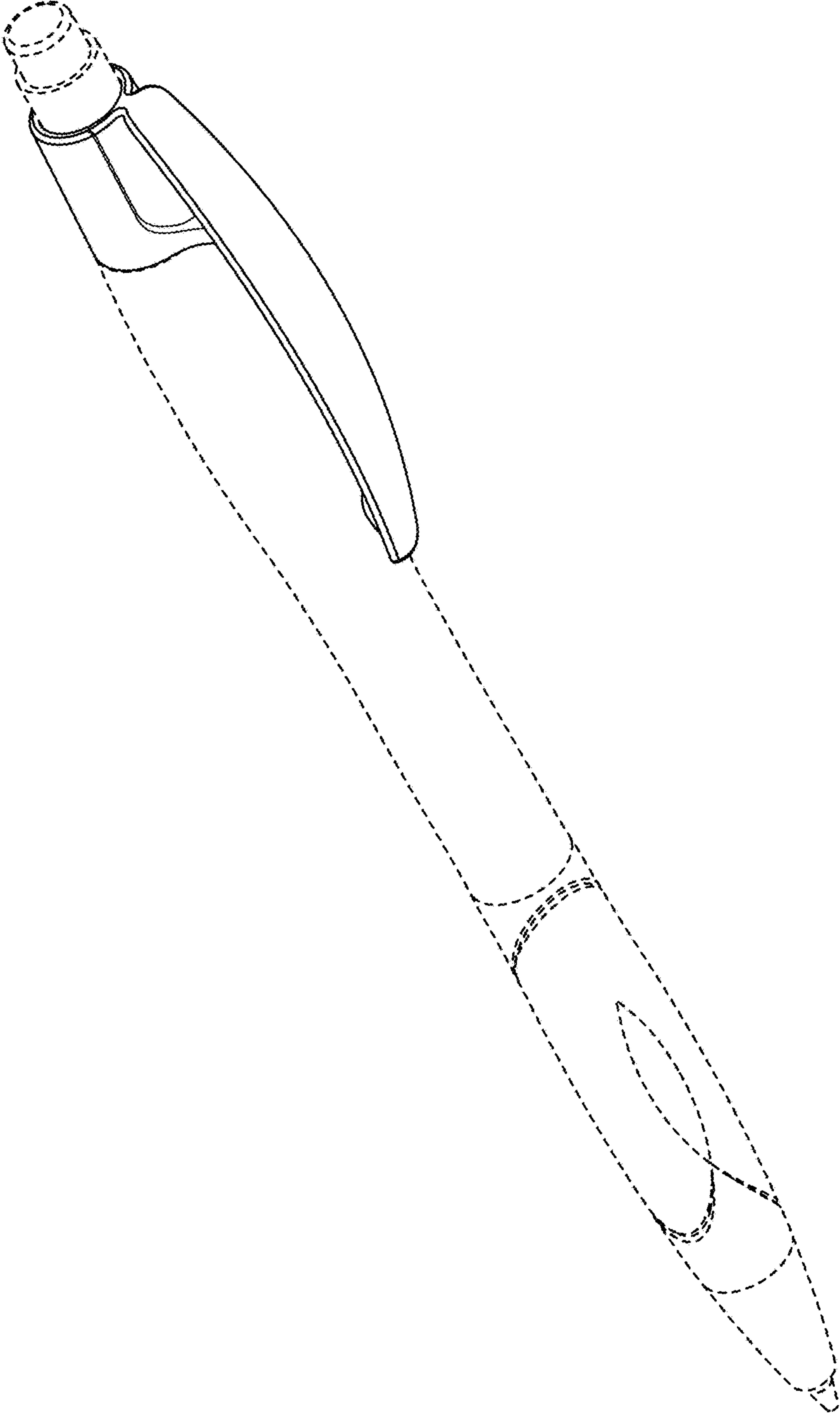

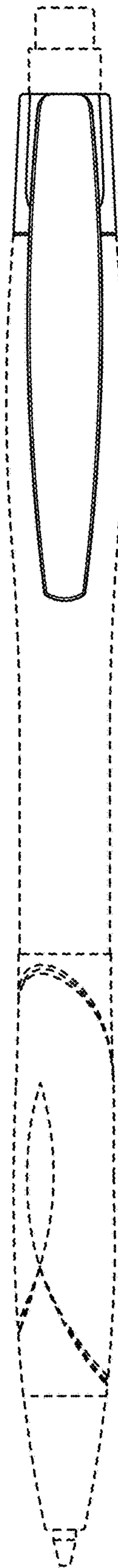

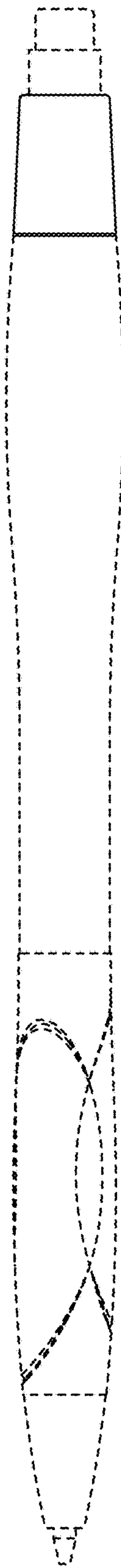

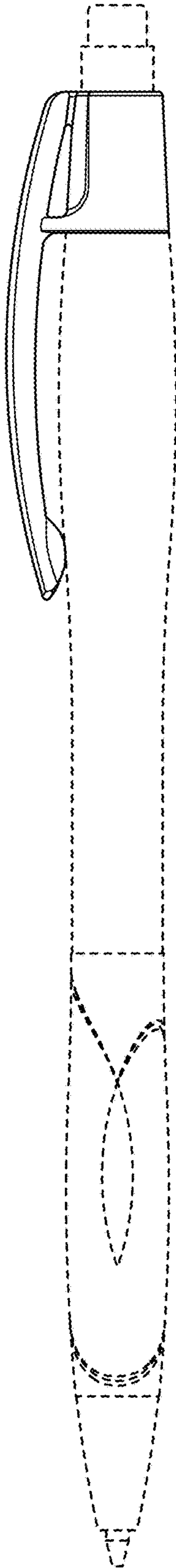

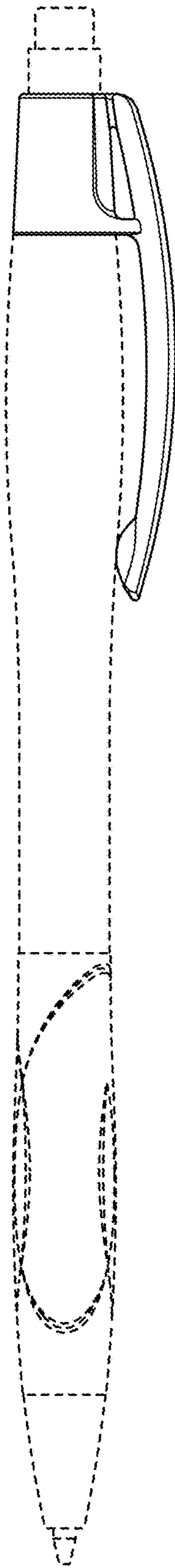

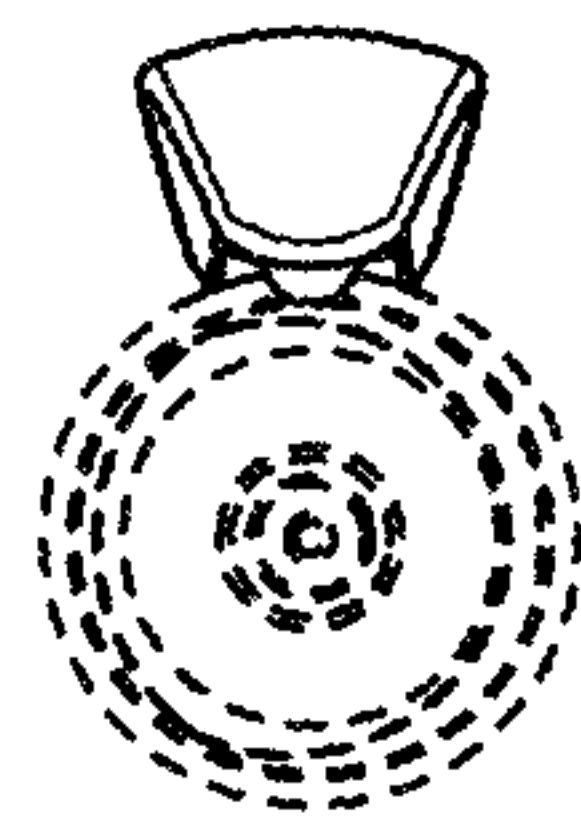
